8	An Act relating to alcoholic beverages; amending 37A
9	O.S. 2021, Section 2-104, which relates to winemaker license; providing requirements for wine to be sold
10	for off-premises consumption; and providing an effective date.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 37A O.S. 2021, Section 2-104, is
15	amended to read as follows:
16	Section 2-104. A winemaker license shall authorize the holder
17	thereof:
18	1. To manufacture (including such mixing, blending and cellar
19	treatment as authorized by federal law), bottle, package and store
20	on licensed premises wine containing not more than twenty-four
21	percent (24%) alcohol by volume, provided the bottle or package
22	sizes authorized shall be limited to the capacities approved by the
23	United States Alcohol and Tobacco Tax and Trade Bureau;

- 2. To sell wine in this state to licensed wholesalers and manufacturers;
- 3. To sell wine produced at the winery from grapes and other fruits and berries grown in this state, if available, for either on-premises or off-premises consumption to consumers on the premises of the winery. Wine sold for off-premises consumption must meet the following requirements:
 - a. must be in a sealed container by a winemaker license at the wine maker licensee's premises, and
 - b. the wine is transferred within the licensed premises
 by an employee of the licensee who:
 - (1) is at least eighteen (18) years of age,
 - (2) upon delivery, verifies the age of the person to whom the wine is being delivered.

If the employee delivering the drink is not able to safely verify a person's age or level of intoxication upon delivery, the employee shall cancel the sale of alcohol and return the product to the license holder;

4. To serve free samples of wine produced at the winery to visitors twenty-one (21) years of age and older. For purposes of this section, no visitor may sample more than a total of six (6) fluid ounces of wine per day. The winery shall restrict the distribution and consumption of wine samples to an area within the licensed premises designated by the winery. A current floor plan

- 1 | that includes the designated sampling area shall be on file with the
- 2 ABLE Commission. No visitor under twenty-one (21) years of age
- 3 | shall be permitted to enter the designated sampling area when
- 4 samples are being distributed and consumed. Samples of wine served
- 5 by a winery under this section shall not be considered a sale of
- 6 | wine within the meaning of Article XXVIII-A of the Oklahoma
- 7 | Constitution or Section 1-103 of this title; provided, such samples
- 8 of wine shall be considered removed or withdrawn from the winery for
- 9 use or consumption within the meaning of Section 5-110 of this title
- 10 | for excise tax determination and reporting requirements;
- 11 5. To serve free samples of wine produced at the winery at
- 12 | public events such as festivals and trade shows;
- 13 6. To sell wine produced at the winery, for either on-premises
- 14 or off-premises consumption at public events such as festivals and
- 15 | trade shows;
- 7. To sell wine out of this state to qualified persons;
- 17 | 8. To purchase from licensed winemakers, distillers and
- 18 rectifiers in this state, and to import into this state wine, brandy
- 19 and fruit spirits for use in manufacturing in accordance with
- 20 | federal laws and regulations;
- 9. To sell and serve Oklahoma-manufactured wine, mulled wine,
- 22 or spiced wine, mixed with nonalcoholic beverages or food items such
- 23 | as water, sugar, fruits and vegetables, at any temperature, for
- 24 either on-premises or off-premises consumption;

To purchase beer in retail containers from the holder of a 2 wholesaler, beer distributor, small brewer self-distributor or 3 brewpub self-distributor license or as specifically provided by law; 4 To sell, offer for sale and possess beer for on-premises 5 consumption; and 6 To establish satellite tasting rooms as defined and 7 authorized in this act where the winemaker's products may be tasted, 8 sampled, sold and served for on-premises consumption and the 9 winemaker is permitted to sell its products in sealed containers; 10 provided, the small farm winery license or winemaker license is 11 active and in good standing. The wine sold at a satellite tasting 12 room must have been produced/manufactured by the holder of a small 13 farm winery license or winemaker license and must have all 14 manufacturing taxes paid. 15 SECTION 2.
