15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. NEW LAW A new section of law to be codified
17	in the Oklahoma Statutes as Section 1-580 of Title 63, unless there
18	is created a duplication in numbering, reads as follows:
19	This act shall be known and may be cited as the "Amyotrophic
20	Lateral Sclerosis (ALS) Grant Program".
21	SECTION 2. NEW LAW A new section of law to be codified
22	in the Oklahoma Statutes as Section 1-580.1 of Title 63, unless
23	there is created a duplication in numbering, reads as follows:

There is hereby created the Amyotrophic Lateral Sclerosis (ALS) Grant Program which shall be administered by the State Department of Health. The program shall grant funds to support research, being conducted in Oklahoma, for Amyotrophic Lateral Sclerosis (ALS) and for programs that help support Oklahoma residents caring for a family member afflicted with ALS. Beginning July 1, 2025, the State Department of Health shall provide an annual report to the Governor, the Speaker of the Oklahoma House of Representatives, the President Pro Tempore of the Oklahoma State Senate, Appropriations and Budget Chair of the Oklahoma House of Representatives, and the Appropriations Chair of the Oklahoma State Senate that includes, but is not limited to, how many grants have been awarded during the Fiscal Year, which entities the grants have been awarded to, and for what purposes the funds are supporting.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-580.2 of Title 63, unless there is created a duplication in numbering, reads as follows:

There is hereby created in the Oklahoma State Treasury a revolving fund for the State Health Department to be designated the "Amyotrophic Lateral Sclerosis (ALS) Grant Program Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies received by the State Department of Health from appropriations, donations, grants, or other sources of funding specifically designated for deposit to the
