9	amended by Section 11, Chapter 271, O.S.L. 2023, 24A.5, as amended by Section 5, Chapter 332, O.S.L.
10	2023, and 24A.17 (51 O.S. Supp. 2023, Sections 24A.3 and 24A.5), which relate to public records; reducing
11	the list of things defined as non-records; increasing the types of confidential records; prescribing a
12	deadline to notify of intent to file suit for denied record access; and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.3, as
17	last amended by Section 11, Chapter 271, O.S.L. 2023 (51 O.S. Supp.
18	2023, Section 24A.3), is amended to read as follows:
19	Section 24A.3 As used in the Oklahoma Open Records Act:
20	1. "Record" means all documents including, but not limited to,
21	any book, paper, photograph, microfilm, data files created by or
22	used with computer software, computer tape, disk, record, sound
23	recording, film recording, video record or other material regardless
24	of physical form or characteristic, created by, received by, under

1 the authority of, or coming into the custody, control or possession 2 of public officials, public bodies or their representatives in 3 connection with the transaction of public business, the expenditure 4 of public funds or the administering of public property. Record 5 does not mean:

"Public body" shall include, but not be limited to, any 8 9 office, department, board, bureau, commission, agency, trusteeship, 10 authority, council, committee, trust or any entity created by a 11 trust, county, city, village, town, township, district, school 12 district, fair board, court, executive office, advisory group, task 13 force, study group or any subdivision thereof, supported in whole or 14 in part by public funds or entrusted with the expenditure of public 15 funds or administering or operating public property, and all 16 committees, or subcommittees thereof. Except for the records 17 required by Section 24A.4 of this title, public body does not mean 18 judges, justices, the Council on Judicial Complaints, the 19 Legislature or legislators. Public body shall not include an 20 organization that is exempt from federal income tax under Section 21 501(c)(3) of the Internal Revenue Code of 1986, as amended, and 22 whose sole beneficiary is a college or university, or an affiliated 23 entity of the college or university, that is a member of The 24 Oklahoma State System of Higher Education. Such organization shall

not receive direct appropriations from the Oklahoma Legislature.
 The following persons shall not be eligible to serve as a voting
 member of the governing board of the organization:

- 4 a. a member, officer, or employee of the Oklahoma State
  5 Regents for Higher Education,
- b. a member of the board of regents or other governing
  board of the college or university that is the sole
  beneficiary of the organization, or
- 9 c. an officer or employee of the college or university
  10 that is the sole beneficiary of the organization;
  11 3. "Public office" means the physical location where public
  12 bodies conduct business or keep records;

4. "Public official" means any official or employee of anypublic body as defined herein; and

15 5. "Law enforcement agency" means any public body charged with
16 enforcing state or local criminal laws and initiating criminal
17 prosecutions including, but not limited to, police departments,
18 county sheriffs, the Department of Public Safety, the Oklahoma State
19 Bureau of Narcotics and Dangerous Drugs Control, the Alcoholic
20 Beverage Laws Enforcement Commission, and the Oklahoma State Bureau
21 of Investigation.

22 SECTION 2. AMENDATORY 51 O.S. 2021, Section 24A.5, as 23 amended by Section 5, Chapter 332, O.S.L. 2023 (51 O.S. Supp. 2023, 24 Section 24A.5), is amended to read as follows:

1 Section 24A.5 All records of public bodies and public officials 2 shall be open to any person for inspection, copying, or mechanical reproduction during regular business hours; provided: 3 The Oklahoma Open Records Act, Sections 24A.1 through 24A.30 4 1. 5 of this title, does not apply to records specifically required by law to be kept confidential including: 6 7 records protected by a state evidentiary privilege a. such as the attorney-client privilege, the work 8 9 product immunity from discovery and the identity of 10 informer privileges, 11 records of what transpired during meetings of a public b. body lawfully closed to the public such as executive 12 13 sessions authorized under the Oklahoma Open Meeting 14 Act, 15 personal information within driver records as defined с. 16 by the Driver's Privacy Protection Act, 18 United 17 States Code, Sections 2721 through 2725, 18 information in the files of the Board of Medicolegal d. 19 Investigations obtained pursuant to Sections 940 and 20 941 of Title 63 of the Oklahoma Statutes that may be 21 hearsay, preliminary unsubstantiated investigation-22 related findings, or confidential medical information, 23 any test forms, question banks and answer keys e. 24 developed for state licensure examinations, but

  - f. last names, addresses, social security numbers or tax identification numbers, and proof of identification submitted to the Oklahoma Lottery Commission by persons claiming a lottery prize;
  - g. unless public disclosure is required by other laws or regulations, vehicle movement records of the Oklahoma Transportation Authority obtained in connection with

the Authority's electronic toll collection system,

- 11h.personal financial information, credit reports, or12other financial data obtained by or submitted to a13public body for the purpose of evaluating credit14worthiness, obtaining a license, permit, or for the15purpose of becoming qualified to contract with a16public body,
- <u>i.</u> any digital audio/video recordings of the toll
   <u>collection and safeguarding activities of the Oklahoma</u>
   <u>Transportation Authority</u>,
- j. any personal information provided by a guest at any
   facility owned or operated by the Oklahoma Tourism and
   Recreation Department to obtain any service at the

19		Act, the Pharmacy Audit Integrity Act or Sections 357
20		through 360 of Title 59 of the Oklahoma Statutes;
21	2. All S	ocial Security numbers included in a record may be
22	confidential	regardless of the person's status as a public employee
23	or private in	dividual and may be redacted or deleted prior to
24	release of th	e record by the public body;

3. Any reasonably segregable portion of a record containing exempt material shall be provided after deletion of the exempt portions; provided however, the Department of Public Safety shall not be required to assemble for the requesting person specific information, in any format, from driving records relating to any person whose name and date of birth or whose driver license number is not furnished by the requesting person.

8 The Oklahoma State Bureau of Investigation shall not be required 9 to assemble for the requesting person any criminal history records 10 relating to persons whose names, dates of birth, and other 11 identifying information required by the Oklahoma State Bureau of 12 Investigation pursuant to administrative rule are not furnished by 13 the requesting person;

14 Any request for a record which contains individual records 4. 15 of persons, and the cost of copying, reproducing or certifying each 16 individual record is otherwise prescribed by state law, the cost may 17 be assessed for each individual record, or portion thereof requested 18 as prescribed by state law. Otherwise, a public body may charge a 19 fee only for recovery of the reasonable, direct costs of record 20 copying, or mechanical reproduction. Notwithstanding any state or 21 local provision to the contrary, in no instance shall the record 22 copying fee exceed twenty-five cents (\$0.25) per page for records 23 having the dimensions of eight and one-half (8 1/2) by fourteen (14)24

1 inches or smaller, or a maximum of One Dollar (\$1.00) per copied 2 page for a certified copy. However, if the request: is solely for commercial purpose, or 3 a. 4 would clearly cause excessive disruption of the b. 5 essential functions of the public body, then the public body may charge a reasonable fee to recover the 6 7 direct cost of record search and copying; however, publication in a newspaper or broadcast by news media for news purposes shall not 8 9 constitute a resale or use of a record for trade or commercial purpose and charges for providing copies of electronic data to the 10 11 news media for a news purpose shall not exceed the direct cost of 12 making the copy. The fee charged by the Department of Public Safety 13 for a copy in a computerized format of a record of the Department 14 shall not exceed the direct cost of making the copy unless the fee 15 for the record is otherwise set by law.

Any public body establishing fees under this act shall post a written schedule of the fees at its principal office and with the county clerk.

In no case shall a search fee be charged when the release of records is in the public interest, including, but not limited to, release to the news media, scholars, authors and taxpayers seeking to determine whether those entrusted with the affairs of the government are honestly, faithfully, and competently performing their duties as public servants.

1 The fees shall not be used for the purpose of discouraging 2 requests for information or as obstacles to disclosure of requested 3 information;

5. The land description tract index of all recorded instruments
concerning real property required to be kept by the county clerk of
any county shall be available for inspection or copying in
accordance with the provisions of the Oklahoma Open Records Act;
provided, however, the index shall not be copied or mechanically
reproduced for the purpose of sale of the information;

10 A public body must provide prompt, reasonable access to its 6. 11 records but may establish reasonable procedures which protect the 12 integrity and organization of its records and to prevent excessive 13 disruptions of its essential functions. A delay in providing access 14 to records shall be limited solely to the time required for 15 preparing the requested documents and the avoidance of excessive 16 disruptions of the public body's essential functions. In no event 17 may production of a current request for records be unreasonably 18 delayed until after completion of a prior records request that will 19 take substantially longer than the current request. Any public body 20 which makes the requested records available on the Internet shall 21 meet the obligation of providing prompt, reasonable access to its 22 records as required by this paragraph; and

7. A public body shall designate certain persons who are
authorized to release records of the public body for inspection,

copying, or mechanical reproduction. At least one person shall be
 available at all times to release records during the regular
 business hours of the public body.

4 SECTION 3. AMENDATORY 51 O.S. 2021, Section 24A.17, is 5 amended to read as follows:

6 Section 24A.17 A. Any public official who willfully violates 7 any provision of the Oklahoma Open Records Act, upon conviction, 8 shall be guilty of a misdemeanor, and shall be punished by a fine 9 not exceeding Five Hundred Dollars (\$500.00) or by imprisonment in 10 the county jail for a period not exceeding one (1) year, or by both 11 such fine and imprisonment.

B. Any person <u>who requests and is</u> denied access to records of a public body or public official:

May bring a civil suit for declarative or injunctive relief,
 or both, but such civil suit shall be limited to records requested
 and denied prior to filing of the civil suit; and

17 2. If successful, shall be entitled to reasonable attorney18 fees.

19 <u>C. Prior to bringing a civil suit under subsection B, any</u> 20 <u>person seeking declaratory or injunctive relief, or both, must</u> 21 <u>notify the public body or public official of his or her intent to</u> 22 <u>bring a civil suit to obtain relief in writing ten (10) business</u> 23 <u>days prior to filing for such relief.</u>

1	C. D. If the public body or public official successfully
2	defends a civil suit and the court finds that the suit was clearly
3	frivolous, the public body or public official shall be entitled to
4	reasonable attorney fees.
5	$\frac{D}{D}$ E. A public body or public official shall not be civilly
6	liable for damages for providing access to records as allowed under
7	the Oklahoma Open Records Act.
8	SECTION 4. This act shall become effective November 1, 2024.
