D. Any person whose license or registration has been revoked by
the Electrical Hearing Board may apply for a new license one (1)
year from the date of such revocation.

Notwithstanding any other provision of law, a political 7 Ε. subdivision of this state that has adopted a nationally recognized 8 9 electrical code and appointed an inspector pursuant to the provisions of Section 1693 of this title or pursuant to the 10 provisions of the Oklahoma Inspectors Act for such work shall have 11 jurisdiction over the interpretation of the code and the 12 installation of all electrical work done in that political 13 subdivision, subject to the provisions of the Oklahoma Inspectors 14 Act. Provided, a state inspector may work directly with an 15 electrical contractor, journeyman electrician, electrical apprentice 16 or student electrical intern apprentice in such a locality if a 17 violation of the code creates an immediate threat to life or health. 18

In the case of a complaint about, investigation of or inspection of any license, registration, permit or electrical work in any political subdivision of this state which has not adopted a nationally recognized electrical code and appointed an inspector pursuant to the provisions of Section 1693 of this title or pursuant to the provisions of the Oklahoma Inspectors Act for such work, the

Construction Industries Board shall have jurisdiction over such
 matters.

No individual, business, company, corporation, 3 G. 1. association or other entity subject to the provisions of the 4 5 Electrical License Act shall install, modify or alter electrical facilities in any incorporated area of this state which has not 6 adopted a nationally recognized electrical code and appointed an 7 inspector pursuant to the provisions of Section 1693 of this title 8 9 or pursuant to the provisions of the Oklahoma Inspectors Act for such work without providing notice of such electrical work to the 10 Construction Industries Board. A notice form for reproduction by an 11 12 individual or entity required to make such notice shall be provided 13 by the Construction Industries Board upon request.

Notice to the Construction Industries Board pursuant to this
 subsection shall not be required for electrical maintenance or
 replacement of existing electrical appliances or fixtures or of any
 petroleum refinery or its research facilities.
