17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. AMENDATORY Section 4, Chapter 346, O.S.L.
19	2022 (68 O.S. Supp. 2022, Section 55009), is amended to read as
20	follows:
21	Section 55009. A. Upon the effective date of this act, there
22	is hereby created the Oklahoma Emission Reduction Technology Rebate
23	Program. There is hereby created a rebate in the amount of up to
24	twenty-five percent (25%) of documented expenditures made in this

state directly attributable to the implementation of a qualified
 Emission Reduction Project.

B. The rebate program shall be administered by the Department
of Environmental Quality and the Oklahoma Tax Commission, as
provided in the Oklahoma Emission Reduction Technology Incentive
Act.

C. To be eligible for a rebate payment:

8 1. The applicant responsible for the implementation of a 9 qualified Emission Reduction Project in this state shall submit 10 documentation to the Department of Environmental Quality no later 11 than six (6) months after the end of the fiscal year in which the 12 expenditures were made stating the amount of expenditures made in 13 this state directly related to the implementation of the qualified 14 Emission Reduction Project;

The applicant has filed all Oklahoma tax returns and tax
 documents which are required by the laws of this state; and

3. The applicant shall provide evidence of a certificate of general liability insurance with a minimum coverage of One Million Dollars (\$1,000,000.00) and a workers' compensation policy pursuant to the laws of this state which shall include coverage of employer's liability.

D. The Department of Environmental Quality shall approve or disapprove all claims for a rebate payment and shall notify the Oklahoma Tax Commission. The Tax Commission shall, upon

1 notification of approval from the Department of Environmental 2 Quality, issue a rebate payment for all approved claims from funds in the Oklahoma Emission Reduction Technology Incentive Revolving 3 Fund created in Section 5 of this act. Rebate payments from the 4 5 fund shall not exceed Ten Million Dollars (\$10,000,000.00) Twentyfive Million Dollars (\$25,000,000.00) in any fiscal year. If the 6 amount of approved claims exceeds the amount specified in this 7 subsection in a fiscal year, payments shall be made proportionately 8 9 to all of the parties making a claim prior to the deadline which is 10 approved by the Department of Environmental Quality with the amount to be paid to each approved party being product of the individual 11 12 claim amount times the percentage resulting from Ten Million Dollars (\$10,000,000.00) Twenty-five Million Dollars (\$25,000,000.00) 13 divided by the total amount of approved claims for the period. 14 Ιf an approved claim is not paid in whole or in part, the unpaid claim 15 or unpaid portion shall be paid in the following fiscal years in the 16

Approved claims for rebate that exceed the balance of the Oklahoma Emission Reduction Technology Incentive Revolving Fund created in Section 5 of this act Section 55010 of this title may be paid in part and the unpaid portion shall be paid upon the fund reaching a sufficient balance in the order in which the claims are approved by the Department.
