11	An Act relating to the Oklahoma Department of Agriculture, Food, and Forestry; creating the
12	Wildfire Reimbursement Revolving Fund; establishing purpose; providing for promulgation of rules to
13	administer the Fund; making an appropriation; providing for noncodification; providing for
14	codification; providing an effective date; and declaring an emergency.

17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 16-14 of Title 2, unless there
20	is created a duplication in numbering, reads as follows:
21	A. There is hereby created in the State Treasury a revolving
22	fund for the Oklahoma Department of Agriculture, Food, and Forestry
23	to be designated the "Wildfire Reimbursement Revolving Fund". The
24	fund shall be a continuing fund, not subject to fiscal year

- limitations, and shall consist of all monies designated to the fund
 by law. All monies accruing to the credit of the fund are hereby
 appropriated and may be budgeted and expended by the Oklahoma

 Department of Agriculture, Food, and Forestry for the purpose of
 reimbursement of expenditures of Oklahoma rural fire departments and
 the Oklahoma Forestry Service who participated in extinguishment
 efforts of fires that:
- 8 1. Were not fully extinguished in the twenty-four (24) hours 9 after their reporting; and

- 2. Involved more than one rural fire department jurisdiction.
- B. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.
- C. The Oklahoma Department of Agriculture, Food, and Forestry is authorized to promulgate rules for the administration of the Wildlife Reimbursement Fund.
- SECTION 2. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the Wildfire Reimbursement
Revolving Fund created in Section 1 of this act from any monies not
otherwise appropriated from the General Revenue Fund of the State
Treasury for the fiscal year ending June 30, 2024, the sum of Five
Million Dollars (\$5,000,000.00) or so much thereof as may be
