AMENDATORY 63 O.S. 2021, Section 2-402, as 16 amended by Section 3, State Question No. 780, Initiative Petition 17 No. 404, is amended to read as follows: 18 Section 2-402. A. 1. It shall be unlawful for any person 19 knowingly or intentionally to possess a controlled dangerous 20 substance unless such substance was obtained directly, or pursuant 21 to a valid prescription or order from a practitioner, while acting 22

in the course of his or her professional practice, or except as

- otherwise authorized by this act Section 2-101 et seq. of this title.
 - 2. It shall be unlawful for any person to purchase any preparation excepted from the provisions of the Uniform Controlled Dangerous Substances Act pursuant to Section 2-313 of this title in an amount or within a time interval other than that permitted by Section 2-313 of this title.
 - 3. It shall be unlawful for any person or business to sell, market, advertise or label any product containing ephedrine, its salts, optical isomers, or salts of optical isomers, for the indication of stimulation, mental alertness, weight loss, appetite control, muscle development, energy or other indication which is not approved by the pertinent federal OTC Final Monograph, Tentative Final Monograph, or FDA-approved new drug application or its legal equivalent. In determining compliance with this requirement, the following factors shall be considered:
 - a. the packaging of the product,
 - b. the name of the product, and
 - c. the distribution and promotion of the product, including verbal representations made at the point of sale.
 - B. $\underline{1.}$ Any person who violates this section is guilty of a misdemeanor punishable by confinement for not more than one (1) year and by a fine not exceeding One Thousand Dollars (\$1,000.00).

- 1 2. Any person who violates this section a second time within 2 ten (10) years, upon conviction, shall be guilty of a misdemeanor. The court may, with the consent of the defendant, order the 3 4 defendant to complete a substance abuse assessment and evaluation 5 and to complete a diversion program for up to one (1) year following the date of conviction in lieu of other punishments. At the 6 7 discretion of the court, the diversion program may include drug testing as a requirement. If the defendant refuses or fails to 8 9 complete the assessment and evaluation or diversion program, the court may impose punishment as provided for in paragraph 1 of this 10

Any person who violates this section a third time within ten 13 (10) years shall, upon conviction, be guilty of a misdemeanor punishable by a fine not exceeding One Thousand Dollars (\$1,000.00), 14 imprisonment in the county jail for a minimum of thirty (30) days, 15 or by both such fine and imprisonment. The court may, with the 16 17 consent of the defendant, order the defendant to complete a substance abuse assessment and evaluation and to complete a 18 diversion program for up to three (3) years following the date of 19 20 conviction. At the discretion of the court, the diversion program may include drug testing as a requirement. If the defendant refuses 21 or fails to complete the assessment and evaluation or diversion 22 program, the court may impose punishment as provided for in 23 paragraph 1 of this subsection. 24

- 1 Any person who violates this section a fourth time 4. a. within ten (10) years shall, upon conviction, be 2 quilty of a felony punishable by a fine not exceeding 3 Five Thousand Dollars (\$5,000.00), imprisonment in the 4 5 custody of the Department of Corrections for not less than one (1) year nor more than five (5) years, or by 6 both such fine and imprisonment. 7 Upon a verdict or plea of guilty or upon a plea of b. nolo contendere, but before a judgment of guilt of a violation of this paragraph, the court may, without 10
 - nolo contendere, but before a judgment of guilt of a violation of this paragraph, the court may, without entering a judgment of guilt and with the consent of the defendant, defer further proceedings upon the specific conditions prescribed by the court not to exceed a three-year period.
