6 An Act relating to State Veterans Homes; establishing  
7 State Veterans Home at Sallisaw; directing assumption  
8 of certain operations; amending 72 O.S. 2021, Section  
9 222, which relates to the Oklahoma Department of  
Veterans Affairs Revolving Fund; conforming and  
10 updating language; amending 72 O.S. 2021, Section  
229, as amended by Section 16, Chapter 83, O.S.L.  
2022 (72 O.S. Supp. 2023, Section 229), which relates  
11 to State Veterans Home at Talihina; directing  
transfer of operations upon certain date; removing  
12 obsolete language; modifying statutory reference;  
amending 72 O.S. 2021, Section 229.1, as amended by  
13 Section 17, Chapter 83, O.S.L. 2022 (72 O.S. Supp.  
2023, Section 229.1), which relates to authority to  
14 plan, develop, and construct Oklahoma veterans  
facilities; specifying facility to assume certain  
15 operations; modifying requirements for location of  
facilities; broadening allowed uses of certain  
16 proceeds; amending 72 O.S. 2021, Section 240, as  
amended by Section 18, Chapter 83, O.S.L. 2022 (72  
17 O.S. Supp. 2023, Section 240), which relates to petty  
cash funds; conforming language; providing for  
codification; and declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law to be codified  
22 in the Oklahoma Statutes as Section 229.2 of Title 72, unless there  
23 is created a duplication in numbering, reads as follows:  
24

1       A. There is hereby established, in addition to the other State  
2 Veterans Homes established under this title, the State Veterans Home  
3 at Sallisaw, Oklahoma, on the site determined by the Oklahoma  
4 Veterans Commission under subsections C and D of Section 229.1 of  
5 Title 72 of the Oklahoma Statutes.

6       B. The State Veterans Home at Sallisaw shall assume operations  
7 of the State Veterans Home at Talihina, Oklahoma, established under  
8 Section 229 of Title 72 of the Oklahoma Statutes, upon the date  
9 determined by the Commission under such section.

10       SECTION 2.       AMENDATORY       72 O.S. 2021, Section 222, is  
11 amended to read as follows:

12       Section 222. A. There is hereby created in the State Treasury  
13 a revolving fund for the Oklahoma Department of Veterans Affairs to  
14 be known as the ~~Oklahoma~~ "Oklahoma Department of Veterans Affairs  
15 Revolving ~~Fund~~ Fund". The revolving fund shall consist of all funds  
16 and monies received by the Oklahoma Department of Veterans Affairs,  
17 its constituent institutions, and/or, the Oklahoma Veterans  
18 Commission, from any gifts, contributions, bequests, individual  
19 reimbursements except as otherwise provided by law, and other  
20 sources of revenue, for the care or support of war veterans  
21 discharged other than under dishonorable conditions, who have been  
22 admitted and cared for at the Oklahoma Department of Veterans  
23 Affairs Centers, at Ardmore, Claremore, Clinton, Lawton/Ft. Sill,  
24 Norman, Sulphur or ~~Talihina~~ Sallisaw. Provided, no grants-in-aid,

1 reimbursements, or other revenue from the United States government  
2 or any instrumentality of the United States government shall be  
3 deposited in the fund. Provided further, nothing contained herein  
4 prohibits the establishment and utilization of special agency  
5 accounts by the Oklahoma Department of Veterans Affairs and its  
6 constituent institutions, as may be approved by the ~~Special Agency~~  
7 ~~Account Board~~ Director of the Office of Management and Enterprise  
8 Services, for receipt and disbursement of the personal funds of  
9 Veteran Center patients and members and/or for receipt and  
10 disbursement of charitable contributions and donations for use by  
11 and for patients and members.

12 B. The revolving fund herein created shall be used by the  
13 Oklahoma Department of Veterans Affairs to pay for the care of war  
14 veterans discharged other than under dishonorable conditions, in  
15 Veterans Centers, to pay the general operating expenses of the  
16 Veterans Centers, including the payment of salaries and wages of  
17 officials and employees, to pay for the employee safety programs and  
18 incentive awards provided for in Section 63.10a of this title, and  
19 to remodel, repair, construct, build additions, modernize, or add  
20 improvements of domiciliary or hospital buildings necessary for the  
21 care of veterans, including tuberculosis, mentally ill or  
22 neuropsychiatric patients, but not excluding others; and  
23 architectural plans, specifications, or other costs pertinent  
24 thereto.

1 C. The Oklahoma Department of Veterans Affairs may transfer  
2 monies from the revolving fund created in this section to the W.V.C.  
3 Revolving Fund in the State Treasury.

4 D. All expenditures from the revolving fund shall be made upon  
5 warrants issued by the State Treasurer based upon claims approved by  
6 the Oklahoma Department of Veterans Affairs, as provided by law, and  
7 filed with the Director of the Office of Management and Enterprise  
8 Services for approval and payment.

9 SECTION 3. AMENDATORY 72 O.S. 2021, Section 229, as  
10 amended by Section 16, Chapter 83, O.S.L. 2022 (72 O.S. Supp. 2023,  
11 Section 229), is amended to read as follows:

12 Section 229. A. Until operations are transferred pursuant to  
13 subsection B of this section, there is hereby established, in  
14 addition to the other State Veterans Homes established by ~~Sections~~  
15 ~~221 and 226 of this title~~, the State Veterans Home at Talihina,  
16 Oklahoma, on the site of the Oklahoma State Sanatorium, Talihina,  
17 Oklahoma. ~~All persons serving as employees of the Oklahoma State~~  
18 ~~Sanatorium under the provisions of the State Merit System of~~  
19 ~~Personnel Administration shall continue to serve as employees of the~~  
20 ~~State Veterans Home at Talihina, provided that such employees remain~~  
21 ~~in the classified service. All employees hired by the State~~  
22 ~~Veterans Home at Talihina on or after July 1, 1975, shall be under~~  
23 ~~the Oklahoma Merit System of Personnel Administration, except one~~  
24 ~~manager, one principal assistant or deputy, one private secretary,~~

~~part-time physicians and other professional personnel engaged in clinical and consultant services. The average number of full-time equivalent employees utilized in the total operation of the State Veterans Home, Talihina, shall not exceed one hundred fifty-three (153) during the fiscal year ending June 30, 1976. The buildings, equipment and land under the jurisdiction of the Oklahoma State Sanatorium, Talihina, are hereby transferred to the State Veterans Home, Talihina.~~

B. Upon a date to be determined by the Oklahoma Veterans Commission, operations of the State Veterans Home at Talihina established under this section shall be transferred to the State Veterans Home at Sallisaw, Oklahoma, established under Section 1 of this act.

SECTION 4. AMENDATORY 72 O.S. 2021, Section 229.1, as amended by Section 17, Chapter 83, O.S.L. 2022 (72 O.S. Supp. 2023, Section 229.1), is amended to read as follows:

Section 229.1. A. The Oklahoma Department of Veterans Affairs is authorized to plan, develop and construct two long-term care facilities for the following purposes:

1. To assume the operations of the State Veterans Home established in Talihina pursuant to Section 229 of this title. In accordance with Section 229 of this title and Section 1 of this act, the facility to assume operations of the State Veterans Home at

1 Talihina shall be the State Veterans Home at Sallisaw, Oklahoma,  
2 established under Section 1 of this act; and

3 2. To replace the State Veterans Home established in Ardmore  
4 pursuant to Section 221 of this title.

5 B. For the two long-term care facilities authorized in  
6 subsection A of this section, the Department may construct new  
7 facilities or refurbish any existing facilities on property  
8 currently owned by this state or on property purchased or donated  
9 from other sources including but not limited to private owners,  
10 tribal entities or other governmental or municipal entities.

11 C. 1. ~~The location of the facility referenced in paragraph 1~~  
12 ~~of subsection A of this section shall be subject only to such~~  
13 ~~geographical constraints as are imposed by the United States~~  
14 ~~Department of Veterans Affairs to preserve and continue recognition~~  
15 ~~and certification of the facility as a State Veterans Home located~~  
16 within or near the corporate limits of the City of Sallisaw.

17 2. The facility referenced in paragraph 2 of subsection A of  
18 this section shall be located within the corporate limits of the  
19 ~~city~~ City of Ardmore or within five (5) miles of the corporate  
20 limits of the ~~city~~ City of Ardmore.

21 D. The locations and sites of the two facilities referenced in  
22 subsection A of this section shall be determined by the Oklahoma  
23 Veterans Commission, subject to such geographical constraints as are  
24 imposed by the United States Department of Veterans Affairs for

1 certification as a State Veterans Home. The Oklahoma Veterans  
2 Commission may consider any and all criteria which, in its sole  
3 discretion, further the interests of Oklahoma veterans.

4 E. The project constituting the construction of the  
5 replacement, long-term care facility for the Ardmore Veterans Home  
6 shall be exempt from the requirements of Sections 9030 through  
7 9030.8 of Title 74 of the Oklahoma Statutes.

8 F. The proceeds received from the sale of the State Veterans  
9 Home in Talihina, along with all associated real and personal  
10 property, shall belong to the Oklahoma Department of Veterans  
11 Affairs and shall be used for any one or more of the following  
12 purposes:

13 1. To purchase land upon which the replacement, long-term care  
14 facility for the Ardmore Veterans Home will be located;

15 2. To purchase any other personal property needed for the  
16 construction and furnishing of the replacement, long-term care  
17 facility for the Ardmore Veterans Home; ~~and~~

18 3. To fund operations of the State Veterans Home at Sallisaw;  
19 and

20 4. To complete the state match for a grant offered under the  
21 State Veterans Home Construction Grant Program of the United States  
22 Department of Veterans Affairs.

1       SECTION 5.       AMENDATORY       72 O.S. 2021, Section 240, as  
2 amended by Section 18, Chapter 83, O.S.L. 2022 (72 O.S. Supp. 2023,  
3 Section 240), is amended to read as follows:

4       Section 240. There is hereby created a petty cash fund at the  
5 Oklahoma Department of Veterans Affairs, at the State Veterans Home,  
6 Ardmore, Oklahoma, at the State Veterans Home, Clinton, Oklahoma, at  
7 the State Veterans Home, Sulphur, Oklahoma, at the State Veterans  
8 Home, ~~Talihina~~ Sallisaw, Oklahoma, at the State Veterans Home,  
9 Norman, Oklahoma, at the State Veterans Home, Claremore, Oklahoma,  
10 and at the State Veterans Home, Lawton/Ft. Sill, Oklahoma. The  
11 Director of the Office of Management and Enterprise Services and the  
12 Director of the Oklahoma Department of Veterans Affairs are  
13 authorized to fix the maximum amount of these petty cash funds and  
14 the Director of the Office of Management and Enterprise Services  
15 shall prescribe the rules and procedures for the administration of  
16 these petty cash funds.

17       SECTION 6. It being immediately necessary for the preservation  
18 of the public peace, health or safety, an emergency is hereby  
19 declared to exist, by reason whereof this act shall take effect and  
20 be in full force from and after its passage and approval.
