12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:						
13	SECTION 1. AMENDATORY 63 O.S. 2021, Section 1-103a.1, is						
14	amended to read as follows:						
15	Section 1-103a.1. A. To assist and advise the State						
16	Commissioner of Health and the State Department of Health, there are						
17	hereby created:						
18	1. The Consumer Protection Licensing Advisory Council;						
19	2. The Trauma and Emergency Response Advisory Council;						
20	3. The Infant and Children's Health Advisory Council;						
21	4. The Advancement of Wellness Advisory Council; and						
22	5. The Home Care, Hospice and Palliative Care Advisory Council.						
23	B. 1. Except for the Home Care, Hospice and Palliative Care						
24	Advisory Council and the Advancement of Wellness Advisory Council,						

1 each Public Health Advisory Council (Advisory Council) created pursuant to subsection A of this section shall consist of seven (7) 2 Two members shall be appointed by the Governor, two 3 members. members shall be appointed by the Speaker of the House of 4 5 Representatives, two members shall be appointed by the President Pro Tempore of the Senate, and one member shall be appointed by the 6 Commissioner. Appointments shall be for three-year terms. 7 Members of the Advisory Councils shall serve at the pleasure of and may be 9 removed from office by the appointing authority. Members shall continue to serve until their successors are appointed. Any vacancy 10 shall be filled in the same manner as the original appointments. 11 12 Four members shall constitute a quorum.

- The Home Care, Hospice and Palliative Care Advisory Council shall consist of nine (9) members. Two members shall be appointed by the Governor, three members shall be appointed by the Speaker of the House of Representatives, three members shall be appointed by the President Pro Tempore of the Senate and one member shall be appointed by the Commissioner. Five members shall constitute a quorum.
- 3. The Advancement of Wellness Advisory Council shall consist of ten (10) members. Three members shall be appointed by the Governor, three members shall be appointed by the President Pro 22 Tempore of the Senate, three members shall be appointed by the Speaker of the House of Representatives, and one member shall be

- 4. Each Advisory Council shall meet at least twice a year, but no more than four times a year and shall elect a chair, a vice-chair vice chair, and a secretary from among its members. Each Advisory Council shall only meet as required for election of officers, establishment of meeting dates and times; rule development, review, and recommendation; and adoption of nonbinding resolutions to the Department or the Commissioner concerning matters brought before the Advisory Council. Special meetings may be called by the chair or by the concurrence of any three members.
- C. 1. All members of the Consumer Protection Licensing

 Advisory Council shall be knowledgeable of certain consumer issues

 as specified below. The Consumer Protection Licensing Advisory

 Council shall be composed as follows:
 - a. the Governor shall appoint:
 - (1) one member who is a licensed radiologist assistant, and
 - (2) one member who is a licensed audiologist,
 - b. the President Pro Tempore of the Senate shall appoint:
 - (1) one member who is a licensed radiologist, and
 - (2) one member representing the hearing-aid-fitting industry,

1 the Speaker of the House of Representatives shall 2 appoint: one member representing the medical 3 (1)micropigmentation industry, and 4 5 (2) one member representing the hearing-impaired public, and 6 d. the Commissioner shall appoint one member representing 7 a diagnostic x-ray facility. 8 9 2. The jurisdiction areas of the Consumer Protection Licensing Advisory Council shall include the hearing-aid-fitting industry, the 10 medical micropigmentation industry, the radiation industry, and such 11 other areas as designated by the Commissioner. 12 13 D. 1. All members of the Trauma and Emergency Response Advisory Council shall be knowledgeable of issues that arise in a 14 hospital setting and issues that arise concerning emergency 15 response. The Trauma and Emergency Response Advisory Council shall 16 17 be composed as follows: the Governor shall appoint: 18 (1) one member who is an administrative director of a 19 licensed ambulance service, and 20 (2) one member who is a Board Certified Emergency 21 Physician board-certified emergency physician, 22 the President Pro Tempore of the Senate shall appoint: b. 23

1 (1)one member who is a representative from a 2 hospital with trauma and emergency services, and one member who is a trauma surgeon with 3 (2) privileges at a hospital with trauma and 4 5 emergency operative services, the Speaker of the House of Representatives shall 6 c. appoint: 7 one member representing the trauma registrar of a 8 9 licensed hospital that is classified as providing trauma and emergency operative services, and 10 one member who is an Emergency Medical Technician 11 (2) 12 emergency medical technician, and 13 d. the Commissioner shall appoint one member who is a critical care nurse. 14 The jurisdictional areas of the Trauma and Emergency 15 Response Advisory Council shall include emergency response systems 16 17 development, injury prevention, catastrophic health emergency, trauma systems improvement and development and such other areas 18 designated by the Commissioner. 19 20 Ε. All members of the Infant and Children's Health Advisory Council shall be knowledgeable of issues that arise in the area of 21 infant and children's health care. The Infant and Children's Health 22 Advisory Council shall be composed as follows: 23

the Governor shall appoint:

a.

1		(1) one member who works for the state or for a

3		(2) one member who is knowledgeable about childhood
4		immunizations,
5	b.	the President Pro Tempore of the Senate shall appoint:

17		physician and works as a pediatrician, and
18		(2) one member who is licensed by the state as a

20	d.	the Commissioner shall appoint one member who is a
21		physician licensed by the state who specializes in the
22		diagnosis and treatment of childhood injuries in a
23		trauma setting.

- 2. The jurisdictional areas of the Infant and Children's Health
 Advisory Council shall include all issues that arise in the area of
 health care for infants and children and such other areas as
 designated by the Commissioner.

 F. 1. All members of the Advancement of Wellness Advisory
 - F. 1. All members of the Advancement of Wellness Advisory

 Council shall be knowledgeable of issues that arise in the area of

 advancing the health of all Oklahomans. The Advancement of Wellness

 Advisory Council shall be composed as follows:
 - a. the Governor shall appoint:
 - (1) one member who is knowledgeable about breast and cervical cancer issues, and
 - (2) one member who is knowledgeable about organ donor issues, and
 - (3) one member who is knowledgeable about

 cardiometabolic disease including obesity,

 dyslipidemia, hypertension, and diabetes,
 - b. the President Pro Tempore of the Senate shall appoint:
 - (1) one member who is mayor of a city or town that has been designated a certified healthy community in an urban setting, and
 - (2) one member who is the president or chief operating officer of a business that has been designated a certified healthy business, and

 - G. 1. All members of the Home Care, Hospice and Palliative
 Care Advisory Council shall be knowledgeable of issues that arise in
 the administration and practice of home care, hospice and palliative
 care services. The Home Care, Hospice and Palliative Care Advisory
 Council shall be composed as follows:
 - a. the Governor shall appoint:
 - (1) one member who is the owner or administrator of an entity licensed in accordance with the Oklahoma Hospice Licensing Act, and
 - (2) one member who is an owner or administrator of an entity licensed in accordance with the Oklahoma

 Home Care Act,
 - b. the President Pro Tempore of the Senate shall appoint:
 - (1) one member who is an owner or administrator of an entity licensed in accordance with the Oklahoma

 Hospice Licensing Act,
 - (2) one member who is an owner or administrator of an entity licensed in accordance with the Oklahoma

 Home Care Act, and

1 (3) one member who is a member of the palliative care 2 patient advocacy community, the Speaker of the House of Representatives shall 3 C. appoint: 4 5 one member representing the public who is or was a legal guardian of a recipient of hospice 6 services, 7 (2) one member representing the public who is a 9 recipient or legal guardian of a recipient of services from a home health agency, and 10 one member who is an allopathic or osteopathic 11 (3) physician or nurse certified in palliative care 12 delivery in this state, and 13 d. the Commissioner shall appoint one member representing 14 an association which advocates on behalf of home care 15 or hospice issues. 16 2. The jurisdictional areas of the Home Care, Hospice and 17 Palliative Care Advisory Council shall include all issues that arise 18 in the areas of home care, hospice services and palliative care, 19 including, but not limited to: 20 identifying methods that improve the quality and 21 delivery of home care, hospice and palliative care, 22 reviewing best practices from home care, hospice and b. 23

palliative care programs in the state,

- c. developing information on home care, hospice and palliative care issues for the general public, and
 - d. such other areas as designated by the Commissioner.
 - H. In addition to other powers and duties assigned to each Advisory Council pursuant to this section, each Advisory Council, within its jurisdictional area, shall:
 - 1. Have authority to recommend to the Commissioner rules on behalf of the Department. The Department shall not have standing to recommend to the Commissioner permanent rules or changes to such rules within the jurisdiction of an Advisory Council which have not been submitted previously to the appropriate Advisory Council for action;
 - 2. Before recommending any permanent rules to the Commissioner, give public notice, offer an opportunity for public comment and conduct a public rulemaking hearing when required by the Administrative Procedures Act;
 - 3. Have the authority to make nonbinding written recommendations to the Commissioner or to the Department which have been concurred upon by at least a majority of the membership of the Advisory Council;
- 4. Have the authority to provide a public forum for the discussion of issues it considers relevant to its area of jurisdiction, and to:

- 1 a. pass nonbinding resolutions expressing the sense of the Advisory Council, and
 - b. make recommendations to the Commissioner or the Department concerning the need and the desirability of conducting meetings, workshops, and seminars; and
 - 5. Cooperate with each other Advisory Council, the public, the Commissioner, and the Commissioner of Health in order to coordinate the rules within their respective jurisdictional areas and to achieve maximum efficiency and effectiveness in furthering the objectives of the Department.
 - I. The Advisory Councils shall not recommend rules for promulgation by the Commissioner unless all applicable requirements of the Administrative Procedures Act have been followed, including but not limited to notice, rule-impact statement, and rulemaking hearings.
 - J. Members of the Advisory Councils shall serve without compensation. The Advisory Councils are authorized to utilize the conference rooms of the Department and obtain administrative assistance from the Department, as required.
- 20 SECTION 2. This act shall become effective November 1, 2024.
