13	SECTION 1. AMENDATORY 62 O.S. 2021, Section 155, as

15	Section 155), is amended to read as follows:
16	Section 155. A. There is hereby created in the State Treasury
17	a revolving fund for each of the following state boards,

  - B. Each revolving fund shall consist of all monies received by the boards, commissions, and departments, pursuant to statutory authority, but not including appropriated funds. These revolving funds shall be continuing funds, not subject to fiscal year limitations, and shall be under the control and management of the administrative authorities of the respective boards, commissions, or departments.
- C. Expenditures from the revolving funds shall be made pursuant 15 to the laws of the state and the statutes relating to the boards, 16 17 commissions, and departments, and without legislative appropriation. Warrants for expenditures from the revolving funds shall be drawn by 18 the State Treasurer, based on claims signed by an authorized 19 employee or employees of the respective boards, commissions, or 20 departments and approved for payment by the Director of the Office 21 of Management and Enterprise Services. 22
- 23 SECTION 2. AMENDATORY 62 O.S. 2021, Section 203, is 24 amended to read as follows:

- Section 203. A. Except as otherwise provided by subsection B
  of this section, all monies that may come into the State Treasury,
  pursuant to the provisions of Section 201 et seq. of this title,
  together with all amounts that may be received by the State
  Treasurer as investment income or as interest on average daily bank
  balances, including investment income or interest on deposits from
  funds deposited to the credit of the Constitutional Reserve Fund
  created pursuant to Section 23 of Article X of the Oklahoma
