- 3 SECTION 10. NEW LAW A new section of law to be codified 4 in the Oklahoma Statutes as Section 1698.440 of Title 69, unless 5 there is created a duplication in numbering, reads as follows:
 - The bridge on U.S. Highway 70 crossing over Bokchito Creek in Bryan County shall be designated as the "Spc. Jaykob Ray Pruitt Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.
 - SECTION 11. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.441 of Title 69, unless there is created a duplication in numbering, reads as follows:
 - The section of U.S. Highway 69 beginning at E2000 Road in Bryan County extending northeasterly to the intersection of South Caddo Highway in Atoka County shall be designated as the "Captain Jeff Sewell Memorial Highway". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the highway.
 - SECTION 12. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.442 of Title 69, unless there is created a duplication in numbering, reads as follows:
