The section of Interstate 35 beginning on the south side of the State Highway 32 interchange extending north approximately seven (7) miles to the north side of the Oswalt Road interchange in Love County shall be designated as the "First MCPON Delbert D. Black, U.S. Navy, Memorial Highway". The Department of Transportation shall cause suitable markers bearing that name to be placed on the highway.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.400 of Title 69, unless there is created a duplication in numbering, reads as follows:

The intersection of U.S. Highway 60 and State Highway 18 north of Fairfax in Osage County shall be designated as the "Captain William 'Willy' Hargraves Memorial Intersection". The Department of Transportation shall cause suitable markers bearing that name to be placed at the intersection.

The bridge crossing over Polecat Creek on U.S. Highway 75A south of Sapulpa in Creek County shall be designated as the "Trooper Larry L. Hillyard Memorial Bridge". The Department of Transportation
