1 ENGROSSED SENATE CONCURRENT RESOLUTION NO. 1x By: McCortney of the Senate 3 and Echols of the House 4 5 A Concurrent Resolution relating to adjournment of 6 the Legislature for a period in excess of three days; and providing reciprocal consent of the Oklahoma 7 State Senate and the Oklahoma House of Representatives to adjournment for a period of time 8 in excess of three days for the duration of the 1st 9 Extraordinary Session of the 59th Oklahoma Legislature. 10 11 12 WHEREAS, the Oklahoma Constitution requires the consent of the two chambers of the Legislature to be adjourned for a period of time 13 in excess of three (3) days; and 14 WHEREAS, it is foreseeable that either the Oklahoma State Senate 15 or the Oklahoma House of Representatives or both chambers of the 16 Legislature may need to adjourn for a period of time of more than 17 three (3) days between the current point of the 1st Extraordinary 18 Session of the 59th Oklahoma Legislature and the sine die 19 adjournment of such session; and 20 WHEREAS, in the interest of time and to avoid potential 21 difficulty in obtaining the required assent pursuant to the 22 provisions of the Oklahoma Constitution it is reasonable for the 23

Legislature to provide a continuing permission for either chamber or

1 both chambers to be adjourned for a period of time in excess of 2 three (3) days.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST EXTRAORDINARY SESSION OF THE 59TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma State Senate grants its consent to the Oklahoma House of Representatives, and the Oklahoma House of Representatives grants its consent to the Oklahoma State Senate, to be adjourned for more than three (3) days from the date of adoption of this measure by the chambers or the date as of which the measure is acted upon by the second chamber to consider it, whichever date last occurs.

THAT the ongoing mutual consent to adjournment for a period of time in excess of three (3) days as provided by this measure shall continue until this measure is either superseded by other action taken by the Oklahoma Legislature or until the sine die adjournment of the 1st Extraordinary Session of the 59th Oklahoma Legislature, whichever event first occurs.
