AMENDATORY 59 O.S. 2021, Section 46.4, is 13 amended to read as follows: 14 Section 46.4 There is hereby re-created, to continue until July 15 1, 2023 2026, in accordance with the provisions of the Oklahoma 16 Sunset Law, a board to be known as the "Board of Governors of the 17 Licensed Architects, Landscape Architects and Registered Commercial 18 Interior Designers of Oklahoma", hereinafter referred to as the 19 Board. The Board shall be composed of eleven (11) members including 20 six persons who are duly licensed to practice architecture and are 21 in good standing in this state, two persons who are duly licensed to 22 practice landscape architecture and are in good standing in this 23 state, two persons who are registered commercial interior designers 24 and who are active and in good standing and one lay member. Each

1 member of the Board shall be a qualified elector of this state, and the architect, landscape architect and registered commercial 2 interior designer members shall have had five (5) years' licensing 3 4 or registration experience as the professional position requires in 5 this state. Re-creation of the Board shall not alter existing staggered terms. Board members, other than the lay member, shall be 6 7 appointed for a period of five (5) years thereafter; provided, that nothing herein shall affect the tenure of office of anyone who is a 8 9 member of the Board on May 31, 1957. A member may be reappointed to 10 succeed such membership. The licensed architect, landscape 11 architect or the registered commercial interior designer members may 12 be appointed by the Governor from a list of nominees submitted by 13 respective professional societies of this state. Membership in a 14 professional society shall not be a prerequisite to appointment to 15 the Board. The lay member of the Board shall be appointed by the 16 Governor to a term coterminous with that of the Governor. The lay 17 member shall serve at the pleasure of the Governor. Provided, the 18 lay member may continue to serve after the expiration of the term of 19 the member until such time as a successor is appointed. Vacancies 20 which may occur in the membership of the Board shall be filled by 21 appointment by the Governor. Each person who has been appointed to 22 fill a vacancy shall serve for the remainder of the term for which 23 the member the person shall succeed was appointed and until a 24 successor, in turn, has been appointed and shall have qualified.

1	Each member of the Board, before entering upon the discharge of the
2	duties of the member, shall make and file with the Secretary of
3	State a written oath or affirmation for the faithful discharge of
4	official duties. Each member of the Board and staff shall be
5	reimbursed for travel expenses pursuant to the State Travel
6	Reimbursement Act.
