B. LCF Recapitalization Payments shall be made by Oklahoma
State University related to the distribution of proceeds provided in
subsection A of this act, in accordance with the provisions of the
Legacy Capital Financing Act.

7 C. The Authority may distribute funds authorized pursuant to8 subsection A in one or more tranches.

9 D. The Authority may enter memoranda of understanding with 10 agencies, departments, and subdivisions of the state as needed, to 11 facilitate the provisions of this act, provided that such memoranda 12 of understanding do not constitute a legal obligation of the State 13 of Oklahoma or impede the administration of the provisions of the 14 Legacy Capital Financing Act.

SECTION 2. This act shall become effective July 1, 2024.
SECTION 3. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby
declared to exist, by reason whereof this act shall take effect and
be in full force from and after its passage and approval.
