23	hunting license for upland winged game, excluding wild turkeys, to

The fees for a five-day paper license issued pursuant to 4 5 this section shall be: 6 1. For residents, Five Dollars (\$5.00); 7 2. For nonresidents, Five Dollars (\$5.00). 8 D. The Oklahoma Wildlife Conservation Commission shall have authority to promulgate and enforce rules governing the issuance and 9 10 enforcement of such five-day paper licenses issued pursuant to this section. 11 12 SECTION 2.
