FLOOR SUBSTITUTE

An Act relating to memorial highway and bridge designations; designating the Army SPC Ryan J. Grady Memorial Highway; designating the First MCPON Delbert D. Black, U.S. Navy, Memorial Highway; designating the Captain William "Willy" Hargraves Memorial Intersection; designating the Trooper Larry L. Hillyard Memorial Bridge; designating the C.D. Scribner WWII Veteran Memorial Highway; designating the LCpl Nelson Matlock Memorial Highway; amending Section 20, Chapter 356, O.S.L. 2022 (69 O.S. Supp. 2022, Section 1698.383), which relates to the William Mark Miller Memorial Highway; modifying location; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.398 of Title 69, unless there is created a duplication in numbering, reads as follows:

1 The section of State Highway 66 beginning at the intersection of
2 Country Club Road on the southwest edge of Bristow extending
3 northeasterly to the intersection of West 3rd Avenue in Creek County
4 shall be designated as the "Army SPC Ryan J. Grady Memorial
5 Highway". The Department of Transportation shall cause suitable
6 markers bearing that name to be placed on the highway.

7 SECTION 2. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.399 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The section of Interstate 35 beginning on the south side of the
11 State Highway 32 interchange extending north approximately seven (7)
12 miles to the north side of the Oswalt Road interchange in Love
13 County shall be designated as the "First MCPON Delbert D. Black,
14 U.S. Navy, Memorial Highway". The Department of Transportation
15 shall cause suitable markers bearing that name to be placed on the
16 highway.

17 SECTION 3. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.400 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The intersection of U.S. Highway 60 and State Highway 18 north
21 of Fairfax in Osage County shall be designated as the "Captain
22 William 'Willy' Hargraves Memorial Intersection". The Department of
23 Transportation shall cause suitable markers bearing that name to be
24 placed at the intersection.

1 SECTION 4. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.401 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge crossing over Polecat Creek on U.S. Highway 75A south
5 of Sapulpa in Creek County shall be designated as the "Trooper Larry
6 L. Hillyard Memorial Bridge". The Department of Transportation
7 shall cause suitable permanent markers bearing that name to be
8 placed on the bridge.

9 SECTION 5. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.402 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The section of State Highway 48A beginning at the intersection
13 of Hollow Springs Road, extending east to the intersection of SH-48
14 in Coleman in Johnston County shall be designated as the "C.D.
15 Scribner WWII Veteran Memorial Highway". The Department of
16 Transportation shall cause suitable permanent markers bearing that
17 name to be placed on the highway.

18 SECTION 6. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.403 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The section of State Highway 66 beginning at the intersection of
22 Flynn Avenue in Depew extending east to the intersection of South
23 433rd W Avenue in Creek County shall be designated as the "LCpl
24 Nelson Matlock Memorial Highway". The Department of Transportation

1 shall cause suitable permanent markers bearing that name to be
2 placed on the highway.

3 SECTION 7. AMENDATORY Section 20, Chapter 356, O.S.L.
4 2022 (69 O.S. Supp. 2022, Section 1698.383), is amended to read as
5 follows:

6 Section 1698.383. The section of Interstate 44 beginning one-
7 half (0.5) mile ~~north~~ south of State Highway 36 interchange
8 extending ~~south~~ north to U.S. Highway 70 interchange in Cotton
9 County shall be designated as the "William Mark Miller Memorial
10 Highway". The Department of Transportation shall cause suitable
11 permanent markers bearing that name to be placed on the highway.

12 SECTION 8. This act shall become effective November 1, 2023.
