21	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:							
22	SECTION 1. NEW LAW A new section of law to be codified							
23	in the Oklahoma Statutes as Section 567.5b of 59, unless there is							
24	created a duplication in numbering, reads as follows:

A. The Oklahoma Board of Nursing, the State Board of Medical Licensure and Supervision, and the State Board of Osteopathic Examiners shall collaborate to promulgate a uniform set of rules:

- 1. Governing supervision requirements of an Advanced Practice Registered Nurse; and
- 2. That impose a reasonable limit on the monetary amount that a supervising physician may charge an Advanced Practice Registered

  Nurse for supervision. Nothing in this paragraph shall be construed to require a supervising physician to charge a fee for supervision.
- B. The Oklahoma Board of Nursing, the State Board of Medical Licensure and Supervision, and the State Board of Osteopathic Examiners may collaborate to promulgate a uniform set of rules imposing a reasonable limit on the number of Advanced Practice Registered Nurses that a physician may supervise; provided, however, such rules shall allow a physician to seek a waiver to exceed this limit for such purposes as may be determined by the Boards in the uniform set of rules.
- C. The State Board of Medical Licensure and Supervision and the State Board of Osteopathic Examiners shall make available, and keep updated, in a conspicuous location on the Internet website of each Board a list of physicians who are available to supervise Advanced Practice Registered Nurses. The Boards shall develop procedures necessary for the implementation of this section.
