3       Section 13.1. Persons convicted of:

4       1. First degree murder as defined in Section 701.7 of this  
5       title;

6       2. Second degree murder as defined by Section 701.8 of this  
7       title;

8       3. Manslaughter in the first degree as defined by Section 711  
9       of this title;

10      4. Poisoning with intent to kill as defined by Section 651 of  
11      this title;

12      5. Shooting with intent to kill, use of a vehicle to  
13      facilitate use of a firearm, crossbow or other weapon, assault,  
14      battery, or assault and battery with a deadly weapon or by other  
15      means likely to produce death or great bodily harm, as provided for  
16      in Section 652 of this title;

33 shall be required to serve not less than eighty-five percent (85%)  
34 of any sentence of imprisonment imposed by the judicial system  
35 prior to becoming eligible for consideration for parole. Persons  
36 convicted of these offenses shall not be eligible for earned  
37 credits or any other type of credits which have the effect of  
38 reducing the length of the sentence to less than eighty-five  
39 percent (85%) of the sentence imposed."
