BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 3 O.S. 2021, Section 85, as amended by Section 5, Chapter 126, O.S.L. 2023 (3 O.S. Supp. 2023, Section 85), is amended to read as follows:

1 Section 85. A. The Oklahoma Department of Aerospace and
2 Aeronautics and its Director acting under its authority is empowered
3 and directed to encourage, foster, and assist in the development of
4 aerospace and aeronautics in this state and to encourage the
5 establishment of airports and air navigation facilities. It shall
6 cooperate with and assist the federal government, the municipalities
7 of this state, and other persons in the development of aerospace and
8 aeronautics, and shall seek to coordinate the aeronautical
9 activities of these bodies and persons. Municipalities are
10 authorized to cooperate with the Department in the development of
11 aeronautics and aeronautical facilities in this state.

12 B. The Department may organize and administer ~~a voluntary~~
13 ~~program of air-age education~~ an aerospace and aviation education
14 program in cooperation with the schools, colleges, and for the
15 general public, and may prepare and conduct voluntary flight clinics
16 for airmen and issue such bulletins and publications as may be
17 required. This program shall be known and may be cited as the
18 "AeroSPACE Program" or "Aero Student Pathways for Aerospace Careers
19 and Education". This program shall be a partnership with primary,
20 secondary, career technology, and higher education providers to
21 respond to the workforce needs of the aviation and aerospace
22 industry by promoting and organizing quality curriculum, enhanced
23 classroom instruction, and research-based educational programs. The
24 AeroSPACE Program shall collaborate with industry and act as the

facilitator for the collection and sharing of information,
development and implementation of activities, and the dissemination
of resources concerning aerospace education with the primary goal
being to establish a common statewide strategy for implementing
aerospace educational curriculum initiatives to better prepare
students for an aviation and aerospace career. The Oklahoma
Aeronautics Commission may employ established program processes or
contract with other qualified entities to operate the AeroSPACE
Program. The Oklahoma Aeronautics Commission may accept funding that
includes, but is not limited to, donations, contractual
arrangements, in-kind services, federal or state appropriations, and
grants.

C. The Department shall assist in all aeronautical matters related to emergency management actions in conformance with federal directions and with the Emergency Operations Plan of the state.

D. The Department may establish air markers throughout the state.

E. The Department may purchase and install roadside signs directing highway traffic to airports, subject to approval of the State Transportation Commission.

F. The Department shall:

1. Draft and recommend necessary legislation to advance the interests of the state in aerospace and aeronautics;

1 2. Represent the state in aeronautical matters before federal
2 agencies and other state agencies; and

3 3. Participate as party plaintiff or defendant or as intervener
4 on behalf of the state or any municipality or citizen thereof in any
5 proceeding which involves the interest of the state in aerospace or
6 aeronautics.

7 G. 1. The Department may, insofar as is reasonably possible,
8 make available its engineering and other technical services to any
9 municipality or person desiring them in connection with the
10 planning, acquisition, construction, improvement, maintenance, or
11 operation of airports or navigation facilities.

12 2. The Department may render financial assistance by grant or
13 loan or both to any municipality or municipalities acting jointly in
14 the planning, acquisition, construction, improvement, maintenance,
15 or operation of an airport owned or controlled, or to be owned or
16 controlled, by such municipality or municipalities, out of
17 appropriations or other monies made available by the Legislature for
18 such purposes. Such financial assistance may be furnished in
19 connection with federal or other financial aid for the same
20 purposes.

21 3. The Department shall be designated as the agent of this
22 state or political subdivision of this state for the purpose of
23 applying for, receiving, administering and disbursing federal funds
24 and other public monies for the benefit of general aviation

1 airports, except reliever airports, as may be available under
2 applicable federal law or other laws. If requested by a political
3 subdivision, the Department may act as its or their agent in
4 contracting for and supervising such planning, acquisition,
5 construction, improvement, maintenance, or operation; and all
6 political subdivisions are authorized to designate the Department as
7 their agent for the foregoing purposes. The Department, as
8 principal on behalf of the state, may enter into any contracts with
9 the United States or with any person, which may be required in
10 connection with a grant or loan of federal monies for municipal
11 airport or air navigation facility purposes. All federal monies
12 accepted under this section shall be accepted and transferred or
13 expended by the Department upon such terms and conditions as are
14 prescribed by the United States. All monies received by the
15 Department pursuant to this section shall be deposited in the
16 Oklahoma Department of Aerospace and Aeronautics Revolving Fund in
17 the State Treasury and shall be paid out by the Department in
18 accordance with the terms and conditions of any agreement entered
19 into under the provisions of this section.

20 H. 1. The Department is authorized on behalf of and in the
21 name of the state, out of appropriations and other monies made
22 available for such purposes, to plan, zone, establish, construct,
23 enlarge, improve, maintain, equip, operate, regulate, protect, and
24 police airports and air navigation facilities, either within or

1 without the state, including the construction, installation,
2 equipping, maintenance, and operation at such airports of buildings
3 and other facilities for the servicing of aircraft or for the
4 comfort and accommodation of air travelers. However, the regulatory
5 authority shall not extend to any airman employed by, nor to any
6 aeronautics facility or aircraft under the exclusive possession,
7 operation, or control of, a person holding a certificate of public
8 convenience and necessity issued by any agency of the United States
9 to operate as a common carrier by air of persons and/or property in
10 interstate commerce. For such purposes the Department may, by
11 purchase, gift, devise, or lease, acquire property, real or
12 personal, or any interest therein including easements in
13 aeronautical hazards or land outside the boundaries of an airport or
14 airport site, as are necessary to permit safe and efficient
15 operation of the state airports or to permit the removal,
16 elimination, obstruction-marking or obstruction-lighting of airport
17 hazards, or to prevent the establishment of airport hazards. In
18 like manner the Department may acquire existing airports and air
19 navigation facilities. However, the Department shall not acquire or
20 take over any airport or air navigation facility owned or controlled
21 by a municipality of this or any other state without the consent of
22 such municipality. The Department may, by sale, lease, or
23 otherwise, dispose of any such property, airport, air navigation
24 facility, or portion thereof or interest therein. The disposal, by

1 sale, lease, or otherwise, shall be in accordance with the laws of
2 this state governing the disposition of other property of the state,
3 except that, in the case of disposals to any municipality or state
4 government or the United States for aeronautical purposes incident
5 thereto, the sale, lease, or other disposal may be effected in such
6 manner and upon such terms as the Department may deem in the best
7 interest of the state.

8 2. All airports owned by the state shall be within the primary
9 jurisdiction of the Oklahoma Department of Aerospace and Aeronautics
10 for purposes of design, development, and operation; provided, that
11 airports owned and operated by the Oklahoma Space Industry
12 Development Authority shall be exempt from such provisions, and
13 during the time of a national emergency, the Air National Guard
14 shall be exempt from such provisions, and provided further, that any
15 airport owned by the state may be leased by the Department to a
16 public or private agency, as it may deem fit.

17 3. Nothing contained in the Oklahoma Department of Aerospace
18 and Aeronautics Act shall be construed to limit any right, power, or
19 authority of the state or a municipality to regulate airport hazards
20 by zoning.

21 4. The Department may exercise any powers granted by this
22 section jointly with any municipalities or with the United States.

23 5. a. In operating an airport or air navigation facility
24 owned or controlled by the state, the Department may

1 enter into contracts, leases, and other arrangements
2 for a term not exceeding twenty-five (25) years with
3 any persons granting the privilege of using or
4 improving such airport or air navigation facility or
5 any portion or facility thereof or space therein for
6 commercial purposes; conferring the privilege of
7 supplying goods, commodities, things, services, or
8 facilities at such airport or air navigation facility;
9 or making available services to be furnished by the
10 Department or its agents at such airport or air
11 navigation facility.

12 In each such case the Department may establish the
13 terms and conditions and fix the charges, rentals, or
14 fees for the privileges or services, which shall be
15 reasonable and uniform for the same class of
16 privileges or services and shall be established with
17 due regard to the property and improvements used and
18 the expenses of operation to the state; provided, that
19 in no case shall the public be deprived of its
20 rightful, equal, and uniform use of the airport, air
21 navigation facility or portion or facility thereof.

- 22 b. The Department may by contract, lease, or other
23 arrangement, upon a consideration fixed by it, grant
24 to any qualified person for a term not to exceed

1 twenty-five (25) years the privilege of operating, as
2 agent of the state or otherwise, any airport owned or
3 controlled by the state; provided, that no such person
4 shall be granted any authority to operate the airport
5 other than as a public airport or to enter into any
6 contracts, leases, or other arrangements in connection
7 with the operation of the airport which the Department
8 might not have undertaken under subparagraph a of this
9 paragraph.

10 c. To enforce the payment of any charges for repairs to,
11 or improvements, storage, or care of, any personal
12 property made or furnished by the Department or its
13 agents in connection with the operation of an airport
14 or air navigation facility owned or operated by the
15 state, the state shall have liens on such property,
16 which shall be enforceable by the Department as
17 provided by law.

18 6. In accepting federal monies under this section, the
19 Department shall have the same authority to enter into contracts on
20 behalf of the state as is granted to the Department under paragraph
21 3 of subsection G of this section with respect to federal monies
22 accepted on behalf of municipalities. All monies received by the
23 Department pursuant to this section shall be deposited in the
24 Oklahoma Department of Aerospace and Aeronautics Revolving Fund in

1 the State Treasury and shall be paid out of the Department Fund in
2 accordance with the terms and conditions of any agreement entered
3 into under the provisions of this section.

4 7. The Department shall grant no exclusive right for the use of
5 any airport or air navigation facility under its jurisdiction. This
6 shall not be construed to prevent the making of contracts, leases,
7 and other arrangements pursuant to paragraph 5 of this subsection.

8 I. The Department may enter into any contracts necessary to the
9 execution of the powers granted it by the Oklahoma Department of
10 Aerospace and Aeronautics Act. All contracts made by the
11 Department, either as the agent of the state or as the agent of any
12 municipality, shall be made pursuant to the laws of the state
13 governing the making of like contracts. When the planning,
14 acquisition, construction, improvement, maintenance, or operation of
15 any airport or air navigation facility is financed wholly or
16 partially with federal monies, the Department as agent of the state
17 or of any municipality may let contracts in the manner prescribed by
18 the federal authorities acting under the laws of the United States
19 and any rules or regulations made thereunder.

20 J. 1. The Commission, the Director, or any officer or employee
21 of the Department designated by it shall have the power to hold
22 investigations, inquiries, and hearings concerning matters covered
23 by the provisions of the Oklahoma Department of Aerospace and
24 Aeronautics Act and the rules, regulations, and orders of the

1 Department. Hearings shall be open to the public and shall be held
2 upon such call or notice as the Commission shall deem advisable.
3 Each member of the Commission, the Director, and every officer or
4 employee of the Department designated by it to hold any inquiry,
5 investigation, or hearing shall have the power to administer oaths
6 and affirmations, certify to all official acts, issue subpoenas, and
7 order the attendance and testimony of witnesses and the production
8 of papers, books, and documents. In case of the failure of any
9 person to comply with any subpoena or order issued under the
10 authority of this subsection, or on the refusal of any witness to
11 testify to any matters regarding which he may be lawfully
12 interrogated, it shall be the duty of the district court of any
13 county or of the judge thereof, on application of the Department or
14 its authorized representative, to compel obedience by proceedings
15 for contempt, as in the case of disobedience of the requirements of
16 a subpoena issued from such court or a refusal to testify therein.

17 2. In order to facilitate the making of investigations by the
18 Department in the interest of public safety and promotion of
19 aeronautics the public interest requires, and it is therefore
20 provided, that the reports of investigations or hearings, or any
21 part thereof, shall not be admitted in evidence or used for any
22 purpose in any suit, action, or proceeding growing out of any matter
23 referred to in the investigation, hearing, or report thereof, except
24 in case of any suit, action, or proceeding, civil or criminal,

1 instituted by or in behalf of the Department or in the name of the
2 state under the provisions of the Oklahoma Department of Aerospace
3 and Aeronautics Act or other laws of the state relating to
4 aeronautics; nor shall any member of the Commission, or the
5 Director, or any officer or employee of the Department be required
6 to testify to any facts ascertained in, or information gained by
7 reason of, such person's official capacity, or be required to
8 testify as an expert witness in any suit, action, or proceeding
9 involving any aircraft. Subject to the foregoing provisions, the
10 Department may in its discretion make available to appropriate
11 federal, state and municipal agencies information and material
12 developed in the course of its investigations and hearings.

13 K. 1. The Department is authorized to confer with or to hold
14 joint hearings with any agency of the United States in connection
15 with any matter arising under the Oklahoma Department of Aerospace
16 and Aeronautics Act or relating to the sound development of
17 aerospace and aeronautics.

18 2. The Department is authorized to avail itself of the
19 cooperation, services, records, and facilities of the agencies of
20 the United States as fully as may be practicable in the
21 administration and enforcement of the Oklahoma Department of
22 Aerospace and Aeronautics Act. The Department shall furnish to the
23 agencies of the United States its cooperation, services, records,
24 and facilities, insofar as may be practicable.

1 3. The Department shall report to the appropriate agency of the
2 United States all accidents in aeronautics in this state of which it
3 is informed and shall, insofar as is practicable, preserve, protect,
4 and prevent the removal of the component parts of any aircraft
5 involved in an accident being investigated by it until the federal
6 agency institutes an investigation.

7 L. The Department may organize and administer an aerospace
8 education program in cooperation with universities, colleges and
9 schools for the general public. The Department may also plan and
10 act jointly in a cooperative aviation research or high technology
11 program. As part of these programs, the Department may issue
12 aviation communication films and publications.

13 M. The Department shall administer an airport inspection
14 program for all public-use airports within this state. The
15 inspection program shall occur on a three-year cycle and shall be
16 administered by the Oklahoma Department of Aerospace and
17 Aeronautics. Airport owners, including individuals and
18 municipalities, shall provide access to airport facilities for
19 conducting the inspections. The Department shall provide a written
20 report to each public-use airport detailing the findings of such
21 inspections.

7 Section 339. A. The board of county commissioners shall have
8 power:

9 1. To make all orders respecting the real property of the
10 county, to sell the public grounds of the county and to purchase
11 other grounds in lieu thereof; and for the purpose of carrying out
12 the provisions of this section it shall be sufficient to convey all
13 the interests of the county in those grounds when an order made for
14 the sale and a deed is executed in the name of the county by the
15 chair of the board of county commissioners, reciting the order, and
16 signed by the chair and acknowledged by the county clerk for and on
17 behalf of the county;

18 2. To audit the accounts of all officers having the care,
19 management, collection or disbursement of any money belonging to the
20 county or appropriated for its benefit;

21 3. To construct and repair bridges and to open, lay out and
22 vacate highways; provided, however, that when any state institution,
23 school or department shall own, lease or otherwise control land on
24 both sides of any established highway, the governing board or body

1 of the same shall have the power to vacate, alter or relocate the
2 highway adjoining the property in the following manner:

3 If it should appear that it would be to the best use and
4 interest of the institution, school or department to vacate, alter
5 or relocate such highway, the governing board or body shall notify
6 the board of county commissioners, in writing, of their intention to
7 hold a public hearing and determine whether to vacate, alter or
8 relocate the highway, setting forth the location and terminals of
9 the road, and all data concerning the proposed right-of-way if
10 changed or relocated, and shall give fifteen (15) days' notice of
11 the hearing by publication in some newspaper in the county or
12 counties in which the road is located, and the hearing shall be held
13 at the county seat of the county in which the road is located, and
14 if a county line road, may be heard in either county. At the
15 hearing testimony may be taken, and any protests or suggestions
16 shall be received as to the proposed measure, and at the conclusion
17 thereof if the governing board or body shall find that it would be
18 to the best use and interest of the institution, school or
19 department, and the public generally, they may make an appropriate
20 order either vacating, altering or relocating the highway, which
21 order shall be final if approved by the board of county
22 commissioners. The institution, school or department may by
23 agreement share the cost of changing any such road. No property
24 owner shall be denied access to a public highway by the order;

1 4. To recommend or sponsor an employee or prospective employee
2 for job-related training and certification in an area that may
3 require training or certification to comply with state or federal
4 law as such training or certification is provided by the Department
5 of Transportation, the Federal Highway Administration, or any other
6 state agency, technology center school, or university;

7 5. To determine the years of service required for full-time
8 county employees to qualify for a continuing education program.
9 Such programs may consist of courses offered by colleges and
10 universities that are members of The Oklahoma State System of Higher
11 Education as well as any other in-state or out-of-state programs or
12 courses which are relevant to the employee's responsibilities as
13 approved by the county commissioners. Such programs shall require
14 that employees maintain at least an A or B average in order to
15 qualify for one hundred percent (100%) reimbursement. Employees who
16 maintain passing or satisfactory grades shall qualify for seventy-
17 five percent (75%) reimbursement under such programs. Such programs
18 shall require that documentation from colleges and universities
19 regarding courses completed, credits earned and tuition charged be
20 submitted to a board of county commissioners within ninety (90) days
21 after the completion of courses. General applications and request
22 forms for such programs shall be submitted to a board of county
23 commissioners or an appropriate human resources department prior to
24 the conclusion of a county's current fiscal year. Employees who

1 elect to participate in such programs shall continue to meet the
2 full responsibilities of their positions, and participation shall
3 not interfere with availability for scheduled work or negatively
4 affect work performance. In order to be eligible for participation
5 in such programs, employees shall not have been formally disciplined
6 within one (1) year prior to submitting their program application.
7 A board of county commissioners shall be authorized to establish a
8 program requiring a one-year commitment of service to the county
9 from individuals who participate in such programs. Under such
10 programs, employees shall only be eligible to receive tuition
11 reimbursements in exchange for employment with the county lasting at
12 least one (1) year;

13 6. Until January 1, 1983, to furnish necessary blank books,
14 plats, blanks and stationery for the clerk of the district court,
15 county clerk, register of deeds, county treasurer and county judge,
16 sheriff, county surveyor and county attorney, justices of the peace,
17 and constables, to be paid for out of the county treasury; also a
18 fireproof vault sufficient in which to keep all the books, records,
19 vouchers and papers pertaining to the business of the county;

20 7. To set off, organize and change the boundaries of townships
21 and to designate and give names therefor; provided, that the
22 boundaries of no township shall be changed within six (6) months
23 next preceding a general election;

1 8. To lease tools, apparatus, machinery or equipment of the
2 county to another political subdivision or a state agency. The
3 Association of County Commissioners of Oklahoma and the Oklahoma
4 State University Center for Local Government Technology together
5 shall establish a system of uniform rates for the leasing of such
6 tools, apparatus, machinery and equipment;

7 9. To jointly, with other counties, buy heavy equipment and to
8 loan or lease such equipment across county lines;

9 10. To develop personnel policies for the county with the
10 approval of a majority of all county elected officers, as evidenced
11 in the minutes of a meeting of the board of county commissioners or
12 the county budget board;

13 11. To purchase, rent, or lease-purchase uniforms, safety
14 devices and equipment for the officers and employees of the county.
15 The county commissioners may pay for any safety training or safety
16 devices and safety equipment out of the general county funds or any
17 county highway funds available to the county commissioners;

18 12. To provide incentive awards for safety-related job
19 performance. However, no employee shall be recognized more than
20 once per calendar year and the award shall not exceed the value of
21 Two Hundred Fifty Dollars (\$250.00); further, no elected official
22 shall be eligible to receive a safety award;

23 13. To provide for payment of notary commissions, filing fees,
24 and the cost of notary seals and bonds;

1 14. To do and perform other duties and acts that the board of
2 county commissioners may be required by law to do and perform;

3 15. To make purchases at a public auction pursuant to the
4 county purchasing procedures in subsection D of Section 1505 of this
5 title;

6 16. To deposit interest income from highway funds in the
7 general fund of the county;

8 17. To submit sealed bids for the purchase of equipment from
9 this state, or any agency or political subdivision of this state;

10 18. To utilize county-owned equipment, labor and supplies at
11 their disposal on property owned by the county, public schools, two-
12 year colleges or technical branches of colleges that are members of
13 The Oklahoma State System of Higher Education, the state and
14 municipalities according to the provisions of Section 36-113 of
15 Title 11 of the Oklahoma Statutes. Cooperative agreements may be
16 general in terms of routine maintenance or specific in terms of
17 construction and agreed to and renewed on an annual basis. Work
18 performed pursuant to Section 36-113 of Title 11 of the Oklahoma
19 Statutes shall comply with the provisions of this section;

20 19. To enter into intergovernmental cooperative agreements with
21 the federally recognized Indian tribes within this state to address
22 issues of construction and maintenance of streets, roads, bridges
23 and highways exclusive of the provisions of Section 1221 of Title 74
24 of the Oklahoma Statutes;

1 20. To execute hold harmless agreements with the lessor in the
2 manner provided by subsection B of Section 636.5 of Title 69 of the
3 Oklahoma Statutes when leasing or lease-purchasing equipment;

4 21. To accept donations of right-of-way or right-of-way
5 easements pursuant to Section 381 et seq. of Title 60 of the
6 Oklahoma Statutes;

7 22. To establish by resolution the use of per diem for specific
8 purposes in accordance with the limitations provided by Sections
9 500.8 and 500.9 of Title 74 of the Oklahoma Statutes;

10 23. To apply to the Department of Environmental Quality for a
11 waste tire permit to bale waste tires for use in approved
12 engineering projects;

13 24. To enter into the National Association of Counties (NACo)
14 Prescription Drug Discount Program;

15 25. To work with federal, state, municipal, and public school
16 district properties in an effort to minimize cost to such entities;

17 26. To provide incentive awards to employees for participating
18 in voluntary wellness programs which result in improved health.
19 Incentive awards may be created by the Wellness Council set forth in
20 Section 1302 of this title;

21 27. To establish a county employee benefit program to encourage
22 outstanding performance in the workplace. Monies may be expended
23 for the purchase of recognition awards for presentation to an
24 employee or members of a work unit. Recognition awards may be

1 presented at a formal or informal ceremony, banquet, reception or
2 luncheon, the cost of which may be expended from monies available in
3 the county department's or division's operating fund;

4 28. To trade in equipment to a vendor or on statewide contract
5 by acquiring used equipment values pursuant to subsection B of
6 Section 421.1 of this title; ~~and~~

7 29. To expend federal funds made available to a county of the
8 state through the federal Coronavirus Aid, Relief, and Economic
9 Security Act (CARES Act), Pub. L. 116-136, or similar relief funds
10 according to the permissible uses of the applicable federal
11 legislation or guidance issued by any federal agency thereof,
12 regardless of any lack of specific state statutory authorization to
13 perform the duties or functions for which the federal government has
14 provided the funds. The expenditure of the funds in accordance with
15 the federal legislation or guidance issued by any federal agency
16 thereof shall be at the discretion of the board of county
17 commissioners.

18 The receipt of funding through the CARES Act or similar relief
19 funds shall not be considered a supplemental appropriation and shall
20 be exempt from the requirements of Section 1420 of this title. In
21 the event the period allotted for expenditure of federal funds
22 crosses fiscal years, such funds shall not be considered revenue
23 when setting the county's budget for the next fiscal year; and

1 30. To enter into intergovernmental cooperative agreements
2 which shall include shared services, with local governmental units
3 within this state pursuant to the provisions of the Interlocal
4 Cooperation Act, Section 1002 et seq. of Title 74 of the Oklahoma
5 Statutes.

6 B. The county commissioners of a county or, in counties where
7 there is a county budget board, the county budget board may
8 designate money from general county funds for the designated purpose
9 of drug enforcement and drug abuse prevention programs within the
10 county.

11 C. When any lease or lease purchase is made on behalf of the
12 county by the board pursuant to the provisions of this section, the
13 county shall be allowed to have trade in values for transactions
14 involving the Oklahoma Central Purchasing Act.

15 D. In order to timely comply with the Oklahoma Vehicle License
16 and Registration Act with regard to county vehicles, the board of
17 county commissioners may, by resolution, create a petty cash
18 account. The board of county commissioners may request a purchase
19 order for petty cash in an amount necessary to pay the expense of
20 license and registration fees for county motor vehicles. Any
21 balance in the petty cash account after the license and registration
22 fees have been paid shall be returned to the account or fund from
23 which the funds originated. The county purchasing agent shall be
24

1 the custodian of the petty cash account, and the petty cash account
2 shall be subject to audit.

3 E. When the board of county commissioners approves an express
4 trust, pursuant to Sections 176 through 180.4 of Title 60 of the
5 Oklahoma Statutes, for the purpose of operating a county jail, the
6 trustees of the public trust may appoint commissioned peace
7 officers, certified by the Council on Law Enforcement Education and
8 Training, to provide security for inmates that are required to be
9 transported outside of the detention facility, and investigate
10 violations of law within the detention facility. Other personnel
11 necessary to operate the jail may be employed and trained or
12 certified as may be required by applicable state or federal law.

24 county jail not exceeding ninety (90) days, or by a fine of not more

1 than One Thousand Dollars (\$1,000.00), or by both such fine and
2 imprisonment.

3 C. Any person who commits any assault and battery against a
4 current or former intimate partner or a family or household member
5 as defined by Section 60.1 of Title 22 of the Oklahoma Statutes
6 shall be guilty of domestic abuse. Upon conviction, the defendant
7 shall be punished by imprisonment in the county jail for not more
8 than one (1) year, or by a fine not exceeding Five Thousand Dollars
9 (\$5,000.00), or by both such fine and imprisonment. Upon conviction
10 for a second or subsequent offense, the person shall be punished by
11 imprisonment in the custody of the Department of Corrections for not
12 more than four (4) years, or by a fine not exceeding Five Thousand
13 Dollars (\$5,000.00), or by both such fine and imprisonment. The
14 provisions of Section 51.1 of this title shall apply to any second
15 or subsequent offense.

16 D. 1. Any person who, with intent to do bodily harm and
17 without justifiable or excusable cause, commits any assault,
18 battery, or assault and battery upon an intimate partner or a family
19 or household member as defined by Section 60.1 of Title 22 of the
20 Oklahoma Statutes with any sharp or dangerous weapon, upon
21 conviction, is guilty of domestic assault or domestic assault and
22 battery with a dangerous weapon which shall be a felony and
23 punishable by imprisonment in the custody of the Department of
24 Corrections not exceeding ten (10) years, or by imprisonment in a

1 county jail not exceeding one (1) year. The provisions of Section
2 51.1 of this title shall apply to any second or subsequent
3 conviction for a violation of this paragraph.

4 2. Any person who, without such cause, shoots an intimate
5 partner or a family or household member as defined by Section 60.1
6 of Title 22 of the Oklahoma Statutes by means of any deadly weapon
7 that is likely to produce death shall, upon conviction, be guilty of
8 domestic assault and battery with a deadly weapon which shall be a
9 felony punishable by imprisonment in the custody of the Department
10 of Corrections not exceeding life. The provisions of Section 51.1
11 of this title shall apply to any second or subsequent conviction for
12 a violation of this paragraph.

13 E. 1. Any person convicted of domestic abuse committed against
14 a pregnant woman with knowledge of the pregnancy shall be guilty of
15 a felony, punishable by imprisonment in the custody of the
16 Department of Corrections for not more than five (5) years.

17 2. Any person convicted of a second or subsequent offense of
18 domestic abuse against a pregnant woman with knowledge of the
19 pregnancy shall be guilty of a felony, punishable by imprisonment in
20 the custody of the Department of Corrections for not less than ten
21 (10) years.

22 3. Any person convicted of domestic abuse committed against a
23 pregnant woman with knowledge of the pregnancy and a miscarriage
24 occurs or injury to the unborn child occurs shall be guilty of a

1 felony, punishable by imprisonment in the custody of the Department
2 of Corrections for not less than twenty (20) years.

3 F. Any person convicted of domestic abuse as defined in
4 subsection C of this section that results in great bodily injury to
5 the victim shall be guilty of a felony and punished by imprisonment
6 in the custody of the Department of Corrections for not more than
7 ten (10) years, or by imprisonment in the county jail for not more
8 than one (1) year. The provisions of Section 51.1 of this title
9 shall apply to any second or subsequent conviction of a violation of
10 this subsection.

11 G. Any person convicted of domestic abuse as defined in
12 subsection C of this section that was committed in the presence of a
13 child shall be punished by imprisonment in the county jail for not
14 less than six (6) months nor more than one (1) year, or by a fine
15 not exceeding Five Thousand Dollars (\$5,000.00), or by both such
16 fine and imprisonment. Any person convicted of a second or
17 subsequent domestic abuse as defined in subsection C of this section
18 that was committed in the presence of a child shall be punished by
19 imprisonment in the custody of the Department of Corrections for not
20 less than one (1) year nor more than five (5) years, or by a fine
21 not exceeding Seven Thousand Dollars (\$7,000.00), or by both such
22 fine and imprisonment. The provisions of Section 51.1 of this title
23 shall apply to any second or subsequent offense. For every
24 conviction of a domestic abuse crime in violation of any provision

1 of this section committed against an intimate partner or a family or
2 household member as defined by Section 60.1 of Title 22 of the
3 Oklahoma Statutes, the court shall:

4 1. Specifically order as a condition of a suspended or deferred
5 sentence that a defendant participate in counseling or undergo
6 treatment to bring about the cessation of domestic abuse as
7 specified in paragraph 2 of this subsection;

8 2. a. The court shall require the defendant to complete an
9 assessment and follow the recommendations of a
10 batterers' intervention program certified by the
11 Attorney General. If the defendant is ordered to
12 participate in a batterers' intervention program, the
13 order shall require the defendant to attend the
14 program for a minimum of fifty-two (52) weeks,
15 complete the program, and be evaluated before and
16 after attendance of the program by program staff.
17 Three unexcused absences in succession or seven
18 unexcused absences in a period of fifty-two (52) weeks
19 from any court-ordered batterers' intervention program
20 shall be prima facie evidence of the violation of the
21 conditions of probation for the district attorney to
22 seek acceleration or revocation of any probation
23 entered by the court.

1 b. A program for anger management, couples counseling, or
2 family and marital counseling shall not solely qualify
3 for the counseling or treatment requirement for
4 domestic abuse pursuant to this subsection. The
5 counseling may be ordered in addition to counseling
6 specifically for the treatment of domestic abuse or
7 per evaluation as set forth below. If, after
8 sufficient evaluation and attendance at required
9 counseling sessions, the domestic violence treatment
10 program or licensed professional determines that the

13 domestic violence and should complete other programs
14 of treatment simultaneously or prior to domestic

2 assure the attendance and compliance of the defendant
3 with the provisions of this subsection and the
4 domestic abuse counseling or treatment requirements.
5 The court may suspend sentencing of the defendant
6 until the defendant has presented proof to the court
7 of enrollment in a program of treatment for domestic
8 abuse by an individual licensed practitioner or a
9 domestic abuse treatment program certified by the
10 Attorney General and attendance at weekly sessions of
11 such program. Such proof shall be presented to the
12 court by the defendant no later than one hundred

3 b. The court shall set a second review hearing after the
4 completion of the counseling or treatment to assure
5 the attendance and compliance of the defendant with
6 the provisions of this subsection and the domestic
7 abuse counseling or treatment requirements. The court
8 shall retain continuing jurisdiction over the
9 defendant during the course of ordered counseling
10 through the final review hearing;

11 4. The court may set subsequent or other review hearings as the
12 court determines necessary to assure the defendant attends and fully
13 complies with the provisions of this subsection and the domestic
14 abuse counseling or treatment requirements;

15 5. At any review hearing, if the defendant is not
16 satisfactorily attending individual counseling or a domestic abuse

13 strangulation against an intimate partner or a family or household
14 member as defined by Section 60.1 of Title 22 of the Oklahoma
15 Statutes shall, upon conviction, be guilty of domestic abuse by
16 strangulation and shall be punished by imprisonment in the custody
17 of the Department of Corrections for a period of not less than one
18 (1) year nor more than three (3) years, or by a fine of not more
19 than Three Thousand Dollars (\$3,000.00), or by both such fine and
20 imprisonment. Upon a second or subsequent conviction for a
21 violation of this section, the defendant shall be punished by
22 imprisonment in the custody of the Department of Corrections for a

12 circumstances:

13 1. Where the victim is under sixteen (16) years of age;

14 2. Where the victim is incapable through mental illness or any
15 other unsoundness of mind, whether temporary or permanent, of giving
16 legal consent;

17 3. Where force or violence is used or threatened, accompanied
18 by apparent power of execution to the victim or to another person;

19 4. Where the victim is intoxicated by a narcotic or anesthetic
20 agent, administered by or with the privity of the accused as a means
21 of forcing the victim to submit;

22 5. Where the victim is at the time unconscious of the nature of
23 the act and this fact is known to the accused;

1 6. Where the victim submits to sexual intercourse under the
2 belief that the person committing the act is a spouse, and this
3 belief is induced by artifice, pretense, or concealment practiced by
4 the accused or by the accused in collusion with the spouse with
5 intent to induce that belief. In all cases of collusion between the
6 accused and the spouse to accomplish such act, both the spouse and
7 the accused, upon conviction, shall be deemed guilty of rape;

8 7. Where the victim is under the legal custody or supervision
9 of a state agency, a federal agency, a county, a municipality or a
10 political subdivision and engages in sexual intercourse with a
11 state, federal, county, municipal or political subdivision employee

11 purposes of this section, means faculty, adjunct faculty,
12 instructors, volunteers, or an employee of a business contracting
13 with an institution of higher education who may exercise, at any
14 time, institutional authority over the victim. Employee of an
15 institution of higher education shall not include an enrolled
16 student who is not more than three (3) years of age or older than
17 the concurrently enrolled student and who is employed or
18 volunteering, in any capacity, for the institution of higher
19 education.

19 Upon conviction for a second or subsequent violation, the person
20 shall be punished by imprisonment in the county jail for a term not
21 to exceed one (1) year, or by a fine not to exceed Two Thousand
22 Dollars (\$2,000.00), or by both such fine and imprisonment.

1 B. To the extent the provisions of Section A apply to medical
2 care providers, the protections provided herein shall not apply when
3 the incident is unrelated to the provider's professional duties.

4 is defined in Section 99 of this title;

5 ~~6.~~ 7. "Personally identifiable information" means information
6 which can identify an individual including, but not limited to,
7 name, birth date, place of birth, mother's maiden name, biometric
8 records, Social Security number, official state- or government-
9 issued driver license or identification number, government passport
10 number, employer or taxpayer identification number or any other
11 information that is linked or linkable to an individual, such as
12 medical, educational, financial or employment information;

13 ~~7.~~ 8. "Public official" means any person elected or appointed
14 to a state office in the executive, legislative, or judicial branch
15 of state government or other political subdivision of the state; and

16 ~~8.~~ 9. "Publish" means to circulate, deliver, distribute,
17 disseminate, transmit, or otherwise make available to another
18 person.

15 person and at least five (5) years have passed since the completion

16 ~~days preceding an election~~ after the deadline to request an absentee
17 ballot as provided in Section 14-103 of this title, is deployed as a
18 first responder or emergency worker to assist with the rescue,
19 recovery, or relief efforts of a declared natural disaster or state
20 of emergency, may make a written request for an emergency absentee
21 ballot in a form prescribed by the Secretary of the State Election
22 Board. The request shall be signed by the voter and shall be
23 provided by the voter to the secretary of the county election board
24 in the county where the voter is registered. Requirements for

1 matching of name, birth date, and identification number established
2 pursuant to Section 14-105 of this title shall apply to a request
3 for an absentee ballot under this section.

4 B. Upon receipt of the voter's request, the secretary of the
5 county election board shall issue to the voter the appropriate
6 ballots and envelopes required for voting an emergency absentee
7 ballot. Provided, the voter shall present proof of identity as
8 required by Section 7-114 of this title.

9 C. The ballots must be returned in person by the voter, by
10 United States mail, or by other means of delivery approved by the
11 Secretary of the State Election Board, to the secretary of the
12 county election board no later than 7:00 p.m. on the day of the
13 election.

14 D. Upon return of the absentee ballots, the secretary of the
15 county election board shall cause the ballots to be processed in the
16 same manner as is prescribed for other absentee ballots.

17 E. The Secretary of the State Election Board shall promulgate
18 rules to implement the procedures described in this section.

1 Section 2-6-103. A. The Department of Environmental Quality
2 shall have and is hereby authorized to exercise the power and duty
3 to:

4 1. Develop comprehensive programs for the prevention, control
5 and abatement of new or existing pollution of the waters of this
6 state;

7 2. Encourage, participate in, or conduct studies,
8 investigations, research and demonstrations relating to water
9 pollution and causes, prevention, control and abatement thereof as
10 it may deem advisable and necessary in the public interest for the
11 discharge of its duties under Section 2-6-101 et seq. of this title;

12 3. Collect and disseminate information relating to water
13 pollution and the prevention, control and abatement thereof;

14 4. Require the submission of and review plans, specifications
15 and other data relative to disposal or treatment systems or any part
16 thereof in connection with the issuance of such permits as are
17 required by this article;

18 5. Enforce the provisions of this article, rules promulgated
19 thereunder, and permits, licenses, and certifications issued
20 pursuant thereto and Oklahoma Water Quality Standards;

21 6. Establish, implement, amend and enforce the Water Quality
22 Management Plan, the continuing planning process documents, and
23 total maximum daily loads;

1 7. Require the submission of reports or laboratory analyses
2 performed by certified laboratories or operators for purposes of
3 compliance monitoring and testing or other purposes for which
4 laboratory reports or analyses are required pursuant to this
5 article;

6 8. Coordinate the preparation of the continuing planning
7 process documents and total maximum daily loads with other
8 environmental agencies and natural resource agencies; and

9 9. Issue swimming and fishing advisories related to human and
10 animal health hazards for waters of the state, based on available
11 data.

12 B. 1. The Environmental Quality Board shall have the authority
13 to promulgate such rules as may be necessary to implement the
14 policies and duties set forth in this article including, but not
15 limited to, rules pertaining to services, permits, licenses and
16 certifications including certifications under Section 401 of the
17 Clean Water Act, and, pursuant to Section 2-3-402 of this title, fee
18 schedules for such services, permits, licenses and certifications.

19 2. The Board may adopt by reference standards of quality of the
20 waters of the state and classifications of such waters as are
21 lawfully established by the Department of Environmental Quality and
22 the United States Environmental Protection Agency as Oklahoma Water
23 Quality Standards, may directly adopt variances and site-specific
24 criteria to such water quality standards, and promulgate other rules

1 to protect, maintain and improve the best uses of waters in this
2 state in the interest of the public under such conditions as may be
3 necessary or appropriate for the prevention, control and abatement
4 of pollution.

5 3. The Board shall promulgate rules which describe procedures
6 for amending and updating the Water Quality Management Plan or which
7 are otherwise consistent with the Continuing Planning Process and
8 its components. Such rules shall:

9 a. be in substantial conformance with any applicable
10 federal requirements and may incorporate appropriate
11 U.S. Environmental Protection Agency regulations by
12 reference, and

13 b. require public notice to be given of any major
14 amendment and of any update of the Water Quality
15 Management Plan and allow not less than a forty-five-
16 day opportunity for public comment thereon. Such
17 rules shall also authorize the Department, if it
18 determines public interest in the proposed amendment
19 or update is significant, to give notice of and
20 conduct a public meeting on the proposals in
21 accordance with federal requirements. The rules shall
22 provide that the notice, comment period, and public
23 meeting if any, related to an amendment or update
24 proposed in conjunction with the issuance,

1 modification or renewal of a discharge permit or
2 permits, may be combined with the notice, comment
3 period, and public meeting if any, held on the
4 proposed permit action or actions.

5 C. The Executive Director may:

6 1. Issue, modify, or revoke orders:

7 a. prohibiting or abating pollution of the waters of the
8 state,

9 b. requiring the construction of new disposal or
10 treatment systems or any parts thereof or the
11 modification, extension or alteration of existing
12 disposal or treatment systems or any part thereof, or
13 the adoption of other remedial measures to prevent,
14 control or abate pollution, and

15 c. requiring other actions such as the Executive Director
16 may deem necessary to enforce the provisions of this
17 article and rules promulgated thereunder;

18 2. Issue, continue in effect, revoke, amend, modify or deny,
19 renew, or refuse to renew under such conditions as the Department

Section 91. A. 1. a. This section applies to every vehicle, all-terrain vehicle, utility vehicle, manufactured home, motorcycle, boat, outboard motor, or trailer that has a certificate of title issued by ~~the Oklahoma Tax Commission~~ Service Oklahoma or by a federally recognized Indian tribe in the State of Oklahoma, except as otherwise provided in subsection D of this section. This section does not apply to farm equipment as defined in Section 91.2 of this title. The items of personal property to which this section applies are collectively referred to as "Section 91 Personal Property". If personal property is apparently covered both by this section and by Sections 191 through 200 of this title, the procedures set out in this section shall apply instead of Sections 191 through 200 of this title.

b. Salvage pools as defined in Section 591.2 of Title 47 of the Oklahoma Statutes and class AA licensed wrecker services taking possession of a vehicle pursuant to an agreement with or at the direction of, or dispatched by, a state or local law enforcement or government

1 agency, or pursuant to the abandoned vehicle renewal
2 provisions of Section 954A of Title 47 of the Oklahoma
3 Statutes, shall not be subject to the provisions of
4 this section, but shall be subject to the provisions
5 of Section 91A of this title. Unless otherwise
6 provided by this subparagraph, class AA licensed
7 wrecker services performing consensual tows shall be
8 subject to the provisions of this section.

9 2. Any person who, while lawfully in possession of an article
10 of Section 91 Personal Property, renders any service to the owner
11 thereof by furnishing storage, rental space, material, labor or
12 skill for the protection, improvement, safekeeping, towing, right to
13 occupy space, storage or carriage thereof, has a special lien
14 thereon, dependent on possession, for the compensation, if any,
15 which is due to such person from the owner for such service.

16 3. This special lien shall be subordinate to any perfected
17 security interest unless the claimant complies with the requirements
18 of this section. Failure to comply with any requirements of this
19 section shall result in denial of any title application and cause
20 the special lien to be subordinate to any perfected lien. Upon such
21 denial, the applicant shall be entitled to one resubmission of the
22 title application within fifteen (15) business days of receipt of
23 the denial, and proceed to comply with the requirements of this
24 section. In the event of a denial, the Notice of Possessory Lien

1 and the Notice of Sale may be mailed on the same day in separate
2 envelopes and storage charges shall only be charged from the date of
3 resubmission; however, before a Notice of Sale is to be mailed, the
4 personal property must have been possessed by the possessory lien
5 claimant for at least twenty-one (21) days. Furthermore, if the
6 denial was due to error by the party submitting the title
7 application, then no additional fee for the resubmission shall be
8 charged to the property owner. "Failure to comply" includes, but is
9 not limited to:

- 10 a. failure to timely provide additional documentation
11 supporting or verifying any entry on submitted forms
12 as requested by ~~the Tax Commission~~ Service Oklahoma,
13 including but not limited to United States Postal
14 Service proof of return receipt requested such as Form
15 3811 or United States Postal Service electronic
16 equivalent,
 - 17 b. failure to provide the documentation supporting lawful
18 possession as defined in paragraph 3 of subsection H
19 of this section,
 - 20 c. claimant or the agent being other than the individual
21 who provided the service giving rise to the special
22 lien, as in paragraph 2 of this subsection,
 - 23 d. claimant not being in possession of the vehicle,
- 24

- e. notice of lien not filed in accordance with paragraph 4 of this subsection, or
- f. foreclosure notification and proceedings not accomplished in accordance with paragraph 6 of this section.

4. Any person claiming the special lien provided in paragraph 2 of this subsection shall mail a notice of such lien, no later than sixty (60) days after the first services are rendered, by regular, first-class United States mail, and by certified mail, return receipt requested, to all interested parties who reside at separate locations. If services provided are pursuant to a contract primarily for the purpose of storage or rental of space, the beginning date of the sixty-day period provided in the previous sentence shall be the first day of the first period or partial period for which rental or storage charges remain unpaid. The notice shall be in writing and shall contain, but not be limited to, the following:

- a. a statement that the notice is a Notice of Possessory Lien,
- b. the complete legal name, physical and mailing address, and telephone number of the claimant,
- c. the complete legal name, physical and mailing address of the person who requested that the claimant render service to the owner by furnishing material, labor or

1 skill, storage, or rental space, or the date the
2 property was abandoned if the claimant did not render
3 any other service,

4 d. a description of the article of personal property,
5 including a photograph if the property is Section 91
6 Personal Property, and the complete physical and
7 mailing address of the location of the article of
8 personal property,

9 e. an itemized statement describing the date or dates the
10 labor or services were performed and material
11 furnished, and the charges claimed for each item, the
12 totals of which shall equal the total compensation
13 claimed,

14 f. a statement by the claimant that the materials, labor
15 or skill furnished, or arrangement for storage or
16 rental of space, was authorized by the owner of the
17 personal property and was in fact provided or
18 performed, and written proof of authority to perform
19 the work, labor or service, or that the property was
20 abandoned by the owner if the claimant did not render
21 any other service, and that storage or rental fees
22 will accrue as allowed by law, and

23 g. the signature of the claimant which shall be notarized
24 and, if applicable, the signature of the claimant's

1 attorney. If the claimant is a business, then the
2 name of the contact person representing the business
3 must be shown. In place of an original signature and
4 notary seal, a digital or electronic signature or seal
5 shall be accepted.

6 5. For services rendered or vehicles abandoned on or after
7 November 1, 2005, storage charges or charges for rental of space,
8 unless agreed to by contract as part of an overall transaction or
9 arrangement that was primarily for the purpose of storage of the
10 Section 91 Personal Property or rental of space, may only be
11 assessed beginning with the day that the Notice of Possessory Lien
12 is mailed as evidenced by certified mail. Provided, however, in the
13 case of contractual charges incurred for storage or rental of space
14 in an overall transaction primarily for the purpose of storage or
15 rental, charges subject to the special lien may only be assessed
16 beginning with a date not more than sixty (60) days prior to the day
17 that the Notice of Possessory Lien is mailed, and shall accrue only
18 at the regular periodic rate for storage or rental as provided in
19 the contract, adjusted for partial periods of storage or rental.
20 The maximum allowable compensation for storage shall not exceed the
21 fees established by the Corporation Commission for nonconsensual
22 tows.

1 6. The lien may be foreclosed by a sale of such personal
2 property upon the notice and in the manner following: The Notice of
3 Sale shall be in writing and shall contain, but not be limited to:

4 a. a statement that the notice is a Notice of Sale,

5 b. the names of all interested parties known to the
6 claimant,

7 c. a description of the property to be sold, including a
8 photograph if the property is Section 91 Personal
9 Property and if the condition of such property has
10 materially changed since the mailing of Notice of
11 Possessory Lien required pursuant to paragraph 4 of
12 this subsection,

13 d. a notarized statement of the nature of the work, labor
14 or service performed, material furnished, or storage
15 or rental of space, and the date thereof, and the name
16 of the person who authorized the work, labor or
17 service performed, or the storage or rental
18 arrangement, and written proof of authority to perform
19 the work, labor or service, or that the property was
20 abandoned if the claimant did not render any other
21 service,

22 e. the date, time, and exact physical location of sale,

23 f. the name, complete physical address, mailing address,
24 and telephone number of the party foreclosing such

1 lien. If the claimant is a business, then the name of
2 the contact person representing the business must be
3 shown. In place of an original signature and notary
4 seal, a digital or electronic signature or seal shall
5 be accepted, and

6 g. itemized charges which shall equal the total
7 compensation claimed.

8 7. Such Notice of Sale shall be posted in two public places in
9 the county where the property is to be sold at least ten (10) days
10 before the time therein specified for such sale, and a copy of the
11 notice shall be mailed to all interested parties at their last-known
12 post office address by regular, first-class United States mail and
13 by certified mail, return receipt requested, at least ten (10) days
14 before the date of the sale. If the item of personal property is a
15 manufactured home, notice shall also be sent by certified mail to
16 the county treasurer and to the county assessor of the county where
17 the manufactured home is located.

18 8. Interested parties shall include all owners of the article
19 of personal property as indicated by the certificate of title issued
20 by ~~the Tax Commission~~ Service Oklahoma or by a federally recognized
21 Indian tribe in the State of Oklahoma; lien debtors, if any, other
22 than the owners; any lienholder whose lien is noted on the face of
23 the certificate of title; and any other person having any interest
24

1 in the article of personal property, of whom the claimant has actual
2 notice.

3 9. Any interested party shall be permitted to inspect and
4 verify the services rendered by the claimant prior to the sale of
5 the article of personal property during normal business hours. The
6 lienholder shall be allowed to retrieve the Section 91 Personal
7 Property without being required to bring the title into the
8 lienholder's name, if the lienholder provides proof it is a
9 lienholder and any payment due the claimant for lawful charges where
10 the claimant has complied with the requirements of this section.
11 Upon the release of personal property to an insurer or
12 representative of the insurer, wrecker operators shall be exempt
13 from all liability and shall be held harmless for any losses or
14 claims of loss.

15 10. The claimant or any other person may in good faith become a
16 purchaser of the property sold.

17 11. Proceedings for foreclosure under this act shall be
18 commenced no sooner than ten (10) days and no later than thirty (30)

20 evidenced by certified mail. The date actually sold shall be within
21 sixty (60) days from the date of the Notice of Sale as evidenced by

23 B. 1. a. Any person who is induced by means of a check or other
24 form of written order for immediate payment of money

1 to deliver up possession of an article of personal
2 property on which the person has a special lien
3 created by subsection A of this section, which check
4 or other written order is dishonored, or is not paid
5 when presented, shall have a lien for the amount
6 thereof upon the personal property.

7 b. The person claiming such lien shall, within thirty
8 (30) days from the date of dishonor of the check or
9 other written order for payment of money, file in the
10 office of the county clerk of the county in which the
11 property is situated a sworn statement that:

12 (1) the check or other written order for immediate
13 payment of money, copy thereof being attached,
14 was received for labor, material or supplies for
15 producing or repairing an article of personal
16 property, or for other specific property-related
17 services covered by this section,

18 (2) the check or other written order was not paid,
19 and

20 (3) the uttering of the check or other written order
21 constituted the means for inducing the person,
22 one possessed of a special lien created by
23 subsection A of this section upon the described
24

1 article of personal property, to deliver up the
2 article of personal property.

3 2. a. Any person who renders service to the owner of an
4 article of personal property by furnishing storage,
5 rental space, material, labor, or skill for the
6 protection, improvement, safekeeping, towing, right to
7 occupy space, storage, or carriage thereof shall have
8 a special lien on such property pursuant to this
9 section if such property is removed from the person's
10 possession, without such person's written consent or
11 without payment for such service.

12 b. The person claiming such lien shall, within five (5)
13 days of such nonauthorized removal, file in the office
14 of the county clerk of the county in which the
15 property is located, a sworn statement including:

16 (1) that services were rendered on or in relation to
17 the article of personal property by the person
18 claiming such lien,

19 (2) that the property was in the possession of the
20 person claiming the lien but such property was
21 removed without his or her written consent,

22 (3) an identifying description of the article of
23 personal property on which the service was
24 rendered, and

1 (4) that the debt for the services rendered on or in
2 relation to the article of personal property was
3 not paid. Provided, if the unpaid total amount
4 of the debt for services rendered on or in
5 relation to the article of personal property is
6 unknown, an approximated amount of the debt due
7 and owing shall be included in the sworn
8 statement but such approximated debt may be
9 amended within thirty (30) days of such filing to
10 reflect the actual amount of the debt due and
11 owing.

12 3. The enforcement of the lien shall be within sixty (60) days
13 after filing the lien in the manner provided by law for enforcing
14 the lien of a security agreement and provided that the lien shall
15 not affect the rights of innocent, intervening purchasers without
16 notice.

17 C. If the person who renders service to the owner of an article
18 of personal property to which this section applies relinquishes or
19 loses possession of the article due to circumstances described in
20 subparagraph a of paragraph 1 or subparagraph a of paragraph 2 of
21 subsection B of this section, the person claiming the lien shall be
22 entitled to possession of the article until the amount due is paid,
23 unless the article is possessed by a person who became a bona fide
24

1 purchaser. Entitlement to possession shall be in accordance with
2 the following:

3 1. The claimant may take possession of an article pursuant to
4 this subsection only if the person obligated under the contract for
5 services has signed an acknowledgement of receipt of a notice that
6 the article may be subject to repossession. The notice and
7 acknowledgement pursuant to this subsection shall be:

8 a. in writing and separate from the written contract for
9 services, or

10 b. printed on the written contract for services, credit
11 agreement or other document which displays the notice
12 in bold-faced, capitalized and underlined type, or is
13 separated from surrounding written material so as to
14 be conspicuous with a separate signature line;

15 2. The claimant may require the person obligated under the
16 contract for services to pay the costs of repossession as a
17 condition for reclaiming the article only to the extent of the
18 reasonable fair market value of the services required to take
19 possession of the article;

20 3. The claimant shall not transfer to a third party or to a
21 person who performs repossession services, a check, money order, or
22 credit card transaction that is received as payment for services
23 with respect to an article and that is returned to the claimant
24 because of insufficient funds or no funds, because the person

1 writing the check, issuing the money order, or credit cardholder has
2 no account or because the check, money order, or credit card account
3 has been closed. A person violating this paragraph shall be guilty
4 of a misdemeanor; and

5 4. An article that is repossessed pursuant to this subsection
6 shall be promptly delivered to the location where the services were
7 performed. The article shall remain at the services location at all
8 times until the article is lawfully returned to the record owner or
9 a lienholder or is disposed of pursuant to this section.

10 D. 1. If a vehicle, all-terrain vehicle, utility vehicle,
11 manufactured home, motorcycle, boat, outboard motor, or trailer has
12 a certificate of title issued by ~~the Tax Commission~~ Service Oklahoma
13 or by a federally recognized Indian tribe in the State of Oklahoma,
14 but there is no active lien recorded on the certificate of title,
15 Section 91A of this title will apply instead of this section.
16 Likewise, if there is an active lien recorded on the certificate of
17 title but the lien is over fifteen (15) years old and the property
18 is not a manufactured home, Section 91A of this title will apply
19 instead of this section.

20 2. If personal property that otherwise would be covered by this
21 section has been registered by ~~the Tax Commission~~ Service Oklahoma
22 or by a federally recognized Indian tribe in the State of Oklahoma,
23 and there is a lien of record but no certificate of title has been
24

1 issued, Section 91A of this title will apply instead of this
2 section.

3 3. If personal property otherwise would be covered by this
4 section, but the services were rendered or the property was
5 abandoned prior to November 1, 2005, Section 91A of this title will
6 apply instead of this section.

7 E. A person who knowingly makes a false statement of a material
8 fact regarding the furnishing of storage, rental space, material,
9 labor or skill for the protection, improvement, safekeeping, towing,
10 right to occupy space, storage or carriage thereof in a proceeding
11 under this section, or attempts to use or uses the provisions of
12 this section to foreclose an owner or lienholder's interest in a
13 vehicle knowing that any of the statements made in the proceeding
14 are false, upon conviction, shall be guilty of a felony.

15 F. Upon receipt of notice of legal proceedings, ~~the Tax~~
16 ~~Commission~~ Service Oklahoma shall cause the sale process to be put
17 on hold until notice of resolution of court proceedings is received
18 from the court. If such notice of commencement of court proceedings
19 is not filed with ~~the Tax Commission~~ Service Oklahoma, the
20 possessory lien sale process may continue.

21 G. No possessory lien sale shall be held on a Sunday.

22 H. For purposes of this section:

23 1. "Possession" includes actual possession and constructive
24 possession;

1 2. "Constructive possession" means possession by a person who,
2 although not in actual possession, does not have an intention to
3 abandon property, knowingly has both power and the intention at a
4 given time to exercise dominion or control over the property, and
5 who holds claim to such thing by virtue of some legal right;

6 3. "Lawfully in possession" means a person has documentation
7 from the owner or the owner's authorized agent, or an insurance
8 company or its authorized agent, authorizing the furnishing of
9 material, labor or storage, or that the property was authorized to
10 be towed to a repair facility. If the person lacks such
11 documentation, he or she shall not be lawfully in possession of the
12 Section 91 Personal Property and shall not be entitled to a special
13 lien as set forth in this section; and

14 4. "Itemized charges" means total parts, total labor, total
15 towing fees, total storage fees, total processing fees and totals of
16 any other fee groups, the sum total of which shall equal the
17 compensation claimed.

18 I. For purposes of this section, the United States Postal
19 Service approved electronic equivalent of proof of return receipt
20 requested Form 3811 shall satisfy return receipt requested
21 documentation requirements.

22 J. If a person claiming a special lien pursuant to this section
23 fails to comply with any of the requirements of this section, any
24 interested party may proceed against the person claiming such lien

1 for all damages arising therefrom, including conversion, if the
2 article of personal property has been sold. If the notice or
3 notices required by this section shall be shown to be knowingly
4 false or fraudulent, the interested party shall be entitled to
5 treble damages. The prevailing party shall be entitled to all
6 costs, including reasonable attorney fees.

7 K. This section shall apply to all actions or proceedings that
8 commence on or after the effective date of this act.

16 A. 1. a. This section applies to all types of personal property
17 other than:

18 (1) farm equipment as defined in Section 91.2 of this
19 title, and

20 (2) "Section 91 Personal Property" as defined in
21 Section 91 of this title.

22 b. This section applies to any vehicle, all-terrain
23 vehicle, utility vehicle, manufactured home,
24 motorcycle, boat, outboard motor, or trailer that is

1 excluded from coverage under subsection A of Section
2 91 of this title because the personal property:

3 (1) does not have a certificate of title,

4 (2) has a certificate of title but does not have an
5 active lien recorded on the certificate of title,

6 (3) has a certificate of title that is not issued by

20 personal property without a certificate of title and

- 3 2. a. Any person who, while lawfully in possession of an
4 article of personal property to which this section
5 applies, renders any service to the owner thereof by
6 furnishing storage, rental space, material, labor or
7 skill for the protection, improvement, safekeeping,
8 towing, right to occupy space, storage or carriage
9 thereof, has a special lien thereon, dependent on
10 possession, for the compensation, if any, which is due
11 to such person from the owner for such service.
12 Charges owed under a contract primarily for the
13 purpose of storage or rental of space shall be accrued
14 only at the regular periodic rate for storage or
15 rental as provided in the contract, adjusted for
16 partial periods of storage or rental.
- 17 b. Except for Class AA licensed wrecker towing charges,
18 the special lien shall be subordinate to any perfected
19 security interest unless the claimant complies with
20 the requirements of this section. Failure to comply
21 with any requirements of this section shall result in
22 denial of any title application and cause the special
23 lien to be subordinate to any perfected lien. Upon
24 such denial, the applicant shall be entitled to one

1 resubmission of the title application within thirty
2 (30) business days of receipt of the denial, and
3 proceed to comply with the requirements of this
4 section. In the event of a denial, the Notice of
5 Possessory Lien and the Notice of Sale may be mailed
6 on the same day in separate envelopes and storage
7 charges shall only be charged from the date of
8 resubmission; however, before a Notice of Sale is to
9 be mailed, the personal property must have been
10 possessed by the possessory lien claimant for at least
11 twenty-one (21) days. Furthermore, if the denial was
12 due to error by the party submitting the title
13 application, then no additional fee for the
14 resubmission shall be charged to the property owner.
15 "Failure to comply" includes, but is not limited to:

9 c. Any person claiming a lien under this section shall
10 request, within five (5) business days of performing
11 any service or work on the property, ~~the Tax~~
12 ~~Commission~~ Service Oklahoma or other appropriate
13 license agency to furnish the name and address of the
14 current owner of and any lienholder upon the property.
15 ~~The Motor Vehicle Division of the Tax Commission~~
16 Service Oklahoma or an appropriate license agency
17 shall respond in person or by mail to the lien
18 claimant within ten (10) business days of the receipt
19 of the request for information. ~~The Tax Commission~~
20 Service Oklahoma shall render assistance to ascertain
21 ownership, if needed. The lien claimant shall send,
22 within seven (7) business days of receipt of the
23 requested information from ~~the Oklahoma Tax Commission~~
24 Service Oklahoma or other license agency, a notice of

1 the location of the property by certified mail with
2 return receipt requested, postage prepaid, to the
3 owner and any lienholder of the vehicle at the
4 addresses furnished. The lien claimant may charge
5 ~~Twenty Dollars (\$20.00)~~ not more than Fifty Dollars
6 (\$50.00) for processing plus the cost of postage if
7 the notice is timely sent pursuant to the requirements
8 of this subparagraph in addition to fees regulated by
9 the ~~Oklahoma~~ Corporation Commission for licensed
10 wreckers. If the lien claimant is unable to meet the
11 time requirements due to a lack of or an altered
12 vehicle identification number on the property, the
13 lien claimant shall proceed diligently to obtain the
14 proper vehicle identification number and shall meet
15 the time requirements on the notice once the vehicle
16 identification number is known. If the lien claimant
17 is required to send additional notices because of
18 change of ownership or lienholder after it has timely
19 complied with the requirements of this subparagraph,
20 the lien claimant shall remain in compliance if such
21 additional notices are sent within the required time
22 periods from the date of discovery of the new owners
23 or lienholders. The notice shall be in writing and
24 shall contain, but not be limited to, the following:

- (1) a statement that the notice is a Notice of Possessory Lien,
- (2) the complete legal name, physical and mailing address, and telephone number of the claimant,
- (3) the complete legal name, physical and mailing address of the person who requested that the claimant render service to the owner by furnishing material, labor or skill, storage, or rental space, or the date the property was abandoned if the claimant did not render any other service,
- (4) a description of the article of personal property, and the complete physical and mailing address of the location of the article of personal property,
- (5) the nature of the work, labor or service performed, material furnished, or the storage or rental arrangement, and the date thereof, and written proof of authority to perform the work, labor or service provided that, in the case of a law enforcement directed tow, the logbook entry prescribed in OAC 595:25-5-5 or the tow ticket as defined by the Corporation Commission shall serve as written proof of authority,

1 (6) the signature of the claimant which shall be
2 notarized and, if applicable, the signature of
3 the claimant's attorney. If the claimant is a
4 business, the name of the contact person
5 representing the business shall be shown. In
6 place of an original signature and notary seal, a
7 digital or electronic signature or seal shall be
8 accepted, and

9 (7) an itemized statement describing the date or
10 dates the labor or services were performed and
11 material furnished and the charges claimed for
12 each item, the totals of which shall equal the
13 total compensation claimed.

14 The lien claimant shall not be required to send the
15 notice required in this subparagraph if the property
16 is released to an interested party before the notice
17 is mailed and no additional charges or fees continue
18 to accrue. If a law enforcement agency has the
19 property towed to a law enforcement facility, the
20 person claiming a lien under this section shall not be
21 required to send notice until the property is released
22 by law enforcement to the claimant or the date which
23 claimant starts charging storage, whichever is
24 earlier. A lien claimant shall have an extension of

1 ten (10) business days to send the notice required in
2 this subparagraph if a state of emergency has been
3 declared in the county in which the property is
4 located.

5 d. Subparagraphs b and c of this paragraph shall not
6 apply to salvage pools as defined in Section 591.2 of
7 Title 47 of the Oklahoma Statutes.

8 3. The lien may be foreclosed by a sale of such personal
9 property upon the notice and in the manner following: The notice
10 shall be in writing and shall contain, but not be limited to:

11 a. the names of the owner and any other known party or
12 parties who may claim any interest in the property,

13 b. a description of the property to be sold, including a
14 visual inspection or a photograph if the property is a
15 motor vehicle, and the physical location of the
16 property,

17 c. the nature of the work, labor or service performed,
18 material furnished, or the storage or rental
19 arrangement, and the date thereof, and written proof
20 of authority to perform the work, labor or service
21 provided. In the case of a law enforcement directed

- 1 d. the time and place of sale,
- 2 e. the name, telephone number, physical address and
- 3 mailing address of the claimant, and agent or

- 6 person representing the business must be shown. In
- 7 place of an original signature and notary seal, a
- 8 digital or electronic signature or seal shall be
- 9 accepted, and
- 10 f. itemized charges which shall equal the total
- 11 compensation claimed.

- 12 4. a. Such Notice of Sale shall be posted in two public
- 13 places in the county where the property is to be sold
- 14 at least ten (10) days before the time therein
- 15 specified for such sale, and a copy of the notice
- 16 shall be mailed to the owner and any other party
- 17 claiming any interest in the property, if known, at
- 18 their last-known post office address, by certified
- 19 mail, return receipt requested, at least ten (10) days
- 20 before the time therein specified for such sale. If
- 21 the item of personal property is a manufactured home,
- 22 notice shall also be sent by certified mail to the
- 23 county treasurer and to the county assessor of the
- 24 county where the manufactured home is located.

1 b. In the case of any item of personal property without a
2 certificate of title and not required to be titled
3 under Oklahoma law, a party who claims any interest in
4 the property shall include all owners of the property;
5 any secured party who has an active financing
6 statement on file with the county clerk of Oklahoma
7 County listing one or more owners of the property by
8 legal name as debtors and indicating a collateral
9 description that would include the property; and any
10 other person having any interest in the personal
11 property, of whom the claimant has actual notice.

12 c. In the case of personal property subject to this
13 section for which a certificate of title has been
14 issued by any jurisdiction, a party who claims any
15 interest in the property shall include all owners of
16 the article of personal property as indicated by the
17 certificate of title; lien debtors, if any, other than
18 the owners; any lienholder whose lien is noted on the
19 face of the certificate of title; and any other person
20 having any interest in the article of personal
21 property, of whom the claimant has actual notice.

22 d. When the jurisdiction of titling for a vehicle, all-
23 terrain vehicle, motorcycle, boat, outboard motor, or
24 trailer that is five (5) model years old or newer, or

1 a manufactured home that is fifteen (15) model years
2 old or newer, cannot be determined by ordinary means,
3 the claimant, the agent of the claimant, or the
4 attorney of the claimant, shall request, in writing,
5 that ~~the Oklahoma Tax Commission Motor Vehicle~~
6 ~~Division~~ Service Oklahoma ascertain the jurisdiction
7 where the vehicle or manufactured home is titled. ~~The~~
8 ~~Oklahoma Tax Commission Motor Vehicle Division~~ Service
9 Oklahoma shall, within fourteen (14) days from the
10 date the request is received, provide information as
11 to the jurisdiction where the personal property is
12 titled. If ~~the Oklahoma Tax Commission Motor Vehicle~~
13 ~~Division~~ Service Oklahoma is unable to provide the
14 information, it shall provide notice that the record
15 is not available.

- 16 e. When personal property is of a type that Oklahoma law
17 requires to be titled, the owner of record of that
18 property is unknown, and the jurisdiction of titling
19 and owner of record cannot be determined by ordinary
20 means and also, if applicable, cannot be determined in
21 accordance with the preceding subparagraph, then the
22 special lien may be foreclosed by publication of a
23 legal notice in a legal newspaper in the county where
24 the personal property is located, as defined in

1 Section 106 of Title 25 of the Oklahoma Statutes.
2 Such notice shall include the description of the
3 property by year, make, vehicle identification number
4 if available from the property, the name of the
5 individual who may be contacted for information, and
6 the telephone number of that person or the address
7 where the vehicle is located. The legal notice shall
8 be published once per week for three (3) consecutive
9 weeks. As soon as circumstances exist as described in
10 the first sentence of this subparagraph, the first
11 date of publication may occur even if the special lien
12 has not accrued for over thirty (30) days. The first
13 date available for public sale of the vehicle is the
14 day following publication of the final notice, but no
15 fewer than thirty (30) days after the lien has
16 accrued. When the owner of record is unknown, the
17 Notice of Sale nevertheless must be completed and
18 mailed to any known interested party by certified
19 mail. For purposes of this paragraph, interested
20 parties shall include all persons described in
21 subparagraph b or subparagraph c of this paragraph,
22 whichever is applicable, with the exception of any
23 owner who is unknown. Except in circumstances
24 described in paragraph 7 of this subsection that

1 provide for a shorter time period, the Notice of Sale
2 shall be posted in two public places in the county
3 where the property is to be sold at least ten (10)
4 days before the time therein specified for such sale,
5 and the Notice of Sale shall not be mailed until at
6 least thirty (30) days after the lien has accrued.

7 5. The lienor or any other person may in good faith become a
8 purchaser of the property sold.

9 6. Proceedings for foreclosure under this act shall commence in
10 twenty (20) days after the lien has accrued, except as provided
11 elsewhere in Oklahoma law.

12 7. Notwithstanding any other provision of law, proceedings for
13 foreclosures for the storage of junk vehicles towed and stored
14 pursuant to Section 955 of Title 47 of the Oklahoma Statutes by
15 Class AA wreckers listed with the Motor Vehicle Division of the
16 Department of Public Safety, may be commenced five (5) days after
17 the lien has accrued. For purposes of this paragraph, "junk
18 vehicles" means any vehicle that is more than ten (10) years old if
19 the cost of a comparable vehicle would be less than Three Hundred
20 Dollars (\$300.00) as quoted in the latest edition of the National
21 Automobile Dealers Association Official Used Car Guide or latest
22 monthly edition of any other nationally recognized published
23 guidebook, adjusting to the condition of the vehicle.

1 B. 1. a. Any person who is induced by means of a check or other
2 form of written order for immediate payment of money
3 to deliver up possession of an article of personal
4 property on which the person has a special lien
5 created by subsection A of this section, which check
6 or other written order is dishonored, or is not paid
7 when presented, shall have a lien for the amount
8 thereof upon the personal property.

9 b. The person claiming such lien shall, within thirty
10 (30) days from the date of dishonor of the check or
11 other written order for payment of money, file in the
12 office of the county clerk of the county in which the
13 property is situated a sworn statement that:

14 (1) the check or other written order for immediate
15 payment of money, copy thereof being attached,
16 was received for labor, material or supplies for
17 producing or repairing an article of personal
18 property, or for other specific property-related

5 article of personal property by furnishing storage,
6 rental space, material, labor, or skill for the
7 protection, improvement, safekeeping, towing, right to
8 occupy space, storage, or carriage thereof shall have
9 a special lien on such property pursuant to this
10 section if such property is removed from the person's
11 possession, without such person's written consent or
12 without payment for such service.

13 b. The person claiming such lien shall, within five (5)
14 days of such nonauthorized removal, file in the office
15 of the county clerk of the county in which the
16 property is located, a sworn statement including:

17 (1) that services were rendered on or in relation to
18 the article of personal property by the person
19 claiming such lien,

20 (2) that the property was in the possession of the
21 person claiming the lien but such property was
22 removed without his or her written consent,
23
24

- 1 (3) an identifying description of the article of
2 personal property on or in relation to which the
3 service was rendered, and
4 (4) that the debt for the services rendered on or in
5 relation to the article of personal property was
6 not paid. Provided, if the unpaid total amount
7 of the debt for services rendered on or in
8 relation to the article of personal property is
9 unknown, an approximated amount of the debt due
10 and owing shall be included in the sworn
11 statement but such approximated debt may be
12 amended within thirty (30) days of such filing to
13 reflect the actual amount of the debt due and
14 owing.

15 3. The enforcement of the lien shall be within sixty (60) days
16 after filing the lien in the manner provided by law for enforcing
17 the lien of a security agreement and provided that the lien shall
18 not affect the rights of innocent, intervening purchasers without
19 notice.

20 C. If the person who renders service to the owner of an article
21 of personal property to which this section applies relinquishes or
22 loses possession of the article due to circumstances described in
23 subparagraph a of paragraph 1 or subparagraph a of paragraph 2 of
24 subsection B of this section, the person claiming the lien shall be

1 entitled to possession of the article until the amount due is paid,
2 unless the article is possessed by a person who became a bona fide
3 purchaser. Entitlement to possession shall be in accordance with
4 the following:

5 1. The claimant may take possession of an article pursuant to
6 this subsection only if the person obligated under the contract for
7 services has signed an acknowledgment of receipt of a notice that
8 the article may be subject to repossession. The notice and
9 acknowledgment pursuant to this subsection shall be:

- 10 a. in writing and separate from the written contract for
11 services, or
12 b. printed on the written contract for services, credit
13 agreement or other document which displays the notice
14 in bold-faced, capitalized and underlined type, or is
15 separated from surrounding written material so as to
16 be conspicuous with a separate signature line;

17 2. The claimant may require the person obligated under the
18 contract for services to pay the costs of repossession as a
19 condition for reclaiming the article only to the extent of the
20 reasonable fair market value of the services required to take
21 possession of the article;

22 3. The claimant shall not transfer to a third party or to a
23 person who performs repossession services, a check, money order, or
24 credit card transaction that is received as payment for services

1 with respect to an article and that is returned to the claimant
2 because of insufficient funds or no funds, because the person
3 writing the check, issuing the money order, or credit cardholder has
4 no account or because the check, money order, or credit card account
5 has been closed. A person violating this paragraph shall be guilty
6 of a misdemeanor; and

7 4. An article that is repossessed pursuant to this subsection
8 shall be promptly delivered to the location where the services were
9 performed. The article shall remain at the services location at all
10 times until the article is lawfully returned to the record owner or
11 a lienholder or is disposed of pursuant to this section.

12 D. 1. This section applies if a vehicle, all-terrain vehicle,
13 manufactured home, motorcycle, boat, outboard motor, or trailer has
14 a certificate of title issued by ~~the Tax Commission~~ Service Oklahoma
15 or by a federally recognized Indian tribe in Oklahoma, but there is
16 no active lien recorded on the certificate of title.

17 2. This section applies if a vehicle, all-terrain vehicle,
18 utility vehicle, motorcycle, boat, outboard motor or trailer has a
19 certificate of title issued by ~~the Tax Commission~~ Service Oklahoma
20 or by a federally recognized Indian tribe in Oklahoma, and there is
21 an active lien recorded on the certificate of title, but the lien is
22 over fifteen (15) years old.

23 3. This section applies if personal property to which Section
24 91 of this title otherwise would apply has been registered by ~~the~~

1 ~~Tax Commission~~ Service Oklahoma or by a federally recognized Indian
2 tribe in the State of Oklahoma, and there is a lien of record but no
3 certificate of title has been issued.

4 4. This section applies if personal property to which Section
5 91 of this title otherwise would apply has not been registered by
6 either ~~the Tax Commission~~ Service Oklahoma or a federally recognized
7 Indian tribe in the State of Oklahoma, and no certificate of title
8 has been issued, but there is a lien of record.

9 5. This section applies to personal property that otherwise
10 would be covered by Section 91 of this title, except that the
11 services were rendered or the property was abandoned prior to
12 November 1, 2005.

13 6. This section applies to a vehicle, all-terrain vehicle,
14 utility vehicle, manufactured home, motorcycle, boat, outboard
15 motor, or trailer for which ownership cannot be determined by
16 ordinary means or by ~~the Oklahoma Tax Commission~~ Service Oklahoma
17 Motor Vehicle Division, as provided in subparagraphs d and e of
18 paragraph 4 of subsection A of this section, as applicable.

19 7. This section applies to items of personal property that are
20 not required by Oklahoma law to be titled, and that do not have a
21 certificate of title.

22 8. This section applies to salvage pools as defined in Section
23 591.2 of Title 47 of the Oklahoma Statutes.

1 9. This section applies to class AA licensed wrecker services
2 taking possession of a vehicle pursuant to an agreement with, or at
3 the direction of, or dispatched by a state or local law enforcement
4 or government agency, or pursuant to the abandoned vehicle removal
5 provisions of Section 954A of Title 47 of the Oklahoma Statutes with
6 respect to all types of personal property, regardless of whether
7 that personal property has a certificate of title.

8 10. For a vehicle abandoned at a salvage pool, if the cost of
9 repairing the vehicle for safe operation on the highway does not
10 exceed sixty percent (60%) of the fair market value of the vehicle
11 as defined in Section 1111 of Title 47 of the Oklahoma Statutes, a
12 salvage title shall not be required.

13 E. A person who knowingly makes a false statement of a material
14 fact regarding the furnishing of storage, rental space, material,
15 labor or skill for the protection, improvement, safekeeping, towing,
16 right to occupy space, storage or carriage thereof in a proceeding
17 under this section, or attempts to use or uses the provisions of
18 this section to foreclose an owner or lienholder's interest in a
19 vehicle knowing that any of the statements made in the proceeding
20 are false, upon conviction, shall be guilty of a felony.

21 F. Upon receipt of notice of legal proceedings, ~~the Tax~~
22 ~~Commission~~ Service Oklahoma shall cause the sale process to be put
23 on hold until notice of resolution of court proceedings is received
24 from the court. If such notice of commencement of court proceedings

1 is not filed with ~~the Tax Commission~~ Service Oklahoma, the
2 possessory lien sale process may continue.

3 G. No possessory lien sale shall be held on a Sunday.

4 H. For purposes of this section:

5 1. "Possession" includes actual possession and constructive
6 possession;

7 2. "Constructive possession" means possession by a person who,
8 although not in actual possession, does not have an intention to
9 abandon property, knowingly has both power and the intention at a
10 given time to exercise dominion or control over the property, and
11 who holds claim to such thing by virtue of some legal right;

12 3. "Lawfully in possession" means a person has documentation
13 from the owner or the owner's authorized agent, or an insurance
14 company or its authorized agent, authorizing the furnishing of
15 material, labor or storage, or that the property was authorized to
16 be towed to a repair facility.

17 Class AA wrecker services taking possession of a vehicle
18 pursuant to an agreement with, or at the direction of, or dispatched
19 by, a state or local law enforcement or government agency, or
20 pursuant to the abandoned vehicle removal provisions of Section 954A
21 of Title 47 of the Oklahoma Statutes, shall be considered lawfully
22 in possession of the vehicle. If the person lacks such
23 documentation, the procedures established by this section shall not
24 apply; and

1 4. "Itemized charges" means total parts, total labor, total
2 towing fees, total storage fees, total processing fees and totals of
3 any other fee groups, the sum total of which shall equal the
4 compensation claimed.

5 I. For purposes of this section, the United States Postal
6 Service approved electronic equivalent of proof of return receipt
7 requested Form 3811 shall satisfy return receipt requested
8 documentation requirements.

9 J. If a person claiming a special lien pursuant to this section
10 fails to comply with any of the requirements of this section, any
11 interested party may proceed against the person claiming such lien
12 for all damages arising therefrom, including conversion, if the
13 article of personal property has been sold. If the notice or
14 notices required by this section shall be shown to be knowingly
15 false or fraudulent, the interested party shall be entitled to
16 treble damages. The prevailing party shall be entitled to all
17 costs, including reasonable attorney fees.

18 K. Any interested party shall be permitted to visually inspect
19 and verify the services rendered by the claimant prior to the sale
20 of the article of property during normal business hours. If the
21 claimant fails to allow any interested party to inspect the
22 property, the interested party shall mail a request for inspection
23 by certified mail, return receipt requested, to the claimant.
24 Within three (3) business days of receipt of the request for

1 inspection, the claimant shall mail a photograph of the property, by
2 certified mail, return receipt requested, and a date of inspection
3 within five (5) business days from the date of the notice to
4 inspect. The lienholder shall be allowed to retrieve the property
5 without being required to bring the title into the lienholder's
6 name, if the lienholder provides proof it is a lienholder and any
7 payment due the claimant for lawful charges where the claimant has
8 complied with this section. Upon the release of personal property
9 to an insurer or representative of the insurer, wrecker operators
10 shall be exempt from all liability and shall be held harmless for
11 any losses or claims of loss. In the event any law enforcement
12 agency places a hold on the property, the party wanting to inspect
13 or photograph the property shall obtain permission from the law
14 enforcement agency that placed the hold on the property before
15 inspecting or photographing.

16 L. This section shall apply to all actions or proceedings that
17 commence on or after ~~the effective date of this act~~ August 22, 2014.

Section 3-106. A. There is hereby created in the State Treasury a revolving fund for Service Oklahoma to be designated the "Service Oklahoma Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations. All monies accruing to the credit of the fund are hereby appropriated and shall be budgeted and expended by Service Oklahoma for the restricted purposes of the monies as prescribed by law. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.

B. There is hereby created in the State Treasury a revolving fund for Service Oklahoma to be designated the "Service Oklahoma Reimbursement Fund". The fund shall be a continuing fund, not subject to fiscal year limitations. All monies accruing to the credit of the fund are hereby appropriated and shall be budgeted and expended by Service Oklahoma for the restricted purposes of the monies as prescribed by law. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims

1 filed as prescribed by law with the Director of the Office of
2 Management and Enterprise Services for approval and payment.

3 C. There is hereby created in the State Treasury a revolving
4 fund for Service Oklahoma, to be designated the "Service Oklahoma
5 Computer Imaging System Revolving Fund". The fund shall be a
6 continuing fund not subject to fiscal year limitations. All monies
7 accruing to the credit of the fund are hereby appropriated and shall
8 be budgeted and expended by Service Oklahoma for the purpose of
9 implementing, developing, administering, and maintaining the
10 computer imaging system of Service Oklahoma. Expenditures from the
11 fund shall be made upon warrants issued by the State Treasurer
12 against claims filed as prescribed by law with the Director of the
13 Office of Management and Enterprise Services for approval and
14 payment.

15 D. There is hereby created in the State Treasury a revolving
16 fund for Service Oklahoma to be designated the "Licensed Operator
17 Performance Fund". This fund shall be a continuing fund not subject
18 to fiscal year limitations. All monies accruing to the credit of
19 the fund are hereby appropriated and shall be budgeted and expended
20 by Service Oklahoma for the restricted purposes of the monies as
21 prescribed by law. Expenditures from the fund shall be made upon
22 warrants issued by the State Treasurer against claims filed as
23 prescribed by law with the Director of the Office of Management and
24 Enterprise Services for approval and payment.

1 1. The Licensed Operator Performance Fund shall be distributed
2 to licensed operators in accordance with the applicable metrics
3 determined by Service Oklahoma.

4 2. In the event that excess funds exist in the Licensed
5 Operator Performance Fund after distribution to licensed operators
6 pursuant to this subsection, the remaining funds are authorized to
7 be expended for the purpose of purchasing back a licensed operator
8 license from a licensed operator, pursuant to Section 1140 of this
9 title.

10 E. There is hereby created a Petty Cash Fund for Service
11 Oklahoma. The fund shall be used by Service Oklahoma to operate
12 cash drawers as necessary. The amount of the Petty Cash Fund shall
13 be determined by the Director of Service Oklahoma and the Director
14 of the Office of Management and Enterprise Services. Purchases from
15 the Petty Cash Fund shall be prohibited. The Director of Management
16 and Enterprise Services shall be authorized to prescribe forms,
17 systems, and procedures for the administration of the Petty Cash
18 Fund.

19 SECTION 33. REPEALER Section 6, Chapter 282, O.S.L.

22 SECTION 34. AMENDATORY 47 O.S. 2021, Section 6-101, as
23 last amended by Section 5, Chapter 47, 1st Extraordinary Session,

1 O.S.L. 2023 (47 O.S. Supp. 2023, Section 6-101), is amended to read
2 as follows:

3 Section 6-101. A. No person, except those hereinafter
4 expressly exempted in Sections 6-102 and 6-102.1 of this title,
5 shall operate any motor vehicle upon a highway in this state unless
6 the person has a valid Oklahoma driver license for the class of
7 vehicle being operated under the provisions of this title. No
8 person shall be permitted to possess more than one valid license at
9 any time, except as provided in paragraph 4 of subsection F of this
10 section.

11 B. 1. No person shall operate a Class A commercial motor
12 vehicle unless the person is eighteen (18) years of age or older and
13 holds a valid Class A commercial license, except as provided in
14 paragraph 5 of this subsection and subsection F of this section.
15 Any person holding a valid Class A commercial license shall be
16 permitted to operate motor vehicles in Classes A, B, C and D, except
17 as provided for in paragraph 4 of this subsection.

18 2. No person shall operate a Class B commercial motor vehicle
19 unless the person is eighteen (18) years of age or older and holds a
20 valid Class B commercial license, except as provided in paragraph 5
21 of subsection F of this section. Any person holding a valid Class B
22 commercial license shall be permitted to operate motor vehicles in
23 Classes B, C and D, except as provided for in paragraph 4 of this
24 subsection.

1 3. No person shall operate a Class C commercial motor vehicle
2 unless the person is eighteen (18) years of age or older and holds a
3 valid Class C commercial license, except as provided in subsection F
4 of this section. Any person holding a valid Class C commercial
5 license shall be permitted to operate motor vehicles in Classes C
6 and D, except as provided for in paragraph 4 of this subsection.

7 4. No person under twenty-one (21) years of age shall be
8 licensed to operate any motor vehicle which is required to be
9 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
10 subpart F, except as provided in subsection F of this section;
11 provided, a person eighteen (18) years of age or older may be
12 licensed to operate a farm vehicle which is required to be placarded
13 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
14 except as provided in subsection F of this section.

15 5. A person at least seventeen (17) years of age who
16 successfully completes all examinations required by law may be
17 issued by Service Oklahoma:

- 18 a. a restricted Class A commercial license which shall
19 grant to the licensee the privilege to operate a Class
20 A or Class B commercial motor vehicle for harvest
21 purposes or a Class D motor vehicle, or
22 b. a restricted Class B commercial license which shall
23 grant to the licensee the privilege to operate a Class
24

1 B commercial motor vehicle for harvest purposes or a
2 Class D motor vehicle.

3 6. No person shall operate a Class D motor vehicle unless the
4 person is sixteen (16) years of age or older and holds a valid Class
5 D license, except as provided for in Section 6-102 or 6-105 of this
6 title. Any person holding a valid Class D license shall be
7 permitted to operate motor vehicles in Class D only.

8 C. Any person issued a driver license pursuant to this section
9 may exercise the privilege thereby granted upon all streets and
10 highways in this state.

11 D. No person shall operate a motorcycle or motor-driven cycle
12 without having a valid Class A, B, C or D license with a motorcycle
13 endorsement. Except as otherwise provided by law, any new applicant
14 for an original driver license shall be required to successfully
15 complete a written examination, vision examination and driving
16 examination for a motorcycle as prescribed by the Department of
17 Public Safety, in conjunction with Service Oklahoma, and a certified
18 state-approved motorcycle basic rider course approved by the
19 Department, in conjunction with Service Oklahoma, if the applicant
20 is seventeen (17) years of age or younger to be eligible for a
21 motorcycle endorsement thereon. The written examination and driving
22 examination for a motorcycle shall be waived by Service Oklahoma
23 upon verification that the person has successfully completed a
24

1 certified Motorcycle Safety Foundation rider course approved by the
2 Department, in conjunction with Service Oklahoma.

3 E. Except as otherwise provided by law, any person who lawfully
4 possesses a valid Oklahoma driver license which is eligible for
5 renewal shall be required to successfully complete a written
6 examination, vision examination and driving examination for a
7 motorcycle as prescribed by the Department, in conjunction with
8 Service Oklahoma, and a certified state-approved motorcycle basic
9 rider course approved by the Department, in conjunction with Service
10 Oklahoma, if the person is seventeen (17) years of age or younger to
11 be eligible for a motorcycle endorsement. The written examination
12 and driving examination for a motorcycle shall be waived by Service
13 Oklahoma upon verification that the person has successfully
14 completed a certified Motorcycle Safety Foundation rider course
15 approved by the Department, in conjunction with Service Oklahoma.

16 F. 1. Any person eighteen (18) years of age or older may apply
17 for a restricted Class A, B or C commercial learner permit. Service
18 Oklahoma, after the applicant has passed all parts of the
19 examination for a Class D license and has successfully passed all
20 parts of the examination for a Class A, B or C commercial license
21 other than the driving examination, may issue to the applicant a
22 commercial learner permit which shall entitle the person having
23 immediate lawful possession of the commercial learner permit and a
24 valid Oklahoma driver license or provisional driver license pursuant

1 to Section 6-212 of this title to operate a Class A, B or C
2 commercial motor vehicle upon the public highways solely for the
3 purpose of behind-the-wheel training in accordance with rules
4 promulgated by the Department.

5 2. This commercial learner permit shall be issued for a period
6 as provided in Section 6-115 of this title of ~~one hundred eighty~~
7 ~~(180) days, which may be renewed one time for an additional one~~
8 ~~hundred eighty (180) days~~ one year; provided, such commercial
9 learner permit may be suspended, revoked, canceled, denied or
10 disqualified at the discretion of the Department, with notice to
11 Service Oklahoma, for violation of the restrictions, for failing to
12 give the required or correct information on the application or for
13 violation of any traffic laws of this state pertaining to the
14 operation of a motor vehicle. Except as otherwise provided, the
15 lawful possessor of a commercial learner permit who has been issued
16 a commercial learner permit for a minimum of fourteen (14) days may
17 have the restriction requiring an accompanying driver removed by
18 satisfactorily completing a driver's examination; provided, the
19 removal of a restriction shall not authorize the operation of a
20 Class A, B or C commercial motor vehicle if such operation is
21 otherwise prohibited by law.

22 3. No person shall apply for and Service Oklahoma shall not
23 issue an original Class A, B or C driver license until the person
24 has been issued a commercial learner permit and held the permit for

1 at least fourteen (14) days. Any person who currently holds a Class
2 B or C license and who wishes to apply for another class of
3 commercial driver license shall be required to apply for a
4 commercial learner permit and to hold the permit for at least
5 fourteen (14) days before applying for the Class A or B license, as
6 applicable. Any person who currently holds a Class A, B or C
7 license and who wishes to add an endorsement or remove a restriction
8 for which a skills examination is required shall be required to
9 apply for a commercial learner permit and to hold the permit for at
10 least fourteen (14) days before applying for the endorsement.

11 4. A commercial learner permit shall be issued by Service
12 Oklahoma as a separate and unique document which shall be valid only
13 in conjunction with a valid Oklahoma driver license or provisional
14 driver license pursuant to Section 6-212 of this title, both of
15 which shall be in the possession of the person to whom they have
16 been issued whenever that person is operating a commercial motor
17 vehicle as provided in this subsection.

18 5. After one renewal of a commercial learner permit, as
19 provided in paragraph 2 of this subsection, a commercial permit
20 shall not be renewed again. Any person who has held a commercial
21 learner permit for the initial issuance period and one renewal
22 period shall not be eligible for and Service Oklahoma shall not
23 issue another renewal of the permit; provided, the person may
24

1 reapply for a new commercial learner permit, as provided for in this
2 subsection.

3 G. 1. For purposes of this title:

4 a. "REAL ID Compliant Driver License" or "Identification
5 Card" means a driver license or identification card
6 issued by this state that has been certified by the
7 United States Department of Homeland Security (USDHS)
8 as compliant with the requirements of the REAL ID Act
9 of 2005, Public Law No. 109-13. A REAL ID Compliant
10 Driver License or Identification Card and the process
11 through which it is issued incorporate a variety of
12 security measures designed to protect the integrity
13 and trustworthiness of the license or card. A REAL ID
14 Compliant Driver License or Identification Card will
15 be clearly marked on the face indicating that it is a
16 compliant document, and

17 b. "REAL ID Noncompliant Driver License" or
18 "Identification Card" means a driver license or
19 identification card issued by this state that has not
20 been certified by the United States Department of
21 Homeland Security (USDHS) as being compliant with the
22 requirements of the REAL ID Act of 2005. A REAL ID
23 Noncompliant Driver License or Identification Card
24 will be clearly marked on the face indicating that it

1 is not compliant with the federal REAL ID Act of 2005
2 and is not acceptable for official federal purposes.
3 The driver license or identification card will have a
4 unique design or color indicator that clearly
5 distinguishes it from a compliant license or card.

6 2. Original Driver License and Identification Card Issuance:

- 7 a. Application for an original REAL ID Compliant or REAL
8 ID Noncompliant Driver License or Identification Card
9 shall be made to Service Oklahoma or a licensed
10 operator provided such licensed operator is authorized
11 to process application for REAL ID Compliant Driver
12 Licenses and Identification Cards. Application for a
13 REAL ID Noncompliant Driver License or Identification
14 Card shall be made to Service Oklahoma.
- 15 b. Service Oklahoma employees or authorized licensed
16 operators shall perform all document recognition and
17 other requirements needed for approval of an original
18 REAL ID Compliant Driver License or Identification
19 Card application. Service Oklahoma employees shall
20 perform all document recognition and other
21 requirements needed for approval of a REAL ID
22 Noncompliant Driver License or Identification Card
23 application.
24

- 1 c. Upon approval of an original REAL ID Compliant or REAL
2 ID Noncompliant Driver License or Identification Card
3 application, the applicant may take the approved
4 application document to a licensed operator to receive
5 a temporary driver license or identification card.
- 6 d. The licensed operator shall process the approved REAL
7 ID Compliant or REAL ID Noncompliant Driver License or
8 Identification Card application and upon payment shall
9 provide the applicant a temporary driver license or
10 identification card. A temporary driver license or
11 identification card shall afford the holder the
12 privileges otherwise granted by the specific class of
13 driver license or identification card for the period
14 of time listed on the temporary driver license or
15 identification card or the period of time prior to the
16 applicant receiving a REAL ID Compliant or REAL ID
17 Noncompliant Driver License or Identification Card,
18 whichever time period is shorter.

19 3. REAL ID Compliant Driver License and Identification Card

20 Renewal and Replacement:

- 21 a. Application for renewal or replacement of a REAL ID
22 Compliant Driver License or Identification Card may be
23 made to Service Oklahoma or to a licensed operator;
24 provided, such licensed operator is authorized to

1 process application for REAL ID Compliant Driver
2 Licenses and Identification Cards. A licensed
3 operator may process the voluntary downgrade of a REAL
4 ID Compliant Commercial Driver License to any lower
5 class license upon request of the licensee; provided,
6 no additional endorsements or restrictions are placed
7 on the license.

8 b. Service Oklahoma employees or authorized licensed
9 operators shall perform all document recognition and
10 other requirements needed for approval of a renewal or
11 replacement REAL ID Compliant Driver License or
12 Identification Card application.

13 c. Upon approval of a renewal or replacement REAL ID
14 Compliant Driver License or Identification Card
15 application, the applicant may receive a temporary
16 driver license or identification card from Service
17 Oklahoma or an authorized licensed operator.

18 d. A temporary driver license or identification card
19 acquired under the provisions of this paragraph shall
20 afford the holder the privileges otherwise granted by
21 the specific class of driver license or identification
22 card being renewed or replaced for the period of time
23 listed on the temporary driver license or
24 identification card or the period of time prior to the

1 applicant receiving a REAL ID Compliant Driver License
2 or Identification Card, whichever time period is
3 shorter.

- 4 e. For purposes of this title, an application for a REAL
5 ID Compliant Driver License or Identification Card by
6 an individual with a valid Oklahoma-issued driver
7 license or identification card shall be considered a
8 renewal of a REAL ID Compliant Driver License or
9 Identification Card.

10 4. REAL ID Noncompliant Driver License and Identification Card

11 Renewal and Replacement:

- 12 a. Application for renewal or replacement of a REAL ID
13 Noncompliant Driver License or Identification Card may
14 be made to Service Oklahoma or to a licensed operator.
15 A licensed operator may process the voluntary
16 downgrade of a REAL ID Noncompliant Commercial Driver
17 License to any lower class license upon request of the
18 licensee; provided, no additional endorsements or
19 restrictions are added to the license.
- 20 b. Service Oklahoma employees or licensed operators shall
21 perform all document recognition and other
22 requirements needed for approval of a renewal or
23 replacement REAL ID Noncompliant Driver License or
24 Identification Card application.

c. Upon approval of a renewal or replacement REAL ID Noncompliant Driver License or Identification Card application, the applicant may receive a temporary driver license or identification card from Service Oklahoma or a licensed operator.

d. A temporary driver license or identification card acquired under the provisions of this paragraph shall afford the holder the privileges otherwise granted by the specific class of driver license or identification card being renewed or replaced for the period of time listed on the temporary driver license or identification card or the period of time prior to the applicant receiving a REAL ID Noncompliant Driver License or Identification Card, whichever time period is shorter.

H. 1. The fee charged for an approved application for an original Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver License or an approved application for the addition of an endorsement to a current valid Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver License shall be assessed in accordance with the following schedule:

L. A commercial learner permit may be renewed one time for a period of one hundred eighty (180) days. The cost for the renewed permit shall be the same as for the original permit.

M. Notwithstanding the provisions of Section 1104 of this title, of each fee charged pursuant to the provisions of subsections J, K and L of this section:

1. Five Dollars and fifty cents (\$5.50) of a 4-year license or Eleven Dollars (\$11.00) of an 8-year license shall be deposited to the Trauma Care Assistance Revolving Fund created in Section 1-2530.9 of Title 63 of the Oklahoma Statutes;

8 service in any branch of the Armed Forces of the United States or
9 Oklahoma National Guard and who has been certified by the United
10 States Department of Veterans Affairs, its successor or the Armed
11 Forces of the United States to be a disabled veteran in receipt of
12 compensation at the one-hundred-percent rate for a permanent
13 disability sustained through military action or accident resulting
14 from disease contracted while in such active service and registered
15 with the veterans registry created by the Oklahoma Department of
16 Veterans Affairs shall be charged a fee for the issuance,
17 replacement or renewal of an Oklahoma driver license; provided, that
18 if a veteran has been previously exempt from a fee pursuant to this
19 subsection, no registration with the veterans registry shall be

18 license agent or licensed operator accepting applications for driver
19 licenses for individuals over the age of sixty-five (65) years or
20 for applications for drivers pursuant to subsection P of this
21 section shall receive Six Dollars (\$6.00) for a 4-year driver
22 license or Twelve Dollars (\$12.00) for an 8-year driver license to
23 be deducted daily by the motor license agent or licensed operator
24 receipts. Beginning July 1, 2023, these fees shall be retained by

1 the licensed operator pursuant to subsection E of Section 1141.1 of
2 this title. The fees received by the licensed operator, authorized
3 by this subsection, shall be used for operating expenses. The
4 amount retained pursuant to this subsection shall not be retained by
5 any state agency. The fees received by the licensed operator,
6 authorized by this subsection, shall be used for operating expenses.
7 For purposes of this subsection, "licensed operator" shall mean an
8 individual who obtains a license from the Service Oklahoma Operator
9 Board to operate a designated Service Oklahoma location and offers
10 third-party fulfillment of designated services to be rendered by
11 Service Oklahoma.

12 R. Notwithstanding the provisions of Section 1104 of this title
13 and subsection Q of this section and except as provided in

4 issued REAL ID Compliant Driver License or REAL ID Compliant

6 Service Oklahoma shall not issue a REAL ID Compliant Driver License
7 to a person who has been previously issued a REAL ID Compliant
8 Driver License or REAL ID Compliant Identification Card until such
9 license or identification card has been surrendered to Service
10 Oklahoma by the applicant. Service Oklahoma may promulgate rules
11 related to the issuance of replacement REAL ID Compliant Driver
12 Licenses in the event of loss or theft.

13 U. Beginning May 24, 2021, and ending on June 30, 2023, in

15 licensed operator shall receive Five Dollars (\$5.00) for each
16 processed application for a REAL ID Compliant 4-year Driver License
17 and Ten Dollars (\$10.00) for each processed application for a REAL
18 ID Compliant 8-year Driver License. Any additional amounts provided
19 pursuant to this subsection shall not be retained by Service
20 Oklahoma.

b. whose custodial legal parent or legal guardian certifies to Service Oklahoma by sworn affidavit that the person has received a minimum of fifty (50) hours of actual behind-the-wheel training, of which at least ten (10) hours of such training was at night, from a licensed driver who was at least twenty-one (21) years of age and who was properly licensed to operate a Class D motor vehicle for a minimum of two (2) years, and

c. who has completed a free course approved by the Oklahoma Department of Transportation on teen driver work zone and first responder safety,

may be issued an intermediate Class D license upon successfully passing all parts of the driver license examinations administered by Service Oklahoma; provided, the written examination, if it has not previously been administered or waived, may be waived by Service Oklahoma upon verification that the person has successfully completed driver education or the driving examination may be waived by Service Oklahoma upon successful passage of the examination administered by a certified designated examiner, as provided for in Section 6-110 of this title. However, notwithstanding the date of issuance of the learner permit, if the person has been convicted of a traffic offense which is reported on the driving record of that person, the time period specified in subparagraph a of this

paragraph shall be recalculated to begin from the date of conviction for the traffic offense, and must elapse before that person may be issued an intermediate Class D license. If the person has been convicted of more than one traffic offense which is reported on the driving record of that person, the time period specified in subparagraph a of this paragraph shall be recalculated to begin from the most recent date of conviction, and must elapse before that person may be issued an intermediate Class D license.

5 receiving satisfactory evidence that the licensee has
6 been involved in two or more accidents chargeable to
7 the licensee and such suspended license shall not be
8 reinstated for one (1) year.

10 shall provide, prior to reaching sixteen (16) years of age, a signed
11 affidavit of either a parent or guardian stating that the applicant

14 supervised driving required by this paragraph shall be conducted by

11 ~~document and no other form of identification is available,~~ Service
12 Oklahoma shall allow the use of a certified copy of a birth
13 certificate coupled with a Department of Corrections-issued
14 consolidated record card to serve as a valid form of photo
15 identification ~~document~~ documentation to obtain a REAL ID
16 Noncompliant Identification Card.

17 3. REAL ID Noncompliant Identification Cards issued with a
18 consolidated record card from the Department of Corrections for
19 inmates shall be valid for a period of four (4) years from the month
20 of issuance for an allowable fee to be determined by Service
21 Oklahoma and are nonrenewable and nontransferable.

22 4. The fee charged for the issuance or replacement of a REAL ID
23 Noncompliant Identification Card pursuant to this subsection shall
24 be deposited in the Department of Public Safety Revolving Fund

1 through October 31, 2022. Beginning November 1, 2022, this fee
2 shall be deposited in the Service Oklahoma Revolving Fund.
3 Provided, however, REAL ID Noncompliant Identification Cards issued
4 to individuals required to register pursuant to the Sex Offenders
5 Registration Act shall only be valid for a period of one (1) year.
6 No person sixty-five (65) years of age or older shall be charged a
7 fee for a REAL ID Noncompliant Identification Card.

8 5. Service Oklahoma is authorized to promulgate rules and
9 procedures to implement the provisions of this subsection.

10 C. No person shall hold more than one state-issued or
11 territory-issued REAL ID Compliant Driver License or REAL ID
12 Compliant Identification Card, as defined in subsection G of Section
13 6-101 of this title. Service Oklahoma shall not issue a REAL ID
14 Compliant Identification Card to any applicant who has been
15 previously issued a REAL ID Compliant Driver License or REAL ID
16 Compliant Identification Card unless such license or identification
17 card has been surrendered to the Department by the applicant.
18 Service Oklahoma may promulgate rules related to the issuance of
19 replacement REAL ID Compliant Identification Cards in the event of
20 loss or theft.

21 D. The fee charged for the issuance or renewal of a REAL ID
22 Compliant Identification Card shall be Twenty-five Dollars (\$25.00)
23 for a 4-year card and Fifty Dollars (\$50.00) for an 8-year card.
24 The fee charged for the issuance or renewal of a REAL ID

1 Noncompliant Identification Card pursuant to this section shall be
2 Twenty-five Dollars (\$25.00) for a 4-year card and Fifty Dollars
3 (\$50.00) for an 8-year card; however, no person sixty-five (65)
4 years of age or older, or one hundred percent (100%) disabled
5 veteran described in subsection P of Section 6-101 of this title
6 shall be charged a fee for an identification card. Of each fee
7 charged pursuant to the provisions of this subsection:

8 1. Seven Dollars (\$7.00) of a 4-year card and Fourteen Dollars
9 (\$14.00) of an 8-year card shall be apportioned as provided in
10 Section 1104 of this title;

11 2. Three Dollars (\$3.00) of a 4-year card and Six Dollars
12 (\$6.00) of an 8-year card shall be credited to the Department of
13 Public Safety Computer Imaging System Revolving Fund to be used
14 solely for the purpose of the administration and maintenance of the
15 computerized imaging system of the Department through October 31,
16 2022. Beginning November 1, 2022, Three Dollars (\$3.00) of a 4-year
17 card and Six Dollars (\$6.00) of an 8-year card shall be credited to
18 the Service Oklahoma Computer Imaging System Revolving Fund to be
19 used solely for the purpose of administration and maintenance of the
20 computerized imaging system of Service Oklahoma;

21 3. Ten Dollars (\$10.00) of a 4-year card and Twenty Dollars
22 (\$20.00) of an 8-year card shall be deposited in the Department of
23 Public Safety Revolving Fund through October 31, 2022. Beginning
24

1 November 1, 2022, this fee shall be deposited in the Service
2 Oklahoma Revolving Fund;

3 4. Three Dollars (\$3.00) of a 4-year card and Six Dollars
4 (\$6.00) of an 8-year card shall be deposited to the State Public
5 Safety Fund created in Section 2-147 of this title; and

6 5. Two Dollars (\$2.00) for a 4-year card and Four Dollars
7 (\$4.00) for an 8-year card of the fee authorized by this subsection
8 related to the issuance or renewal of an identification card by a
9 licensed operator that does process approved applications or
10 renewals for REAL ID Compliant and REAL ID Noncompliant Driver
11 Licenses or Identification Cards shall be retained by the licensed
12 operator pursuant to subsection E of Section 1141.1 of this title.

13 E. The fee charged for replacement of a REAL ID Compliant
14 Identification Card, or REAL ID Noncompliant Identification Card,
15 shall be Twenty-five Dollars (\$25.00); however, no person sixty-five
16 (65) years of age or older shall be charged a fee for an
17 identification card replacement. Of each fee charged pursuant to
18 the provisions of this subsection:

19 1. Seven Dollars (\$7.00) shall be apportioned as provided in
20 Section 1104 of this title;

21 2. Three Dollars (\$3.00) shall be credited to the Department of
22 Public Safety Computer Imaging System Revolving Fund to be used
23 solely for the purpose of the administration and maintenance of the
24 computerized imaging system of the Department through October 31,

2022. Beginning November 1, 2022, Three Dollars (\$3.00) shall be credited to the Service Oklahoma Computer Imaging System Revolving Fund to be used solely for the purpose of administration and maintenance of the computerized imaging system of Service Oklahoma;

3. Ten Dollars (\$10.00) shall be deposited in the Department of Public Safety Revolving Fund through October 31, 2022. Beginning November 1, 2022, this fee shall be deposited in the Service Oklahoma Revolving Fund;

4. Three Dollars (\$3.00) shall be deposited to the State Public Safety Fund created in Section 2-147 of this title; and

5. Two Dollars (\$2.00) of the fee authorized by this subsection related to the replacement of an identification card by a licensed operator that does process approved applications or renewals for REAL ID Compliant or REAL ID Noncompliant Driver Licenses or Identification Cards shall be retained by the licensed operator pursuant to subsection E of Section 1141.1 of this title.

F. The Oklahoma Tax Commission is hereby authorized to reimburse, from funds available to that agency, each licensed operator issuing an identification card to a person sixty-five (65) years of age or older, an amount not to exceed One Dollar (\$1.00) for each card or driver license so issued through June 30, 2023. The Tax Commission shall develop procedures for claims for reimbursement.

1 G. Notwithstanding any other provision of law, when a person
2 makes application for a new identification card, or makes
3 application to renew an identification card, and the person has been
4 convicted of, or received a deferred judgment for, any offense
5 required to register pursuant to the Sex Offenders Registration Act,
6 the identification card shall be valid for a period of one (1) year
7 from the month of issuance, but may be renewed yearly during the
8 time the person is subject to registration on the Sex Offender
9 Registry. The cost for such identification card shall be the same
10 as for other identification cards and renewals.

11 H. Nothing in this section requires or authorizes the
12 Department of Public Safety to issue a REAL ID Noncompliant
13 Identification Card without the documentation required by the
14 provisions of paragraph 9 of subsection A of Section 6-103 of this
15 title.

20 SECTION 44. AMENDATORY 47 O.S. 2021, Section 6-110, as
21 last amended by Section 1, Chapter 82, O.S.L. 2023 (47 O.S. Supp.
22 2023, Section 6-110), is amended to read as follows:

23 Section 6-110. A. 1. Service Oklahoma shall establish
24 procedures to ensure every applicant for an original Class A, B, C

1 or D license and for any endorsements thereon is examined by Service
2 Oklahoma, or an approved written examination proctor, except as
3 otherwise provided in Section 6-101 et seq. of this title or as
4 provided in paragraph 2 of this subsection or in subsections D and E
5 of this section. Service Oklahoma is authorized to approve and
6 enter into agreements with third parties to act as approved written
7 examination proctors with regard to any written examination required
8 by this section. The examination shall include a test of the
9 applicant's:

- 10 a. eyesight,
- 11 b. ability to read and understand highway signs
12 regulating, warning and directing traffic,
- 13 c. knowledge of the traffic laws of this state including
14 a portion on bicycle and motorcycle safety, and
- 15 d. ability, by actual demonstration, to exercise ordinary
16 and reasonable control in the operation of a motor
17 vehicle. The actual demonstration shall be conducted
18 in the type of motor vehicle for the class of driver
19 license being applied for.

20 The Department of Public Safety, in conjunction with Service
21 Oklahoma, may create a knowledge test that may be taken on the
22 Internet by an applicant applying for a Class D license.

1 Any licensee seeking to apply for a driver license of another class
2 which is not covered by the licensee's current driver license shall
3 be considered an applicant for an original license for that class.

4 2. Service Oklahoma shall have the authority to waive the
5 requirement of any part of the examination required in paragraph 1
6 of this subsection for those applicants whose driving record meets
7 the standards set by the Department of Public Safety and surrender
8 either of the following:

9 a. a valid unexpired driver license issued by any state
10 or country for the same type or types of vehicles, or

11 b. an expired driver license that:

12 (1) is not expired more than six (6) months past the
13 expiration date listed on the driver license, and

14 (2) is not a Class A, B or C commercial driver
15 license or commercial driver license permit.

16 3. Service Oklahoma shall accept skills test results from
17 another state for Class A, B or C license applicants who have
18 successfully completed commercial motor vehicle driver training in
19 that state and successfully passed the skills test in that state;
20 provided, Service Oklahoma shall not accept skills test results from
21 another state when the applicant has not successfully completed
22 commercial motor vehicle driver training in that state. Nothing in
23 this section shall be construed to prohibit Service Oklahoma from
24

1 administering the skills test to any applicant who has successfully
2 completed commercial vehicle driver training in another state.

3 4. All applicants requiring a hazardous materials endorsement
4 shall be required, for the renewal of the endorsement, to
5 successfully complete the examination and to submit to a security
6 threat assessment performed by the Transportation Security
7 Administration of the Department of Homeland Security as required by
8 and pursuant to 49 C.F.R., Part 1572, which shall be used to
9 determine whether the applicant is eligible for renewal of the
10 endorsement pursuant to federal law and regulation.

11 5. Service Oklahoma, or an approved written examination
12 proctor, shall give the complete examination as provided for in this
13 section within thirty (30) days from the date the application is
14 received, and the examination shall be given at a location within
15 one hundred (100) miles of the residence of the applicant. Service
16 Oklahoma shall make every effort to make the examination locations
17 and times convenient for applicants. Service Oklahoma shall
18 consider giving the examination at any public or private site, if
19 economically feasible and practicable, and if Service Oklahoma and
20 the owner or the governing body agree.

21 B. Any person holding a valid Oklahoma Class D license or
22 provisional driver license pursuant to Section 6-212 of this title
23 and applying for a Class A, B or C commercial license shall be
24 required to successfully complete all examinations as required for

1 the specified class. Failure to submit to Service Oklahoma
2 federally required medical certification information pursuant to 49
3 C.F.R., Part 391.41 et seq. shall result in an automatic downgrade
4 of a commercial license to a Class D license. Provided, however,
5 once the required medical certification information has been
6 received by Service Oklahoma, the license shall be reinstated to the
7 classification of the commercial license prior to the downgrade and
8 the holder of such a license shall not be required to reapply.

9 C. Except as provided in subsection E of Section 6-101 of this
10 title, any person holding a valid Oklahoma Class A, B or C
11 commercial license shall, upon time for renewal thereof, be entitled
12 to a Class D license without any type of testing or examination,
13 except for any endorsements thereon as otherwise provided for by
14 Section 6-110.1 of this title.

15 D. 1. Any certified driver education instructor who is
16 currently an operator or an employee of a commercial driver training
17 school in this state or any driver education instructor employed by
18 any school district in this state shall be eligible to apply to be a
19 designated examiner of Service Oklahoma for the purposes of
20 administering the Class D driving skills portion of the Oklahoma
21 driving examination to any person who has been issued a learner

23 2. The Department of Public Safety, in conjunction with Service

2 designated examiner. The courses and training for certification
3 shall meet the same standards as required for driver examiners of
4 Service Oklahoma.

5 3. Each person applying to be a designated examiner shall be
6 required to pay an initial designated examiner certification fee of
7 One Thousand Dollars (\$1,000.00). Upon successful completion of
8 training prescribed by paragraph 2 of this subsection, the person
9 shall be required to pay an annual designated examiner certification
10 fee of Five Hundred Dollars (\$500.00). If an applicant for the
11 designated examiner program is employed by an Oklahoma public school
12 system that offers driver education, and he or she administers the
13 skills test only to students enrolled in a public school driver
14 education program, the certification fee may be waived by Service
15 Oklahoma. Each designated examiner certification shall expire on
16 the last day of the calendar year and may be renewed upon
17 application to Service Oklahoma. The designated examiner
18 certification fees collected by Service Oklahoma pursuant to this
19 subsection shall be deposited to the credit of the Department of
20 Public Safety Restricted Revolving Fund to be used for the purposes
21 of this subsection, through October 31, 2022. Beginning November 1,
22 2022, the designated examiner certification fees collected by
23 Service Oklahoma pursuant to this subsection shall be deposited to
24 the credit of the Service Oklahoma Revolving Fund. No designated

1 examiner certification fee shall be refunded in the event that
2 certification is denied, suspended or revoked.

3 4. A designated examiner may charge a fee for each Class D
4 driving skills examination given, whether the person being examined
5 passes or fails the examination.

6 5. Service Oklahoma shall ~~conduct an annual complete nationwide~~
7 ~~criminal history background check on~~ require each designated
8 examiner and a ~~complete nationwide criminal history background check~~
9 ~~on each designated examiner applicant~~ and driver education
10 instructor applicant to submit to an electronic national criminal
11 history record check pursuant to Section 150.9 of Title 74 of the
12 Oklahoma Statutes. The fees for the ~~background~~ record check shall
13 be borne by the designated examiner, ~~or~~ designated examiner
14 applicant, driver education instructor, or driver education
15 instructor applicant.

16 6. The Department of Public Safety, in conjunction with Service
17 Oklahoma, shall promulgate rules to implement and administer the
18 provisions of this subsection.

19 E. 1. Upon application and approval of Service Oklahoma, any
20 public or private commercial truck driving school that has or
21 maintains a program instructing students for a Class A, B or C
22 license, public transit agency, state, county or municipal
23 government agency in this state, such as local school districts, the
24 Oklahoma Department of Career and Technology Education, or

1 institutions of higher education, or a private entity, shall be
2 authorized to hire or employ designated examiners approved by
3 Service Oklahoma to be third-party examiners of the Class A, B or C
4 driving skills portion and/or knowledge written portion, pursuant to
5 paragraph A of this section, of the Oklahoma driving examination.
6 All designated examiners must successfully have completed the
7 courses and training as outlined in paragraph 2 of this subsection.
8 Service Oklahoma shall be required to approve at least one public
9 transit agency that has or maintains a program instructing students
10 for a Class A, B or C license to hire or employ third-party
11 examiners pursuant to this section. It shall be permissible for any
12 public transit agency operating in the State of Oklahoma to utilize
13 the third-party examiners hired or employed by a public transit
14 agency approved by Service Oklahoma.

15 2. The Department of Public Safety, in conjunction with Service
16 Oklahoma, shall adopt a curriculum of required courses and training
17 to be offered to third-party examiners. The courses and training
18 for certification shall meet the same standards as required for
19 commercial driver examiners of Service Oklahoma.

20 3. Service Oklahoma shall require each third-party examiner
21 applicant and commercial school driver education instructor
22 applicant to submit to an electronic national criminal history
23 record check pursuant to Section 150.9 of Title 74 of the Oklahoma
24 Statutes. On or before December 1, 2022, Service Oklahoma shall

1 require each third-party examiner or commercial school driver
2 education instructor to submit to an electronic national criminal
3 history record check pursuant to Section 150.9 of Title 74 of the
4 Oklahoma Statutes. The fees for the background check shall be borne
5 by the third-party examiner, third-party examiner applicant,
6 commercial school driver education instructor or commercial school
7 driver education instructor applicant.

8 F. Service Oklahoma shall promulgate rules to:

9 1. Implement and administer the provisions of this section
10 based on requirements set forth in Section 383.75 of Title 49 of the
11 Code of Federal Regulations;

12 2. Establish a process to inform any school, public transit
13 agency, examiner, or state, county or municipal government agency,
14 who has been denied, within forty-five (45) days from the denial;

15 3. Create an appeal process for any school, public transit
16 agency, examiner, or state, county or municipal government agency
17 denied; and

18 4. If the initial application for approval was denied, limit
19 the number of times an individual school, public transit agency,
20 individual examiner applicant, or state, county or municipal
21 government agency may reapply in a calendar year to two
22 reapplications.

4 SECTION 46. AMENDATORY 47 O.S. 2021, Section 6-111, as
5 last amended by Section 16, Chapter 310, O.S.L. 2023 (47 O.S. Supp.
6 2023, Section 6-111), is amended to read as follows:

7 Section 6-111. A. 1. Service Oklahoma shall, upon payment of
8 the required fee, issue to every applicant qualifying therefor a
9 Class A, B, C or D driver license or identification card as applied
10 for, which license or card shall bear thereon a distinguishing
11 alphanumeric identification assigned to the licensee or cardholder,
12 date of issuance and date of expiration of the license or card, the
13 full legal name, signature or computerized signature, date of birth,
14 residence address, unless specified as an exception in the Code of
15 Federal Regulations per 6 C.F.R., Section 37.17, sex, a computerized
16 color image of the licensee or cardholder taken in accordance with
17 Service Oklahoma rules and security features as determined by
18 Service Oklahoma. The image shall depict a full front unobstructed
19 view of the entire face of the licensee or cardholder; provided, a
20 commercial learner permit shall not bear the image of the licensee.
21 When any person is issued both a driver license and an

2 Oklahoma on or after March 1, 2004, shall bear thereon the county of

6 number, assign a new distinguishing alphanumeric identification, and
7 issue a new license or identification card without charge to the
8 licensee or cardholder.

9 4. Service Oklahoma may promulgate rules for inclusion of the
10 height and a brief description of the licensee or cardholder on the
11 face of the card or license identifying the licensee or cardholder
12 as deaf or hard-of-hearing.

13 5. It is unlawful for any person to apply, adhere, or otherwise
14 attach to a driver license or identification card any decal,
15 sticker, label, or other attachment. Any law enforcement officer is
16 authorized to remove and dispose of any unlawful decal, sticker,
17 label, or other attachment from the driver license of a person. The
18 law enforcement officer, the employing agency of the officer,
19 Service Oklahoma, and the State of Oklahoma shall be immune from any
20 liability for any loss suffered by the licensee, cardholder, or the
21 owner of the decal, sticker, label, or other attachment caused by
22 the removal and destruction of the decal, sticker, label, or other
23 attachment.

1 6. Service Oklahoma may develop by rule a procedure which
2 complies with the provisions of subsection G of Section 6-101 of
3 this title whereby a person may apply for a renewal or replacement
4 Oklahoma Class D license or Oklahoma identification card.

5 B. 1. Service Oklahoma may issue or authorize the issuance of
6 a temporary permit or license to an applicant for a driver license
7 permitting such applicant to operate a motor vehicle while Service
8 Oklahoma is completing its investigation and determination of all
9 facts relative to such applicant's privilege to receive a license,
10 or while a permanent driver license is being produced and delivered
11 to the applicant. Such permit or license must be in the immediate
12 possession of the driver while operating a motor vehicle, and it
13 shall be invalid when the applicant's permanent driver license has
14 been issued and delivered or for good cause has been refused.

15 2. Service Oklahoma may issue or authorize the issuance of a
16 temporary identification card to an applicant, permitting the holder
17 the privileges otherwise granted by identification cards, while a
18 permanent driver license is being provided and delivered to the
19 applicant. Such card shall be invalid when the applicant's
20 permanent identification card has been issued and delivered, or for
21 good cause has been refused.

22 C. 1. Service Oklahoma may issue a restricted commercial
23 driver license to drivers eighteen (18) years of age or older for
24 any of the following specific farm-related service industries:

- a. farm retail outlets and suppliers,
- b. agri-chemical businesses,
- c. custom harvesters, and
- d. livestock feeders.

The applicant shall have held a valid driver license for at least one year. Applicants with more than two (2) years of driving experience shall have a good driving record for the most recent two (2) year period and shall meet all the requirements for a commercial driver license. The restricted commercial driver license shall not exceed the maximum total days that federal law allows. Applicants for the restricted commercial driver license shall be exempt from the knowledge and skills test. Application of the restricted commercial driver license does not have to be used in consecutive days. The use of the permit shall be declared at application.

2. A "good driving record" as used in this subsection shall mean an applicant:

- a. has not had more than one license,
- b. has not had any license suspended, revoked, or canceled,
- c. has not had any conviction for any type of disqualifying offenses or serious traffic violations, or
- d. has not had any conviction for a violation of state or local law relating to motor vehicle traffic control,

1 other than a parking violation, arising in connection
2 with any traffic accident and has no record of an
3 accident in which they are at fault.

4 3. The restricted commercial driver license shall not be valid
5 for operators of commercial motor vehicles beyond one hundred fifty
6 (150) miles from the place of business or the farm currently being
7 served. Such license shall be limited to Class B or C vehicles.
8 Holders of such licenses who transport hazardous materials which are
9 required to be placarded shall be limited to the following:

- 10 a. diesel fuel in quantities of one thousand (1,000)
11 gallons or less,
12 b. liquid fertilizers in vehicles with total capacities
13 of three thousand (3,000) gallons or less, and
14 c. solid fertilizers that are not mixed with any organic

16 No other placarded hazardous materials shall be transported by
17 holders of such licenses.

18 D. Service Oklahoma may issue a non-domiciled commercial
19 learner permit or a non-domiciled commercial driver license to:

20 ~~1. An H2A Temporary Agricultural worker lawfully present in the~~
21 ~~United States as indicated on an original, valid and unexpired I-94~~
22 ~~immigration status document issued by the United States Customs and~~
23 ~~Immigration Service; and~~
24

1 ~~2. A J-1 Exchange Visitor Program participant lawfully present~~
2 ~~in the United States as indicated on a valid and unexpired J-1~~
3 ~~Visitor Visa issued by the United States Customs and Immigration~~
4 ~~Service and who is enrolled in an agricultural education training~~
5 ~~program.~~

6 A person applying for such permit or license must comply with
7 all testing and licensing requirements in accordance with applicable
8 federal regulations, state laws and Service Oklahoma rules. The
9 issued license shall be valid until the expiration of the visa for
10 the non-domiciled worker. Service Oklahoma may promulgate rules for
11 the implementation of the process to carry out the provisions of
12 this section.

13 E. 1. Service Oklahoma shall develop a procedure whereby a
14 person applying for an original, renewal or replacement Class A, B,
15 C or D driver license or identification card who is required to
16 register as a convicted sex offender with the Department of
17 Corrections pursuant to the provisions of the Sex Offenders
18 Registration Act and who the Department of Corrections designates as
19 an aggravated or habitual offender pursuant to subsection J of
20 Section 584 of Title 57 of the Oklahoma Statutes shall be issued a
21 license or card bearing the words "Sex Offender".

22 2. Service Oklahoma shall notify every person subject to
23 registration under the provisions of Section 1-101 et seq. of this
24 title who holds a current Class A, B, C or D driver license or

1 identification card that such person is required to surrender the
2 license or card to Service Oklahoma within one hundred eighty (180)
3 days from the date of the notice.

4 3. Upon surrendering the license or card for the reason set
5 forth in this subsection, application may be made with Service
6 Oklahoma for a replacement license or card bearing the words "Sex
7 Offender".

8 4. Failure to comply with the requirements set forth in such
9 notice shall result in cancellation of the person's license or card.
10 Such cancellation shall be in effect for one (1) year, after which
11 time the person may make application with Service Oklahoma for a new
12 license or card bearing the words "Sex Offender". Continued use of
13 a canceled license or card shall constitute a misdemeanor and shall,
14 upon conviction thereof, be punishable by a fine of not less than
15 Twenty-five Dollars (\$25.00), nor more than Two Hundred Dollars
16 (\$200.00). When an individual is no longer required to register as
17 a convicted sex offender with the Department of Corrections pursuant
18 to the provisions of the Sex Offenders Registration Act, the
19 individual shall be eligible to receive a driver license or
20 identification card which does not bear the words "Sex Offender".

21 F. Nothing in subsection E of this section shall be deemed to
22 impose any liability upon or give rise to a cause of action against
23 any employee, agent or official of the Department of Corrections for
24 failing to designate a sex offender as an aggravated or habitual

1 offender pursuant to subsection J of Section 584 of Title 57 of the
2 Oklahoma Statutes.

3 G. A person subject to an order for the installation of an
4 ignition interlock device shall be required by Service Oklahoma to
5 submit his or her driver license for a replacement. The replacement
6 driver license shall bear the words "Interlock Required" and such
7 designation shall remain on the driver license for the duration of
8 the order requiring the ignition interlock device. The replacement
9 license shall be subject to the same expiration and renewal
10 procedures provided by law. Upon completion of the requirements for
11 the interlock device, a person may apply for a replacement driver
12 license.

15 license who has been granted modified driving privileges under this

4. Knowingly leaving the scene of a collision which occurs while operating a Class A, B or C commercial motor vehicle, or if the person is the holder of a commercial driver license, committing the offense while operating any vehicle;

5. Any felony during the commission of which a Class A, B or C commercial motor vehicle is used, except a felony involving the manufacture, distribution or dispensation of a controlled dangerous substance, or if the person is the holder of a commercial driver license, committing the offense while operating any vehicle;

6. Operating a commercial motor vehicle while the commercial driving privilege is revoked, suspended, canceled, denied, or disqualified;

7. Manslaughter homicide, or negligent homicide occurring as a direct result of negligent operation of a commercial motor vehicle, or, if the person is the holder of a commercial driver license, committing the offense while operating any vehicle;

8. Fraud related to examination for or issuance of a commercial learner permit or a Class A, B or C driver license; or

9. Failure to submit to skills or knowledge reexamination, or both, for the purpose of issuance of a commercial learner permit or a Class A, B or C driver license within thirty (30) days of receipt of notification from the Department.

1 C. ~~The Department of Public Safety~~ Service Oklahoma shall

6 Commissioner, to use a state-owned or state-leased vehicle to

12 SECTION 58. AMENDATORY 47 O.S. 2021, Section 584, as
13 last amended by Section 4, Chapter 192, O.S.L. 2022 (47 O.S. Supp.
14 2023, Section 584), is amended to read as follows:

15 Section 584. A. The Oklahoma Used Motor Vehicle ~~and Parts,~~
16 Dismantler, and Manufactured Housing Commission may deny an
17 application for a license, impose a fine not to exceed One Thousand
18 Dollars (\$1,000.00) per occurrence and/or revoke or suspend a
19 license after it has been granted, when any provision of Sections
20 581 through 588 of this title is violated or for any of the
21 following reasons:

22 1. On satisfactory proof of unfitness of the applicant or the
23 licensee, as the case may be, under the standards established by
24 Sections 581 through 588 of this title;

1 2. For fraud practices or any material misstatement made by an
2 applicant in any application for license under the provisions of
3 Sections 581 through 588 of this title;

4 3. For any willful failure to comply with any provision of
5 Section 581 et seq. of this title or with any rule promulgated by
6 the Commission under authority vested in it by Sections 581 through
7 588 of this title;

8 4. Change of condition after license is granted resulting in
9 failure to maintain the qualifications for license;

10 5. Continued or flagrant violation of any of the rules of the
11 Commission;

12 6. Being a used motor vehicle dealer, a used motor vehicle
13 salesperson, a wholesale used motor vehicle dealer, or a
14 manufactured home dealer, a restricted manufactured home park
15 dealer, a manufactured home installer, a manufactured home
16 salesperson or a manufactured home manufacturer who:

- 17 a. resorts to or uses any false or misleading advertising
18 in connection with business as a used motor vehicle
19 dealer, wholesale used motor vehicle dealer or a
20 restricted manufactured home park dealer or
21 manufactured home dealer, installer or manufacturer,
22 b. has committed any unlawful act which resulted in the
23 revocation of any similar license in another state,
24

- 1 c. has been convicted of a felony crime that
2 substantially relates to the occupation of a used
3 motor vehicle dealer, a wholesale used motor vehicle
4 dealer, a manufactured home dealer, a restricted
5 manufactured home park dealer, a manufactured home
6 installer or a manufactured home manufacturer and
7 poses a reasonable threat to public safety,
- 8 d. has committed a fraudulent act in selling, purchasing
9 or otherwise dealing in motor vehicles or manufactured
10 homes or has misrepresented the terms and conditions
11 of a sale, purchase or contract for sale or purchase
12 of a motor vehicle or manufactured home or any
13 interest therein including an option to purchase such
14 motor vehicles or manufactured homes,
- 15 e. has engaged in business under a past or present
16 license issued pursuant to Sections 581 through 588 of
17 this title, in such a manner as to cause injury to the
18 public or to those with whom the licensee is dealing,
- 19 f. has failed to meet or maintain the conditions and
20 requirements necessary to qualify for the issuance of
21 a license,
- 22 g. has failed or refused to furnish and keep in force any
23 bond required under Sections 581 through 588 of this
24 title,

1 h. has installed or attempted to install a manufactured
2 home in an unworkmanlike manner, or

3 i. employs a person in connection with the sale of
4 manufactured homes without first obtaining a
5 certificate of registration for the person;

6 7. Being a used motor vehicle dealer who:

7 a. does not have an established place of business,

8 b. employs a person in connection with the sale of used
9 vehicles without first obtaining a certificate of
10 registration for the person,

11 c. fails or refuses to furnish or keep in force single
12 limit liability insurance on any vehicle offered for
13 sale and otherwise required under the financial
14 responsibility laws of this state, or

15 d. is not operating from the address shown on the license
16 if this change has not been reported to the
17 Commission; or

18 8. Being a manufactured home dealer or a restricted
19 manufactured home park dealer who:

20 a. does not have an established place of business,

21 b. fails or refuses to furnish or keep in force garage
22 liability and completed operations insurance, or
23

1 c. is not operating from the address shown on the license
2 if this change has not been reported to the
3 Commission.

4 B. 1. The Commission shall deny an application for a license,
5 or revoke or suspend a license after it has been granted, if a
6 manufactured home dealer does not meet the following guidelines and
7 restrictions:

8 a. a display area for manufactured homes which is easily
9 accessible, with sufficient parking for the public,

10 b. an office for conducting business where the books,
11 records, and files are kept, with access to a restroom
12 for the public,

13 c. a place of business which meets all zoning, occupancy
14 and other requirements of the appropriate local
15 government and regular occupancy by a person, firm, or
16 corporation engaged in the business of selling
17 manufactured homes, and

18 d. a place of business which is separate and apart from
19 any other dealer's location.

20 2. The Commission shall deny an application for a restricted
21 manufactured home park dealer license, or revoke or suspend a
22 license after it has been granted, if a manufactured home park
23 dealer does not satisfy the following guidelines and restrictions:

- a. only mobile or manufactured homes that are "ready for occupancy" are sold or offered for sale,
- b. maintains an office for conducting business where the books, records, and files are kept, with access to a restroom for the public,
- c. maintains a place of business which meets all zoning, occupancy and other requirements of the appropriate local government and regular occupancy by a person, firm or corporation engaged in the business of selling manufactured homes inside a park, and
- d. maintains a place of business which is separate and apart from any other dealer's location.

C. The Commission shall deny an application for a license, or revoke or suspend a license after it has been granted, if a manufactured home installer:

1. Installs or attempts to install a manufactured home in a manner that is not in compliance with installation standards as set by the Commission pursuant to rule; or

2. Violates or fails to comply with any applicable rule as promulgated by the Commission concerning manufactured home installers.

D. The Commission shall deny an application for a license, or revoke or suspend a license after it has been granted, if a manufactured home manufacturer violates or fails to comply with any

1 applicable rule as promulgated by the Commission concerning
2 manufactured home manufacturers.

3 E. The Commission shall deny an application for a license by a
4 motor vehicle manufacturer or factory if the application is for the
5 purpose of selling used motor vehicles to any retail consumer in the
6 state, other than through its retail franchised dealers, or acting
7 as a broker between a seller and a retail buyer. This subsection
8 does not prohibit a manufacturer from selling used motor vehicles
9 where the retail customer is a nonprofit organization or a federal,
10 state, or local government or agency. This subsection does not
11 prohibit a manufacturer from providing information to a consumer for
12 the purpose of marketing or facilitating the sale of used motor
13 vehicles or from establishing a program to sell or offer to sell
14 used motor vehicles through the manufacturer's retail franchised
15 dealers as provided for in Sections 561 through 580.2 of this title.
16 This subsection shall not prevent a factory from obtaining a
17 wholesale used motor vehicle dealer's license or the factory's
18 financing subsidiary from obtaining a wholesale used motor vehicle
19 dealer's license.

20 F. If the Commission denies issuance of a license the
21 Commission shall provide the grounds for the action to the applicant
22 in writing and allow the applicant sixty (60) days to resolve any
23 issues that are the grounds for the action.

1 G. Each of the aforementioned grounds for suspension,
2 revocation, or denial of issuance or renewal of license shall also
3 constitute a violation of Sections 581 through 588 of this title,
4 unless the person involved has been tried and acquitted of the
5 offense constituting such grounds.

6 The suspension, revocation or refusal to issue or renew a
7 license or the imposition of any other penalty by the Commission
8 shall be in addition to any penalty which might be imposed upon any
9 licensee upon a conviction at law for any violation of Sections 581
10 through 588 of this title.

11 H. As used in this section:

12 1. "Substantially relates" means the nature of criminal conduct
13 for which the person was convicted has a direct bearing on the
14 fitness or ability to perform one or more of the duties or
15 responsibilities necessarily related to the occupation; and

16 2. "Poses a reasonable threat" means the nature of criminal
17 conduct for which the person was convicted involved an act or threat
18 of harm against another and has a bearing on the fitness or ability
19 to serve the public or work with others in the occupation.

4 Section 1102. As used in the Oklahoma Vehicle License and
5 Registration Act:

6 1. "All-terrain vehicle" means a vehicle manufactured and used
7 exclusively for off-highway use traveling on four or more non-
8 highway tires, and being fifty (50) inches or less in width;

9 2. "Carrying capacity" means the carrying capacity of a vehicle
10 as determined or declared in tons of cargo or payload by the owner;
11 provided, that such declared capacity shall not be less than the
12 minimum tonnage capacity fixed, listed or advertised by the
13 manufacturer of any vehicle;

14 3. "Certificate of title" means a document which is proof of
15 legal ownership of a motor vehicle as described and provided for in
16 Section 1105 of this title;

17 4. "Chips and oil" or the term "road oil and crushed rock"
18 means, with respect to materials authorized for use in the surfacing
19 of roads or highways as provided for in this title or in any
20 equivalent statute pertaining to road or highway surfacing in the
21 State of Oklahoma, any asphaltic materials. Wherever chips and oil
22 or road oil and crushed rock are authorized for use in the surfacing
23 of roads or highways in this state, whether by the Department of
24 Transportation, or by the county commissioners, or other road

1 building authority subject to the Oklahoma Vehicle License and
2 Registration Act, asphaltic materials are also authorized for use in
3 such surfacing and construction;

4 5. "Combined laden weight" means the weight of a truck or
5 station wagon and its cargo or payload transported thereon, or the
6 weight of a truck or truck-tractor plus the weight of any trailers
7 or semitrailers together with the cargo or payload transported
8 thereon;

9 6. "Commercial trailer" means any trailer, as defined in
10 Section 1-180 of this title, or semitrailer, as defined in Section
11 1-162 of this title, when such trailer or semitrailer is used
12 primarily for business or commercial purposes;

13 7. "Commercial trailer dealer" means any person, firm or
14 corporation engaged in the business of selling any new and unused,
15 or used, or both new and used commercial trailers;

16 8. "Commercial vehicle" means any vehicle over eight thousand
17 (8,000) pounds combined laden weight used primarily for business or
18 commercial purposes. Each motor vehicle being registered pursuant
19 to the provisions of this section shall have the name of the
20 commercial establishment or the words "Commercial Vehicle"
21 permanently and prominently displayed upon the outside of the
22 vehicle in letters not less than two (2) inches high. Such letters
23 shall be in sharp contrast to the background and shall be of
24 sufficient shape and color as to be readily legible during daylight

1 hours, from a distance of fifty (50) feet while the vehicle is not
2 in motion;

3 9. "Commission" or "Tax Commission" means the Oklahoma Tax
4 Commission;

5 10. "Construction machinery" means machines or devices drawn as
6 trailers which are designed and used for construction, tree trimming
7 and waste maintenance projects, which derive no revenue from the
8 transportation of persons or property, whose use of the highway is
9 only incidental and which are not mounted or affixed to another
10 vehicle; provided, construction machinery shall not include
11 implements of husbandry as defined in Section 1-125 of this title;

12 11. "Dealer" means any person, firm, association, corporation
13 or trust who sells, solicits or advertises the sale of new and
14 unused motor vehicles and holds a bona fide contract or franchise in
15 effect with a manufacturer or distributor of a particular make of
16 new or unused motor vehicle or vehicles for the sale of same;

17 12. "Mini-truck" means a foreign-manufactured import or
18 domestic-manufactured vehicle powered by an internal combustion
19 engine with a piston or rotor displacement of one thousand cubic
20 centimeters (1,000 cc) or less, which is sixty-seven (67) inches or
21 less in width, with an unladen dry weight of three thousand four
22 hundred (3,400) pounds or less, traveling on four or more tires,

3 13. "Interstate commerce" means any commerce moving between any
4 place in a state and any place in another state or between places in
5 the same state through another state;

6 14. "Laden weight" means the combined weight of a vehicle when
7 fully equipped for use and the cargo or payload transported thereon;
8 provided, that in no event shall the laden weight be less than the
9 unladen weight of the vehicle fully equipped for use, plus the
10 manufacturer's rated carrying capacity;

11 15. "Local authorities" means every county, municipality or
12 local board or body having authority to adopt police regulations
13 under the Constitution and laws of this state;

14 16. "Low-speed electrical vehicle" means any four-wheeled
15 electrical vehicle that is powered by an electric motor that draws
16 current from rechargeable storage batteries or other sources of
17 electrical current and whose top speed is greater than twenty (20)
18 miles per hour but not greater than twenty-five (25) miles per hour
19 and is manufactured in compliance with the National Highway Traffic
20 Safety Administration standards for low-speed vehicles in 49 C.F.R.
21 571.500;

22 17. "Manufactured home" means a residential dwelling built in
23 accordance with the National Manufactured Housing Construction and
24 Safety Standards Act of 1974, 42 U.S.C., Section 5401 et seq., and

1 rules promulgated pursuant thereto and the rules promulgated by the
2 Oklahoma Used Motor Vehicle ~~and Parts~~, Dismantler, and Manufactured
3 Housing Commission pursuant to Section 582 of this title.

4 Manufactured home shall not mean a park model recreational vehicle
5 as defined in this section;

6 18. "Manufactured home dealer" means any person, firm or
7 corporation engaged in the business of selling any new and unused,
8 or used, or both new and used manufactured homes. Such information
9 and a valid franchise letter as proof of authorization to sell any
10 such new manufactured home product line or lines shall be attached
11 to the application for a dealer license to sell manufactured homes.
12 "Manufactured home dealer" shall not include any person, firm or
13 corporation who sells or contracts for the sale of the dealer's own
14 personally titled manufactured home or homes. No person, firm or
15 corporation shall be considered a manufactured home dealer as to any
16 manufactured home purchased or acquired by such person, firm or
17 corporation for purposes other than resale; provided, that the
18 restriction set forth in this sentence shall not prevent an
19 otherwise qualified person, firm or corporation from utilizing a
20 single manufactured home as a sales office;

21 19. "Medium-speed electrical vehicle" means any self-propelled,

23 roll cage or crush-proof body design, whose speed attainable in one

1 (1) mile is more than thirty (30) miles per hour but not greater
2 than thirty-five (35) miles per hour;

3 20. "Licensed operator" means any person appointed, designated
4 or authorized by Service Oklahoma to collect the fees and to enforce
5 the provisions provided for in the Oklahoma Vehicle License and
6 Registration Act;

7 21. "New vehicle" or "unused vehicle" means a vehicle which has
8 been in the possession of the manufacturer, distributor or
9 wholesaler or has been sold only by the manufacturer, distributor or
10 wholesaler to a dealer;

11 22. "Nonresident" means any person who is not a resident of
12 this state;

13 23. "Off-road motorcycle" means any motorcycle, as defined in
14 Section 1-135 of this title, when such motorcycle has been
15 manufactured for and used exclusively off roads, highways and any
16 other paved surfaces;

17 24. "Owner" means any person owning, operating or possessing
18 any vehicle herein defined;

19 25. "Park model recreational vehicle" means a vehicle that is:

- 20 a. designed and marketed as temporary living quarters for
21 camping, recreational, seasonal or travel use,
- 22 b. not permanently affixed to real property for use as a
23 permanent dwelling,

- c. built on a single chassis mounted on wheels with a gross trailer area not exceeding four hundred (400) square feet in the setup mode, and
- d. certified by the manufacturer as complying with standard A119.5 of the American National Standards Institute, Inc.;

26. "Person" means any individual, copartner, joint venture, association, corporation, limited liability company, estate, trust, business trust, syndicate, the State of Oklahoma, or any county, city, municipality, school district or other political subdivision thereof, or any group or combination acting as a unit, or any receiver appointed by the state or federal court;

27. "Rebodied vehicle" means a vehicle:

- a. which has been assembled using a new body or new major component which is of the identical type as the original vehicle and is licensed by the manufacturer of the original vehicle and other original, new or reconditioned parts. For purposes of this paragraph, "new body or new major component" means a new body, cab, frame, front end clip or rear end clip,
- b. which is not a salvage, rebuilt, or junked vehicle as defined by paragraph 1, 2, or 6 of subsection A of Section 1105 of this title, and

1 c. for which Service Oklahoma has assigned or will assign
2 a new identifying number;

3 28. "Recreational off-highway vehicle" means a vehicle
4 manufactured and used exclusively for off-highway use, traveling on
5 four or more non-highway tires, and being sixty-five (65) inches or
6 less in width;

7 29. "Recreational vehicle" means every vehicle which is built
8 on or permanently attached to a self-propelled motor chassis or
9 chassis cab which becomes an integral part of the completed vehicle
10 and is capable of being operated on the highways. In order to
11 qualify as a recreational vehicle pursuant to this paragraph such
12 vehicle shall be permanently constructed and equipped for human
13 habitation, having its own sleeping and kitchen facilities,
14 including permanently affixed cooking facilities, water tanks and
15 holding tank with permanent toilet facilities. Recreational vehicle
16 shall not include manufactured homes or any vehicle with portable
17 sleeping, toilet and kitchen facilities which are designed to be
18 removed from such vehicle. Recreational vehicle shall include park
19 model recreational vehicles as defined in this section;

20 30. "Remanufactured vehicle" means a vehicle which has been
21 assembled by a vehicle remanufacturer using a new body and which may
22 include original, reconditioned, or remanufactured parts, and which
23 is not a salvage, rebuilt, or junked vehicle as defined by
24

1 paragraphs 1, 2, and 6, respectively, of subsection A of Section
2 1105 of this title;

3 31. "Rental trailer" means all small or utility trailers or
4 semitrailers constructed and suitable for towing by a passenger
5 automobile and designed only for carrying property, when the
6 trailers or semitrailers are owned by, or are in the possession of,
7 any person engaged in renting or leasing such trailers or
8 semitrailers for intrastate or interstate use or combined intrastate
9 and interstate use;

10 32. "Special mobilized machinery" means special purpose
11 machines or devices, either self-propelled or drawn as trailers or
12 semitrailers, which derive no revenue from the transportation of
13 persons or property, whose use of the highway is only incidental,
14 and whose useful revenue producing service is performed at
15 destinations in an area away from the traveled surface of an
16 established open highway;

17 33. "State" means the State of Oklahoma;

18 34. "Station wagon" means any passenger vehicle which does not
19 have a separate luggage compartment or trunk and which does not have
20 open beds, and has one or more rear seats readily lifted out or
21 folded, whether same is called a station wagon or ranch wagon;

22 35. "Street-legal utility vehicle" means a vehicle meeting the
23 description and specifications of Section 1-171.1 of this title;

1 36. "Travel trailer" means any vehicular portable structure
2 built on a chassis, used as a temporary dwelling for travel,
3 recreational or vacational use, and, when factory-equipped for the
4 road, it shall have a body width not exceeding eight (8) feet and an
5 overall length not exceeding forty (40) feet, including the hitch or
6 coupling;

7 37. "Travel trailer dealer" means any person, firm or
8 corporation engaged in the business of selling any new and unused,
9 or used, or both new and used travel trailers. Such information and
10 a valid franchise letter as proof of authorization to sell any such
11 new travel trailer product line or lines shall be attached to the
12 application for a dealer license to sell travel trailers. "Travel
13 trailer dealer" shall not include any person, firm or corporation
14 who sells or contracts for the sale of his or her own personally
15 titled travel trailer or trailers. No person, firm or corporation
16 shall be considered as a travel trailer dealer as to any travel
17 trailer purchased or acquired by such person, firm or corporation

24 "secondhand" vehicle. This shall also include any vehicle other

1 than a remanufactured vehicle, regardless of age, owned by any
2 person who is not a dealer;

3 40. "Utility vehicle" means a vehicle powered by an internal
4 combustion engine, manufactured and used exclusively for off-highway
5 use, equipped with seating for two or more people and a steering
6 wheel, traveling on four or more wheels;

7 41. "Vehicle" means any type of conveyance or device in, upon
8 or by which a person or property is or may be transported from one
9 location to another upon the avenues of public access within the
10 state. "Vehicle" does not include bicycles, trailers except travel
11 trailers and rental trailers, or implements of husbandry as defined
12 in Section 1-125 of this title. All implements of husbandry used as

2 last amended by Section 10, Chapter 47, 1st Extraordinary Session,
3 O.S.L. 2023 (47 O.S. Supp. 2023, Section 1104), is amended to read
4 as follows:

5 Section 1104. A. Unless otherwise provided by law, all fees,
6 taxes and penalties collected or received pursuant to the Oklahoma
7 Vehicle License and Registration Act or Section 1-101 et seq. of
8 this title shall be apportioned and distributed monthly by the
9 Oklahoma Tax Commission in accordance with this section. Service
10 Oklahoma shall provide to the Oklahoma Tax Commission monthly
11 reports of motor vehicle collection information, including, but not
12 limited to, motor vehicle monthly apportionment information,
13 refunds, canceled vouchers, waste tire collections, organ donor
14 program amounts, driver license records, prorate amounts, and sales
15 tax amounts. The reports shall be delivered electronically pursuant
16 to the current calendar year apportionment disbursement schedule
17 provided to Service Oklahoma by the Oklahoma Tax Commission on or
18 before December 1st annually.

19 One percent (1%) of fees collected shall be apportioned to the

1 B. 1. The following percentages of the monies referred to in

5 and forty-six one-hundredths percent (35.46%),

6 b. for the year beginning July 1, 2001, and ending June
7 30, 2002, thirty-five and ninety-one one-hundredths

22 percent (36.20%), but in no event shall the amount
23 apportioned in any fiscal year pursuant to this
24 subparagraph exceed the total amount apportioned for

1 the fiscal year ending on June 30, 2015. Any amounts
2 in excess of such limitation shall be placed to the
3 credit of the Rebuilding Oklahoma Access and Driver
4 Safety Fund created in Section 1521 of Title 69 of the
5 Oklahoma Statutes.

19 various counties based upon the proportion that each county's
20 population bears to the total state population.

21 Each county's allocation of funds shall be remitted to the
22 various county treasurers to be deposited in the general fund of the
23 county and used for the support of county government.

1 I. 1. The following percentages of the monies referred to in
2 subsection A of this section shall be apportioned to the various
3 cities and incorporated towns as set forth in paragraph 2 of this
4 subsection:

5 a. from October 1, 2000, until June 30, 2001, three and
6 four one-hundredths percent (3.04%),

7 b. for the year beginning July 1, 2001, and ending June
8 30, 2002, three and eight one-hundredths percent
9 (3.08%),

10 c. for the year beginning July 1, 2002, through the year
11 ending on June 30, 2015, three and ten one-hundredths
12 percent (3.10%),

13 d. for the year beginning July 1, 2015, through the year

3 Improvements for Roads and Bridges Fund, to the
4 various counties of the state. The Commission

18 SECTION 63. REPEALER 47 O.S. 2021, Section 1104, as
19 amended by Section 107, Chapter 282, O.S.L. 2022 (47 O.S. Supp.

21 SECTION 64. AMENDATORY 47 O.S. 2021, Section 1105, as
22 last amended by Section 110, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
23 2023, Section 1105), is amended to read as follows:

1 Section 1105. A. As used in the Oklahoma Vehicle License and
2 Registration Act:

3 1. "Salvage vehicle" means any vehicle which is within the last
4 ten (10) model years and which has been damaged by collision or
5 other occurrence to the extent that the cost of repairing the
6 vehicle for safe operation on the highway exceeds sixty percent
7 (60%) of its fair market value, as defined by Section 1111 of this
8 title, immediately prior to the damage. For purposes of this
9 section, actual repair costs shall only include labor and parts for
10 actual damage to the suspension, motor, transmission, frame or
11 unibody and designated structural components;

12 2. "Rebuilt vehicle" means any salvage vehicle which has been
13 rebuilt and inspected for the purpose of registration and title;

14 3. "Flood-damaged vehicle" means a salvage or rebuilt vehicle
15 which was damaged by flooding or a vehicle which was submerged at a
16 level to or above the dashboard of the vehicle and on which an
17 amount of loss was paid by the insurer;

18 4. "Unrecovered-theft vehicle" means a vehicle which has been
19 stolen and not yet recovered;

20 5. "Recovered-theft vehicle" means a vehicle, including a
21 salvage or rebuilt vehicle, which was recovered from a theft; and

22 6. "Junked vehicle" means any vehicle which is incapable of
23 operation or use on the highway, has no resale value except as a
24

1 source of parts or scrap and has an eighty percent (80%) loss in
2 fair market value.

3 B. The owner of every vehicle in this state shall possess a
4 certificate of title as proof of ownership of such vehicle, except
5 those vehicles registered pursuant to Section 1120 of this title and
6 trailers registered pursuant to Section 1133 of this title,
7 previously titled by anyone in another state and engaged in
8 interstate commerce, and except as provided in subsection M of this
9 section. Except for owners that possess an agricultural exemption
10 permit pursuant to Section 1358.1 of Title 68 of the Oklahoma
11 Statutes, the owner of an all-terrain vehicle or a motorcycle used
12 exclusively off roads or highways in this state which is purchased
13 or the ownership of which is transferred on or after July 1, 2005,
14 and the owner of a utility vehicle used exclusively off roads and
15 highways in this state which is purchased or the ownership of which
16 is transferred on or after July 1, 2008, shall possess a certificate
17 of title as proof of ownership. Any person possessing an
18 agricultural exemption permit and owning an all-terrain vehicle or a
19 motorcycle used exclusively off roads or highways in this state
20 which is purchased or the ownership of which is transferred on or
21 after July 1, 2008, shall possess a certificate of title as proof of
22 ownership. Upon receipt of proper application information by such
23 owner, Service Oklahoma shall issue an original or transfer
24 certificate of title. Until July 1, 2008, any security interest in

1 an all-terrain vehicle that attached and was perfected before July
2 1, 2005, and that has not otherwise terminated shall remain
3 perfected, and shall take priority over any subsequently perfected
4 security interest in the same all-terrain vehicle, notwithstanding
5 that a certificate of title may have been issued with respect to the
6 same all-terrain vehicle on or after July 1, 2005, and that a lien
7 may have been recorded on said certificate of title. There shall be
8 eight types of certificates of title:

9 1. Original title for any motor vehicle which is not a
10 remanufactured, salvage, unrecovered-theft, rebuilt, rebodied or
11 junked vehicle;

12 2. Salvage title for any motor vehicle which is a salvage
13 vehicle or is specified as a salvage vehicle or the equivalent
14 thereof on a certificate of title from another state;

15 3. Rebuilt title for any motor vehicle which is a rebuilt
16 vehicle;

17 4. Junked title for any motor vehicle which is a junked vehicle
18 or is specified as a junked vehicle or the equivalent thereof on a
19 certificate of title from another state;

20 5. Classic title for any motor vehicle, except a junked
21 vehicle, which is twenty-five (25) model years or older;

22 6. Remanufactured title for any vehicle which is a
23 remanufactured vehicle;

1 7. Unrecovered-theft title for any motor vehicle which has been
2 stolen and not recovered; and

3 8. Rebodied title for any motor vehicle which is a rebodied
4 vehicle.

5 Application for a certificate of title, whether the initial
6 certificate of title or a duplicate, may be made to Service Oklahoma
7 or any licensed operator. When application is made with a licensed
8 operator, the application information shall be transmitted either
9 electronically or by mail to Service Oklahoma by the licensed
10 operator. If the application information is transmitted
11 electronically, the licensed operator shall forward the required
12 application along with evidence of ownership, where required, by
13 mail. Where the transmission of application information cannot be
14 performed electronically, Service Oklahoma is authorized to provide
15 postage paid envelopes to licensed operators for the purpose of
16 mailing the application along with evidence of ownership, where
17 required. Service Oklahoma shall upon receipt of proper application
18 information issue an Oklahoma certificate of title. The
19 certificates may be mailed to the applicant. Upon issuance of a
20 certificate of title, Service Oklahoma shall provide the appropriate
21 licensed operator with confirmation of such issuance.

22 C. 1. The application for certificate of title shall be upon a
23 blank form furnished by Service Oklahoma, containing:

24 a. a full description of the vehicle,

- b. the manufacturer's serial or other identification number,
- c. the motor number and the date on which first sold by the manufacturer or dealer to the owner,
- d. any distinguishing marks,
- e. a statement of the applicant's source of title,
- f. any security interest upon the vehicle, and
- g. such other information as Service Oklahoma may require.

2. The application for a certificate of title for a vehicle which is within the last seven (7) model years shall require a declaration as to whether the vehicle has been damaged by collision or other occurrence and whether the vehicle has been recovered from theft and the extent of the damage to the vehicle. The declaration shall be made by the owner of a vehicle if:

- a. the vehicle has been damaged or stolen,
- b. the owner did or did not receive any payment for the loss from an insurer, or
- c. the vehicle is titled or registered in a state that does not classify the vehicle or brand the title because of damage to or loss of the vehicle similar to the classifications or brands utilized by this state.

The declaration shall be based upon the best information and knowledge of the owner and shall be in addition to the requirements

1 specified in paragraph 1 of this subsection. Service Oklahoma shall
2 not issue a certificate of title for a vehicle which is subject to
3 the provisions of this paragraph without the required declaration,
4 completed and signed by the owner of the vehicle. Upon receipt of
5 an application without the properly completed declaration, Service
6 Oklahoma shall return the application to the applicant with notice
7 that the title may not be issued without the required declaration.
8 Nothing in this paragraph shall prohibit Service Oklahoma from
9 recognizing the type of or brand on a title or other ownership
10 document issued by another state or the inspection conducted in
11 another state and issuing the appropriate certificate of title for
12 the vehicle.

13 3. The certificate of title shall have the following security
14 features:

- 15 a. intaglio printing or security thread, with or without
- 16 watermark,
- 17 b. latent images,
- 18 c. fluorescent inks,
- 19 d. micro print,
- 20 e. void background, and
- 21 f. color coding.

22 4. Each title issued pursuant to the provisions of the Oklahoma
23 Vehicle License and Registration Act shall be color coded as
24 determined by Service Oklahoma.

1 5. The certificate of title shall be of such size and design
2 and color as Service Oklahoma may direct pursuant to the provisions
3 of this section. The title shall be on colored paper or other
4 material as designated by Service Oklahoma and be of such intensity
5 or hue as will allow easy identification as to whether the title is
6 an original title, a salvage title, a rebuilt title, remanufactured
7 title, rebodied title or a junked title. The type of title shall be
8 identified on the front of the certificate of title. The original
9 title, rebuilt title, remanufactured title, an unrecovered-theft
10 title, rebodied title or classic title shall be identified by the
11 word "Original", "Rebuilt", "Remanufactured", "Unrecovered Theft",
12 "Rebodied" or "Classic" printed in the upper right quadrant of the
13 certificate of title, in the space which is currently captioned
14 "type of title". A rebodied title shall also identify on the front
15 of the title the year, make and model of the originally manufactured
16 vehicle which has been rebodied and display a notation that reads as
17 follows: "This vehicle has been assembled with new major components
18 licensed by the original manufacturer."

19 D. 1. To obtain an original certificate of title for a vehicle
20 that is being registered for the first time in this state which has
21 not been previously registered in any other state, the applicant
22 shall be required to deliver, as evidence of ownership, a
23 manufacturer's certificate of origin properly assigned by the
24 manufacturer, distributor, or dealer licensed in this or any other

1 state shown thereon to be the last transferee to the applicant upon
2 a form to be prescribed and approved by Service Oklahoma. A
3 manufacturer's certificate of origin shall contain:

- 4 a. the manufacturer's serial or other identification
5 number,
- 6 b. date on which first sold by the manufacturer to the
7 dealer,
- 8 c. any distinguishing marks including model and the year
9 same was made,
- 10 d. a statement of any security interests upon the
11 vehicle, and
- 12 e. such other information as Service Oklahoma may
13 require.

14 2. The manufacturer's certificate of origin shall have the
15 following security features:

- 16 a. intaglio printing or security thread, with or without
17 watermark,
- 18 b. latent images,
- 19 c. fluorescent inks,
- 20 d. micro print, and
- 21 e. void background.

22 E. In the absence of a dealer's or manufacturer's number,
23 Service Oklahoma may assign such identifying number to the vehicle,
24 which shall be permanently stamped, burned or pressed or attached

1 into the vehicle, and a certificate of title shall be delivered to
2 the applicant upon payment of all fees and taxes, and the remaining
3 copies shall be permanently filed and indexed by Service Oklahoma.
4 Service Oklahoma shall assign an identifying number to any rebuilt
5 vehicle if the vehicle identification number displayed on the
6 rebuilt vehicle does not accurately describe the vehicle as rebuilt.
7 The licensed operator, at the time of inspection of the rebuilt
8 vehicle pursuant to Section 1111 of this title, shall identify the
9 make, model, and year for the body to accurately describe the
10 rebuilt vehicle. At the time of the inspection, an appropriate
11 identifying number shall be permanently stamped, burned, pressed, or
12 attached on the rebuilt vehicle. The assigned identifying number
13 shall be recorded on the certificate of title for the rebuilt
14 vehicle. The dealer's or manufacturer's vehicle identification
15 number on the rebuilt vehicle shall be preserved in the computer
16 files of Service Oklahoma for at least five (5) years.

17 F. When registering for the first time in this state a vehicle
18 which was not originally manufactured for sale in the United States,
19 to obtain a certificate of title, Service Oklahoma shall require the
20 applicant to deliver:

21 1. As evidence of ownership, if the vehicle has not previously
22 been titled in the United States, the documents constituting valid
23 proof of ownership in the country in which the vehicle was
24

1 originally purchased, together with a notarized translation of any
2 such documents; and

3 2. As evidence of compliance with federal law, copies of the
4 bond release letters for the vehicle issued by the United States
5 Environmental Protection Agency and the United States Department of
6 Transportation, together with a receipt issued by the Internal
7 Revenue Service indicating that the applicable federal gas guzzler
8 tax has been paid.

9 Service Oklahoma shall not issue a certificate of title for a
10 vehicle which is subject to the provisions of this paragraph without
11 the required documentation from agencies of the United States and
12 evidence of ownership. Upon receipt of an application without the
13 required documentation, Service Oklahoma shall return the
14 application to the applicant with notice that the certificate of
15 title may not be issued without the required documentation. Nothing
16 in this paragraph shall prohibit Service Oklahoma from issuing
17 certificates of title for antique or classic vehicles not driven
18 upon the public streets, roads, or highways, for mini-trucks
19 registered pursuant to Section 1151.3 of this title, or for medium-
20 speed electric vehicles.

21 G. When registering in this state a vehicle which was titled in
22 another state and which title contains the name of a secured party
23 on the face of the other state certificate of title, or such state
24 certificate is being held by the secured party in that state or any

1 other state, Service Oklahoma or the licensed operator shall
2 complete a lien entry form as prescribed by Service Oklahoma. The
3 owner of such vehicle shall file an affidavit with Service Oklahoma
4 or the licensed operator stating that title to the vehicle is being
5 held by a secured party, has not been issued pursuant to the laws of
6 the state where titled, and that there is an existing lien or
7 encumbrance on the vehicle. The current name and address of the
8 secured party or lienholder shall also be stated in the affidavit.
9 The form of the affidavit shall be prescribed by Service Oklahoma
10 and contain any other information deemed necessary by Service
11 Oklahoma. A statement of the lien or encumbrance shall be included
12 on the Oklahoma certificate of title and the lien or encumbrance
13 shall be deemed continuously perfected as though it had been
14 perfected pursuant to Section 1110 of this title. For completing
15 the lien entry form and recording the security interest on the
16 certificate of title, Service Oklahoma or the licensed operator
17 shall collect a fee of Three Dollars (\$3.00) which shall be in
18 addition to other fees provided by the Oklahoma Vehicle License and
19 Registration Act. The fee, if collected by the licensed operator
20 pursuant to this subsection, shall be retained by the licensed
21 operator.

22 H. The charge for each certificate of title issued, except for
23 junked titles as defined in paragraph 4 of subsection B of this
24 section, shall be Eleven Dollars (\$11.00), which charge shall be in

1 addition to any other fees or taxes imposed by law for such vehicle.
2 One Dollar (\$1.00) of each such charge shall be deposited in the
3 Oklahoma Tax Commission Reimbursement Fund through December 31,
4 2022, and beginning January 1, 2023, it shall be deposited in the
5 Service Oklahoma Reimbursement Fund. However, the charge shall not
6 apply to any vehicle which is to be registered in this state
7 pursuant to the provisions of Section 1120 or 1133 of this title and
8 which was registered in another state at least sixty (60) days prior
9 to the time it is required to be registered in this state. When an
10 insurer requests a salvage or junk title in the name of the insurer
11 resulting from the settlement of a total loss claim and upon
12 presentation of appropriate proof of loss documentation as required
13 by Service Oklahoma, such transfer may be processed as one title
14 transaction, without first requiring issuance of a replacement
15 certificate of title in the name of the vehicle owner. The fee
16 shall be Twenty-two Dollars (\$22.00). Two Dollars (\$2.00) of this
17 fee shall be deposited in the Oklahoma Tax Commission Reimbursement
18 Fund.

19 I. The vehicle identification number of a junked vehicle shall
20 be preserved in the computer files of Service Oklahoma for a period
21 of not less than five (5) years. The charge of junked titles as
22 defined in paragraph 4 of subsection B of this section shall be Four
23 Dollars (\$4.00). The fee remitted to the Tax Commission shall be
24 deposited in the Oklahoma Tax Commission Reimbursement Fund through

1 December 31, 2022, and beginning January 1, 2023, this fee shall be
2 deposited in the Service Oklahoma Reimbursement Fund.

3 J. If a vehicle is sold to a resident of another state
4 destroyed, dismantled, or ceases to be used as a vehicle, the owner
5 shall immediately notify Service Oklahoma. Absent evidence to the
6 contrary, failure to notify Service Oklahoma shall be prima facie
7 evidence that the vehicle has been in continuous operation in this
8 state.

9 K. If a vehicle is stolen, the owner shall immediately notify
10 the appropriate law enforcement agency. Immediately after receiving
11 such notification, the law enforcement agency shall notify Service
12 Oklahoma.

13 L. Except for all-terrain vehicles, utility vehicles and
14 motorcycles used exclusively for off-road use, no title for an out-
15 of-state vehicle, except any commercial truck or truck-tractor
16 registered pursuant to Section 1120 of this title which is engaged
17 in interstate commerce or any trailer or semitrailer registered
18 pursuant to Section 1133 of this title which is engaged in
19 interstate commerce, shall be issued without an inspection of such
20 vehicle and payment of a fee of Four Dollars (\$4.00) for such
21 inspection; provided, Service Oklahoma may enter into reciprocal
22 agreements with other states for such inspections to be performed at
23 locations outside the boundaries of this state for vehicles which:

24 1. Are offered for sale at auction;

1 2. Have been solely used as vehicles for rent under the
2 ownership of a licensed motor vehicle dealer or a person engaged in
3 the business of renting motor vehicles; or

4 3. Have not been registered in this or any other state for more
5 than one (1) year.

6 The inspection shall include a comparison of the vehicle
7 identification number on the vehicle with the number recorded on the
8 ownership records and the recording of the actual odometer reading
9 on the vehicle. An establishment engaged in vehicle rentals as
10 defined or classified in the NAICS Manual under Industry No. 532111,
11 shall be exempt from the inspection required pursuant to this
12 subsection; provided, the establishment shall be required to submit
13 payment of any fees required pursuant to this subsection when the
14 title is issued. The four-dollar fee shall be collected by the
15 licensed operator or Service Oklahoma when the title is issued. The
16 licensed operator shall retain Two Dollars (\$2.00). The remaining
17 Two Dollars (\$2.00) shall be deposited in the Oklahoma Tax
18 Commission Reimbursement Fund through December 31, 2022, and
19 beginning January 1, 2023, this fee shall be deposited in the
20 Service Oklahoma Reimbursement Fund.

21 Service Oklahoma may allow the inspection to be performed at a
22 location out-of-state by another state's department of motor
23 vehicles or state police.

1 M. No title for any out-of-state vehicle offered for sale at
2 salvage pools, salvage disposal sales, or an auction, or by a dealer
3 or a licensed automotive dismantler and parts recycler, shall be
4 issued without an inspection to compare the vehicle identification
5 number on the vehicle with the number recorded on the ownership
6 record and to record the actual odometer reading on the vehicle.
7 Upon request of the seller, person or entity conducting an auction,
8 dealer or licensed dismantler, the inspection shall be conducted at
9 the location or place of business of the sale, auction, dealer, or
10 the dismantler. The inspection shall be conducted by any licensed
11 operator or a duly authorized employee thereof; provided, if the
12 vehicle identification number on the vehicle offered for sale at
13 salvage pools, salvage disposal sales or a classic or antique
14 auction does not match the number recorded on the ownership record,
15 the inspection may be conducted at the location of or place of
16 business of such sale or auction by any state, county or city law
17 enforcement officer. Service Oklahoma may enter into reciprocal
18 agreements with other states for such inspections to be performed at
19 locations outside the boundaries of this state for vehicles which:
20 1. Are offered for sale at auction;
21 2. Have been solely used as vehicles for rent under the
22 ownership of a licensed motor vehicle dealer or a person engaged in
23 the business of renting motor vehicles; or
24

1 3. Have not been registered in this or any other state for more
2 than one (1) year.

3 The inspection shall be certified upon forms prescribed by Service
4 Oklahoma. The name and other identification of the authorized
5 person conducting the inspection shall be legibly printed or typed
6 on the form. Prior to any inspection by any employee of a licensed
7 operator, the licensed operator shall notify Service Oklahoma of the
8 name and any other identification information requested by Service
9 Oklahoma of the authorized person. A signature specimen of the
10 authorized person shall be submitted to Service Oklahoma by the
11 employing licensed operator. If the authorization to inspect
12 vehicles is withdrawn or the employer-employee relationship is
13 terminated, the licensed operator, immediately, shall notify Service
14 Oklahoma and return any remaining inspection forms to Service
15 Oklahoma. The fee for the inspection shall be Four Dollars (\$4.00).
16 The licensed operator shall retain Three Dollars (\$3.00) of the fee.
17 Fees received by a licensed operator or an authorized employee
18 thereof shall be handled and accounted for in the manner as
19 prescribed by law for any other fees paid to or received by a
20 licensed operator. Out-of-state vehicles brought into this state by
21 a person licensed in another state to sell new or used vehicles to
22 be sold within this state at a motor vehicle auction which is
23 limited to dealer-to-dealer transactions shall not be required to be
24 inspected, unless the vehicle is purchased by an Oklahoma dealer.

1 Any person licensed in another state to sell new or used motor
2 vehicles, who offers a motor vehicle for sale within this state at a
3 motor vehicle auction which is limited to dealer-to-dealer
4 transactions, shall not be within the definition of "owner" in
5 Section 1102 of this title, for purposes of Section 1101 et seq. of
6 this title.

7 N. A licensed motor vehicle dealer, upon payment of a fee of
8 Fifteen Dollars (\$15.00), may reassign an out-of-state certificate
9 of title to a used motor vehicle provided such dealer obtains the
10 appropriate inspection form required by either subsection L or M of
11 this section and attaches the form to the out-of-state certificate
12 of title. Licensed operators shall be allowed to retain Two Dollars
13 and twenty-five cents (\$2.25) of the fee plus an additional Two
14 Dollars (\$2.00) or Three Dollars (\$3.00) as provided in subsections
15 L and M of this section for performance of the inspection. Two
16 Dollars (\$2.00) of the fee shall be deposited in the Service
17 Oklahoma Reimbursement Fund. An out-of-state vehicle which has been
18 rebuilt shall be inspected pursuant to the provisions of Section
19 1111 of this title. Service Oklahoma shall train licensed operators
20 in interpreting vehicle identification numbers to assure that it
21 accurately describes the vehicle and to detect rollback or
22 alteration of the odometer. Failure of a licensed operator to
23 inspect the vehicle and make the required notations shall be a
24 misdemeanor punishable by a fine of not more than One Thousand

1 Dollars (\$1,000.00) for the first offense and Five Thousand Dollars
2 (\$5,000.00) for the second offense or subsequent offense, or by
3 imprisonment in the county jail for not more than six (6) months, or
4 by both such fine and imprisonment.

5 O. The ownership of any unrecovered vehicle which has been
6 declared a total loss by an insurer because of theft shall be
7 transferred to the insurer by an unrecovered-theft vehicle title;
8 provided, the ownership of any such vehicle which has been declared
9 a total loss by an insurer licensed by the Insurance Department of
10 the State of Oklahoma and maintaining a multi-state motor vehicle
11 salvage processing center in this state shall be transferred to the
12 insurer by a salvage or an unrecovered-theft title without the
13 requirement of a visual inspection of the vehicle identification
14 number by the insurer. Upon recovery of the vehicle, the ownership
15 shall be transferred by an original title, salvage title, or junked
16 title, as may be appropriate based upon an estimate of the amount of
17 loss submitted by the insurer.

18 P. When an insurance company makes a total loss settlement on a
19 total loss vehicle and the insurance company or a salvage pool
20 authorized by the insurance company is unable to obtain the properly
21 endorsed certificate of ownership or other evidence of ownership
22 acceptable to Service Oklahoma within thirty (30) days following
23 acceptance by the owner of an offer of an amount in settlement of a
24 total loss, that insurance company or salvage pool, on a form

1 provided by Service Oklahoma and signed under penalty of perjury,
2 may request Service Oklahoma to issue the applicable salvage title
3 for the vehicle. The request shall include information declaring
4 that the requester has made at least two written attempts to obtain
5 the certificate of ownership or other acceptable evidence of title.

6 Q. The owner of any vehicle which is incapable of operation or
7 use on the public roads and has no resale value, except as parts,
8 scrap, or junk, may deliver the certificate of title to the vehicle
9 to Service Oklahoma for cancellation. Upon verification that any
10 perfected lien against the vehicle has been released, the
11 certificate of title shall be canceled without any fee, charge, or
12 cost required from the owner. The vehicle identification numbers on
13 the certificates of title shall be preserved in the computer files
14 of Service Oklahoma for at least five (5) years from the date of
15 cancellation of the certificate of title. Service Oklahoma shall
16 prescribe and provide an affidavit form to be completed by the owner
17 of any vehicle for which the certificate of title is canceled. No
18 title or registration shall subsequently be issued for a vehicle for
19 which the certificate of title has been surrendered pursuant to this
20 subsection. Service Oklahoma shall prescribe a form for the
21 transfer of ownership of a vehicle for which the certificate of
22 title has been canceled.

23 R. The owner of a vehicle which is not within the last ten (10)
24 model years, not roadworthy and not capable of repair for operation

1 or use on the roads and highways, or a vehicle which is being sold
2 to a scrap metal dealer pursuant to Section 11-92 of Title 2 of the
3 Oklahoma Statutes, shall transfer the vehicle only upon a
4 certificate of ownership prescribed by Service Oklahoma, if the
5 certificate of title to the vehicle is lost, has been canceled, or
6 otherwise not available. The prescribed ownership form shall
7 include the names and addresses of the buyer and seller, the driver
8 license number or Social Security number of the seller, the make and
9 model of the vehicle, and the public vehicle identification number.
10 If there is no public vehicle identification number, the vehicle
11 shall be inspected by a law enforcement officer to verify the
12 absence of the number on the vehicle and the prescribed ownership
13 form shall include a signed statement, by such officer, verifying
14 the absence of the number.

15 The certificate of ownership shall be completed in triplicate.
16 The buyer and seller shall each retain a copy. Within thirty (30)
17 days of the transaction, the seller shall submit one copy to Service
18 Oklahoma or a licensed operator accompanied with a fee of Four
19 Dollars (\$4.00). One Dollar (\$1.00) shall be retained by the
20 licensed operator and Three Dollars (\$3.00) shall be deposited in
21 the Oklahoma Tax Commission Reimbursement Fund in the State Treasury
22 through December 31, 2022, and beginning January 1, 2023, this fee
23 shall be deposited in the Service Oklahoma Reimbursement Fund.

24

1 Upon receipt of the certificate, Service Oklahoma shall verify
2 that any perfected lien upon the vehicle has been released. If the
3 lien is not released, Service Oklahoma shall mail notice of the
4 transfer to the lienholder at the lienholder's last-known address.
5 If a certificate of title has been issued, it shall be canceled and
6 the vehicle identification number shall be preserved in the computer
7 of Service Oklahoma for at least five (5) years. The buyer of the
8 vehicle may not be sued and shall not be liable for monetary damages
9 to the lienholder, however, the vehicle shall be subject to a valid
10 repossession by a lienholder.

11 S. Service Oklahoma shall notify the chief administrative
12 officer of the agency or department responsible for issuing motor
13 vehicle certificates of title in each state in the United States of
14 the types of motor vehicle certificate of title effective in
15 Oklahoma on and after January 1, 1989.

16 T. When registering for the first time in this state a
17 remanufactured vehicle which has not been registered in any other
18 state since its remanufacture, before issuing a certificate of
19 title, Service Oklahoma shall require the applicant to deliver a
20 statement of origin from the remanufacturer.

21 U. If a vehicle is sold to a foreign buyer pursuant to the
22 provisions of the Automotive Dismantlers and Parts Recycler Act, the
23 licensed seller shall stamp the title with: "EXPORT ONLY.
24 NONTRANSFERABLE IN THE UNITED STATES." The licensed seller shall

1 supply Service Oklahoma the title number, the vehicle identification
2 number and the foreign buyer's bid identification number on a form
3 prescribed by Service Oklahoma. Service Oklahoma shall cancel the
4 title, and the vehicle identification number shall be preserved in
5 the computer files of Service Oklahoma for a period of not less than
6 five (5) years.

7 V. Service Oklahoma shall not be considered a necessary party
8 to any lawsuit which is instigated for the purpose of determining
9 ownership of a vehicle, wherein Service Oklahoma's only involvement
10 would be to issue title, and the court shall issue an order
11 dismissing Service Oklahoma from the pending action. In the event
12 no other party or lienholder can be identified as to ownership or
13 claim, Service Oklahoma shall accept an affidavit of ownership from
14 the party claiming ownership and issue proper title thereon.

15 SECTION 65. REPEALER 47 O.S. 2021, Section 1105, as
16 amended by Section 1, Chapter 47, O.S.L. 2022 (47 O.S. Supp. 2023,
17 Section 1105), is hereby repealed.

18 SECTION 66. AMENDATORY 47 O.S. 2021, Section 1105A, as
19 last amended by Section 1, Chapter 366, O.S.L. 2023 (47 O.S. Supp.
20 2023, Section 1105A), is amended to read as follows:

21 Section 1105A. A. On or before July 1, 2023, Service Oklahoma
22 shall implement a program which will permit the electronic filing,
23 storage, and delivery of motor vehicle certificates of title and
24 allow a lienholder to perfect, assign and release a lien on a motor

1 vehicle in lieu of submission and maintenance of paper documents as
2 otherwise provided in the provisions of Section 1101 et seq. of this
3 title. Service Oklahoma may:

4 1. Enter into a competitive contract with a qualified third-
5 party service provider (System Developer), subject to the provisions
6 of the Oklahoma Central Purchasing Act, Section 85.1 et seq. of
7 Title 74 of the Oklahoma Statutes;

8 2. Act as the service provider; or

9 3. Authorize proprietary provider systems by Oklahoma financial
10 institutions,

11 to provide necessary hardware, software and services facilitating
12 the interconnection between licensed operators and electronic title
13 service providers described in subsection B of this section for a
14 certificate of title and for filing or releasing a lien pursuant to
15 the procedures prescribed by Service Oklahoma. The provisions of
16 this section shall apply to ~~applications for~~ certificates of title
17 issued and liens filed after June 30, 2022. Service Oklahoma shall
18 promulgate rules to implement the provisions of this section.

19 B. The program authorized under subsection A of this section
20 shall include, but not be limited to, procedures:

21 1. For the delivery of a certificate of title, on a paper
22 document or in an electronic format, to the secured party having the
23 primary perfected security interest in a vehicle in lieu of delivery
24 to the record owner, notwithstanding the provisions of Section 1101

et seq. of this title. When there is no security interest, lien, or other encumbrance on the vehicle, delivery of a certificate of title, on a paper document or in an electronic format, shall be made to the record owner. Provided, when electronic transmission of liens and lien satisfactions is used, a certificate of title need not be issued or printed until the last lien is satisfied and a clear certificate of title is issued to the owner of the vehicle at their request;

2. Establishing qualifications for third-party electronic title service providers offering electronic lien services. The vendor selected in subsection A of this section shall not be considered an electronic title service provider and shall not operate or own an electronic title service provider;

3. Establishing reasonable fees, if necessary, to be charged by service providers or contractors for the establishment, maintenance and operation of the electronic lien title program;

4. Providing access to the electronic certificate of title records including liens on record, for licensed motor vehicle dealers and lienholders who participate in the program notwithstanding the provisions of Section 1109 of this title;

5. Allowing licensed operators to participate in the electronic lien title program. Participating licensed operators shall receive all fees provided by the Oklahoma Vehicle License and Registration Act unless otherwise provided in Section 1132A of this title; and

1 6. For the acceptance and use of electronic or digital
2 signatures.

3 C. As used in this section and Section 1101 et seq. of this
4 title:

5 1. "Deliver" or "delivery" means, with respect to a certificate
6 of title or lien, either the physical delivery of a paper document
7 or the electronic delivery of a document in an electronic format;

8 2. "Electronic format" means an electronic or digital format or
9 medium of any document, record or other information; and

10 3. "Possess" or "possession" means, with respect to a
11 certificate of title or lien, to hold or otherwise exercise control
12 over a document which is in either a physical or electronic format.

13 D. Any documents created, stored or delivered under the
14 electronic lien title program as provided in this section shall be
15 ~~considered~~ presumed valid including any signatures which are
16 generated electronically or contained on a scanned copy. A
17 certified copy of Service Oklahoma's electronic record of a motor
18 vehicle certificate of title or lien is admissible in any civil,
19 criminal, or administrative proceeding in this state as evidence of
20 the existence and contents of the certificate of title or lien.

21 E. The Tax Commission is authorized to expend funds necessary
22 for the implementation of the program provided in subsection A of
23 this section from available monies in the Oklahoma Tax Commission
24 and Office of Management and Enterprise Services Joint Computer

1 Enhancement Fund created pursuant to Section 265 of Title 68 of the
2 Oklahoma Statutes.

3 F. In the development of the program provided in subsection A
4 of this section, the Oklahoma Tax Commission shall consult
5 interested parties including, but not limited to, representatives of
6 the Oklahoma Automobile Dealers Association, the Oklahoma Bankers
7 Association, the ~~Oklahoma~~ Credit Union Association of Oklahoma and
8 the ~~Oklahoma~~ Tag Agent Coalition.

9 G. All documents submitted electronically pursuant to the
10 provisions of subsection A shall not require notarization.

11 H. All documents submitted pursuant to the provisions of this
12 section shall be retained pursuant to the provision of subsection A
13 of this section.

14 I. Submission and maintenance of paper documents as otherwise
15 provided in this provisions of Section 1101 et seq. of this title
16 shall be accepted through June 30, 2025.

21 last amended by Section 2, Chapter 366, O.S.L. 2023 (47 O.S. Supp.
22 2023, Section 1107), is amended to read as follows:

23 Section 1107. A. In the event of the sale or transfer of the
24 ownership of a vehicle for which a certificate of title has been

1 issued as provided by Section 1105 of this title, the holder of such
2 certificate shall endorse on the back of same a complete assignment
3 thereof with warranty of title in form printed thereon with a
4 statement of all liens or encumbrances on the vehicle, sworn to
5 before a notary public or some other person authorized by law to
6 take acknowledgments, and deliver same to the purchaser or
7 transferee at the time of delivery to the purchaser or transferee of
8 the vehicle; provided, a transfer of the ownership of a vehicle to
9 an insurer resulting from the settlement of a total loss claim shall
10 not require a notarized signature on the certificate of title. In
11 the event that any other documents used for a transfer of the
12 ownership of a vehicle to an insurer resulting from the settlement
13 of a total loss claim require a notarized signature, the documents
14 shall be permitted to be signed electronically pursuant to Section
15 15-109 of Title 12A of the Oklahoma Statutes. These supporting
16 documents shall include but are not limited to vehicle powers of
17 attorney forms and an odometer statement. The purchaser or
18 transferee, unless such person is a bona fide used motor vehicle
19 dealer licensed by this state, a retail implement dealer in
20 connection with the purchase or transfer of off-road vehicles or a
21 charitable organization shall, within thirty (30) days from the time
22 of delivery to the purchaser or transferee of the vehicle, present
23 the assigned certificate of title and the insurance security
24 verification to the vehicle to Service Oklahoma, or one of its

1 licensed operators, accompanied by a fee of Eleven Dollars (\$11.00),
2 together with any motor vehicle excise tax or license fee that may
3 be due, whereupon a new certificate of title, shall be issued to the
4 assignee. One Dollar (\$1.00) of each fee shall be deposited in the
5 Oklahoma Tax Commission Reimbursement Fund through December 31,
6 2022, and beginning January 1, 2023, this fee shall be deposited in
7 the Service Oklahoma Reimbursement Fund. Any charitable
8 organization utilizing the exemption authorized by this subsection
9 shall receive training as prescribed by the Oklahoma Used Motor
10 Vehicle ~~and Parts~~, Dismantler, and Manufactured Housing Commission.

11 B. A licensed dealer, a retail implement dealer in connection
12 with the sale or disposal of off-road vehicles or a charitable
13 organization shall, on selling or otherwise disposing of a vehicle,
14 execute and deliver to the purchaser thereof the certificate of
15 title properly and completely reassigned. Thereupon, the purchaser
16 of the vehicle shall present the reassigned certificate to Service
17 Oklahoma, or a licensed operator, accompanied by a fee of Eleven
18 Dollars (\$11.00), and any motor vehicle excise tax or license fee
19 that may be due, whereupon a new certificate of title will be issued
20 to the purchaser. One Dollar (\$1.00) of each fee shall be deposited
21 in the Oklahoma Tax Commission Reimbursement Fund through December
22 31, 2022, and beginning January 1, 2023, this fee shall be deposited
23 in the Service Oklahoma Reimbursement Fund. The certificate, when
24 so assigned and returned to Service Oklahoma, together with any

1 subsequent assignment or reissue thereof, shall be appropriately
2 filed and indexed so that at all times it will be possible to trace
3 title to the vehicle designated therein. Provided, when the
4 ownership of any motor vehicle shall pass by operation of law, the
5 person owning the vehicle may, upon furnishing satisfactory proof to
6 Service Oklahoma of ownership, procure a title to the motor vehicle,
7 regardless of whether a certificate of title has ever been issued.
8 The dealer shall execute and deliver to the purchaser bills of sale
9 on forms prescribed by Service Oklahoma for all new vehicles sold by
10 the dealer. On presentation of a bill of sale executed on forms
11 prescribed by Service Oklahoma, by a manufacturer or dealer for a
12 new vehicle sold in this state, accompanied by remittance in the sum
13 of Eleven Dollars (\$11.00), together with any motor vehicle excise
14 tax or license fee that may be due, a certificate of title shall be
15 issued in accordance with the provisions of the Oklahoma Vehicle
16 License and Registration Act. One Dollar (\$1.00) of each fee shall
17 be deposited in the Oklahoma Tax Commission Reimbursement Fund
18 through December 31, 2022, and beginning January 1, 2023, this fee
19 shall be deposited in the Service Oklahoma Reimbursement Fund. For
20 purposes of this subsection, "charitable organization" shall mean
21 any organization which is exempt from taxation pursuant to the
22 provisions of the Internal Revenue Code, 26 U.S.C., Section
23 501(c)(3) and which is registered as a charitable organization with
24 the Oklahoma Secretary of State and the Oklahoma Attorney General's

1 office; "off-road vehicles" means all-terrain vehicles, utility
2 vehicles, and motorcycles used exclusively for off-road use; "retail
3 implement dealer" means a business engaged primarily in the sale of
4 farm tractors as defined in Section 1-118 of this title or
5 implements of husbandry as defined in Section 1-125 of this title or
6 a combination thereof.

7 C. Any person violating the provisions of this section shall be
8 guilty of a misdemeanor and upon the first conviction thereof shall
9 be punished by a fine not to exceed Five Hundred Dollars (\$500.00),
10 with impoundment of the vehicle until all taxes and fees are paid.
11 A second or subsequent conviction shall be punished by a fine not to
12 exceed One Thousand Dollars (\$1,000.00), with impoundment of the
13 vehicle until all taxes and fees are paid. If a vehicle is
14 impounded pursuant to the provisions of this section, the vehicle
15 shall not be released to the owner until the owner provides proof of
16 security or an affidavit that the vehicle will not be used on public
17 highways or public streets, as required pursuant to Section 7-600 et
18 seq. of this title. Each vehicle involved in a violation of this
19 section shall be considered a separate offense.

1 SECTION 70. AMENDATORY 47 O.S. 2021, Section 1110, as
2 last amended by Section 122, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
3 2023, Section 1110), is amended to read as follows:

4 Section 1110. A. 1. Except for a security interest in
5 vehicles held by a dealer for sale or lease, a vehicle registered by
6 a federally recognized Indian tribe as provided in subsection G of
7 this section, and a vehicle being registered in this state which was
8 previously registered in another state and which title contains the
9 name of a secured party on the face of the other state certificate
10 or title, and except as otherwise provided in subsection B of
11 Section 1105 of this title, a security interest in a vehicle as to
12 which a certificate of title may be properly issued by Service
13 Oklahoma shall be perfected only when a lien entry form, and the
14 existing certificate of title, if any, or application for a
15 certificate of title and manufacturer's certificate of origin
16 containing the name and address of the secured party and the date of
17 the security agreement and the required fee are delivered to Service
18 Oklahoma or to a licensed operator. As used in this section, the
19 term "dealer" shall be defined as provided in Section 1-112 of this
20 title and the term "security interest" shall be defined as provided
21 in paragraph (35) of Section 1-201 of Title 12A of the Oklahoma
22 Statutes. When a vehicle title is presented to a licensed operator
23 for transferring or registering and the documents reflect a
24 lienholder, the licensed operator shall perfect the lien pursuant to

1 subsection G of Section 1105 of this title. For the purposes of
2 this section, the term "vehicle" shall not include special mobilized
3 machinery, machinery used in highway construction or road material
4 construction and rubber-tired road construction vehicles including
5 rubber-tired cranes. The filing and duration of perfection of a
6 security interest, pursuant to the provisions of Title 12A of the
7 Oklahoma Statutes, including, but not limited to, Section 1-9-311 of
8 Title 12A of the Oklahoma Statutes, shall not be applicable to
9 perfection of security interests in vehicles as to which a
10 certificate of title may be properly issued by Service Oklahoma,
11 except as to vehicles held by a dealer for sale or lease and except
12 as provided in subsection D of this section. In all other respects
13 Title 12A of the Oklahoma Statutes shall be applicable to such
14 security interests in vehicles as to which a certificate of title
15 may be properly issued by Service Oklahoma.

16 2. Whenever a person creates a security interest in a vehicle,
17 the person shall surrender to the secured party the certificate of
18 title or the signed application for a new certificate of title, on
19 the form prescribed by Service Oklahoma, and the manufacturer's
20 certificate of origin. The secured party shall deliver the lien
21 entry form and the required lien filing fee within twenty-five (25)
22 days as provided hereafter with certificate of title or the
23 application for certificate of title and the manufacturer's
24 certificate of origin to Service Oklahoma or to a licensed operator.

1 If the lien entry form, the lien filing fee and the certificate of
2 title or application for certificate of title and the manufacturer's
3 certificate of origin are delivered to Service Oklahoma or to a
4 licensed operator within twenty-five (25) days after the date of the
5 lien entry form, perfection of the security interest shall begin
6 from the date of the execution of the lien entry form, but
7 otherwise, perfection of the security interest shall begin from the
8 date of the delivery to Service Oklahoma or to a licensed operator.

9 3. a. For each security interest recorded on a certificate
10 of title, or manufacturer's certificate of origin,
11 such person shall pay a fee of Ten Dollars (\$10.00),
12 which shall be in addition to other fees provided for
13 in the Oklahoma Vehicle License and Registration Act.
14 Upon the receipt of the lien entry form and the
15 required fees with either the certificate of title or
16 an application for certificate of title and
17 manufacturer's certificate of origin, a licensed
18 operator shall, by placement of a clearly
19 distinguishing mark, record the date and number shown
20 in a conspicuous place, on each of these instruments.
21 Of the ten-dollar fee, the licensed operator shall
22 retain Two Dollars (\$2.00) for recording the security
23 interest lien.

1 b. It shall be unlawful for any person to solicit, accept
2 or receive any gratuity or compensation for acting as
3 a messenger and for acting as the agent or
4 representative of another person in applying for the
5 recording of a security interest or for the
6 registration of a motor vehicle and obtaining the
7 license plates or for the issuance of a certificate of
8 title therefor unless Service Oklahoma has appointed
9 and approved the person to perform such acts; and
10 before acting as a messenger, any such person shall
11 furnish to Service Oklahoma a surety bond in such
12 amount as Service Oklahoma shall determine
13 appropriate.

14 4. The certificate of title or the application for certificate
15 of title and manufacturer's certificate of origin with the record of
16 the date of receipt clearly marked thereon shall be returned to the
17 debtor together with a notice that the debtor is required to
18 register and pay all additional fees and taxes due within thirty
19 (30) days from the date of purchase of the vehicle.

20 5. Any person creating a security interest in a vehicle that
21 has been previously registered in the debtor's name and on which all
22 taxes due the state have been paid shall surrender the certificate
23 of ownership to the secured party. The secured party shall have the
24 duty to record the security interest as provided in this section and

1 shall, at the same time, obtain a new certificate of title which
2 shall show the secured interest on the face of the certificate of
3 title.

4 6. The lien entry form with the date and assigned number
5 thereof clearly marked thereon shall be returned to the secured
6 party. If the lien entry form is received and authenticated, as
7 herein provided, by a licensed operator, the licensed operator shall
8 make a report thereof to Service Oklahoma upon the forms and in the
9 manner as may be prescribed by Service Oklahoma.

10 7. Service Oklahoma shall have the duty to record the lien upon
11 the face of the certificate of title issued at the time of
12 registering and paying all fees and taxes due on the vehicle.

13 8. When there is an active lien from a commercial lender in
14 place on a vehicle, licensed operators shall be prohibited from
15 transferring the certificate of title on that vehicle until the lien
16 is satisfied, except when the title is transferred:

17 a. to a person whose name is included on the loan for
18 which the lien is placed pursuant to an agreement by
19 the lender and any party to the title,

20 b. to a trust created by a person whose name is included
21 on the loan for which the lien is placed, or

22 c. from a person who has died, upon the submission of a
23 death certificate.
24

1 The provisions of this paragraph shall not be construed to release
2 any lien or debt based solely upon a transfer of certificate of
3 title.

4 B. 1. A secured party shall, within seven (7) business days
5 after the satisfaction of the security interest, furnish directly or
6 by mail a release of a security interest to Service Oklahoma and
7 mail a copy thereof to the last-known address of the debtor. If the
8 security interest has been satisfied by payment from a licensed used
9 motor vehicle dealer to whom the motor vehicle has been transferred,
10 the secured party shall also, within seven (7) business days after
11 such satisfaction, mail an additional copy of the release to the
12 dealer. If the secured party fails to furnish the release as
13 required, the secured party shall be liable to the debtor for a
14 penalty of One Hundred Dollars (\$100.00). Following the seven (7)
15 business days after satisfaction of the lien and upon receipt by the
16 lienholder of written communication demanding the release of the
17 lien, thereafter the penalty shall increase to One Hundred Dollars
18 (\$100.00) per day for each additional day beyond seven (7) business
19 days until accumulating to One Thousand Five Hundred Dollars
20 (\$1,500.00) or the value of the vehicle, whichever is less, and, in
21 addition, any loss caused to the debtor by such failure.

22 2. Upon release of a security interest the owner may obtain a
23 new certificate of title omitting reference to the security
24

1 interest, by submitting to Service Oklahoma or to a licensed
2 operator:

- 3 a. a release signed by the secured party, an application
4 for new certificate of title and the proper fees, or
- 5 b. by submitting to Service Oklahoma or the licensed
6 operator an affidavit, supported by such documentation
7 as Service Oklahoma may require, by the owner on a
8 form prescribed by Service Oklahoma stating that the
9 security interest has been satisfied and stating the
10 reasons why a release cannot be obtained, an
11 application for a new certificate of title and the
12 proper fees.

13 Upon receiving such affidavit that the security interest has been
14 satisfied, Service Oklahoma shall issue a new certificate of title
15 eliminating the satisfied security interest and the name and address
16 of the secured parties who have been paid and satisfied. Service
17 Oklahoma shall accept a release of a security interest in any form
18 that identifies the debtor, the secured party, and the vehicle, and
19 contains the signature of the secured party. Service Oklahoma shall
20 not require any particular form for the release of a security
21 interest.

22 The words "security interest" when used in the Oklahoma Vehicle
23 License and Registration Act do not include liens dependent upon
24 possession.

1 C. Service Oklahoma shall file and index certificates of title
2 so that at all times it will be possible to trace a certificate of
3 title to the vehicle designated therein, identify the lien entry
4 form, and the names and addresses of secured parties, or their
5 assignees, so that all or any part of such information may be made
6 readily available to those who make legitimate inquiry of Service
7 Oklahoma as to the existence or nonexistence of security interest in
8 the vehicle.

9 D. 1. Any security interest in a vehicle properly perfected
10 prior to July 1, 1979, may be continued as to its effectiveness or
11 duration as provided by Sections 1-9-510 and 1-9-515 of Title 12A of
12 the Oklahoma Statutes, or may be terminated, assigned or released as
13 provided by Sections 1-9-512, 1-9-513 and 1-9-514 of Title 12A of
14 the Oklahoma Statutes, as fully as if this section had not been
15 enacted, or, at the option of the secured party, may also be
16 perfected under this section, and, if so perfected, the time of
17 perfection under this section shall be the date the security
18 interest was originally perfected under the prior law.

19 2. Upon request of the secured party, the debtor or any other
20 holder of the certificate of title shall surrender the certificate
21 of title to the secured party and shall do such other acts as may be
22 required to perfect the security interest under this section.

23 E. If a manufactured home is permanently affixed to real
24 estate, an Oklahoma certificate of title may be surrendered to

1 Service Oklahoma or a licensed operator for cancellation. When the
2 document of title is surrendered, the owner shall provide the legal
3 description or the appropriate tract or parcel number of the real
4 estate and other information as may be required on a form provided
5 by Service Oklahoma. Service Oklahoma may not cancel a document of
6 title if a lien has been registered or recorded. Service Oklahoma
7 or the licensed operator shall notify the owner and any lienholder
8 that the title has been surrendered to Service Oklahoma and that
9 Service Oklahoma may not cancel the title until the lien is
10 released. Such notification shall include a description of the lien
11 and such notification to the owner shall be accompanied by the
12 return of title surrendered. Permanent attachment to real estate
13 does not affect the validity of a lien recorded or registered with
14 Service Oklahoma before the document of title is canceled pursuant
15 to this section. The rights of a prior lienholder pursuant to a
16 security agreement or the provisions of a credit transaction and the
17 rights of the state pursuant to a tax lien are preserved. Service
18 Oklahoma or the licensed operator shall forward the information to
19 the county assessor of the county where the real estate is located
20 and indicate whether the original document of title has been
21 canceled. A fee of Five Dollars (\$5.00) shall accompany the
22 application for cancellation of title. When the fee is paid by a
23 person making an application directly with Service Oklahoma, the fee
24 shall be deposited in the Oklahoma Tax Commission Revolving Fund.

Beginning January 1, 2023, the fee shall be deposited in the Service Oklahoma Revolving Fund. A fee paid to a licensed operator shall be retained by the licensed operator. The owner of a manufactured home upon which the document of title has been properly surrendered may apply to Service Oklahoma for issuance of a new original certificate of title upon submission of:

1. An attestation from the homeowner indicating ownership of the manufactured home and the nonexistence of any security interest or lien of record in the manufactured home; and

2. A title opinion by a licensed attorney, determining that the owner of the manufactured home has marketable title to the real property upon which the manufactured home is located and that no documents filed of record in the county clerk's office concerning the real property contain a mortgage, recorded financial statement, judgment, or lien of record. Persons or entities to whom the title opinion is addressed may rely on the title opinion. A security interest in a manufactured home perfected pursuant to this section shall have priority over a conflicting interest of a mortgagee or other lien encumbrancer, or the owner of the real property upon which the manufactured home became affixed or otherwise permanently attached. The holder of the security interest in the manufactured home, upon default, may remove the manufactured home from such real property. The holder of the security interest in the manufactured home shall reimburse the owner of the real property who is not the

1 debtor and who has not otherwise agreed to access the real property
2 for the cost of repair of any physical injury to the real property,
3 but shall not be liable for any diminution in value to the real
4 property caused by the removal of the manufactured home, trespass,
5 or any other damages caused by the removal. The debtor shall notify
6 the holder of the security interest in the manufactured home of the
7 street address, if any, and the legal description of the real
8 property upon which the manufactured home is affixed or otherwise
9 permanently attached and shall sign such other documents, including
10 any appropriate mortgage, as may reasonably be requested by the
11 holder of such security interest.

12 F. In the case of motor vehicles or trailers, notwithstanding
13 any other provision of law, a transaction does not create a sale or
14 security interest merely because it provides that the rental price
15 is permitted or required to be adjusted under the agreement either
16 upward or downward by reference to the amount realized upon sale or
17 other disposition of the motor vehicle or trailer.

18 G. A security interest in vehicles registered by a federally
19 recognized Indian tribe shall be deemed valid under Oklahoma law if
20 validly perfected under the applicable tribal law and the lien is
21 noted on the face of the tribal certificate of title.

22 SECTION 71. REPEALER 47 O.S. 2021, Section 1110, as
23 amended by Section 1, Chapter 204, O.S.L. 2022 (47 O.S. Supp. 2023,

4 Section 1113. A. 1. Except for all-terrain vehicles, utility
5 vehicles and motorcycles used exclusively off roads and highways,
6 upon the filing of a registration application and the payment of the
7 fees provided for in the Oklahoma Vehicle License and Registration
8 Act, Service Oklahoma or the Corporation Commission, as applicable,
9 shall assign to the vehicle described in the application a
10 distinctive number, and issue to the owner of the vehicle a
11 certificate of registration, one license plate and a yearly decal.
12 Service Oklahoma shall assign an all-terrain vehicle, utility
13 vehicle or motorcycle used exclusively off roads and highways a
14 distinctive number and issue to the owner a certificate of
15 registration and a decal but not a license plate. For each
16 subsequent registration year, Service Oklahoma shall issue a yearly
17 decal to be affixed to the license plate, except for an all-terrain
18 vehicle, utility vehicle or motorcycle used exclusively off roads
19 and highways. The initial decal for an all-terrain vehicle, utility
20 vehicle or motorcycle shall be attached to the front of the vehicle
21 and shall be in clear view. The decal shall be on the front or on
22 the front fork of the motorcycle used exclusively off roads and
23 highways and the decal shall be in clear view. The yearly decal
24 shall have an identification number and the last two numbers of the

1 registration year for which it shall expire. Except as provided by
2 Section 1113A of this title, the license plate shall be affixed to
3 the exterior of the vehicle until a replacement license plate is
4 applied for. If the owner applies for a replacement license plate,
5 Service Oklahoma shall charge the fee provided for in Section 1114
6 of this title. The yearly decal will validate the license plate for
7 each registration period other than the year the license plate is
8 issued. The license plate and decal shall be of such size, color,

15 monthly decal which shall include a two-letter abbreviation

18 Oklahoma on the effective date of this act before issuing any decals
19 which do not contain the county abbreviation.

20 2. a. The operation of a street-legal utility vehicle on the
21 streets and highways of this state requires the
22 vehicle be issued a certificate of registration and
23 license plate to be renewed annually. Upon the filing
24 of a registration application and the payment of the

2 Registration Act, Service Oklahoma or the Corporation
3 Commission, as applicable, shall assign to the vehicle
4 described in the application a distinctive number, and

11 date of expiration, which shall be five (5) days,
12 including the day of issuance. Upon application for a
13 temporary tag, the out-of-state owner shall show proof
14 of insurance coverage that satisfies the requirements

16 et seq. of this title. Service Oklahoma is authorized

19 3. a. The operation of a military surplus vehicle, as

12 same collector will bear the same collector's
13 identification number followed by a suffix letter for
14 vehicle identification.

15 c. A military surplus vehicle collector must own and have
16 registered one or more vehicles with regular Oklahoma
17 license plates that are used for regular

19 d. There shall be a one-time processing fee of Twenty
20 Dollars (\$20.00) to defray the cost of issuing the

22 surplus vehicle designation license plates to ensure

9 B. The license plates required under the provisions of this
10 title shall conform to the requirements and specifications listed
11 hereinafter:

16 Registration Act regarding the issuance of yearly decals shall not

3 4. Except as otherwise provided in this subsection, Service
4 Oklahoma shall design appropriate official license plates for all
5 state vehicles. Such license plates shall be permanent in nature
6 and designed in such manner as to remain with the vehicle for the
7 duration of the vehicle's life span or until the title is
8 transferred to a nongovernmental owner;

9 5. Within the limits prescribed in this section, Service
10 Oklahoma shall design appropriate official license plates for
11 vehicles of the Oklahoma Highway Patrol. The license plates shall
12 have the legend "Oklahoma OK" and shall contain the letters "OHP"
13 followed by the state seal and the badge number of the Highway
14 Patrol officer to whom the vehicle is assigned. The words "Oklahoma
15 Highway Patrol" shall also be included on such license plates;

16 6. Within the limits prescribed in this section, Service
17 Oklahoma shall design appropriate official license plates for
18 vehicles of the Oklahoma Military Department. Such license plates
19 shall have the legend "Oklahoma OK" and shall contain the letters
20 "OMD" followed by the state seal and three numbers or letters as
21 designated by the Adjutant General. The words "Oklahoma Military
22 Department" shall also be included on such license plates;

23 7. Within the limits prescribed in this section, Service
24 Oklahoma shall design appropriate official license plates for

1 vehicles of the Oklahoma Department of Corrections. Such license
2 plates shall contain the letters "DOC" followed by the Department of
3 Corrections badge and three numbers or letters or combination of
4 both as designated by the Director of the agency. The words
5 "Department of Corrections" shall also be included on such license
6 plates; and

7 8. Within the limits prescribed in this section, the Oklahoma
8 Tourism and Recreation Department shall design any license plates
9 required by the initiation of a license plate reissuance by Service
10 Oklahoma at the request of the Department of Public Safety pursuant
11 to the provisions of Section 1113.2 of this title. Any such new
12 designs shall be submitted by the Oklahoma Tourism and Recreation
13 Department to the Department of Public Safety for its approval prior
14 to being issued by Service Oklahoma.

15 C. Where the applicant has satisfactorily shown that the
16 applicant owns the vehicle sought to be registered but is unable to
17 produce documentary evidence of the ownership, a license plate may
18 be issued upon approval by Service Oklahoma or the Corporation
19 Commission, as applicable. In such instances the reason for not
20 issuing a certificate of title shall be indicated on the receipt
21 given to the applicant. It shall still be the duty of the applicant
22 to immediately take all necessary steps to obtain the Oklahoma

4 shall be in convenient form, and the certificate of registration, or

8 such manner as to permit a ready examination thereof upon demand by
9 any peace officer of the state or duly authorized employee of the

13 any such officer or agent determines that the registration
14 certificate has been obtained by misrepresentation of any essential
15 or material fact or when any number or identifying information
16 appearing on such certificate has been changed, altered, obliterated
17 or concealed in any way, until the proper registration or
18 identification of such vehicle has been made or produced by the
19 owner thereof.

20 E. The purchaser of a new or used manufactured home shall,
21 within thirty (30) days of the date of purchase, register the home
22 with Service Oklahoma or a licensed operator pursuant to the
23 provisions of Section 1117 of this title. For a new manufactured
24 home, it shall be the responsibility of the dealer selling the home

1 to place a temporary license plate on the home in the same manner as
2 provided in Section 1128 of this title for other new motor vehicles.
3 For the first year that any manufactured home is registered in this
4 state, Service Oklahoma shall issue a metal license plate which
5 shall be affixed to the manufactured home. The temporary dealer
6 license plate or the metal license plate shall be displayed on the
7 manufactured home at all times when upon a public roadway; provided,
8 a repossession affidavit issued pursuant to Sections 1110 and 1126
9 of this title shall be permissible in lieu of a current license
10 plate and decal for the purposes of removing a repossessed
11 manufactured home to a secure location. Manufactured homes
12 previously registered and subject to ad valorem taxation as provided
13 by law shall have a decal affixed at the time ad valorem taxes are
14 paid for such manufactured home; provided, for a manufactured home
15 permanently affixed to real estate, no decal or license plate shall
16 be required to be affixed and the owner thereof shall be given a
17 receipt upon payment of ad valorem taxes due on the home. Service
18 Oklahoma shall make sufficient plates and decals available to the
19 various licensed operators of the state in order for an owner of a
20 manufactured home to acquire the plate or decal. A one-dollar fee
21 shall be charged for issuance of any plate or decal. The fee shall
22 be apportioned each month to the General Revenue Fund of the State
23 Treasury.

1 F. The decal shall be easily visible for purposes of
2 verification by a county assessor that the manufactured home is
3 properly assessed for ad valorem taxation. In the first year of
4 registration, a decal shall be issued for placement on the license
5 plate indicating payment of applicable registration fees and excise
6 taxes. A duplicate manufactured home registration decal shall be
7 affixed inside the window nearest the front door of the manufactured
8 home. In the second and all subsequent years for which the
9 manufactured home is subject to ad valorem taxation, an annual decal
10 shall be affixed inside the window nearest the front door as
11 evidence of payment of ad valorem taxes. Service Oklahoma shall
12 issue decals to the various county treasurers of the state in order
13 for a manufactured home owner to obtain such decal each year. Upon
14 presentation of a valid ad valorem tax receipt, the manufactured
15 home owner shall be issued the annual decal.

16 G. Upon the registration of a manufactured home in this state
17 for the first time or upon discovery of a manufactured home
18 previously registered within this state for which the information
19 required by this subsection is not known, Service Oklahoma shall
20 obtain:

- 21 1. The name of the owner of the manufactured home;
- 22 2. The serial number or identification number of the
23 manufactured home;
- 24 3. A legal description or address of the location for the home;

1 4. The actual retail selling price of the manufactured home
2 excluding Oklahoma taxes;

3 5. The certificate of title number for the home; and

4 6. Any other information which Service Oklahoma deems to be
5 necessary.

6 The application for registration shall also include the school
7 district in which the manufactured home is located or is to be
8 located. The information shall be entered into a computer data
9 system which shall be used by Service Oklahoma to provide
10 information to county assessors upon request by the assessor. The
11 assessor may request any information from the system in order to
12 properly assess a manufactured home for ad valorem taxation.

19 SECTION 75. AMENDATORY 47 O.S. 2021, Section 1132, as
20 last amended by Section 146, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
21 2023, Section 1132), is amended to read as follows:

22 Section 1132. A. For all vehicles, unless otherwise
23 specifically provided by the Oklahoma Vehicle License and
24 Registration Act, a registration fee shall be assessed at the time

1 of initial registration by the owner and annually thereafter, for
2 the use of the avenues of public access within this state in the
3 following amounts:

4 1. For the first through the fourth year of registration in
5 this state or any other state, Eighty-five Dollars (\$85.00);

6 2. For the fifth through the eighth year of registration in
7 this state or any other state, Seventy-five Dollars (\$75.00);

8 3. For the ninth through the twelfth year of registration in
9 this state or any other state, Fifty-five Dollars (\$55.00);

10 4. For the thirteenth through the sixteenth year of
11 registration in this state or any other state, Thirty-five Dollars
12 (\$35.00); and

13 5. For the seventeenth and any following year of registration
14 in this state or any other state, Fifteen Dollars (\$15.00).

15 The registration fee provided for in this subsection shall be in
16 lieu of all other taxes, general or local, unless otherwise
17 specifically provided.

18 On and after January 1, 2022, if a physically disabled license
19 plate is issued pursuant to paragraph 3 of subsection B of Section
20 1135.1 of this title, any registration fee required for such license
21 plate and the fee required pursuant to this subsection shall be
22 remitted at the same time and subject to a single registration
23 period. Upon receipt of a physically disabled license plate, the
24 standard issue license plate must be surrendered to Service Oklahoma

1 or the licensed operator. The physically disabled license plate
2 must be properly displayed as required for a standard issue license
3 plate and will be the sole license plate issued and assigned to the
4 vehicle. Service Oklahoma shall determine, by rule, a method for
5 making required fee adjustments when a physically disabled license
6 plate is obtained during a twelve-month period for which a
7 registration fee has already been remitted pursuant to this
8 subsection. The combination of fees in a single remittance shall
9 not alter the apportionment otherwise provided for by law.

10 B. For all-terrain vehicles and motorcycles used exclusively
11 for use off roads or highways purchased on or after July 1, 2005,
12 and for all-terrain vehicles and motorcycles used exclusively for
13 use off roads or highways purchased prior to July 1, 2005, which the
14 owner chooses to register pursuant to the provisions of Section
15 1115.3 of this title, an initial and nonrecurring registration fee
16 of Eleven Dollars (\$11.00) shall be assessed at the time of initial
17 registration by the owner. Nine Dollars (\$9.00) of the registration
18 fee shall be deposited in the Oklahoma Tax Commission Reimbursement
19 Fund through December 31, 2022, and beginning January 1, 2023, this
20 fee shall be deposited in the Service Oklahoma Reimbursement Fund.
21 Two Dollars (\$2.00) of the registration fee shall be retained by the
22 licensed operator. The fees required by subsection A of this
23 section shall not be required for all-terrain vehicles or
24 motorcycles used exclusively off roads and highways.

1 C. For utility vehicles used exclusively for use off roads or
2 highways purchased on or after July 1, 2008, and for utility
3 vehicles used exclusively for use off roads or highways purchased
4 prior to July 1, 2008, which the owner chooses to register pursuant
5 to the provisions of Section 1115.3 of this title, an initial and
6 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be
7 assessed at the time of initial registration by the owner. Nine
8 Dollars (\$9.00) of the registration fee shall be deposited in the
9 Oklahoma Tax Commission Reimbursement Fund through December 31,
10 2022, and beginning January 1, 2023, this fee shall be deposited in
11 the Service Oklahoma Reimbursement Fund. Two Dollars (\$2.00) of the
12 registration fee shall be retained by the licensed operator. The
13 fees required by subsection A of this section shall not be required
14 for utility vehicles used exclusively off roads and highways.

15 D. There shall be a credit allowed with respect to the fee for
16 registration of a new vehicle which is a replacement for:

17 1. A new original vehicle which is stolen from the
18 purchaser/registrant within ninety (90) days of the date of purchase
19 of the original vehicle as certified by a police report or other
20 documentation as required by Service Oklahoma; or

21 2. A defective new original vehicle returned by the
22 purchaser/registrant to the seller within six (6) months of the date
23 of purchase of the defective new original vehicle as certified by
24 the manufacturer.

1 The credit shall be in the amount of the fee for registration
2 which was paid for the new original vehicle and shall be applied to
3 the registration fee for the replacement vehicle. In no event will
4 the credit be refunded.

5 E. Upon every transfer or change of ownership of a vehicle, the
6 new owner shall obtain title for and, except in the case of salvage
7 vehicles and manufactured homes, register the vehicle within thirty
8 (30) days of change of ownership and pay a transfer fee of Fifteen
9 Dollars (\$15.00) in addition to any other fees provided for in the
10 Oklahoma Vehicle License and Registration Act. No new decal shall
11 be issued to the registrant. Thereafter, the owner shall register
12 the vehicle annually on the anniversary date of its initial
13 registration in this state and shall pay the fees provided in
14 subsection A of this section and receive a decal evidencing such
15 payment. Provided, used motor vehicle dealers shall be exempt from
16 the provisions of this section.

17 F. In the event a new or used vehicle is not registered, titled
18 and tagged within thirty (30) days from the date of transfer of
19 ownership, the penalty for the failure of the owner of the vehicle
20 to register the vehicle within thirty (30) days shall be One Dollar
21 (\$1.00) per day, provided that in no event shall the penalty exceed
22 One Hundred Dollars (\$100.00). No penalty shall be waived by
23 Service Oklahoma or any licensed operator except as provided in
24 subsection C of Section 1127 of this title, or when it can be shown

1 the vehicle was stolen as certified by a police report or other
2 documentation as required by the Oklahoma Tax Commission. Of each
3 dollar penalty collected pursuant to this subsection:

21 Oklahoma shall determine, by rule, a method for making required fee
22 and registration period adjustments if a special license plate is
23 obtained during a twelve-month period for which a registration fee
24 has already been remitted pursuant to Section 1132 of this title.

1 The combination of fees in a single remittance shall not alter the
2 apportionment otherwise provided for in this section.

3 On and after January 1, 2022, if a physically disabled license
4 plate is issued pursuant to paragraph 3 of subsection B of this
5 section, any registration fee required for such plate pursuant to
6 this section and the fee required pursuant to Section 1132 of this
7 title shall be remitted at the same time and subject to a single
8 registration period. ~~The Oklahoma Tax Commission~~ Service Oklahoma
9 shall determine, by rule, a method for making required fee and
10 registration period adjustments when a physically disabled license
11 plate is obtained during a twelve-month period for which a
12 registration fee has already been remitted pursuant to Section 1132
13 of this title. The combination of fees in a single remittance shall
14 not alter the apportionment otherwise provided for in this section.

15 B. The special license plates provided by this section are as
16 follows:

17 1. Political Subdivision Plates - such plates shall be designed
18 for any vehicle owned by any political subdivision of this state
19 having obtained a proper Oklahoma certificate of title. Such
20 political subdivisions shall file an annual report with the Tax
21 Commission stating the agency where such vehicle is located. Such
22 license plates shall be permanent in nature and designed in such a
23 manner as to remain with the vehicle for the duration of the life
24

1 span of the vehicle or until the title is transferred to an owner
2 who is not a political subdivision.

3 The registration fee shall be Eight Dollars (\$8.00) and shall be
4 in addition to all other registration fees provided by law, except
5 the registration fees levied by Section 1132 of this title;

6 2. Tax-Exempt or Nonprofit License Plates - such plates shall
7 be designed for:

- 8 a. any motor bus, manufactured home, or mobile chapel and
9 power unit owned and operated by a religious
10 corporation or society of this state holding a valid
11 exemption from taxation issued pursuant to Section
12 501(a) of the Internal Revenue Code, 26 U.S.C.,
13 Section 501(a), and listed as an exempt organization
14 in Section 501(c)(3) of the Internal Revenue Code, as
15 amended, 26 U.S.C., Section 501(c)(3), and that is
16 used by the corporation or society solely for the
17 furtherance of its religious functions,
- 18 b. any vehicle owned and operated only by nonprofit
19 organizations devoted exclusively to youth programs
20 including, but not limited to, the Girl Scouts and Boy
21 Scouts of America,
- 22 c. any vehicle, except passenger automobiles, owned or
23 operated by nonprofit organizations actually involved
24 in programs for the employment of the handicapped and

- 1 used exclusively in the transportation of goods or
2 materials for such organization,
- 3 d. any vehicle owned and operated by a nonprofit
4 organization that provides older persons
5 transportation to and from medical, dental and
6 religious services and relief from business and social
7 isolation,
- 8 e. any vehicle owned and operated by a private nonprofit
9 organization that:
- 10 (1) warehouses and distributes surplus foods to other
11 nonprofit agencies and organizations, and
- 12 (2) holds a valid exemption from taxation issued
13 pursuant to Section 501(c) of the Internal
14 Revenue Code, as amended, 26 U.S.C., Section
15 501(c), and listed as an exempt organization in
16 Section 501(c)(3) of the Internal Revenue Code,
17 as amended, and
- 18 (3) uses such vehicle exclusively for the
19 transportation of such surplus foods,
- 20 f. any vehicle which:
- 21 (1) is owned and operated by a private, nonprofit
22 organization which is exempt from taxation
23 pursuant to the provisions of Section 501(c)(3)
24 of the Internal Revenue Code, 26 U.S.C., Section

1 501(c)(3), and which is primarily funded by a
2 fraternal or civic service organization with at
3 least one hundred local chapters or clubs, and
4 (2) is designed and used to provide mobile health
5 screening services to the general public at no
6 cost to the recipient, and for which no
7 reimbursement of any kind is received from any
8 health insurance provider, health maintenance
9 organization or governmental program, or

10 g. any vehicle owned and operated by the Civil Air
11 Patrol, a congressionally chartered corporation that
12 also serves an auxiliary of the United States Air
13 Force and which is exempt from taxation pursuant to
14 the provisions of Section 501(c)(3) of the Internal
15 Revenue Code, 26 U.S.C., Section 501(c)(3), and is
16 used exclusively for its corporate missions of
17 aerospace education, cadet programs and emergency
18 services. Such license plates shall be permanent in
19 nature and designed in such a manner as to remain with
20 the vehicle for the duration of the life span of the
21 vehicle or until the title to such vehicle is
22 transferred to an owner who is not subject to this
23 exemption. Such vehicles shall be exempt from the
24 registration fees levied under Section 1132 of this

1 title, except that an initial registration fee of
2 Twenty-five Dollars (\$25.00) shall apply to each
3 vehicle.

4 Any person claiming to be eligible for a tax-exempt or nonprofit
5 license plate under the provisions of this paragraph must have the
6 name of the tax-exempt or nonprofit organization prominently
7 displayed upon the outside of the vehicle, except those vehicles
8 registered pursuant to the provisions of subparagraph b of this
9 paragraph, unless such display is prohibited by federal or state law
10 or by state agency rules. No vehicle shall be licensed as a tax-
11 exempt or nonprofit vehicle unless the vehicle has affixed on each
12 side thereof, in letters not less than two (2) inches high and two
13 (2) inches wide, the name of the tax-exempt or nonprofit
14 organization or the insignia or other symbol of such organization
15 which shall be of sufficient size, shape and color as to be readily
16 legible during daylight hours from a distance of fifty (50) feet
17 while the vehicle is not in motion.

18 Except as provided in subparagraph g of this paragraph, the
19 registration fee shall be Eight Dollars (\$8.00) and shall be in
20 addition to all other registration fees provided by law, except the
21 registration fees levied by Section 1132 of this title;

22 3. Physically Disabled License Plates - such plates shall be
23 designed for persons who are eligible for a physically disabled
24 placard under the provisions of Section 15-112 of this title. It

1 shall prominently display the international accessibility symbol,
2 which is a stylized human figure in a wheelchair. ~~The Tax~~
3 ~~Commission~~ Service Oklahoma shall also design physically disabled
4 license plates for motorcycles owned by persons who are eligible for
5 a physically disabled placard pursuant to the provisions of Section
6 15-112 of this title. Upon the death of the physically disabled
7 person, the disabled license plate shall be returned to ~~the Tax~~
8 ~~Commission~~ Service Oklahoma. There shall be no fee for such plate
9 in addition to the rate provided by the Oklahoma Vehicle License and
10 Registration Act for the registration of the vehicle. For an
11 additional fee of Ten Dollars (\$10.00), a person eligible for a
12 physically disabled license plate shall have the option of
13 purchasing a duplicate physically disabled special license plate
14 which shall be securely attached to the front of the vehicle. The
15 original physically disabled special license plate shall be securely
16 attached to the rear of the vehicle at all times.

17 Any person who is eligible for a physically disabled license
18 plate and whose vehicle has had modifications because of the
19 physical disability of the owner or of a family member within the
20 second degree of consanguinity of the owner, may register the
21 vehicle for a flat fee of Twenty-five Dollars (\$25.00). This fee
22 shall be in lieu of all other registration fees provided by the
23 Oklahoma Vehicle License and Registration Act;

1 4. Indian Tribal License Plates - such plates shall be designed
2 for any vehicle of a native American Indian Tribal Association
3 exempted in Sections 201 through 204 of Public Law 97-473 and used
4 by the tribal association exclusively for the furtherance of its
5 tribal functions.

6 The registration fee shall be Eight Dollars (\$8.00) and shall be
7 in addition to all other registration fees provided by law, except
8 the registration fees levied by Section 1132 of this title;

9 5. Hearing Impaired License Plates - such plates shall be
10 designed for persons who are hearing impaired. Such persons may
11 apply for a hearing-impaired license plate for each vehicle with a
12 rated carrying capacity of one (1) ton or less upon the presentment
13 of an application on a form furnished by ~~the Tax Commission~~ Service
14 Oklahoma and certified by a physician holding a valid license to
15 practice pursuant to the licensing provisions of Title 59 of the
16 Oklahoma Statutes, attesting that the person is hearing impaired.
17 The license plate shall be designed so that such persons may be
18 readily identified as being hearing impaired. There shall be no
19 additional fee for the plate, but all other registration fees
20 provided by the Oklahoma Vehicle License and Registration Act shall
21 apply;

22 6. Antique or Classic Vehicles License Plates - such plates
23 shall be designed and issued for any vehicle twenty-five (25) years
24 of age or older, based upon the date of manufacture thereof and

1 which travels on the highways of this state primarily incidental to
2 historical or exhibition purposes only.

3 The registration fee shall be Eight Dollars (\$8.00) and shall be
4 in addition to all other registration fees provided by law, except
5 the registration fees levied by Section 1132 of this title. Any
6 person registering an antique or classic vehicle may elect to have
7 the vehicle registered for a ten-year period. The registration fee
8 for the elected ten-year registration shall be Seventy-five Dollars
9 (\$75.00). The ~~motor license agent~~ licensed operator registering the
10 antique or classic vehicle for a ten-year period shall receive one
11 hundred percent (100%) of the fees the ~~motor license agent~~ licensed
12 operator would have otherwise received pursuant to subsection A of
13 Section 1141.1 of this title if the antique or classic vehicle had
14 been registered on an annual basis; and

15 7. Honorary Consul License Plates - such plates shall be
16 designed to include the words "Honorary Consul" and issued to
17 persons who are honorary consuls authorized by the United States to
18 perform consular duties. Persons applying for such license plates
19 must show proof of standing as an honorary consul. The fee for such
20 plate shall be Eight Dollars (\$8.00) and shall be in addition to all
21 other registration fees required by the Oklahoma Vehicle License and
22 Registration Act. The owner of the vehicle that possesses such
23 license plates shall return the special license plates to ~~the~~
24 ~~Oklahoma Tax Commission~~ Service Oklahoma if the owner disposes of

1 the vehicle during the registration year or ceases to be authorized
2 to perform consular duties.

3 C. Special license plates provided by this section shall be
4 designed in such a manner as to identify the use or ownership of the
5 vehicle. Use of any vehicle possessing a special license plate
6 provided by this section for any purpose not specified herein shall
7 be grounds for revocation of the special license plate and
8 registration certificate.

9 D. The fees provided by this section shall be deposited in the
10 Oklahoma Tax Commission Reimbursement Fund. Beginning January 1,
11 2023, the fees provided by this section shall be deposited in the
12 Service Oklahoma Reimbursement Fund.

13 SECTION 78. REPEALER 47 O.S. 2021, Section 1135.1, as
14 amended by Section 160, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
15 2023, Section 1135.1), is hereby repealed.

16 SECTION 79. REPEALER 47 O.S. 2021, Section 1135.1, as
17 amended by Section 2, Chapter 188, O.S.L. 2021, is hereby repealed.

18 SECTION 80. AMENDATORY 47 O.S. 2021, Section 1135.2, as
19 last amended by Section 1, Chapter 294, O.S.L. 2023 (47 O.S. Supp.
20 2023, Section 1135.2), is amended to read as follows:

21 Section 1135.2. A. Service Oklahoma is hereby authorized to
22 design and issue appropriate official special license plates to
23 persons in recognition of their service or awards as provided by
24 this section.

1 Special license plates shall not be transferred to any other
2 person but shall be removed from the vehicle upon transfer of
3 ownership and retained. The special license plate may then be used
4 on another vehicle but only after such other vehicle has been
5 registered for the current year.

6 Special license plates shall be renewed each year by Service
7 Oklahoma or a licensed operator. Service Oklahoma shall annually
8 notify ~~by mail~~ all persons issued special license plates. Service
9 Oklahoma shall send the notifications to the electronic mail address
10 provided by the person. If a person does not provide an electronic
11 mail address, Service Oklahoma shall notify the person by mail. The
12 notice shall contain all necessary information and shall contain
13 instructions for the renewal procedure upon presentation to a
14 licensed operator or Service Oklahoma. The license plates shall be
15 issued on a staggered system except for legislative plates and
16 amateur radio operator license plates.

17 On and after January 1, 2022, if a special license plate is
18 issued pursuant to this section, any registration fee required for
19 such plate pursuant to this section and the fee required pursuant to
20 Section 1132 of this title shall be remitted at the same time and
21 subject to a single registration period. Service Oklahoma shall
22 determine, by rule, a method for making required fee and
23 registration period adjustments if a special license plate is
24 obtained during a twelve-month period for which a registration fee

1 has already been remitted pursuant to Section 1132 of this title.

2 The combination of fees in a single remittance shall not alter the
3 apportionment otherwise provided for in this section.

4 Service Oklahoma is hereby directed to develop and implement a
5 system whereby licensed operators are permitted to accept
6 applications for special license plates authorized under this
7 section. The licensed operator shall confirm the applicant's
8 eligibility, if applicable, collect and deposit any amount
9 specifically authorized by law, accept and process the necessary
10 information directly into such system and generate a receipt
11 accordingly. For performance of these duties, licensed operators
12 shall retain the fee provided in Section 1141.1 of this title for
13 registration of a motor vehicle. The licensed operator fees for
14 acceptance of applications and renewals shall be paid out of the
15 Oklahoma Tax Commission Reimbursement Fund. Beginning January 1,
16 2023, the licensed operator fees for acceptance of applications and
17 renewals shall be paid out of the Service Oklahoma Reimbursement
18 Fund.

19 B. The special license plates provided by this section are as
20 follows:

21 1. Prisoner of War License Plates - such plates shall be
22 designed for honorably discharged or present members of the United
23 States Armed Forces and civilians who were former prisoners of war
24 held by a foreign country and who can provide proper certification

1 of that status. Such persons may apply for a prisoner of war
2 license plate for no more than two vehicles with each vehicle having
3 a rated carrying capacity of one (1) ton or less. The surviving
4 spouse of any deceased former prisoner of war, if the spouse has not
5 since remarried, or if remarried, the remarriage is terminated by
6 death, divorce, or annulment, may apply for a prisoner of war
7 license plate for one vehicle with a rated carrying capacity of one
8 (1) ton or less. The fee provided by this section for the special
9 license plate authorized by this paragraph shall be in addition to
10 all other registration fees provided by law, except the registration
11 fees levied by Section 1132 of this title;

12 2. National Guard License Plates - such plates shall be
13 designed for active or retired members of the Oklahoma National
14 Guard. Retirees who are eligible for such plates shall provide
15 proof of eligibility upon initial application, but shall not be
16 required to provide proof of eligibility annually;

17 3. Air National Guard License Plates - such plates shall be
18 designed for active or retired members of the Oklahoma Air National
19 Guard. Retirees who are eligible for such plates shall provide
20 proof of eligibility upon initial application, but shall not be
21 required to provide proof of eligibility annually;

22 4. United States Armed Forces License Plates - such plates
23 shall be designed for active, retired, former or reserve members of
24 the United States Armed Forces, and shall identify which branch of

1 service, and carry the emblem and name of either the Army, Navy, Air
2 Force, Marines or Coast Guard, according to the branch of service to
3 which the member belongs or did belong. Former members who have
4 been dishonorably discharged shall not be eligible for such plates.
5 Persons applying for such license plate must show proof of present
6 or past military service by presenting a valid Uniformed Services
7 Identity Card or the United States Department of Defense ~~Form~~
8 ~~(DD)~~214 form DD 214. Retired or former members who are eligible for
9 such plates shall provide proof of eligibility upon initial
10 application, but shall not be required to provide proof of
11 eligibility annually;

12 5. Congressional Medal of Honor Recipient License Plates - such
13 plates shall be designed for any resident of this state who has been
14 awarded the Congressional Medal of Honor. Such persons may apply
15 for a Congressional Medal of Honor recipient license plate for each
16 vehicle with a rated carrying capacity of one (1) ton or less.
17 There shall be no registration fee for the issuance of this plate;

18 6. Missing In Action License Plates - such plates shall be
19 designed to honor members of the United States Armed Forces who are
20 missing in action. The spouse of such missing person, if the spouse
21 has not since remarried, or if remarried, the remarriage is
22 terminated by death, divorce, or annulment, and each parent of the
23 missing person may apply for a missing in action license plate upon
24 presenting proper certification that the person is missing in action

1 and that the person making the application is the qualifying spouse
2 or the parent of the missing person. The qualifying spouse and each
3 parent of the missing person may each apply for the missing in
4 action license plate for each vehicle with a rated carrying capacity
5 of one (1) ton or less;

6 7. Purple Heart Recipient License Plates - such plates shall be
7 designed for any resident of this state presenting proper
8 certification from the United States Department of Veterans Affairs
9 or the Armed Forces of the United States certifying that such
10 resident has been awarded the Purple Heart military decoration.
11 Such persons may apply for a Purple Heart recipient license plate
12 for vehicles having a rated carrying capacity of one (1) ton or
13 less. The surviving spouse of any deceased veteran who has been
14 awarded the Purple Heart military decoration, if such spouse has not
15 since remarried, or if remarried, the remarriage has been terminated
16 by death, divorce or annulment, may apply for such plate for one
17 vehicle with a rated carrying capacity of one (1) ton or less. The
18 license plate created by this paragraph shall be exempt from the fee
19 provided by this section for special license plates;

20 8. Pearl Harbor Survivor License Plates - such plates shall be
21 designed for any resident of this state who can be verified by the
22 United States Department of Veterans Affairs or the Armed Forces of
23 the United States as being:
24

- a. a member of the United States Armed Forces on December 7, 1941,
- b. stationed on December 7, 1941, during the hours of 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor, the island of Oahu, or offshore at a distance not to exceed three (3) miles, and
- c. a recipient of an honorable discharge from the United States Armed Forces.

Such person may apply for a Pearl Harbor Survivor license plate for each vehicle with a rated carrying capacity of one (1) ton or less;

9. Iwo Jima License Plates - such plates shall be designed for any resident of this state who can be verified by the United States Department of Veterans Affairs or the Armed Forces of the United States as being:

- a. a member of the United States Armed Forces in February of 1945,
- b. stationed in February of 1945 on or in the immediate vicinity of the island of Iwo Jima, and
- c. a recipient of an honorable discharge from the United States Armed Forces.

Such person may apply for an Iwo Jima license plate for each vehicle with a rated carrying capacity of one (1) ton or less.

1 Such license plate shall have the legend "Oklahoma OK" and shall
2 contain three letters and three numbers. Between the letters and
3 numbers shall be a logo of the flag-raising at Iwo Jima. Below the
4 letters, logo and numbers, the plate shall contain the words "FEB."
5 at the left, "Iwo Jima" in the center and "1945" at the right. Such
6 plates shall not be subject to the design requirements of any other
7 license plates prescribed by law other than the space for the
8 placement of the yearly decals for each succeeding year of
9 registration after the initial issue;

10 10. D-Day Survivor License Plates - such plates shall be
11 designed for any resident of this state who can be verified by the
12 United States Department of Veterans Affairs or the Armed Forces of
13 the United States as being:

- 14 a. a member of the United States Armed Forces on June 6,
15 1944,
- 16 b. a participant in the Allied invasion of the coast of
17 Normandy on June 6, 1944; provided, if such
18 participation cannot be verified by the United States
19 Department of Veterans Affairs or the Armed Forces of
20 the United States, the Tax Commission may, in its
21 discretion, accept evidence of such participation from
22 the person applying for the license plate, and
- 23 c. a recipient of an honorable discharge from the United
24 States Armed Forces.

1 Such person may apply for a D-Day Survivor license plate for
2 each vehicle with a rated carrying capacity of one (1) ton or less;

3 11. Killed in Action License Plates - such plates shall be
4 designed to honor members of the United States Armed Forces who were
5 killed in action. The spouse of the deceased person, if the spouse
6 has not remarried, or if remarried, the remarriage is terminated by
7 death, divorce, or annulment, may apply for a killed in action
8 license plate upon presenting proper certification that the person
9 was killed in action and that the person making the application is
10 the qualifying spouse of the deceased person. The qualifying spouse
11 may apply for a killed in action license plate for no more than two
12 vehicles with each vehicle with a rated carrying capacity of one (1)
13 ton or less. The fee provided by this section for the special
14 license plate authorized by this paragraph shall be in addition to
15 all other registration fees provided by law, except the registration
16 fees levied by Section 1132 of this title. Beginning November 1,
17 2021, the killed in action license plate shall be designed to honor
18 members of the United States Armed Forces who were killed in action
19 while engaged in combat with a hostile force. The parents,
20 siblings, half-siblings, grandparents or spouse of the deceased
21 person, if the spouse has not remarried, or if remarried, the
22 remarriage is terminated by death, divorce or annulment, may apply
23 for a killed in action license plate upon presenting proper
24 certification that the person was killed in action and that the

1 person making the application is the qualifying spouse or family
2 member of the deceased person. The qualifying spouse or family
3 member may apply for a killed in action license plate for no more
4 than two vehicles with each vehicle with a rated carrying capacity
5 of one (1) ton or less. The license plate shall have a white
6 background and the legend "Killed in Action" and shall contain any
7 combination of numbers and letters from one to a maximum of seven in
8 black, as for personalized license plates. To the left of the
9 numbers and letters shall be the Battlefield Cross in gold. The
10 killed in action license plate shall be exempt from any minimum
11 issuance criteria related to license plate applications;

12 12. Gold Star Families License Plates - such plates shall be
13 designed to honor members of the United States Armed Forces who were
14 killed while on active duty. The parents, siblings, half-siblings
15 or grandparents of the deceased person may apply for a gold star
16 license plate upon presenting proper certification that the person
17 was killed while on active duty and that the person making the
18 application is the parent, sibling, half-sibling or grandparent of
19 the deceased person. The family member may apply for a gold star
20 families license plate for no more than two vehicles with each
21 vehicle having a rated carrying capacity of one (1) ton or less.
22 The fee provided by this section for the special license plate
23 authorized by this paragraph shall be in addition to all other
24

1 registration fees provided by law, except the registration fees
2 levied by Section 1132 of this title;

3 13. Military Decoration License Plates - such plates shall be
4 designed for any resident of this state who has been awarded the
5 Distinguished Service Medal, the Distinguished Service Cross, the
6 Distinguished Flying Cross, the Bronze Star military decoration or
7 the Silver Star military decoration. Such persons may apply for a
8 military decoration license plate for each vehicle with a rated
9 carrying capacity of one (1) ton or less;

10 14. Vietnam Veteran License Plates - such plates shall be
11 designed for honorably discharged or present members of the United
12 States Armed Forces who served in the Vietnam Conflict. Such
13 persons may apply for a Vietnam veteran license plate for each
14 vehicle with a rated carrying capacity of one (1) ton or less;

15 15. Police Officer License Plates - such plates shall be
16 designed for any currently employed, reserve or retired municipal
17 police officer or full-time, reserve or retired university police
18 officer certified by the Council on Law Enforcement Education and
19 Training or common education police officer certified by the Council
20 on Law Enforcement Education and Training. Police officers may
21 apply for police officer license plates for vehicles with a rated
22 capacity of one (1) ton or less or for a motorcycle upon proof of
23 employment by or retirement from a municipal, university or common
24 education police department by either an identification card or

1 letter from the chief of the police department or the Oklahoma
2 Police Pension and Retirement Board. Retirees who are eligible for
3 such plates shall provide proof of eligibility upon initial
4 application but shall not be required to provide proof of
5 eligibility annually. The license plates shall be designed in
6 consultation with municipal police departments of this state;
7 provided, the license plate for motorcycles may be of similar design
8 to the license plate for motor vehicles or may be a new design in
9 order to meet space requirements for a motorcycle license plate;

10 16. World War II Veteran License Plates - such plates shall be
11 designed to honor honorably discharged former members of the United
12 States Armed Forces who are residents of this state and who can be
13 verified by the Military Department of the State of Oklahoma, the
14 Department of Veterans Affairs or the Armed Forces of the United
15 States as having served on federal active duty anytime during the
16 period from September 16, 1940, to December 7, 1945. The former
17 members may apply for a World War II Veteran license plate for
18 vehicles with a rated carrying capacity of one (1) ton or less.

19 The license plate shall have the legend "Oklahoma" and shall
20 contain, in the center of the plate, either the Thunderbird Insignia
21 of the 45th Infantry Division in the prescribed red and gold
22 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,
23 Marines or Coast Guard according to the branch of service to which
24 the member belonged. For the purpose of license plate

1 identification, the plate shall contain four digits, two digits at
2 the left and two digits at the right of the insignia or emblem.
3 Centered on the bottom of the license plate shall be the words
4 "WORLD WAR II";

5 17. Korean War Veteran License Plates - such plates shall be
6 designed to honor honorably discharged former members of the United
7 States Armed Forces who are residents of this state and who can be
8 verified by the Military Department of the State of Oklahoma, the
9 Department of Veterans Affairs or the Armed Forces of the United
10 States as having served on federal active duty anytime during the
11 period from June 27, 1950, to January 31, 1955, both dates
12 inclusive. The former members may apply for a Korean War Veteran
13 license plate for vehicles with a rated carrying capacity of one (1)
14 ton or less.

15 The license plate shall have the legend "OKLAHOMA" and shall
16 contain, in the center of the plate, either the Thunderbird Insignia
17 of the 45th Infantry Division in the prescribed red and gold
18 coloring or the emblem of the Army, Navy, Air Force, Marines or
19 Coast Guard according to the branch of service to which the member
20 belonged. For the purpose of license plate identification, the
21 plate shall contain four digits, two digits at the left and two
22 digits at the right of the insignia or emblem. Centered on the
23 bottom of the license plate shall be the word "KOREA";
24

1 18. Municipal Official License Plates - such plates shall be
2 designed for persons elected to a municipal office in this state and
3 shall designate the name of the municipality and the district or
4 ward in which the municipal official serves. The plates shall only
5 be produced upon application;

6 19. Red Cross Volunteer License Plates - such plates shall be
7 designed to honor American Red Cross volunteers and staff who are
8 residents of this state. Such persons must present an
9 identification card issued by the American Red Cross and bearing a
10 photograph of the person. The license plate shall be designed with
11 the assistance of the American Red Cross and shall have the legend
12 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
13 symbol of the American Red Cross and no more than three letters and
14 three numbers shall be in the color Pantone 186C Red. Below the
15 symbol and letters and numbers shall be the words "American Red
16 Cross" in black. The plates shall not be subject to the design
17 requirements of any other license plates prescribed by law other
18 than the space for the placement of the yearly decals for each
19 succeeding year of registration after the initial issue;

20 20. Desert Storm License Plates - such plates shall be designed
21 and issued to any honorably discharged or present member of the
22 United States Armed Forces who served in the Persian Gulf Crisis and
23 the Desert Storm operation. Such persons may apply for a Desert
24

1 Storm license plate for each vehicle with a rated carrying capacity
2 of one (1) ton or less;

3 21. Military Reserve Unit License Plates - such plates shall be
4 designed and issued to any honorably discharged or present member of
5 a reserve unit of the United States Armed Forces. Such persons may
6 apply for a Military Reserve Unit license plate for each vehicle
7 with a rated carrying capacity of one (1) ton or less;

8 22. Oklahoma City Bombing Victims and Survivors License Plates
9 - such plates shall be designed and issued to any victim or survivor
10 of the bombing attack on the Alfred P. Murrah Federal Building in
11 downtown Oklahoma City on April 19, 1995;

12 23. Civil Air Patrol License Plates - such plates shall be
13 designed and issued to any person who is a member of the Civil Air
14 Patrol. Such persons may apply for a Civil Air Patrol license plate
15 for each vehicle with a rated carrying capacity of one (1) ton or
16 less upon proof of membership in the Civil Air Patrol. The license
17 plate shall be designed in consultation with the Civil Air Patrol;

18 24. Ninety-Nines License Plates - such plates shall be designed
19 and issued to members of the Ninety-Nines. Persons applying for
20 such license plate must show proof of membership in the Ninety-
21 Nines. The license plates shall be designed in consultation with
22 the Ninety-Nines;

23 25. Combat Infantryman Badge License Plates - such plates shall
24 be designed to honor recipients of the Combat Infantryman Badge.

1 The plate shall have the legend "Oklahoma OK". Below the legend
2 shall be the Combat Infantryman Badge and three numbers. Below the
3 badge and the numbers shall be the words "Combat Infantryman Badge".
4 Such persons may apply for a Combat Infantryman Badge license plate
5 for each vehicle with a rated carrying capacity of one (1) ton or
6 less;

7 26. Somalia Combat Veterans License Plates - such plates shall
8 be designed and issued to any honorably discharged or present member
9 of the United States Armed Forces who saw combat in the United
10 Nations relief effort. Such persons may apply for a Somalia Combat
11 Veteran license plate for each vehicle with a rated carrying
12 capacity of one (1) ton or less;

13 27. Police Chaplain License Plates - such plates shall be
14 designed and issued to members of the International Conference of
15 Police Chaplains (ICPC) who have completed the ICPC requirements for
16 basic certification as a police chaplain. The license plates shall
17 be designed in consultation with the ICPC;

18 28. Joint Service Commendation Medal License Plates - such
19 plates shall be designed and issued to any resident of this state
20 who has been awarded the Joint Service Commendation Medal by the
21 United States Secretary of Defense;

22 29. Merchant Marine License Plates - such plates shall be
23 designed, subject to criteria to be presented to Service Oklahoma by
24 the Oklahoma Department of Veterans Affairs, and issued to any

1 person who during combat was a member of the Merchant Marines as
2 certified by the Oklahoma Department of Veterans Affairs. Such
3 license plate may be issued for each vehicle with a rated carrying
4 capacity of one (1) ton or less;

5 30. Legislative License Plates - such plates shall be designed
6 for persons elected to the Oklahoma Legislature and shall designate
7 the house of the Legislature in which the legislator serves and the
8 district number;

9 31. Disabled Veterans License Plates - such plates shall be
10 designed for persons presenting proper certification from the United
11 States Department of Veterans Affairs or the Armed Forces of the
12 United States certifying such veteran has a service-connected
13 disability rating of fifty percent (50%) or more, regardless which
14 agency pays the disability benefits, or that such veteran has been
15 awarded a vehicle by the United States government or receives a
16 grant from the United States Department of Veterans Affairs for the
17 purchase of an automobile due to a service-connected disability
18 rating or due to the loss of use of a limb or an eye. Such persons
19 may apply to Service Oklahoma for a disabled veterans license plate
20 or to a licensed operator for a regular license plate for no more
21 than two vehicles with each vehicle having a rated carrying capacity
22 of one (1) ton or less. The surviving spouse of any deceased
23 disabled veteran, if the spouse has not since remarried, or if
24 remarried, the remarriage is terminated by death, divorce, or

1 annulment, or a surviving spouse in receipt of Dependency and
2 Indemnity Compensation from the United States Department of Veterans
3 Affairs, may apply for a disabled veterans license plate for one
4 vehicle with a rated carrying capacity of one (1) ton or less. The
5 fee provided by this section for the special license plate
6 authorized by this paragraph shall be in addition to all other
7 registration fees provided by law, except the registration fees
8 levied by Section 1132 of this title. The total expense of this
9 license plate shall not exceed Five Dollars (\$5.00).

10 If the person qualifies for a disabled veterans license plate
11 and is also eligible for a physically disabled placard under the
12 provisions of Section 15-112 of this title, the person shall be
13 eligible to receive a disabled veterans license plate that also
14 displays the international accessibility symbol, which is a stylized
15 human figure in a wheelchair. Upon the death of the disabled
16 veteran with a disabled veterans license plate with the
17 international accessibility symbol, the plate shall be returned to
18 Service Oklahoma;

19 32. United States Air Force Association License Plates - such
20 plates shall be designed for members of the United States Air Force
21 Association. Persons applying for such license plate must show
22 proof of membership in the Association. The license plates shall be
23 designed in consultation with the Association;

1 33. Oklahoma Military Academy Alumni License Plates - such
2 plates shall be designed and issued to any resident of this state
3 who is an alumnus of the Oklahoma Military Academy. Such persons
4 may apply for an Oklahoma Military Academy Alumnus license plate for
5 each vehicle with a rated carrying capacity of one (1) ton or less.
6 The license plates shall be designed in consultation with the
7 Oklahoma Military Academy and shall contain the shield of the
8 Academy;

9 34. Amateur Radio Operator License Plates - such plates shall
10 be designed and issued to any person, holding a valid operator's
11 license, technician class or better, issued by the Federal
12 Communications Commission, and who is also the owner of a motor
13 vehicle currently registered in Oklahoma, in which has been
14 installed amateur mobile transmitting and receiving equipment.
15 Eligible persons shall be entitled to two special vehicle
16 identification plates as herein provided. Application for such
17 identification plates shall be on a form prescribed by Service
18 Oklahoma and the plates issued to such applicant shall have stamped
19 thereon the word "Oklahoma" and bear the official call letters of
20 the radio station assigned by the Federal Communications Commission
21 to the individual amateur operator thereof. All applications for
22 such plates must be made to Service Oklahoma on or before the first
23 day of October of any year for such plates for the following
24 calendar year and must be accompanied by the fee required in this

1 section together with a certificate, or such other evidence as
2 Service Oklahoma may require, of proof that applicant has a valid
3 technician class or better amateur operator's license and proof of
4 applicant's ownership of a vehicle in which radio receiving and
5 transmitting equipment is installed. Applicants shall only be
6 entitled to one set of special identification plates in any one (1)
7 year, and such calendar year shall be stamped thereon. The right to
8 such special identification plates herein provided for shall
9 continue until the amateur radio operator's license of the person to
10 whom such plates are issued expires or is revoked;

11 35. American Legion License Plates - such plates shall be
12 designed for members of the American Legion. Persons applying for
13 such license plate must show proof of membership. The license
14 plates shall be designed in consultation with the American Legion of
15 Oklahoma;

16 36. Deputy Sheriff License Plates - such plates shall be
17 designed for any currently employed or retired county sheriff or
18 deputy sheriff. County sheriffs or deputy sheriffs may apply for
19 such plates for vehicles with a rated capacity of one (1) ton or
20 less upon proof of employment by or retirement from a county
21 sheriff's office by either an identification card or letter from the
22 county sheriff or a government-sponsored retirement board from which
23 the county sheriff or deputy sheriff may be receiving a pension.
24 Retirees who are eligible for such plates shall provide proof of

1 eligibility upon initial application but shall not be required to
2 provide proof of eligibility annually. The license plates shall be
3 designed in consultation with the county sheriff offices of this
4 state;

5 37. Gold Star Surviving Spouse License Plates - such plates
6 shall be designed to honor the surviving spouses and children of
7 qualified veterans. As used in this paragraph, "qualified veteran"
8 shall mean:

- 9 a. any person honorably discharged from any branch of the
10 United States Armed Forces or as a member of the
11 Oklahoma National Guard, who died as a direct result
12 of the performance of duties for any branch of the
13 United States Armed Forces or Oklahoma National Guard
14 while on active military duty, or
15 b. any person honorably discharged from any branch of the
16 United States Armed Forces or as a member of the
17 Oklahoma National Guard, who died as a result of
18 injury, illness or disease caused by the performance
19 of such duties while on active duty, whether the death
20 occurred while on active duty or after the honorable
21 discharge of such person.

22 The fee provided by this section for the special license plate
23 authorized by this paragraph shall be in addition to all other
24

1 registration fees provided by law, except the registration fees
2 levied by Section 1132 of this title;

3 38. Korea Defense Service Medal License Plates - such plates
4 shall be designed and issued to any resident of this state who has
5 been awarded the Korea Defense Service Medal by the United States
6 Secretary of Defense. Such persons may apply for a Korea Defense
7 Service Medal license plate for each vehicle with a rated carrying
8 capacity of one (1) ton or less;

9 39. 180th Infantry License Plates - such plates shall be
10 designed for members and prior members of the 180th Infantry.
11 Persons applying for such license plate must obtain and provide
12 proof of their membership from the 180th Infantry Association. The
13 license plates shall be designed in consultation with the 180th
14 Infantry;

15 40. Operation Iraqi Freedom Veteran License Plates - such
16 plates shall be designed and issued to any honorably discharged or
17 present member of the United States Armed Forces who served in
18 Operation Iraqi Freedom. Such person may apply for an Operation
19 Iraqi Freedom Veteran license plate for each vehicle with a rated
20 carrying capacity of one (1) ton or less, or for a motorcycle;
21 provided, the license plate for motorcycles may be of similar design
22 to the license plate for motor vehicles or may be a new design in
23 order to meet space requirements for a motorcycle license plate;

1 41. United States Air Force Academy Alumni License Plates -
2 such plates shall be designed and issued to any resident of this
3 state who is an alumnus of the United States Air Force Academy.
4 Such persons may apply for a United States Air Force Academy Alumnus
5 license plate for each vehicle with a rated carrying capacity of one
6 (1) ton or less;

7 42. Operation Enduring Freedom Veteran License Plate - such
8 plates shall be designed and issued to any honorably discharged or
9 present member of the United States Armed Forces who served in
10 Operation Enduring Freedom on or after September 11, 2001. The
11 license plate shall be designed in consultation with the Military
12 Department of the State of Oklahoma. Such person may apply for an
13 Operation Enduring Freedom Veteran license plate for each vehicle
14 with a rated carrying capacity of one (1) ton or less, or for a
15 motorcycle; provided, the license plate for motorcycles may be of
16 similar design to the license plate for motor vehicles or may be a
17 new design in order to meet space requirements for a motorcycle
18 license plate;

19 43. Military Multi-Decoration License Plate - such plates shall
20 be designed and issued to any honorably discharged or present member
21 of the United States Armed Forces who qualifies for more than one
22 military decoration license plate pursuant to the provisions of this
23 section. Service Oklahoma shall develop and implement a system
24 whereby the designs of the eligible license plates can be included

1 together on a single license plate. Such person may apply for a
2 Military Multi-Decoration license plate for each vehicle with a
3 rated carrying capacity of one (1) ton or less;

4 44. Global War on Terror Expeditionary License Plate - such
5 plates shall be designed and issued to any honorably discharged or
6 present member of the United States Armed Forces who has earned a
7 Global War on Terror Expeditionary decoration. The license plate
8 shall be designed in consultation with the United States Institute
9 of Heraldry and the Military Department of the State of Oklahoma.
10 Such person may apply for a Global War on Terror Expeditionary
11 license plate for each vehicle with a rated carrying capacity of one
12 (1) ton or less;

13 45. Legion of Merit Medal Recipient License Plates - such
14 plates shall be designed for any resident of this state presenting
15 proper certification from the United States Department of Veterans
16 Affairs or the Armed Forces of the United States certifying that
17 such resident has been awarded the Legion of Merit military
18 decoration. Such persons may apply for a Legion of Merit recipient
19 license plate for vehicles having a rated carrying capacity of one
20 (1) ton or less. The license plate shall be designed in
21 consultation with the Military Department of the State of Oklahoma;

22 46. 1-179th License Plates - such plates shall be designed for
23 members, prior members and members of the household of a member or
24 former member of the 1-179th Infantry. Persons applying for such

1 license plate must obtain and provide proof of their membership
2 association with the 1-179th Infantry Association. The license
3 plate shall be designed in consultation with the 1-179th Infantry;

4 47. 2-179th License Plates - such plates shall be designed for
5 members, prior members and members of the household of a member or
6 former member of the 2-179th Infantry. Persons applying for such
7 license plate must obtain and provide proof of their membership
8 association with the 2-179th Infantry Association. The license
9 plate shall be designed in consultation with the 2-179th Infantry;

10 48. Combat Action Ribbon Recipient License Plates - such plates
11 shall be designed to honor recipients of the Combat Action Ribbon
12 who present proper certification from the United States Department
13 of the Navy. The license plate shall include the Combat Action
14 Ribbon earned by the recipient. Such persons may apply for a Combat
15 Action Ribbon Recipient license plate for vehicles having a rated
16 carrying capacity of one (1) ton or less;

17 49. Oklahoma Submarine Veterans License Plate - such plates
18 shall be designed for any resident of this state who is a United
19 States submarine veteran and presents either a Department of Defense
20 form 214 or other documentation certifying such service. Such
21 persons may apply for an Oklahoma Submarine Veterans license plate
22 for vehicles having a rated capacity of one (1) ton or less. The
23 license plate design shall include both gold and silver dolphins to
24 represent both officer and enlisted service members;

1 50. United States Navy Seabees and Civil Engineer Corps License
2 Plate - such plates shall be designed and issued to any honorably
3 discharged or present member of the United States Navy Seabees or
4 Civil Engineer Corps. Such persons may apply for a United States
5 Navy Seabees and Civil Engineer Corps license plate for vehicles
6 having a rated carrying capacity of one (1) ton or less. The
7 license plate shall be designed in consultation with the Military
8 Department of the State of Oklahoma;

9 51. Combat Action Badge Recipient License Plate - such plates
10 shall be designed to honor recipients of the Combat Action Badge who
11 present proper certification from the United States Army. The
12 license plate shall include the Combat Action Badge earned by the
13 recipient. Such persons may apply for a Combat Action Badge
14 Recipient license plate for vehicles having a rated carrying
15 capacity of one (1) ton or less, or for a motorcycle; provided, the
16 license plate for motorcycles may be of similar design to the
17 license plate for motor vehicles or may be a new design in order to
18 meet space requirements for a motorcycle license plate;

19 52. Iraq Combat Veteran License Plate - such plates shall be
20 designed and issued to any honorably discharged or present member of
21 the United States Armed Forces who saw combat in Operation Iraqi
22 Freedom. Such persons may apply for an Iraq Combat Veteran license
23 plate for each vehicle with a rated carrying capacity of one (1) ton
24 or less, or for a motorcycle; provided, the license plate for

1 motorcycles may be of similar design to the license plate for motor
2 vehicles or may be a new design in order to meet space requirements
3 for a motorcycle license plate;

4 53. Afghanistan Combat Veteran License Plate - such plates
5 shall be designed and issued to any honorably discharged or present
6 member of the United States Armed Forces who saw combat in Operation
7 Enduring Freedom. Such persons may apply for an Afghanistan Combat
8 Veteran license plate for each vehicle with a rated carrying
9 capacity of one (1) ton or less, or for a motorcycle; provided, the
10 license plate for motorcycles may be of similar design to the
11 license plate for motor vehicles or may be a new design in order to
12 meet space requirements for a motorcycle license plate;

13 54. Special Forces Association License Plates - such plates
14 shall be designed and issued to any honorably discharged or present
15 member of the Army Special Forces qualified and authorized to wear
16 upon the person's United States military uniform the Army Special
17 Forces Tab. Persons applying for the Special Forces Association
18 license plate must provide a copy of the orders awarding the Special
19 Forces Tab or authorizing its wear upon a United States military
20 uniform. The license plate shall be designed in consultation with
21 the Special Forces Association, Chapter 32-50. Service Oklahoma
22 shall produce up to two distinct designs for the Special Forces
23 Association license plate. Qualified persons may select one design
24 at the time of application. The plates shall be issued to any

1 qualified person in any combination of numbers and letters from one
2 to a maximum of seven, as for personalized license plates;

3 55. Veterans of the United States Armed Forces License Plates -
4 such plates shall be designed for veterans of the United States
5 Armed Forces, and shall identify the branch of service, carry the
6 emblem and name of either the Army, Navy, Air Force, Marines or
7 Coast Guard, according to the branch of service to which the member
8 belonged, and shall reflect veteran status. Former members who have
9 been dishonorably discharged shall not be eligible for such plates.
10 Persons applying for such license plates must show proof of past
11 military service by presenting a valid United States Department of
12 Defense Form (DD)214 upon initial application but shall not be
13 required to provide proof of eligibility annually;

14 56. Navy Chief License Plates - such plates shall be designed
15 and issued to any resident of this state who has achieved the rank
16 of E7 through E9 in the United States Navy and presents proper
17 certification that the resident has achieved such rank and was
18 either honorably discharged or is an active or retired member of the
19 United States Navy. Such persons may apply for a Navy Chief license
20 plate for vehicles having a rated carrying capacity of one (1) ton
21 or less, or for a motorcycle; provided, the license plate for
22 motorcycles may be of similar design to the license plate for motor
23 vehicles or may be a new design in order to meet space requirements
24 for a motorcycle license plate;

1 57. Air Medal License Plate - such plates shall be designed and
2 issued to any resident of this state who has earned the Air Medal
3 and presents proper certification that the resident has been awarded
4 such medal. The license plate shall include an image of the Air
5 Medal earned by the recipient. Such persons may apply for an Air
6 Medal license plate for vehicles having a rated carrying capacity of
7 one (1) ton or less, or for a motorcycle; provided, the license
8 plate for motorcycles may be of similar design to the license plate
9 for motor vehicles or may be a new design in order to meet space
10 requirements for a motorcycle license plate;

11 58. a. U.S. Army Ranger License Plate - such plates shall be
12 designed and issued to any resident of this state who
13 is an active, retired, or honorably discharged member
14 of a U.S. Army Ranger unit, or who is a graduate of
15 the U.S. Army Ranger School. Persons applying for the
16 U.S. Army Ranger License Plate shall provide military
17 orders or official documentation proving the
18 applicant's eligibility, including:

- 19 (1) military orders detailing a past or current
20 assignment to a U.S. Army Ranger unit,
21 (2) military orders awarding the Ranger Tab
22 authorized by the U.S. Army,
23 (3) certificate of release or discharge from active
24 duty, DD Form 214, or report of separation and

1 record of service, NGB form 22, indicating the
2 awarding of the Ranger Tab, or
3 (4) diploma issued to the applicant from the U.S.
4 Army Ranger School.

5 b. In addition to the documentation listed above, an
6 active military member shall present a valid military
7 identification card or a document that shows
8 sufficient proof that the applicant is an active
9 member of the military. A retired or honorably
10 discharged member of the military shall present:

11 (1) a certified copy of the member's release or
12 discharge from active duty, DD Form 214,
13 honorable discharge certificate, United States
14 Department of Defense Form 256, or report of
15 separation and record of service, NGB form 22,
16 which has an honorable discharge
17 characterization, or

18 (2) a valid form DD2 (retired) military
19 identification card. Such persons may apply for
20 a U.S. Army Ranger License Plate for vehicles
21 having a rated carrying capacity of one (1) ton
22 or less, or for a motorcycle; provided, the
23 license plate for motorcycles may be of similar
24 design to the license plate for motor vehicles or

1 may be a new design in order to meet space
2 requirements for a motorcycle license plate. The
3 license plate shall be designed in consultation
4 with the Military Department of the State of
5 Oklahoma;

6 59. 45th Infantry Brigade Combat Team License Plate - such
7 plates shall be designed for members, former members, and members of
8 the household of a member or former member of the 45th Infantry
9 Brigade Combat Team. Persons applying for such license plate shall
10 obtain and provide suitable proof of their membership association
11 with the 45th Infantry Brigade Combat Team. Such persons may apply
12 for a 45th Infantry Brigade Combat Team License Plate for vehicles
13 having a rated carrying capacity of one (1) ton or less, or for a
14 motorcycle; provided, the license plate for motorcycles may be of
15 similar design to the license plate for motor vehicles or may be a
16 new design in order to meet space requirements for a motorcycle
17 license plate. The license plate shall be designed in consultation
18 with the Military Department of the State of Oklahoma; and

19 60. Meritorious Service Medal License Plate - such plates shall
20 be designed and issued to any resident of this state who has earned
21 the Meritorious Service Medal and presents proper certification that
22 the resident has been awarded such medal. The license plate shall
23 include an image of the Meritorious Service Medal earned by the
24 recipient. Such persons may apply for a Meritorious Service Medal

1 license plate for vehicles having a rated carrying capacity of one
2 (1) ton or less, or for a motorcycle; provided, the license plate
3 for motorcycles may be of similar design to the license plate for
4 motor vehicles or may be a new design in order to meet space
5 requirements for a motorcycle license plate.

6 C. Unless otherwise provided by this section, the fee for such
7 plates shall be Eight Dollars (\$8.00) and shall be in addition to
8 all other registration fees provided by the Oklahoma Vehicle License
9 and Registration Act. Such fees shall be deposited in the Oklahoma
10 Tax Commission Reimbursement Fund to be used for the administration
11 of the Oklahoma Vehicle License and Registration Act. Beginning
12 January 1, 2023, such fees shall be deposited in the Service
13 Oklahoma Reimbursement Fund to be used for the administration of the
14 Oklahoma Vehicle License and Registration Act.

4 SECTION 85. AMENDATORY 47 O.S. 2021, Section 1135.3, as
5 last amended by Section 2, Chapter 275, O.S.L. 2023 (47 O.S. Supp.
6 2023, Section 1135.3), is amended to read as follows:

7 Section 1135.3. A. Service Oklahoma is hereby authorized to
8 design and issue appropriate official special license plates to
9 persons wishing to demonstrate support, interest or membership to or
10 for an organization, occupation, cause or other subject as provided
11 by this section.

12 Special license plates shall not be transferred to any other
13 person but shall be removed from the vehicle upon transfer of
14 ownership and retained. The special license plate may then be used
15 on another vehicle but only after such other vehicle has been
16 registered for the current year.

17 Special license plates shall be renewed each year by Service
18 Oklahoma or a licensed operator, unless authorized by Service
19 Oklahoma to be renewed for a period greater than one (1) year.
20 Service Oklahoma shall notify by mail all persons issued special
21 license plates. The notice shall contain all necessary information
22 and shall contain instructions for the renewal procedure upon
23 presentation to a licensed operator or Service Oklahoma. The
24 license plates shall be issued on a staggered system.

1 On and after January 1, 2022, if a special license plate is
2 issued pursuant to this section, any registration fee required for
3 such plate pursuant to this section and the fee required pursuant to
4 Section 1132 of this title shall be remitted at the same time and
5 subject to a single registration period. Service Oklahoma shall
6 determine, by rule, a method for making required fee and
7 registration period adjustments if a special license plate is
8 obtained during a twelve-month period for which a registration fee
9 has already been remitted pursuant to Section 1132 of this title.
10 The combination of fees in a single remittance shall not alter the
11 apportionment otherwise provided for in this section.

12 Service Oklahoma is hereby directed to develop and implement a
13 system whereby licensed operators are permitted to accept
14 applications for special license plates authorized under this
15 section. The licensed operator shall confirm the applicant's
16 eligibility, if applicable, collect and deposit any amount
17 specifically authorized by law, accept and process the necessary
18 information directly into such system and generate a receipt
19 accordingly. For performance of these duties, licensed operators
20 shall retain the fee provided in Section 1141.1 of this title for
21 registration of a motor vehicle. The licensed operator fees for
22 acceptance of applications and renewals shall be paid out of the
23 Oklahoma Tax Commission Reimbursement Fund. Beginning January 1,
24 2023, the licensed operator fees for acceptance of applications and

1 renewals shall be paid out of the Service Oklahoma Reimbursement
2 Fund.

3 If fewer than one hundred of any type of special license plates
4 authorized prior to January 1, 2004, are issued prior to January 1,
5 2006, Service Oklahoma shall discontinue issuance and renewal of
6 that type of special license plate. Any such authorized special
7 license plate registrant shall be allowed to display the license
8 plate upon the designated vehicle until the registration expiration
9 date. After such time the expired special license plate shall be
10 removed from the vehicle.

11 Except as otherwise provided in law, for special license plates
12 authorized on or after July 1, 2004, no special license plates shall
13 be developed or issued by Service Oklahoma until Service Oklahoma
14 receives one hundred (100) prepaid applications therefor. The
15 prepaid applications must be received by Service Oklahoma within one
16 hundred eighty (180) days of the effective date of the authorization
17 or the authority to issue shall be null and void. In the event one
18 hundred (100) prepaid applications are not received by Service
19 Oklahoma within such prescribed time period any payment so received
20 shall be refunded accordingly.

20 consultation with the Masonic Fraternities of Oklahoma and shall
21 contain the Masonic emblem;

22 5. Shriners Hospitals for Children License Plate - such plates
23 shall be designed to demonstrate support for Shriners Hospitals for
24 Children and shall be issued to any resident of this state who is a

1 member of a Shriners Temple in Oklahoma. The license plate shall be
2 designed in consultation with the Shriners Temples in Oklahoma and
3 shall contain the Shriners emblem;

4 6. Balloonists License Plate - such plates shall be designed
5 and issued to any person wishing to demonstrate support for hot air
6 ballooning in this state;

7 7. Order of the Eastern Star License Plate - such plates shall
8 be designed and issued to any resident of this state who is a member
9 of an Order of the Eastern Star. Such persons may apply for an
10 Order of the Eastern Star license plate for each vehicle with a
11 rated carrying capacity of one (1) ton or less upon proof of an
12 Order of the Eastern Star membership or upon the presentment of an
13 application for an Order of the Eastern Star license plate
14 authorized and approved by the organization. The license plate
15 shall be designed in consultation with the Order of the Eastern Star
16 and shall contain the Order of the Eastern Star emblem;

17 8. Knights of Columbus License Plate - such plates shall be
18 designed and issued to any resident of this state who is a member of
19 the Knights of Columbus. Such persons may apply for a Knights of
20 Columbus license plate for each vehicle with a rated carrying
21 capacity of one (1) ton or less upon proof of a Knights of Columbus
22 membership or upon the presentment of an application for a Knights
23 of Columbus license plate authorized and approved by the
24 organization. The license plate shall be designed in consultation

1 with the Knights of Columbus and shall contain the Knights of
2 Columbus emblem;

3 9. Jaycees License Plate - such plates shall be designed and
4 issued to members of the Jaycees. Persons applying for such license
5 plate must show proof of membership in the Jaycees. The license
6 plates shall be designed in consultation with the Jaycees;

7 10. Kiwanis International License Plate - such plates shall be
8 designed and issued to members of Kiwanis International. Persons
9 applying for such license plate must show proof of membership in
10 Kiwanis International. The license plates shall be designed in
11 consultation with Kiwanis International;

12 11. Certified Public Accountants License Plate - such plates
13 shall be designed and issued to any resident of this state who is a
14 Certified Public Accountant. Such persons may apply for a Certified

11 consultation with the Southeast High School Alumni Association;

12 75. Catoosa High School License Plate - such plates shall be
13 designed and issued to any person wishing to demonstrate support for
14 Catoosa High School located in Catoosa. The plates shall bear the
15 image of the Catoosa High School mascot and be designed in
16 consultation with representatives of Catoosa High School;

17 76. Toastmasters International License Plate - such plates
18 shall be issued to persons wishing to demonstrate support for
19 Toastmasters International and shall be designed in consultation
20 with District 16 of Toastmasters International;

21 77. Millwood High School Alumni License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for Millwood High School Alumni. The license plate shall be

1 designed in consultation with representatives of the Millwood High

3 78. Patriot Guard Riders License Plate - such plates shall be
4 issued to persons wishing to demonstrate support for Patriot Guard
5 Riders and shall be designed in consultation with the Patriot Guard

8 designed and issued to any person wishing to demonstrate support for
9 the Bixby School District. The license plate shall be designed in

12 be designed in consultation with the Advanced Power Alliance and
13 issued to any person wishing to demonstrate support for renewable

17 the Scottish Rite Masons. Such persons may apply for a Scottish

20 membership. The license plates shall be designed in consultation
21 with the Scottish Rite Masons in Oklahoma and shall contain the
22 Scottish Rite emblem;

23 82. New State Brand License Plate - such plates shall be
24 designed, subject to the criteria to be presented to Service

Oklahoma by the Oklahoma Tourism and Recreation Department, and issued to any person wishing to demonstrate support for the new Oklahoma brand. The license plates shall contain the new state brand;

83. Tulsa Flag License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for the City of Tulsa. The license plates shall be designed in consultation with the Tulsa Community Foundation;

84. ROAD License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for Recovering Oklahomans After Disaster. The license plates shall be designed in consultation with the Recovering Oklahomans After Disaster organization;

85. Tulsa Icon License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for the Tulsa community for a vehicle or motorcycle in a pre-numbered format or any combination of numbers and letters from one to a maximum of six for vehicles or one to a maximum of five for motorcycles, as for personalized plates. The plate design for vehicles will include Tulsa's iconic Golden Driller and Route 66 Rising sculpture. The license plate for a motorcycle may be of similar design as space permits or a new design in order to meet the space requirements of a motorcycle license plate; ~~and~~

1 86. ORA License Plate - such plates shall be designed and
2 issued to any person wishing to demonstrate support for the Oklahoma
3 Rifle Association. The license plates shall be designed in
4 consultation with the Oklahoma Rifle Association;

6 shall be designed and issued to any person wishing to demonstrate
7 support for the Hallett Motor Racing Circuit. The license plates
8 shall be designed in consultation with the Hallett Motor Racing

11 designed and issued to any person wishing to demonstrate support for
12 the University of Kansas. The license plates shall be designed in

4 vehicles with a rated capacity of one (1) ton or less or for a
5 motorcycle upon proof of a fire department membership by either an
6 identification card or letter from the chief of the fire department.
7 Retirees who are eligible for such plates shall provide proof of
8 eligibility upon initial application, but shall not be required to
9 provide proof of eligibility annually. The surviving spouse of any
10 deceased firefighter, if the spouse has not since remarried, may
11 apply for a firefighter license plate for one vehicle with a rated
12 carrying capacity of one (1) ton or less or for a motorcycle upon

22 designed, subject to the criteria to be presented to Service
23 Oklahoma by the Department of Wildlife Conservation in consultation
24 with the Oklahoma Arts Council, and issued to any person wishing to

1 demonstrate support for wildlife conservation in this state through
2 the Wildlife Diversity Fund, provided for in Section 3-310 of Title
3 29 of the Oklahoma Statutes. Such plates may be designed and issued
4 to any person as for personalized license plates.

5 As provided in this section, an amount of the fee collected
6 shall be apportioned pursuant to subsection D of Section 3-310 of
7 Title 29 of the Oklahoma Statutes;

8 5. Child Abuse Prevention License Plate - such plates shall be
9 designed, subject to the criteria to be presented to Service
10 Oklahoma by the Office of Child Abuse Prevention in the State
11 Department of Health and the Child Abuse Prevention Action
12 Committee, and issued to any person wishing to demonstrate support
13 for the prevention of child abuse.

14 As provided in this section, an amount of the fee collected
15 shall be deposited in the Child Abuse Prevention Fund;

16 6. United States Olympic and Paralympic Committee Supporter
17 License Plate - such plates shall be designed and issued to any
18 person wishing to demonstrate support for the United States Olympic
19 and Paralympic Committee. The plates shall be issued to any person
20 in any combination of numbers and letters from one to a maximum of
21 seven, as for personalized license plates. The plate shall contain
22 the official United States Olympic and Paralympic Committee logo.
23 Service Oklahoma shall be authorized, if necessary, to enter into a
24 licensing agreement with the United States Olympic and Paralympic

1 Committee for any licensing fees which may be required in order to

3 design. The licensing agreement shall provide for a payment not

9 collected shall be deposited to the Oklahoma Historical Society

11 8. Historic Route 66 License Plate - such:

12 a. vehicle plates shall be designed to honor historic
13 Route 66, also known as the "Mother Road". As
14 provided in this section, an amount of the fee
15 collected for each vehicle license plate shall be
16 apportioned to the Oklahoma Historical Society
17 Revolving Fund to be distributed to the Route 66
18 Museum located in Clinton, Oklahoma, and

19 b. motorcycle plates shall be designed in consultation
20 with the Oklahoma Route 66 Association, Inc. Service
21 Oklahoma shall be authorized to enter into a licensing
22 agreement with the Oklahoma Route 66 Association,
23 Inc., for any licensing fees which may be required in
24 order to use the Oklahoma Route 66 Association, Inc.,

5 9. Heart of the Heartland License Plate - such plates shall be

7 the terrorist bombing attack on the Alfred P. Murrah Federal
8 Building in downtown Oklahoma City on April 19, 1995. As provided
9 in this section, an amount of the fee collected shall be deposited
10 in the Heart of the Heartland Scholarship Fund, as established in
11 Section 2282 of Title 70 of the Oklahoma Statutes;

12 10. Emergency Medical Technician License Plate - such plates
13 shall be designed and issued to any person who is an emergency
14 medical technician. Such persons may apply for an emergency medical
15 technician license plate for each vehicle with a rated carrying
16 capacity of one (1) ton or less upon proof of an emergency medical
17 technician's license. The license plate shall be designed in
18 consultation with the Oklahoma Emergency Medical Technicians
19 Association. As provided in this section, an amount of the fee
20 collected shall be apportioned to the Emergency Medical Personnel
21 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
22 of the Oklahoma Statutes;

1 11. Fight Breast Cancer License Plate - such plates shall be
2 designed to demonstrate support for the prevention and treatment of
3 breast cancer in this state;

4 12. Crime Victims Awareness License Plate - such plates shall
5 be designed and issued to any person wishing to demonstrate
6 awareness of and support for victims of crimes. The license plates
7 shall be designed in consultation with the Crime Victims
8 Compensation Program. As provided in this section, an amount of the
9 fee collected shall be apportioned to the Attorney General's
10 Revolving Fund for the Office of the Attorney General, which is
11 hereby directed to use such funds to contract with a statewide
12 nonprofit organization to provide services to crime victims;

13 13. Safe Kids Oklahoma License Plate - such plates shall be
14 designed and issued to any person wishing to demonstrate support and
15 awareness of Safe Kids Oklahoma. The license plate shall be
16 designed in consultation with the Safe Kids Oklahoma. As provided
17 in this section, an amount of the fee collected shall be deposited
18 in the Children's Hospital - Safe Kids Oklahoma Revolving Fund to be

7 consultation with the Oklahoma Arts Council, and issued to any
8 person wishing to demonstrate support of the Department's Ag in the
9 Classroom Education Program. As provided in this section, an amount
10 of the fee collected shall be apportioned as provided in Section
11 1104.3 of this title;

12 16. Oklahoma Statehood Centennial License Plate - such plates
13 shall be designed and issued to any person wishing to commemorate
14 the centennial of Oklahoma's admission to statehood in 1907. The
15 license plates shall be designed in consultation with the Oklahoma
16 Capitol Complex and Centennial Commemoration Commission. As
17 provided in this section, an amount of the fee collected shall be
18 deposited in the Oklahoma Department of Commerce Revolving Fund
19 created in Section 5012 of Title 74 of the Oklahoma Statutes;

20 17. Support Education License Plate - such plates shall be
21 designed, subject to criteria to be presented to Service Oklahoma by
22 the State Department of Education in consultation with the Oklahoma
23 Arts Council, and issued to any person wishing to demonstrate
24 support for education in this state. All licensed operators shall

1 display a sample of the Support Education License plate in the area
2 of the business accessed by the public. Twenty-three Dollars
3 (\$23.00) of the fee collected shall be apportioned as follows:

- 4 a. five percent (5%) shall be deposited to the Education
5 Reform Revolving Fund,
- 6 b. five percent (5%) shall be deposited to the Oklahoma
7 State Regents for Higher Education Revolving Fund,
- 8 c. five percent (5%) shall be deposited to the State

D. For special license plates that provide financial assistance created pursuant to the provisions of this section, Service Oklahoma shall be authorized to enter into a licensing agreement with an organization for any licensing fees that may be required to use the organization's logo or design.

E. The fee for special license plates that provide financial assistance shall be determined in accordance with Section 1135.9 of this title. Provided, the fee shall be no less than Thirty-five Dollars (\$35.00) and shall be in addition to all other registration fees provided by the Oklahoma Vehicle License and Registration Act. Thirty-five Dollars (\$35.00) per year of renewal of the fee shall be apportioned as follows:

1. a. Twenty Dollars (\$20.00) of the fee shall be apportioned to the License Plate Special Program Assistance Revolving Fund created in Section 1135.8 of

1 this title to be used in the manner detailed in the
2 application for the special license plate, except as
3 provided in subparagraph b of this paragraph.

4 b. If Service Oklahoma has entered into a licensing
5 agreement with an organization for the use of its
6 design or logo pursuant to Chapter 74 of this title,
7 an amount to be determined in the licensing agreement,

14 It shall be the responsibility of the selling dealer to place a
15 temporary license plate, in size similar to the permanent Oklahoma
16 license plate but of a weatherproof plastic-impregnated substance
17 approved by the Oklahoma Used Motor Vehicle, Dismantler, and
18 Manufactured Housing Commission, upon a used motor vehicle, travel
19 trailer or commercial trailer when a transaction is completed for
20 the sale of said vehicle. The temporary license plate under this
21 subsection shall be placed at the location provided for the
22 permanent motor vehicle license plate. The temporary license plate
23 shall show the license number which is issued to the dealer each
24 year by ~~the Oklahoma Tax Commission~~ Service Oklahoma or the Oklahoma

1 Used Motor Vehicle, Dismantler, and Manufactured Housing Commission,
2 the date the used motor vehicle, travel trailer or commercial
3 trailer was purchased and the company name of the selling dealer.
4 The Oklahoma Used Motor Vehicle, Dismantler, and Manufactured
5 Housing Commission is hereby directed to develop the temporary
6 license plate design to incorporate these requirements in a manner
7 that will permit law enforcement personnel to readily identify the
8 dealer license number and date of the vehicle purchase. The
9 Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing
10 Commission is hereby authorized to develop additional requirements
11 and parameters as deemed appropriate to discourage or prevent
12 illegal duplication and use of the temporary license plate. Such
13 temporary license plate shall be valid for a period of thirty (30)
14 days from the date of purchase. Use of the temporary license by a
15 dealer for other than the purposes set forth herein shall constitute
16 grounds for revocation of the dealer's license to conduct business.
17 Purchasers of a commercial trailer shall affix the temporary license
18 plate to the rear of the commercial trailer. The purchaser shall
19 display the temporary license plate for a period not to exceed
20 ~~thirty (30) days~~ two (2) months or until registration and title are
21 obtained as provided in this section.

22 The provisions of this subsection on temporary licenses shall
23 apply to nonresidents who purchase a used motor vehicle, travel
24 trailer or commercial trailer within this state that is to be

1 licensed in another state. The nonresident purchaser shall be
2 allowed to operate the vehicle or trailer within the state with a
3 temporary license plate for a period not to exceed ~~thirty (30) days~~
4 two (2) months from date of purchase. Any nonresident purchaser
5 found to be operating a used motor vehicle, travel trailer or
6 commercial trailer within this state after ~~thirty (30) days~~ two (2)
7 months shall be subject to the registration fees of this state upon
8 the same terms and conditions applying to residents of this state.

9 F. It shall be unlawful for any dealer to procure the
10 registration and licensing of any used motor vehicle, travel trailer
11 or commercial trailer sold by the dealer or to act as the agent for
12 the purchaser in the procurement of the registration and licensing
13 of the purchaser's used vehicle, travel trailer or commercial
14 trailer. A license of any dealer violating the provision of this
15 section may be revoked.

16 G. Dealers following the procedure set forth herein shall not
17 be required to register vehicles, travel trailers or commercial
18 trailers to which this section applies, nor will the registration
19 fee otherwise required be assessed. Provided, dealers shall not
20 purchase or trade for a used motor vehicle, travel trailer or
21 commercial trailer on which the registration therefor has been
22 expired for a period exceeding ~~thirty (30) days~~ two (2) months
23 without obtaining current registration therefor.

1 H. A nonprofit charitable organization which is exempt from
2 taxation pursuant to the provisions of the Internal Revenue Code, 26
3 U.S.C., Section 501(c)(3), and which accepts donations of used motor
4 vehicles previously titled in Oklahoma to be subsequently
5 transferred to another owner, upon the qualifying organization
6 providing sufficient documentation of its tax-exempt status, may
7 obtain from ~~the Oklahoma Tax Commission~~ Service Oklahoma charitable
8 nonprofit organization license plates for demonstrating,
9 transporting or test-driving donated vehicles, provided that no
10 organization shall possess or use at any one time more than eight
11 such plates. ~~The Tax Commission~~ Service Oklahoma shall design
12 distinctive license plates for that purpose. The cost for said
13 plates shall be the same as provided in subsection A of this section
14 for dealer plates.

15 I. The transfer of ownership from the vehicle donor to the
16 qualifying nonprofit organization described in subsection H of this
17 section shall be made without the payment of motor vehicle excise
18 tax levied pursuant to Section 2103 of Title 68 of the Oklahoma
19 Statutes.

20 SECTION 103. REPEALER 47 O.S. 2021, Section 1137.1, as
21 last amended by Section 1, Chapter 262, O.S.L. 2023 (47 O.S. Supp.
22 2023, Section 1137.1), is hereby repealed.

1 SECTION 104. AMENDATORY 47 O.S. 2021, Section 1137.3, as
2 last amended by Section 32, Chapter 29, O.S.L. 2023 (47 O.S. Supp.
3 2023, Section 1137.3), is amended to read as follows:

4 Section 1137.3. The purchaser of every new motor vehicle,
5 travel trailer, or commercial trailer shall register or license the
6 same within thirty ~~(30) days~~ two (2) months from the date of
7 purchase. It shall be the responsibility of the selling dealer to
8 place a temporary license plate, in size similar to the permanent
9 Oklahoma license plate but of a weatherproof plastic-impregnated
10 substance approved by the Oklahoma New Motor Vehicle Commission,
11 upon a new motor vehicle, travel trailer, or commercial trailer when
12 a transaction is completed for the sale of the vehicle or trailer.
13 Except for cab and chassis trucks, the temporary license plate under
14 this section shall be placed at the location provided for the
15 permanent motor vehicle license plate. The purchaser of a new cab
16 and chassis truck may place the temporary license plate under this
17 section in the rear window. The temporary license plate shall show
18 the dealer's license number which is issued to him or her each year
19 by Service Oklahoma, the date the new motor vehicle, travel trailer,
20 or commercial trailer was purchased, and the company name of the
21 selling dealer. The Commission is hereby directed to develop a
22 temporary license plate design to incorporate these requirements in
23 a manner that will permit law enforcement personnel to readily
24 identify the dealer license number and date of the vehicle purchase.

1 The Commission is further authorized to develop additional
2 requirements and parameters designed to discourage or prevent
3 illegal duplication and use of the temporary license plate. On or
4 before ~~thirty (30) days~~ two (2) months from the date of purchase of
5 a new motor vehicle, travel trailer, or commercial trailer, the
6 temporary license plate shall be removed and replaced with a
7 permanent, current Oklahoma license plate. Use of the temporary
8 license plate by a licensed dealer for other than the purpose of
9 normally doing business shall constitute grounds for revocation of
10 the dealer's license.

11 It shall be unlawful for any licensed dealer of new motor
12 vehicles, travel trailers, or commercial trailers to procure the
13 registration and licensing of any new motor vehicle, travel trailer,
14 or commercial trailer sold by such licensed dealer or to act as the
15 agent for such purchaser in the procurement of the registration and
16 licensing. The license of any licensed dealer of new motor
17 vehicles, travel trailers, or commercial trailers violating the
18 provisions of this section shall be revoked.

22 SECTION 106. AMENDATORY 47 O.S. 2021, Section 1140, as
23 last amended by Section 33, Chapter 310, O.S.L. 2023 (47 O.S. Supp.
24 2023, Section 1140), is amended to read as follows:

1 Section 1140. A. The Service Oklahoma Operator Board shall
2 adopt rules prescribing minimum qualifications and requirements for
3 locating Service Oklahoma locations and for persons applying for a
4 license to operate a designated Service Oklahoma location. Such
5 qualifications and requirements shall include, but not be limited
6 to, the following:

7 1. Necessary job skills and experience;

8 2. Minimum office hours;

9 3. Provision for sufficient staffing, equipment, office space
10 and parking to provide maximum efficiency and maximum convenience to
11 the public;

12 4. Obtainment of a faithful performance surety bond as provided
13 for by law;

14 5. That the applicant has not been convicted of a felony and
15 that no felony charges are pending against the applicant;

16 6. That the location specified in the individual's application
17 for a license to operate a designated Service Oklahoma location not
18 be owned by a member of Service Oklahoma or an employee of Service
19 Oklahoma or any person related to a member of Service Oklahoma or an
20 employee of Service Oklahoma within the third degree by
21 consanguinity, marriage, or adoption and that the location not be
22 within a three-mile radius of an existing licensed operator unless
23 the applicant is assuming the location of an operating licensed
24 operator;

1 7. That a single website, designated by Service Oklahoma, will
2 be used for the distribution of services provided by Service
3 Oklahoma with motor vehicle services to be fulfilled by licensed
4 operators;

5 8. That licensed operators will attend all required training
6 provided by Service Oklahoma; and

7 9. That there should be at least one Service Oklahoma location
8 in each county.

9 B. 1. Any person making application to the Service Oklahoma
10 Operator Board for the purpose of obtaining a license to operate a
11 designated Service Oklahoma location shall pay, when submitting the
12 application, a nonrefundable application fee of One Hundred Dollars
13 (\$100.00). All such application fees shall be deposited in the
14 Oklahoma Tax Commission ~~Revolving~~ Fund. Beginning January 1, 2023,
15 all such application fees shall be deposited in the Service Oklahoma
16 Revolving Fund.

17 2. Any person making application to the Service Oklahoma
18 Operator Board for the purpose of obtaining a license to operate a
19 designated Service Oklahoma location must meet standardization and
20 branding requirements established by the Service Oklahoma Operator
21 Board, upon recommendations from Service Oklahoma. Upon approval,
22 the person must either pay a fee to Service Oklahoma for all costs
23 related to meeting the standardization and branding requirements or
24 obtain approval from the Service Oklahoma Operator Board that the

1 location meets all standardization and branding requirements. All
2 such fees shall be deposited in the Service Oklahoma Revolving Fund.
3 The amount of the license fee will be determined by the Service
4 Oklahoma Operator Board. This provision shall not apply to any
5 existing Service Oklahoma location.

6 3. Any person shall have been a resident of the State of
7 Oklahoma for a period of six (6) months prior to submitting an
8 application for a license to operate a designated Service Oklahoma
9 location. If a licensed operator moves his or her residence to a
10 place outside the State of Oklahoma, the licensed operator shall
11 provide notice to the Service Oklahoma Operator Board and sell his
12 or her license within ninety (90) days of such notice.

13 C. Upon application by a person to serve as a licensed
14 operator, the Service Oklahoma Operator Board is authorized to make
15 a determination whether such person and such location meets the
16 criteria and guidelines established by the Service Oklahoma Operator
17 Board and, if such be the case, may issue a license to operate a
18 designated Service Oklahoma location.

19 D. 1. A licensed operator may be permitted, upon application,
20 to sell or transfer an existing license to operate a designated
21 Service Oklahoma location. Any sale or transfer of a license is
22 subject to approval of the Service Oklahoma Operator Board. In
23 order to sell or transfer an existing licensed operator license, the
24

1 licensed operator shall meet the following guidelines and
2 requirements:

- 3 a. the licensed operator shall be in good standing with
4 the Service Oklahoma Operator Board,
- 5 b. the licensed operator shall have held a licensed
6 operator license, issued by the Service Oklahoma
7 Operator Board, for a minimum of five (5) years, and
- 8 c. the licensed operator shall provide the Service
9 Oklahoma Operator Board evidence that the proposed
10 buyer or transferee of the licensed operator licensee
11 meets the qualifications and requirements set forth in
12 subsection A of this section, has the ability to meet
13 all financial requirements and terms of any current
14 existing contract between the licensed operator and
15 Service Oklahoma, and agrees to the onboarding and
16 training requirements of Service Oklahoma, as
17 established by Service Oklahoma and the Service
18 Oklahoma Operator Board.

19 2. The purchase price of a licensed operator license shall be
20 agreed upon by the licensed operator and the individual purchasing
21 the license to operate a designated Service Oklahoma location.
22 However, the purchaser or transferee agrees to pay a transfer fee to
23 Service Oklahoma in the amount of three percent (3%) of the last
24 annual gross revenue from fees retained at the Service Oklahoma

1 location to be purchased, not to exceed Fifteen Thousand Dollars
2 (\$15,000.00). The transfer fee shall be deposited in the Service
3 Oklahoma Revolving Fund.

4 3. Upon receipt of the application to sell or transfer an
5 existing licensed operator license, the Service Oklahoma Operator
6 Board will determine whether the licensed operator license may be
7 sold or transferred on the condition that the existing location is
8 in good standing and the new licensee meets the requirements
9 outlined in Section 1140 et seq. of this title.

10 4. The Service Oklahoma Operator Board may, at its discretion,
11 buy back a licensed operator license from a licensed operator who
12 desires to sell or transfer its licensed operator license but has
13 held a licensed operator license issued by Service Oklahoma for less
14 than five (5) years. The purchase price for such a license will be
15 one-half (1/2) times the most recent annual gross revenue from fees
16 retained of that Service Oklahoma location, not to exceed Two
17 Hundred Thousand Dollars (\$200,000.00). The purchase price shall be
18 paid out of the excess funds available in the Licensed Operator
19 Performance Fund, created in Section 3-106 of this title, after
20 distribution to licensed operators, pursuant to Section 3-106 of
21 this title.

22 5. Licensed operators issued a license to operate a designated
23 Service Oklahoma location on January 1, 2023, may be permitted, upon
24 application, to sell or transfer their existing license within the

1 first five (5) years. Any sale or transfer of such license is
2 subject to the approval of the Service Oklahoma Operator Board.

3 a. In order to sell or transfer the existing license
4 within the first five (5) years, the licensed operator
5 shall meet the following guidelines and requirements:

6 1. the licensed operator shall be in good standing
7 with the Service Oklahoma Operator Board, and

8 2. the licensed operator shall provide the Service
9 Oklahoma Operator Board evidence that the

10 proposed buyer or transferee of the licensed

11 operator licensee meets the qualifications and

12 requirements set forth in this section, has the

13 ability to meet all financial requirements and

14 terms of any current existing contract between

15 the licensed operator and Service Oklahoma, and

16 agrees to the onboarding and training

17 requirements of Service Oklahoma, as established

18 by Service Oklahoma and the Service Oklahoma

19 Operator Board.

20 b. The branding and physical standardization exemption
21 specified in this section shall not transfer to the
22 purchaser, unless:

23 (1) the licensed operator submitted a contingent
24 resignation and the purchaser submitted a

1 relation application to the Oklahoma Tax
2 Commission prior to May 19, 2022, or

3 2. the purchaser is related to the licensed operator
4 within the third degree by consanguinity,
5 marriage, or adoption.

6 E. 1. Licensed operators shall be subject to all laws relating
7 to licensed operators and shall be subject to removal for cause by
8 the Service Oklahoma Operator Board. Any action taken by Service
9 Oklahoma to revoke a license shall be pursuant to and in accordance
10 with the provisions of the Administrative Procedures Act. For the
11 purposes of this section, "for cause" shall be defined as follows:

- 12 a. repeated violations of written contracts, rules,
13 regulations and statutes pertaining to licensed
14 operators after written warning by the Service
15 Oklahoma Operator Board and an opportunity to correct
16 such violations,
- 17 b. failure of the licensed operator to promptly remit
18 funds owed to Service Oklahoma upon written demand,
- 19 c. being charged with a felony crime involving dishonesty
20 or moral turpitude,
- 21 d. failure to timely file state and federal income tax
22 returns, or
- 23 e. any act of official misconduct as set forth in Section
24 93 of Title 51 of the Oklahoma Statutes.

1 In the event a license is revoked by the Service Oklahoma
2 Operator Board for cause, the Service Oklahoma location operated by
3 the licensed operator will be permanently closed and the licensed
4 operator shall not be entitled to any compensation.

5 Motor license agents and licensed operators in good standing as
6 of November 1, 2022, shall be exempt from the branding and physical
7 standardization requirements to be established by the Service
8 Oklahoma Operator Board, with the recommendation of the Director of
9 Service Oklahoma.

10 2. A license to operate a designated Service Oklahoma location
11 may be revoked by the Service Oklahoma Operator Board for failure to
12 meet the standards for customer satisfaction established by the
13 Service Oklahoma Operator Board. In the event of revocation, the
14 licensed operator shall sell his or her license to operate a Service
15 Oklahoma location to Service Oklahoma at a rate of one-half (1/2)
16 times the most recent annual gross revenue from fees retained of
17 that Service Oklahoma location, not to exceed Two Hundred Thousand
18 Dollars (\$200,000.00). The purchase price shall be paid out of the
19 excess funds available in the Licensed Operator Performance Fund,
20 created in Section 3-106 of this title, after distribution to
21 licensed operators, pursuant to Section 3-106 of this title.

22 F. All licensed operators shall be licensed by and under the
23 supervision of Service Oklahoma; provided, any agent authorized to
24 issue registrations pursuant to the International Registration Plan

1 shall also be under the supervision of the Corporation Commission,
2 subject to rules promulgated by the Corporation Commission pursuant
3 to the provisions of subsection E of Section 1166 of this title.
4 Service Oklahoma shall be the holder of all licenses and has the
5 right to approve and revoke such licenses. After obtaining a
6 license, any such licensed operator shall furnish and file with
7 Service Oklahoma a bond in such amount as may be fixed by Service
8 Oklahoma. Such licensed operator shall be removable at the will of
9 Service Oklahoma. Such licensed operator shall perform all duties
10 and do such things in the administration of the laws of this state
11 as shall be enjoined upon and required by the Service Oklahoma
12 Operator Board. Provided, Service Oklahoma may operate a Service
13 Oklahoma location in any county where a vacancy occurs, as
14 determined by Service Oklahoma.

15 G. In the event of a vacancy due to the death of a licensed
16 operator, the licensed operator's designee or a licensed operator
17 location employee shall immediately notify Service Oklahoma. A
18 licensed operator may designate an individual to continue to operate
19 the Service Oklahoma location upon the death of the licensed
20 operator. The designee shall apply to obtain a license to operate
21 the vacant licensed operator location with the Service Oklahoma
22 Operator Board within thirty (30) days of the licensed operator's
23 death. In the event that no designee is designated or that the
24 designee fails to apply to be a licensed operator with Service

1 Oklahoma within thirty (30) days, Service Oklahoma may take any and
2 all action it deems appropriate in order to provide for the orderly
3 transition and the maintenance of operations of the Service Oklahoma
4 location, as permitted by law.

5 H. When an application for registration is made with Service
6 Oklahoma, the Corporation Commission or a licensed operator, a
7 registration fee of One Dollar and seventy-five cents (\$1.75) shall
8 be collected for each license plate or decal issued. Such fees
9 shall be in addition to the registration fees on motor vehicles and
10 when an application for registration is made to the licensed
11 operator, such licensed operator shall retain a fee as provided in
12 Section 1141.1 of this title through June 30, 2023. Beginning July
13 1, 2023, the fee shall be retained by the licensed operator pursuant
14 to subsection E of Section 1141.1 of this title. When the fee is
15 paid by a person making application directly with Service Oklahoma
16 or the Corporation Commission, as applicable, the registration fees
17 shall be in the same amount as provided for licensed operators and
18 the fee provided by Section 1141.1 of this title shall be deposited
19 in the Oklahoma Tax Commission ~~Revolving~~ Fund or as provided in
20 Section 1167 of this title, as applicable. Beginning January 1,
21 2023, the fee provided by Section 1141.1 of this title shall be
22 deposited in the Service Oklahoma Revolving Fund or as provided in
23 Section 1167 of this title, as applicable. Service Oklahoma shall
24 prepare schedules of registration fees and charges for titles which

1 shall include the fees for such licensed operators and all fees and
2 charges paid by a person shall be listed separately on the
3 application and registration and totaled on the application and
4 registration. The licensed operators shall charge only such fees as
5 are specifically provided for by law, and all such authorized fees
6 shall be posted in such a manner that any person shall have notice
7 of all fees that are imposed by law.

8 I. Any licensed operator shall be responsible for all costs
9 incurred by Service Oklahoma when relocating an existing Service
10 Oklahoma location. The Service Oklahoma Operator Board may waive
11 payment of such costs in case of unforeseen business or emergency
12 conditions beyond the control of the licensed operator.

13 J. Any existing contracts by or between any motor license agent
14 and the Oklahoma Tax Commission shall be assigned to Service
15 Oklahoma. All existing motor license agents in good standing with
16 the Oklahoma Tax Commission will be offered a subsequent contract
17 from Service Oklahoma to become a licensed operator to take effect
18 on January 1, 2023. The contract between existing motor license
19 agents and Service Oklahoma shall be agreed to no later than
20 December 31, 2022. In the event an existing motor license agent
21 declines to enter into the subsequent contract with Service Oklahoma
22 to become a licensed operator, that motor license agent may continue
23 to conduct business pursuant to the existing contract through
24 December 31, 2025, so long as that motor license agent remains in

1 good standing with Service Oklahoma in accordance with the terms of
2 the existing contract.

3 SECTION 107. REPEALER 47 O.S. 2021, Section 1140, as
4 last amended by Section 12, Chapter 47, 1st Extraordinary Session,
5 O.S.L. 2023 (47 O.S. Supp. 2023, Section 1140), is hereby repealed.

6 SECTION 108. REPEALER 47 O.S. 2021, Section 1141.1, as
7 amended by Section 16, Chapter 228, O.S.L. 2022 (47 O.S. Supp. 2023,
8 Section 1141.1), is hereby repealed.

9 SECTION 109. AMENDATORY 47 O.S. 2021, Section 1151, as
10 last amended by Section 189, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
11 2023, Section 1151), is amended to read as follows:

12 Section 1151. A. It shall be unlawful for any person to commit
13 any of the following acts:

14 1. To lend or to sell to, or knowingly permit the use of by,
15 one not entitled thereto any certificate of title, license plate or
16 decal issued to or in the custody of the person so lending or
17 permitting the use thereof;

18 2. To alter or in any manner change a certificate of title,
19 registration certificate, license plate or decal issued under the
20 laws of this or any other state;

21 3. To procure from another state or country, or display upon
22 any vehicle owned by such person within this state, except as
23 otherwise provided in the Oklahoma Vehicle License and Registration
24 Act, any license plate issued by any state or country other than

1 this state, unless there shall be displayed upon such vehicle at all
2 times the current license plate and decal assigned to it by Service
3 Oklahoma or the Corporation Commission or the vehicle shall display
4 evidence that the vehicle is registered as a nonresident vehicle
5 pursuant to rules promulgated by Service Oklahoma, with the
6 concurrence of the Department of Public Safety. A violation of the
7 provisions of this paragraph shall be presumed to have occurred if a
8 person who is the holder of an Oklahoma driver license operates a
9 vehicle owned by such person on the public roads or highways of this
10 state and there is not displayed on the vehicle a current Oklahoma
11 license plate and decal, unless the vehicle is owned by a member of
12 the Armed Forces of the United States assigned to duty in this state
13 in compliance with official military or naval orders or the spouse
14 of such a member of the Armed Forces;

15 4. To drive, operate or move, or for the owner to cause or
16 permit to be driven or moved, upon the roads, streets or highways of
17 this state, any vehicle loaded in excess of its registered laden
18 weight, or which is licensed for a capacity less than the
19 manufacturer's rated capacity as provided for in the Oklahoma
20 Vehicle License and Registration Act;

21 5. To operate a vehicle without proper license plate or decal
22 or on which all taxes due the state have not been paid. No citation
23 may be issued by any state, county or municipal law enforcement
24 officer during the ~~thirty-day~~ one-month period immediately

1 succeeding the last day of the month during which a vehicle
2 registration should have been renewed and a current license plate
3 decal obtained and displayed on the license plate of the vehicle;

4 6. To buy, sell or dispose of, or possess for sale, use or
5 storage, any secondhand or used vehicle on which the registration or
6 license fee has not been paid, as required by law, and on which
7 vehicle the person neglects, fails or refuses to display at all
8 times the license plate or decal assigned to it;

9 7. To give a fictitious name or fictitious address or make any
10 misstatement of facts in application for certificate of title and
11 registration of a vehicle;

12 8. To purchase a license plate on an assigned certificate of
13 title. This particular paragraph shall be applicable to all persons
14 except a bona fide registered dealer in used cars who are holders of
15 a current and valid used car dealer license;

16 9. To operate a vehicle upon the highways of this state after
17 the registration deadline for that vehicle without a proper license
18 plate, as prescribed by the Oklahoma Vehicle License and
19 Registration Act, for the current year;

20 10. For any owner of a vehicle registered on the basis of laden
21 weight to fail or refuse to weigh or reweigh it when requested to do
22 so by any enforcement officer charged with the duty of enforcing
23 this law;

1 11. To operate or possess any vehicle which bears a motor
2 number or serial number other than the original number placed
3 thereon by the factory except a number duly assigned and authorized
4 by the state;

5 12. For any licensed operator to release a license plate, a
6 manufactured home registration receipt, decal or excise tax receipt
7 to any unauthorized person or source including any dealer in new or
8 used motor vehicles. Violation of this paragraph shall constitute
9 sufficient grounds for discharge of a licensed operator by Service
10 Oklahoma;

11 13. To operate any vehicle registered as a commercial vehicle
12 without the lettering requirements of Section 1102 of this title; or

13 14. To operate any vehicle in violation of the provisions of
14 Sections 7-600 through 7-606 of this title while displaying a yearly
15 decal issued to the owner who has filed an affidavit with the
16 appropriate licensed operator in accordance with Section 7-607 of
17 this title.

18 Any person convicted of violating any provision of this
19 subsection, other than paragraph 3 of this subsection, shall be
20 deemed guilty of a misdemeanor and upon conviction shall be punished
21 by a fine not to exceed Five Hundred Dollars (\$500.00). Any person
22 convicted of violating the provisions of paragraph 3 of this
23 subsection shall be deemed guilty of a misdemeanor and, upon
24 conviction, shall be punished by a fine of not less than One Hundred

1 Dollars (\$100.00) and not more than Five Hundred Dollars (\$500.00)
2 and shall be required to obtain an Oklahoma license plate.
3 Employees of the Corporation Commission may be authorized by the
4 Corporation Commission to issue citations to motor carriers or
5 operators of commercial motor vehicles, pursuant to the jurisdiction

4 to the date of registration; provided, that in no event shall the
5 penalty exceed One Hundred Dollars (\$100.00). No penalty shall be
6 waived by Service Oklahoma or any licensed operator except as
7 provided in subsection C of Section 1127 of this title. Of each
8 dollar penalty collected pursuant to this subsection:

9 1. Twenty-one cents (\$0.21) shall be apportioned as provided in
10 Section 1104 of this title;

11 2. Twenty-one cents (\$0.21) shall be retained by the licensed

19 deemed guilty of a misdemeanor and, upon conviction, shall be fined
20 not more than One Thousand Dollars (\$1,000.00), or shall be
21 imprisoned in the county jail for not more than one (1) year, or by
22 both such fine and imprisonment.

23 E. The following self-propelled or motor-driven and operated
24 vehicles shall not be registered under the provisions of the

Oklahoma Vehicle License and Registration Act or, except as provided for in Section 11-1116 of this title, be permitted to be operated on the streets or highways of this state:

1. Vehicles known and commonly referred to as "minibikes" and other similar trade names; provided, minibikes may be registered and operated in this state by food vendor services upon streets having a speed limit of thirty (30) miles per hour or less;

2. Golf carts;

3. Go-carts; and

4. Other motor vehicles, except motorcycles, which are manufactured principally for use off the streets and highways.

Transfers and sales of such vehicles shall be subject to sales tax and not motor vehicle excise taxes.

F. Any person violating paragraph 3 or 6 of subsection A of this section, in addition to the penal provisions provided in this section, shall pay as additional penalty a sum equal to the amount of license fees due on such vehicle or registration fees due on a manufactured home known to be in violation and such amount is hereby declared to be a lien upon the vehicle as provided in the Oklahoma Vehicle License and Registration Act. In addition to the penalty provisions provided in this section, any person violating paragraph 3 of subsection A of this section shall be deemed guilty of a misdemeanor and shall, upon conviction, be punished by a fine of One Hundred Dollars (\$100.00).

5 Subsidized hourly employment or unsubsidized hourly
6 employment pursuant to this subparagraph shall only be
7 approved by the Department as work activity if such

9 (a) the federal minimum wage requirements
10 pursuant to the Fair Labor Standards Act of
11 1938, as amended,

12 (b) the federal Social Security tax and Medicare
13 tax, and

14 (c) regulations promulgated pursuant to the
15 federal Occupational Safety and Health Act
16 of 1970 and rules promulgated by the State
17 Department of Labor pursuant thereto,

18 b. a program of work experience,

19 c. on-the-job training,

20 d. assisted job search which may include supervised or
21 unsupervised job-seeking activities,

22 e. job readiness assistance which may include, but is not
23 limited to:

- (1) orientation in the work environment and basic job-seeking and job retention skills,
 - (2) instruction in completing an application for employment and writing a resume,
 - (3) instruction in conducting oneself during a job interview, including appropriate dress, and
 - (4) substance abuse treatment and mental health counseling,
- f. job skills training which is directly related to employment in a specific occupation for which there is a written commitment by an employer to offer employment to a recipient who successfully completes the training. Job skills training includes, but is not limited to, customized training designed to meet the needs of a specific employer or a specific industry,
- g. community service programs which are job-training activities provided in areas where sufficient public or private sector employment is not available. Such activities are linked to both education or training and activities that substantially enhance a recipient's employability,
- h. literacy and adult basic education programs,

1 i. vocational-educational programs, not to exceed twelve
2 (12) months for any individual, which are directed
3 toward vocational-educational training and education
4 directly related to employment,

5 j. education programs which are directly related to
6 specific employment opportunities, if a recipient has
7 not received a high school diploma or General
8 Equivalency Degree, and

9 k. child care for other STARS recipients. The recipient
10 must meet training and licensing requirements for
11 child care providers as required by the Oklahoma Child

~~11.~~ 12. An applicant who applies and is otherwise eligible to receive TANF benefits but who has resided in this state less than twelve (12) months shall be subject to Section 230.57 of this title;

~~12.~~ 13. The recipient shall enter into a personal responsibility agreement with the Department for receipt of assistance pursuant to Section 230.65 of this title;

~~13.~~ 14. The Department shall, beginning November 1, 2023, screen all adult TANF recipients as part of the required TANF employability plan to determine if they are engaged in the illegal use of a controlled substance or substances. If the Department has made a determination that the recipient is engaged in the illegal use of a controlled substance or substances, the recipient's TANF employability plan will include substance abuse treatment and/or mental health counseling as a part of the assigned work activities as set out in paragraph 4 of this subsection. The Department of Human Services shall adopt rules to implement the requirements of this paragraph consistent with the following:

a. the Department shall create a controlled substance screening process to be administered during the assessment process that determines the TANF employability plan. The process shall, at a minimum,

~~15.~~ 16. The recipient shall comply with all other conditions and requirements of the STARS, and rules of the Commission promulgated pursuant thereto.

B. 1. Agencies of this state involved in providing services to recipients pursuant to the STARS shall exchange information as necessary for each agency to accomplish objectives and fulfill obligations created or imposed by the STARS and rules promulgated pursuant thereto.

2. Information received pursuant to the STARS shall be maintained by the applicable agency and, except as otherwise provided by this subsection, shall be disclosed only in accordance with any confidentiality provisions applicable to the agency originating the information.

3. The various agencies of the state shall execute operating agreements to facilitate information exchanges pursuant to the STARS.

C. In implementing the TANF program, the Department shall:

1. Provide assistance to aliens pursuant to Section 230.73 of this title;

2. Provide for the closure of the TANF case when the adult recipient refuses to cooperate with agreed upon work activities or other case requirements pursuant to the TANF program;

3. Provide for the sanctioning of parents who do not require their minor children to attend school; and

4. Deny temporary assistance to fugitive felons.

D. In order to ensure that the needy citizens of this state are receiving necessary benefits, the Department shall maintain a listing of all recipients receiving public assistance. The listing shall reflect each recipient's income, social security number, and the programs in which the recipient is participating including, but not limited to, TANF, food stamps, child care, and medical assistance.

E. The Department is hereby authorized to establish a grant diversion program and emergency assistance services.

"Partnership" means a contractual relationship based upon a written, oral, or implied agreement between two or more individuals who combine their resources and activities in a joint enterprise and share in varying degrees and by specific agreement in the management and in the profits or losses. A partnership may be general or limited as the laws of this state define those terms;

31. "PCAOB" means the Public Company Accounting Oversight Board;

32. ~~"Peer Review"~~ "Peer review" means a review performed pursuant to a set of peer review rules established by the Board. The term peer review also encompasses the term "quality review";

- a. the education, examination and experience requirements contained in the statutes and administrative rules of another jurisdiction are comparable to, or exceed, the education, examination and experience requirements contained in the AICPA/NASBA Uniform Accountancy Act, or
- b. that an individual certified public accountant's or public accountant's education, examination and experience qualifications are comparable to or exceed the education, examination and experience requirements contained in the Oklahoma Accountancy Act and rules of the Board.

1 In ascertaining substantial equivalency as used in the Oklahoma
2 Accountancy Act, the Board or its designee shall take into account
3 the qualifications without regard to the sequence in which
4 experience, education, or examination requirements were attained.

- c. two members shall have at least ten (10) years' experience in the mechanical trade, of which one shall be a mechanical contractor and one shall be a mechanical journeyman, and
- d. one member shall have at least ten (10) years' experience as a building and construction inspector.

2. Members shall be appointed for staggered terms of four (4) years, as designated by the Governor. Members shall continue in office until a successor is appointed by the Governor. The Governor shall fill all vacancies and unexpired terms in the same manner as the original appointment of the member whose position is to be filled. A member may be removed by the Governor at any time.

6 real estate services;

10 a. "agency construction management" whereby the
11 construction entity provides services to the owner

16 b. "at-risk construction management" whereby the
17 construction entity, after providing agency services
18 during the pre-construction period:

19 (1) takes on the financial obligation to timely carry
20 out construction under a specified cost
21 agreement, and

22 (2) enters into written subcontracts for the work in
23 accordance with the construction management
24 procedures for state agencies;

1 6. "Consultant" means an individual or legal entity possessing
2 the qualifications to provide licensed architectural, registered
3 engineering, registered land surveying, certified appraisal, land
4 title, or abstract services or possessing specialized credentials
5 and qualifications as may be needed to evaluate, plan or design for
6 any construction or public work improvement project, or to lease,
7 acquire or dispose of state-owned real property;

8 7. "Energy performance index or indices" (EPI) means a number
9 describing the energy requirements at the building boundary of a
10 structure, per square foot of floor space or per cubic foot of
11 occupied volume, as appropriate under defined internal and external
12 ambient conditions over an entire seasonal cycle. As experience
13 develops on the energy performance achieved with state construction,
14 the indices (EPI) will serve as a measure of structure performance
15 with respect to energy consumption;

16 8. "Life cycle costs" means the cost of owning, operating, and
17 maintaining the structure over the life of the structure. This may
18 be expressed as an annual cost for each year of the facility's use;

19 9. "Office" means the Office of Management and Enterprise
20 Services;

21 10. "Procurement" means buying, purchasing, renting, leasing,
22 allocating, trading or otherwise acquiring or disposing of supplies,
23 services, or construction necessary to evaluate, plan, construct,

2 change or addition, betterment, enhancement or amelioration of or

6 term does not include the direct purchase of materials used for

12 recompensed either out of a negotiated portion of the savings

3 As used in this subparagraph, "funded ratio" means the
4 figure derived by dividing the actuarial value of

A nonfiscal retirement bill shall include any retirement bill that

1 system or increasing the percentage of the revenue earmarked from a

17 of the institution or a designated representative shall obtain the
18 personal data, prepare the certificate and secure the signatures
19 required by the certificate. The physician in attendance shall
20 certify to the facts of birth and provide the medical information
21 required by the certificate within five (5) days after the birth.

22 C. When a birth occurs outside an institution, the certificate
23 shall be prepared and filed by one of the following in the indicated
24 order of priority:

1 1. The physician in attendance at or immediately after the
2 birth;

3 2. Any other person in attendance at or immediately after the
4 birth; or

5 3. The father, the mother or, in the absence or inability of
6 the father or mother, the person in charge of the premises where the
7 birth occurred and present at the birth.

8 D. 1. If the mother was married at the time of birth, or
9 married at any time during the three hundred (300) calendar days
10 before the birth, the name of the husband shall be entered on the
11 certificate as the father of the child unless paternity has been
12 determined otherwise by a court of competent jurisdiction or a
13 husband's denial of paternity form has been filed along with an
14 affidavit acknowledging paternity, in which case the name of the
15 father as determined by the court or affidavit acknowledging
16 paternity shall be entered.

17 2. If the mother was not married at the time of birth, nor
18 married at any time during the three hundred (300) calendar days
19 before the birth, the name of the father shall be entered on the
20 certificate of birth only if:

21 a. a determination of paternity has been made by an
22 administrative action through the Department of Human

12 certificate of live birth worksheet to attest to the accuracy of the
13 personal data entered thereon, in time to permit its filing within

13 C. The medical certification shall be completed and signed
14 within forty-eight (48) hours after death by the physician,

16 of the patient's care for the illness or condition which resulted in
17 death, except when inquiry as to the cause of death is required by
18 Section 938 of this title. No later than July 1, 2017, the medical
19 certification portion of certificate data shall be entered into the
20 prescribed electronic system provided by the State Registrar of
21 Vital Statistics and the information submitted to the State
22 Registrar of Vital Statistics.

23 D. In the event that the physician, physician assistant, or
24 advanced practice registered nurse in charge of the patient's care

1 for the illness or condition which resulted in death is not in
2 attendance at the time of death, the medical certification shall be
3 completed and signed within forty-eight (48) hours after death by

6 1. When the patient is under hospice care at the time of death,

17 death who knows that a lethal drug, overdose or other means of

20 that means among the chain of events under cause of death or list it
21 in the box that describes how the injury occurred. If such means is
22 in the chain of events under cause of death or in the box that
23 describes how the injury occurred, the certifier shall indicate
24 "suicide" as the manner of death.

1 F. The authority of a physician assistant to carry out the
2 functions described in this section shall be governed by the
3 practice agreement as provided by Section 519.6 of Title 59 of the
4 Oklahoma Statutes.

18 unprocessed fresh fruits, melons, vegetables and legumes and/or
19 whole uncracked and unprocessed nuts;

20 2. A manufacturer, wholesaler or broker of food licensed
21 pursuant to Section 1-1119 of this title;

22 3. A kitchen in a private home if only food that does not
23 require time and temperature control for safety is prepared for sale
24

1 or service at a function such as a nonprofit civic, charitable or
2 religious organization's bake sale;

3 4. An area where food that is prepared as specified in
4 paragraph 3 of this subsection is sold or offered for human
5 consumption;

6 5. A private home that receives catered or home-delivered food;

7 6. A hotel licensed pursuant to Section 1-1201 of this title
8 which provides limited food service in compliance with rules
9 promulgated by the State Commissioner of Health;

10 7. A kitchen in a private home or in a bed and breakfast that
11 prepares and offers food to guests, if the home is owner-occupied,
12 the number of available guest bedrooms does not exceed ~~three~~ four,
13 and breakfast is the only meal offered;

14 8. A nonprofit civic, charitable or religious organization
15 using unpaid individuals to prepare or serve food on its behalf, for
16 occasional fundraising events sponsored and conducted by the
17 organization. For the purposes of this paragraph, an "occasional
18 fund-raising event" shall be defined as an event that occurs four
19 times a year or less;

20 9. Day care centers or family day care centers, and all other
21 child care facilities as defined and licensed pursuant to the
22 provisions of the Oklahoma Child Care Facilities Licensing Act;

23 10. Nursing facilities and specialized facilities, as defined
24 in and licensed pursuant to the provisions of the Nursing Home Care

1 Act, residential care homes as defined by the Residential Care Act,
2 adult day care centers as defined by the Adult Day Care Act, and
3 assisted living centers and continuum of care facilities licensed
4 pursuant to the Continuum of Care and Assisted Living Act;

5 11. Vendors at farmers markets selling frozen meat that is
6 either kept refrigerated or on ice; and

7 12. Other establishments exempted from food establishment
8 licensure pursuant to state law.

9 B. Each license shall expire one (1) year following the date of
10 its issuance. The State Department of Health shall charge and
11 collect for each such license an annual fee to be fixed by the State
12 Commissioner of Health.

13 1. The Commissioner may provide by rule for a fee-exempt
14 license for a food establishment operated by a nonprofit, civic,
15 charitable or religious organization that uses unpaid persons to
16 sell or offer food on a more frequent basis than the occasional
17 fundraising event. A fee-exempt license shall not expire but shall
18 remain in full force and effect until affirmatively revoked,
19 suspended, annulled or withdrawn by the Department in accordance
20 with applicable law.

21 2. The Commissioner may by rule also provide that licenses for
22 establishments serving events of limited duration or operating on a
23 seasonal basis shall extend only for the term of the event or
24

1 season, and may by rule adjust the fees for such licenses
2 accordingly.

3 3. The Commissioner shall provide by rule a three-day license
4 for vendors who only sell at farmers markets as defined in 310:257-
5 1-2 of the Oklahoma Administrative Code or at county fairs.

6 Licenses for vendors who only sell at farmers markets or county
7 fairs shall not exceed Fifty Dollars (\$50.00). Vendors who do not
8 sell food and vendors who meet the exceptions provided in subsection
9 A of this section shall not be required to obtain a three-day
10 license or a food establishment license.

11 4. The Commissioner shall provide by rule a multiseasonal
12 license for snow cone stands that sell hot beverages in addition to
13 snow cones. A snow cone stand that does not sell hot beverages
14 shall be considered a seasonal food establishment.

15 C. The State Commissioner of Health shall promulgate reasonable
16 standards and rules for sanitation of establishments required to be
17 licensed, which shall include the following: buildings, vehicles,
18 and appurtenances thereto, including plumbing, ventilation and
19 lighting; construction, cleanliness and bactericidal treatment of
20 equipment and utensils; cleanliness, wholesomeness, storage and
21 refrigeration of food and drink sold or served; cleanliness and
22 hygiene of personnel; toilet facilities; disposal of waste; water
23 supply; and other items deemed necessary to safeguard the health,
24 comfort, and safety of customers.

1 SECTION 136. REPEALER 63 O.S. 2021, Section 1-1118, as
2 last amended by Section 1, Chapter 228, O.S.L. 2023 (63 O.S. Supp.
3 2023, Section 1-1118), is hereby repealed.

4 SECTION 137. AMENDATORY 63 O.S. 2021, Section 427.3, as
5 last amended by Section 19 of Enrolled Senate Bill No. 1995 of the
6 2nd Session of the 59th Oklahoma Legislature, is amended to read as
7 follows:

8 Section 427.3. A. There is hereby created the Oklahoma Medical
9 Marijuana Authority which shall address issues related to the
10 medical marijuana program in this state including, but not limited
11 to, the issuance of patient licenses and medical marijuana business
12 licenses, and the dispensing, cultivating, processing, testing,
13 transporting, storage, research, and the use of and sale of medical
14 marijuana pursuant to the Oklahoma Medical Marijuana and Patient
15 Protection Act.

16 B. 1. Beginning on the effective date of this act, the
17 Authority shall cease to be part of or a division of the State
18 Department of Health and shall be deemed to be a separate and
19 distinct agency, to be known as the Oklahoma Medical Marijuana
20 Authority. The Authority and the Executive Director of the
21 Authority shall continue to exercise their statutory powers, duties,
22 and contractual responsibilities. All records, property, equipment,
23 assets, monies, financial interests, liabilities, matters pending,
24 and funds of the division shall be transferred to the Authority.

1 2. All licenses granted by the Department pertaining to medical
2 marijuana shall maintain rights and privileges under the authority
3 of the Authority; provided, however, that all licenses shall be
4 subject to revocation, suspension, or disciplinary action for
5 violation of any of the provisions of the Oklahoma Medical Marijuana
6 and Patient Protection Act and rules promulgated by the Executive
7 Director.

8 3. The Authority shall succeed to any contractual rights or
9 responsibilities incurred by the Department pertaining to medical
10 marijuana.

11 4. Rules promulgated by the State Commissioner of Health
12 pertaining to medical marijuana that are in effect on the effective
13 date of this act shall be immediately adopted and enforced by the
14 Executive Director. The Executive Director maintains the authority
15 to further promulgate and enforce rules.

16 5. The Department and the Authority may enter into an agreement
17 for the transfer of personnel from the Department to the Authority.
18 No employee shall be transferred to the Authority except on the
19 freely given written consent of the employee. All employees who are
20 transferred to the Authority shall not be required to accept a
21 lesser grade or salary than presently received. All employees shall
22 retain leave, sick, and annual time earned, and any retirement and
23 longevity benefits which have accrued during their tenure with the
24 Department. The transfer of personnel between the state agencies

1 shall be coordinated with the Office of Management and Enterprise
2 Services.

3 6. The expenses incurred by the Authority as a result of the
4 transfer required by this subsection shall be paid by the Authority.

5 7. The division within the Department known as the Oklahoma
6 Medical Marijuana Authority shall be abolished by the Department
7 after the transfer has been completed.

8 8. The Office of Management and Enterprise Services shall
9 coordinate the transfer of records, property, equipment, assets,
10 funds, allotments, purchase orders, liabilities, outstanding
11 financial obligations, or encumbrances provided for in this
12 subsection.

13 C. The Authority shall implement the provisions of the Oklahoma
14 Medical Marijuana and Patient Protection Act consistently with the
15 voter-approved State Question No. 788, Initiative Petition No. 412,
16 subject to the provisions of the Oklahoma Medical Marijuana and
17 Patient Protection Act.

18 D. The Authority shall exercise its respective powers and
19 perform its respective duties and functions as specified in the
20 Oklahoma Medical Marijuana and Patient Protection Act and this title
21 including, but not limited to, the following:

22 1. Determine steps the state shall take, whether administrative
23 or legislative in nature, to ensure that research on marijuana and
24

1 marijuana products is being conducted for public purposes including
2 the advancement of:

- 3 a. public health policy and public safety policy,
- 4 b. agronomic and horticultural best practices, and
- 5 c. medical and pharmacopoeia best practices;

6 2. Contract with third-party vendors and other governmental
7 entities in order to carry out the respective duties and functions
8 as specified in the Oklahoma Medical Marijuana and Patient
9 Protection Act;

10 3. Upon complaint or upon its own motion and upon a completed
11 investigation, levy fines as prescribed in applicable laws, rules
12 and regulations and suspend, revoke or not renew licenses pursuant
13 to applicable laws, rules and regulations;

14 4. Issue subpoenas for the appearance or production of persons,
15 records and things in connection with disciplinary or contested
16 cases considered by the Authority;

17 5. Apply for injunctive or declaratory relief to enforce the
18 provisions of applicable laws, rules and regulations;

19 6. Inspect and examine all licensed premises of medical
20 marijuana businesses, research facilities, education facilities and
21 waste disposal facilities in which medical marijuana is cultivated,
22 manufactured, sold, stored, transported, tested, distributed or
23 disposed of;

1 7. Upon action by the federal government by which the
2 production, sale, and use of marijuana in this state does not
3 violate federal law, work with the Banking Department and the State
4 Treasurer to develop good practices and standards for banking and
5 finance for medical marijuana businesses;

6 8. Establish internal control procedures for licenses including
7 accounting procedures, reporting procedures, and personnel policies;

8 9. Establish a fee schedule and collect fees for performing
9 background checks as the Executive Director deems appropriate. The
10 fees charged pursuant to this paragraph shall not exceed the actual
11 cost incurred for each background check;

12 10. Establish a fee schedule and collect fees for material
13 changes requested by the licensee;

14 11. Establish regulations, which require a medical marijuana
15 business to submit information to the Authority, deemed reasonably
16 necessary to assist the Authority in the prevention of diversion of
17 medical marijuana by a licensed medical marijuana business. Such
18 information required by the Authority may include, but shall not be
19 limited to:

- 20 a. the square footage of the licensed premises,
- 21 b. a diagram of the licensed premises,
- 22 c. the number and type of lights at the licensed medical
23 marijuana commercial grower business,

- 1 d. the number, type, and production capacity of equipment
2 located at the medical marijuana processing facility,
3 e. the names, addresses, and telephone numbers of
4 employees or agents of a medical marijuana business,
5 f. employment manuals and standard operating procedures
6 for the medical marijuana business, and
7 g. any other information as the Authority reasonably
8 deems necessary; and

9 12. Declare and establish a moratorium on processing and
10 issuing new medical marijuana business licenses pursuant to Section
11 427.14 of this title for an amount of time the Authority deems
12 necessary;

13 ~~E. The Authority shall be authorized to enter~~

14 13. Enter into and negotiate the terms of a Memorandum of
15 Understanding between the Authority and other state agencies
16 concerning the enforcement of laws regulating medical marijuana in
17 this state. The Oklahoma State Bureau of Narcotics and Dangerous
18 Drugs Control, the Oklahoma State Bureau of Investigation, and the
19 Oklahoma Attorney General shall have full authority to investigate
20 and enforce any violations of the laws regarding medical marijuana
21 including medical marijuana business licenses held by commercial
22 growers, processors, transporters, researchers, education
23 facilities, and waste disposal facilities;

1 14. Purchase and maintain motor vehicles for use by the
2 employees of the Authority; and

3 15. Enter into contracts and agreements for the payment of
4 food, lodging, and other authorized expenses as may be necessary to
5 host, conduct, sponsor, or participate in conferences, meetings, or
6 training sessions. The Authority may establish accounts as
7 necessary for the collection and distribution of funds, including
8 funds of sponsors and registration fees, related to such
9 conferences, meetings, and training sessions. Any expenses incurred
10 may be paid directly to the contracting agency or business
11 establishment.

12 SECTION 138. AMENDATORY 63 O.S. 2021, Section 427.4, as
13 last amended by Section 6, Chapter 322, O.S.L. 2023 (63 O.S. Supp.
14 2023, Section 427.4), is amended to read as follows:

15 Section 427.4. A. The Oklahoma Medical Marijuana Authority
16 shall employ an Executive Director and other personnel as necessary
17 to assist the Authority in carrying out its duties. The Executive
18 Director shall be appointed by the Governor, with the advice and
19 consent of the Senate. The Executive Director shall serve at the
20 pleasure of the Governor and may be removed or replaced without
21 cause. Compensation for the Executive Director shall be determined
22 pursuant to Section 3601.2 of Title 74 of the Oklahoma Statutes.

23 B. The Authority shall not employ an individual if any of the
24 following circumstances exist:

1 1. The individual has a direct or indirect interest in a
2 licensed medical marijuana business; or

3 2. The individual or his or her spouse, parent, child, spouse
4 of a child, sibling, or spouse of a sibling has an application for a
5 medical marijuana business license pending before the Authority or
6 is a member of the board of directors of a medical marijuana
7 business, or is an individual financially interested in any licensee
8 or medical marijuana business.

9 C. All officers and employees of the Authority shall be in the
10 exempt unclassified service.

11 D. The Executive Director may delegate to any officer or
12 employee of the Authority any of the powers of the Executive
13 Director and may designate any officer or employee of the Authority
14 to perform any of the duties of the Executive Director.

15 E. The Executive Director may promulgate rules governing the
16 oversight and implementation of the Oklahoma Medical Marijuana and
17 Patient Protection Act.

18 F. The Authority is hereby authorized to create employment
19 positions necessary for the implementation of its obligations
20 pursuant to the Oklahoma Medical Marijuana and Patient Protection
21 Act including, but not limited to, investigators of the Authority
22 and a director of enforcement. The Authority, the director of
23 enforcement, the Executive Director, investigators of the Authority,
24 the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control,

1 the Oklahoma State Bureau of Investigation, and the Attorney General
2 shall have all the powers and authority of a peace officer of this
3 state for the purpose of enforcing the provisions of the Oklahoma
4 Medical Marijuana and Patient Protection Act and other laws
5 pertaining to medical marijuana, rules promulgated by the Executive
6 Director, or criminal laws of this state. These powers shall
7 include but not be limited to:

8 1. Investigating violations or suspected violations of the
9 Oklahoma Medical Marijuana and Patient Protection Act or other laws
10 pertaining to medical marijuana, any rules promulgated pursuant
11 thereto, and any violations of criminal laws of this state
12 discovered through the course of such investigations;

13 2. Serving and executing all warrants, summonses, subpoenas,
14 administrative citations, notices or other processes relating to the
15 enforcement of laws regulating marijuana, concentrate, and marijuana
16 product;

17 3. Seizing, destroying, confiscating, embargoing, or placing an
18 administrative hold on any marijuana or marijuana product not
19 properly logged in the inventory tracking system or untraceable
20 product required to be in the system, altered or improperly
21 packaged, or illegally held in violation of the Oklahoma Medical
22 Marijuana and Patient Protection Act, any other laws of this state,
23 or any rules promulgated by the Executive Director;

1 4. Assisting or aiding any law enforcement officer in the
2 performance of his or her duties upon such law enforcement officer's
3 request or the request of other local officials having jurisdiction;

4 5. Referring any evidence, reports, or charges regarding
5 violations of any provision of the Oklahoma Medical Marijuana and
6 Patient Protection Act that carries criminal penalty, or of any
7 other criminal laws of this state, to the appropriate law
8 enforcement authority and prosecutorial authority for action;

9 6. Aiding the enforcement authorities of this state or any
10 county or municipality of the state, or the federal government, in
11 prosecutions of violations of the Oklahoma Medical Marijuana and
12 Patient Protection Act or any other laws of this state that carry
13 criminal penalty involving crimes discovered during the
14 investigation of violations or suspected violations of the Oklahoma
15 Medical Marijuana and Patient Protection Act or other laws
16 pertaining to medical marijuana or any rules promulgated pursuant
17 thereto;

18 7. ~~Requiring~~ As provided in Section 427.6 of this title,
19 requiring any business applicant or licensee to permit an inspection
20 of licensed premises during business hours or at any time of
21 apparent operation, marijuana equipment, and marijuana accessories,
22 or books and records; and to permit the testing of or examination of
23 medical marijuana, concentrate, or product;

1 8. Requiring applicants and licensees to submit complete and
2 current applications, information and fees required by the Oklahoma
3 Medical Marijuana and Patient Protection Act, the Oklahoma Medical
4 Marijuana Waste Management Act and Sections 420 through 426.1 of
5 this title, and approve material changes made by the applicant or
6 licensee;

7 9. Requiring medical marijuana business licensees to submit a
8 sample or unit of medical marijuana or medical marijuana product to
9 the quality assurance laboratory when the Authority has reason to
10 believe the medical marijuana or medical marijuana product may be
11 unsafe for patient consumption or inhalation or has not been tested
12 in accordance with the provisions of the Oklahoma Medical Marijuana
13 and Patient Protection Act and the rules and regulations promulgated
14 by the Executive Director. The licensee shall provide the samples
15 or units of medical marijuana or medical marijuana products at its
16 own expense but shall not be responsible for the costs of testing;
17 and

18 10. Requiring medical marijuana business licensees to
19 periodically submit samples or units of medical marijuana or medical
20 marijuana products to the quality assurance laboratory for quality
21 assurance purposes. Licensed growers, processors, dispensaries and
22 transporters shall not be required to submit samples or units of
23 medical marijuana or medical marijuana products more than twice a
24 year. The licensee shall provide the samples or units of medical

1 marijuana or medical marijuana products at its own expense but shall
2 not be responsible for the costs of testing.

3 G. All investigators of the Authority shall meet all training
4 requirements and qualifications for peace officers as required by
5 Section 3311 et seq. of Title 70 of the Oklahoma Statutes.

6 H. During the course of an investigation, the Authority, as
7 provided by subsection F of this section, may arrest a violator or
8 suspected violator of any laws of this state committed in the
9 presence of the Authority or upon the development of probable cause
10 that such crime has been committed. The Authority as provided by
11 subsection F of this section may, upon request of a sheriff or
12 another peace officer of this state, or any political subdivision
13 thereof, assist in the apprehension and arrest of a violator or
14 suspected violator of any of the laws of this state.

15 I. The Executive Director may employ or contract with
16 attorneys, as needed, to advise the Authority on all legal matters
17 and to appear for and represent the Executive Director and the
18 Authority in all administrative hearings and all litigation or other
19 proceedings which may arise in the discharge of their duties. At
20 the request of the Executive Director, such attorneys shall assist
21 district attorneys in prosecuting charges of violators of the
22 Oklahoma Medical Marijuana and Patient Protection Act or any other
23 laws of this state that carry criminal penalty involving crimes
24 discovered during the investigation of violations or suspected

1 violations of the Oklahoma Medical Marijuana and Patient Protection
2 Act or other laws pertaining to medical marijuana or any rules
3 promulgated pursuant thereto.

4 SECTION 139. REPEALER 63 O.S. 2021, Section 427.4, as
5 amended by Section 32, Chapter 228, O.S.L. 2022 (63 O.S. Supp. 2023,
6 Section 427.4), is hereby repealed.

7 SECTION 140. AMENDATORY 63 O.S. 2021, Section 427.16, as
8 last amended by Section 8, Chapter 322, O.S.L. 2023 (63 O.S. Supp.
9 2023, Section 427.16), is amended to read as follows:

10 Section 427.16. A. There is hereby created a medical marijuana
11 transporter license as a category of the medical marijuana business
12 license.

13 B. Pursuant to Section 424 of this title, the Oklahoma Medical
14 Marijuana Authority shall issue a medical marijuana transporter
15 license to licensed medical marijuana commercial growers, processors
16 and dispensaries upon issuance of such licenses and upon each
17 renewal. Medical marijuana transporter licenses shall also be
18 issued to licensed medical marijuana research facilities, medical
19 marijuana education facilities and medical marijuana testing
20 laboratories upon issuance of such licenses and upon each renewal.

21 C. A medical marijuana transporter license may also be issued
22 to qualifying applicants who are registered with the Secretary of
23 State and otherwise meet the requirements for a medical marijuana
24 business license set forth in the Oklahoma Medical Marijuana and

1 Patient Protection Act and the requirements set forth in this
2 section to provide logistics, distribution and storage of medical
3 marijuana, medical marijuana concentrate and medical marijuana
4 products.

5 D. A medical marijuana transporter license shall be valid for
6 one (1) year and shall not be transferred with a change of
7 ownership. A licensed medical marijuana transporter shall be
8 responsible for all medical marijuana, medical marijuana concentrate
9 and medical marijuana products once the transporter takes control of
10 the product.

11 E. A transporter license shall be required for any person or
12 entity to transport or transfer medical marijuana, medical marijuana
13 concentrate or medical marijuana products from a licensed medical
14 marijuana business to another medical marijuana business, or from a
15 medical marijuana business to a medical marijuana research facility
16 or medical marijuana education facility.

17 F. A medical marijuana transporter licensee may contract with
18 multiple licensed medical marijuana businesses.

19 G. A medical marijuana transporter may maintain a licensed
20 premises to temporarily store medical marijuana, medical marijuana
21 concentrate and medical marijuana products and to use as a
22 centralized distribution point. A medical marijuana transporter may
23 store and distribute medical marijuana, medical marijuana
24 concentrate and medical marijuana products from the licensed

1 premises. The licensed premises shall meet all security
2 requirements applicable to a medical marijuana business.

3 H. A medical marijuana transporter licensee shall use the seed-
4 to-sale tracking system developed pursuant to the Oklahoma Medical
5 Marijuana and Patient Protection Act to create shipping manifests
6 documenting the transport of medical marijuana, medical marijuana
7 concentrate and medical marijuana products throughout the state.

8 I. A licensed medical marijuana transporter may maintain and
9 operate one or more warehouses in the state to handle medical
10 marijuana, medical marijuana concentrate and medical marijuana
11 products. Each location shall be registered and inspected by the
12 Authority prior to its use.

13 J. With the exception of a lawful transfer between medical
14 marijuana businesses who are licensed to operate at the same
15 physical address, all medical marijuana, medical marijuana
16 concentrate and medical marijuana products shall be transported:

17 1. In vehicles equipped with Global Positioning System (GPS)
18 trackers;

19 2. In a locked container and clearly labeled "Medical Marijuana
20 or Derivative"; and

21 3. In a secured area of the vehicle that is not accessible by
22 the driver during transit.

23 K. A transporter agent may possess marijuana at any location
24 while the transporter agent is transferring marijuana to or from a

1 licensed medical marijuana business, licensed medical marijuana
2 research facility or licensed medical marijuana education facility.
3 The Authority shall administer the provisions of this section and
4 the Authority, the Oklahoma State Bureau of Narcotics and Dangerous
5 Drugs Control, the Oklahoma State Bureau of Investigation, and the
6 Attorney General shall have the authority to enforce the provisions
7 of this section concerning transportation.

8 L. The Authority shall issue a transporter agent license to
9 individual agents, employees, officers or owners of a transporter
10 license in order for the individual to qualify to transport medical
11 marijuana, medical marijuana concentrate or medical marijuana
12 products.

13 M. The annual fee for a transporter agent license shall be
14 Twenty-five Dollars (\$25.00) and shall be paid by the transporter
15 ~~license holder~~ license-holder or the individual applicant.
16 Transporter agent license reprints shall be Twenty Dollars (\$20.00).

17 N. The Authority shall issue each transporter agent a registry
18 identification card within thirty (30) days of receipt of:

- 19 1. The name, address and date of birth of the person;
- 20 2. Proof of current state residency;
- 21 3. Proof of identity as required for a medical marijuana
22 business license;
- 23 4. Possession of a valid state-issued driver license;
- 24 5. Verification of employment with a licensed transporter;

1 6. The application and affiliated fee; and

2 7. A copy of the criminal background check conducted by the
3 Oklahoma State Bureau of Investigation, paid for by the applicant.

4 O. If the transporter agent application is denied, the
5 Authority shall notify the transporter in writing of the reason for
6 denying the registry identification card.

7 P. A registry identification card for a transporter shall
8 expire one (1) year after the date of issuance or upon notification
9 from the holder of the transporter license that the transporter
10 agent ceases to work as a transporter.

11 Q. The Authority may revoke the registry identification card of
12 a transporter agent who knowingly violates any provision of this
13 section, and the transporter is subject to any other penalties
14 established by law for the violation.

15 R. The Authority may revoke or suspend the transporter license
16 of a transporter that the Authority determines knowingly aided or
17 facilitated a violation of any provision of this section, and the
18 license holder is subject to any other penalties established in law
19 for the violation.

20 S. Vehicles used in the transport of medical marijuana or
21 medical marijuana product shall be:

22 1. Insured at or above the legal requirements in this state;

23 2. Capable of securing medical marijuana during transport; and
24

1 3. In possession of a shipping container as defined in Section
2 427.2 of this title capable of securing all transported products.

3 T. Prior to the transport of any medical marijuana, medical
4 marijuana concentrate or medical marijuana products, an inventory
5 manifest shall be prepared at the origination point of the medical
6 marijuana. The inventory manifest shall include the following
7 information:

8 1. For the origination point of the medical marijuana:

- 9 a. the licensee number for the commercial grower,
10 processor or dispensary,
- 11 b. address of origination of transport, and
- 12 c. name and contact information for the originating
13 licensee;

14 2. For the end recipient license holder of the medical
15 marijuana:

- 16 a. the license number for the dispensary, commercial
17 grower, processor, research facility or education
18 facility destination,
- 19 b. address of the destination, and
- 20 c. name and contact information for the destination
21 licensee;

22 3. Quantities by weight or unit of each type of medical
23 marijuana product contained in transport;
24

1 4. The date of the transport and the approximate time of
2 departure;

3 5. The arrival date and estimated time of arrival;

4 6. Printed names and signatures of the personnel accompanying
5 the transport; and

6 7. Notation of the transporting licensee.

7 U. 1. A separate inventory manifest shall be prepared for each
8 licensee receiving the medical marijuana.

9 2. The transporter agent shall provide the other medical
10 marijuana business with a copy of the inventory manifest at the time
11 the product changes hands and after the other licensee prints his or
12 her name and signs the inventory manifest.

13 3. A receiving licensee shall refuse to accept any medical
14 marijuana, medical marijuana concentrate or medical marijuana
15 products that are not accompanied by an inventory manifest.

16 4. Originating and receiving licensees shall maintain copies of
17 inventory manifests and logs of quantities of medical marijuana
18 received for seven (7) years from date of receipt.

19 SECTION 141. REPEALER 63 O.S. 2021, Section 427.16, as
20 amended by Section 34, Chapter 228, O.S.L. 2022 (63 O.S. Supp. 2023,
21 Section 427.16), is hereby repealed.

22 SECTION 142. AMENDATORY 63 O.S. 2021, Section 427.17, as
23 last amended by Section 1, Chapter 351, O.S.L. 2022 (63 O.S. Supp.
24 2023, Section 427.17), is amended to read as follows:

1 Section 427.17. A. There is hereby created a medical marijuana
2 testing laboratory license as a category of the medical marijuana
3 business license. The Oklahoma Medical Marijuana Authority ~~is~~, the
4 Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the
5 Oklahoma State Bureau of Investigation, and the Attorney General are
6 hereby enabled to monitor, inspect and audit a licensed testing
7 laboratory under the Oklahoma Medical Marijuana and Patient
8 Protection Act.

9 B. The Authority is hereby authorized to operate a quality
10 assurance laboratory or to contract with a private laboratory for
11 the purpose of conducting compliance testing of medical marijuana
12 testing laboratories licensed in this state. Any such laboratory
13 under contract for compliance testing shall be prohibited from
14 conducting any other commercial medical marijuana testing in this
15 state. ~~The laboratory~~ If the Authority contracts with ~~for~~
16 ~~compliance testing~~ a private laboratory to implement the
17 requirements of this section:

18 1. The laboratory shall not employ, or be owned by, the
19 following:

20 ~~1. Any~~

21 a. any individual that has a direct or indirect interest
22 in a licensed medical marijuana business~~+~~l or

23 ~~2. Any~~

1 b. any individual or his or her spouse, parent, child,
2 spouse of a child, sibling or spouse of a sibling that
3 has an application for a medical marijuana business
4 license pending before the Authority or is a member of
5 the board of directors of a medical marijuana
6 business, or is an individual financially interested
7 in any licensee or medical marijuana business located
8 within this state-; and

9 2. The laboratory and a board or committee comprised of
10 licensed Oklahoma medical marijuana laboratories currently
11 accredited by the International Organization for Standardization
12 (ISO) shall provide to the Authority its recommendations for all
13 equipment and standards to be utilized by licensed medical marijuana
14 testing laboratories when testing samples of medical marijuana,
15 medical marijuana concentrate, and medical marijuana products as
16 well as standard operating procedures when extracting and testing
17 medical marijuana, medical marijuana concentrate, and medical
18 marijuana products. The recommendations shall be submitted to the
19 Authority no later than June 1, 2023. The Authority shall have
20 ninety (90) days from the date it receives the recommendations to
21 promulgate new rules or modify its current rules for laboratory
22 standards and testing. Beginning June 1, 2024, medical marijuana
23 testing laboratories renewing their medical marijuana business
24 license shall be subject to and comply with any new or modified

1 rules relating to the testing of medical marijuana, medical
2 marijuana concentrate, and medical marijuana products. The refusal
3 or failure of a medical marijuana testing laboratory licensee to
4 comply with new or modified rules relating to laboratory standards
5 and testing procedures promulgated under the provisions of this
6 paragraph shall result in the permanent revocation of the medical
7 marijuana testing laboratory license.

8 C. The Authority shall develop acceptable testing practices
9 including, but not limited to, testing, standards, quality control
10 analysis, equipment certification and calibration, process
11 validation, and chemical identification and substances used.

12 D. A person who is a direct beneficial owner of a medical
13 marijuana dispensary, medical marijuana commercial grower or medical
14 marijuana processor shall not be an owner of a laboratory.

15 E. A laboratory and a laboratory applicant shall comply with
16 all applicable local ordinances including, but not limited to,
17 zoning, occupancy, licensing and building codes.

18 F. A separate license shall be required for each specific
19 laboratory.

20 G. A medical marijuana testing laboratory license may be issued
21 to a person who performs testing on medical marijuana and medical
22 marijuana products for medical marijuana businesses, medical
23 marijuana research facilities, medical marijuana education
24 facilities, and testing on marijuana and marijuana products grown or

1 produced by a patient or caregiver on behalf of a patient, upon
2 verification of registration. A medical marijuana testing
3 laboratory may also conduct research related to the development and
4 improvement of its testing practices and procedures. No state-
5 approved medical marijuana testing facility shall operate unless a
6 medical laboratory director is on site during operational hours.

7 H. Laboratory applicants and licensees shall comply with the
8 application requirements of this section and shall submit such other
9 information as required for a medical marijuana business applicant,
10 in addition to any information the Authority may request for initial
11 approval and periodic evaluations during the approval period.

12 I. A medical marijuana testing laboratory may accept samples of
13 medical marijuana, medical marijuana concentrate or medical
14 marijuana product from a medical marijuana business, medical
15 marijuana research facility or medical marijuana education facility
16 for testing purposes only, which purposes may include the provision
17 of testing services for samples submitted by a medical marijuana
18 business for product development. The Authority may require a
19 medical marijuana business to submit a sample of medical marijuana,
20 medical marijuana concentrate or medical marijuana product to a
21 medical marijuana testing or quality assurance laboratory upon
22 demand.

23 J. A medical marijuana testing laboratory may accept samples of
24 medical marijuana, medical marijuana concentrate or medical

1 marijuana product from an individual person for testing only under
2 the following conditions:

3 1. The individual person is a patient or caregiver pursuant to
4 the Oklahoma Medical Marijuana and Patient Protection Act or is a
5 participant in an approved clinical or observational study conducted
6 by a research facility; and

7 2. The medical marijuana testing laboratory shall require the
8 patient or caregiver to produce a valid patient license and current
9 and valid photo identification.

10 K. A medical marijuana testing laboratory may transfer samples
11 to another medical marijuana testing laboratory for testing. All
12 laboratory reports provided to or by a medical marijuana business or
13 to a patient or caregiver shall identify the medical marijuana
14 testing laboratory that actually conducted the test.

15 L. A medical marijuana testing laboratory may utilize a
16 licensed medical marijuana transporter to transport samples of
17 medical marijuana, medical marijuana concentrate and medical
18 marijuana product for testing, in accordance with the Oklahoma
19 Medical Marijuana and Patient Protection Act and the rules adopted
20 pursuant thereto, between the originating medical marijuana business
21 requesting testing services and the destination laboratory
22 performing testing services.

23 M. The medical marijuana testing laboratory shall establish
24 policies to prevent the existence of or appearance of undue

1 commercial, financial or other influences that may diminish the
2 competency, impartiality and integrity of the testing processes or
3 results of the laboratory, or that may diminish public confidence in
4 the competency, impartiality and integrity of the testing processes
5 or results of the laboratory. At a minimum, employees, owners or
6 agents of a medical marijuana testing laboratory who participate in
7 any aspect of the analysis and results of a sample are prohibited
8 from improperly influencing the testing process, improperly
9 manipulating data or improperly benefiting from any ongoing
10 financial, employment, personal or business relationship with the
11 medical marijuana business that provided the sample. A medical
12 marijuana testing laboratory shall not test samples for any medical
13 marijuana business in which an owner, employee or agent of the
14 medical marijuana testing laboratory has any form of ownership or
15 financial interest in the medical marijuana business.

16 N. The Authority, pursuant to rules promulgated by the
17 Executive Director of the Authority, shall develop standards,
18 policies and procedures as necessary for:

19 1. The cleanliness and orderliness of a laboratory premises and
20 the location of the laboratory in a secure location, and inspection,
21 cleaning and maintenance of any equipment or utensils used for the
22 analysis of test samples;

23 2. Testing procedures, testing standards for cannabinoid and
24 terpenoid potency and safe levels of contaminants, process

1 validation, and remediation procedures. Process validation shall be
2 voluntary, and no licensee shall be required to validate their
3 process. The Authority shall develop standards and requirements for
4 a licensee to achieve process validation by January 1, 2024. The
5 standards, policies, and procedures for process validation shall
6 include, but not be limited to:

- 7 a. initial requirements to achieve process validation and
8 ongoing minimum testing requirements once a licensee
9 has achieved process validation,
- 10 b. requiring licensees to track their marijuana and
11 marijuana product inventory with the Authority's
12 designated seed-to-sale system provided the Authority
13 has selected a seed-to-sale system. This requirement
14 for compliance with the seed-to-sale system shall be
15 mandatory for licensees seeking to achieve process
16 validation whether or not compliance with a seed-to-
17 sale system is mandatory for all licensees,
- 18 c. requiring licensees that are utilizing process
19 validation to use a laboratory that is certified as a
20 certified process validation testing laboratory,
- 21 d. requiring licensees to record and document retention
22 policies, which at a minimum shall require licensees
23 to retain all documents and records related to process
24 validation. Such records shall be maintained by the

licensee for as long as the licensee is continuing to operate under that validated process. Licensees shall retain all such documents and records for at least four (4) years after the licensee has stopped using the validated process or after the licensee has made a significant process change to a validated process. Any significant process change to the validated processes of a licensee is subject to the same document retention requirements and shall be retained for as long as the significant process change is part of an ongoing validated process, and for at least four (4) years after the licensee has stopped using the validated process or after the licensee has made a subsequent significant process change to the validated process. The Authority shall promulgate rules for any modifications to the validated processes,

e. requiring licensees to keep all records and documents related to their process validation ready and accessible at the address listed on their marijuana business license for inspection or audit by the Authority without any notice from the Authority,

f. a process for biannual inspections by the Authority that, at a minimum, includes random testing of products being produced under process validation. The

1 Authority shall be the entity that obtains the random
2 sample during the biannual inspections and shall have
3 access to all products being produced or grown under
4 process validation. The Authority shall take samples
5 to the quality assurance laboratory,

6 g. a process to revoke the authority of licensees to
7 operate under process validation,

8 h. punishment for violations of process validation that,
9 at a minimum, would prohibit a licensee from operating
10 under process validation for five (5) years and the
11 assessment of a fine not to exceed Fifty Thousand
12 Dollars (\$50,000.00). Any such fine levied against a
13 licensee found to have violated the laws or rules of
14 process validation shall be remitted to the Department
15 of Mental Health and Substance Abuse Services,

16 i. punishment for violations if an adulterated product
17 that was produced under process validation fails
18 testing and the batch or lot has been sold to a
19 dispensary, the first violation shall be the
20 assessment of a fine not to exceed Ten Thousand
21 Dollars (\$10,000.00) and a public recall of the
22 product. The licensee shall further be required to
23 revalidate the process. A second violation within two
24 (2) years of a previous violation shall be the

1 assessment of a fine not to exceed Seventy-five
2 Thousand Dollars (\$75,000.00) and a public recall of
3 the product. The licensee shall further be prohibited
4 from utilizing process validation for a minimum of
5 five (5) years. A third violation within two (2)
6 years of a previous violation shall be the assessment
7 of a fine of Two Hundred Fifty Thousand Dollars

9 licensee shall further be prohibited from utilizing
10 process validation,

11 j. any willful violation of process validation shall
12 result in the assessment of a fine of Two Hundred
13 Fifty Thousand Dollars (\$250,000.00) and a license
14 revocation hearing. A second willful violation of
15 process validation shall result in the assessment of a
16 fine of One Million Dollars (\$1,000,000.00) and a
17 hearing to permanently revoke the license,

18 k. an annual registration fee of Five Thousand Dollars
19 (\$5,000.00) per licensee, in addition to any other
20 fees due by the licensee, to be deposited in the
21 Oklahoma Medical Marijuana Authority Revolving Fund
22 for the enforcement of the laws and regulations of the
23 Authority,

1. establishing criteria for eligibility of testing laboratories to be certified as a Certified Process Validation Testing Laboratory and to conduct testing for licensees pursuing or operating under process validation. The criteria shall, at a minimum, pass five (5) consecutive blind proficiency tests without a failure over the course of six (6) months. The proficiency tests shall be administered by the quality assurance laboratory,
- m. punishment for violations by a Certified Process Validation Testing Laboratory that has been found to have been falsifying data, providing misinformation, or any unethical practices related to process validation at a minimum shall prohibit a licensee from operating under process validation for up to twenty-five (25) years and the assessment of a fine not to exceed One Million Dollars (\$1,000,000.00). Any such fine levied against a licensee shall be remitted to the Authority for deposit into the Oklahoma Medical Marijuana Authority Revolving Fund. In addition to this fine, in response to a finding of a willful violation of process validation by the Authority, the Authority shall also be authorized to collect, levy,

1 or impose any other fee, fine, penalty, or action as
2 allowed by law, and

3 n. a process to revoke the certification of a testing
4 laboratory that is seeking to be a Certified Process
5 Validation Testing Laboratory;

6 3. Controlled access areas for storage of medical marijuana and
7 medical marijuana product test samples, waste and reference
8 standards;

9 4. Records to be retained and computer systems to be utilized
10 by the laboratory;

11 5. The possession, storage and use by the laboratory of
12 reagents, solutions and reference standards;

13 6. A certificate of analysis (COA) for each lot of reference
14 standard;

15 7. The transport and disposal of unused marijuana, marijuana
16 products and waste;

17 8. The mandatory use by a laboratory of an inventory tracking
18 system to ensure all harvest and production batches or samples
19 containing medical marijuana, medical marijuana concentrate or
20 medical marijuana products are identified and tracked from the point
21 they are transferred from a medical marijuana business, a patient or
22 a caregiver through the point of transfer, destruction or disposal.
23 The inventory tracking system reporting shall include the results of
24

1 any tests that are conducted on medical marijuana, medical marijuana
2 concentrate or medical marijuana product;

3 9. Standards of performance;

4 10. The employment of laboratory personnel;

5 11. A written standard operating procedure manual to be
6 maintained and updated by the laboratory;

7 12. The successful participation in a proficiency testing
8 program approved by the Executive Director for each testing category
9 listed in this section, in order to obtain and maintain
10 certification;

11 13. The establishment of and adherence to a quality assurance
12 and quality control program to ensure sufficient monitoring of
13 laboratory processes and quality of results reported;

14 14. The immediate recall of medical marijuana or medical
15 marijuana products that test above allowable thresholds or are
16 otherwise determined to be unsafe;

17 15. The establishment by the laboratory of a system to document
18 the complete chain of custody for samples from receipt through
19 disposal;

20 16. The establishment by the laboratory of a system to retain
21 and maintain all required records, including business records, and
22 processes to ensure results are reported in a timely and accurate
23 manner; and

1 17. Any other aspect of laboratory testing of medical marijuana
2 or medical marijuana product deemed necessary by the Executive
3 Director.

4 O. A medical marijuana testing laboratory shall promptly
5 provide the Authority or designee of the Authority access to a
6 report of a test and any underlying data that is conducted on a
7 sample at the request of a medical marijuana business or qualified
8 patient. A medical marijuana testing laboratory shall also provide
9 access to the Authority or designee of the Authority to laboratory
10 premises and to any material or information requested by the
11 Authority to determine compliance with the requirements of this
12 section.

13 P. A medical marijuana testing laboratory shall retain all
14 results of laboratory tests conducted on marijuana or products for a
15 period of at least seven (7) years and shall make them available to
16 the Authority upon request.

17 Q. A medical marijuana testing laboratory shall test samples
18 from each harvest batch or, product batch, or samples consistent
19 with the rules promulgated for process validation, as appropriate,
20 of medical marijuana, medical marijuana concentrate and medical
21 marijuana product for each of the following categories of testing,
22 consistent with standards developed by the Executive Director:

23 1. Microbials;

24 2. Mycotoxins;

3. Residual solvents;
4. Pesticides;
5. Tetrahydrocannabinol (THC) and other cannabinoid potency;
6. Terpenoid type and concentration; and
7. Heavy metals.

R. A licensed medical marijuana testing laboratory shall test each individual harvest batch. A grower shall separate each harvest lot of usable marijuana into harvest batches containing no more than fifteen (15) pounds, with the exception of any plant material to be sold to a licensed processor for the purposes of turning the plant material into concentrate which may be separated into harvest batches of no more than fifty (50) pounds. A processor shall separate each medical marijuana production lot into production batches containing no more than four (4) liters of concentrate or nine (9) pounds for nonliquid products, and for final products, the Oklahoma Medical Marijuana Authority shall be authorized to promulgate rules on final products as necessary. Provided, however, the Authority shall not require testing of final products less often than every one thousand (1,000) grams of THC. As used in this subsection, "final products" shall include, but not be limited to, cookies, brownies, candies, gummies, beverages and chocolates.

S. Medical marijuana testing laboratory licensure shall be contingent upon successful on-site inspection, successful

1 participation in proficiency testing and ongoing compliance with the
2 applicable requirements in this section.

3 T. A medical marijuana testing laboratory shall be inspected
4 prior to initial licensure and up to two (2) times per year
5 thereafter by an inspector approved by the Authority. The Authority
6 may enter the licensed premises of a testing laboratory to conduct
7 investigations and additional inspections when the Authority
8 believes an investigation or additional inspection is necessary due
9 to a possible violation of applicable laws, rules or regulations.

10 U. Medical marijuana testing laboratories shall obtain
11 accreditation by an accrediting body approved by the Executive
12 Director or the Authority's quality assurance laboratory within one
13 (1) year of the date the initial license is issued. Renewal of any
14 medical marijuana testing laboratory license shall be contingent
15 upon accreditation in accordance with this subsection. All medical
16 marijuana testing laboratories shall obtain accreditation prior to
17 applying for and receiving a medical marijuana testing laboratory
18 license.

19 V. Unless authorized by the provisions of this section, a
20 commercial grower shall not transfer or sell medical marijuana and a
21 processor shall not transfer, sell or process into a concentrate or
22 product any medical marijuana, medical marijuana concentrate or
23 medical marijuana product unless samples from each harvest batch or,
24 production batch, or samples consistent with the rules promulgated

1 for process validation, from which that medical marijuana, medical
2 marijuana concentrate or medical marijuana product was derived has
3 been tested by a medical marijuana testing laboratory and passed all
4 contaminant tests required by the Oklahoma Medical Marijuana and
5 Patient Protection Act and applicable laws, rules and regulations.
6 A licensed commercial grower may transfer medical marijuana that has
7 failed testing to a licensed processor only for the purposes of
8 decontamination or remediation and only in accordance with the
9 provisions of the Oklahoma Medical Marijuana and Patient Protection
10 Act and the rules and regulations promulgated by the Executive
11 Director. Remediated and decontaminated medical marijuana may be
12 returned only to the originating licensed commercial grower.

13 W. Kief shall not be transferred or sold except as authorized
14 in the rules and regulations promulgated by the Executive Director.

22 shall not sell, transfer or otherwise distribute medical marijuana
23 or medical marijuana product that has not been packaged and labeled
24 in accordance with this section and rules promulgated by the ~~State~~

1 ~~Commissioner of Health~~ Executive Director of the Oklahoma Medical
2 Marijuana Authority.

3 B. A medical marijuana dispensary shall return medical
4 marijuana and medical marijuana product that does not meet packaging
5 or labeling requirements in this section or rules promulgated
6 pursuant thereto to the entity who transferred it to the dispensary.
7 The medical marijuana dispensary shall document to whom the item was
8 returned, what was returned and the date of the return or dispose of
9 any usable marijuana that does not meet these requirements in
10 accordance with the Oklahoma Medical Marijuana and Patient
11 Protection Act.

12 C. 1. Medical marijuana packaging shall be packaged to
13 minimize its appeal to children and shall not depict images other
14 than the business name logo of the medical marijuana producer and
15 image of the product.

16 2. A medical marijuana business shall not place any content on
17 a container in a manner that reasonably appears to target
18 individuals under the age of twenty-one (21) including, but not
19 limited to, cartoon characters or similar images.

20 3. Labels on a container shall not include any false or
21 misleading statements.

22 4. No container shall be intentionally or knowingly labeled so
23 as to cause a reasonable patient confusion as to whether the medical
24 marijuana, medical marijuana concentrate or medical marijuana

1 product is a trademarked product or labeled in a manner that
2 violates any federal trademark law or regulation. The label on the
3 container shall include a warning that states the following:

- 4 a. "For use by licensed medical marijuana patients only",
- 5 and
- 6 b. "Keep out of reach of children".

7 5. The label on the container shall not make any claims
8 regarding health or physical benefits to the patient.

9 6. The container itself may be clear in order to allow licensed
10 medical marijuana patients and licensed medical marijuana caregivers
11 the ability to view the product inside the container but shall be
12 child-resistant, as defined in Section 427.2 of this title.

13 7. At the point of sale and transfer of any medical marijuana,
14 medical marijuana concentrate, or medical marijuana products to a
15 licensed medical marijuana patient or licensed medical marijuana
16 caregiver, the dispensary shall place the medical marijuana, medical
17 marijuana concentrate, or medical marijuana products in an exit
18 package, as such term is defined in Section 427.2 of this title.

20 develop minimum standards for packaging and labeling of medical

7 directly used in or for the benefit of a state park in this state,
8 which are made to an organization which is exempt from taxation
9 pursuant to the provisions of the Internal Revenue Code, 26 U.S.C.,
10 Section 501(c)(3) and which is organized primarily for the purpose
11 of supporting one or more state parks located in this state;

12 40. The sale, lease, or use of parking privileges by an
13 institution of The Oklahoma State System of Higher Education;

14 41. Sales of tangible personal property or services for use on
15 campus or school construction projects for the benefit of
16 institutions of The Oklahoma State System of Higher Education,
17 private institutions of higher education accredited by the Oklahoma
18 State Regents for Higher Education, or any public school or school
19 district when such projects are financed by or through the use of
20 nonprofit entities which are exempt from taxation pursuant to the
21 provisions of the Internal Revenue Code, 26 U.S.C., Section
22 501(c)(3);

23 42. Sales of tangible personal property or services by an
24 organization which is exempt from taxation pursuant to the

provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), in the course of conducting a national championship sports event, but only if all or a portion of the payment in exchange therefor would qualify as the receipt of a qualified sponsorship payment described in Internal Revenue Code, 26 U.S.C., Section 513(i). Sales exempted pursuant to this paragraph shall be exempt from all Oklahoma sales, use, excise, and gross receipts taxes;

43. Sales of tangible personal property or services to or by an organization which:

- a. is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3),
- b. is affiliated with a comprehensive university within The Oklahoma State System of Higher Education, and
- c. has been organized primarily for the purpose of providing education and teacher training and conducting events relating to robotics;

44. The first Fifteen Thousand Dollars (\$15,000.00) each year from sales of tangible personal property to or by youth athletic teams which are part of an athletic organization exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(4), for the purposes of raising funds for the benefit of the team;

1 45. Sales of tickets for admission to a collegiate athletic
2 event that is held in a facility owned or operated by a municipality
3 or a public trust of which the municipality is the sole beneficiary
4 and that actually determines or is part of a tournament or
5 tournament process for determining a conference tournament
6 championship, a conference championship, or a national championship;

7 46. Sales of tangible personal property or services to or by an
8 organization which is exempt from taxation pursuant to the
9 provisions of the Internal Revenue Code, 26 U.S.C., Section
10 501(c)(3) and is operating the Oklahoma City National Memorial and
11 Museum, an affiliate of the National Park System;

12 47. Sales of tangible personal property or services to
13 organizations which are exempt from federal taxation pursuant to the
14 provisions of Section 501(c)(3) of the Internal Revenue Code, 26
15 U.S.C., Section 501(c)(3), the memberships of which are limited to
16 honorably discharged veterans, and which furnish financial support
17 to area veterans' organizations to be used for the purpose of
18 constructing a memorial or museum;

19 48. Sales of tangible personal property or services on or after
20 January 1, 2003, to an organization which is exempt from taxation
21 pursuant to the provisions of the Internal Revenue Code, 26 U.S.C.,
22 Section 501(c)(3) that is expending monies received from a private
23 foundation grant in conjunction with expenditures of local sales tax
24 revenue to construct a local public library;

1 49. Sales of tangible personal property or services to a state
2 that borders this state or any political subdivision of that state,
3 but only to the extent that the other state or political subdivision
4 exempts or does not impose a tax on similar sales of items to this
5 state or a political subdivision of this state;

6 50. Effective July 1, 2005, sales of tangible personal property
7 or services to the Career Technology Student Organizations under the
8 direction and supervision of the Oklahoma Department of Career and
9 Technology Education;

10 51. Sales of tangible personal property to a public trust
11 having either a single city, town or county or multiple cities,
12 towns or counties, or combination thereof as beneficiary or
13 beneficiaries or a nonprofit organization which is exempt from
14 taxation pursuant to the provisions of the Internal Revenue Code, 26
15 U.S.C., Section 501(c)(3) for the purpose of constructing
16 improvements to or expanding a hospital or nursing home owned and
17 operated by any such public trust or nonprofit entity prior to July
18 1, 2008, in counties with a population of less than one hundred
19 thousand (100,000) persons, according to the most recent Federal
20 Decennial Census. As used in this paragraph, "constructing
21 improvements to or expanding" shall not mean any expense for routine
22 maintenance or general repairs and shall require a project cost of
23 at least One Hundred Thousand Dollars (\$100,000.00). For purposes
24 of this paragraph, sales made to a contractor or subcontractor that

1 enters into a contractual relationship with a public trust or
2 nonprofit entity as described by this paragraph shall be considered
3 sales made to the public trust or nonprofit entity. The exemption
4 authorized by this paragraph shall be administered in the form of a
5 refund from the sales tax revenues apportioned pursuant to Section
6 1353 of this title and the vendor shall be required to collect the
7 sales tax otherwise applicable to the transaction. The purchaser
8 may apply for a refund of the sales tax paid in the manner
9 prescribed by this paragraph. Within thirty (30) days after the end
10 of each fiscal year, any purchaser that is entitled to make
11 application for a refund based upon the exempt treatment authorized
12 by this paragraph may file an application for refund of the sales
13 taxes paid during such preceding fiscal year. The Tax Commission
14 shall prescribe a form for purposes of making the application for
15 refund. The Tax Commission shall determine whether or not the total
16 amount of sales tax exemptions claimed by all purchasers is equal to
17 or less than Six Hundred Fifty Thousand Dollars (\$650,000.00). If
18 such claims are less than or equal to that amount, the Tax
19 Commission shall make refunds to the purchasers in the full amount
20 of the documented and verified sales tax amounts. If such claims by
21 all purchasers are in excess of Six Hundred Fifty Thousand Dollars
22 (\$650,000.00), the Tax Commission shall determine the amount of each
23 purchaser's claim, the total amount of all claims by all purchasers,
24 and the percentage each purchaser's claim amount bears to the total.

1 The resulting percentage determined for each purchaser shall be
2 multiplied by Six Hundred Fifty Thousand Dollars (\$650,000.00) to
3 determine the amount of refundable sales tax to be paid to each
4 purchaser. The pro rata refund amount shall be the only method to
5 recover sales taxes paid during the preceding fiscal year and no
6 balance of any sales taxes paid on a pro rata basis shall be the
7 subject of any subsequent refund claim pursuant to this paragraph;

8 52. Effective July 1, 2006, sales of tangible personal property
9 or services to any organization which assists, trains, educates, and
10 provides housing for physically and mentally handicapped persons and
11 which is exempt from taxation pursuant to the provisions of the
12 Internal Revenue Code, 26 U.S.C., Section 501(c)(3) and that
13 receives at least eighty-five percent (85%) of its annual budget
14 from state or federal funds. In order to receive the benefit of the
15 exemption authorized by this paragraph, the taxpayer shall be
16 required to make payment of the applicable sales tax at the time of
17 sale to the vendor in the manner otherwise required by law.

18 Notwithstanding any other provision of the Oklahoma Uniform Tax
19 Procedure Code to the contrary, the taxpayer shall be authorized to
20 file a claim for refund of sales taxes paid that qualify for the
21 exemption authorized by this paragraph for a period of one (1) year
22 after the date of the sale transaction. The taxpayer shall be
23 required to provide documentation as may be prescribed by the
24 Oklahoma Tax Commission in support of the refund claim. The total

1 amount of sales tax qualifying for exempt treatment pursuant to this
2 paragraph shall not exceed One Hundred Seventy-five Thousand Dollars
3 (\$175,000.00) each fiscal year. Claims for refund shall be
4 processed in the order in which such claims are received by the
5 Oklahoma Tax Commission. If a claim otherwise timely filed exceeds
6 the total amount of refunds payable for a fiscal year, such claim
7 shall be barred;

8 53. The first Two Thousand Dollars (\$2,000.00) each year of
9 sales of tangible personal property or services to, by, or for the
10 benefit of a qualified neighborhood watch organization that is
11 endorsed or supported by or working directly with a law enforcement
12 agency with jurisdiction in the area in which the neighborhood watch
13 organization is located. As used in this paragraph, "qualified
14 neighborhood watch organization" means an organization that is a
15 not-for-profit corporation under the laws of this state that was
16 created to help prevent criminal activity in an area through
17 community involvement and interaction with local law enforcement and
18 which is one of the first two thousand organizations which makes
19 application to the Oklahoma Tax Commission for the exemption after
20 March 29, 2006;

21 54. Sales of tangible personal property to a nonprofit
22 organization, exempt from taxation pursuant to the provisions of the
23 Internal Revenue Code, 26 U.S.C., Section 501(c)(3), organized
24 primarily for the purpose of providing services to homeless persons

1 during the day and located in a metropolitan area with a population
2 in excess of five hundred thousand (500,000) persons according to
3 the latest Federal Decennial Census. The exemption authorized by
4 this paragraph shall be applicable to sales of tangible personal
5 property to a qualified entity occurring on or after January 1,
6 2005;

7 55. Sales of tangible personal property or services to or by an
8 organization which is exempt from taxation pursuant to the
9 provisions of the Internal Revenue Code, 26 U.S.C., Section
10 501(c)(3) for events the principal purpose of which is to provide
11 funding for the preservation of wetlands and habitat for wild ducks;

12 56. Sales of tangible personal property or services to or by an
13 organization which is exempt from taxation pursuant to the
14 provisions of the Internal Revenue Code, 26 U.S.C., Section
15 501(c)(3) for events the principal purpose of which is to provide
16 funding for the preservation and conservation of wild turkeys;

17 57. Sales of tangible personal property or services to an
18 organization which:

19 a. is exempt from taxation pursuant to the provisions of
20 the Internal Revenue Code, 26 U.S.C., Section
21 501(c)(3), and

22 b. is part of a network of community-based, autonomous
23 member organizations that meets the following
24 criteria:

- (1) serves people with workplace disadvantages and disabilities by providing job training and employment services, as well as job placement opportunities and post-employment support,
- (2) has locations in the United States and at least twenty other countries,
- (3) collects donated clothing and household goods to sell in retail stores and provides contract labor services to business and government, and
- (4) provides documentation to the Oklahoma Tax Commission that over seventy-five percent (75%) of its revenues are channeled into employment, job training and placement programs, and other critical community services;

58. Sales of tickets made on or after September 21, 2005, and complimentary or free tickets for admission issued on or after September 21, 2005, which have a value equivalent to the charge that would have otherwise been made, for admission to a professional athletic event in which a team in the National Basketball Association is a participant, which is held in a facility owned or operated by a municipality, a county, or a public trust of which a municipality or a county is the sole beneficiary, and sales of tickets made on or after July 1, 2007, and complimentary or free tickets for admission issued on or after July 1, 2007, which have a

1 value equivalent to the charge that would have otherwise been made,
2 for admission to a professional athletic event in which a team in
3 the National Hockey League is a participant, which is held in a
4 facility owned or operated by a municipality, a county, or a public
5 trust of which a municipality or a county is the sole beneficiary;

6 59. Sales of tickets for admission and complimentary or free
7 tickets for admission which have a value equivalent to the charge
8 that would have otherwise been made to a professional sporting event
9 involving ice hockey, baseball, basketball, football or arena
10 football, or soccer. As used in this paragraph, "professional
11 sporting event" means an organized athletic competition between
12 teams that are members of an organized league or association with
13 centralized management, other than a national league or national
14 association, that imposes requirements for participation in the
15 league upon the teams, the individual athletes, or both, and which
16 uses a salary structure to compensate the athletes;

17 60. Sales of tickets for admission to an annual event sponsored
18 by an educational and charitable organization of women which is
19 exempt from taxation pursuant to the provisions of the Internal
20 Revenue Code, 26 U.S.C., Section 501(c)(3) and has as its mission
21 promoting volunteerism, developing the potential of women and
22 improving the community through the effective action and leadership
23 of trained volunteers;

1 61. Sales of tangible personal property or services to an
2 organization, which is exempt from taxation pursuant to the
3 provisions of the Internal Revenue Code, 26 U.S.C., Section
4 501(c)(3), and which is itself a member of an organization which is
5 exempt from taxation pursuant to the provisions of the Internal
6 Revenue Code, 26 U.S.C., Section 501(c)(3), if the membership
7 organization is primarily engaged in advancing the purposes of its
8 member organizations through fundraising, public awareness, or other
9 efforts for the benefit of its member organizations, and if the
10 member organization is primarily engaged either in providing
11 educational services and programs concerning health-related diseases
12 and conditions to individuals suffering from such health-related
13 diseases and conditions or their caregivers and family members or
14 support to such individuals, or in health-related research as to
15 such diseases and conditions, or both. In order to qualify for the
16 exemption authorized by this paragraph, the member nonprofit
17 organization shall be required to provide proof to the Oklahoma Tax
18 Commission of its membership status in the membership organization;

19 62. Sales of tangible personal property or services to or by an
20 organization which is part of a national volunteer women's service
21 organization dedicated to promoting patriotism, preserving American
22 history, and securing better education for children and which has at
23 least 168,000 members in 3,000 chapters across the United States;
24

1 63. Sales of tangible personal property or services to or by a
2 YWCA or YMCA organization which is part of a national nonprofit
3 community service organization working to meet the health and social
4 service needs of its members across the United States;

5 64. Sales of tangible personal property or services to or by a
6 veteran's organization which is exempt from taxation pursuant to the
7 provisions of the Internal Revenue Code, 26 U.S.C., Section
8 501(c)(19) and which is known as the Veterans of Foreign Wars of the
9 United States, Oklahoma Chapters;

10 65. Sales of boxes of food by a church or by an organization,
11 which is exempt from taxation pursuant to the provisions of the
12 Internal Revenue Code, 26 U.S.C., Section 501(c)(3). To qualify
13 under the provisions of this paragraph, the organization must be
14 organized for the primary purpose of feeding needy individuals or to
15 encourage volunteer service by requiring such service in order to
16 purchase food. These boxes shall only contain edible staple food
17 items;

18 66. Sales of tangible personal property or services to any
19 person with whom a church has duly entered into a construction
20 contract, necessary for carrying out such contract or to any
21 subcontractor to such a construction contract;

22 67. Sales of tangible personal property or services used
23 exclusively for charitable or educational purposes, to or by an
24 organization which:

- a. is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3),
- b. has filed a Not-for-Profit Certificate of Incorporation in this state, and
- c. is organized for the purpose of:
 - (1) providing training and education to developmentally disabled individuals,
 - (2) educating the community about the rights, abilities, and strengths of developmentally disabled individuals, and
 - (3) promoting unity among developmentally disabled individuals in their community and geographic area;

68. Sales of tangible personal property or services to any organization which is a shelter for abused, neglected, or abandoned children and which is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3); provided, until July 1, 2008, such exemption shall apply only to eligible shelters for children from birth to age twelve (12) and after July 1, 2008, such exemption shall apply to eligible shelters for children from birth to age eighteen (18);

1 69. Sales of tangible personal property or services to a child
2 care center which is licensed pursuant to the Oklahoma Child Care
3 Facilities Licensing Act and which:

4 a. possesses a 3-star rating from the Department of Human
5 Services Reaching for the Stars Program or a national
6 accreditation, and

7 b. allows on-site universal prekindergarten education to
8 be provided to four-year-old children through a
9 contractual agreement with any public school or school
10 district.

11 For the purposes of this paragraph, sales made to any person,
12 firm, agency, or entity that has entered previously into a
13 contractual relationship with a child care center for construction
14 and improvement of buildings and other structures owned by the child
15 care center and operated for educational purposes shall be
16 considered sales made to a child care center. Any such person,
17 firm, agency, or entity making purchases on behalf of a child care
18 center shall certify, in writing, on the copy of the invoice or
19 sales ticket the nature of the purchase. Any such person, or person
20 acting on behalf of a firm, agency, or entity making purchases on
21 behalf of a child care center in violation of this paragraph shall
22 be guilty of a misdemeanor and upon conviction thereof shall be
23 fined an amount equal to double the amount of sales tax involved or
24 incarcerated for not more than sixty (60) days or both;

- 1 70. a. Sales of tangible personal property to a service
2 organization of mothers who have children who are
3 serving or who have served in the military, which
4 service organization is exempt from taxation pursuant
5 to the provisions of the Internal Revenue Code, 26
6 U.S.C., Section 501(c)(19) and which is known as the
7 Blue Star Mothers of America, Inc. The exemption
8 provided by this paragraph shall only apply to the
9 purchase of tangible personal property actually sent
10 to United States military personnel overseas who are
11 serving in a combat zone and not to any other tangible
12 personal property purchased by the organization.
13 Provided, this exemption shall not apply to any sales
14 tax levied by a city, town, county, or any other
15 jurisdiction in this state.
- 16 b. The exemption authorized by this paragraph shall be
17 administered in the form of a refund from the sales
18 tax revenues apportioned pursuant to Section 1353 of
19 this title, and the vendor shall be required to
20 collect the sales tax otherwise applicable to the
21 transaction. The purchaser may apply for a refund of
22 the state sales tax paid in the manner prescribed by
23 this paragraph. Within sixty (60) days after the end
24 of each calendar quarter, any purchaser that is

1 entitled to make application for a refund based upon
2 the exempt treatment authorized by this paragraph may
3 file an application for refund of the state sales
4 taxes paid during such preceding calendar quarter.

5 The Tax Commission shall prescribe a form for purposes
6 of making the application for refund.

7 c. A purchaser who applies for a refund pursuant to this
8 paragraph shall certify that the items were actually
9 sent to military personnel overseas in a combat zone.
10 Any purchaser that applies for a refund for the
11 purchase of items that are not authorized for
12 exemption under this paragraph shall be subject to a
13 penalty in the amount of Five Hundred Dollars
14 (\$500.00);

15 71. Sales of food and snack items to or by an organization
16 which is exempt from taxation pursuant to the provisions of the
17 Internal Revenue Code, 26 U.S.C., Section 501(c)(3), whose primary
18 and principal purpose is providing funding for scholarships in the
19 medical field;

20 72. Sales of tangible personal property or services for use
21 solely on construction projects for organizations which are exempt
22 from taxation pursuant to the provisions of the Internal Revenue
23 Code, 26 U.S.C., Section 501(c)(3) and whose purpose is providing
24 end-of-life care and access to hospice services to low-income

1 individuals who live in a facility owned by the organization. The
2 exemption provided by this paragraph applies to sales to the
3 organization as well as to sales to any person with whom the
4 organization has duly entered into a construction contract,
5 necessary for carrying out such contract or to any subcontractor to
6 such a construction contract. Any person making purchases on behalf
7 of such organization shall certify, in writing, on the copy of the
8 invoice or sales ticket to be retained by the vendor that the
9 purchases are made for and on behalf of such organization and set
10 out the name of such organization. Any person who wrongfully or
11 erroneously certifies that purchases are for any of the above-named
12 organizations or who otherwise violates this section shall be guilty
13 of a misdemeanor and upon conviction thereof shall be fined an
14 amount equal to double the amount of sales tax involved or
15 incarcerated for not more than sixty (60) days or both;

16 73. Sales of tickets for admission to events held by
17 organizations exempt from taxation pursuant to the provisions of the
18 Internal Revenue Code, 26 U.S.C., Section 501(c)(3) that are
19 organized for the purpose of supporting general hospitals licensed
20 by the State Department of Health;

21 74. Sales of tangible personal property or services:

22 a. to a foundation which is exempt from taxation pursuant
23 to the provisions of the Internal Revenue Code, 26
24 U.S.C., Section 501(c)(3) and which raises tax-

deductible contributions in support of a wide range of firearms-related public interest activities of the National Rifle Association of America and other organizations that defend and foster Second Amendment rights, and

b. to or by a grassroots fundraising program for sales related to events to raise funds for a foundation meeting the qualifications of subparagraph a of this paragraph;

75. Sales by an organization or entity which is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3) which are related to a fundraising event sponsored by the organization or entity when the event does not exceed any five (5) consecutive days and when the sales are not in the organization's or the entity's regular course of business. Provided, the exemption provided in this paragraph shall be limited to tickets sold for admittance to the fundraising event and items which were donated to the organization or entity for sale at the event;

76. Effective November 1, 2017, sales of tangible personal property or services to an organization which is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3) and operates as a collaborative model which connects community agencies in one location to serve

1 individuals and families affected by violence and where victims have
2 access to services and advocacy at no cost to the victim;

3 77. Effective July 1, 2018, sales of tangible personal property
4 or services to or by an association which is exempt from taxation
5 pursuant to the provisions of the Internal Revenue Code, 26 U.S.C.,
6 Section 501(c)(19) and which is known as the National Guard
7 Association of Oklahoma;

8 78. Effective July 1, 2018, sales of tangible personal property
9 or services to or by an association which is exempt from taxation
10 pursuant to the provisions of the Internal Revenue Code, 26 U.S.C.,
11 Section 501(c)(4) and which is known as the Marine Corps League of
12 Oklahoma;

13 79. Sales of tangible personal property or services to the
14 American Legion, whether the purchase is made by the entity
15 chartered by the United States Congress or is an entity organized
16 under the laws of this or another state pursuant to the authority of
17 the national American Legion organization;

18 80. Sales of tangible personal property or services to or by an
19 organization which is:

- 20 a. exempt from taxation pursuant to the provisions of the
21 Internal Revenue Code, 26 U.S.C., Section 501(c)(3),
22 b. verified with a letter from the MIT Fab Foundation as
23 an official member of the Fab Lab Network in
24 compliance with the Fab Charter, and

1 c. able to provide documentation that its primary and
2 principal purpose is to provide community access to
3 advanced 21st century manufacturing and digital
4 fabrication tools for science, technology,
5 engineering, art and math (STEAM) learning skills,
6 developing inventions, creating and sustaining
7 businesses, and producing personalized products;

8 81. Effective November 1, 2021, sales of tangible personal
9 property or services used solely for construction and remodeling
10 projects to an organization which is exempt from taxation pursuant
11 to the provisions of the Internal Revenue Code, 26 U.S.C., Section
12 501(c) (3), and which meets the following requirements:

13 a. its primary purpose is to construct or remodel and
14 sell affordable housing and provide homeownership
15 education to residents of Oklahoma that have an income
16 that is below one hundred percent (100%) of the Family
17 Median Income guidelines as defined by the U.S.

18 Department of Housing and Urban Development,

19 b. it conducts its activities in a manner that serves
20 public or charitable purposes, rather than commercial
21 purposes,

22 c. it receives funding and revenue and charges fees in a
23 manner that does not incentivize it or its employees
24

1 to act other than in the best interests of its
2 clients, and

3 d. it compensates its employees in a manner that does not
4 incentivize employees to act other than in the best
5 interests of its clients;

6 82. Effective November 1, 2021, sales of tangible personal
7 property or services to a nonprofit entity, organized pursuant to
8 Oklahoma law before January 1, 2022, exempt from federal income
9 taxation pursuant to Section 501(c) of the Internal Revenue Code of
10 1986, as amended, the principal functions of which are to provide
11 assistance to natural persons following a disaster, with program
12 emphasis on repair or restoration to single-family residential
13 dwellings or the construction of a replacement single-family
14 residential dwelling. As used in this paragraph, "disaster" means
15 damage to property with or without accompanying injury to persons
16 from heavy rain, high winds, tornadic winds, drought, wildfire,
17 snow, ice, geologic disturbances, explosions, chemical accidents or
18 spills, and other events causing damage to property on a large
19 scale. For purposes of this paragraph, an entity that expended at
20 least seventy-five percent (75%) of its funds on the restoration to
21 single-family housing following a disaster including related general
22 and administrative expenses, shall be eligible for the exemption
23 authorized by this paragraph;

1 83. Effective November 1, 2021, through December 31, 2024,
2 sales of tangible personal property or services to a museum that:

- 3 a. operates as a part of an organization which is exempt
4 from taxation pursuant to the provisions of the
5 Internal Revenue Code, 26 U.S.C., Section 501(c)(3),
- 6 b. is not accredited by the American Alliance of Museums,
7 and
- 8 c. operates on an annual budget of less than One Million
9 Dollars (\$1,000,000.00);

10 84. Until July 1, 2022, sales of tangible personal property or
11 services for use in a clinical practice or medical facility operated
12 by an organization which is exempt from taxation pursuant to the
13 provisions of the Internal Revenue Code of the United States, 26

3 the Oklahoma Women Veterans Organization;

4 86. Sales of tangible personal property or services to a
5 nonprofit entity, organized pursuant to Oklahoma law before January
6 1, 2019, exempt from federal income taxation pursuant to Section
7 501(c) of the Internal Revenue Code of 1986, as amended, the
8 principal functions of which are to provide assistance to natural
9 persons following a disaster, with program emphasis on repair or
10 restoration to single-family residential dwellings or the
11 construction of a replacement single-family residential dwelling.

8 any four-wheeled electrical vehicle that is powered by an electric

12 (25) miles per hour and is manufactured in compliance with the
13 National Highway Traffic Safety Administration standards for low-

6 assignment, gift, operation of law, or in any other manner;

7 15. The term "person" means and includes natural persons,
8 individuals, partnerships, firms, associations, limited liability
9 companies, corporations, estates, trustees, business trusts,
10 syndicates, this state, any county, city, municipality, school
11 district or other political subdivision of the state, or any
12 corporation or combination acting as a unit or any receiver
13 appointed by any state or federal court; and the use of the singular
14 number shall include the plural number;

10 ~~Any property covered by this paragraph which is related to the~~

13 4. Property which is directly related to the compression and
14 delivery of natural gas from a private home or residence, for
15 noncommercial purposes, into the fuel tank of a motor vehicle
16 propelled by compressed natural gas. The property covered by this
17 paragraph must be new and must not have been previously installed or
18 used to refuel vehicles powered by natural gas; or

19 5. For tax years 2010 and 2023 through 2028, a motor vehicle
20 originally equipped so that the vehicle may be propelled by a
21 hydrogen fuel cell electric fueling system.

22 C. As used in this section, "motor vehicle" means a motor
23 vehicle originally designed by the manufacturer to operate lawfully
24 and principally on streets and highways.

1 D. The credit provided for in subsection A of this section
2 shall be as follows:

3 1. For the qualified clean-burning motor vehicle fuel property
4 defined in paragraphs 1, 2, or 5 of subsection B of this section,
5 the amount of the credit shall be as follows based upon gross
6 vehicle weight of the qualified vehicle:

6 E. In cases where no credit has been claimed pursuant to

10 manufacturer of such motor vehicle and the taxpayer is unable or
11 elects not to determine the exact basis which is attributable to
12 such property, the taxpayer may claim a credit in an amount not
13 exceeding the lesser of ten percent (10%) of the cost of the motor
14 vehicle or One Thousand Five Hundred Dollars (\$1,500.00).

15 F. If the tax credit allowed pursuant to subsection A of this
16 section exceeds the amount of income taxes due or if there are no
17 state income taxes due on the income of the taxpayer, the amount of

20 subsequent income tax liability for a period not to exceed five (5)

9 calculate and publish by the first day of the affected taxable year
10 a percentage by which the credits authorized by this section shall
11 be reduced so the total amount of credits used to offset tax does
12 not exceed Twenty Million Dollars (\$20,000,000.00) per year. The
13 formula to be used for the percentage adjustment shall be Twenty
14 Million Dollars (\$20,000,000.00) divided by the credits claimed in
15 the second preceding year, with respect to any changes to the future
16 of the credit.

17 K. Pursuant to subsection J of this section, in the event the
18 total tax credits authorized by this section exceed Twenty Million
19 Dollars (\$20,000,000.00) in any calendar year, the Tax Commission
20 shall permit any excess over Twenty Million Dollars (\$20,000,000.00)
21 but shall factor such excess into the percentage adjustment formula
22 for subsequent years with respect to any changes to the future of
23 the credit.

1 L. For the tax years 2023 through 2028, the total amount of
2 credits authorized by this section used to offset tax shall be
3 adjusted annually to limit the annual amount of credits to:

4 1. Ten Million Dollars (\$10,000,000.00) for qualified clean
5 burning fuel property propelled by compressed natural gas, liquefied
6 natural gas, or liquefied petroleum gas, property related to the
7 delivery of compressed natural gas, liquefied natural gas or
8 liquefied petroleum gas, and property directly related to the
9 compression and delivery of natural gas;

10 2. Ten Million Dollars (\$10,000,000.00) for property originally
11 equipped so that the vehicle may be propelled by a hydrogen fuel
12 cell electric fueling system and property directly related to the
13 delivery of hydrogen; and

15 metered-for-fee, public access recharging system for motor vehicles

20 amount of credits used to offset tax does not exceed each of the

22 formula to be used for the percentage adjustment shall be Ten
23 Million Dollars (\$10,000,000.00) divided by the credits claimed in

15 notice to the Governor, President Pro Tempore of the Senate and

4 arrive at Oklahoma taxable income for corporations and Oklahoma
5 adjusted gross income for individuals, as follows:

6 1. There shall be added interest income on obligations of any
7 state or political subdivision thereto which is not otherwise
8 exempted pursuant to other laws of this state, to the extent that
9 such interest is not included in taxable income and adjusted gross
10 income.

11 2. There shall be deducted amounts included in such income that
12 the state is prohibited from taxing because of the provisions of the
13 Federal Constitution, the State Constitution, federal laws or laws
14 of Oklahoma.

15 3. The amount of any federal net operating loss deduction shall
16 be adjusted as follows:

17 a. For carryovers and carrybacks to taxable years
18 beginning before January 1, 1981, the amount of any
19 net operating loss deduction allowed to a taxpayer for
20 federal income tax purposes shall be reduced to an
21 amount which is the same portion thereof as the loss
22 from sources within this state, as determined pursuant
23 to this section and Section 2362 of this title, for
24

1 the taxable year in which such loss is sustained is of
2 the total loss for such year;

3 b. For carryovers and carrybacks to taxable years

4 beginning after December 31, 1980, the amount of any
5 net operating loss deduction allowed for the taxable
6 year shall be an amount equal to the aggregate of the
7 Oklahoma net operating loss carryovers and carrybacks
8 to such year. Oklahoma net operating losses shall be
9 separately determined by reference to Section 172 of
10 the Internal Revenue Code, 26 U.S.C., Section 172, as
11 modified by the Oklahoma Income Tax Act, Section 2351
12 et seq. of this title, and shall be allowed without
13 regard to the existence of a federal net operating
14 loss. For tax years beginning after December 31,
15 2000, and ending before January 1, 2008, the years to
16 which such losses may be carried shall be determined
17 solely by reference to Section 172 of the Internal
18 Revenue Code, 26 U.S.C., Section 172, with the
19 exception that the terms "net operating loss" and
20 "taxable income" shall be replaced with "Oklahoma net
21 operating loss" and "Oklahoma taxable income". For

24 losses may be carried back shall be limited to two (2)

1 years. For tax years beginning after December 31,
2 2008, the years to which such losses may be carried
3 back shall be determined solely by reference to

5 Section 172, with the exception that the terms "net
6 operating loss" and "taxable income" shall be replaced
7 with "Oklahoma net operating loss" and "Oklahoma
8 taxable income".

9 4. Items of the following nature shall be allocated as
10 indicated. Allowable deductions attributable to items separately
11 allocable in subparagraphs a, b and c of this paragraph, whether or
12 not such items of income were actually received, shall be allocated
13 on the same basis as those items:

14 a. Income from real and tangible personal property, such
15 as rents, oil and mining production or royalties, and
16 gains or losses from sales of such property, shall be
17 allocated in accordance with the situs of such
18 property;

19 b. Income from intangible personal property, such as
20 interest, dividends, patent or copyright royalties,
21 and gains or losses from sales of such property, shall
22 be allocated in accordance with the domiciliary situs
23 of the taxpayer, except that:

1 (1) where such property has acquired a nonunitary
2 business or commercial situs apart from the
3 domicile of the taxpayer such income shall be
4 allocated in accordance with such business or
5 commercial situs; interest income from
6 investments held to generate working capital for
7 a unitary business enterprise shall be included
8 in apportionable income; a resident trust or
9 resident estate shall be treated as having a
10 separate commercial or business situs insofar as
11 undistributed income is concerned, but shall not
12 be treated as having a separate commercial or
13 business situs insofar as distributed income is
14 concerned,

15 (2) for taxable years beginning after December 31,
16 2003, capital or ordinary gains or losses from
17 the sale of an ownership interest in a publicly
18 traded partnership, as defined by Section 7704(b)
19 of the Internal Revenue Code, shall be allocated
20 to this state in the ratio of the original cost
21 of such partnership's tangible property in this
22 state to the original cost of such partnership's
23 tangible property everywhere, as determined at
24 the time of the sale; if more than fifty percent

(50%) of the value of the partnership's assets consists of intangible assets, capital or ordinary gains or losses from the sale of an ownership interest in the partnership shall be allocated to this state in accordance with the sales factor of the partnership for its first full tax period immediately preceding its tax period during which the ownership interest in the partnership was sold; the provisions of this division shall only apply if the capital or ordinary gains or losses from the sale of an ownership interest in a partnership do not constitute qualifying gain receiving capital treatment as defined in subparagraph a of paragraph 2 of subsection F of this section,

(3) income from such property which is required to be allocated pursuant to the provisions of paragraph 5 of this subsection shall be allocated as herein provided;

c. Net income or loss from a business activity which is not a part of business carried on within or without the state of a unitary character shall be separately allocated to the state in which such activity is conducted;

1 d. In the case of a manufacturing or processing
2 enterprise the business of which in Oklahoma consists
3 solely of marketing its products by:

4 (1) sales having a situs without this state, shipped
5 directly to a point from without the state to a
6 purchaser within the state, commonly known as
7 interstate sales,

8 (2) sales of the product stored in public warehouses
9 within the state pursuant to "in transit"
10 tariffs, as prescribed and allowed by the
11 Interstate Commerce Commission, to a purchaser
12 within the state,

13 (3) sales of the product stored in public warehouses
14 within the state where the shipment to such
15 warehouses is not covered by "in transit"
16 tariffs, as prescribed and allowed by the
17 Interstate Commerce Commission, to a purchaser
18 within or without the state,

19 the Oklahoma net income shall, at the option of the
20 taxpayer, be that portion of the total net income of
21 the taxpayer for federal income tax purposes derived
22 from the manufacture and/or processing and sales
23 everywhere as determined by the ratio of the sales
24 defined in this section made to the purchaser within

1 the state to the total sales everywhere. The term
2 "public warehouse" as used in this subparagraph means
3 a licensed public warehouse, the principal business of
4 which is warehousing merchandise for the public;

5 e. In the case of insurance companies, Oklahoma taxable
6 income shall be taxable income of the taxpayer for
7 federal tax purposes, as adjusted for the adjustments
8 provided pursuant to the provisions of paragraphs 1
9 and 2 of this subsection, apportioned as follows:

10 (1) except as otherwise provided by division (2) of
11 this subparagraph, taxable income of an insurance
12 company for a taxable year shall be apportioned
13 to this state by multiplying such income by a
14 fraction, the numerator of which is the direct
15 premiums written for insurance on property or
16 risks in this state, and the denominator of which
17 is the direct premiums written for insurance on
18 property or risks everywhere. For purposes of
19 this subsection, the term "direct premiums
20 written" means the total amount of direct
21 premiums written, assessments and annuity
22 considerations as reported for the taxable year
23 on the annual statement filed by the company with
24 the Insurance Commissioner in the form approved

1 by the National Association of Insurance
2 Commissioners, or such other form as may be
3 prescribed in lieu thereof,

4 (2) if the principal source of premiums written by an
5 insurance company consists of premiums for
6 reinsurance accepted by it, the taxable income of
7 such company shall be apportioned to this state
8 by multiplying such income by a fraction, the
9 numerator of which is the sum of (a) direct
10 premiums written for insurance on property or
11 risks in this state, plus (b) premiums written
12 for reinsurance accepted in respect of property
13 or risks in this state, and the denominator of
14 which is the sum of (c) direct premiums written
15 for insurance on property or risks everywhere,
16 plus (d) premiums written for reinsurance
17 accepted in respect of property or risks
18 everywhere. For purposes of this paragraph,
19 premiums written for reinsurance accepted in
20 respect of property or risks in this state,
21 whether or not otherwise determinable, may at the
22 election of the company be determined on the
23 basis of the proportion which premiums written
24 for insurance accepted from companies

1 commercially domiciled in Oklahoma bears to
2 premiums written for reinsurance accepted from
3 all sources, or alternatively in the proportion
4 which the sum of the direct premiums written for
5 insurance on property or risks in this state by
6 each ceding company from which reinsurance is
7 accepted bears to the sum of the total direct
8 premiums written by each such ceding company for
9 the taxable year.

10 5. The net income or loss remaining after the separate
11 allocation in paragraph 4 of this subsection, being that which is
12 derived from a unitary business enterprise, shall be apportioned to
13 this state on the basis of the arithmetical average of three factors
14 consisting of property, payroll and sales or gross revenue
15 enumerated as subparagraphs a, b and c of this paragraph. Net
16 income or loss as used in this paragraph includes that derived from
17 patent or copyright royalties, purchase discounts, and interest on
18 accounts receivable relating to or arising from a business activity,
19 the income from which is apportioned pursuant to this subsection,
20 including the sale or other disposition of such property and any
21 other property used in the unitary enterprise. Deductions used in
22 computing such net income or loss shall not include taxes based on
23 or measured by income. Provided, for corporations whose property
24 for purposes of the tax imposed by Section 2355 of this title has an

1 initial investment cost equaling or exceeding Two Hundred Million
2 Dollars (\$200,000,000.00) and such investment is made on or after
3 July 1, 1997, or for corporations which expand their property or
4 facilities in this state and such expansion has an investment cost
5 equaling or exceeding Two Hundred Million Dollars (\$200,000,000.00)
6 over a period not to exceed three (3) years, and such expansion is
7 commenced on or after January 1, 2000, the three factors shall be
8 apportioned with property and payroll, each comprising twenty-five
9 percent (25%) of the apportionment factor and sales comprising fifty
10 percent (50%) of the apportionment factor. The apportionment
11 factors shall be computed as follows:

12 a. The property factor is a fraction, the numerator of
13 which is the average value of the taxpayer's real and
14 tangible personal property owned or rented and used in
15 this state during the tax period and the denominator
16 of which is the average value of all the taxpayer's
17 real and tangible personal property everywhere owned
18 or rented and used during the tax period.

19 (1) Property, the income from which is separately
20 allocated in paragraph 4 of this subsection,
21 shall not be included in determining this
22 fraction. The numerator of the fraction shall
23 include a portion of the investment in
24 transportation and other equipment having no

1 fixed situs, such as rolling stock, buses, trucks
2 and trailers, including machinery and equipment
3 carried thereon, airplanes, salespersons'
4 automobiles and other similar equipment, in the
5 proportion that miles traveled in Oklahoma by
6 such equipment bears to total miles traveled,

7 (2) Property owned by the taxpayer is valued at its
8 original cost. Property rented by the taxpayer
9 is valued at eight times the net annual rental
10 rate. Net annual rental rate is the annual
11 rental rate paid by the taxpayer, less any annual
12 rental rate received by the taxpayer from
13 subrentals,

14 (3) The average value of property shall be determined
15 by averaging the values at the beginning and
16 ending of the tax period but the Oklahoma Tax
17 Commission may require the averaging of monthly
18 values during the tax period if reasonably
19 required to reflect properly the average value of
20 the taxpayer's property;

21 b. The payroll factor is a fraction, the numerator of
22 which is the total compensation for services rendered
23 in the state during the tax period, and the
24 denominator of which is the total compensation for

1 services rendered everywhere during the tax period.

2 "Compensation", as used in this subsection means those
3 paid-for services to the extent related to the unitary
4 business but does not include officers' salaries,
5 wages and other compensation.

6 (1) In the case of a transportation enterprise, the
7 numerator of the fraction shall include a portion
8 of such expenditure in connection with employees
9 operating equipment over a fixed route, such as
10 railroad employees, airline pilots, or bus
11 drivers, in this state only a part of the time,
12 in the proportion that mileage traveled in
13 Oklahoma bears to total mileage traveled by such
14 employees,

15 (2) In any case the numerator of the fraction shall
16 include a portion of such expenditures in
17 connection with itinerant employees, such as
18 traveling salespersons, in this state only a part
19 of the time, in the proportion that time spent in
20 Oklahoma bears to total time spent in furtherance
21 of the enterprise by such employees;

22 c. The sales factor is a fraction, the numerator of which
23 is the total sales or gross revenue of the taxpayer in
24 this state during the tax period, and the denominator

1 of which is the total sales or gross revenue of the
2 taxpayer everywhere during the tax period. "Sales",
3 as used in this subsection does not include sales or
4 gross revenue which are separately allocated in
5 paragraph 4 of this subsection.

6 (1) Sales of tangible personal property have a situs
7 in this state if the property is delivered or
8 shipped to a purchaser other than the United
9 States government, within this state regardless
10 of the FOB point or other conditions of the sale;
11 or the property is shipped from an office, store,
12 warehouse, factory or other place of storage in
13 this state and (a) the purchaser is the United
14 States government or (b) the taxpayer is not
15 doing business in the state of the destination of
16 the shipment.

17 (2) In the case of a railroad or interurban railway
18 enterprise, the numerator of the fraction shall
19 not be less than the allocation of revenues to
20 this state as shown in its annual report to the
21 Corporation Commission.

22 (3) In the case of an airline, truck or bus
23 enterprise or freight car, tank car, refrigerator
24 car or other railroad equipment enterprise, the

1 numerator of the fraction shall include a portion
2 of revenue from interstate transportation in the
3 proportion that interstate mileage traveled in
4 Oklahoma bears to total interstate mileage
5 traveled.

6 (4) In the case of an oil, gasoline or gas pipeline
7 enterprise, the numerator of the fraction shall
8 be either the total of traffic units of the
9 enterprise within Oklahoma or the revenue
10 allocated to Oklahoma based upon miles moved, at
11 the option of the taxpayer, and the denominator
12 of which shall be the total of traffic units of
13 the enterprise or the revenue of the enterprise
14 everywhere as appropriate to the numerator. A
15 "traffic unit" is hereby defined as the
16 transportation for a distance of one (1) mile of
17 one (1) barrel of oil, one (1) gallon of gasoline
18 or one thousand (1,000) cubic feet of natural or
19 casinghead gas, as the case may be.

20 (5) In the case of a telephone or telegraph or other
21 communication enterprise, the numerator of the
22 fraction shall include that portion of the
23 interstate revenue as is allocated pursuant to
24 the accounting procedures prescribed by the

1 Federal Communications Commission; provided that
2 in respect to each corporation or business entity
3 required by the Federal Communications Commission
4 to keep its books and records in accordance with
5 a uniform system of accounts prescribed by such
6 Commission, the intrastate net income shall be
7 determined separately in the manner provided by
8 such uniform system of accounts and only the
9 interstate income shall be subject to allocation
10 pursuant to the provisions of this subsection.
11 Provided further, that the gross revenue factors
12 shall be those as are determined pursuant to the
13 accounting procedures prescribed by the Federal
14 Communications Commission.

15 In any case where the apportionment of the three factors
16 prescribed in this paragraph attributes to Oklahoma a portion of net
17 income of the enterprise out of all appropriate proportion to the
18 property owned and/or business transacted within this state, because
19 of the fact that one or more of the factors so prescribed are not
20 employed to any appreciable extent in furtherance of the enterprise;
21 or because one or more factors not so prescribed are employed to a
22 considerable extent in furtherance of the enterprise; or because of
23 other reasons, the Tax Commission is empowered to permit, after a
24 showing by taxpayer that an excessive portion of net income has been

1 attributed to Oklahoma, or require, when in its judgment an
2 insufficient portion of net income has been attributed to Oklahoma,
3 the elimination, substitution, or use of additional factors, or
4 reduction or increase in the weight of such prescribed factors.
5 Provided, however, that any such variance from such prescribed
6 factors which has the effect of increasing the portion of net income
7 attributable to Oklahoma must not be inherently arbitrary, and
8 application of the recomputed final apportionment to the net income
9 of the enterprise must attribute to Oklahoma only a reasonable
10 portion thereof.

11 6. For calendar years 1997 and 1998, the owner of a new or
12 expanded agricultural commodity processing facility in this state
13 may exclude from Oklahoma taxable income, or in the case of an
14 individual, the Oklahoma adjusted gross income, fifteen percent
15 (15%) of the investment by the owner in the new or expanded
16 agricultural commodity processing facility. For calendar year 1999,
17 and all subsequent years, the percentage, not to exceed fifteen
18 percent (15%), available to the owner of a new or expanded
19 agricultural commodity processing facility in this state claiming
20 the exemption shall be adjusted annually so that the total estimated
21 reduction in tax liability does not exceed One Million Dollars
22 (\$1,000,000.00) annually. The Tax Commission shall promulgate rules
23 for determining the percentage of the investment which each eligible
24 taxpayer may exclude. The exclusion provided by this paragraph

1 shall be taken in the taxable year when the investment is made. In
2 the event the total reduction in tax liability authorized by this
3 paragraph exceeds One Million Dollars (\$1,000,000.00) in any
4 calendar year, the Tax Commission shall permit any excess over One
5 Million Dollars (\$1,000,000.00) and shall factor such excess into
6 the percentage for subsequent years. Any amount of the exemption
7 permitted to be excluded pursuant to the provisions of this
8 paragraph but not used in any year may be carried forward as an
9 exemption from income pursuant to the provisions of this paragraph
10 for a period not exceeding six (6) years following the year in which
11 the investment was originally made.

12 For purposes of this paragraph:

13 a. "Agricultural commodity processing facility" means
14 building, structures, fixtures and improvements used
15 or operated primarily for the processing or production
16 of marketable products from agricultural commodities.
17 The term shall also mean a dairy operation that
18 requires a depreciable investment of at least Two
19 Hundred Fifty Thousand Dollars (\$250,000.00) and which
20 produces milk from dairy cows. The term does not
21 include a facility that provides only, and nothing
22 more than, storage, cleaning, drying or transportation
23 of agricultural commodities, and
24

1 b. "Facility" means each part of the facility which is
2 used in a process primarily for:

3 (1) the processing of agricultural commodities,
4 including receiving or storing agricultural
5 commodities, or the production of milk at a dairy
6 operation,

7 (2) transporting the agricultural commodities or
8 product before, during or after the processing,
9 or

10 (3) packaging or otherwise preparing the product for
11 sale or shipment.

12 7. Despite any provision to the contrary in paragraph 3 of this
13 subsection, for taxable years beginning after December 31, 1999, in
14 the case of a taxpayer which has a farming loss, such farming loss
15 shall be considered a net operating loss carryback in accordance
16 with and to the extent of the Internal Revenue Code, 26 U.S.C.,
17 Section 172(b)(G). However, the amount of the net operating loss
18 carryback shall not exceed the lesser of:

19 a. Sixty Thousand Dollars (\$60,000.00), or

20 b. the loss properly shown on Schedule F of the Internal
21 Revenue Service Form 1040 reduced by one-half (1/2) of
22 the income from all other sources other than reflected
23 on Schedule F.

1 8. In taxable years beginning after December 31, 1995, all
2 qualified wages equal to the federal income tax credit set forth in
3 26 U.S.C.A., Section 45A, shall be deducted from taxable income.
4 The deduction allowed pursuant to this paragraph shall only be
5 permitted for the tax years in which the federal tax credit pursuant
6 to 26 U.S.C.A., Section 45A, is allowed. For purposes of this
7 paragraph, "qualified wages" means those wages used to calculate the
8 federal credit pursuant to 26 U.S.C.A., Section 45A.

9 9. In taxable years beginning after December 31, 2005, an
10 employer that is eligible for and utilizes the Safety Pays OSHA
11 Consultation Service provided by the Oklahoma Department of Labor
12 shall receive an exemption from taxable income in the amount of One
13 Thousand Dollars (\$1,000.00) for the tax year that the service is
14 utilized.

15 10. For taxable years beginning on or after January 1, 2010,
16 there shall be added to Oklahoma taxable income an amount equal to
17 the amount of deferred income not included in such taxable income
18 pursuant to Section 108(i)(1) of the Internal Revenue Code of 1986
19 as amended by Section 1231 of the American Recovery and Reinvestment
20 Act of 2009 (P.L. No. 111-5). There shall be subtracted from
21 Oklahoma taxable income an amount equal to the amount of deferred
22 income included in such taxable income pursuant to Section 108(i)(1)
23 of the Internal Revenue Code by Section 1231 of the American
24 Recovery and Reinvestment Act of 2009 (P.L. No. 111-5).

1 11. For taxable years beginning on or after January 1, 2019,
2 there shall be subtracted from Oklahoma taxable income or adjusted
3 gross income any item of income or gain, and there shall be added to
4 Oklahoma taxable income or adjusted gross income any item of loss or
5 deduction that in the absence of an election pursuant to the
6 provisions of the Pass-Through Entity Tax Equity Act of 2019 would
7 be allocated to a member or to an indirect member of an electing
8 pass-through entity pursuant to Section 2351 et seq. of this title,
9 if (i) the electing pass-through entity has accounted for such item
10 in computing its Oklahoma net entity income or loss pursuant to the
11 provisions of the Pass-Through Entity Tax Equity Act of 2019, and
12 (ii) the total amount of tax attributable to any resulting Oklahoma
13 net entity income has been paid. The Oklahoma Tax Commission shall
14 promulgate rules for the reporting of such exclusion to direct and
15 indirect members of the electing pass-through entity. As used in
16 this paragraph, "electing pass-through entity", "indirect member",
17 and "member" shall be defined in the same manner as prescribed by
18 Section 2355.1P-2 of this title. Notwithstanding the application of
19 this paragraph, the adjusted tax basis of any ownership interest in
20 a pass-through entity for purposes of Section 2351 et seq. of this
21 title shall be equal to its adjusted tax basis for federal income
22 tax purposes.

23 B. 1. The taxable income of any corporation shall be further
24 adjusted to arrive at Oklahoma taxable income, except those

1 corporations electing treatment as provided in subchapter S of the
2 Internal Revenue Code, 26 U.S.C., Section 1361 et seq., and Section
3 2365 of this title, deductions pursuant to the provisions of the
4 Accelerated Cost Recovery System as defined and allowed in the
5 Economic Recovery Tax Act of 1981, Public Law 97-34, 26 U.S.C.,
6 Section 168, for depreciation of assets placed into service after
7 December 31, 1981, shall not be allowed in calculating Oklahoma
8 taxable income. Such corporations shall be allowed a deduction for
9 depreciation of assets placed into service after December 31, 1981,
10 in accordance with provisions of the Internal Revenue Code, 26
11 U.S.C., Section 1 et seq., in effect immediately prior to the
12 enactment of the Accelerated Cost Recovery System. The Oklahoma tax
13 basis for all such assets placed into service after December 31,
14 1981, calculated in this section shall be retained and utilized for
15 all Oklahoma income tax purposes through the final disposition of
16 such assets.

17 Notwithstanding any other provisions of the Oklahoma Income Tax
18 Act, Section 2351 et seq. of this title, or of the Internal Revenue
19 Code to the contrary, this subsection shall control calculation of
20 depreciation of assets placed into service after December 31, 1981,
21 and before January 1, 1983.

22 For assets placed in service and held by a corporation in which
23 accelerated cost recovery system was previously disallowed, an
24 adjustment to taxable income is required in the first taxable year

1 beginning after December 31, 1982, to reconcile the basis of such
2 assets to the basis allowed in the Internal Revenue Code. The
3 purpose of this adjustment is to equalize the basis and allowance
4 for depreciation accounts between that reported to the Internal
5 Revenue Service and that reported to Oklahoma.

6 2. For tax years beginning on or after January 1, 2009, and
7 ending on or before December 31, 2009, there shall be added to
8 Oklahoma taxable income any amount in excess of One Hundred Seventy-
9 five Thousand Dollars (\$175,000.00) which has been deducted as a
10 small business expense under Internal Revenue Code, Section 179 as
11 provided in the American Recovery and Reinvestment Act of 2009.

12 C. 1. For taxable years beginning after December 31, 1987, the
13 taxable income of any corporation shall be further adjusted to
14 arrive at Oklahoma taxable income for transfers of technology to
15 qualified small businesses located in Oklahoma. Such transferor
16 corporation shall be allowed an exemption from taxable income of an
17 amount equal to the amount of royalty payment received as a result
18 of such transfer; provided, however, such amount shall not exceed
19 ten percent (10%) of the amount of gross proceeds received by such
20 transferor corporation as a result of the technology transfer. Such
21 exemption shall be allowed for a period not to exceed ten (10) years
22 from the date of receipt of the first royalty payment accruing from
23 such transfer. No exemption may be claimed for transfers of
24

1 technology to qualified small businesses made prior to January 1,
2 1988.

3 2. For purposes of this subsection:

4 a. "Qualified small business" means an entity, whether
5 organized as a corporation, partnership, or
6 proprietorship, organized for profit with its
7 principal place of business located within this state
8 and which meets the following criteria:

9 (1) Capitalization of not more than Two Hundred Fifty
10 Thousand Dollars (\$250,000.00),

11 (2) Having at least fifty percent (50%) of its
12 employees and assets located in Oklahoma at the
13 time of the transfer, and

14 (3) Not a subsidiary or affiliate of the transferor
15 corporation;

16 b. "Technology" means a proprietary process, formula,
17 pattern, device or compilation of scientific or
18 technical information which is not in the public
19 domain;

20 c. "Transferor corporation" means a corporation which is
21 the exclusive and undisputed owner of the technology
22 at the time the transfer is made; and
23
24

1 d. "Gross proceeds" means the total amount of
2 consideration for the transfer of technology, whether
3 the consideration is in money or otherwise.

4 D. 1. For taxable years beginning after December 31, 2005, the
5 taxable income of any corporation, estate or trust, shall be further
6 adjusted for qualifying gains receiving capital treatment. Such
7 corporations, estates or trusts shall be allowed a deduction from
8 Oklahoma taxable income for the amount of qualifying gains receiving
9 capital treatment earned by the corporation, estate or trust during
10 the taxable year and included in the federal taxable income of such
11 corporation, estate or trust.

12 2. As used in this subsection:

13 a. "qualifying gains receiving capital treatment" means
14 the amount of net capital gains, as defined in Section
15 1222(11) of the Internal Revenue Code, included in the
16 federal income tax return of the corporation, estate
17 or trust that result from:

18 (1) the sale of real property or tangible personal
19 property located within Oklahoma that has been
20 directly or indirectly owned by the corporation,
21 estate or trust for a holding period of at least
22 five (5) years prior to the date of the
23 transaction from which such net capital gains
24 arise,

1 (2) the sale of stock or on the sale of an ownership
2 interest in an Oklahoma company, limited
3 liability company, or partnership where such
4 stock or ownership interest has been directly or
5 indirectly owned by the corporation, estate or
6 trust for a holding period of at least three (3)
7 years prior to the date of the transaction from
8 which the net capital gains arise, or

9 (3) the sale of real property, tangible personal
10 property or intangible personal property located
11 within Oklahoma as part of the sale of all or
12 substantially all of the assets of an Oklahoma
13 company, limited liability company, or
14 partnership where such property has been directly
15 or indirectly owned by such entity owned by the
16 owners of such entity, and used in or derived
17 from such entity for a period of at least three
18 (3) years prior to the date of the transaction
19 from which the net capital gains arise,

20 b. "holding period" means an uninterrupted period of
21 time. The holding period shall include any additional
22 period when the property was held by another
23 individual or entity, if such additional period is
24

1 included in the taxpayer's holding period for the
2 asset pursuant to the Internal Revenue Code,

3 c. "Oklahoma company", "limited liability company", or
4 "partnership" means an entity whose primary
5 headquarters have been located in Oklahoma for at
6 least three (3) uninterrupted years prior to the date
7 of the transaction from which the net capital gains
8 arise,

9 d. "direct" means the taxpayer directly owns the asset,
10 and

11 e. "indirect" means the taxpayer owns an interest in a
12 pass-through entity (or chain of pass-through
13 entities) that sells the asset that gives rise to the
14 qualifying gains receiving capital treatment.

15 (1) With respect to sales of real property or
16 tangible personal property located within
17 Oklahoma, the deduction described in this
18 subsection shall not apply unless the pass-
19 through entity that makes the sale has held the
20 property for not less than five (5) uninterrupted
21 years prior to the date of the transaction that
22 created the capital gain, and each pass-through
23 entity included in the chain of ownership has
24 been a member, partner, or shareholder of the

1 pass-through entity in the tier immediately below
2 it for an uninterrupted period of not less than
3 five (5) years.

4 (2) With respect to sales of stock or ownership
5 interest in or sales of all or substantially all
6 of the assets of an Oklahoma company, limited
7 liability company, or partnership, the deduction
8 described in this subsection shall not apply
9 unless the pass-through entity that makes the
10 sale has held the stock or ownership interest or
11 the assets for not less than three (3)
12 uninterrupted years prior to the date of the
13 transaction that created the capital gain, and
14 each pass-through entity included in the chain of
15 ownership has been a member, partner or
16 shareholder of the pass-through entity in the
17 tier immediately below it for an uninterrupted
18 period of not less than three (3) years.

19 E. The Oklahoma adjusted gross income of any individual
20 taxpayer shall be further adjusted as follows to arrive at Oklahoma
21 taxable income:

22 1. a. In the case of individuals, there shall be added or
23 deducted, as the case may be, the difference necessary
24 to allow personal exemptions of One Thousand Dollars

1 (\$1,000.00) in lieu of the personal exemptions allowed
2 by the Internal Revenue Code.

3 b. There shall be allowed an additional exemption of One
4 Thousand Dollars (\$1,000.00) for each taxpayer or
5 spouse who is blind at the close of the tax year. For
6 purposes of this subparagraph, an individual is blind
7 only if the central visual acuity of the individual
8 does not exceed 20/200 in the better eye with
9 correcting lenses, or if the visual acuity of the
10 individual is greater than 20/200, but is accompanied
11 by a limitation in the fields of vision such that the
12 widest diameter of the visual field subtends an angle
13 no greater than twenty (20) degrees.

14 c. There shall be allowed an additional exemption of One
15 Thousand Dollars (\$1,000.00) for each taxpayer or
16 spouse who is sixty-five (65) years of age or older at
17 the close of the tax year based upon the filing status
18 and federal adjusted gross income of the taxpayer.
19 Taxpayers with the following filing status may claim
20 this exemption if the federal adjusted gross income
21 does not exceed:

22 (1) Twenty-five Thousand Dollars (\$25,000.00) if
23 married and filing jointly~~+~~L
24

- 1 (2) Twelve Thousand Five Hundred Dollars (\$12,500.00)
2 if married and filing separately~~+~~,
3 (3) Fifteen Thousand Dollars (\$15,000.00) if single~~+~~,
4 and
5 (4) Nineteen Thousand Dollars (\$19,000.00) if a
6 qualifying head of household.

7 Provided, for taxable years beginning after December
8 31, 1999, amounts included in the calculation of
9 federal adjusted gross income pursuant to the

17 deduction in determining taxable income, there shall
18 be added or deducted, as the case may be, the
19 difference necessary to allow a standard deduction in
20 lieu of the standard deduction allowed by the Internal
21 Revenue Code, in an amount equal to the larger of
22 fifteen percent (15%) of the Oklahoma adjusted gross
23 income or One Thousand Dollars (\$1,000.00), but not to
24 exceed Two Thousand Dollars (\$2,000.00), except that

1 in the case of a married individual filing a separate
2 return such deduction shall be the larger of fifteen
3 percent (15%) of such Oklahoma adjusted gross income
4 or Five Hundred Dollars (\$500.00), but not to exceed

20 c. For the taxable year beginning on January 1, 2007, and
21 ending December 31, 2007, in the case of individuals
22 who use the standard deduction in determining taxable
23 income, there shall be added or deducted, as the case
24 may be, the difference necessary to allow a standard

1 deduction in lieu of the standard deduction allowed by
2 the Internal Revenue Code, in an amount equal to:

3 (1) Five Thousand Five Hundred Dollars (\$5,500.00),
4 if the filing status is married filing joint or

6 (2) Four Thousand One Hundred Twenty-five Dollars

11 d. For the taxable year beginning on January 1, 2008, and
12 ending December 31, 2008, in the case of individuals
13 who use the standard deduction in determining taxable
14 income, there shall be added or deducted, as the case
15 may be, the difference necessary to allow a standard
16 deduction in lieu of the standard deduction allowed by
17 the Internal Revenue Code, in an amount equal to:

18 (1) Six Thousand Five Hundred Dollars (\$6,500.00), if
19 the filing status is married filing joint or
20 qualifying widow, ~~or~~

21 (2) Four Thousand Eight Hundred Seventy-five Dollars
22 (\$4,875.00) for a head of household, or

2 (\$3,250.00), if the filing status is single or

4 e. For the taxable year beginning on January 1, 2009, and
5 ending December 31, 2009, in the case of individuals
6 who use the standard deduction in determining taxable
7 income, there shall be added or deducted, as the case
8 may be, the difference necessary to allow a standard
9 deduction in lieu of the standard deduction allowed by
10 the Internal Revenue Code, in an amount equal to:

11 (1) Eight Thousand Five Hundred Dollars (\$8,500.00),
12 if the filing status is married filing joint or
13 qualifying widow, ~~or~~

14 (2) Six Thousand Three Hundred Seventy-five Dollars
15 (\$6,375.00) for a head of household, or

16 (3) Four Thousand Two Hundred Fifty Dollars
17 (\$4,250.00), if the filing status is single or
18 married filing separate.

19 Oklahoma adjusted gross income shall be increased by
20 any amounts paid for motor vehicle excise taxes which
21 were deducted as allowed by the Internal Revenue Code.

22 f. For taxable years beginning on or after January 1,
23 2010, and ending on December 31, 2016, in the case of
24 individuals who use the standard deduction in

determining taxable income, there shall be added or deducted, as the case may be, the difference necessary to allow a standard deduction equal to the standard deduction allowed by the Internal Revenue Code, based upon the amount and filing status prescribed by such Code for purposes of filing federal individual income tax returns.

g. For taxable years beginning on or after January 1, 2017, in the case of individuals who use the standard deduction in determining taxable income, there shall be added or deducted, as the case may be, the difference necessary to allow a standard deduction in lieu of the standard deduction allowed by the Internal Revenue Code, as follows:

- (1) Six Thousand Three Hundred Fifty Dollars
(\$6,350.00) for single or married filing separately,
- (2) Twelve Thousand Seven Hundred Dollars
(\$12,700.00) for married filing jointly or qualifying widower with dependent child, and
- (3) Nine Thousand Three Hundred Fifty Dollars
(\$9,350.00) for head of household.

3. a. In the case of resident and part-year resident individuals having adjusted gross income from sources

1 both within and without the state, the itemized or
2 standard deductions and personal exemptions shall be
3 reduced to an amount which is the same portion of the
4 total thereof as Oklahoma adjusted gross income is of
5 adjusted gross income. To the extent itemized
6 deductions include allowable moving expense, proration
7 of moving expense shall not be required or permitted
8 but allowable moving expense shall be fully deductible
9 for those taxpayers moving within or into Oklahoma and

12 All other itemized or standard deductions and personal

19 not exceed Seventeen Thousand Dollars (\$17,000.00).

22 federal income tax purposes shall be excluded from the
23 amount of Seventeen Thousand Dollars (\$17,000.00) as
24 specified by this subparagraph.

1 4. A resident individual with a physical disability
2 constituting a substantial handicap to employment may deduct from
3 Oklahoma adjusted gross income such expenditures to modify a motor
4 vehicle, home or workplace as are necessary to compensate for his or
5 her handicap. A veteran certified by the Department of Veterans
6 Affairs of the federal government as having a service-connected
7 disability shall be conclusively presumed to be an individual with a
8 physical disability constituting a substantial handicap to
9 employment. The Tax Commission shall promulgate rules containing a
10 list of combinations of common disabilities and modifications which
11 may be presumed to qualify for this deduction. The Tax Commission
12 shall prescribe necessary requirements for verification.

13 5. a. Before July 1, 2010, the first One Thousand Five
14 Hundred Dollars (\$1,500.00) received by any person
15 from the United States as salary or compensation in
16 any form, other than retirement benefits, as a member
17 of any component of the Armed Forces of the United
18 States shall be deducted from taxable income.

19 b. On or after July 1, 2010, one hundred percent (100%)
20 of the income received by any person from the United
21 States as salary or compensation in any form, other
22 than retirement benefits, as a member of any component
23 of the Armed Forces of the United States shall be
24 deducted from taxable income.

1 c. Whenever the filing of a timely income tax return by a
2 member of the Armed Forces of the United States is
3 made impracticable or impossible of accomplishment by
4 reason of:

5 (1) absence from the United States, which term
6 includes only the states and the District of
7 Columbia~~+~~L

8 (2) absence from the State of Oklahoma while on
9 active duty~~+~~L or

10 (3) confinement in a hospital within the United
11 States for treatment of wounds, injuries or
12 disease,

13 the time for filing a return and paying an income tax
14 shall be and is hereby extended without incurring
15 liability for interest or penalties, to the fifteenth
16 day of the third month following the month in which:

17 (a) Such individual shall return to the United
18 States if the extension is granted pursuant
19 to subparagraph a of this paragraph, return
20 to the State of Oklahoma if the extension is
21 granted pursuant to subparagraph b of this
22 paragraph or be discharged from such
23 hospital if the extension is granted
24

1 pursuant to subparagraph c of this
2 paragraph~~7~~, or

3 (b) An executor, administrator, or conservator
4 of the estate of the taxpayer is appointed,
5 whichever event occurs the earliest.

6 Provided, that the Tax Commission may, in its discretion, grant
7 any member of the Armed Forces of the United States an extension of
8 time for filing of income tax returns and payment of income tax
9 without incurring liabilities for interest or penalties. Such
10 extension may be granted only when in the judgment of the Tax
11 Commission a good cause exists therefor and may be for a period in
12 excess of six (6) months. A record of every such extension granted,
13 and the reason therefor, shall be kept.

14 6. Before July 1, 2010, the salary or any other form of
15 compensation, received from the United States by a member of any
16 component of the Armed Forces of the United States, shall be
17 deducted from taxable income during the time in which the person is
18 detained by the enemy in a conflict, is a prisoner of war or is
19 missing in action and not deceased; provided, after July 1, 2010,
20 all such salary or compensation shall be subject to the deduction as
21 provided pursuant to paragraph 5 of this subsection.

22 7. a. An individual taxpayer, whether resident or
23 nonresident, may deduct an amount equal to the federal
24

1 income taxes paid by the taxpayer during the taxable
2 year.

3 b. Federal taxes as described in subparagraph a of this
4 paragraph shall be deductible by any individual
5 taxpayer, whether resident or nonresident, only to the
6 extent they relate to income subject to taxation
7 pursuant to the provisions of the Oklahoma Income Tax
8 Act. The maximum amount allowable in the preceding
9 paragraph shall be prorated on the ratio of the
10 Oklahoma adjusted gross income to federal adjusted
11 gross income.

12 c. For the purpose of this paragraph, "federal income
13 taxes paid" shall mean federal income taxes, surtaxes
14 imposed on incomes or excess profits taxes, as though
15 the taxpayer was on the accrual basis. In determining
16 the amount of deduction for federal income taxes for
17 tax year 2001, the amount of the deduction shall not
18 be adjusted by the amount of any accelerated ten
19 percent (10%) tax rate bracket credit or advanced
20 refund of the credit received during the tax year
21 provided pursuant to the federal Economic Growth and
22 Tax Relief Reconciliation Act of 2001, P.L. No. 107-
23 16, and the advanced refund of such credit shall not
24 be subject to taxation.

1 d. The provisions of this paragraph shall apply to all
2 taxable years ending after December 31, 1978, and
3 beginning before January 1, 2006.

4 8. Retirement benefits not to exceed Five Thousand Five Hundred
5 Dollars (\$5,500.00) for the 2004 tax year, Seven Thousand Five
6 Hundred Dollars (\$7,500.00) for the 2005 tax year and Ten Thousand
7 Dollars (\$10,000.00) for the 2006 tax year and all subsequent tax
8 years, which are received by an individual from the civil service of
9 the United States, the Oklahoma Public Employees Retirement System,
10 the Teachers' Retirement System of Oklahoma, the Oklahoma Law
11 Enforcement Retirement System, the Oklahoma Firefighters Pension and
12 Retirement System, the Oklahoma Police Pension and Retirement
13 System, the employee retirement systems created by counties pursuant
14 to Section 951 et seq. of Title 19 of the Oklahoma Statutes, the
15 Uniform Retirement System for Justices and Judges, the Oklahoma
16 Wildlife Conservation Department Retirement Fund, the Oklahoma
17 Employment Security Commission Retirement Plan, or the employee
18 retirement systems created by municipalities pursuant to Section 48-
19 101 et seq. of Title 11 of the Oklahoma Statutes shall be exempt
20 from taxable income.

21 9. In taxable years beginning after December 31, 1984, Social
22 Security benefits received by an individual shall be exempt from
23 taxable income, to the extent such benefits are included in the
24

1 federal adjusted gross income pursuant to the provisions of Section
2 86 of the Internal Revenue Code, 26 U.S.C., Section 86.

3 10. For taxable years beginning after December 31, 1994, lump-
4 sum distributions from employer plans of deferred compensation,
5 which are not qualified plans within the meaning of Section 401(a)
6 of the Internal Revenue Code, 26 U.S.C., Section 401(a), and which
7 are deposited in and accounted for within a separate bank account or
8 brokerage account in a financial institution within this state,
9 shall be excluded from taxable income in the same manner as a
10 qualifying rollover contribution to an individual retirement account
11 within the meaning of Section 408 of the Internal Revenue Code, 26
12 U.S.C., Section 408. Amounts withdrawn from such bank or brokerage
13 account, including any earnings thereon, shall be included in
14 taxable income when withdrawn in the same manner as withdrawals from
15 individual retirement accounts within the meaning of Section 408 of
16 the Internal Revenue Code.

17 11. In taxable years beginning after December 31, 1995,
18 contributions made to and interest received from a medical savings
19 account established pursuant to Sections 2621 through 2623 of Title
20 63 of the Oklahoma Statutes shall be exempt from taxable income.

21 12. For taxable years beginning after December 31, 1996, the
22 Oklahoma adjusted gross income of any individual taxpayer who is a
23 swine or poultry producer may be further adjusted for the deduction
24 for depreciation allowed for new construction or expansion costs

1 which may be computed using the same depreciation method elected for
2 federal income tax purposes except that the useful life shall be
3 seven (7) years for purposes of this paragraph. If depreciation is
4 allowed as a deduction in determining the adjusted gross income of
5 an individual, any depreciation calculated and claimed pursuant to
6 this section shall in no event be a duplication of any depreciation
7 allowed or permitted on the federal income tax return of the
8 individual.

9 13. a. In taxable years beginning before January 1, 2005,
10 retirement benefits not to exceed the amounts
11 specified in this paragraph, which are received by an
12 individual sixty-five (65) years of age or older and
13 whose Oklahoma adjusted gross income is Twenty-five
14 Thousand Dollars (\$25,000.00) or less if the filing
15 status is single, head of household, or married filing
16 separate, or Fifty Thousand Dollars (\$50,000.00) or
17 less if the filing status is married filing joint or
18 qualifying widow, shall be exempt from taxable income.
19 In taxable years beginning after December 31, 2004,
20 retirement benefits not to exceed the amounts
21 specified in this paragraph, which are received by an
22 individual whose Oklahoma adjusted gross income is
23 less than the qualifying amount specified in this
24 paragraph, shall be exempt from taxable income.

b. For purposes of this paragraph, the qualifying amount shall be as follows:

- (1) in taxable years beginning after December 31, 2004, and prior to January 1, 2007, the qualifying amount shall be Thirty-seven Thousand Five Hundred Dollars (\$37,500.00) or less if the filing status is single, head of household, or married filing separate, or Seventy-five Thousand Dollars (\$75,000.00) or less if the filing status is married filing jointly or qualifying widow,
- (2) in the taxable year beginning January 1, 2007, the qualifying amount shall be Fifty Thousand Dollars (\$50,000.00) or less if the filing status is single, head of household, or married filing separate, or One Hundred Thousand Dollars (\$100,000.00) or less if the filing status is married filing jointly or qualifying widow,
- (3) in the taxable year beginning January 1, 2008, the qualifying amount shall be Sixty-two Thousand Five Hundred Dollars (\$62,500.00) or less if the filing status is single, head of household, or married filing separate, or One Hundred Twenty-five Thousand Dollars (\$125,000.00) or less if

1 the filing status is married filing jointly or
2 qualifying widow,

3 (4) in the taxable year beginning January 1, 2009,
4 the qualifying amount shall be One Hundred
5 Thousand Dollars (\$100,000.00) or less if the
6 filing status is single, head of household, or
7 married filing separate, or Two Hundred Thousand
8 Dollars (\$200,000.00) or less if the filing
9 status is married filing jointly or qualifying
10 widow, and

11 (5) in the taxable year beginning January 1, 2010,
12 and subsequent taxable years, there shall be no
13 limitation upon the qualifying amount.

14 c. For purposes of this paragraph, "retirement benefits"
15 means the total distributions or withdrawals from the
16 following:

17 (1) an employee pension benefit plan which satisfies
18 the requirements of Section 401 of the Internal
19 Revenue Code, 26 U.S.C., Section 401,

20 (2) an eligible deferred compensation plan that
21 satisfies the requirements of Section 457 of the
22 Internal Revenue Code, 26 U.S.C., Section 457,

23 (3) an individual retirement account, annuity or
24 trust or simplified employee pension that

1 satisfies the requirements of Section 408 of the
2 Internal Revenue Code, 26 U.S.C., Section 408,
3 (4) an employee annuity subject to the provisions of
4 Section 403(a) or (b) of the Internal Revenue
5 Code, 26 U.S.C., Section 403(a) or (b),
6 (5) United States Retirement Bonds which satisfy the
7 requirements of Section 86 of the Internal
8 Revenue Code, 26 U.S.C., Section 86, or
9 (6) lump-sum distributions from a retirement plan
10 which satisfies the requirements of Section
11 402(e) of the Internal Revenue Code, 26 U.S.C.,
12 Section 402(e).

13 d. The amount of the exemption provided by this paragraph
14 shall be limited to Five Thousand Five Hundred Dollars
15 (\$5,500.00) for the 2004 tax year, Seven Thousand Five
16 Hundred Dollars (\$7,500.00) for the 2005 tax year and
17 Ten Thousand Dollars (\$10,000.00) for the tax year
18 2006 and for all subsequent tax years. Any individual
19 who claims the exemption provided for in paragraph 8
20 of this subsection shall not be permitted to claim a
21 combined total exemption pursuant to this paragraph
22 and paragraph 8 of this subsection in an amount
23 exceeding Five Thousand Five Hundred Dollars
24 (\$5,500.00) for the 2004 tax year, Seven Thousand Five

1 Hundred Dollars (\$7,500.00) for the 2005 tax year and
2 Ten Thousand Dollars (\$10,000.00) for the 2006 tax
3 year and all subsequent tax years.

4 14. In taxable years beginning after December 31, 1999, for an
5 individual engaged in production agriculture who has filed a
6 Schedule F form with the taxpayer's federal income tax return for
7 such taxable year, there shall be excluded from taxable income any
8 amount which was included as federal taxable income or federal
9 adjusted gross income and which consists of the discharge of an
10 obligation by a creditor of the taxpayer incurred to finance the
11 production of agricultural products.

12 15. In taxable years beginning December 31, 2000, an amount
13 equal to one hundred percent (100%) of the amount of any scholarship
14 or stipend received from participation in the Oklahoma Police Corps
15 Program, as established in Section 2-140.3 of Title 47 of the
16 Oklahoma Statutes shall be exempt from taxable income.

17 16. a. In taxable years beginning after December 31, 2001,
18 and before January 1, 2005, there shall be allowed a
19 deduction in the amount of contributions to accounts
20 established pursuant to the Oklahoma College Savings
21 Plan Act. The deduction shall equal the amount of
22 contributions to accounts, but in no event shall the
23 deduction for each contributor exceed Two Thousand
24

1 Five Hundred Dollars (\$2,500.00) each taxable year for
2 each account.

- 3 b. In taxable years beginning after December 31, 2004,
4 each taxpayer shall be allowed a deduction for
5 contributions to accounts established pursuant to the
6 Oklahoma College Savings Plan Act. The maximum annual
7 deduction shall equal the amount of contributions to
8 all such accounts plus any contributions to such
9 accounts by the taxpayer for prior taxable years after
10 December 31, 2004, which were not deducted, but in no
11 event shall the deduction for each tax year exceed Ten
12 Thousand Dollars (\$10,000.00) for each individual
13 taxpayer or Twenty Thousand Dollars (\$20,000.00) for
14 taxpayers filing a joint return. Any amount of a
15 contribution that is not deducted by the taxpayer in
16 the year for which the contribution is made may be
17 carried forward as a deduction from income for the
18 succeeding five (5) years. For taxable years
19 beginning after December 31, 2005, deductions may be
20 taken for contributions and rollovers made during a
21 taxable year and up to April 15 of the succeeding
22 year, or the due date of a taxpayer's state income tax
23 return, excluding extensions, whichever is later.

1 Provided, a deduction for the same contribution may
2 not be taken for two (2) different taxable years.

3 c. In taxable years beginning after December 31, 2006,
4 deductions for contributions made pursuant to
5 subparagraph b of this paragraph shall be limited as
6 follows:

7 (1) for a taxpayer who qualified for the five-year
8 carryforward election and who takes a rollover or
9 nonqualified withdrawal during that period, the
10 tax deduction otherwise available pursuant to
11 subparagraph b of this paragraph shall be reduced
12 by the amount which is equal to the rollover or
13 nonqualified withdrawal, and

14 (2) for a taxpayer who elects to take a rollover or
15 nonqualified withdrawal within the same tax year
16 in which a contribution was made to the
17 taxpayer's account, the tax deduction otherwise
18 available pursuant to subparagraph b of this
19 paragraph shall be reduced by the amount of the
20 contribution which is equal to the rollover or
21 nonqualified withdrawal.

22 d. If a taxpayer elects to take a rollover on a
23 contribution for which a deduction has been taken
24 pursuant to subparagraph b of this paragraph within

1 one (1) year of the date of contribution, the amount
2 of such rollover shall be included in the adjusted
3 gross income of the taxpayer in the taxable year of
4 the rollover.

5 e. If a taxpayer makes a nonqualified withdrawal of
6 contributions for which a deduction was taken pursuant
7 to subparagraph b of this paragraph, such nonqualified
8 withdrawal and any earnings thereon shall be included
9 in the adjusted gross income of the taxpayer in the
10 taxable year of the nonqualified withdrawal.

11 f. As used in this paragraph:

12 (1) "non-qualified withdrawal" means a withdrawal
13 from an Oklahoma College Savings Plan account
14 other than one of the following:

15 (a) a qualified withdrawal,

16 (b) a withdrawal made as a result of the death
17 or disability of the designated beneficiary
18 of an account,

19 (c) a withdrawal that is made on the account of
20 a scholarship or the allowance or payment
21 described in Section 135(d)(1)(B) or (C) or
22 by the Internal Revenue Code, received by
23 the designated beneficiary to the extent the
24 amount of the refund does not exceed the

1 amount of the scholarship, allowance, or
2 payment, or

3 (d) a rollover or change of designated
4 beneficiary as permitted by subsection F of
5 Section 3970.7 of Title 70 of Oklahoma
6 Statutes, and

7 (2) "rollover" means the transfer of funds from the
8 Oklahoma College Savings Plan to any other plan
9 under Section 529 of the Internal Revenue Code.

10 17. For ~~taxable years beginning after December 31, 2005~~ tax
11 years 2006 through 2021, retirement benefits received by an
12 individual from any component of the Armed Forces of the United
13 States in an amount not to exceed the greater of seventy-five
14 percent (75%) of such benefits or Ten Thousand Dollars (\$10,000.00)
15 shall be exempt from taxable income but in no case less than the
16 amount of the exemption provided by paragraph 13 of this subsection.
17 For tax year 2022 and subsequent tax years, retirement benefits
18 received by an individual from any component of the Armed Forces of
19 the United States shall be exempt from taxable income.

20 18. For taxable years beginning after December 31, 2006,
21 retirement benefits received by federal civil service retirees,
22 including survivor annuities, paid in lieu of Social Security
23 benefits shall be exempt from taxable income to the extent such
24 benefits are included in the federal adjusted gross income pursuant

1 to the provisions of Section 86 of the Internal Revenue Code, 26
2 U.S.C., Section 86, according to the following schedule:

- 3 a. in the taxable year beginning January 1, 2007, twenty
4 percent (20%) of such benefits shall be exempt,
- 5 b. in the taxable year beginning January 1, 2008, forty
6 percent (40%) of such benefits shall be exempt,
- 7 c. in the taxable year beginning January 1, 2009, sixty
8 percent (60%) of such benefits shall be exempt,
- 9 d. in the taxable year beginning January 1, 2010, eighty
10 percent (80%) of such benefits shall be exempt, and
- 11 e. in the taxable year beginning January 1, 2011, and
12 subsequent taxable years, one hundred percent (100%)
13 of such benefits shall be exempt.

- 14 19. a. For taxable years beginning after December 31, 2007, a
15 resident individual may deduct up to Ten Thousand
16 Dollars (\$10,000.00) from Oklahoma adjusted gross
17 income if the individual, or the dependent of the
18 individual, while living, donates one or more human
19 organs of the individual to another human being for
20 human organ transplantation. As used in this
21 paragraph, "human organ" means all or part of a liver,
22 pancreas, kidney, intestine, lung, or bone marrow. A
23 deduction that is claimed under this paragraph may be
24

1 claimed in the taxable year in which the human organ
2 transplantation occurs.

3 b. An individual may claim this deduction only once, and
4 the deduction may be claimed only for unreimbursed
5 expenses that are incurred by the individual and
6 related to the organ donation of the individual.

7 c. The Oklahoma Tax Commission shall promulgate rules to
8 implement the provisions of this paragraph which shall
9 contain a specific list of expenses which may be
10 presumed to qualify for the deduction. The Tax
11 Commission shall prescribe necessary requirements for
12 verification.

13 20. For taxable years beginning after December 31, 2009, there
14 shall be exempt from taxable income any amount received by the
15 beneficiary of the death benefit for an emergency medical technician
16 or a registered emergency medical responder provided by Section 1-
17 2505.1 of Title 63 of the Oklahoma Statutes.

18 21. For taxable years beginning after December 31, 2008,
19 taxable income shall be increased by any unemployment compensation
20 exempted under Section 85(c) of the Internal Revenue Code, 26
21 U.S.C., Section 85(c) (2009) .

22 22. For taxable years beginning after December 31, 2008, there
23 shall be exempt from taxable income any payment in an amount less
24 than Six Hundred Dollars (\$600.00) received by a person as an award

1 for participation in a competitive livestock show event. For
2 purposes of this paragraph, the payment shall be treated as a
3 scholarship amount paid by the entity sponsoring the event and the
4 sponsoring entity shall cause the payment to be categorized as a
5 scholarship in its books and records.

6 23. For taxable years beginning on or after January 1, 2016,
7 taxable income shall be increased by any amount of state and local
8 sales or income taxes deducted under 26 U.S.C., Section 164 of the
9 Internal Revenue Code. If the amount of state and local taxes
10 deducted on the federal return is limited, taxable income on the
11 state return shall be increased only by the amount actually deducted
12 after any such limitations are applied.

13 24. For taxable years beginning after December 31, 2020, each
14 taxpayer shall be allowed a deduction for contributions to accounts
15 established pursuant to the Achieving a Better Life Experience
16 (ABLE) Program as established in Section 4001.1 et seq. of Title 56
17 of the Oklahoma Statutes. For any tax year, the deduction provided
18 for in this paragraph shall not exceed Ten Thousand Dollars
19 (\$10,000.00) for an individual taxpayer or Twenty Thousand Dollars
20 (\$20,000.00) for taxpayers filing a joint return. Any amount of
21 contribution not deducted by the taxpayer in the tax year for which
22 the contribution is made may be carried forward as a deduction from
23 income for up to five (5) tax years. Deductions may be taken for
24 contributions made during the tax year and through April 15 of the

1 succeeding tax year, or through the due date of a taxpayer's state
2 income tax return excluding extensions, whichever is later.

3 Provided, a deduction for the same contribution may not be taken in
4 more than one (1) tax year.

5 F. 1. For taxable years beginning after December 31, 2004, a
6 deduction from the Oklahoma adjusted gross income of any individual
7 taxpayer shall be allowed for qualifying gains receiving capital
8 treatment that are included in the federal adjusted gross income of
9 such individual taxpayer during the taxable year.

10 2. As used in this subsection:

11 a. "qualifying gains receiving capital treatment" means
12 the amount of net capital gains, as defined in Section
13 1222(11) of the Internal Revenue Code, included in an
14 individual taxpayer's federal income tax return that
15 result from:

16 (1) the sale of real property or tangible personal
17 property located within Oklahoma that has been
18 directly or indirectly owned by the individual
19 taxpayer for a holding period of at least five
20 (5) years prior to the date of the transaction
21 from which such net capital gains arise,

22 (2) the sale of stock or the sale of a direct or
23 indirect ownership interest in an Oklahoma
24 company, limited liability company, or

1 partnership where such stock or ownership
2 interest has been directly or indirectly owned by
3 the individual taxpayer for a holding period of
4 at least two (2) years prior to the date of the
5 transaction from which the net capital gains
6 arise, or

7 (3) the sale of real property, tangible personal
8 property or intangible personal property located
9 within Oklahoma as part of the sale of all or
10 substantially all of the assets of an Oklahoma
11 company, limited liability company, or
12 partnership or an Oklahoma proprietorship
13 business enterprise where such property has been
14 directly or indirectly owned by such entity or
15 business enterprise or owned by the owners of
16 such entity or business enterprise for a period
17 of at least two (2) years prior to the date of
18 the transaction from which the net capital gains
19 arise,

20 b. "holding period" means an uninterrupted period of
21 time. The holding period shall include any additional
22 period when the property was held by another
23 individual or entity, if such additional period is
24

1 included in the taxpayer's holding period for the
2 asset pursuant to the Internal Revenue Code,

3 c. "Oklahoma company," "limited liability company," or
4 "partnership" means an entity whose primary
5 headquarters have been located in Oklahoma for at
6 least three (3) uninterrupted years prior to the date
7 of the transaction from which the net capital gains
8 arise,

9 d. "direct" means the individual taxpayer directly owns
10 the asset,

11 e. "indirect" means the individual taxpayer owns an
12 interest in a pass-through entity (or chain of pass-
13 through entities) that sells the asset that gives rise
14 to the qualifying gains receiving capital treatment.

15 (1) With respect to sales of real property or
16 tangible personal property located within
17 Oklahoma, the deduction described in this
18 subsection shall not apply unless the pass-
19 through entity that makes the sale has held the
20 property for not less than five (5) uninterrupted
21 years prior to the date of the transaction that
22 created the capital gain, and each pass-through
23 entity included in the chain of ownership has
24 been a member, partner, or shareholder of the

1 pass-through entity in the tier immediately below
2 it for an uninterrupted period of not less than
3 five (5) years.

4 (2) With respect to sales of stock or ownership
5 interest in or sales of all or substantially all
6 of the assets of an Oklahoma company, limited
7 liability company, partnership or Oklahoma
8 proprietorship business enterprise, the deduction
9 described in this subsection shall not apply
10 unless the pass-through entity that makes the
11 sale has held the stock or ownership interest for
12 not less than two (2) uninterrupted years prior
13 to the date of the transaction that created the
14 capital gain, and each pass-through entity
15 included in the chain of ownership has been a
16 member, partner or shareholder of the pass-
17 through entity in the tier immediately below it
18 for an uninterrupted period of not less than two
19 (2) years. For purposes of this division,
20 uninterrupted ownership prior to July 1, 2007,
21 shall be included in the determination of the
22 required holding period prescribed by this
23 division, and
24

1 f. "Oklahoma proprietorship business enterprise" means a
2 business enterprise whose income and expenses have
3 been reported on Schedule C or F of an individual
4 taxpayer's federal income tax return, or any similar
5 successor schedule published by the Internal Revenue
6 Service and whose primary headquarters have been
7 located in Oklahoma for at least three (3)
8 uninterrupted years prior to the date of the
9 transaction from which the net capital gains arise.

10 G. 1. For purposes of computing its Oklahoma taxable income
11 under this section, the dividends-paid deduction otherwise allowed
12 by federal law in computing net income of a real estate investment
13 trust that is subject to federal income tax shall be added back in
14 computing the tax imposed by this state under this title if the real
15 estate investment trust is a captive real estate investment trust.

16 2. For purposes of computing its Oklahoma taxable income under
17 this section, a taxpayer shall add back otherwise deductible rents
18 and interest expenses paid to a captive real estate investment trust
19 that is not subject to the provisions of paragraph 1 of this
20 subsection. As used in this subsection:

21 a. the term "real estate investment trust" or "REIT"
22 means the meaning ascribed to such term in Section 856
23 of the Internal Revenue Code,
24

b. the term "captive real estate investment trust" means a real estate investment trust, the shares or beneficial interests of which are not regularly traded on an established securities market and more than fifty percent (50%) of the voting power or value of the beneficial interests or shares of which are owned or controlled, directly or indirectly, or constructively, by a single entity that is:

- (1) treated as an association taxable as a corporation under the Internal Revenue Code, and
- (2) not exempt from federal income tax pursuant to the provisions of Section 501(a) of the Internal Revenue Code.

The term shall not include a real estate investment trust that is intended to be regularly traded on an established securities market, and that satisfies the requirements of Section 856(a)(5) and (6) of the U.S. Internal Revenue Code by reason of Section 856(h)(2) of the Internal Revenue Code,

c. the term "association taxable as a corporation" shall not include the following entities:

- (1) any real estate investment trust as defined in paragraph a of this subsection other than a "captive real estate investment trust", ~~or~~

- 1 (2) any qualified real estate investment trust
2 subsidiary under Section 856(i) of the Internal
3 Revenue Code, other than a qualified REIT
4 subsidiary of a "captive real estate investment
5 trust", ~~or~~
- 6 (3) any Listed Australian Property Trust (meaning an
7 Australian unit trust registered as a "Managed
8 Investment Scheme" under the Australian
9 Corporations Act in which the principal class of
10 units is listed on a recognized stock exchange in
11 Australia and is regularly traded on an
12 established securities market), or an entity
13 organized as a trust, provided that a Listed
14 Australian Property Trust owns or controls,
15 directly or indirectly, seventy-five percent
16 (75%) or more of the voting power or value of the
17 beneficial interests or shares of such trust, or
- 18 (4) any Qualified Foreign Entity, meaning a
19 corporation, trust, association or partnership
20 organized outside the laws of the United States
21 and which satisfies the following criteria:
22 (a) at least seventy-five percent (75%) of the
23 entity's total asset value at the close of
24 its taxable year is represented by real

1 estate assets, as defined in Section
2 856(c)(5)(B) of the Internal Revenue Code,
3 thereby including shares or certificates of
4 beneficial interest in any real estate
5 investment trust, cash and cash equivalents,
6 and U.S. Government securities,

7 (b) the entity receives a dividend-paid
8 deduction comparable to Section 561 of the
9 Internal Revenue Code, or is exempt from
10 entity level tax,

11 (c) the entity is required to distribute at
12 least eighty-five percent (85%) of its
13 taxable income, as computed in the
14 jurisdiction in which it is organized, to
15 the holders of its shares or certificates of
16 beneficial interest on an annual basis,

17 (d) not more than ten percent (10%) of the
18 voting power or value in such entity is held
19 directly or indirectly or constructively by
20 a single entity or individual, or the shares
21 or beneficial interests of such entity are
22 regularly traded on an established
23 securities market, and
24

(e) the entity is organized in a country which
has a tax treaty with the United States.

3. For purposes of this subsection, the constructive ownership rules of Section 318(a) of the Internal Revenue Code, as modified by Section 856(d)(5) of the Internal Revenue Code, shall apply in determining the ownership of stock, assets, or net profits of any person.

4. A real estate investment trust that does not become regularly traded on an established securities market within one (1) year of the date on which it first becomes a real estate investment trust shall be deemed not to have been regularly traded on an established securities market, retroactive to the date it first became a real estate investment trust, and shall file an amended return reflecting such retroactive designation for any tax year or part year occurring during its initial year of status as a real estate investment trust. For purposes of this subsection, a real estate investment trust becomes a real estate investment trust on the first day it has both met the requirements of Section 856 of the Internal Revenue Code and has elected to be treated as a real estate investment trust pursuant to Section 856(c)(1) of the Internal Revenue Code.

SECTION 156. REPEALER 68 O.S. 2021, Section 2358, as amended by Section 1, Chapter 377, O.S.L. 2022 (68 O.S. Supp. 2023, Section 2358), is hereby repealed.

SECTION 157. AMENDATORY 68 O.S. 2021, Section 3604, as amended by Section 1, Chapter 360, O.S.L. 2023 (68 O.S. Supp. 2023, Section 3604), is amended to read as follows:

Section 3604. A. Except as otherwise provided in subsection I or subsection L of this section, an establishment which meets the qualifications specified in the Oklahoma Quality Jobs Program Act may receive quarterly incentive payments for a ten-year period from the Oklahoma Tax Commission pursuant to the provisions of the Oklahoma Quality Jobs Program Act; provided, such an establishment defined or classified in the NAICS Manual under U.S. Industry No. 711211 (2007 version) may receive quarterly incentive payments for a ~~thirty-year~~ thirty-year period. The amount of such payments shall be equal to the net benefit rate multiplied by the actual gross payroll of new direct jobs for a calendar quarter as verified by the Oklahoma Employment Security Commission. For an establishment defined or classified in the NAICS Manual under U.S. Industry No. 711211 (2007 version) that entered into a contract pursuant to the Oklahoma Quality Jobs Program Act with the Oklahoma Department of Commerce before the effective date of this act:

1. The contract shall be extended from fifteen (15) years to thirty (30) years; and

2. The extension shall not include additional money awarded but shall allow for payments to continue for the thirty-year period, or until the net benefit for the new direct jobs for the original

1 contract has been fully paid out as calculated based upon the
2 original application.

3 B. In order to receive incentive payments, an establishment
4 shall apply to the Oklahoma Department of Commerce. The application
5 shall be on a form prescribed by the Department and shall contain
6 such information as may be required by the Department to determine
7 if the applicant is qualified. An establishment may apply for an
8 effective date for a project, which shall not be more than twenty-
9 four (24) months from the date the application is submitted to the
10 Department.

11 C. Except as otherwise provided by subsection D or E of this
12 section, in order to qualify to receive such payments, the
13 establishment applying shall be required to:

14 1. Be engaged in a basic industry;

15 2. Have an annual gross payroll for new direct jobs projected
16 by the Department to equal or exceed Two Million Five Hundred
17 Thousand Dollars (\$2,500,000.00) within three (3) years of the first
18 complete calendar quarter following the start date; and

19 3. Have a number of full-time-equivalent employees subject to
20 the tax imposed by Section 2355 of this title and working an annual
21 average of thirty (30) or more hours per week in new direct jobs
22 located in this state equal to or in excess of eighty percent (80%)
23 of the total number of new direct jobs.

1 D. In order to qualify to receive incentive payments as
2 authorized by the Oklahoma Quality Jobs Program Act, an
3 establishment engaged in an activity described under:

4 1. Industry Group Nos. 3111 through 3119 of the NAICS Manual
5 shall be required to:

- 6 a. have an annual gross payroll for new direct jobs
7 projected by the Department to equal or exceed One
8 Million Five Hundred Thousand Dollars (\$1,500,000.00)
9 within three (3) years of the first complete calendar
10 quarter following the start date and make, or which
11 will make within one (1) year, at least seventy-five
12 percent (75%) of its total sales, as determined by the
13 Incentive Approval Committee pursuant to the
14 provisions of subsection B of Section 3603 of this
15 title, to out-of-state customers or buyers, to in-
16 state customers or buyers if the product or service is
17 resold by the purchaser to an out-of-state customer or
18 buyer for ultimate use, or to the federal government,
19 unless the annual gross payroll equals or exceeds Two
20 Million Five Hundred Thousand Dollars (\$2,500,000.00)
21 in which case the requirements for purchase of output
22 provided by this subparagraph shall not apply, and
23 b. have a number of full-time-equivalent employees
24 working an average of thirty (30) or more hours per

1 week in new direct jobs equal to or in excess of
2 eighty percent (80%) of the total number of new direct
3 jobs; and

4 2. Division (4) of subparagraph a of paragraph 1 of subsection
5 A of Section 3603 of this title, shall be required to:

- 6 a. have an annual gross payroll for new direct jobs
7 projected by the Department to equal or exceed One
8 Million Five Hundred Thousand Dollars (\$1,500,000.00)
9 within three (3) years of the first complete calendar
10 quarter following the start date, and
11 b. have a number of full-time-equivalent employees
12 working an average of thirty (30) or more hours per
13 week in new direct jobs equal to or in excess of
14 eighty percent (80%) of the total number of new direct
15 jobs.

16 E. 1. An establishment which locates its principal business
17 activity within a site consisting of at least ten (10) acres which:

- 18 a. is a federal Superfund removal site,
19 b. is listed on the National Priorities List established
20 under Section 9605 of Title 42 of the United States
21 Code,
22 c. has been formally deferred to the state in lieu of
23 listing on the National Priorities List, or
24

1 d. has been determined by the Department of Environmental
2 Quality to be contaminated by any substance regulated
3 by a federal or state statute governing environmental
4 conditions for real property pursuant to an order of
5 the Department of Environmental Quality,

6 shall qualify for incentive payments irrespective of its actual
7 gross payroll or the number of full-time-equivalent employees
8 engaged in new direct jobs.

9 2. In order to qualify for the incentive payments pursuant to
10 this subsection, the establishment shall conduct the activity
11 resulting in at least fifty percent (50%) of its Oklahoma taxable
12 income or adjusted gross income, as determined under Section 2358 of
13 this title, whether from the sale of products or services or both
14 products and services, at the physical location which has been
15 determined not to comply with the federal or state statutes
16 described in this subsection with respect to environmental
17 conditions for real property. The establishment shall be subject to
18 all other requirements of the Oklahoma Quality Jobs Program Act
19 other than the exemptions provided by this subsection.

20 3. In order to qualify for the incentive payments pursuant to
21 this subsection, the entity shall obtain from the Department of
22 Environmental Quality a letter of concurrence that:
23
24

1 a. the site designated by the entity does meet one or
2 more of the requirements listed in paragraph 1 of this
3 subsection, and

4 b. the site is being or has been remediated to a level
5 which is consistent with the intended use of the
6 property.

7 In making its determination, the Department of Environmental
8 Quality may rely on existing data and information available to it,
9 but may also require the applying entity to provide additional data
10 and information, as necessary.

11 4. If authorized by the Department of Environmental Quality
12 pursuant to paragraph 3 of this subsection, the entity may utilize a
13 remediated portion of the property for its intended purpose prior to
14 remediation of the remainder of the site, and shall qualify for
15 incentive payments based on employment associated with the portion
16 of the site.

17 F. Except as otherwise provided by subsection G of this
18 section, for applications submitted on and after June 4, 2003, in
19 order to qualify to receive incentive payments as authorized by the
20 Oklahoma Quality Jobs Program Act, in addition to other
21 qualifications specified herein, an establishment shall be required
22 to pay new direct jobs an average annualized wage which equals or
23 exceeds:

1 1. One hundred ten percent (110%) of the average county wage as
2 determined by the Department of Commerce based on the most recent
3 U.S. Department of Commerce data for the county in which the new
4 direct jobs are located. For purposes of this paragraph, health
5 care premiums paid by the applicant for individuals in new direct
6 jobs shall be included in the annualized wage; or

7 2. One hundred percent (100%) of the average county wage as
8 that percentage is determined by the Department of Commerce based
9 upon the most recent U.S. Department of Commerce data for the county
10 in which the new jobs are located. For purposes of this paragraph,
11 health care premiums paid by the applicant for individuals in new
12 direct jobs shall not be included in the annualized wage.

13 Provided, no average wage requirement shall exceed Twenty-five
14 Thousand Dollars (\$25,000.00), in any county. This maximum wage
15 threshold shall be indexed and modified from time to time based on
16 the latest Consumer Price Index year-to-date percent change release
17 as of the date of the annual average county wage data release from
18 the Bureau of Economic Analysis of the U.S. Department of Commerce.

19 G. 1. As used in this subsection, "opportunity zone" means one
20 or more census tracts in which, according to the most recent Federal
21 Decennial Census, at least thirty percent (30%) of the residents
22 have annual gross household incomes from all sources below the
23 poverty guidelines established by the U.S. Department of Health and
24 Human Services. An establishment which is otherwise qualified to

1 receive incentive payments and which locates its principal business
2 activity in an opportunity zone shall not be subject to the
3 requirements of subsection F of this section.

4 2. As used in this subsection:

5 a. "negative economic event" means:

6 (1) a man-made disaster or natural disaster as
7 defined in Section 683.3 of Title 63 of the
8 Oklahoma Statutes, resulting in the loss of a
9 significant number of jobs within a particular
10 county of this state, or

11 (2) an economic circumstance in which a significant
12 number of jobs within a particular county of this
13 state have been lost due to an establishment
14 changing its structure, consolidating with
15 another establishment, closing or moving all or
16 part of its operations out of this state, and

17 b. "significant number of jobs" means Local Area
18 Unemployment Statistics (LAUS) data, as determined by
19 the Bureau of Labor Statistics, for a county which are
20 equal to or in excess of five percent (5%) of the
21 total amount of Local Area Unemployment Statistics
22 (LAUS) data for that county for the calendar year, or
23 most recent twelve-month period in which employment is
24 measured, preceding the event.

1 An establishment which is otherwise qualified to receive
2 incentive payments and which locates in a county in which a negative
3 economic event has occurred within the eighteen-month period
4 preceding the start date shall not be subject to the requirements of
5 subsection F of this section; provided, an establishment shall not
6 be eligible to receive incentive payments based upon a negative
7 economic event with respect to jobs that are transferred from one
8 county of this state to another.

9 H. The Department shall determine if the applicant is qualified
10 to receive incentive payments.

11 I. If the applicant is determined to be qualified by the
12 Department and is not subject to the provisions of subparagraph d of
13 paragraph 7 of subsection A of Section 3603 of this title, the
14 Department shall conduct a cost/benefit analysis to determine the
15 estimated net direct state benefits and the net benefit rate
16 applicable for a ten-year period beginning with the first complete
17 calendar quarter following the start date and to estimate the amount
18 of gross payroll for a ten-year period beginning with the first
19 complete calendar quarter following the start date or for a thirty-
20 year period for an establishment defined or classified in the NAICS
21 Manual under U.S. Industry No. 711211 (2007 version). In conducting
22 such cost/benefit analysis, the Department shall consider
23 quantitative factors, such as the anticipated level of new tax
24 revenues to the state along with the added cost to the state of

1 providing services, and such other criteria as deemed appropriate by
2 the Department. In no event shall incentive payments, cumulatively,
3 exceed the estimated net direct state benefits, except for
4 applicants subject to the provisions of subparagraph d of paragraph
5 7 of subsection A of Section 3603 of this title.

6 J. Upon approval of such an application, the Department shall
7 notify the Tax Commission and shall provide it with a copy of the
8 contract and the results of the cost/benefit analysis. The Tax
9 Commission may require the qualified establishment to submit such
10 additional information as may be necessary to administer the
11 provisions of the Oklahoma Quality Jobs Program Act. The approved
12 establishment shall file quarterly claims with the Tax Commission
13 and shall continue to file such quarterly claims during the ten-year
14 incentive period to show its continued eligibility for incentive
15 payments, as provided in Section 3606 of this title, or until it is
16 no longer qualified to receive incentive payments. The
17 establishment may be audited by the Tax Commission to verify such
18 eligibility. Once the establishment is approved, an agreement shall
19 be deemed to exist between the establishment and the State of
20 Oklahoma, requiring the continued incentive payment to be made as
21 long as the establishment retains its eligibility as defined in and
22 established pursuant to this section and Sections 3603 and 3606 of
23 this title and within the limitations contained in the Oklahoma
24 Quality Jobs Program Act, which existed at the time of such

1 approval. An establishment described in this subsection shall be
2 required to repay all incentive payments received under the Oklahoma
3 Quality Jobs Program Act if the establishment is determined by the
4 Oklahoma Tax Commission to no longer have business operations in the
5 state within three (3) years from the beginning of the calendar
6 quarter for which the first incentive payment claim is filed.

7 K. A municipality with a population of less than one hundred
8 thousand (100,000) persons in which an establishment eligible to
9 receive quarterly incentive payments pursuant to the provisions of
10 this section is located may file a claim with the Tax Commission for
11 up to twenty-five percent (25%) of the amount of such payment. The
12 amount of such claim shall not exceed amounts paid by the
13 municipality for direct costs of municipal infrastructure
14 improvements to provide water and sewer service to the
15 establishment. Such claim shall not be approved by the Tax
16 Commission unless the municipality and the establishment have
17 entered into a written agreement for such claims to be filed by the
18 municipality prior to submission of the application of the
19 establishment pursuant to the provisions of this section. If such
20 claim is approved, the amount of the payment to the establishment
21 made pursuant to the provisions of Section 3606 of this title shall
22 be reduced by the amount of the approved claim by the municipality
23 and the Tax Commission shall issue a warrant to the municipality in
24

1 the amount of the approved claim in the same manner as warrants are
2 issued to qualifying establishments.

3 L. For any contract executed by an establishment on or after
4 August 2, 2018, five percent (5%) of the quarterly incentive payment
5 amount shall be transferred by the Oklahoma Tax Commission to the
6 Oklahoma Quick Action Closing Fund.

7 SECTION 158. REPEALER 68 O.S. 2021, Section 3604, as

12 2023, Section 3635), is amended to read as follows:

13 Section 3635. A. Subject to the final approval of the
14 eligibility application by the Oklahoma Department of Commerce, a
15 requirement that the incentive payments made pursuant to the
16 provisions of the Filmed in Oklahoma Act of 2021 achieve the maximum
17 positive impact for the Oklahoma economy and subject to the Oklahoma
18 workforce requirements of Section 3637 of this title, the base
19 incentive amount for a project filmed in this state, not including
20 above-the-line personnel, shall be a maximum of thirty percent (30%)
21 of the qualified production expenditure amount. An incentive for a
22 project filmed in this state for wages paid to nonresident crew, not
23 including above-the-line personnel, shall be provided in the amount
24 of seven and one-half percent (7.5%) for wages paid before April 1,

1 2023, and twenty percent (20%) for wages paid on or after April 1,
2 2023.

3 B. In addition to the amount authorized by subsection A of this
4 section, there may be an additional incentive amount, subject to the
5 final approval of the Oklahoma Department of Commerce, in the
6 maximum amount of:

7 1. Three percent (3%) of the qualified production expenditure
8 amount for projects where at least twenty-five percent (25%) of main
9 crew principal photography days are filmed on location, excluding
10 sound stage production, in any county of this state if the county
11 has a population of less than two hundred fifty thousand (250,000)
12 persons according to the Federal Decennial Census or most recent
13 population estimate;

14 2. Two percent (2%) of the qualified production expenditure
15 amount for projects whose hub location, as determined by the
16 Department, is ~~or~~ for projects where at least twenty-five percent
17 (25%) of main crew principal photography days are filmed on
18 location, excluding sound stage production, in a municipality having
19 a population of twenty-five thousand (25,000) or fewer persons
20 according to the Federal Decennial Census or most recent population
21 estimate regardless of the county in which the municipality is
22 located or partially located;

23 3. Five percent (5%) of the qualified production expenditure
24 amount for soundstage expenditures if at least twenty-five percent

(25%) of main crew principal photography days are filmed at a qualified soundstage facility;

4. For eligible television series as defined in paragraph 4 of Section 3632 of this title:

a. two percent (2%) of the qualified production expenditure amount for an eligible television episodic pilot, and

b. five percent (5%) of the qualified production expenditure amount if a television series is filmed for one or more seasons;

5. Five percent (5%) of the qualified production expenditure amount for an eligible multi-film deal as defined in paragraph 7 of Section 3632 of this title;

6. On or after July 1, 2023, two percent (2%) of the qualified production expenditure amount for the post-production expenses of:

a. music production, recording, mixing, or composition, or

b. licensing of Oklahoma music; and

7. Three percent (3%) of the qualified production expenditure amount based on expenditures paid to Oklahoma vendors for post-production expenses with a minimum expenditure of three percent (3%) of Oklahoma production expenditures. Post-production expenditures include but are not limited to the following categories:

a. sound recording or mixing,

- b. color grading,
- c. editorial work,
- d. visual effects,
- e. animation,
- f. deliverables, excluding marketing and advertising,
- g. editing equipment or editing facility rental,
- h. color grading or digital intermediate processing,
- i. audio post-production processes including Foley artist processes or services, and
- j. graphics, including but not limited to the GFX system.

C. Notwithstanding any other provisions of this section or the provisions of the Filmed in Oklahoma Act of 2021 to the contrary, in no case shall the total incentive payments authorized by this section exceed thirty percent (30%) of the otherwise qualified production expenditure amount. The incentive payment amount prescribed by subsection A of this section may be used in any combination with the additional incentive amounts authorized by subsection B of this section, but the combination of the incentive amounts shall not exceed thirty percent (30%).

4 SECTION 162. AMENDATORY 70 O.S. 2021, Section 6-122.3,
5 as amended by Section 1, Chapter 121, O.S.L. 2022 (70 O.S. Supp.
6 2023, Section 6-122.3), is amended to read as follows:

7 Section 6-122.3. A. The State Board of Education shall grant
8 an alternative placement teaching certificate to a person who makes
9 application to the Board and meets the following criteria:

- 10 1. a. holds at least a baccalaureate degree from an
11 institution whose accreditation is recognized by the
12 Oklahoma State Regents for Higher Education and has
13 attained a retention grade point average of not less
14 than 2.50 on a 4.0 scale, or
- 15 b. has successfully completed a terminal degree, such as
16 a doctorate of philosophy, a doctorate in education,
17 professional doctorates, a master of fine arts degree
18 or a master of library science degree, from an
19 institution accredited by a national or regional
20 accrediting agency which is recognized by the
21 Secretary of the United States Department of
22 Education. The Oklahoma State Regents for Higher
23 Education shall be consulted to verify other terminal
24 degrees, or

1 c. holds at least a baccalaureate degree from an
2 institution whose accreditation is recognized by the
3 Oklahoma State Regents for Higher Education and has
4 qualified work experience in a field that corresponds
5 to an area of certification as determined by the State
6 Board of Education, and

7 d. in addition to the requirements of subparagraphs a, b
8 and c of this paragraph, has demonstrated competency
9 or completed a major in a field that corresponds to an
10 area of specialization for an Elementary-Secondary
11 Certificate or a Secondary Certificate as determined
12 by the State Board of Education or a vocational-
13 technical certificate as recommended by the Oklahoma
14 Department of Career and Technology Education;

15 2. Declares the intention to earn standard certification by
16 means of an alternative placement program in not more than three (3)
17 years. The State Board of Education shall determine the subject
18 matter and the number of clock or semester hours required for the
19 professional education component for each person making application
20 for an alternative placement teaching certificate based on the
21 criteria of paragraph 1 of this subsection.

22 The State Board of Education shall establish a core minimum of
23 six (6) semester hours or ninety (90) clock hours and a maximum of
24

1 eight (18) semester hours or two hundred seventy (270) clock
2 hours for the professional education component.

3 The requirements set forth in this subsection shall exclude all
4 student teaching requirements pursuant to the provisions of
5 subsection E of this section;

6 3. Has passed the ~~general education and subject area portions~~
7 portion of the competency examination required in Section 6-187 of
8 this title in the area of specialization for which certification is
9 sought; and

10 4. Either presents a document from an accredited public school
11 district in this state offering employment in the area of
12 specialization for which certification is sought on condition that
13 the person enroll in an alternative placement program approved by
14 the State Board of Education or declares the intention to seek
15 employment as a teacher at an accredited public school district in
16 this state. The certificate granted pursuant to this subsection
17 shall be considered a "valid certificate of qualification" for the
18 purposes of Sections 6-107 and 6-108 of this title, and the holder
19 of the certificate shall be considered an inductee for the purposes
20 of Section 6-195 of this title.

21 B. An alternative placement teaching certificate shall be
22 renewed for not more than a maximum of three (3) years upon
23 presentation of a document from an accredited public school district
24 in this state offering renewed employment in the same area of

1 specialization and a document from a teacher education institution
2 verifying satisfactory progress in an appropriate alternative
3 placement program.

4 C. Persons enrolled in an alternative placement program shall:

5 1. Have never been denied admittance to a teacher education
6 program approved by the Oklahoma State Regents for Higher Education,
7 the North Central Association of Colleges and Schools and by the
8 Oklahoma Commission for Teacher Preparation to offer teacher
9 education programs, nor have enrolled in and subsequently failed
10 courses necessary to successfully meet the minimum requirements of
11 the program, except those persons who hold a certificate;

12 2. Have on file with the director of teacher education at an
13 Oklahoma institution of higher education a plan for meeting standard
14 certification requirements within three (3) years; and

15 3. Participate in an induction program as required in Section
16 6-195 of this title and have the same duties and responsibilities as
17 other inductees.

18 D. The State Board of Education may grant an exception to the
19 requirements for certification and, upon demonstration by an
20 individual of specific competency in the subject area of
21 specialization, may grant a certificate to the individual. The
22 State Board may establish other requirements necessary to grant
23 exceptions.

1 E. The State Board of Education, in consultation with the
2 Commission for Educational Quality and Accountability, may grant an
3 exception to the requirement to complete a subject area examination
4 for initial certification in a field which does not require an
5 advanced degree pursuant to this section if the candidate has an
6 advanced degree in a subject that is substantially comparable to the
7 content assessed on a subject area examination. The degree shall be
8 from an institution accredited by a national or regional accrediting
9 agency which is recognized by the Secretary of the U.S. Department
10 of Education. The Commission shall provide the Board with the
11 necessary information to determine comparability.

12 F. Student teaching and a prestudent teaching field experience
13 shall not be required of alternative placement program participants
14 for standard certification.

15 G. The State Board of Education shall promulgate rules
16 authorizing adjunct teachers who shall be persons with distinguished
17 qualifications in their field. Adjunct teachers shall not be
18 required to meet standard certification. A person employed as an
19 adjunct teacher pursuant to this subsection who does not hold a
20 valid certificate to teach shall not be considered a teacher as
21 defined by Section 1-116 of this title.

22 H. Each teacher education institution shall provide the
23 Oklahoma Commission for Teacher Preparation an annual report of
24

1 information as specified by the Commission regarding participation
2 in the alternative placement programs offered by the institution.

3 I. The Oklahoma Commission for Teacher Preparation shall not
4 accredit, renew the accreditation of, or otherwise approve any
5 teacher education program of any institution of higher education in
6 this state that has not implemented alternative placement programs
7 in at least four areas of specialization including mathematics,
8 science and a foreign language. Each institution shall allow
9 individuals who meet the criteria of subsections A and C of this
10 section to be:

11 1. Admitted to an alternative placement program without further
12 qualification; and

13 2. Offered the opportunity to complete the requirements for
14 standard certification set forth in subsection A of this section
15 during the summer preceding and the summer following the first year
16 of teaching with an alternative placement teaching certificate. Any
17 person seeking standard certification through an alternative
18 placement program shall be permitted to take necessary courses
19 during regular semesters if offered.

20 J. The criteria specified in subsection I of this section can
21 be met through a cooperative arrangement entered into by two or more
22 institutions of higher education.

SECTION 164. AMENDATORY 70 O.S. 2021, Section 6-187, as amended by Section 49, Chapter 228, O.S.L. 2022 (70 O.S. Supp. 2023, Section 6-187), is amended to read as follows:

Section 6-187. A. Prior to July 1, 2014, a competency examination shall be adopted by the Oklahoma Commission for Teacher Preparation and beginning July 1, 2014, a competency examination shall be adopted by the Commission for Educational Quality and Accountability for the ~~general education~~, professional education and various subject areas and grade levels for purposes of ensuring academic achievement and competency of each teacher candidate or teacher in the subject area the person is seeking certification to teach which shall also include certification as an administrator, as prescribed by the State Board of Education.

The Commission, consistent with the purposes of this section, shall promulgate rules and procedures to guarantee the confidentiality of examinations.

B. No teacher candidate shall be eligible for certification until successfully completing the competency examination except those candidates who make application to the State Board and meet the criteria for the alternative placement program pursuant to Section 6-122.3 of this title. Certification shall be limited to

1 areas of approval in which the certified teacher has successfully
2 completed the examination. Subject to the provisions of subsection
3 C of this section, testing for certification for subjects in which a
4 teacher candidate or teacher is seeking a minor teaching assignment
5 or an endorsement to teach shall be limited to the specific subject
6 area test.

7 A teacher candidate or teacher may take the ~~general education~~,
8 professional education or subject area portions of the examination
9 subject to any limit imposed by the Commission.

10 C. 1. Except as otherwise provided for in this subsection, a
11 teacher may be certified in as many areas as the teacher meets the
12 necessary requirements provided by law and has successfully
13 completed the subject area portion of the examination.

14 2. Except as otherwise provided for in this paragraph,
15 certification in early childhood, elementary, or special education
16 shall require completion of an appropriate teacher education program
17 approved by the Commission.

18 Any teacher who is certified to teach elementary education may
19 be certified in early childhood education upon meeting the
20 requirements provided in law and successful completion of the
21 appropriate subject area portion of the examination. Any teacher
22 who is certified to teach early childhood education may be certified
23 in elementary education upon meeting the requirements provided in
24 law and successful completion of the appropriate subject area

1 portion of the examination. Any special education teacher who
2 becomes certified to teach through completion of an accredited
3 teacher preparation program may be certified in early childhood or
4 elementary education upon meeting the requirements provided in law
5 and successful completion of the appropriate subject portion of the
6 examination. Any teacher who becomes certified to teach through
7 completion of an accredited teacher preparation program or becomes
8 alternatively certified to teach through the Troops to Teachers
9 program may be certified in special education upon meeting the
10 requirements provided in law and successful completion of the
11 appropriate subject area portion of the examination. Any special
12 education teacher who has not completed a Commission-approved
13 teacher education program in elementary education or early childhood
14 education but who has successfully completed the subject area
15 portion of the examination may be certified in elementary education
16 or early childhood education for the purpose of providing direct
17 instruction and serving as the teacher of record for grading
18 purposes in special education settings only.

19 D. The Commission shall offer the competency examination at
20 least four times per calendar year on dates to be established by the
21 Commission.

22 E. If a teacher candidate or teacher is a non-native-English
23 speaker, the Commission shall offer the subject area competency
24 examination in the native language of the teacher candidate or

1 teacher only if the teacher candidate or teacher is employed or has
2 been offered employment by a school district as a teacher in a
3 foreign language immersion program offered by the school district.
4 If a non-native-English speaker who has received certification in a
5 subject area after taking the subject area competency examination in
6 the native language of the speaker seeks to add a certification area
7 in the future and that person is no longer employed as a teacher in
8 a foreign language immersion program, the examination for the
9 additional certification area shall be taken in English. The State
10 Board of Education shall issue a restricted license or certificate
11 to any teacher who has completed a subject area competency
12 examination in the native language of the teacher as provided for in
13 this subsection restricting the teacher to teaching only in a
14 foreign language immersion program.

15 F. The State Board of Education, in consultation with the
16 Commission for Educational Quality and Accountability, may grant an
17 exception to the requirement to complete a subject area examination
18 for initial certification in a field which does not require an
19 advanced degree if the candidate has an advanced degree in a subject
20 that is substantially comparable to the content assessed on a
21 subject area examination. The advanced degree shall be from an
22 institution accredited by a national or regional accrediting agency
23 which is recognized by the Secretary of the United States Department
24

1 of Education. The Commission shall provide the Board with the
2 necessary information to determine comparability.

3 G. 1. Nothing in the Oklahoma Teacher Preparation Act shall
4 restrict the right of the State Board of Education to issue an
5 emergency or provisional certificate, as needed. Provided, however,
6 prior to the issuance of an emergency certificate, the district
7 shall document substantial efforts to employ a teacher who holds a
8 provisional or standard certificate. In the event a district is
9 unable to hire an individual meeting this criteria, the district
10 shall document efforts to employ an individual with a provisional or
11 standard certificate in another curricular area with academic
12 preparation in the field of need. Only after these alternatives
13 have been exhausted shall the district be allowed to employ an
14 individual meeting minimum standards as established by the State
15 Board of Education for the issuance of emergency certificates.

16 2. The State Board of Education may renew the emergency or
17 provisional certificate of an individual who has been employed by a
18 school district board of education for at least two (2) years if the
19 following criteria are met:

- 20 a. the individual has been granted an emergency or
21 provisional certificate pursuant to paragraph 1 of
22 this subsection for two (2) years,
23 b. the individual has not successfully completed the
24 competency examinations required by this section,

- c. the individual submits a portfolio of his or her work to the State Board of Education, which shall include evidence of progress toward standard certification,
- d. the employing school district board of education agrees to renew the individual's contract to teach for the ensuing fiscal year, and
- e. the superintendent of the employing school district submits to the State Board of Education the reason the emergency or provisional certificate should be renewed and provides evidence of the district's inability to hire a teacher who holds a standard certificate.

3. Individuals employed by a school district under an emergency or provisional certificate shall not be considered career teachers and therefore not entitled to the protections of the Teacher Due Process Act of 1990.

H. The State Board of Education may grant an exception to the requirements for all certification examinations for teacher candidates who are "deaf", which for the purposes of this section shall mean having a hearing loss so severe that the person cannot process auditory linguistic information with or without accommodation and whose primary language and teaching environment is American Sign Language. The Board may grant an exception upon:

- 1 1. Verification by a licensed audiologist of a hearing loss so
- 2 severe that the teacher candidate cannot process auditory linguistic
- 3 information with or without accommodation;
- 4 2. Demonstration of fluency in American Sign Language;
- 5 3. Demonstration of competency in the subject area of
- 6 specialization as approved by the Board in lieu of certification
- 7 examinations; and
- 8 4. Sponsorship by a certified deaf education teacher for a
- 9 mentorship program.

10 The Board may promulgate rules and other requirements as
11 necessary to grant the exceptions described in this subsection.
12 Applicable teaching environments may include American Sign Language
13 immersion programs, the Oklahoma School for the Deaf, programs for
14 the deaf or other classroom settings in which American Sign Language
15 is the language of instruction.

16 SECTION 165. REPEALER 70 O.S. 2021, Section 6-187, as
17 last amended by Section 4, Chapter 220, O.S.L. 2022 (70 O.S. Supp.
18 2023, Section 6-187), is hereby repealed.

19 SECTION 166. AMENDATORY 70 O.S. 2021, Section 11-103.6,
20 as last amended by Section 1, Chapter 9, O.S.L. 2023 (70 O.S. Supp.
21 2023, Section 11-103.6), is amended to read as follows:

22 Section 11-103.6. A. 1. The State Board of Education shall
23 adopt subject matter standards for instruction of students in the
24 public schools of this state that are necessary to ensure there is

1 attainment of desired levels of competencies in a variety of areas
2 to include language, mathematics, science, social studies,
3 communication, and health and physical education.

4 2. School districts shall develop and implement curriculum,
5 courses and instruction in order to ensure that students meet the
6 skills and competencies as set forth in this section and in the
7 subject matter standards adopted by the State Board of Education.

8 3. All students shall gain literacy at the elementary and
9 secondary levels. Students shall develop skills in reading,
10 writing, speaking, computing and critical thinking. For purposes of
11 this section, critical thinking means a manner of analytical
12 thinking which is logical and uses linear factual analysis to reach
13 a conclusion. They shall learn about cultures and environments -
14 their own and those of others with whom they share the earth. All
15 students shall receive the instruction needed to lead healthy and
16 physically active lifestyles. Students, therefore, shall study
17 social studies, literature, languages, the arts, health, mathematics
18 and science. Such curricula shall provide for the teaching of a
19 hands-on career exploration program in cooperation with technology
20 center schools.

21 4. The subject matter standards shall be designed to teach the
22 competencies for which students shall be tested as provided in
23 Section 1210.508 of this title, and shall be designed to prepare all
24 students for active citizenship, employment and/or successful

1 completion of postsecondary education without the need for remedial
2 coursework at the postsecondary level.

3 5. The subject matter standards shall be designed with rigor as
4 defined in paragraph 3 of subsection G of this section.

5 6. The subject matter standards for English Language Arts shall
6 give Classic Literature and nonfiction literature equal
7 consideration to other literature. In addition, emphasis shall be
8 given to the study of complete works of literature.

9 7. At a minimum, the subject matter standards for mathematics
10 shall require mastery of the standard algorithms in mathematics,
11 which is the most logical, efficient way of solving a problem that
12 consistently works, and for students to attain fluency in Euclidian
13 geometry.

14 8. The subject matter standards for history, social studies and
15 United States Government shall include study of important historical
16 documents, including the United States Constitution, Declaration of
17 Independence, Emancipation Proclamation, Federalist Papers and other
18 documents with significant history and heritage of the United
19 States, and the content of the United States naturalization test,
20 with an emphasis on the specific content of the test and the ideas
21 and concepts it references. Beginning with the 2022-2023 school
22 year, the United States naturalization test shall be administered in
23 accordance with subsection F of this section.

1 9. The subject matter standards for United States Government
2 shall include an emphasis on civics, the structure and relationship
3 between the national, state, county and local governments and
4 simulations of the democratic process. For the purposes of this
5 section, "civics" means the study of the rights and duties of
6 Oklahoma and United States citizens and of how those governments
7 work.

8 10. The subject matter standards for health and physical
9 education shall include but not be limited to the domains of
10 physical, emotional, social and intellectual health. Health
11 literacy shall include the ability to obtain, process and understand
12 basic health information and services needed to make appropriate
13 health decisions. Health shall also include the importance of
14 proper nutrition and exercise, mental health and wellness, substance
15 abuse, coping skills for understanding and managing trauma,
16 establishing and maintaining positive relationships and responsible
17 decision making. Physical literacy shall include the ability to
18 move with competence and confidence in a wide variety of physical
19 activities in multiple environments that benefit the healthy
20 development of the whole person.

21 B. Subject to the provisions of subsection C of this section,
22 in order to graduate from a public high school accredited by the
23 State Board of Education with a standard diploma, students shall
24

complete the following college preparatory/work ready curriculum units or sets of competencies at the secondary level:

1. Four units or sets of competencies of English to include Grammar, Composition, Literature, or any English course approved for college admission requirements;

2. Three units or sets of competencies of mathematics, limited to Algebra I, Algebra II, Geometry, Trigonometry, Math Analysis, Calculus, Advanced Placement Statistics, or any mathematics course with content and/or rigor above Algebra I and approved for college admission requirements;

3. Three units or sets of competencies of laboratory science approved for college admission requirements including one unit or set of competencies of life science meeting the standards for Biology I; one unit or set of competencies of physical science, meeting the standards for Physical Science, Chemistry or Physics; and one unit or set of competencies from the domains of physical science, life science or earth and space science such that the content and rigor is above Biology I or Physical Science;

4. Three units or sets of competencies of history and citizenship skills, including one unit of American History, one-half unit of Oklahoma History, one-half unit of United States Government and one unit from the subjects of History, Government, Geography, Economics, Civics, or non-Western culture and approved for college admission requirements;

1 5. Two units or sets of competencies of the same world or non-
2 English language or two units of computer technology approved for
3 college admission requirements, whether taught at a high school or a
4 technology center school, including computer programming, hardware,
5 and business computer applications, such as word processing,
6 databases, spreadsheets, and graphics, excluding keyboarding or
7 typing courses;

8 6. One additional unit or set of competencies selected from
9 paragraphs 1 through 5 of this subsection or career and technology
10 education courses, concurrently enrolled courses, ~~Advanced Placement~~
11 advanced placement courses, or International Baccalaureate courses
12 approved for college admission requirements; and

13 7. One unit or set of competencies of fine arts, such as music,
14 art, or drama, or one unit or set of competencies of speech.

15 C. In lieu of the requirements of subsection B of this section
16 which requires a college preparatory/work ready curriculum, a
17 student may enroll in the core curriculum as provided in subsection
18 D of this section upon written approval of the parent or legal
19 guardian of the student. For students under the age of eighteen
20 (18) school districts shall require a parent or legal guardian of
21 the student to meet with a designee of the school prior to
22 enrollment in the core curriculum. The State Department of
23 Education shall develop and distribute to school districts a form
24 suitable for this purpose, which shall include information on the

benefits to students of completing the college preparatory/work ready curriculum as provided for in subsection B of this section.

D. For those students subject to the requirements of subsection C of this section, in order to graduate from a public high school accredited by the State Board of Education with a standard diploma, students shall complete the following core curriculum units or sets of competencies at the secondary level:

1. Language Arts - Four units or sets of competencies, to consist of one unit or set of competencies of grammar and composition, and three units or sets of competencies which may include, but are not limited to, the following courses:

- a. American Literature,
- b. English Literature,
- c. World Literature,
- d. Advanced English Courses, or
- e. other English courses with content and/or rigor equal to or above grammar and composition;

2. Mathematics - Three units or sets of competencies to consist of one unit or set of competencies of Algebra I or Algebra I taught in a contextual methodology, and two units or sets of competencies which may include, but are not limited to, the following courses:

- a. Algebra II,
- b. Geometry or Geometry taught in a contextual methodology,

- c. Trigonometry,
- d. Math Analysis or Precalculus,
- e. Calculus,
- f. Statistics and/or Probability,
- g. Computer Science or acceptance and successful completion of one (1) year of a full-time, three-hour career and technology program leading to an industry credential/certificate or college credit. The State Board of Career and Technology Education shall promulgate rules to define the provisions of this section related to the accepted industry-valued credentials which are industry-endorsed or industry-aligned. The list of accepted industry-valued credentials shall be reviewed annually and updated at least every three (3) years by the Board,
- h.
 - (1) contextual mathematics courses which enhance technology preparation, or

6 the law regarding such subject matter;

7 19. To convene multicounty grand juries in such manner and for
8 such purposes as provided by law; provided, such grand juries are
9 composed of citizens from each of the counties on a pro rata basis
10 by county;

11 20. To investigate any report by the State Auditor and
12 Inspector filed with the Attorney General pursuant to Section 223 of
13 this title and prosecute all actions, civil or criminal, relating to
14 such reports or any irregularities or derelictions in the management
15 of public funds or property which are violations of the laws of this
16 state;

17 21. To represent and protect the collective interests of all
18 utility consumers of this state in rate-related proceedings before
19 the Corporation Commission or in any other state or federal judicial
20 or administrative proceeding;

21 22. To represent and protect the collective interests of
22 insurance consumers of this state in rate-related proceedings before
23 the Insurance Commissioner or in any other state or federal judicial
24 or administrative proceeding;

1 23. To investigate and prosecute any criminal action relating
2 to insurance fraud, if in the opinion of the Attorney General a
3 criminal prosecution is warranted, or to refer such matters to the
4 appropriate district attorney;

5 24. To monitor and evaluate any action by the federal
6 government including, but not limited to, executive orders by the
7 President of the United States, rules or regulations promulgated by
8 an agency of the federal government or acts of Congress to determine
9 if such actions are in violation of the Tenth Amendment to the
10 Constitution of the United States; ~~and~~

11 25. To cross-deputize police officers of the police department
12 of any municipality or any officer deputized by the county sheriff
13 or a designee subject to an interlocal governmental agreement with
14 the Attorney General's Office in an effort to combine city, county,
15 and state law enforcement efforts and to encourage cooperation
16 between city, county, and state law enforcement officials.
17 Liability for the conduct of any municipal police officer cross-
18 deputized under the terms and conditions of an interlocal
19 governmental agreement or any officer deputized by the county
20 sheriff under the terms and conditions of an interlocal governmental
21 agreement shall remain the responsibility of the respective employer
22 for that officer; and

1 26. To maintain data related to human trafficking and to assist
2 law enforcement, social service agencies, and victim services
3 programs in identifying and supporting victims of human trafficking.

4 B. Nothing in this section shall be construed as requiring the
5 Attorney General to appear and defend or prosecute in any court any
6 cause or proceeding for or on behalf of the Oklahoma Tax Commission,
7 the Board of Managers of the State Insurance Fund, or the
8 Commissioners of the Land Office.

9 C. In all appeals from the Corporation Commission to the
10 Supreme Court of Oklahoma in which the state is a party, the
11 Attorney General shall have the right to designate counsel of the
12 Corporation Commission as the Attorney General's legally appointed
13 representative in such appeals, and it shall be the duty of the
14 Corporation Commission counsel to act when so designated and to
15 consult and advise with the Attorney General regarding such appeals
16 prior to taking action therein.

17 SECTION 171. REPEALER 74 O.S. 2021, Section 18b, as last
18 amended by Section 1, Chapter 296, O.S.L. 2022 (74 O.S. Supp. 2023,
19 Section 18b), is hereby repealed.

20 SECTION 172. AMENDATORY 74 O.S. 2021, Section 840-2.20,
21 as last amended by Section 1, Chapter 18, 1st Extraordinary Session,
22 O.S.L. 2023 (74 O.S. Supp. 2023, Section 840-2.20), is amended to
23 read as follows:
24

1 Section 840-2.20. A. The Director of the Office of Management
2 and Enterprise Services shall promulgate such emergency and
3 permanent rules regarding leave and holiday leave as are necessary
4 to assist the state and its agencies.

5 The Director of the Office of Management and Enterprise
6 Services, in adopting new rules, amending rules and repealing rules,
7 shall ensure that the following provisions are incorporated:

8 1. Eligible employees who enter on duty or who are reinstated
9 after a break in service shall receive leave benefits in accordance
10 with the schedule outlined below. Leave shall be accrued based upon
11 hours worked, paid leave, and holidays, but excluding overtime, not
12 to exceed the total possible work hours for the pay period. Years
13 of service shall be based on cumulative periods of employment
14 calculated in the manner that cumulative service is determined for
15 longevity purposes pursuant to Section 840-2.18 of this title.
16 Employees may accumulate more than the maximum annual leave
17 accumulation limits shown in the schedule below provided that such
18 excess is used during the same calendar year in which it accrues or
19 within twelve (12) months of the date on which it accrues, at the
20 discretion of the appointing authority. If an employee whose job
21 duties include providing fire protection services, law enforcement
22 services or services with the Department of Corrections is unable to
23 use excess leave as provided for in this paragraph because the
24 employee's request for leave is denied by the employee's appointing

1 authority and the denial of leave is due to extraordinary
2 circumstances such that taking leave could pose a threat to public
3 safety, health or welfare, the employee shall receive compensation
4 at the employee's regular rate of pay for the amount of excess leave
5 the employee is unable to use. Such compensation shall be paid at
6 the end of the time period during which the excess leave was
7 required to have been used;

8 2. On and after the effective date of this act, the following
9 accrual rates and accumulation limits apply to eligible employees as
10 follows:

20 Following an emergency declaration as described in Section 683.8
21 of Title 63 of the Oklahoma Statutes, the accumulation limits for
22 annual leave shall temporarily increase and shall carryover to the
23 end of the fiscal year following the year in which the emergency
24 declaration ended.

1 All annual leave that accrued or expired during the period of
2 the emergency declarations issued by the Governor in 2020 and 2021
3 in response to the novel coronavirus (COVID-19) shall carry over to
4 the end of the fiscal year following the year in which the emergency
5 declaration ended regardless of regulatory provisions that establish
6 a maximum amount of annual leave that may be accumulated by an
7 employee of this state. Expired annual leave governed by this
8 subsection shall be reinstated as of May 7, 2021, and accumulation
9 limits for annual leave shall not apply to amounts accrued or
10 reinstated pursuant to this subsection. Eligibility for
11 reinstatement of annual leave is limited to employees currently
12 employed by this state on May 7, 2021;

13 3. Temporary employees and other limited term employees are
14 ineligible to accrue, use, or be paid for sick leave and annual
15 leave. Such employees shall be eligible for paid holiday leave at
16 the discretion of the appointing authority;

17 4. Except as provided in paragraph 2 of this subsection,
18 employees shall not be entitled to retroactive accumulation of leave
19 as a result of amendments to this section;

20 5. The Director of the Office of Management and Enterprise
21 Services shall assist agencies in developing policies to prevent
22 violence in state government workplaces without abridging the rights
23 of state employees. Such policies shall include a paid
24 administrative leave provision as a cooling-off period which the

1 Director of the Office of Management and Enterprise Services is
2 authorized to provide pursuant to the Administrative Procedures Act.
3 Such leave shall not be charged to annual or sick leave
4 accumulations;

5 6. State employees who terminated their employment in the state
6 service on or after October 1, 1992, may be eligible to have sick
7 leave accrued at the time of termination of employment restored if
8 they return to state employment provided that the state employees'
9 enter-on-duty dates for reemployment occur on or before two (2)
10 years after their termination of employment and they are eligible to
11 accrue sick leave before the two (2) years expire;

12 7. Employees who are volunteer firefighters pursuant to the
13 Oklahoma Volunteer Firefighters Act and who are called to fight a
14 fire shall not have to use any accrued leave or need to make up any
15 time due to the performance of their volunteer firefighter duties;

16 8. Employees who are reserve municipal police officers pursuant
17 to Section 34-101 of Title 11 of the Oklahoma Statutes and who miss
18 work in performing their duties in cases of emergency shall not have
19 to use any accrued leave or need to make up any time due to the
20 performance of their reserve municipal police officer duties;

21 9. Employees who are reserve deputy sheriffs pursuant to
22 Section 547 of Title 19 of the Oklahoma Statutes and who miss work
23 in performing their duties in case of emergency shall not have to
24

1 use any accrued leave or need to make up any time due to the
2 performance of their reserve deputy sheriff duties; ~~and~~

3 10. For purposes of the computation required by this section,
4 any service performed by a person during which the person received
5 compensation for duties performed for the state shall be counted if
6 payment for such service was made using state fiscal resources. The
7 provisions of this section shall not apply to elected or appointed
8 justices or judges, including special judges, who perform service in
9 the trial or appellate courts. The provisions of this section shall
10 apply to persons who perform services as an administrative law judge
11 within the executive department and employees of the judicial
12 branch; and

13 11. Eligible employees shall be entitled to paid maternity
14 leave as provided for in Section 840-2.20D of this title.

15 B. Nothing in law is intended to prevent or discourage an
16 appointing authority from disciplining or terminating an employee
17 due to abuse of leave benefits or absenteeism. Appointing
18 authorities are encouraged to consider attendance of employees in
19 making decisions regarding promotions, pay increases, and
20 discipline.

21 C. Upon the transfer of a function in state government to an
22 entity outside state government, employees may, with the agreement
23 of the outside entity, waive any payment for leave accumulations to
24

1 which the employee is entitled and authorize the transfer of the
2 leave accumulations or a portion thereof to the outside entity.

3 D. All permanent employees of the state shall be eligible to
4 carry over a maximum of six hundred forty (640) hours of annual
5 leave each year. Additionally, all employees shall be paid up to a
6 maximum of six hundred forty (640) hours of annual leave upon
7 separation from state service.

8 SECTION 173. REPEALER 74 O.S. 2021, Section 840-2.20, as
9 last amended by Section 2, Chapter 32, 1st Extraordinary Session,
10 O.S.L. 2023 (74 O.S. Supp. 2023, Section 840-2.20), is hereby
11 repealed.

12 SECTION 174. AMENDATORY 82 O.S. 2021, Section 1085.30,
13 as last amended by Section 6, Chapter 185, O.S.L. 2022, and as
14 renumbered by Section 4, Chapter 164, O.S.L. 2023 (27A O.S. Supp.
15 2023, Section 2-6-103.2), is amended to read as follows:

16 Section 2-6-103.2. A. 1. In order to effectuate a
17 comprehensive program to assist in the prevention, control and
18 abatement of pollution of the waters of this state, and in order to
19 establish state standards which comply with the Federal Water
20 Pollution Control Act as amended, the Department of Environmental
21 Quality is authorized to promulgate rules to be known as "Oklahoma
22 Water Quality Standards" which establish classifications of uses of
23 waters of the state, criteria to maintain and protect such
24

1 classifications, and other standards or policies pertaining to the
2 quality of such waters.

3 2. The Oklahoma Water Quality Standards shall, at a minimum, be
4 designed to maintain and protect the quality of the waters of the
5 state.

6 3. Wherever the Department finds it is practical and in the
7 public interest to do so, the rules may be amended to upgrade and
8 improve progressively the quality of waters of the state.

9 4. a. The Department may also amend Oklahoma Water Quality
10 Standards to downgrade a designated use of any waters
11 of this state which is not an existing use, may
12 establish subcategories of a use or may provide for
13 less stringent criteria or other provisions thereof
14 only in those limited circumstances permissible under
15 the Federal Water Pollution Control Act as amended or
16 federal rules which implement the act.

17 b. The Department may amend the Oklahoma Water Quality
18 Standards to downgrade a designated use, establish
19 subcategories of a use or may provide for less
20 stringent criteria or other provisions thereof only to
21 the extent as will maintain or improve the existing
22 uses and the water quality of the water affected;
23 provided, however, the Department shall not modify the
24 Oklahoma Water Quality Standards applicable to scenic

1 river areas as such areas are described by Section
2 896.5 of this title, to downgrade a designated use,
3 establish a subcategory of a use or provide for less
4 stringent criteria or other provisions thereof.

5 5. The Department shall propose any necessary rules to allow
6 for the development of nutrient trading programs by state
7 environmental agencies no later than November 1, 2026.

8 B. 1. Prior to adopting such standards or any amendment
9 thereof, the Department shall conduct public hearings thereon.
10 Notice of such hearing shall be published in accordance with the
11 Administrative Procedures Act and shall be mailed at least twenty
12 (20) days before such public hearing to the chief executive of each
13 municipality and county in the area affected and shall be mailed to
14 all affected holders of permits obtained pursuant to the Oklahoma
15 Environmental Quality Code, and such other persons that have
16 requested notice of hearings on such standard modifications.

17 2. If adoption or amendment of a classification to a lower or
18 downgraded classification is proposed because treatment controls
19 required of the current or a higher or upgraded classification would
20 result in substantial and widespread social and economic impact, the
21 Department shall, in addition to any hearing required by subsection
22 B of this section, conduct a public meeting within a central
23 location within the area to be affected. The Department shall cause
24 notice of such additional public meeting to be published for at

1 least two (2) consecutive weeks in a newspaper of general
2 circulation published in the county or counties in the area
3 affected.

4 C. 1. The Oklahoma Water Quality Standards, their accompanying
5 use support assessment protocols, anti-degradation policy and
6 implementation, and policies generally affecting Oklahoma Water
7 Quality Standards application and implementation including, but not
8 limited to, mixing zones, low flows and variances, except for
9 variances and site-specific criteria adopted by the Department of
10 Environmental Quality pursuant to paragraph 18 of subsection B of
11 Section 1-3-101 of Title 27A of the Oklahoma Statutes, or any
12 modification or change thereof shall be promulgated by the
13 Department in compliance with the Administrative Procedures Act and
14 shall be enforced by all state agencies within the scope of their
15 jurisdiction. All use support assessment protocols promulgated by
16 the Department shall be consistent with state and federal law and
17 guidance specifically related to beneficial use support
18 determinations as set forth in Section 305(b) of the Federal Water
19 Pollution Control Act, where applicable.

20 2. In promulgating Oklahoma Water Quality Standards or making
21 any modification or change thereof, the Department shall announce a
22 reasonable time for persons discharging waste into the waters of the
23 state to comply with such new or modified standards unless such
24 discharges create an actual or potential hazard to public health.

1 3. Any discharge in accord with such standards of the
2 Department and in compliance with all other rules, requirements and
3 wasteload allocations established by the Department and with rules
4 promulgated by other state environmental agencies shall not be
5 deemed to be pollution.

6 4. Notwithstanding the implementation jurisdiction provided to
7 the Department in paragraph 1 of subsection C of this section, the
8 Department of Environmental Quality shall also have jurisdiction to
9 adopt variances and site-specific criteria and to develop and
10 utilize policies and requirements, as provided in paragraph
11 paragraphs 18 and 22 of subsection B of Section 1-3-101 of Title 27A
12 of the Oklahoma Statutes.

13 SECTION 175. REPEALER 82 O.S. 2021, Section 1085.30, as
14 amended by Section 4, Chapter 113, O.S.L. 2022 (82 O.S. Supp. 2023,
15 Section 1085.30), is hereby repealed.

16 SECTION 176. It being immediately necessary for the
17 preservation of the public peace, health or safety, an emergency is
18 hereby declared to exist, by reason whereof this act shall take
19 effect and be in full force from and after its passage and approval.
