L7	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
L8	SECTION 1. AMENDATORY 11 O.S. 2021, Section 50-112, is
L 9	amended to read as follows:
20	Section 50-112. A. All persons employed as full-time duly
21	appointed or elected officers who are paid for working more than
22	twenty-five (25) hours per week or any person hired by a
23	participating municipality who is undergoing police training to
24	become a permanent police officer of the municipality shall

1 participate in the System upon initial employment with a police 2 department of a participating municipality. All such persons shall submit to a physical-medical examination pertaining to sight, 3 4 hearing, agility and other conditions the requirements of which 5 shall be established by the State Board. The person shall be required to complete this physical-medical examination prior to the 6 7 beginning of actual employment. This examination shall identify any preexisting conditions. Except as otherwise provided in this 8 9 section, a police officer shall be not less than twenty-one (21) nor 10 more than forty-five (45) years of age when accepted for membership 11 in the System. However, if a municipality should be found to be in 12 noncompliance with the provisions of Article 50 of this title, as 13 determined by the State Board, then any current full-time active 14 police officer employed by a municipality as of July 1, 2001, shall 15 not be denied eligibility to participate in the Oklahoma Police 16 Pension and Retirement System solely due to age. The State Board 17 shall have authority to deny or revoke membership of any person 18 submitting false information in such person's membership 19 application. The State Board shall have final authority in 20 determining eligibility for membership in the System, pursuant to 21 the provisions of this article.

B. The police chief of any participating municipality may be exempt from membership in the System or may become a member provided

the member is not a retired member and the requirements of this section are met at the time of employment.

- C. A member of the System who has attained his or her normal retirement date may, if the member so elects, agree to terminate employment and retire as a member of the System and make an election to receive distributions from the System. If a retired member is reemployed by a participating municipality in the position of police chief or in a position which is not covered by the System, retirement shall include receipt by such retired member of inservice distributions from the System.
- D. A former member of the System who terminates from covered employment and who has neither retired from the System nor entered the Oklahoma Police Deferred Option Plan and is later employed in a covered position with a participating municipality shall not be denied eligibility to become a member of the System because he or she is forty-five (45) years of age or older. If such member has withdrawn his or her contributions prior to re-entering the System and the member desires to receive credit for such prior service, then the member shall pay back such contributions and interest pursuant to Section 50-111.1 of this title.
- E. Notwithstanding any other provision of law to the contrary, a municipality that employs two (2) or fewer full-time police

 officers with a population of Four Thousand Five Hundred (4,500) or less, according to the latest Federal Decennial Census, may employ a

1 police officer retired police officers who is are more than forty-2 five (45) years of age and who has never have participated in the Oklahoma Police Pension and Retirement System, but such police 3 4 officer and are receiving retirement benefits. Such officers shall 5 not be eliqible to reenter and participate in the System. Such 6 police officer shall be counted in the limitation imposed by this 7 subsection. Notwithstanding any other provisions of law, the State Board shall be granted access to information concerning a list of 8 9 actively working police officers within the municipalities and 10 agencies under the purview provided by the Council on Law 11 Enforcement Education and Training.

SECTION 2. This act shall become effective July 1, 2023.

SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
