9 An Act relating to the Teachers' Retirement System;
10 amending 70 O.S. 2021, Section 17-116.10, which
11 relates to postretirement employment; modifying
provisions relating to retirement benefits; providing
an effective date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 70 O.S. 2021, Section 17-116.10,
17 is amended to read as follows:

18 Section 17-116.10 A. Subject to the requirements of Section 6-
19 101.2 of this title and any other applicable requirements of law, a
20 member may enter into postretirement employment with a public school
21 of Oklahoma and still receive monthly retirement benefits subject to
22 the following ~~limitations~~:

23 1. A retired member is not eligible to be employed by the
24 public schools of Oklahoma, in any capacity, for sixty (60) calendar

1 days between the retiree's last day of preretirement public
2 education employment and any postretirement public education
3 employment. For purposes of this section, the term "last day of
4 preretirement employment" shall mean the last day the employee is
5 required to be physically present on the job to complete the terms
6 of the employment contract or agreement. An employee on paid leave
7 is still considered to be employed for purposes of this section.
8 Employment under any conditions during this time, volunteer services
9 for the purpose of obtaining a paid position at a later date, or
10 payment at a later time for services performed during this time
11 period shall cause the forfeiture of all retirement benefits
12 received during the period;

13 2. ~~Unless otherwise provided in paragraph 3 of this subsection,~~
14 ~~earnings from the public schools may not exceed one-half (1/2) of~~
15 ~~the member's final average salary used in computing retirement~~
16 ~~benefits, or the Earnings Limitation for employees allowed by the~~
17 ~~Social Security Administration, whichever is less. For retired~~
18 ~~members under the age of sixty-two (62) years, the limit on allowed~~
19 ~~earnings from the public schools of Oklahoma for employment for the~~
20 ~~performance of duties ordinarily performed by classified or~~
21 ~~nonclassified personnel shall be the lesser of Fifteen Thousand~~
22 ~~Dollars (\$15,000.00) or one-half (1/2) of the member's final average~~
23 ~~salary used in computing retirement benefits unless the earnings~~
24 ~~limitation allowed by the Social Security Administration would be~~

1 ~~greater than Fifteen Thousand Dollars (\$15,000.00). For retired~~
2 ~~members sixty-two (62) years of age or older the limit on allowed~~
3 ~~earnings from the public schools of Oklahoma for the performance of~~
4 ~~duties ordinarily performed by classified or nonclassified personnel~~
5 ~~shall be the lesser of Thirty Thousand Dollars (\$30,000.00) or one~~
6 ~~half (1/2) of the member's final average salary used in computing~~
7 ~~retirement benefits. For purposes of this paragraph, the following~~
8 ~~shall apply:~~

9 ~~a. earnings shall mean "regular annual compensation" as~~
10 ~~defined in paragraph (25) of Section 17-101 of this~~
11 ~~title, and shall include any payment by a public~~
12 ~~school for services rendered by a retired member who~~
13 ~~is employed for any purpose whatsoever. Supplemental~~
14 ~~retirement payments paid by a former public school~~
15 ~~employer pursuant to subsection 9 of Section 17-105 of~~
16 ~~this title or other state law shall not be considered~~
17 ~~as earnings,~~

18 ~~b. the Earnings Limitation for employees allowed by the~~
19 ~~Social Security Administration to workers between the~~
20 ~~age of sixty-two (62) years and sixty-five (65) years~~
21 ~~shall apply to retired members below the age of sixty-~~
22 ~~two (62) years,~~

23 ~~c. the limit on allowed earnings from the public schools~~
24 ~~shall be automatically adjusted effective the first~~

~~day of January of each year to reflect the current
Earnings Limitation for employees as determined from
time to time by the Social Security Administration,
d. the earnings limit for the calendar year in which a
member retires shall be one twelfth (1/12) of the
annual limit multiplied by the number of months the
member is eligible to work and receive payments from
the public schools of Oklahoma,
e. earnings in excess of the maximum limit on allowed
earnings from public schools of Oklahoma shall result
in a loss of future retirement benefits for the year
the postretirement employment was performed of One
Dollar (\$1.00) for each One Dollar (\$1.00) earned over
the maximum allowed earnings amount,
f. for those members age seventy (70) years and over, the
earnings in excess of the maximum limit allowed
earnings from public schools of Oklahoma shall be one-
half (1/2) the member's final average salary used in
computing retirement benefits. However, any retired
member receiving benefits from the Retirement System
who reached age seventy (70) years prior to July 1,
1991, shall not be restricted by the earnings limits
pursuant to this subparagraph until January 1, 1994.
To qualify for the provisions of this subparagraph,~~

1 ~~the member must be employed less than one-half (1/2)~~
2 ~~time compared to other full-time employees in similar~~
3 ~~positions;~~

4 ~~3. Notwithstanding paragraph 2 of this subsection, a A retired~~
5 ~~classified or nonclassified member who has been retired for thirty-~~
6 ~~six (36) or more months and who is employed by a public school to~~
7 ~~perform duties ordinarily performed by classified or nonclassified~~
8 ~~personnel shall be able to receive annualized earnings from the~~
9 ~~public school with no reduction in retirement benefits regardless of~~
10 ~~the amount of annualized earnings. For a period of three (3) years~~
11 ~~beginning July 1, 2017, members who have retired as of July 1, 2017,~~
12 ~~as active classroom teachers, who have been retired and receiving a~~
13 ~~benefit for at least one (1) year, and who have not been employed by~~
14 ~~any public school during that one-year period, shall be eligible to~~
15 ~~be reemployed as an active classroom teacher in common or career~~
16 ~~tech school districts, with no limitations on earnings. For a~~
17 ~~period of three (3) years beginning July 1, 2021, members who have~~
18 ~~retired as of July 1, 2020, who have been retired and receiving a~~
19 ~~benefit for at least one (1) year, and who have not been employed by~~
20 ~~any public school during that one-year period, shall be eligible to~~
21 ~~be reemployed as an active classroom teacher in common or career~~
22 ~~tech school districts, with no limitations on earnings. The one-~~
23 ~~year period starts with the retiree's last day of preretirement~~
24 ~~public education employment. Members returning under this section~~

1 ~~shall not be subject to any earning limitations following the end of~~
2 ~~the three-year periods described in this paragraph. Members~~
3 ~~returning under this section shall only be employed pursuant to a~~
4 ~~temporary contract; and~~

5 ~~4.~~ 3. A member shall be considered to be employed by a school
6 district to perform the duties ordinarily performed by classified or
7 nonclassified personnel if the member is hired by the school
8 district in the member's individual capacity to perform the duties
9 or if the member performs the duties through employment with a
10 proprietorship, partnership, corporation, limited liability company
11 or partnership, or any other business structure that has agreed or
12 contracted to provide the services to the school district.

13 B. A public school district that employs a retired member shall
14 be required to make contributions to the System for the retired
15 member in an amount as required in Section 17-108.1 and in paragraph
16 3 of subsection B of Section 17-116.2 of this title.

17 C. For purposes of this section, postretirement employment of
18 less than one thousand (1,000) hours per year with the Governor, the
19 State Senate, the House of Representatives or the Legislative
20 Service Bureau shall not be considered as postretirement employment
21 with a public school of Oklahoma.

22 D. The Board of Trustees of the Teachers' Retirement System of
23 Oklahoma shall promulgate such rules as are necessary to implement
24 the provisions of this section.

1 E. A member who has entered into postretirement employment with
2 a participating employer of the Teachers' Retirement System of
3 Oklahoma must fully comply with all the provisions of the rules
4 promulgated by the Board of Trustees pursuant to this section in
5 order to continue receiving his or her monthly retirement benefit.

6 SECTION 2. This act shall become effective July 1, 2023.

7 SECTION 3. It being immediately necessary for the preservation
8 of the public peace, health or safety, an emergency is hereby
9 declared to exist, by reason whereof this act shall take effect and
10 be in full force from and after its passage and approval.
