11	An Act relating to the State Department of Health; creating the Oklahoma Adolescent Psychiatric Facility
12	Grant Program; placing the program at a certain agency; providing purpose; requiring certain reports;
13 14	establishing the Adolescent Psychiatric Facility Revolving Fund; establishing fund nature; authorizing certain budgeting and expenditure of funds for
15	certain purposes; providing for codification; providing an effective date; and declaring an
16	emergency.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. NEW LAW A new section of law to be codified
20	in the Oklahoma Statutes as Section 3240.9 of Title 63, unless there
21	is created a duplication in numbering, reads as follows:
22	This act shall be known and may be cited as the "Oklahoma
23	Adolescent Psychiatric Facility Grant Program".

A new section of law to be codified 1 SECTION 2. NEW LAW 2 in the Oklahoma Statutes as Section 3420.10 of Title 63, unless there is created a duplication in numbering, reads as follows: 3 4 There is hereby created the Adolescent Psychiatric Facility 5 Grant Program which shall be administered by the State Department of 6 Health. The program shall help increase the number of adolescent 7 psychiatric beds available in Oklahoma. The program shall help 8 provide funding for remodeling or building out existing facility 9 space to be used for an adolescent psychiatric facility. The 10 program shall be used for facilities where a Public Trust Hospital, 11 as defined in Sections 3250.1 through 3250.9 of Title 63 of the 12 Oklahoma Statutes, are donating both the space and the staffing 13 needs to support the facility. Applicants shall have, in writing, 14 the agreed upon support from the donating Public Trust Hospital upon 15 application. The location of these facilities shall be in counties 16 with a population of less than forty-five thousand (45,000) people 17 per the 2020 Federal Decennial Census. The facility, upon 18 completion, shall hold between ten and twenty beds for adolescent 19 psychiatric patients upon completion. Beginning January 1, 2025, 20 the State Department of Health shall provide an annual report to the 21 Governor, the Speaker of the Oklahoma House of Representatives, the 22 President Pro Tempore of the Oklahoma State Senate, the 23 Appropriations and Budget Chair of the Oklahoma House of 24 Representatives, and the Appropriations Chair of the State Senate

1 that includes information about any grants awarded and where 2 awardees are on the completion of the projects.

SECTION 3. NEW LAW A new section of law to be codified 3 4 in the Oklahoma Statutes as Section 3240.11 of Title 63, unless 5 there is created a duplication in numbering, reads as follows: 6 There is hereby created in the State Treasury a revolving fund 7 for the State Department of Health to be designated the "Adolescent Psychiatric Facility Revolving Fund". The fund shall be a 8 9 continuing fund, not subject to fiscal year limitations, and shall 10 consist of all monies received by the State Department of Health 11 from appropriations to the fund. All monies accruing to the credit 12 of said fund are hereby appropriated and may be budgeted and 13 expended by the State Department of Health for the purpose of the 14 Oklahoma Adolescent Psychiatric Facility Grant Program. The State 15 Department of Health may retain one percent (1%) of all funds 16 otherwise deposited to the fund to cover administrative costs 17 related to the Oklahoma Adolescent Psychiatric Facility Grant 18 Expenditures from said fund shall be made upon warrants Program. 19 issued by the State Treasurer against claims filed as prescribed by 20 law with the Director of the Office of Management and Enterprise 21 Services for approval and payment.

SECTION 4. This act shall become effective July 1, 2024.
SECTION 5. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby

1	declared to exist, by reason whereof this act shall take effect and
2	be in full force from and after its passage and approval.
