17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 3-335 of Title 43A, unless there
20	is created a duplication in numbering, reads as follows:
21	A. As used in this section:
22	1. "Board" means any of the following:
23	a. the State Board of Examiners of Psychologists,
24	b. the State Board of Behavioral Health Licensure,

1	c. the Oklahoma State Board of Licensed Social Workers,
2	or
3	d. the Oklahoma Board of Licensed Alcohol and Drug
4	Counselors;
5	2. "Licensed mental health professional" means an individual
6	who holds any type of license pursuant to the:
7	a. Psychologists Licensing Act,
8	b. Psychology Interjurisdictional Compact,
9	c. Licensed Professional Counselors Act,
10	d. Janet Phillips Act of 2023,
11	e. Marital and Family Therapist Licensure Act,
12	f. Social Worker's Licensing Act, or
13	g. Licensed Alcohol and Drug Counselors Act; and
14	3. "Certified mental health professional" means an individual
15	who holds any type of certification pursuant to the Unified
16	Community Mental Health Services Act.
17	B. Every applicant for a behavioral health certification or
18	license issued by a designated board shall provide the following
19	information:
20	1. Demographic information, including race, ethnicity, gender,
21	date of birth, and languages spoken;
22	2. Educational background, training information, internship
23	information, if applicable, and location of internship or program
24	attended; and

1	3. If the applicant has any other mental health certifications
2	or licenses.
3	C. Every mental health professional who is renewing a
4	behavioral health certification or license issued by a designated

- 1. Changes to demographic information required upon initial application for licensure or certification;
- 2. Workforce retention information, including, but not limited to, anticipated changes in licensure status or retirement; and
 - 3. Workforce practice trends, including, but not limited to:
 - a. practice specialization, if applicable,
 - b. practice setting,

board shall report the following information:

- c. practice location and physical address, if applicable,
- d. service delivery area, by county,
- e. the average weekly number of hours providing direct services,
- f. the type of behavioral health care services provided,
- q. the use of telehealth, and
- h. predominant payer source, if providing direct services.
- D. The boards designated in subsection A of this section shall promulgate rules to effectuate the provisions of this section.

2	furnish annual licensure and certification data to the Oklahoma
3	Department of Mental Health and Substance Abuse Services.
4	F. The Oklahoma Department of Mental Health and Substance Abuse
5	Services shall compile the information collected in this section
6	into an annual report. The report shall not contain any personal
7	identifying information. The annual report shall be posted on the
8	agency's website and submitted to the President Pro Tempore of the
9	Oklahoma State Senate, the Speaker of the Oklahoma House of
10	Representatives, and the chairs of the committees with
11	responsibility over public health in both chambers of the
12	Legislature.
13	SECTION 2. This act shall become effective November 1, 2024.
