8 AS INTRODUCED

9 A Joint Resolution approving certain proposed
10 permanent rules of Oklahoma state agencies;
11 disapproving certain proposed permanent rules; and
12 directing distribution.

13 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
14 Statutes, the Legislature shall have a joint resolution prepared for
15 consideration each session.

16 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
17 AND THE SENATE OF THE 1ST SESSION OF THE 59TH OKLAHOMA LEGISLATURE:

18 SECTION 1. All proposed permanent rules of Oklahoma state
19 agencies not declared invalid by the Oklahoma Attorney General and
20 filed on or before April 1, 2023, are hereby approved, except for:

- 21 1. Oklahoma Department of Agriculture, Food, and Forestry, OAC
22 35:20-3-9, 35:20-3-12, 35:37-19-2, 35:37-19-3 and 35:37-19-6;
23 2. Oklahoma Cosmetology and Barbering Board, OAC 175:1-1-2,
24 175:1-3-1, 175:10-1-3 and 175:20-5-7;

1 3. Oklahoma Board of Medical Licensure and Supervision, OAC
2 435:15-1-1.1, 435:15-3-1, 435:15-3-13, 435:15-3-17, 435:15-3-19,
3 435:15-5-10, 435:15-5-11, 435:15-11-1 and 435:15-11-2;

4 4. Oklahoma Used Motor Vehicle, Dismantler, and Manufactured
5 Housing Commission, OAC 765:10-3-5.

6 5. Oklahoma Department of Wildlife Conservation, OAC 800:25-24-
7 3 paragraph (2) of subsection (c), 800:25-30-2 and 800:25-37-12.

8 6. Oklahoma Health Care Authority, OAC 317:30-3-35;

9 7. Oklahoma State Board of Examiners for Long-Term Care
10 Administrators, OAC 490-10-1-2.1 disapproving changes in
11 subparagraph (d);

12 8. Department of Public Safety, OAC 595:25-1-2 disapproving
13 adding definition of ""Payment" means compensation for services
14 rendered by a wrecker or towing company in the form of cash, credit
15 card, debit card, Automated Clearinghouse Transfer (ACH), business
16 checks, cashier's check, or money order." and OAC 595:25-5-7(b) and
17 (c), disapproving proposed changes, except for the P.O. Box number.

18 SECTION 2. The Secretary of State is hereby directed to
19 distribute copies of this resolution to the Governor and the editor
20 of "The Oklahoma Register".
