6	4. Oklahoma Office of Management and Enterprise Services,
7	paragraph (e) of OAC 260:60-3-3 and OAC 260:60-3-12;
8	5. Oklahoma Department of Mental Health and Substance Abuse
9	Services, OAC 450:17-1-6; and
10	6. Oklahoma State Board of Examiners of Psychologists, OAC
11	575:1-1-3.
