7 AS INTRODUCED

8 A Resolution relating to the World Health
9 Organization, the United Nations and the World
10 Economic Forum; expressing intent with regard to
11 policies of state and local government.

12 WHEREAS, the State of Oklahoma is a sovereign governmental
13 entity and through its elected officials, including the members of
14 the Oklahoma House of Representatives is the appropriate entity to
15 make law and policy for the people of the State of Oklahoma; and

16 WHEREAS, the political subdivisions of the State of Oklahoma are
17 legally constituted pursuant to the authority of the Oklahoma
18 Constitution and the Oklahoma Statutes and each such entity has a
19 governing board equally capable of making decisions related to the
20 health and welfare of the people of the State of Oklahoma; and

21 WHEREAS, the World Health Organization, the United Nations and
22 the World Economic Forum are not government entities and do not have
23 any authority to make law or policy that impacts the lives of the
24 people of the State of Oklahoma; and

1 WHEREAS, the people of the State of Oklahoma have fundamental
2 rights which should not be subject to the influence of
3 nongovernmental entities such as the World Health Organization, the
4 United Nations or the World Economic Forum.

5 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
6 OF THE 2ND SESSION OF THE 59TH OKLAHOMA LEGISLATURE:

7 THAT the World Health Organization, the United Nations and the
8 World Economic Forum should have no jurisdiction in the State of
9 Oklahoma.

10 THAT the state and its political subdivisions, including, but
11 not limited to counties, cities, towns, precincts, water districts,
12 school districts, school administrative units, or quasi-public
13 entities, should not engage in the enforcement of, or any
14 collaboration with the enforcement of, any requirements,
15 instructions, mandates, recommendations, or guidance provided by the
16 World Health Organization, the United Nations or the World Economic
17 Forum.

18 THAT any mandates, recommendations, instructions, communications
19 or guidance issued by the World Health Organization, the United
20 Nations or the World Economic Forum should not be used in this state
21 as a basis for action, nor to direct, order or otherwise impose,
22 contrary to the constitution and laws of the State of Oklahoma any
23 requirements whatsoever, including those for masks, vaccines or
24 medical testing, or gather any public or private information about

1 the state's citizens or residents, and shall have no force or effect
2 in the State of Oklahoma.
