There is hereby appropriated to the Oklahoma 21 Aeronautics Commission from any monies not otherwise appropriated 22 from the Statewide Recovery Fund of the State Treasury created in 23

Legislature, the sum of Six Hundred Thousand Dollars (\$600,000.00)
or so much thereof as may be necessary to address the negative
economic and public health impacts of the pandemic experienced by
the dedicated air and space museums and their ability to provide
education services. Such funds shall be utilized in a manner
consistent with the recommendations adopted by the Joint Committee
on Pandemic Relief Funding on May 11, 2023.

There is hereby created in the State Treasury a SECTION 2. A. Statewide Recovery Special Account for the Oklahoma Aeronautics Commission for the appropriated monies as provided in Section 1 of The duration of such account shall continue for the this act. period of time that monies related to the American Rescue Plan Act of 2021 are being budgeted, expended, or managed in the state. The ending of such period shall be determined by the State Treasurer, and shall result in the closing of such account as a matter of law. Such account shall be a continuing account as otherwise provided in this section, not subject to fiscal year limitations, and shall exclusively consist of monies related to the relevant appropriation made in this act and as otherwise directed by law. All monies deposited to the credit of such account are hereby appropriated and may be budgeted and expended by the Oklahoma Aeronautics Commission in accordance with the provisions of this act. Expenditures from such account shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the

- Director of the Office of Management and Enterprise Services for approval and payment.
- B. The Oklahoma Aeronautics Commission is authorized to request in writing that the monies appropriated by the provisions of this act be deposited or transferred to the account created pursuant to subsection A of this section. No later than seven (7) calendar days from the date of such request, the Director of the Office of Management and Enterprise Services shall comply with such request and verify to the requesting agency that such deposit or transfer has been completed.
- SECTION 3. The Oklahoma Aeronautics Commission may enter into memorandums of understanding with other agencies of the State of Oklahoma for the auditing, documentation, evaluation, implementation, oversight, reporting, and management of funds and associated efforts related to the appropriation made in this act; provided, no such memorandum of understanding shall require or include, as an option or condition, the direct or practical transfer or relinquishment of control by the agency appropriated such funds to budget, expend, allocate, and request the distribution of the funds appropriated by this act.
 - SECTION 4. The Oklahoma Aeronautics Commission may promulgate rules, utilize existing rules, establish procedures, and utilize existing procedures to implement the provisions of this act,

provided such rules and procedures do not conflict with or impede the provisions of this act.

SECTION 5. The Oklahoma Aeronautics Commission shall retain no more than two percent (2%) of the funds appropriated by this act to reimburse:

- 1. Costs incurred by the Oklahoma Aeronautics Commission; or
- 2. Costs incurred on the agency's behalf,

associated with the administration of the appropriated funds and programming required by the Oklahoma Aeronautics Commission under the provisions of this act; provided, no funds shall be retained that would be disallowable under the provisions of the American Rescue Plan Act of 2021.

SECTION 6. A. The Oklahoma Aeronautics Commission shall:

- 1. Submit to the chairs of the Joint Committee on Pandemic Relief Funding, or any successor of the Oklahoma State Senate or Oklahoma House of Representatives legislative committee or joint committee, as designated by the President Pro Tempore of the Oklahoma State Senate and the Speaker of the Oklahoma House of Representatives:
 - a. a written or electronic quarterly report detailing the budgeting, expenditure, and management of all monies appropriated in this act, and
 - b. a copy of all memorandums of understanding and contracts with third parties entered into by the

Oklahoma Aeronautics Commission to facilitate, assist, or administer powers and duties provided to the Commission under the provisions of this act; and

- 2. At the Joint Committee on Pandemic Relief Funding's request, appear before the Joint Committee no later than six (6) months after the effective date of this act, and as otherwise requested by the Joint Committee, to provide a status update regarding the implementation of the provisions of this act.
- B. The provisions of subsection A of this section shall remain applicable for the period of time that monies appropriated under this act are being budgeted, expended, or managed in the state. The ending of such period shall be determined by the State Treasurer, and shall be reported to the Governor, the President Pro Tempore of the Oklahoma State Senate, and the Speaker of the Oklahoma House of Representatives.
- SECTION 7. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
