9 An Act relating to vehicle registration; amending 47
10 O.S. 2021, Section 1133, which relates to the
11 registration of commercial vehicles; directing
12 Service Oklahoma to promulgate certain rules;
13 establishing due date for certain license fees; and
14 providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1133, is
17 amended to read as follows:

18 Section 1133. A. The following license fees shall be paid
19 annually to the Oklahoma Tax Commission or Corporation Commission,
20 as applicable, upon the registration of the following vehicles:

21 Except as provided in this subsection, for each commercial
22 vehicle over eight thousand (8,000) pounds as defined in Section
23 1102 of this title, the license fee shall be based on the combined
24 laden weight of the vehicle or combination of vehicles. The license
fees shall be computed and assessed at the following rates:

15 For the purposes of this section, the license fee of a wrecker
16 or tow vehicle shall be based on the gross weight of the wrecker or
17 tow vehicle alone without any inclusion of weight for a vehicle
18 towed by the wrecker or tow vehicle.

19 B. After the fifth year's registration in this or any other
20 state, the license fee upon any truck registered on a basis of the
21 combined laden weight not in excess of fifteen thousand (15,000)
22 pounds shall be assessed at fifty percent (50%) of the fee computed
23 and assessed for each of the first five (5) years. On the seventh
24 and all subsequent years of registration in this or any other state,

1 on such truck, such license fees shall be assessed and computed at
2 fifty percent (50%) of the amount due on the sixth year's
3 registration. In no event shall such annual license fee on any
4 truck be less than Ten Dollars (\$10.00) nor shall the annual license
5 fee of any truck-tractor be less than Ninety-five Dollars (\$95.00).

6 C. In addition to the fees required by subsection A of this
7 section, there shall be paid a registration fee of Forty Dollars
8 (\$40.00) upon the first registration in this state after July 1,
9 1985, and upon the transfer of ownership of any frac tank, as
10 defined by Section 54 of Title 17 of the Oklahoma Statutes,
11 construction machinery, as defined by Section 1102 of this title,
12 rental trailer, commercial trailer, or semitrailer designed to be
13 pulled and usually pulled by a truck or truck-tractor.

14 Thereafter, a fee of Four Dollars (\$4.00) shall be paid annually
15 for each frac tank, construction machinery, rental trailer,
16 commercial trailer, or semitrailer. The fee of Four Dollars (\$4.00)
17 shall be due and payable on January 1 of each year on any frac tank,
18 construction machinery, rental trailer, commercial trailer, or
19 semitrailer registered under this section.

20 Upon the payment of the registration fee of Forty Dollars
21 (\$40.00), a nonexpiring registration certificate and identification
22 plate shall be issued for each frac tank, construction machinery,
23 rental trailer, commercial trailer, or semitrailer. The nonexpiring
24 identification plate shall remain displayed on the frac tank,

1 construction machinery, rental trailer, commercial trailer, or
2 semitrailer for which the identification plate is issued until such
3 frac tank, construction machinery, trailer, or semitrailer is sold
4 or removed from service.

5 A receipt shall be issued upon the payment of the annual fee.
6 The receipt shall show the total fee paid for one or more frac
7 tanks, construction machinery units, rental trailers, commercial
8 trailers, or semitrailers. The receipt shall be retained by the
9 owner of any frac tank, construction machinery, rental trailer,
10 commercial trailer, or semitrailer for a period of three (3) years
11 and shall be subject to audit by the Tax Commission or Corporation
12 Commission.

13 Any frac tank, construction machinery, commercial trailer, or
14 semitrailer licensed pursuant to this section shall not be permitted
15 to be operated on the highways of this state when such frac tank,
16 construction machinery, commercial trailer, or semitrailer is being
17 operated by a resident of this state, or is being operated by a
18 person operating a vehicle or vehicles domiciled in this state and
19 required by law to be licensed in Oklahoma, unless the pulling truck
20 or truck-tractor has been licensed pursuant to this section or is
21 twenty-four thousand (24,000) pounds or less and operating under a
22 valid temporary license plate provided by Section 1137.1 or 1137.3
23 of this title. In no event shall any truck, truck-tractor, frac
24 tank, construction machinery, trailer, or semitrailer used in the

1 furtherance of any commercial enterprise be permitted to operate on
2 the highways of this state or register at a smaller license fee than
3 that prescribed in this section except as provided in this section.

4 D. For each fiscal year, notwithstanding the provisions of
5 Section 1104 of this title, the first Four Hundred Thousand Dollars
6 (\$400,000.00) of all monies collected pursuant to subsections A, B,
7 and C of this section shall be paid by the Tax Commission to the
8 State Treasurer of the State of Oklahoma who shall deposit same each
9 fiscal year, or such lesser amount as may accrue each fiscal year,
10 under the provisions of this section to the credit of the General
11 Revenue Fund of the State Treasury. All monies collected in excess
12 of Four Hundred Thousand Dollars (\$400,000.00) each fiscal year
13 shall be apportioned as provided in Section 1104 of this title.

14 E. If any vehicle is used for a purpose other than that for
15 which it has been registered, the owner of the vehicle shall be
16 required to immediately reregister the vehicle at the appropriate
17 rate. If any vehicle is placed or operated upon any street, road,
18 or highway of this state with a laden weight in excess of that for
19 which it is licensed, the license fee for such increased laden
20 weight shall become due, and the owner of the vehicle shall be
21 required to immediately reregister the vehicle at the increased
22 rate. Provided, that, in either event there shall be credited upon
23 the increased license fee for such reregistration for any portion of
24 the year or period remaining after the change in use or increase in

1 laden weight shall have occurred a proportionate part of the license
2 fees previously paid. If this reregistration is made voluntarily by
3 the owner, the ratable proportion of the credit allowed shall be
4 determined as of the date the reregistration is voluntarily made.
5 If the reregistration is not voluntarily made but occurs as a result
6 of the discovery by any enforcement officer of an improper operation
7 of the vehicle, that shall be considered prima facie evidence that
8 it has been improperly registered for the entire portion of the year
9 covered by the improper registration. Provided further, that the
10 ratable credit shall be allowed only on the first reregistration of
11 any vehicle during any calendar year. If, during the calendar year,
12 subsequent changes of license plate are desired, the ratable credit
13 shall not be allowed but the owner of the vehicle shall be required
14 to pay the license fee due for that portion of the calendar year
15 remaining without benefit of any additional credits. No owner of a
16 motor vehicle shall possess at any time more than one license plate
17 for any vehicle owned by such person. No reregistration shall be
18 made until the current license plate previously issued has been
19 surrendered.

20 Any person who has paid a fee under the terms and provisions of
21 this subsection may at any time within one (1) year after the
22 payment of such fee file with the Tax Commission or Corporation
23 Commission a claim under oath for refund stating the grounds
24 therefor. However, the Tax Commission or Corporation Commission

1 shall allow refunds only where the amount of tax paid has been
2 erroneously computed or determined through clerical errors or
3 miscalculations. No refund shall be allowed by the Tax Commission
4 or Corporation Commission of a tax paid by the person where such
5 payment is made through a mistake as to the legal misinterpretation
6 or construction of the provisions of this section. Any refunds made
7 by the Tax Commission or Corporation Commission pursuant to this
8 subsection shall be made out of any monies collected pursuant to
9 this subsection and which have not been apportioned.

10 F. The annual license fee required by this section is intended
11 to cover only the motor vehicle for which it is issued. The Tax
12 Commission or Corporation Commission upon application, when a
13 licensed truck-tractor has been destroyed by fire or accident, shall
14 credit the unused portion of the annual license fee of the vehicle
15 toward the license fee of a replacement vehicle of equal registered
16 weight. The amount of credit shall not exceed the license fee due
17 on the replacement vehicle. The Tax Commission or Corporation
18 Commission shall not be required to make a refund. If the
19 replacement vehicle is to be registered at a greater weight, the
20 applicant shall pay an additional sum equivalent to the difference
21 between the unused portion of the annual license fee for the
22 original motor vehicle and the license fee due for the replacement
23 motor vehicle.

1 G. The license fees provided for in this section shall be paid
2 each year whether or not the vehicle is operated on the public
3 highway.

4 H. Notwithstanding the provision of any other statute in
5 respect to the time for payment of license fees on motor vehicles,
6 if the total amount of the annual license fees due from any resident
7 owner, either individual, partnership, or Oklahoma corporation, upon
8 the registration, on or before January 15 of any year, of commercial
9 trucks, truck-tractors, frac tanks, construction machinery, trailers
10 or semitrailers exceeds the sum of One Thousand Dollars (\$1,000.00),
11 the license fees may be paid in equal semiannual installments. The
12 first installment shall be paid at the time of the application for
13 registration of the vehicles and not later than January 15 of each
14 year, and the second installment shall be paid on or before the
15 first day of July of such year.

16 This subsection shall not operate to reduce the amount of the
17 license fees due. If any installment is not paid on or before the
18 date due, all unpaid installments of license fees for such year on
19 each vehicle shall be deemed delinquent and immediately due and
20 payable, and there shall be added a penalty of twenty-five cents
21 (\$0.25) per day to the balance of the license fee due on each
22 vehicle for each day the balance remains unpaid up to thirty (30)
23 days, after which the penalty due on each vehicle shall be Twenty-
24 five Dollars (\$25.00). The penalty for vehicles registered by

1 weight in excess of eight thousand (8,000) pounds shall be an amount
2 equal to the license fee. On and after the thirtieth day each such
3 vehicle involved shall be considered as improperly licensed and as
4 not currently registered, and all of the provisions of the Oklahoma
5 Vehicle License and Registration Act relating to enforcement,
6 including the provisions for the seizure and sale of vehicles not
7 registered and not displaying current license plates, shall apply to
8 the vehicles.

9 All fees and taxes levied by the Oklahoma Vehicle License and
10 Registration Act shall become and remain a first lien upon the
11 vehicle upon which the fees or taxes are due until paid. The lien
12 shall have priority to all other liens. No title to any vehicle may
13 be transferred until the unpaid balance on the vehicle has been paid
14 in full. Provided, that any unpaid balance of the license fees
15 shall remain and become a lien against any and all property of the
16 owner, both real and personal, for so long as any license tag fee
17 balance shall remain unpaid. Any unpaid balance under these
18 provisions shall be immediately due and payable by the owner if any
19 vehicle is sold, wrecked, or otherwise retired from service.

20 Any person electing to pay license fees on a semiannual
21 installment basis, as herein authorized, shall be required to
22 purchase a new license tag for the last half and shall pay the sum
23 of Four Dollars (\$4.00) for each tag to cover the costs of the
24 license tags. The license tags for each half shall be plainly

1 marked in designating the half for which they were issued. A
2 validation sticker may be used in lieu of a metal tag where
3 appropriate. Such license tag fee shall be, in addition to the
4 license fees or any other fees, collected on each application as
5 provided by statute and shall be apportioned according to the
6 provisions of Section 1104 of this title.

7 I. Any person pulling or towing any vehicle intended to be
8 resold, into or through this state, shall pay a fee of Three Dollars
9 (\$3.00) for the vehicle towing and Three Dollars (\$3.00) for the one
10 being towed. It shall be unlawful to operate any series of such
11 units on the public highways of this state at a distance closer than
12 five hundred (500) feet from each other. All fees and taxes levied
13 by the terms and provisions of this section shall become and remain
14 a first lien upon the vehicle upon which the fees or taxes are due
15 until paid. The lien shall be prior, superior, and paramount to all
16 other liens of whatsoever kind or character.

17 J. In addition to any other penalties prescribed by law, the
18 following penalty shall be imposed by enforcement officers upon any
19 owner or operator of a commercial vehicle registered under the
20 provisions of this section when the laden weight or combined laden
21 weight of such vehicle is found to be in excess of that for which
22 registered. The penalty shall be imposed each and every time a
23 vehicle is found to be in violation of the registered laden weight
24 or combined laden weight.

1 The penalty shall be not less than Twenty Dollars (\$20.00) when
2 such vehicle exceeds the laden weight or combined laden weight by
3 two thousand one (2,001) pounds; thereafter, an additional penalty
4 of not less than Twenty Dollars (\$20.00) shall be imposed for each
5 additional one thousand (1,000) pounds or fraction thereof of weight
6 in excess of the registered laden weight or combined laden weight.
7 Such penalty shall not exceed the amount established by the
8 Corporation Commission pursuant to the provisions of subsection A of
9 Section 1167 of this title. Revenue from such penalties shall be
10 apportioned as provided in Section 1167 of this title.

11 K. Service Oklahoma shall promulgate rules for the mass renewal
12 of commercial vehicle registration for businesses that possess at
13 least ten vehicles registered as commercial vehicles under the
14 provisions of this section, provided that such mass renewal shall
15 not be mandatory for such businesses. For such mass renewal, the
16 annual license fees described in subsections A and B of this section
17 shall be due and payable on January 1 of each year on such
18 commercial vehicles.

19 SECTION 2. This act shall become effective November 1, 2024.
