14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 59 O.S. 2021, Section 15.2, as
16	amended by Section 2, Chapter 26, O.S.L. 2022 (59 O.S. Supp. 2022,
17	Section 15.2), is amended to read as follows:
18	Section 15.2. A. There is hereby re-created, to continue until
19	July 1, 2023 July 1, 2028, in accordance with the provisions of the
20	Oklahoma Sunset Law, the Oklahoma Accountancy Board. The Oklahoma
21	Accountancy Board shall have the responsibility for administering
22	and enforcing the Oklahoma Accountancy Act. The Oklahoma
23	Accountancy Board shall be composed of seven (7) members, who shall
24	have professional or practical experience in the use of accounting

1 services and financial matters, so as to be qualified to make 2 judgments about the qualifications and conduct of persons and firms 3 subject to regulation under the Oklahoma Accountancy Act to be appointed by the Governor and confirmed by the Senate. 4 The number 5 of registrant members shall not be more than five, not including a firm, who shall serve terms of five (5) years. No member who has 6 served two successive complete terms shall be eligible for 7 reappointment, but an appointment to fill an unexpired term shall 8 9 not be considered a complete term for this purpose. One public 10 member shall serve coterminously with the Governor appointing the public member. The other public member shall serve a term of five 11 12 (5) years.

B. Five members shall be certified public accountants holding 13 certificates and four shall hold permits issued pursuant to the 14 provisions of the Oklahoma Accountancy Act, at least four of whom 15 shall have been engaged in the practice of public accounting as a 16 17 certified public accountant continuously for not less than five (5) out of the last fifteen (15) years immediately preceding their 18 appointments. A list of qualified persons shall be compiled and 19 submitted to the Governor by the Oklahoma Society of Certified 20 Public Accountants from time to time as appointments of the 21 certified public accountant Board members are required. A list of 22 three names shall be submitted for each single appointment from 23 which the Governor may make the appointment. 24

1 C. Two members shall be public members who are not certified 2 public accountants. One public member shall be appointed by the Governor to a term coterminous with the Governor, to serve at his or 3 her pleasure. The other public member shall serve a term of five 4 5 (5) years and have professional or practical experience in the use of accounting services and financial matters. A list of qualified 6 persons shall be compiled and submitted to the Governor by the 7 Oklahoma Society of Public Accountants, Oklahoma Society of 8 9 Certified Public Accountants, or successor organizations from time 10 to time as appointment of the Board member is required. A list of three (3) names shall be submitted for each single appointment from 11 12 which the Governor may make the appointment.

D. Upon the expiration of the term of office, a member shall
continue to serve until a qualified successor has been appointed.
Confirmation by the Senate is required during the next regular
session of the Senate for the member to continue to serve.
SECTION 2. This act shall become effective July 1, 2023.
SECTION 3. It being immediately necessary for the preservation

19 of the public peace, health or safety, an emergency is hereby 20 declared to exist, by reason whereof this act shall take effect and 21 be in full force from and after its passage and approval.
