14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 62 O.S. 2021, Section 155, as
16	amended by Section 34, Chapter 29, O.S.L. 2023 (62 O.S. Supp. 2023,
17	Section 155), is amended to read as follows:
18	Section 155. A. There is hereby created in the State Treasury
19	a revolving fund for each of the following state boards,
20	commissions, and departments:
21	1. The Board of Governors of the Licensed Architects, Landscape
22	Architects and Registered Commercial Interior Designers of Oklahoma;
23	2. Oklahoma Funeral Board;
24	3. Board of Podiatric Medical Examiners;

- 1 4. Board of Chiropractic Examiners; State Board of Medical Licensure and Supervision; 2 5. Oklahoma Board of Nursing; 3 6. 7. State Board of Osteopathic Examiners; 4 5 8. State Board of Pharmacy; 9. State Board of Licensed Social Workers; 6 10. Oklahoma New Motor Vehicle Commission; and 7 11. Oklahoma Real Estate Commission; and 8 12. Santa Claus Commission. 9 Each revolving fund shall consist of all monies received by 10 Β. the boards, commissions, and departments, pursuant to statutory 11
- 12 authority, but not including appropriated funds. These revolving 13 funds shall be continuing funds, not subject to fiscal year 14 limitations, and shall be under the control and management of the 15 administrative authorities of the respective boards, commissions, or 16 departments.
- С. Expenditures from the revolving funds shall be made pursuant 17 to the laws of the state and the statutes relating to the boards, 18 commissions, and departments, and without legislative appropriation. 19 Warrants for expenditures from the revolving funds shall be drawn by 20 the State Treasurer, based on claims signed by an authorized 21 employee or employees of the respective boards, commissions, or 22 departments and approved for payment by the Director of the Office 23 of Management and Enterprise Services. 24

1SECTION 2.AMENDATORY62 O.S. 2021, Section 203, is2amended to read as follows:

Section 203. A. Except as otherwise provided by subsection B 3 of this section, all monies that may come into the State Treasury, 4 5 pursuant to the provisions of Section 201 et seq. of this title, 6 together with all amounts that may be received by the State Treasurer as investment income or as interest on average daily bank 7 balances, including investment income or interest on deposits from 8 9 funds deposited to the credit of the Constitutional Reserve Fund created pursuant to Section 23 of Article X of the Oklahoma 10 Constitution, shall be apportioned and credited to the General 11 12 Revenue Fund for the current year.
