9 An Act relating to boats; amending 47 O.S. 2021,
10 Section 1107.5, as amended by Section 119, Chapter
11 282, O.S.L. 2022 (47 O.S. Supp. 2022, Section
12 1107.5), which relates to transfer of title in
13 transfer-on-death form; modifying inclusions; and
14 providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1107.5, as
17 amended by Section 119, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
18 2022, Section 1107.5), is amended to read as follows:

19 Section 1107.5. A. The title of a motor vehicle or boat or
20 motor that is not subject to any lien or other encumbrance may be
21 transferred in transfer-on-death form by filing with Service
22 Oklahoma a written notice of transfer signed by the transferor and
23 designating the transferee. Such notice shall transfer ownership of
24 the vehicle or boat or motor to the transferee upon the death of the
transferor. The notice shall include:

1 1. The vehicle identification number of the vehicle or hull
2 identification number of the boat;

3 2. The number of the license plate issued to the vehicle, if
4 any;

5 3. The full name and address of the transferor;

6 4. The full name and address of the transferee; and

7 5. The signature of the transferor. The signature or consent
8 of or notice to the transferee shall not be required for any purpose
9 during the lifetime of the transferor.

10 B. A designation of the transferee may be revoked or changed at
11 any time prior to the death of the transferor by filing an amended
12 notice with Service Oklahoma.

13 C. To accept a certificate of title of a motor vehicle or boat
14 or motor pursuant to notice filed under subsection A of this act,
15 the designated transferee shall execute an affidavit verifying the
16 death of the transferor owner and submit to Service Oklahoma. After
17 the date of the transfer of the vehicle or boat or motor as
18 evidenced by the submitted affidavit and the records of Service
19 Oklahoma, Service Oklahoma shall issue a title reflecting the
20 transfer of ownership.

21 SECTION 2. This act shall become effective November 1, 2023.
