21 enforcement of human trafficking information, school
22 license, instructor's license, license fees,
23 suspension or revocation of license, confidentiality
24 of information, special license plates, and
qualifications to locate and operate Service Oklahoma
locations; modifying period of certain permit;
authorizing certain application processing and
document recognition; allowing certain fee retention;
requiring certain national criminal history record
check; requiring certain driving record; setting
certain time for notification and replacement;
authorizing certain use of state owned vehicles;
modifying inclusions; modifying certain number of
plates required; requiring certain residency;
allowing certain sell or transfer; requiring certain

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 22 O.S. 2021, Section 171.3, is
amended to read as follows:

Section 171.3. A. A law enforcement agency that has custody of
a person who is subject to an immigration detainer request issued by
the United States Immigration and Customs Enforcement shall:

1. Comply with, honor and fulfill any request made in the
immigration detainer request provided by the United States
Immigration and Customs Enforcement; and

2. Inform the person identified in the immigration detainer
request that he or she is being held pursuant to an immigration
detainer request issued by the United States Immigration and Customs
Enforcement.

B. A law enforcement agency shall not be required to perform a
duty imposed by subsection A of this section with respect to a
person who has provided proof that the person is a citizen of the
United States. Such proof may include:

1 1. An Oklahoma driver license or identification card issued by
2 ~~the Department of Public Safety~~ Service Oklahoma on or after
3 November 1, 2007; or

4 2. State- or federal government-issued identification.

5 C. As used in this section:

6 1. "Immigration detainer request" means a federal government
7 request to a local entity to maintain temporary custody of an alien,
8 including a United States Department of Homeland Security Form I-247
9 document or a similar successor form; and

10 2. "Law enforcement agency" means any state, county or
11 municipal agency or department which maintains custody of persons
12 accused of, charged with or convicted of any criminal offense. This
13 term includes, but shall not be limited to, peace officers,
14 sheriffs, deputy sheriffs, jailers, correctional officers, agents,
15 employees or contractors of a law enforcement agency.

16 SECTION 2. AMENDATORY 22 O.S. 2021, Section 471.6, as
17 amended by Section 5, Chapter 277, O.S.L. 2022 (22 O.S. Supp. 2022,
18 Section 471.6), is amended to read as follows:

19 Section 471.6. A. The drug court judge shall conduct a hearing
20 as required by subsection F of Section 471.4 of this title to
21 determine final eligibility by considering:

22 1. Whether the offender voluntarily consents to the program
23 requirements;

1 2. Whether to accept the offender based upon the findings and
2 recommendations of the drug court investigation authorized by
3 Section 471.4 of this title;

4 3. Whether there is a written plea agreement, and if so,
5 whether the terms and conditions of the written negotiated plea
6 between the district attorney, the defense attorney and the offender
7 are appropriate and consistent with the penalty provisions and
8 conditions of other similar cases;

9 4. Whether there is an appropriate treatment program available
10 to the offender and whether there is a recommended treatment plan;
11 and

12 5. Any information relevant to determining eligibility;
13 provided, however, an offender shall not be denied admittance to any
14 drug court program based upon an inability to pay court costs or
15 other costs or fees.

16 B. At the hearing to determine final eligibility for the drug
17 court program, the judge shall not grant any admission of any
18 offender to the program when:

19 1. The required treatment plan and plea agreement have not been
20 completed;

21 2. The program funding or availability of treatment has been
22 exhausted;

23 3. The treatment program or drug court team is unwilling to
24 accept the offender;

1 4. The offender does not meet the presumptive eligibility
2 criteria of the program; or

3 5. The offender is inappropriate for admission to the program,
4 in the discretion of the judge.

5 C. At the final eligibility hearing, if evidence is presented
6 that was not discovered by the drug court investigation, the
7 district attorney or the defense attorney may make an objection and
8 may ask the court to withdraw the plea agreement previously
9 negotiated. The court shall determine whether to proceed and
10 overrule the objection, to sustain the objection and transfer the
11 case for traditional criminal prosecution or to require further
12 negotiations of the plea or punishment provisions. The decision of
13 the judge for or against eligibility and admission shall be final.

14 D. When the court accepts the treatment plan with the written
15 plea agreement, the offender, upon entering the plea as agreed by
16 the parties, shall be ordered and escorted immediately into the
17 program. The offender must have voluntarily signed the necessary
18 court documents before the offender may be admitted to treatment.
19 The court documents shall include:

20 1. Waiver of the offender's rights to speedy trial;

21 2. A written plea agreement which sets forth the offense
22 charged, the penalty to be imposed for the offense in the event of a
23 breach of the agreement and the penalty to be imposed, if any, in
24 the event of a successful completion of the treatment program;

1 provided, however, incarceration shall be prohibited when the
2 offender completes the treatment program;

3 3. A written treatment plan which is subject to modification at
4 any time during the program; and

5 4. A written performance contract requiring the offender to
6 enter the treatment program as directed by the court and participate
7 until completion, withdrawal or removal by the court.

8 E. If admission into the drug court program is denied, the
9 criminal case shall be returned to the traditional criminal docket
10 and shall proceed as provided for any other criminal case.

11 F. At the time an offender is admitted to the drug court
12 program, any bail or undertaking on behalf of the offender shall be
13 exonerated.

14 G. The period of time during which an offender may participate
15 in the active treatment portion of the drug court program shall be
16 not less than six (6) months nor more than twenty-four (24) months
17 and may include a period of supervision not less than six (6) months
18 nor more than one (1) year following the treatment portion of the
19 program. The period of supervision may be extended by order of the
20 court for not more than six (6) months. No treatment dollars shall
21 be expended on the offender during the extended period of
22 supervision. If the court orders that the period of supervision
23 shall be extended, the drug court judge, district attorney, the
24 attorney for the offender and the supervising staff for the drug

1 court program shall evaluate the appropriateness of continued
2 supervision on a quarterly basis. All participating treatment
3 providers shall be certified by the Department of Mental Health and
4 Substance Abuse Services and shall be selected and evaluated for
5 performance-based effectiveness annually by the Department of Mental
6 Health and Substance Abuse Services. Treatment programs shall be
7 designed to be completed within twelve (12) months and shall have
8 relapse prevention and evaluation components.

9 H. The drug court judge shall order the offender to pay court
10 costs, treatment costs, drug testing costs, a program user fee not
11 to exceed Twenty Dollars (\$20.00) per month and necessary
12 supervision fees, unless the offender is indigent. The drug court
13 judge shall establish a schedule for the payment of costs and fees.
14 The cost for treatment, drug testing and supervision shall be set by
15 the treatment and supervision providers respectively and made part
16 of the court's order for payment. User fees shall be set by the
17 drug court judge within the maximum amount authorized by this
18 subsection and payable directly to the court clerk for the benefit
19 and administration of the drug court program. Treatment, drug
20 testing and supervision costs shall be paid to the respective
21 providers. The court clerk shall collect all other costs and fees
22 ordered and deposit such costs and fees with the county treasurer in
23 a drug court fund created and administered pursuant to subsection I
24 of Section 471.1 of this title. The remaining user fees shall be

1 remitted to the State Treasurer by the court clerk for deposit in
2 the Department of Mental Health and Substance Abuse Services' Drug
3 Abuse Education and Treatment Revolving Fund established pursuant to
4 Section 2-503.2 of Title 63 of the Oklahoma Statutes. Court orders
5 for costs and fees pursuant to this subsection shall not be limited
6 for purposes of collection to the maximum term of imprisonment for
7 which the offender could have been imprisoned for the offense, nor
8 shall any court order for costs and fees be limited by any term of
9 probation, parole, supervision, treatment or extension thereof.

10 Court orders for costs and fees shall remain an obligation of the
11 offender until fully paid; provided, however, once the offender has
12 successfully completed the drug court program, the drug court judge
13 shall have the discretion to expressly waive all or part of the
14 costs and fees provided for in this subsection if, in the opinion of
15 the drug court judge, continued payment of the costs and fees by the
16 offender would create a financial hardship for the offender.

17 Offenders who have not fully paid all costs and fees pursuant to
18 court order but who have otherwise successfully completed the drug
19 court program shall not be counted as an active drug court
20 participant for purposes of drug court contracts or program
21 participant numbers.

22 I. Notwithstanding any other provision of law, if the driving
23 privileges of the offender have been suspended, revoked, canceled or
24 denied by ~~the Department of Public Safety~~ Service Oklahoma and if

1 the drug court judge determines that no other means of
2 transportation for the offender is available, the drug court judge
3 may enter a written order requiring ~~the Department of Public Safety~~
4 Service Oklahoma to stay any and all such actions against the Class
5 D driving privileges of the offender; provided, the stay shall not
6 be construed to grant driving privileges to an offender who has not
7 been issued a driver license by ~~the Department~~ Service Oklahoma or
8 whose Oklahoma driver license has expired, in which case the
9 offender shall be required to apply for and be found eligible for a
10 driver license, pass all examinations, if applicable, and pay all
11 statutory driver license issuance or renewal fees. The offender
12 shall provide proof of insurance to the drug court judge prior to
13 the judge ordering a stay of any driver license suspension,
14 revocation, cancellation or denial. When a judge of a drug court
15 enters a stay against an order by ~~the Department of Public Safety~~
16 Service Oklahoma suspending or revoking the driving privileges of an
17 offender, the time period set in the order by ~~the Department~~ Service
18 Oklahoma for the suspension or revocation shall continue to run
19 during the stay. When an offender has successfully completed the
20 drug court program, the drug court judge shall maintain jurisdiction
21 over the offender's driving privileges for one (1) year after the
22 date on which the offender graduates from the drug court program.

1 SECTION 3. AMENDATORY 22 O.S. 2021, Section 983, as
2 amended by Section 5, Chapter 350, O.S.L. 2022 (22 O.S. Supp. 2022,
3 Section 983), is amended to read as follows:

4 Section 983. A. 1. Except in cases provided for in Section
5 983b of this title, when the judgment and sentence of a court,
6 either in whole or in part, imposes fines, costs, fees, or
7 assessments upon a defendant, the court at the time of sentencing
8 shall require the defendant to complete under oath a form
9 promulgated by the Court of Criminal Appeals that provides current
10 information regarding the financial ability of the defendant to pay.

11 2. The information to be required on the form shall include,
12 but not be limited to, the individual and household income and
13 living expenses of the defendant, excluding child support and any
14 monies received from a federal or state government need-based or
15 disability assistance program, the number of dependents, a listing
16 of assets, excluding assets exempt from bankruptcy, child support
17 obligations, health, mental or behavioral health conditions that
18 diminish the ability of the defendant to pay restitution, and
19 additional court-related expenses to be paid by the defendant.

20 3. For purposes of this section, fines, costs, fees, and
21 assessments shall include all financial obligations imposed by the
22 court or required by law to be paid, excluding restitution or
23 payments to be made other than to the court clerk, and shall be
24 referred to as financial obligations.

1 B. 1. The court shall order the defendant to appear
2 immediately after sentencing at the office of the court clerk who
3 shall inform the defendant of the total amount of all financial
4 obligations that have been ordered by the court. If the defendant
5 states to the court clerk that he or she is unable to pay the
6 financial obligations immediately, the court clerk, based on the
7 verified information provided by the defendant, shall establish,
8 subject to approval of the court, a monthly installment plan that
9 will cause the financial obligations to be satisfied within no more
10 than seventy-two (72) months, unless extended by the court.

11 2. The court clerk shall advise the defendant orally and by
12 delivery of a form promulgated by the Court of Criminal Appeals,
13 that:

14 a. it is the obligation of the defendant to keep the
15 court clerk informed of the contact information of the
16 defendant until the financial obligations have been
17 paid. Such information shall include the current
18 mailing and physical addresses of the defendant,
19 telephone or cellular phone number of the defendant,
20 and the email address where the defendant may receive
21 notice from the court,

22 b. if the defendant is unable to pay the financial
23 obligations ordered by the court immediately or in the
24 installments recommended by the court clerk, the

1 defendant may request a cost hearing for the court to
2 determine the ability of the defendant to pay the
3 amount due and to request modification of the
4 installment plan, a reduction in the amount owed, or
5 waiver of payment of the amount owed, and

6 c. upon any subsequent change in circumstances affecting
7 the ability of the defendant to pay, the defendant may
8 contact the court clerk and request additional cost
9 hearings before the court.

10 3. An order shall be filed in the case with the approval or
11 disapproval by the court of the payment plan. If the court does not
12 approve the payment plan recommended by the court clerk, the court
13 shall enter its order establishing the payment plan. The defendant
14 shall be notified by certified mail or personal service of the order
15 entered by the court and shall be given the opportunity for a cost
16 hearing.

17 4. The district court for each county and all municipal courts
18 shall set a regular time and courtroom for cost hearings.

19 C. If the defendant requests a cost hearing, the court clerk
20 shall set the hearing no later than sixty (60) days after
21 sentencing. In determining the ability of the defendant to pay, the
22 court shall rely on the verified information submitted by the
23 defendant on the form promulgated by the Court of Criminal Appeals
24 and any updates to the information. In addition, the court may make

1 inquiry of the defendant and consider any other evidence or
2 testimony concerning the ability of the defendant to pay.

3 D. 1. If at the initial cost hearing or any subsequent cost
4 hearing, the court determines that the defendant is unable to
5 immediately pay the financial obligations or the required
6 installments, the court may reduce the amount of the installments,
7 extend the payment plan beyond seventy-two (72) months, or waive
8 payment of all or part of the amount owed. The court may include a
9 financial incentive for accelerated payment. Additionally, the
10 court may order community service in lieu of payment. The defendant
11 shall receive credit for no less than two times the amount of the
12 minimum wage specified pursuant to state law for each hour of
13 community service.

14 2. If at any time due to a change in conditions the defendant
15 is unable to pay the financial obligations ordered by the court or
16 any installment, the defendant may request an additional cost
17 hearing.

18 E. If the court determines that a waiver of any of the
19 financial obligations is warranted, the court shall equally apply
20 the same percentage reduction to all fines, costs, fees, and
21 assessments, excluding restitution.

22 F. 1. If a defendant is delinquent in the payment of financial
23 obligations or an installment by more than sixty (60) days, the
24 court clerk shall notify the court which shall, within ten (10) days

1 thereafter, set a cost hearing for the court to determine if the
2 defendant is able to pay. The hearing shall be set on a date that
3 will allow the court clerk to issue a summons fourteen (14) days
4 prior to the cost hearing.

5 2. No less than fourteen (14) days prior to the cost hearing,
6 the court clerk shall issue one summons to the defendant to be
7 served by United States mail to the mailing address of the defendant
8 on file in the case, substantially as follows:

9 SUMMONS

10 You are ORDERED to appear for a cost hearing at a specified time,
11 place, and date to determine if you are financially able but
12 willfully refuse or neglect to pay the fines, costs, fees, or
13 assessments or an installment due in Case No._____.

14 You must be present at the hearing.

15 At any time before the date of the cost hearing, you may contact the
16 court clerk and pay the fines, costs, fees, or assessments or any
17 installment due.

18 THIS IS NOT AN ARREST WARRANT. However, if you fail to appear for
19 the cost hearing or to make the payment, the court will issue a
20 WARRANT for "FAILURE TO APPEAR-COST HEARING" and refer the case to a
21 court cost compliance liaison which will cause an additional thirty
22 percent (30%) administrative fee to be added to the amount owed.

23 3. If the defendant fails to appear at the cost hearing or pay
24 the amount due the court shall issue a warrant for FAILURE TO

1 APPEAR-COST HEARING and refer the case to the court cost compliance
2 program as provided in subsection K of this section.

3 4. Municipal courts, in lieu of mailing the summons provided
4 for in this subsection, may give the defendant personal notice at
5 the time of sentencing of a specific date, time, and place, not less
6 than sixty (60) nor more than one hundred twenty (120) days from the
7 date of sentencing to appear for a cost hearing if the fines, costs,
8 fees, and assessments remain unpaid.

9 G. If a defendant is found by a law enforcement officer to have
10 an outstanding warrant for FAILURE TO APPEAR-COST HEARING, the law
11 enforcement officer shall release the defendant and issue a citation
12 to appear pursuant to Section 209 of this title. If the defendant
13 fails to appear at the time and place cited by the law enforcement
14 officer, the court may issue a summons or warrant as provided in
15 Section 209 of this title. The provisions of this subsection shall
16 not apply to a municipal court if the municipal court has previously
17 provided personal service to the defendant of an opportunity for a
18 cost hearing.

19 H. In determining whether the defendant is able to pay
20 delinquent financial obligations or any installments due, the court
21 shall consider the criteria provided in subsection C of this
22 section.

23 I. Any defendant found guilty of an offense in any court of
24 this state may be imprisoned for nonpayment of his or her financial

1 obligations when the court finds after notice and hearing that the
2 defendant is financially able but willfully refuses or neglects to
3 pay the financial obligations owed. A sentence to pay a fine, cost,
4 fee, or assessment may be converted into a jail sentence only after
5 a hearing and a judicial determination, memorialized of record, that
6 the defendant is able to satisfy the fine, cost, fee, or assessment
7 by payment, but refuses or neglects so to do.

8 J. In addition, the district court or municipal court, within
9 one hundred twenty (120) days from the date upon which the person
10 was originally ordered to make payment, and if the court finds and
11 memorializes into the record that the defendant is financially able
12 but willfully refuses to or neglects to pay the fines, costs, fees,
13 or assessments, or an installment due, may send notice of nonpayment
14 of any court ordered fine and costs for a moving traffic violation
15 to ~~the Department of Public Safety~~ Service Oklahoma with a
16 recommendation of suspension of driving privileges of the defendant
17 until the total amount of any fine and costs has been paid. Upon
18 receipt of payment of the total amount of the fine and costs for the
19 moving traffic violation, the court shall send notice thereof to ~~the~~
20 ~~Department~~ Service Oklahoma, if a nonpayment notice was sent as
21 provided for in this subsection. Notices sent to ~~the Department~~
22 Service Oklahoma shall be on forms or by a method approved by ~~the~~
23 ~~Department~~ Service Oklahoma.

1 K. All counties of the state shall fully utilize and
2 participate in the court cost compliance program. Cases shall be
3 referred to the court cost compliance program not less than thirty
4 (30) days nor more than sixty (60) days after the defendant fails to
5 appear for a cost hearing unless the defendant pays the amount owed
6 on the financial obligation, or an installment due. When the court
7 refers the case, the updated contact information on file shall be
8 forwarded to a court cost compliance liaison for collection
9 purposes.

10 L. The Court of Criminal Appeals shall implement procedures,
11 forms, and rules consistent with the provisions of this section for
12 methods of establishing payment plans of fines, costs, fees, and
13 assessments by indigents, which procedures, forms, and rules shall
14 be distributed to all district courts and municipal courts by the
15 Administrative Office of the Courts.

16 SECTION 4. AMENDATORY 22 O.S. 2021, Section 991a, as
17 amended by Section 2, Chapter 469, O.S.L. 2021, is amended to read
18 as follows:

19 Section 991a. A. Except as otherwise provided in the Elderly
20 and Incapacitated Victim's Protection Program, when a defendant is
21 convicted of a crime and no death sentence is imposed, the court
22 shall either:

23 1. Suspend the execution of sentence in whole or in part, with
24 or without probation. The court, in addition, may order the

1 convicted defendant at the time of sentencing or at any time during
2 the suspended sentence to do one or more of the following:

- 3 a. to provide restitution to the victim as provided by
4 Section 991f et seq. of this title or according to a
5 schedule of payments established by the sentencing
6 court, together with interest upon any pecuniary sum
7 at the rate of twelve percent (12%) per annum, if the
8 defendant agrees to pay such restitution or, in the
9 opinion of the court, if the defendant is able to pay
10 such restitution without imposing manifest hardship on
11 the defendant or the immediate family and if the
12 extent of the damage to the victim is determinable
13 with reasonable certainty,
- 14 b. to reimburse any state agency for amounts paid by the
15 state agency for hospital and medical expenses
16 incurred by the victim or victims, as a result of the
17 criminal act for which such person was convicted,
18 which reimbursement shall be made directly to the
19 state agency, with interest accruing thereon at the
20 rate of twelve percent (12%) per annum,
- 21 c. to engage in a term of community service without
22 compensation, according to a schedule consistent with
23 the employment and family responsibilities of the
24 person convicted,

- 1 d. to pay a reasonable sum into any trust fund
2 established pursuant to the provisions of Sections 176
3 through 180.4 of Title 60 of the Oklahoma Statutes and
4 which provides restitution payments by convicted

14 provided, however, the authority of this provision is
15 limited to Section 843.5 of Title 21 of the Oklahoma
16 Statutes when the offense involved sexual abuse or
17 sexual exploitation; Sections 681, 741 and 843.1 of
18 Title 21 of the Oklahoma Statutes when the offense
19 involved sexual abuse or sexual exploitation; and
20 Sections 865 et seq., 885, 886, 888, 891, 1021,
21 1021.2, 1021.3, 1040.13a, 1087, 1088, 1111.1, 1115 and
22 1123 of Title 21 of the Oklahoma Statutes,
- 23 g. to repay the reward or part of the reward paid by a
24 local certified crime stoppers program and the

Oklahoma Reward System. In determining whether the defendant shall repay the reward or part of the reward, the court shall consider the ability of the defendant to make the payment, the financial hardship on the defendant to make the required payment and the importance of the information to the prosecution of the defendant as provided by the arresting officer or the district attorney with due regard for the confidentiality of the records of the local certified crime stoppers program and the Oklahoma Reward System. The court shall assess this repayment against the defendant as a cost of prosecution. The term "certified" means crime stoppers organizations that annually meet the certification standards for crime stoppers programs established by the Oklahoma Crime Stoppers Association to the extent those standards do not conflict with state statutes. The term "court" refers to all municipal and district courts within this state. The "Oklahoma Reward System" means the reward program established by Section 150.18 of Title 74 of the Oklahoma Statutes,

h. to reimburse the Oklahoma State Bureau of Investigation for costs incurred by that agency during its investigation of the crime for which the defendant

1 pleaded guilty, nolo contendere or was convicted
2 including compensation for laboratory, technical or
3 investigation services performed by the Bureau if, in
4 the opinion of the court, the defendant is able to pay
5 without imposing manifest hardship on the defendant,
6 and if the costs incurred by the Bureau during the

12 bb. to restore damaged property in kind or payment of out-
13 of-pocket expenses to the victim, if the court is able
14 to determine the actual out-of-pocket expenses
15 suffered by the victim,

16 cc. to attend a victim-offender reconciliation program if
17 the victim agrees to participate and the offender is
18 deemed appropriate for participation,

19 dd. in the case of a person convicted of prostitution
20 pursuant to Section 1029 of Title 21 of the Oklahoma
21 Statutes, require such person to receive counseling
22 for the behavior which may have caused such person to
23 engage in prostitution activities. Such person may be
24 required to receive counseling in areas including but

1 not limited to alcohol and substance abuse, sexual
2 behavior problems or domestic abuse or child abuse
3 problems,

4 ee. in the case of a sex offender sentenced after November
5 1, 1989, and required by law to register pursuant to
6 the Sex Offender Registration Act, the court shall
7 require the person to comply with sex offender
8 specific rules and conditions of supervision
9 established by the Department of Corrections and
10 require the person to participate in a treatment
11 program designed for the treatment of sex offenders
12 during the period of time while the offender is
13 subject to supervision by the Department of
14 Corrections. The treatment program shall include
15 polygraph examinations specifically designed for use

8 participate in a drug court program, if available. If
9 a drug court program is not available, the defendant
10 may be required to participate in a community
11 sanctions program, if available,

12 gg. in the case of a person convicted of any false or
13 bogus check violation, as defined in Section 1541.4 of
14 Title 21 of the Oklahoma Statutes, impose a fee of
15 Twenty-five Dollars (\$25.00) to the victim for each
16 check, and impose a bogus check fee to be paid to the
17 district attorney. The bogus check fee paid to the
18 district attorney shall be equal to the amount
19 assessed as court costs plus Twenty-five Dollars
20 (\$25.00) for each check upon filing of the case in

2 defendant, if in the opinion of the court the
3 defendant has the ability to pay such fee,

4 c. to both participate in the alcohol and drug substance
5 abuse course or treatment program, pursuant to
6 subparagraph a of this paragraph and attend a victims
7 impact panel program, pursuant to subparagraph b of
8 this paragraph,

9 d. to install, at the expense of the person, an ignition
10 interlock device approved by the Board of Tests for
11 Alcohol and Drug Influence, upon every motor vehicle
12 operated by such person and to require that a notation
13 of this restriction be affixed to the person's driver
14 license at the time of reinstatement of the license.
15 The restriction shall remain on the driver license for
16 such period as the court shall determine. The
17 restriction may be modified or removed by order of the
18 court and notice of the order shall be given to ~~the~~
19 ~~Department of Public Safety~~ Service Oklahoma. Upon
20 the expiration of the period for the restriction, ~~the~~
21 ~~Department of Public Safety~~ Service Oklahoma shall
22 remove the restriction without further court order.
23 Failure to comply with the order to install an
24 ignition interlock device or operating any vehicle

1 without such device during the period of restriction
2 shall be a violation of the sentence and may be
3 punished as deemed proper by the sentencing court, or
4 e. beginning January 1, 1993, to submit to electronically
5 monitored home detention administered and supervised
6 by the Department of Corrections, and to pay to the
7 Department a monitoring fee, not to exceed Seventy-
8 five Dollars (\$75.00) a month, to the Department of
9 Corrections, if in the opinion of the court the
10 defendant has the ability to pay such fee. Any fees
11 collected pursuant to this subparagraph shall be
12 deposited in the Department of Corrections Revolving
13 Fund. Any order by the court for the payment of the
14 monitoring fee, if willfully disobeyed, may be
15 enforced as an indirect contempt of court;

16 8. In addition to the other sentencing powers of the court, in
17 the case of a person convicted of prostitution pursuant to Section
18 1029 of Title 21 of the Oklahoma Statutes, require such person to
19 receive counseling for the behavior which may have caused such
20 person to engage in prostitution activities. Such person may be
21 required to receive counseling in areas including but not limited to
22 alcohol and substance abuse, sexual behavior problems or domestic
23 abuse or child abuse problems;

1 9. In addition to the other sentencing powers of the court, in
2 the case of a person convicted of any crime related to domestic
3 abuse, as defined in Section 60.1 of this title, the court may
4 require the defendant to undergo the treatment or participate in the
5 counseling services necessary to bring about the cessation of
6 domestic abuse against the victim. The defendant may be required to
7 pay all or part of the cost of the treatment or counseling services;

8 10. In addition to the other sentencing powers of the court,
9 the court, in the case of a sex offender sentenced after November 1,
10 1989, and required by law to register pursuant to the Sex Offenders
11 Registration Act, shall require the defendant to participate in a
12 treatment program designed specifically for the treatment of sex
13 offenders, if available. The treatment program will include
14 polygraph examinations specifically designed for use with sex
15 offenders for the purpose of supervision and treatment compliance,
16 provided the examination is administered by a certified licensed
17 polygraph examiner. The treatment program must be approved by the
18 Department of Corrections or the Department of Mental Health and
19 Substance Abuse Services. Such treatment shall be at the expense of
20 the defendant based on the ability of the defendant to pay;

21 11. In addition to the other sentencing powers of the court,
22 the court, in the case of a person convicted of abuse or neglect of
23 a child, as defined in Section 1-1-105 of Title 10A of the Oklahoma
24 Statutes, may require the person to undergo treatment or to

1 participate in counseling services. The defendant may be required
2 to pay all or part of the cost of the treatment or counseling
3 services;

4 12. In addition to the other sentencing powers of the court,
5 the court, in the case of a person convicted of cruelty to animals
6 pursuant to Section 1685 of Title 21 of the Oklahoma Statutes, may
7 require the person to pay restitution to animal facilities for
8 medical care and any boarding costs of victimized animals;

9 13. In addition to the other sentencing powers of the court, a
10 sex offender who is habitual or aggravated as defined by Section 584
11 of Title 57 of the Oklahoma Statutes and who is required to register
12 as a sex offender pursuant to the Sex Offenders Registration Act
13 shall be supervised by the Department of Corrections for the
14 duration of the registration period and shall be assigned to a
15 global position monitoring device by the Department of Corrections
16 for the duration of the registration period. The cost of such
17 monitoring device shall be reimbursed by the offender;

18 14. In addition to the other sentencing powers of the court, in
19 the case of a sex offender who is required by law to register
20 pursuant to the Sex Offenders Registration Act, the court may
21 prohibit the person from accessing or using any Internet social
22 networking website that has the potential or likelihood of allowing
23 the sex offender to have contact with any child who is under the age
24 of eighteen (18) years;

1 15. In addition to the other sentencing powers of the court, in
2 the case of a sex offender who is required by law to register
3 pursuant to the Sex Offenders Registration Act, the court shall
4 require the person to register any electronic mail address
5 information, instant message, chat or other Internet communication
6 name or identity information that the person uses or intends to use
7 while accessing the Internet or used for other purposes of social
8 networking or other similar Internet communication; or

9 16. In addition to the other sentencing powers of the court,
10 and pursuant to the terms and conditions of a written plea
11 agreement, the court may prohibit the defendant from entering,
12 visiting or residing within the judicial district in which the
13 defendant was convicted until after completion of his or her
14 sentence; provided, however, the court shall ensure that the
15 defendant has access to those services or programs for which the
16 defendant is required to participate as a condition of probation.
17 When seeking to enter the prohibited judicial district for personal
18 business not related to his or her criminal case, the defendant
19 shall be required to obtain approval by the court.

20 B. Notwithstanding any other provision of law, any person who
21 is found guilty of a violation of any provision of Section 761 or
22 11-902 of Title 47 of the Oklahoma Statutes or any person pleading
23 guilty or nolo contendere for a violation of any provision of such
24 sections shall be ordered to participate in, prior to sentencing, an

1 alcohol and drug assessment and evaluation by an assessment agency
2 or assessment personnel certified by the Department of Mental Health
3 and Substance Abuse Services for the purpose of evaluating the
4 receptivity to treatment and prognosis of the person. The court
5 shall order the person to reimburse the agency or assessor for the
6 evaluation. The fee shall be the amount provided in subsection C of
7 Section 3-460 of Title 43A of the Oklahoma Statutes. The evaluation
8 shall be conducted at a certified assessment agency, the office of a
9 certified assessor or at another location as ordered by the court.
10 The agency or assessor shall, within seventy-two (72) hours from the
11 time the person is assessed, submit a written report to the court
12 for the purpose of assisting the court in its final sentencing
13 determination. No person, agency or facility operating an alcohol
14 and drug substance abuse evaluation program certified by the
15 Department of Mental Health and Substance Abuse Services shall
16 solicit or refer any person evaluated pursuant to this subsection
17 for any treatment program or alcohol and drug substance abuse
18 service in which such person, agency or facility has a vested
19 interest; however, this provision shall not be construed to prohibit
20 the court from ordering participation in or any person from
21 voluntarily utilizing a treatment program or alcohol and drug
22 substance abuse service offered by such person, agency or facility.
23 If a person is sentenced to the custody of the Department of
24 Corrections and the court has received a written evaluation report

1 pursuant to this subsection, the report shall be furnished to the
2 Department of Corrections with the judgment and sentence. Any
3 evaluation report submitted to the court pursuant to this subsection
4 shall be handled in a manner which will keep such report
5 confidential from the general public's review. Nothing contained in
6 this subsection shall be construed to prohibit the court from
7 ordering judgment and sentence in the event the defendant fails or
8 refuses to comply with an order of the court to obtain the
9 evaluation required by this subsection.

10 C. When sentencing a person convicted of a crime, the court
11 shall first consider a program of restitution for the victim, as
12 well as imposition of a fine or incarceration of the offender. The
13 provisions of paragraph 1 of subsection A of this section shall not
14 apply to defendants being sentenced upon their third or subsequent
15 to their third conviction of a felony or, beginning January 1, 1993,
16 to defendants being sentenced for their second or subsequent felony
17 conviction for violation of Section 11-902 of Title 47 of the
18 Oklahoma Statutes, except as otherwise provided in this subsection.
19 In the case of a person being sentenced for his or her second or
20 subsequent felony conviction for violation of Section 11-902 of
21 Title 47 of the Oklahoma Statutes, the court may sentence the person
22 pursuant to the provisions of paragraph 1 of subsection A of this
23 section if the court orders the person to submit to electronically
24 monitored home detention administered and supervised by the

1 Department of Corrections pursuant to subparagraph e of paragraph 7
2 of subsection A of this section. Provided, the court may waive
3 these prohibitions upon written application of the district
4 attorney. Both the application and the waiver shall be made part of
5 the record of the case.

6 D. When sentencing a person convicted of a crime, the judge
7 shall consider any victim impact statements if submitted to the
8 jury, or the judge in the event a jury is waived.

9 E. Probation, for purposes of subsection A of this section, is
10 a procedure by which a defendant found guilty of a crime, whether
11 upon a verdict or plea of guilty or upon a plea of nolo contendere,
12 is released by the court subject to conditions imposed by the court
13 and subject to supervision by the Department of Corrections, a
14 private supervision provider or other person designated by the
15 court. Such supervision shall be initiated upon an order of
16 probation from the court, and shall not exceed two (2) years, unless
17 a petition alleging a violation of any condition of deferred
18 judgment or seeking revocation of the suspended sentence is filed
19 during the supervision, or as otherwise provided by law. In the
20 case of a person convicted of a sex offense, supervision shall begin
21 immediately upon release from incarceration or if parole is granted
22 and shall not be limited to two (2) years. Provided further, any
23 supervision provided for in this section may be extended for a
24 period not to exceed the expiration of the maximum term or terms of

1 the sentence upon a determination by the court or the Division of
2 Probation and Parole of the Department of Corrections that the best
3 interests of the public and the release will be served by an
4 extended period of supervision.

5 F. The Department of Corrections, or such other agency as the
6 court may designate, shall be responsible for the monitoring and
7 administration of the restitution and service programs provided for
8 by subparagraphs a, c and d of paragraph 1 of subsection A of this
9 section, and shall ensure that restitution payments are forwarded to
10 the victim and that service assignments are properly performed.

11 G. 1. The Department of Corrections is hereby authorized,
12 subject to funds available through appropriation by the Legislature,
13 to contract with counties for the administration of county Community
14 Service Sentencing Programs.

15 2. Any offender eligible to participate in the Program pursuant
16 to this section shall be eligible to participate in a county
17 Program; provided, participation in county-funded Programs shall not
18 be limited to offenders who would otherwise be sentenced to
19 confinement with the Department of Corrections.

20 3. The Department shall establish criteria and specifications
21 for contracts with counties for such Programs. A county may apply
22 to the Department for a contract for a county-funded Program for a
23 specific period of time. The Department shall be responsible for
24 ensuring that any contracting county complies in full with

1 specifications and requirements of the contract. The contract shall
2 set appropriate compensation to the county for services to the
3 Department.

4 4. The Department is hereby authorized to provide technical
5 assistance to any county in establishing a Program, regardless of
6 whether the county enters into a contract pursuant to this
7 subsection. Technical assistance shall include appropriate
8 staffing, development of community resources, sponsorship,
9 supervision and any other requirements.

10 5. The Department shall annually make a report to the Governor,
11 the President Pro Tempore of the Senate and the Speaker of the House
12 on the number of such Programs, the number of participating
13 offenders, the success rates of each Program according to criteria
14 established by the Department and the costs of each Program.

15 H. As used in this section:

16 1. "Ignition interlock device" means a device that, without
17 tampering or intervention by another person, would prevent the
18 defendant from operating a motor vehicle if the defendant has a
19 blood or breath alcohol concentration of two-hundredths (0.02) or
20 greater;

21 2. "Electronically monitored home detention" means
22 incarceration of the defendant within a specified location or
23 locations with monitoring by means of a device approved by the
24

1 Department of Corrections that detects if the person leaves the
2 confines of any specified location; and

3 3. "Victims impact panel program" means a program conducted by
4 a corporation registered with the Secretary of State in Oklahoma for
5 the sole purpose of operating a victims impact panel program. The
6 program shall include live presentations from presenters who will
7 share personal stories with participants about how alcohol, drug
8 abuse, the operation of a motor vehicle while using an electronic
9 communication device or the illegal conduct of others has personally
10 impacted the lives of the presenters. A victims impact panel
11 program shall be attended by persons who have committed the offense
12 of driving, operating or being in actual physical control of a motor
13 vehicle while under the influence of alcohol or other intoxicating
14 substance, operating a motor vehicle while the ability of the person
15 to operate such vehicle was impaired due to the consumption of
16 alcohol or any other substance or operating a motor vehicle while
17 using an electronic device or by persons who have been convicted of
18 furnishing alcoholic beverage to persons under twenty-one (21) years
19 of age, as provided in Sections 6-101 and 6-120 of Title 37A of the
20 Oklahoma Statutes. Persons attending a victims impact panel program
21 shall be required to pay a fee of Seventy-five Dollars (\$75.00) to
22 the provider of the program. A certificate of completion shall be
23 issued to the person upon satisfying the attendance and fee
24 requirements of the victims impact panel program. The certificate

1 of completion shall contain the business identification number of
2 the program provider. A certified assessment agency, certified
3 assessor or provider of an alcohol and drug substance abuse course
4 shall be prohibited from providing a victims impact panel program
5 and shall further be prohibited from having any proprietary or
6 pecuniary interest in a victims impact panel program. The provider
7 of the victims impact panel program shall carry general liability
8 insurance and maintain an accurate accounting of all business
9 transactions and funds received in relation to the victims impact
10 panel program. Beginning October 1, 2020, and each October 1
11 thereafter, the provider of the victims impact panel program shall
12 provide to the District Attorneys Council the following:

- 13 a. proof of registration with the Oklahoma Secretary of
14 State,
- 15 b. proof of general liability insurance,
- 16 c. end-of-year financial statements prepared by a
17 certified public accountant,
- 18 d. a copy of federal income tax returns filed with the
19 Internal Revenue Service,
- 20 e. a registration fee of One Thousand Dollars
21 (\$1,000.00). The registration fee shall be deposited
22 in the District Attorneys Council Revolving Fund
23 created in Section 215.28 of Title 19 of the Oklahoma
24 Statutes, and

1 f. a statement certifying that the provider of the
2 victims impact panel program has complied with all of
3 the requirements set forth in this paragraph.

4 I. A person convicted of a felony offense or receiving any form
5 of probation for an offense in which registration is required
6 pursuant to the Sex Offenders Registration Act, shall submit to
7 deoxyribonucleic acid (DNA) testing for law enforcement
8 identification purposes in accordance with Section 150.27 of Title
9 74 of the Oklahoma Statutes and the rules promulgated by the
10 Oklahoma State Bureau of Investigation for the OSBI Combined DNA
11 Index System (CODIS) Database. Subject to the availability of
12 funds, any person convicted of a misdemeanor offense of assault and
13 battery, domestic abuse, stalking, possession of a controlled
14 substance prohibited under the Uniform Controlled Dangerous
15 Substances Act, outraging public decency, resisting arrest, escape
16 or attempting to escape, eluding a police officer, Peeping Tom,
17 pointing a firearm, threatening an act of violence, breaking and
18 entering a dwelling place, destruction of property, negligent
19 homicide or causing a personal injury accident while driving under
20 the influence of any intoxicating substance, or any alien unlawfully
21 present under federal immigration law, upon arrest, shall submit to
22 DNA testing for law enforcement identification purposes in
23 accordance with Section 150.27 of Title 74 of the Oklahoma Statutes
24 and the rules promulgated by the Oklahoma State Bureau of

1 Investigation for the OSBI Combined DNA Index System (CODIS)
2 Database. Any defendant sentenced to probation shall be required to
3 submit to testing within thirty (30) days of sentencing either to
4 the Department of Corrections or to the county sheriff or other
5 peace officer as directed by the court. Defendants who are
6 sentenced to a term of incarceration shall submit to testing in
7 accordance with Section 530.1 of Title 57 of the Oklahoma Statutes,
8 for those defendants who enter the custody of the Department of
9 Corrections or to the county sheriff, for those defendants sentenced
10 to incarceration in a county jail. Convicted individuals who have
11 previously submitted to DNA testing under this section and for whom
12 a valid sample is on file in the OSBI Combined DNA Index System
13 (CODIS) Database at the time of sentencing shall not be required to
14 submit to additional testing. Except as required by the Sex
15 Offenders Registration Act, a deferred judgment does not require
16 submission to DNA testing.

17 Any person who is incarcerated in the custody of the Department
18 of Corrections after July 1, 1996, and who has not been released
19 before January 1, 2006, shall provide a blood or saliva sample prior
20 to release. Every person subject to DNA testing after January 1,
21 2006, whose sentence does not include a term of confinement with the
22 Department of Corrections shall submit a blood or saliva sample.
23 Every person subject to DNA testing who is sentenced to unsupervised
24 probation or otherwise not supervised by the Department of

1 Corrections shall submit for blood or saliva testing to the sheriff

3 J. Samples of blood or saliva for DNA testing required by
4 subsection I of this section shall be taken by employees or
5 contractors of the Department of Corrections, peace officers, or the
6 county sheriff or employees or contractors of the sheriff's office.
7 The individuals shall be properly trained to collect blood or saliva
8 samples. Persons collecting blood or saliva for DNA testing
9 pursuant to this section shall be immune from civil liabilities
10 arising from this activity. All collectors of DNA samples shall
11 ensure the collection of samples are mailed to the Oklahoma State
12 Bureau of Investigation within ten (10) days of the time the subject
13 appears for testing or within ten (10) days of the date the subject
14 comes into physical custody to serve a term of incarceration. All
15 collectors of DNA samples shall use sample kits provided by the OSBI
16 and procedures promulgated by the OSBI. Persons subject to DNA
17 testing who are not received at the Lexington Assessment and
18 Reception Center shall be required to pay a fee of Fifteen Dollars
19 (\$15.00) to the agency collecting the sample for submission to the
20 OSBI Combined DNA Index System (CODIS) Database. Any fees collected
21 pursuant to this subsection shall be deposited in the revolving
22 account or the service fee account of the collection agency or
23 department.

1 K. When sentencing a person who has been convicted of a crime
2 that would subject that person to the provisions of the Sex
3 Offenders Registration Act, neither the court nor the district
4 attorney shall be allowed to waive or exempt such person from the
5 registration requirements of the Sex Offenders Registration Act.

6 SECTION 5. AMENDATORY 22 O.S. 2021, Section 1111.2, is
7 amended to read as follows:

8 Section 1111.2. The arresting officer shall indicate on the
9 citation the date of the arraignment, and the defendant shall appear
10 in person or by counsel at the stated time and place for

22 of the district attorney, the court shall issue a bench warrant for

1 defendant's personal check is not honored, the court clerk shall
2 immediately forward to ~~the Department of Public Safety Service~~
3 Oklahoma the license stating that the check has not been honored.
4 If bail has been forfeited, on motion of the district attorney, the

1 B. If the arrested person is eligible for release on personal
2 recognizance as provided for in subsection A of this section, then

8 issuing state, and expiration date;

11 request provided for in paragraph 1 of this subsection if, with
12 respect to such charges:

- 13 a. the defendant was arraigned, posted bail, paid a fine,
14 was jailed, or otherwise settled the case,
- 15 b. the defendant was not released upon personal
16 recognizance upon an acknowledged written promise to
17 appear as provided for in this section or if released,
18 was not permitted to remain on such personal
19 recognizance for arraignment,
- 20 c. the violation relates to parking or standing, or
- 21 d. a period of one hundred twenty (120) calendar days or
22 more has elapsed from the date the citation was issued
23 by the arresting officer.

1 F. Following receipt of the notice and request from the court
2 clerk for driving privilege and driver license suspension as
3 provided for in subsection E of this section, ~~the Department of~~
4 ~~Public Safety~~ Service Oklahoma shall proceed as provided for in
5 Section 1115.5 of this title.

6 G. The municipal or district court clerk shall maintain a
7 record of each request for driving privilege and driver license
8 suspension submitted to ~~the Department of Public Safety~~ Service
9 Oklahoma pursuant to the provisions of this section. When the court
10 or court clerk receives appropriate bail or payment of the fine and
11 costs, settles the citation, makes other arrangements with the
12 defendant, or otherwise closes the case, the court clerk shall
13 furnish proof thereof to the defendant, if the defendant personally
14 appears, or shall mail such proof by first-class mail, postage
15 prepaid, to the defendant at the address noted on the citation or at
16 such other address as is furnished by the defendant or by email if
17 the defendant has furnished an email address for such purposes.
18 Additionally, the court or court clerk shall notify the home
19 jurisdiction of the defendant as listed on the citation, if such
20 jurisdiction is a member of the Nonresident Violator Compact, and
21 shall, in all other cases, notify ~~the Department~~ Service Oklahoma of
22 the resolution of the case. The form of proof and the procedures
23 for notification shall be approved by ~~the Department of Public~~
24 ~~Safety~~ Service Oklahoma. Provided however, failure by the court or

1 court clerk to furnish such proof or notice in the manner provided
2 for in this subsection shall in no event create any civil liability
3 upon the court, the court clerk, the State of Oklahoma or any
4 political subdivision thereof, or any state department or agency or
5 any employee thereof but duplicate proof shall be furnished to the
6 person entitled to such proof or notice upon request.

7 H. For purposes of this section, "electronic signature" shall
8 have the same meaning as defined in Section 15-102 of Title 12A of
9 the Oklahoma Statutes.

10 SECTION 8. AMENDATORY 22 O.S. 2021, Section 1115.5, is
11 amended to read as follows:

12 Section 1115.5. A. 1. Following receipt of notification and a
13 request for driving privilege suspension from a municipal or
14 district court clerk as provided for in Section 1115.1 of this title
15 or Section 1 of this act, ~~the Department of Public Safety~~ Service
16 Oklahoma shall:

- 17 a. suspend the privilege of the person to operate a motor
18 vehicle in this state; or
- 19 b. request suspension of the driving privilege of the
20 person in the state which issued the license as
21 provided by the Nonresident Violator Compact.

22 A person whose license is subject to suspension pursuant to this
23 section may avoid the effective date of the suspension or, if
24 suspended, shall be eligible for reinstatement, if otherwise

1 eligible, upon meeting the requirements of subsection C of this
2 section.

3 2. ~~The Department of Public Safety~~ Service Oklahoma may decline
4 to initiate such suspension action if the request is discovered to
5 be improper or questionable.

6 3. ~~The Department~~ Service Oklahoma shall not be required to
7 issue more than one suspension of the driving privilege of a person
8 in the event multiple requests for suspensions are received from a
9 court clerk based upon the failure of the person to appear at a
10 particular time and date on multiple charges.

11 B. Following receipt of a request from another jurisdiction for
12 the suspension of the driving privilege of an Oklahoma resident as
13 provided by the Nonresident Violator Compact, ~~the Department of~~
14 ~~Public Safety~~ Service Oklahoma, if the request appears to be valid,
15 shall initiate suspension of the privilege of the person to operate
16 a motor vehicle in this state. If suspended, such suspension shall
17 remain in effect until the person meets the requirements of
18 subsection C of this section.

19 C. 1. A person whose license is subject to suspension in this
20 state pursuant to the provisions of this section may avoid the
21 effective date of suspension, or if suspended in this state, shall
22 be eligible for reinstatement, if otherwise eligible, upon:

- 23 a. making application therefore to ~~the Department of~~
24 ~~Public Safety~~ Service Oklahoma, and

- b. showing proof from the court or court clerk that the person has entered an appearance in the case which was the basis for the suspension action and was released by the court as provided for by the Nonresident Violator Compact or consistent provisions, and
- c. submitting with the application the fees, as provided for in Section 6-212 of Title 47 of the Oklahoma Statutes. The fees shall be remitted to the State Treasurer to be credited to the General Revenue Fund of the State Treasury;

2. Upon reinstatement, ~~the Department of Public Safety Service~~ Oklahoma may remove any record of the suspension and reinstatement as provided for in this section from the file of the individual licensee and maintain an internal record of the suspension and reinstatement for fiscal and other purposes.

D. Any person whose driving privilege is suspended or subject to suspension in this state pursuant to the provisions of this section, at any time, may informally present specific reasons or documentation to ~~the Department of Public Safety Service~~ Oklahoma to show that such suspension may be unwarranted. ~~The Department of Public Safety Service~~ Oklahoma may stay the suspension or suspension action pending receipt of further information or documentation from the person or from the jurisdiction requesting such suspension, or pending review of the record, or other inquiry. If ~~the Department~~

1 ~~of Public Safety~~ Service Oklahoma determines the suspension is
2 unwarranted, the suspension action shall be withdrawn or vacated
3 without the requirement of a processing fee and a reinstatement fee
4 and ~~the Department of Public Safety~~ Service Oklahoma shall
5 accordingly notify the jurisdiction which requested the suspension.
6 If, however, the request for suspension appears valid, ~~the~~
7 ~~Department of Public Safety~~ Service Oklahoma shall proceed with

11 shall not consider modification, but shall either sustain or vacate

15 ~~Commission~~ Service Oklahoma or by a federally
16 recognized Indian tribe in the State of Oklahoma,
17 except as otherwise provided in subsection D of this
18 section. This section does not apply to farm
19 equipment as defined in Section 91.2 of this title.
20 The items of personal property to which this section
21 applies are collectively referred to as "Section 91
22 Personal Property". If personal property is
23 apparently covered both by this section and by
24 Sections 191 through 200 of this title, the procedures

1 set out in this section shall apply instead of
2 Sections 191 through 200 of this title.

3 b. Salvage pools as defined in Section 591.2 of Title 47
4 of the Oklahoma Statutes and class AA licensed wrecker
5 services taking possession of a vehicle pursuant to an
6 agreement with or at the direction of, or dispatched
7 by, a state or local law enforcement or government
8 agency, or pursuant to the abandoned vehicle renewal
9 provisions of Section 954A of Title 47 of the Oklahoma
10 Statutes, shall not be subject to the provisions of
11 this section, but shall be subject to the provisions
12 of Section 91A of this title. Unless otherwise
13 provided by this subparagraph, class AA licensed
14 wrecker services performing consensual tows shall be
15 subject to the provisions of this section.

16 2. Any person who, while lawfully in possession of an article
17 of Section 91 Personal Property, renders any service to the owner
18 thereof by furnishing storage, rental space, material, labor or
19 skill for the protection, improvement, safekeeping, towing, right to
20 occupy space, storage or carriage thereof, has a special lien
21 thereon, dependent on possession, for the compensation, if any,
22 which is due to such person from the owner for such service.

23 3. This special lien shall be subordinate to any perfected
24 security interest unless the claimant complies with the requirements

1 of this section. Failure to comply with any requirements of this
2 section shall result in denial of any title application and cause
3 the special lien to be subordinate to any perfected lien. Upon such
4 denial, the applicant shall be entitled to one resubmission of the
5 title application within fifteen (15) business days of receipt of
6 the denial, and proceed to comply with the requirements of this
7 section. In the event of a denial, the Notice of Possessory Lien
8 and the Notice of Sale may be mailed on the same day in separate
9 envelopes and storage charges shall only be charged from the date of
10 resubmission. "Failure to comply" includes, but is not limited to:

- 11 a. failure to timely provide additional documentation
12 supporting or verifying any entry on submitted forms as
13 requested by ~~the Tax Commission~~ Service Oklahoma,
14 including but not limited to United States Postal
15 Service proof of return receipt requested such as Form
16 3811 or United States Postal Service electronic
17 equivalent,
- 18 b. failure to provide the documentation supporting lawful
19 possession as defined in paragraph 3 of subsection H of
20 this section,
- 21 c. claimant or the agent being other than the individual
22 who provided the service giving rise to the special
23 lien, as in paragraph 2 of this subsection,
- 24 d. claimant not being in possession of the vehicle,

1 e. notice of lien not filed in accordance with paragraph 4
2 of this subsection, or

3 f. foreclosure notification and proceedings not
4 accomplished in accordance with paragraph 6 of this
5 section.

6 4. Any person claiming the special lien provided in paragraph 2
7 of this subsection shall mail a notice of such lien, no later than
8 sixty (60) days after the first services are rendered, by regular,
9 first-class United States mail, and by certified mail, return
10 receipt requested, to all interested parties who reside at separate
11 locations. If services provided are pursuant to a contract
12 primarily for the purpose of storage or rental of space, the
13 beginning date of the sixty-day period provided in the previous
14 sentence shall be the first day of the first period or partial
15 period for which rental or storage charges remain unpaid. The
16 notice shall be in writing and shall contain, but not be limited to,
17 the following:

18 a. a statement that the notice is a Notice of Possessory
19 Lien,

20 b. the complete legal name, physical and mailing address,
21 and telephone number of the claimant,

22 c. the complete legal name, physical and mailing address
23 of the person who requested that the claimant render
24 service to the owner by furnishing material, labor or

1 skill, storage, or rental space, or the date the
2 property was abandoned if the claimant did not render
3 any other service,

4 d. a description of the article of personal property,
5 including a photograph if the property is Section 91
6 Personal Property, and the complete physical and
7 mailing address of the location of the article of
8 personal property,

9 e. an itemized statement describing the date or dates the
10 labor or services were performed and material
11 furnished, and the charges claimed for each item, the
12 totals of which shall equal the total compensation
13 claimed,

14 f. a statement by the claimant that the materials, labor
15 or skill furnished, or arrangement for storage or
16 rental of space, was authorized by the owner of the
17 personal property and was in fact provided or
18 performed, and written proof of authority to perform
19 the work, labor or service, or that the property was
20 abandoned by the owner if the claimant did not render
21 any other service, and that storage or rental fees
22 will accrue as allowed by law, and

23 g. the signature of the claimant which shall be notarized
24 and, if applicable, the signature of the claimant's

1 attorney. If the claimant is a business, then the
2 name of the contact person representing the business
3 must be shown. In place of an original signature and
4 notary seal, a digital or electronic signature or seal
5 shall be accepted.

6 5. For services rendered or vehicles abandoned on or after
7 November 1, 2005, storage charges or charges for rental of space ,
8 unless agreed to by contract as part of an overall transaction or
9 arrangement that was primarily for the purpose of storage of the
10 Section 91 Personal Property or rental of space, may only be
11 assessed beginning with the day that the Notice of Possessory Lien
12 is mailed as evidenced by certified mail. Provided, however, in the
13 case of contractual charges incurred for storage or rental of space
14 in an overall transaction primarily for the purpose of storage or
15 rental, charges subject to the special lien may only be assessed
16 beginning with a date not more than sixty (60) days prior to the day
17 that the Notice of Possessory Lien is mailed, and shall accrue only
18 at the regular periodic rate for storage or rental as provided in
19 the contract, adjusted for partial periods of storage or rental.
20 The maximum allowable compensation for storage shall not exceed the
21 fees established by the Corporation Commission for nonconsensual
22 tows.

1 6. The lien may be foreclosed by a sale of such personal
2 property upon the notice and in the manner following: The Notice of
3 Sale shall be in writing and shall contain, but not be limited to:

4 a. a statement that the notice is a Notice of Sale,

5 b. the names of all interested parties known to the
6 claimant,

7 c. a description of the property to be sold, including a
8 photograph if the property is Section 91 Personal
9 Property and if the condition of such property has
10 materially changed since the mailing of Notice of
11 Possessory Lien required pursuant to paragraph 4 of
12 this subsection,

13 d. a notarized statement of the nature of the work, labor
14 or service performed, material furnished, or storage
15 or rental of space, and the date thereof, and the name
16 of the person who authorized the work, labor or
17 service performed, or the storage or rental
18 arrangement, and written proof of authority to perform
19 the work, labor or service, or that the property was
20 abandoned if the claimant did not render any other
21 service,

22 e. the date, time, and exact physical location of sale,

23 f. the name, complete physical address, mailing address,
24 and telephone number of the party foreclosing such

1 lien. If the claimant is a business, then the name of
2 the contact person representing the business must be
3 shown. In place of an original signature and notary
4 seal, a digital or electronic signature or seal shall
5 be accepted, and

6 g. itemized charges which shall equal the total
7 compensation claimed.

8 7. Such Notice of Sale shall be posted in two public places in
9 the county where the property is to be sold at least ten (10) days
10 before the time therein specified for such sale, and a copy of the
11 notice shall be mailed to all interested parties at their last-known
12 post office address by regular, first-class United States mail and
13 by certified mail, return receipt requested, at least ten (10) days
14 before the date of the sale. If the item of personal property is a
15 manufactured home, notice shall also be sent by certified mail to
16 the county treasurer and to the county assessor of the county where
17 the manufactured home is located.

18 8. Interested parties shall include all owners of the article
19 of personal property as indicated by the certificate of title issued
20 by ~~the Tax Commission~~ Service Oklahoma or by a federally recognized
21 Indian tribe in the State of Oklahoma; lien debtors, if any, other
22 than the owners; any lienholder whose lien is noted on the face of
23 the certificate of title; and any other person having any interest
24

1 in the article of personal property, of whom the claimant has actual
2 notice.

3 9. Any interested party shall be permitted to inspect and
4 verify the services rendered by the claimant prior to the sale of
5 the article of personal property during normal business hours. The
6 lienholder shall be allowed to retrieve the Section 91 Personal
7 Property without being required to bring the title into the
8 lienholder's name, if the lienholder provides proof it is a
9 lienholder and any payment due the claimant for lawful charges where
10 the claimant has complied with the requirements of this section.
11 Upon the release of personal property to an insurer or
12 representative of the insurer, wrecker operators shall be exempt
13 from all liability and shall be held harmless for any losses or
14 claims of loss.

15 10. The claimant or any other person may in good faith become a
16 purchaser of the property sold.

17 11. Proceedings for foreclosure under this act shall be
18 commenced no sooner than ten (10) days and no later than thirty (30)

20 evidenced by certified mail. The date actually sold shall be within
21 sixty (60) days from the date of the Notice of Sale as evidenced by
22 certified mail.

23 B. 1. a. Any person who is induced by means of a check or other
24 form of written order for immediate payment of money

1 to deliver up possession of an article of personal
2 property on which the person has a special lien
3 created by subsection A of this section, which check
4 or other written order is dishonored, or is not paid
5 when presented, shall have a lien for the amount
6 thereof upon the personal property.

7 b. The person claiming such lien shall, within thirty
8 (30) days from the date of dishonor of the check or
9 other written order for payment of money, file in the
10 office of the county clerk of the county in which the
11 property is situated a sworn statement that:

12 (1) the check or other written order for immediate
13 payment of money, copy thereof being attached,
14 was received for labor, material or supplies for
15 producing or repairing an article of personal
16 property, or for other specific property-related
17 services covered by this section,

18 (2) the check or other written order was not paid,
19 and

20 (3) the uttering of the check or other written order
21 constituted the means for inducing the person,
22 one possessed of a special lien created by
23 subsection A of this section upon the described
24

1 article of personal property, to deliver up the
2 article of personal property.

3 2. a. Any person who renders service to the owner of an
4 article of personal property by furnishing storage,
5 rental space, material, labor, or skill for the
6 protection, improvement, safekeeping, towing, right to
7 occupy space, storage, or carriage thereof shall have
8 a special lien on such property pursuant to this
9 section if such property is removed from the person's
10 possession, without such person's written consent or
11 without payment for such service.

12 b. The person claiming such lien shall, within five (5)
13 days of such nonauthorized removal, file in the office
14 of the county clerk of the county in which the
15 property is located, a sworn statement including:

16 (1) that services were rendered on or in relation to
17 the article of personal property by the person
18 claiming such lien,

19 (2) that the property was in the possession of the
20 person claiming the lien but such property was
21 removed without his or her written consent,

22 (3) an identifying description of the article of
23 personal property on which the service was
24 rendered, and

1 (4) that the debt for the services rendered on or in
2 relation to the article of personal property was
3 not paid. Provided, if the unpaid total amount
4 of the debt for services rendered on or in
5 relation to the article of personal property is
6 unknown, an approximated amount of the debt due
7 and owing shall be included in the sworn
8 statement but such approximated debt may be
9 amended within thirty (30) days of such filing to
10 reflect the actual amount of the debt due and
11 owing.

12 3. The enforcement of the lien shall be within sixty (60) days
13 after filing the lien in the manner provided by law for enforcing
14 the lien of a security agreement and provided that the lien shall
15 not affect the rights of innocent, intervening purchasers without
16 notice.

17 C. If the person who renders service to the owner of an article
18 of personal property to which this section applies relinquishes or
19 loses possession of the article due to circumstances described in
20 subparagraph a of paragraph 1 or subparagraph a of paragraph 2 of
21 subsection B of this section, the person claiming the lien shall be
22 entitled to possession of the article until the amount due is paid,
23 unless the article is possessed by a person who became a bona fide
24

1 purchaser. Entitlement to possession shall be in accordance with
2 the following:

3 1. The claimant may take possession of an article pursuant to
4 this subsection only if the person obligated under the contract for
5 services has signed an acknowledgement of receipt of a notice that
6 the article may be subject to repossession. The notice and
7 acknowledgement pursuant to this subsection shall be:

8 a. in writing and separate from the written contract for
9 services, or

10 b. printed on the written contract for services, credit
11 agreement or other document which displays the notice
12 in bold-faced, capitalized and underlined type, or is
13 separated from surrounding written material so as to
14 be conspicuous with a separate signature line;

15 2. The claimant may require the person obligated under the
16 contract for services to pay the costs of repossession as a
17 condition for reclaiming the article only to the extent of the
18 reasonable fair market value of the services required to take
19 possession of the article;

20 3. The claimant shall not transfer to a third party or to a
21 person who performs repossession services, a check, money order, or
22 credit card transaction that is received as payment for services
23 with respect to an article and that is returned to the claimant
24 because of insufficient funds or no funds, because the person

1 writing the check, issuing the money order, or credit cardholder has
2 no account or because the check, money order, or credit card account
3 has been closed. A person violating this paragraph shall be guilty
4 of a misdemeanor; and

5 4. An article that is repossessed pursuant to this subsection
6 shall be promptly delivered to the location where the services were
7 performed. The article shall remain at the services location at all
8 times until the article is lawfully returned to the record owner or
9 a lienholder or is disposed of pursuant to this section.

10 D. 1. If a vehicle, all-terrain vehicle, utility vehicle,
11 manufactured home, motorcycle, boat, outboard motor, or trailer has
12 a certificate of title issued by ~~the Tax Commission~~ Service Oklahoma
13 or by a federally recognized Indian tribe in the State of Oklahoma,
14 but there is no active lien recorded on the certificate of title,
15 Section 91A of this title will apply instead of this section.
16 Likewise, if there is an active lien recorded on the certificate of
17 title but the lien is over fifteen (15) years old and the property
18 is not a manufactured home, Section 91A of this title will apply
19 instead of this section.

20 2. If personal property that otherwise would be covered by this
21 section has been registered by ~~the Tax Commission~~ Service Oklahoma
22 or by a federally recognized Indian tribe in the State of Oklahoma,
23 and there is a lien of record but no certificate of title has been
24

1 issued, Section 91A of this title will apply instead of this
2 section.

3 3. If personal property otherwise would be covered by this
4 section, but the services were rendered or the property was
5 abandoned prior to November 1, 2005, Section 91A of this title will
6 apply instead of this section.

7 E. A person who knowingly makes a false statement of a material
8 fact regarding the furnishing of storage, rental space, material,
9 labor or skill for the protection, improvement, safekeeping, towing,
10 right to occupy space, storage or carriage thereof in a proceeding
11 under this section, or attempts to use or uses the provisions of
12 this section to foreclose an owner or lienholder's interest in a
13 vehicle knowing that any of the statements made in the proceeding
14 are false, upon conviction, shall be guilty of a felony.

15 F. Upon receipt of notice of legal proceedings, ~~the Tax~~
16 ~~Commission~~ Service Oklahoma shall cause the sale process to be put
17 on hold until notice of resolution of court proceedings is received
18 from the court. If such notice of commencement of court proceedings
19 is not filed with ~~the Tax Commission~~ Service Oklahoma, the
20 possessory lien sale process may continue.

21 G. No possessory lien sale shall be held on a Sunday.

22 H. For purposes of this section:

23 1. "Possession" includes actual possession and constructive
24 possession;

1 2. "Constructive possession" means possession by a person who,
2 although not in actual possession, does not have an intention to
3 abandon property, knowingly has both power and the intention at a
4 given time to exercise dominion or control over the property, and
5 who holds claim to such thing by virtue of some legal right;

6 3. "Lawfully in possession" means a person has documentation
7 from the owner or the owner's authorized agent, or an insurance
8 company or its authorized agent, authorizing the furnishing of
9 material, labor or storage, or that the property was authorized to
10 be towed to a repair facility. If the person lacks such
11 documentation, he or she shall not be lawfully in possession of the
12 Section 91 Personal Property and shall not be entitled to a special
13 lien as set forth in this section; and

14 4. "Itemized charges" means total parts, total labor, total
15 towing fees, total storage fees, total processing fees and totals of
16 any other fee groups, the sum total of which shall equal the
17 compensation claimed.

18 I. For purposes of this section, the United States Postal
19 Service approved electronic equivalent of proof of return receipt
20 requested Form 3811 shall satisfy return receipt requested
21 documentation requirements.

22 J. If a person claiming a special lien pursuant to this section
23 fails to comply with any of the requirements of this section, any
24 interested party may proceed against the person claiming such lien

1 for all damages arising therefrom, including conversion, if the
2 article of personal property has been sold. If the notice or
3 notices required by this section shall be shown to be knowingly
4 false or fraudulent, the interested party shall be entitled to
5 treble damages. The prevailing party shall be entitled to all
6 costs, including reasonable attorney fees.

7 K. This section shall apply to all actions or proceedings that
8 commence on or after the effective date of this act.

9 SECTION 11. AMENDATORY 42 O.S. 2021, Section 91A, is
10 amended to read as follows:

11 Section 91A.

12 A. 1. a. This section applies to all types of personal property
13 other than:

14 (1) farm equipment as defined in Section 91.2 of this
15 title, and

16 (2) "Section 91 Personal Property" as defined in
17 Section 91 of this title.

18 b. This section applies to any vehicle, all-terrain
19 vehicle, utility vehicle, manufactured home,
20 motorcycle, boat, outboard motor, or trailer that is
21 excluded from coverage under subsection A of Section
22 91 of this title because the personal property:

23 (1) does not have a certificate of title,
24

1 (2) has a certificate of title but does not have an
2 active lien recorded on the certificate of title,
3 (3) has a certificate of title that is not issued by
4 ~~the Oklahoma Tax Commission~~ Service Oklahoma or
5 by a federally recognized Indian tribe in the
6 State of Oklahoma, or
7 (4) is otherwise excluded by subparagraph b of
8 paragraph 1 of subsection A of Section 91 of this
9 title or subsection D of Section 91 of this
10 title.

11 c. If personal property has a certificate of title, or
12 would be required to have a certificate of title under
13 Oklahoma law, and is apparently covered both by this
14 section and by Sections 191 through 200 of this title,
15 the procedures set out in this section shall apply
16 instead of Sections 191 through 200 of this title. If
17 personal property without a certificate of title and
18 not required to be titled under Oklahoma law is
19 covered both by this section and Sections 191 through
20 200 of this title, the procedures set out in Sections
21 191 through 200 of this title shall apply instead of
22 this section.

23 2. a. Any person who, while lawfully in possession of an
24 article of personal property to which this section

1 applies, renders any service to the owner thereof by
2 furnishing storage, rental space, material, labor or
3 skill for the protection, improvement, safekeeping,
4 towing, right to occupy space, storage or carriage
5 thereof, has a special lien thereon, dependent on
6 possession, for the compensation, if any, which is due
7 to such person from the owner for such service.
8 Charges owed under a contract primarily for the
9 purpose of storage or rental of space shall be accrued
10 only at the regular periodic rate for storage or
11 rental as provided in the contract, adjusted for
12 partial periods of storage or rental.

- 13 b. Except for Class AA licensed wrecker towing charges,
14 the special lien shall be subordinate to any perfected
15 security interest unless the claimant complies with
16 the requirements of this section. Failure to comply
17 with any requirements of this section shall result in
18 denial of any title application and cause the special
19 lien to be subordinate to any perfected lien. Upon
20 such denial, the applicant shall be entitled to one
21 resubmission of the title application within thirty
22 (30) business days of receipt of the denial, and
23 proceed to comply with the requirements of this
24

1 section. "Failure to comply" includes, but is not
2 limited to:

- 3 (1) failure to timely provide additional
4 documentation supporting or verifying any entry
5 on submitted forms as requested by ~~the Tax~~
6 ~~Commission~~ Service Oklahoma,
- 7 (2) failure to provide the documentation supporting
8 lawful possession as outlined in paragraph 3 of
9 subsection H of this section,
- 10 (3) claimant being other than the individual who
11 provided the service giving rise to the special
12 lien, as in subparagraph a of this paragraph,
- 13 (4) claimant not being in possession of the vehicle,
14 or
- 15 (5) notification and proceedings not accomplished in
16 accordance with subparagraph c of this paragraph,
17 and paragraph 3 of this subsection.

18 c. Any person claiming a lien under this section shall
19 request, within five (5) business days of performing
20 any service or work on the property, ~~the Tax~~
21 ~~Commission~~ Service Oklahoma or other appropriate
22 license agency to furnish the name and address of the
23 current owner of and any lienholder upon the property.
24 ~~The Motor Vehicle Division of the Tax Commission~~

1 Service Oklahoma or an appropriate license agency
2 shall respond in person or by mail to the lien
3 claimant within ten (10) business days of the receipt
4 of the request for information. ~~The Tax Commission~~
5 Service Oklahoma shall render assistance to ascertain
6 ownership, if needed. The lien claimant shall send,
7 within seven (7) business days of receipt of the
8 requested information from ~~the Oklahoma Tax Commission~~
9 Service Oklahoma or other license agency, a notice of
10 the location of the property by certified mail with
11 return receipt requested, postage prepaid, to the
12 owner and any lienholder of the vehicle at the
13 addresses furnished. The lien claimant may charge
14 Twenty Dollars (\$20.00) for processing plus the cost
15 of postage if the notice is timely sent pursuant to
16 the requirements of this subparagraph in addition to
17 fees regulated by the Oklahoma Corporation Commission
18 for licensed wreckers. If the lien claimant is unable
19 to meet the time requirements due to a lack of or an
20 altered vehicle identification number on the property,
21 the lien claimant shall proceed diligently to obtain
22 the proper vehicle identification number and shall
23 meet the time requirements on the notice once the
24 vehicle identification number is known. If the lien

1 claimant is required to send additional notices
2 because of change of ownership or lienholder after it
3 has timely complied with the requirements of this
4 subparagraph, the lien claimant shall remain in
5 compliance if such additional notices are sent within
6 the required time periods from the date of discovery
7 of the new owners or lienholders. The notice shall be
8 in writing and shall contain, but not be limited to,
9 the following:

- 10 (1) a statement that the notice is a Notice of
11 Possessory Lien,
- 12 (2) the complete legal name, physical and mailing
13 address, and telephone number of the claimant,
- 14 (3) the complete legal name, physical and mailing
15 address of the person who requested that the
16 claimant render service to the owner by
17 furnishing material, labor or skill, storage, or
18 rental space, or the date the property was
19 abandoned if the claimant did not render any
20 other service,
- 21 (4) a description of the article of personal
22 property, and the complete physical and mailing
23 address of the location of the article of
24 personal property,

- 1 (5) the nature of the work, labor or service
2 performed, material furnished, or the storage or
3 rental arrangement, and the date thereof, and
4 written proof of authority to perform the work,
5 labor or service provided that, in the case of a
6 law enforcement directed tow, the logbook entry
7 prescribed in OAC 595:25-5-5 or the tow ticket as
8 defined by the Corporation Commission shall serve
9 as written proof of authority,
- 10 (6) the signature of the claimant which shall be
11 notarized and, if applicable, the signature of
12 the claimant's attorney. If the claimant is a
13 business, the name of the contact person
14 representing the business shall be shown. In
15 place of an original signature and notary seal, a
16 digital or electronic signature or seal shall be
17 accepted, and
- 18 (7) an itemized statement describing the date or
19 dates the labor or services were performed and
20 material furnished and the charges claimed for
21 each item, the totals of which shall equal the
22 total compensation claimed.

23 The lien claimant shall not be required to send the
24 notice required in this subparagraph if the property

1 is released to an interested party before the notice
2 is mailed and no additional charges or fees continue
3 to accrue. If a law enforcement agency has the
4 property towed to a law enforcement facility, the
5 person claiming a lien under this section shall not be
6 required to send notice until the property is released
7 by law enforcement to the claimant or the date which
8 claimant starts charging storage, whichever is
9 earlier. A lien claimant shall have an extension of
10 ten (10) business days to send the notice required in
11 this subparagraph if a state of emergency has been
12 declared in the county in which the property is
13 located.

14 d. Subparagraphs b and c of this paragraph shall not
15 apply to salvage pools as defined in Section 591.2 of
16 Title 47 of the Oklahoma Statutes.

17 3. The lien may be foreclosed by a sale of such personal
18 property upon the notice and in the manner following: The notice
19 shall be in writing and shall contain, but not be limited to:

- 20 a. the names of the owner and any other known party or
21 parties who may claim any interest in the property,
22 b. a description of the property to be sold, including a
23 visual inspection or a photograph if the property is a
24

- 1 motor vehicle, and the physical location of the
2 property,
- 3 c. the nature of the work, labor or service performed,
4 material furnished, or the storage or rental
5 arrangement, and the date thereof, and written proof
6 of authority to perform the work, labor or service
7 provided. In the case of a law enforcement directed
8 tow, the logbook entry prescribed in OAC 595:25-5-5 or
9 the tow ticket as defined by the Corporation
10 Commission, shall serve as written proof of authority,
- 11 d. the time and place of sale,
- 12 e. the name, telephone number, physical address and
13 mailing address of the claimant, and agent or
14 attorney, if any, foreclosing such lien. If the
15 claimant is a business, then the name of the contact
16 person representing the business must be shown. In
17 place of an original signature and notary seal, a
18 digital or electronic signature or seal shall be
19 accepted, and
- 20 f. itemized charges which shall equal the total
21 compensation claimed.
- 22 4. a. Such Notice of Sale shall be posted in two public
23 places in the county where the property is to be sold
24 at least ten (10) days before the time therein

1 specified for such sale, and a copy of the notice
2 shall be mailed to the owner and any other party
3 claiming any interest in the property, if known, at
4 their last-known post office address, by certified
5 mail, return receipt requested, at least ten (10) days
6 before the time therein specified for such sale. If
7 the item of personal property is a manufactured home,
8 notice shall also be sent by certified mail to the
9 county treasurer and to the county assessor of the
10 county where the manufactured home is located.

11 b. In the case of any item of personal property without a
12 certificate of title and not required to be titled
13 under Oklahoma law, a party who claims any interest in
14 the property shall include all owners of the property;
15 any secured party who has an active financing
16 statement on file with the county clerk of Oklahoma
17 County listing one or more owners of the property by
18 legal name as debtors and indicating a collateral
19 description that would include the property; and any
20 other person having any interest in the personal
21 property, of whom the claimant has actual notice.

22 c. In the case of personal property subject to this
23 section for which a certificate of title has been
24 issued by any jurisdiction, a party who claims any

1 interest in the property shall include all owners of
2 the article of personal property as indicated by the
3 certificate of title; lien debtors, if any, other than
4 the owners; any lienholder whose lien is noted on the
5 face of the certificate of title; and any other person
6 having any interest in the article of personal
7 property, of whom the claimant has actual notice.

- 8 d. When the jurisdiction of titling for a vehicle, all-
9 terrain vehicle, motorcycle, boat, outboard motor, or
10 trailer that is five (5) model years old or newer, or
11 a manufactured home that is fifteen (15) model years
12 old or newer, cannot be determined by ordinary means,
13 the claimant, the agent of the claimant, or the
14 attorney of the claimant, shall request, in writing,
15 that ~~the Oklahoma Tax Commission Motor Vehicle~~
16 ~~Division~~ Service Oklahoma ascertain the jurisdiction
17 where the vehicle or manufactured home is titled. ~~The~~
18 ~~Oklahoma Tax Commission Motor Vehicle Division~~ Service
19 Oklahoma shall, within fourteen (14) days from the
20 date the request is received, provide information as
21 to the jurisdiction where the personal property is
22 titled. If ~~the Oklahoma Tax Commission Motor Vehicle~~
23 ~~Division~~ Service Oklahoma is unable to provide the
24

1 information, it shall provide notice that the record
2 is not available.

3 e. When personal property is of a type that Oklahoma law
4 requires to be titled, the owner of record of that
5 property is unknown, and the jurisdiction of titling
6 and owner of record cannot be determined by ordinary
7 means and also, if applicable, cannot be determined in
8 accordance with the preceding subparagraph, then the
9 special lien may be foreclosed by publication of a
10 legal notice in a legal newspaper in the county where
11 the personal property is located, as defined in
12 Section 106 of Title 25 of the Oklahoma Statutes.
13 Such notice shall include the description of the
14 property by year, make, vehicle identification number
15 if available from the property, the name of the
16 individual who may be contacted for information, and
17 the telephone number of that person or the address
18 where the vehicle is located. The legal notice shall
19 be published once per week for three (3) consecutive
20 weeks. As soon as circumstances exist as described in
21 the first sentence of this subparagraph, the first
22 date of publication may occur even if the special lien
23 has not accrued for over thirty (30) days. The first
24 date available for public sale of the vehicle is the

1 day following publication of the final notice, but no
2 fewer than thirty (30) days after the lien has
3 accrued. When the owner of record is unknown, the
4 Notice of Sale nevertheless must be completed and
5 mailed to any known interested party by certified
6 mail. For purposes of this paragraph, interested
7 parties shall include all persons described in
8 subparagraph b or subparagraph c of this paragraph,
9 whichever is applicable, with the exception of any
10 owner who is unknown. Except in circumstances
11 described in paragraph 7 of this subsection that
12 provide for a shorter time period, the Notice of Sale
13 shall be posted in two public places in the county
14 where the property is to be sold at least ten (10)
15 days before the time therein specified for such sale,
16 and the Notice of Sale shall not be mailed until at
17 least thirty (30) days after the lien has accrued.

18 5. The lienor or any other person may in good faith become a
19 purchaser of the property sold.

20 6. Proceedings for foreclosure under this act shall not be
21 commenced until thirty (30) days after the lien has accrued, except
22 as provided elsewhere in Oklahoma law.

23 7. Notwithstanding any other provision of law, proceedings for
24 foreclosures for the storage of junk vehicles towed and stored

1 pursuant to Section 955 of Title 47 of the Oklahoma Statutes by
2 Class AA wreckers listed with the Motor Vehicle Division of the
3 Department of Public Safety, may be commenced five (5) days after
4 the lien has accrued. For purposes of this paragraph, "junk
5 vehicles" means any vehicle that is more than ten (10) years old if
6 the cost of a comparable vehicle would be less than Three Hundred
7 Dollars (\$300.00) as quoted in the latest edition of the National
8 Automobile Dealers Association Official Used Car Guide or latest
9 monthly edition of any other nationally recognized published
10 guidebook, adjusting to the condition of the vehicle.

11 B. 1. a. Any person who is induced by means of a check or other
12 form of written order for immediate payment of money
13 to deliver up possession of an article of personal
14 property on which the person has a special lien
15 created by subsection A of this section, which check
16 or other written order is dishonored, or is not paid
17 when presented, shall have a lien for the amount
18 thereof upon the personal property.

19 b. The person claiming such lien shall, within thirty
20 (30) days from the date of dishonor of the check or
21 other written order for payment of money, file in the
22 office of the county clerk of the county in which the
23 property is situated a sworn statement that:
24

- 1 (1) the check or other written order for immediate
2 payment of money, copy thereof being attached,
3 was received for labor, material or supplies for
4 producing or repairing an article of personal
5 property, or for other specific property-related
6 services covered by this section,
7 (2) the check or other written order was not paid,
8 and
9 (3) the uttering of the check or other written order
10 constituted the means for inducing the person,
11 one possessed of a special lien created by
12 subsection A of this section upon the described
13 article of personal property, to deliver up the
14 article of personal property.

- 15 2. a. Any person who renders service to the owner of an
16 article of personal property by furnishing storage,
17 rental space, material, labor, or skill for the
18 protection, improvement, safekeeping, towing, right to
19 occupy space, storage, or carriage thereof shall have
20 a special lien on such property pursuant to this
21 section if such property is removed from the person's
22 possession, without such person's written consent or
23 without payment for such service.
24

1 b. The person claiming such lien shall, within five (5)
2 days of such nonauthorized removal, file in the office
3 of the county clerk of the county in which the
4 property is located, a sworn statement including:
5 (1) that services were rendered on or in relation to
6 the article of personal property by the person
7 claiming such lien,
8 (2) that the property was in the possession of the
9 person claiming the lien but such property was
10 removed without his or her written consent,
11 (3) an identifying description of the article of
12 personal property on or in relation to which the
13 service was rendered, and
14 (4) that the debt for the services rendered on or in
15 relation to the article of personal property was
16 not paid. Provided, if the unpaid total amount
17 of the debt for services rendered on or in
18 relation to the article of personal property is
19 unknown, an approximated amount of the debt due
20 and owing shall be included in the sworn
21 statement but such approximated debt may be
22 amended within thirty (30) days of such filing to
23 reflect the actual amount of the debt due and
24 owing.

1 3. The enforcement of the lien shall be within sixty (60) days
2 after filing the lien in the manner provided by law for enforcing
3 the lien of a security agreement and provided that the lien shall
4 not affect the rights of innocent, intervening purchasers without
5 notice.

6 C. If the person who renders service to the owner of an article
7 of personal property to which this section applies relinquishes or
8 loses possession of the article due to circumstances described in
9 subparagraph a of paragraph 1 or subparagraph a of paragraph 2 of
10 subsection B of this section, the person claiming the lien shall be
11 entitled to possession of the article until the amount due is paid,
12 unless the article is possessed by a person who became a bona fide
13 purchaser. Entitlement to possession shall be in accordance with
14 the following:

15 1. The claimant may take possession of an article pursuant to
16 this subsection only if the person obligated under the contract for
17 services has signed an acknowledgment of receipt of a notice that
18 the article may be subject to repossession. The notice and
19 acknowledgment pursuant to this subsection shall be:

20 a. in writing and separate from the written contract for
21 services, or

22 b. printed on the written contract for services, credit
23 agreement or other document which displays the notice
24 in bold-faced, capitalized and underlined type, or is

1 separated from surrounding written material so as to
2 be conspicuous with a separate signature line;

3 2. The claimant may require the person obligated under the
4 contract for services to pay the costs of repossession as a
5 condition for reclaiming the article only to the extent of the
6 reasonable fair market value of the services required to take
7 possession of the article;

8 3. The claimant shall not transfer to a third party or to a
9 person who performs repossession services, a check, money order, or
10 credit card transaction that is received as payment for services
11 with respect to an article and that is returned to the claimant
12 because of insufficient funds or no funds, because the person
13 writing the check, issuing the money order, or credit cardholder has
14 no account or because the check, money order, or credit card account
15 has been closed. A person violating this paragraph shall be guilty
16 of a misdemeanor; and

17 4. An article that is repossessed pursuant to this subsection
18 shall be promptly delivered to the location where the services were
19 performed. The article shall remain at the services location at all
20 times until the article is lawfully returned to the record owner or
21 a lienholder or is disposed of pursuant to this section.

22 D. 1. This section applies if a vehicle, all-terrain vehicle,
23 manufactured home, motorcycle, boat, outboard motor, or trailer has
24 a certificate of title issued by ~~the Tax Commission~~ Service Oklahoma

1 or by a federally recognized Indian tribe in Oklahoma, but there is
2 no active lien recorded on the certificate of title.

3 2. This section applies if a vehicle, all-terrain vehicle,
4 utility vehicle, motorcycle, boat, outboard motor or trailer has a
5 certificate of title issued by ~~the Tax Commission~~ Service Oklahoma
6 or by a federally recognized Indian tribe in Oklahoma, and there is
7 an active lien recorded on the certificate of title, but the lien is
8 over fifteen (15) years old.

9 3. This section applies if personal property to which Section
10 91 of this title otherwise would apply has been registered by ~~the~~
11 ~~Tax Commission~~ Service Oklahoma or by a federally recognized Indian
12 tribe in the State of Oklahoma, and there is a lien of record but no
13 certificate of title has been issued.

14 4. This section applies if personal property to which Section
15 91 of this title otherwise would apply has not been registered by
16 either ~~the Tax Commission~~ Service Oklahoma or a federally recognized
17 Indian tribe in the State of Oklahoma, and no certificate of title
18 has been issued, but there is a lien of record.

19 5. This section applies to personal property that otherwise
20 would be covered by Section 91 of this title, except that the
21 services were rendered or the property was abandoned prior to
22 November 1, 2005.

23 6. This section applies to a vehicle, all-terrain vehicle,
24 utility vehicle, manufactured home, motorcycle, boat, outboard

1 motor, or trailer for which ownership cannot be determined by
2 ordinary means or by ~~the Oklahoma Tax Commission Motor Vehicle~~
3 ~~Division Service Oklahoma~~, as provided in subparagraphs d and e of
4 paragraph 4 of subsection A of this section, as applicable.

5 7. This section applies to items of personal property that are
6 not required by Oklahoma law to be titled, and that do not have a
7 certificate of title.

8 8. This section applies to salvage pools as defined in Section
9 591.2 of Title 47 of the Oklahoma Statutes.

10 9. This section applies to class AA licensed wrecker services
11 taking possession of a vehicle pursuant to an agreement with, or at
12 the direction of, or dispatched by a state or local law enforcement
13 or government agency, or pursuant to the abandoned vehicle removal
14 provisions of Section 954A of Title 47 of the Oklahoma Statutes with
15 respect to all types of personal property, regardless of whether
16 that personal property has a certificate of title.

17 10. For a vehicle abandoned at a salvage pool, if the cost of
18 repairing the vehicle for safe operation on the highway does not
19 exceed sixty percent (60%) of the fair market value of the vehicle
20 as defined in Section 1111 of Title 47 of the Oklahoma Statutes, a
21 salvage title shall not be required.

22 E. A person who knowingly makes a false statement of a material
23 fact regarding the furnishing of storage, rental space, material,
24 labor or skill for the protection, improvement, safekeeping, towing,

1 right to occupy space, storage or carriage thereof in a proceeding
2 under this section, or attempts to use or uses the provisions of
3 this section to foreclose an owner or lienholder's interest in a
4 vehicle knowing that any of the statements made in the proceeding
5 are false, upon conviction, shall be guilty of a felony.

6 F. Upon receipt of notice of legal proceedings, ~~the Tax~~
7 ~~Commission~~ Service Oklahoma shall cause the sale process to be put
8 on hold until notice of resolution of court proceedings is received
9 from the court. If such notice of commencement of court proceedings
10 is not filed with ~~the Tax Commission~~ Service Oklahoma, the
11 possessory lien sale process may continue.

12 G. No possessory lien sale shall be held on a Sunday.

13 H. For purposes of this section:

14 1. "Possession" includes actual possession and constructive
15 possession;

16 2. "Constructive possession" means possession by a person who,
17 although not in actual possession, does not have an intention to
18 abandon property, knowingly has both power and the intention at a
19 given time to exercise dominion or control over the property, and
20 who holds claim to such thing by virtue of some legal right;

21 3. "Lawfully in possession" means a person has documentation
22 from the owner or the owner's authorized agent, or an insurance
23 company or its authorized agent, authorizing the furnishing of
24

1 material, labor or storage, or that the property was authorized to
2 be towed to a repair facility.

3 Class AA wrecker services taking possession of a vehicle
4 pursuant to an agreement with, or at the direction of, or dispatched
5 by, a state or local law enforcement or government agency, or
6 pursuant to the abandoned vehicle removal provisions of Section 954A
7 of Title 47 of the Oklahoma Statutes, shall be considered lawfully
8 in possession of the vehicle. If the person lacks such
9 documentation, the procedures established by this section shall not
10 apply; and

11 4. "Itemized charges" means total parts, total labor, total
12 towing fees, total storage fees, total processing fees and totals of
13 any other fee groups, the sum total of which shall equal the
14 compensation claimed.

15 I. For purposes of this section, the United States Postal
16 Service approved electronic equivalent of proof of return receipt
17 requested Form 3811 shall satisfy return receipt requested
18 documentation requirements.

19 J. If a person claiming a special lien pursuant to this section
20 fails to comply with any of the requirements of this section, any
21 interested party may proceed against the person claiming such lien
22 for all damages arising therefrom, including conversion, if the
23 article of personal property has been sold. If the notice or
24 notices required by this section shall be shown to be knowingly

1 false or fraudulent, the interested party shall be entitled to
2 treble damages. The prevailing party shall be entitled to all
3 costs, including reasonable attorney fees.

4 K. Any interested party shall be permitted to visually inspect
5 and verify the services rendered by the claimant prior to the sale
6 of the article of property during normal business hours. If the
7 claimant fails to allow any interested party to inspect the
8 property, the interested party shall mail a request for inspection
9 by certified mail, return receipt requested, to the claimant.

10 Within three (3) business days of receipt of the request for
11 inspection, the claimant shall mail a photograph of the property, by
12 certified mail, return receipt requested, and a date of inspection
13 within five (5) business days from the date of the notice to
14 inspect. The lienholder shall be allowed to retrieve the property
15 without being required to bring the title into the lienholder's
16 name, if the lienholder provides proof it is a lienholder and any
17 payment due the claimant for lawful charges where the claimant has
18 complied with this section. Upon the release of personal property
19 to an insurer or representative of the insurer, wrecker operators
20 shall be exempt from all liability and shall be held harmless for
21 any losses or claims of loss. In the event any law enforcement
22 agency places a hold on the property, the party wanting to inspect
23 or photograph the property shall obtain permission from the law

1 enforcement agency that placed the hold on the property before
2 inspecting or photographing.

3 L. This section shall apply to all actions or proceedings that
4 commence on or after the effective date of this act.

5 SECTION 12. AMENDATORY Section 6, Chapter 282, O.S.L.
6 2022 (47 O.S. Supp. 2022, Section 3-106), is amended to read as
7 follows:

8 Section 3-106. A. There is hereby created in the State
9 Treasury a revolving fund for Service Oklahoma to be designated the
10 "Service Oklahoma Revolving Fund". The fund shall be a continuing
11 fund, not subject to fiscal year limitations. All monies accruing
12 to the credit of said fund are hereby appropriated and shall be
13 budgeted and expended by Service Oklahoma for the restricted
14 purposes of the monies as prescribed by law. Expenditures from said
15 fund shall be made upon warrants issued by the State Treasurer
16 against claims filed as prescribed by law with the Director of the
17 Office of Management and Enterprise Services for approval and
18 payment.

19 B. There is hereby created in the State Treasury a revolving
20 fund for Service Oklahoma to be designated the "Service Oklahoma
21 Reimbursement Fund". The fund shall be a continuing fund, not
22 subject to fiscal year limitations. All monies accruing to the
23 credit of said fund are hereby appropriated and shall be budgeted
24 and expended by Service Oklahoma for the restricted purposes of the

1 monies as prescribed by law. Expenditures from said fund shall be
2 made upon warrants issued by the State Treasurer against claims
3 filed as prescribed by law with the Director of the Office of
4 Management and Enterprise Services for approval and payment.

5 C. There is hereby created in the State Treasury a revolving
6 fund for Service Oklahoma, to be designated the "Service Oklahoma
7 Computer Imaging System Revolving Fund". The fund shall be a
8 continuing fund not subject to fiscal year limitations. All monies
9 accruing to the credit of said fund are hereby appropriated and
10 shall be budgeted and expended by Service Oklahoma for the purpose
11 of implementing, developing, administering, and maintaining the
12 computer imaging system of Service Oklahoma. Expenditures from said
13 fund shall be made upon warrants issued by the State Treasurer
14 against claims filed as prescribed by law with the Director of the
15 Office of Management and Enterprise Services for approval and
16 payment.

17 D. There is hereby created a Petty Cash Fund for Service
18 Oklahoma. The fund shall be used by Service Oklahoma to operate
19 cash drawers as necessary. The amount of the Petty Cash Fund shall
20 be determined by the Director of Service Oklahoma and the Director
21 of the Office of Management and Enterprise Services. Purchases from
22 the Petty Cash Fund shall be prohibited. The Director of Office of
23 Management and Enterprise Services shall be authorized to prescribe
24

1 forms, systems, and procedures for the administration of the Petty
2 Cash Fund.

3 SECTION 13. AMENDATORY 47 O.S. 2021, Section 6-101, as
4 last amended by Section 37, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
5 2022, Section 6-101), is amended to read as follows:

6 Section 6-101. A. No person, except those hereinafter
7 expressly exempted in Sections 6-102 and 6-102.1 of this title,
8 shall operate any motor vehicle upon a highway in this state unless
9 the person has a valid Oklahoma driver license for the class of
10 vehicle being operated under the provisions of this title. No
11 person shall be permitted to possess more than one valid license at
12 any time, except as provided in paragraph 4 of subsection F of this
13 section.

14 B. 1. No person shall operate a Class A commercial motor
15 vehicle unless the person is eighteen (18) years of age or older and
16 holds a valid Class A commercial license, except as provided in
17 paragraph 5 of this subsection and subsection F of this section.
18 Any person holding a valid Class A commercial license shall be
19 permitted to operate motor vehicles in Classes A, B, C and D, except
20 as provided for in paragraph 4 of this subsection.

21 2. No person shall operate a Class B commercial motor vehicle
22 unless the person is eighteen (18) years of age or older and holds a
23 valid Class B commercial license, except as provided in paragraph 5
24 of subsection F of this section. Any person holding a valid Class B

1 commercial license shall be permitted to operate motor vehicles in
2 Classes B, C and D, except as provided for in paragraph 4 of this
3 subsection.

4 3. No person shall operate a Class C commercial motor vehicle
5 unless the person is eighteen (18) years of age or older and holds a
6 valid Class C commercial license, except as provided in subsection F
7 of this section. Any person holding a valid Class C commercial
8 license shall be permitted to operate motor vehicles in Classes C
9 and D, except as provided for in paragraph 4 of this subsection.

10 4. No person under twenty-one (21) years of age shall be
11 licensed to operate any motor vehicle which is required to be
12 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
13 subpart F, except as provided in subsection F of this section;
14 provided, a person eighteen (18) years of age or older may be
15 licensed to operate a farm vehicle which is required to be placarded
16 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
17 except as provided in subsection F of this section.

18 5. A person at least seventeen (17) years of age who
19 successfully completes all examinations required by law may be
20 issued by Service Oklahoma:

- 21 a. a restricted Class A commercial license which shall
22 grant to the licensee the privilege to operate a Class
23 A or Class B commercial motor vehicle for harvest
24 purposes or a Class D motor vehicle, or

1 b. a restricted Class B commercial license which shall
2 grant to the licensee the privilege to operate a Class
3 B commercial motor vehicle for harvest purposes or a
4 Class D motor vehicle.

5 6. No person shall operate a Class D motor vehicle unless the
6 person is sixteen (16) years of age or older and holds a valid Class
7 D license, except as provided for in Section 6-102 or 6-105 of this
8 title. Any person holding a valid Class D license shall be
9 permitted to operate motor vehicles in Class D only.

10 C. Any person issued a driver license pursuant to this section
11 may exercise the privilege thereby granted upon all streets and
12 highways in this state.

13 D. No person shall operate a motorcycle or motor-driven cycle
14 without having a valid Class A, B, C or D license with a motorcycle
15 endorsement. Except as otherwise provided by law, any new applicant
16 for an original driver license shall be required to successfully
17 complete a written examination, vision examination and driving
18 examination for a motorcycle as prescribed by the Department of
19 Public Safety, in conjunction with Service Oklahoma, and a certified
20 state-approved motorcycle basic rider course approved by the
21 Department, in conjunction with Service Oklahoma, if the applicant
22 is seventeen (17) years of age or younger to be eligible for a
23 motorcycle endorsement thereon. The written examination and driving
24 examination for a motorcycle shall be waived by Service Oklahoma

1 upon verification that the person has successfully completed a
2 certified Motorcycle Safety Foundation rider course approved by the
3 Department, in conjunction with Service Oklahoma.

4 E. Except as otherwise provided by law, any person who lawfully
5 possesses a valid Oklahoma driver license which is eligible for
6 renewal shall be required to successfully complete a written
7 examination, vision examination and driving examination for a
8 motorcycle as prescribed by the Department, in conjunction with
9 Service Oklahoma, and a certified state-approved motorcycle basic
10 rider course approved by the Department, in conjunction with Service
11 Oklahoma, if the person is seventeen (17) years of age or younger to
12 be eligible for a motorcycle endorsement. The written examination
13 and driving examination for a motorcycle shall be waived by Service
14 Oklahoma upon verification that the person has successfully
15 completed a certified Motorcycle Safety Foundation rider course
16 approved by the Department, in conjunction with Service Oklahoma.

17 F. 1. Any person eighteen (18) years of age or older may apply
18 for a restricted Class A, B or C commercial learner permit. Service
19 Oklahoma, after the applicant has passed all parts of the
20 examination for a Class D license and has successfully passed all
21 parts of the examination for a Class A, B or C commercial license
22 other than the driving examination, may issue to the applicant a
23 commercial learner permit which shall entitle the person having
24 immediate lawful possession of the commercial learner permit and a

1 valid Oklahoma driver license or provisional driver license pursuant
2 to Section 6-212 of this title to operate a Class A, B or C
3 commercial motor vehicle upon the public highways solely for the
4 purpose of behind-the-wheel training in accordance with rules
5 promulgated by the Department.

6 2. This commercial learner permit shall be issued for a period
7 as provided in Section 6-115 of this title of ~~one hundred eighty~~
8 ~~(180) days, which may be renewed one time for an additional one~~
9 ~~hundred eighty (180) days~~ one year; provided, such commercial
10 learner permit may be suspended, revoked, canceled, denied or
11 disqualified at the discretion of the Department, with notice to
12 Service Oklahoma, for violation of the restrictions, for failing to
13 give the required or correct information on the application or for
14 violation of any traffic laws of this state pertaining to the
15 operation of a motor vehicle. Except as otherwise provided, the
16 lawful possessor of a commercial learner permit who has been issued
17 a commercial learner permit for a minimum of fourteen (14) days may
18 have the restriction requiring an accompanying driver removed by
19 satisfactorily completing a driver's examination; provided, the
20 removal of a restriction shall not authorize the operation of a
21 Class A, B or C commercial motor vehicle if such operation is
22 otherwise prohibited by law.

23 3. No person shall apply for and Service Oklahoma shall not
24 issue an original Class A, B or C driver license until the person

1 has been issued a commercial learner permit and held the permit for
2 at least fourteen (14) days. Any person who currently holds a Class
3 B or C license and who wishes to apply for another class of
4 commercial driver license shall be required to apply for a
5 commercial learner permit and to hold the permit for at least
6 fourteen (14) days before applying for the Class A or B license, as
7 applicable. Any person who currently holds a Class A, B or C
8 license and who wishes to add an endorsement or remove a restriction
9 for which a skills examination is required shall be required to
10 apply for a commercial learner permit and to hold the permit for at
11 least fourteen (14) days before applying for the endorsement.

12 4. A commercial learner permit shall be issued by Service
13 Oklahoma as a separate and unique document which shall be valid only
14 in conjunction with a valid Oklahoma driver license or provisional
15 driver license pursuant to Section 6-212 of this title, both of
16 which shall be in the possession of the person to whom they have
17 been issued whenever that person is operating a commercial motor
18 vehicle as provided in this subsection.

19 5. After one renewal of a commercial learner permit, as
20 provided in paragraph 2 of this subsection, a commercial permit
21 shall not be renewed again. Any person who has held a commercial
22 learner permit for the initial issuance period and one renewal
23 period shall not be eligible for and Service Oklahoma shall not
24 issue another renewal of the permit; provided, the person may

1 reapply for a new commercial learner permit, as provided for in this
2 subsection.

3 G. 1. For purposes of this title:

- 4 a. "REAL ID Compliant Driver License" or "Identification
5 Card" means a driver license or identification card
6 issued by the State of Oklahoma that has been
7 certified by the United States Department of Homeland
8 Security (USDHS) as compliant with the requirements of
9 the REAL ID Act of 2005, Public Law No. 109-13. A
10 REAL ID Compliant Driver License or Identification
11 Card and the process through which it is issued
12 incorporate a variety of security measures designed to
13 protect the integrity and trustworthiness of the
14 license or card. A REAL ID Compliant Driver License
15 or Identification Card will be clearly marked on the
16 face indicating that it is a compliant document, and
- 17 b. "REAL ID Noncompliant Driver License" or
18 "Identification Card" means a driver license or
19 identification card issued by the State of Oklahoma
20 that has not been certified by the United States
21 Department of Homeland Security (USDHS) as being
22 compliant with the requirements of the REAL ID Act. A
23 REAL ID Noncompliant Driver License or Identification
24 Card will be clearly marked on the face indicating

1 that it is not compliant with the federal REAL ID Act
2 and is not acceptable for official federal purposes.
3 The driver license or identification card will have a
4 unique design or color indicator that clearly
5 distinguishes it from a compliant license or card.

6 2. Original Driver License and Identification Card Issuance:

7 a. Application for an original REAL ID Compliant or REAL
8 ID Noncompliant Driver License or Identification Card
9 shall be made to Service Oklahoma. Beginning January
10 1, 2023, application for an original REAL ID Compliant
11 Driver License or Identification Card may be made to
12 Service Oklahoma or a licensed operator provided such
13 licensed operator is authorized to process
14 applications for REAL ID Compliant Driver Licenses and
15 Identification Cards. Applications for a REAL ID
16 Noncompliant Driver License or Identification Card
17 shall be made to Service Oklahoma.

18 b. Service Oklahoma employees shall perform all document
19 recognition and other requirements needed for approval
20 of an original REAL ID Compliant or REAL ID
21 Noncompliant Driver License or Identification Card
22 application. Beginning January 1, 2023, Service
23 Oklahoma employees or authorized licensed operators
24 shall perform all document recognition and other

1 requirements necessary for approval of an original
2 REAL ID Compliant Driver License or Identification
3 Card application. Service Oklahoma employees shall
4 perform all document recognition and other
5 requirements necessary for approval of a REAL ID
6 Noncompliant Driver License or Identification Card
7 application.

8 c. Upon approval of an original REAL ID Compliant or REAL
9 ID Noncompliant Driver License or Identification Card
10 application, the applicant may take the approved
11 application document to a licensed operator to receive
12 a temporary driver license or identification card.

13 d. The licensed operator shall process the approved REAL
14 ID Compliant or REAL ID Noncompliant Driver License or
15 Identification Card application and upon payment shall
16 provide the applicant a temporary driver license or
17 identification card. A temporary driver license or
18 identification card shall afford the holder the
19 privileges otherwise granted by the specific class of
20 driver license or identification card for the period
21 of time listed on the temporary driver license or
22 identification card or the period of time prior to the
23 applicant receiving a REAL ID Compliant or REAL ID

1 Noncompliant Driver License or Identification Card,
2 whichever time period is shorter.

3 3. REAL ID Compliant Driver License and Identification Card

4 Renewal and Replacement:

- 5 a. Application for renewal or replacement of a REAL ID
6 Compliant Driver License or Identification Card may be
7 made to Service Oklahoma or to a licensed operator;
8 provided, such licensed operator is authorized to
9 process application for REAL ID Compliant Driver
10 Licenses and Identification Cards. A licensed
11 operator may process the voluntary downgrade of a REAL
12 ID Compliant Commercial Driver License to any lower
13 class license upon request of the licensee; provided,
14 no additional endorsements or restrictions are placed
15 on the license.
- 16 b. Service Oklahoma employees or authorized licensed
17 operators shall perform all document recognition and
18 other requirements needed for approval of a renewal or
19 replacement REAL ID Compliant Driver License or
20 Identification Card application.
- 21 c. Upon approval of a renewal or replacement REAL ID
22 Compliant Driver License or Identification Card
23 application, the applicant may receive a temporary
24

1 driver license or identification card from Service
2 Oklahoma or an authorized licensed operator.

3 d. A temporary driver license or identification card
4 acquired under the provisions of this paragraph shall
5 afford the holder the privileges otherwise granted by
6 the specific class of driver license or identification
7 card being renewed or replaced for the period of time
8 listed on the temporary driver license or
9 identification card or the period of time prior to the
10 applicant receiving a REAL ID Compliant Driver License
11 or Identification Card, whichever time period is
12 shorter.

13 e. For purposes of this title, an application for a REAL
14 ID Compliant Driver License or Identification Card by
15 an individual with a valid Oklahoma-issued driver
16 license or identification card shall be considered a
17 renewal of a REAL ID Compliant Driver License or
18 Identification Card.

19 4. REAL ID Noncompliant Driver License and Identification Card

20 Renewal and Replacement:

21 a. Application for renewal or replacement of a REAL ID
22 Noncompliant Driver License or Identification Card may
23 be made to Service Oklahoma or to a licensed operator.
24 A licensed operator may process the voluntary

1 downgrade of a REAL ID Noncompliant Commercial Driver
2 License to any lower class license upon request of the
3 licensee; provided, no additional endorsements or
4 restrictions are added to the license.

5 b. Service Oklahoma employees or licensed operators shall
6 perform all document recognition and other
7 requirements needed for approval of a renewal or
8 replacement REAL ID Noncompliant Driver License or
9 Identification Card application.

10 c. Upon approval of a renewal or replacement REAL ID
11 Noncompliant Driver License or Identification Card
12 application, the applicant may receive a temporary
13 driver license or identification card from Service
14 Oklahoma or a licensed operator.

15 d. A temporary driver license or identification card
16 acquired under the provisions of this paragraph shall
17 afford the holder the privileges otherwise granted by
18 the specific class of driver license or identification
19 card being renewed or replaced for the period of time
20 listed on the temporary driver license or
21 identification card or the period of time prior to the
22 applicant receiving a REAL ID Noncompliant Driver
23 License or Identification Card, whichever time period
24 is shorter.

H. 1. The fee charged for an approved application for an original Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver License or an approved application for the addition of an endorsement to a current valid Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver License shall be assessed in accordance with the following schedule:

14 P. No person who has been honorably discharged from active
15 service in any branch of the Armed Forces of the United States or
16 Oklahoma National Guard and who has been certified by the United
17 States Department of Veterans Affairs, its successor or the Armed
18 Forces of the United States to be a disabled veteran in receipt of
19 compensation at the one-hundred-percent rate for a permanent
20 disability sustained through military action or accident resulting
21 from disease contracted while in such active service and registered
22 with the veterans registry created by the Oklahoma Department of
23 Veterans Affairs shall be charged a fee for the issuance,
24 replacement or renewal of an Oklahoma driver license; provided, that

1 if a veteran has been previously exempt from a fee pursuant to this
2 subsection, no registration with the veterans registry shall be
3 required.

4 Q. In accordance with the provisions of subsection G of this
5 section, Service Oklahoma is authorized to promulgate rules for the
6 issuance and renewal of driver licenses authorized pursuant to the

8 any state agency. The fees received by the licensed operator,

17 subsections H and M of this section, the first Sixty Thousand
18 Dollars (\$60,000.00) of all monies collected pursuant to this
19 section shall be paid by the Oklahoma Tax Commission to the State
20 Treasurer to be deposited in the General Revenue Fund of the State
21 Treasury.

22 The next Five Hundred Thousand Dollars (\$500,000.00) of monies
23 collected pursuant to this section shall be paid by the Tax
24 Commission to the State Treasurer to be deposited each fiscal year

7 a. who has applied for, been issued, and has possessed a
8 learner permit for a minimum of ~~six (6) months~~ one
9 hundred eighty (180) days, and

10 b. whose custodial legal parent or legal guardian
11 certifies to Service Oklahoma by sworn affidavit that
12 the person has received a minimum of fifty (50) hours
13 of actual behind-the-wheel training, of which at least
14 ten (10) hours of such training was at night, from a
15 licensed driver who was at least twenty-one (21) years
16 of age and who was properly licensed to operate a
17 Class D motor vehicle for a minimum of two (2) years,

18 may be issued an intermediate Class D license upon successfully

E. Any person who has been issued an intermediate Class D license for a minimum of:

1. One (1) year; or

2. ~~Six (6) months~~ One hundred eighty (180) days, if the person has completed both the driver education and the parent-certified behind-the-wheel training provisions of subparagraph b of paragraph 1 of subsection D of this section, may be issued a Class D license. However, notwithstanding the date of issuance of the Class D license, if the person has been convicted of a traffic offense which is reported on the driving record of that

1 person, the time periods specified in paragraph 1 or 2 of this
2 subsection, as applicable, shall be recalculated to begin from the
3 date of conviction for the traffic offense, and must elapse before

11 I. Service Oklahoma may in its discretion issue a special
12 permit to any person who has attained the age of fourteen (14)
13 years, authorizing such person to operate farm vehicles between the

16 than thirty (30) days after the issuance of the special permit.

19 procedures to ensure every applicant for an original Class A, B, C
20 or D license and for any endorsements thereon is examined by Service
21 Oklahoma, or an approved written examination proctor, except as
22 otherwise provided in Section 6-101 et seq. of this title or as
23 provided in paragraph 2 of this subsection or in subsections D and E
24 of this section. Service Oklahoma is authorized to approve and

1 enter into agreements with local school districts, the Oklahoma
2 Department of Career and Technology Education, or institutions of
3 higher education to act as approved written examination proctors
4 with regard to any written examination required by this section.

5 The examination shall include a test of the applicant's:

- 6 a. eyesight,
- 7 b. ability to read and understand highway signs
8 regulating, warning and directing traffic,
- 9 c. knowledge of the traffic laws of this state including
10 a portion on bicycle and motorcycle safety, and
- 11 d. ability, by actual demonstration, to exercise ordinary
12 and reasonable control in the operation of a motor

- 3 a. a valid unexpired driver license issued by any state
4 or country for the same type or types of vehicles, or

9 license or commercial driver license permit.

10 3. Service Oklahoma shall accept skills test results from

15 another state when the applicant has not successfully completed
16 commercial motor vehicle driver training in that state. Nothing in

20 4. All applicants requiring a hazardous materials endorsement
21 shall be required, for the renewal of the endorsement, to
22 successfully complete the examination and to submit to a security
23 threat assessment performed by the Transportation Security

2 determine whether the applicant is eligible for renewal of the

5 instructor applicant to submit to an electronic national criminal
6 history record check pursuant to Section 150.9 of Title 74 of the
7 Oklahoma Statutes. The fees for the ~~background~~ record check shall
8 be borne by the designated examiner, ~~or~~ designated examiner
9 applicant, driver education instructor, or driver education
10 instructor applicant.

11 6. The Department of Public Safety, in conjunction with Service
12 Oklahoma, shall promulgate rules to implement and administer the
13 provisions of this subsection.

14 E. 1. Upon application and approval of Service Oklahoma, any
15 public or private commercial truck driving school that has or
16 maintains a program instructing students for a Class A, B or C
17 license, public transit agency or state, county or municipal
18 government agency in this state shall be authorized to hire or
19 employ designated examiners approved by Service Oklahoma to be
20 third-party examiners of the Class A, B or C driving skills portion
21 of the Oklahoma driving examination. All designated examiners must
22 successfully have completed the courses and training as outlined in
23 paragraph 2 of this subsection. Service Oklahoma shall be required
24 to approve at least one public transit agency that has or maintains

16 require each third-party examiner or commercial school driver
17 education instructor to submit to an electronic national criminal
18 history record check pursuant to Section 150.9 of Title 74 of the
19 Oklahoma Statutes. The fees for the background check shall be borne
20 by the third-party examiner, third-party examiner applicant,
21 commercial school driver education instructor or commercial school
22 driver education instructor applicant.

23 F. Service Oklahoma shall promulgate rules to:

1 1. Implement and administer the provisions of this section
2 based on requirements set forth in Section 383.75 of Title 49 of the
3 Code of Federal Regulations;

4 2. Establish a process to inform any school, public transit
5 agency, examiner, or state, county or municipal government agency,
6 who has been denied, within forty-five (45) days from the denial;

7 3. Create an appeal process for any school, public transit
8 agency, examiner, or state, county or municipal government agency
9 denied; and

10 4. If the initial application for approval was denied, limit
11 the number of times an individual school, public transit agency,
12 individual examiner applicant, or state, county or municipal

16 last amended by Section 53, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
17 2022, Section 6-111), is amended to read as follows:

18 Section 6-111. A. 1. Service Oklahoma shall, upon payment of
19 the required fee, issue to every applicant qualifying therefor a
20 Class A, B, C or D driver license or identification card as applied
21 for, which license or card shall bear thereon a distinguishing
22 alphanumeric identification assigned to the licensee or cardholder,
23 date of issuance and date of expiration of the license or card, the
24 full legal name, signature or computerized signature, date of birth,

1 residence address, unless specified as an exception in the Code of
2 Federal Regulations per 6 C.F.R., Section 37.17, sex, a computerized
3 color image of the licensee or cardholder taken in accordance with
4 Service Oklahoma rules and security features as determined by
5 Service Oklahoma. The image shall depict a full front unobstructed
6 view of the entire face of the licensee or cardholder; provided, a
7 commercial learner permit shall not bear the image of the licensee.
8 When any person is issued both a driver license and an

13 Oklahoma on or after March 1, 2004, shall bear thereon the county of

21 height and a brief description of the licensee or cardholder on the
22 face of the card or license identifying the licensee or cardholder
23 as deaf or hard-of-hearing.

1 5. It is unlawful for any person to apply, adhere, or otherwise
2 attach to a driver license or identification card any decal,
3 sticker, label, or other attachment. Any law enforcement officer is
4 authorized to remove and dispose of any unlawful decal, sticker,
5 label, or other attachment from the driver license of a person. The
6 law enforcement officer, the employing agency of the officer,
7 Service Oklahoma, and the State of Oklahoma shall be immune from any
8 liability for any loss suffered by the licensee, cardholder, or the
9 owner of the decal, sticker, label, or other attachment caused by

21 or while a permanent driver license is being produced and delivered

4 temporary identification card to an applicant, permitting the holder
5 the privileges otherwise granted by identification cards, while a
6 permanent driver license is being provided and delivered to the
7 applicant. Such card shall be invalid when the applicant's
8 permanent identification card has been issued and delivered, or for
9 good cause has been refused.

10 C. 1. Service Oklahoma may issue a restricted commercial
11 driver license to drivers eighteen (18) years of age or older for
12 any of the following specific farm-related service industries:

- 13 a. farm retail outlets and suppliers,
- 14 b. agri-chemical businesses,
- 15 c. custom harvesters, and
- 16 d. livestock feeders.

17 The applicant shall ~~hold~~ have held a valid ~~Oklahoma~~ driver
18 license for at least one year. Applicants with more than two (2)
19 years of driving experience shall have a good driving record for the
20 most recent two (2) year period and shall meet all the requirements
21 for a commercial driver license. The restricted commercial driver
22 license shall not exceed ~~a total of one hundred eighty (180) days~~
23 ~~within any twelve-month period~~ the maximum total days that federal
24 law allows. Applicants for the restricted commercial driver license

1 shall be exempt from the knowledge and skills test. Application of
2 the restricted commercial driver license does not have to be used in
3 consecutive days. The use of the permit shall be declared at
4 application.

5 2. A "good driving record" as used in this subsection shall
6 mean an applicant:

7 a. has not had more than one license,

8 b. has not had any license suspended, revoked, or
9 canceled,

10 c. has not had any conviction for any type of
11 disqualifying offenses or serious traffic violations,
12 or

13 d. has not had any conviction for a violation of state or
14 local law relating to motor vehicle traffic control,
15 other than a parking violation, arising in connection
16 with any traffic accident and has no record of an
17 accident in which they are at fault.

18 3. The restricted commercial driver license shall not be valid
19 for operators of commercial motor vehicles beyond one hundred fifty
20 (150) miles from the place of business or the farm currently being
21 served. Such license shall be limited to Class B or C vehicles.
22 Holders of such licenses who transport hazardous materials which are
23 required to be placarded shall be limited to the following:
24

- a. diesel fuel in quantities of one thousand (1,000) gallons or less,
- b. liquid fertilizers in vehicles with total capacities of three thousand (3,000) gallons or less, and
- c. solid fertilizers that are not mixed with any organic substance.

No other placarded hazardous materials shall be transported by holders of such licenses.

D. Service Oklahoma may issue a non-domiciled commercial learner permit or a non-domiciled commercial driver license to:

1. An H2A-Temporary Agricultural worker lawfully present in the United States as indicated on an original, valid and unexpired I-94 immigration status document issued by the United States Customs and Immigration Service; and

2. A J-1 Exchange Visitor Program participant lawfully present in the United States as indicated on a valid and unexpired J-1 Visitor Visa issued by the United States Customs and Immigration Service and who is enrolled in an agricultural education training program.

A person applying for such permit or license must comply with all testing and licensing requirements in accordance with applicable federal regulations, state laws and Service Oklahoma rules. The issued license shall be valid until the expiration of the visa for the non-domiciled worker. Service Oklahoma may promulgate rules for

1 the implementation of the process to carry out the provisions of
2 this section.

3 E. 1. Service Oklahoma shall develop a procedure whereby a
4 person applying for an original, renewal or replacement Class A, B,
5 C or D driver license or identification card who is required to
6 register as a convicted sex offender with the Department of
7 Corrections pursuant to the provisions of the Sex Offenders
8 Registration Act and who the Department of Corrections designates as
9 an aggravated or habitual offender pursuant to subsection J of
10 Section 584 of Title 57 of the Oklahoma Statutes shall be issued a
11 license or card bearing the words "Sex Offender".

12 2. Service Oklahoma shall notify every person subject to
13 registration under the provisions of Section 1-101 et seq. of this
14 title who holds a current Class A, B, C or D driver license or
15 identification card that such person is required to surrender the
16 license or card to Service Oklahoma within one hundred eighty (180)
17 days from the date of the notice.

18 3. Upon surrendering the license or card for the reason set
19 forth in this subsection, application may be made with Service
20 Oklahoma for a replacement license or card bearing the words "Sex
21 Offender".

22 4. Failure to comply with the requirements set forth in such
23 notice shall result in cancellation of the person's license or card.
24 Such cancellation shall be in effect for one (1) year, after which

1 time the person may make application with Service Oklahoma for a new
2 license or card bearing the words "Sex Offender". Continued use of
3 a canceled license or card shall constitute a misdemeanor and shall,
4 upon conviction thereof, be punishable by a fine of not less than
5 Twenty-five Dollars (\$25.00), nor more than Two Hundred Dollars
6 (\$200.00). When an individual is no longer required to register as
7 a convicted sex offender with the Department of Corrections pursuant
8 to the provisions of the Sex Offenders Registration Act, the
9 individual shall be eligible to receive a driver license or
10 identification card which does not bear the words "Sex Offender".

11 F. Nothing in subsection E of this section shall be deemed to
12 impose any liability upon or give rise to a cause of action against
13 any employee, agent or official of the Department of Corrections for
14 failing to designate a sex offender as an aggravated or habitual
15 offender pursuant to subsection J of Section 584 of Title 57 of the
16 Oklahoma Statutes.

17 G. A person subject to an order for the installation of an
18 ignition interlock device shall be required by Service Oklahoma to
19 submit his or her driver license for a replacement. The replacement
20 driver license shall bear the words "Interlock Required" and such
21 designation shall remain on the driver license for the duration of
22 the order requiring the ignition interlock device. The replacement
23 license shall be subject to the same expiration and renewal
24 procedures provided by law. Upon completion of the requirements for

1 the interlock device, a person may apply for a replacement driver
2 license.

3 H. Service Oklahoma shall develop a procedure whereby a person
4 applying for an original, renewal or replacement Class D driver
5 license who has been granted modified driving privileges under this
6 title shall be issued a Class D driver license which identifies the
7 license as a modified license.

8 SECTION 17. AMENDATORY 47 O.S. 2021, Section 6-113, is
9 amended to read as follows:

10 Section 6-113. A. ~~The Department of Public Safety~~ Service
11 Oklahoma upon issuing a ~~driver's~~ driver license shall have the
12 authority whenever good cause appears to impose restrictions

15 which the licensee may operate or such other restrictions applicable

20 restricted license or may set forth such restrictions upon the usual

23 satisfactory evidence of any violation of the restrictions of such
24 license suspend or revoke the same but the licensee shall be

1 entitled to a hearing as upon a suspension or revocation under this
2 chapter.

3 D. It is a misdemeanor for any person to operate a motor
4 vehicle in any manner in violation of the restrictions imposed in a
5 restricted license issued to him.

6 SECTION 18. AMENDATORY 47 O.S. 2021, Section 6-116, as
7 amended by Section 56, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2022,

1. Change a county of residence unless the person specifically notifies Service Oklahoma of such change; and

2. Presume that a new mailing address which is a different county than the old mailing address means that the person has changed his or her county of residence, and shall not change the county of residence unless specifically notified of such change.

1 relating thereto, shall be for a period of no less than one hundred

5 the Impaired Driver Accountability Program shall run concurrently

B. The driving privilege of a person who is convicted of any offense as provided in paragraph 3 or 6 of subsection A of Section 6-205 of this title shall be revoked or denied by ~~the Department of Public Safety~~ Service Oklahoma for the following period, as applicable:

1. The first license revocation shall be for one hundred eighty (180) days, which shall be modified upon request; provided, any modification under this paragraph shall apply to Class D driver licenses only;

1 2. A revocation shall be for a period of one (1) year if within
2 ten (10) years preceding the date of arrest relating thereto, as
3 shown by the records of ~~the Department~~ Service Oklahoma:

4 a. a prior revocation commenced pursuant to paragraph 2,
5 3 or 6 of subsection A of Section 6-205 of this title,

20 Such period shall not be modified; or

21 3. A revocation shall be for a period of three (3) years if
22 within ten (10) years preceding the date of arrest relating thereto,

- 1 a. two or more prior revocations commenced pursuant to
2 paragraph 2 or 6 of subsection A of Section 6-205 of
3 this title, or Section 753 or 754 of this title,
4 b. two or more prior revocations commenced pursuant to
5 paragraph 2 or 6 of subsection A of Section 6-205 of
6 this title or Section 753 or 754 of this title, or two
7 or more current enrollments in or previous completions

8 E. The petition shall be filed within thirty (30) days after
9 the notice of revocation, pursuant to Section 753 or 754 of this

12 of the facts and circumstances of the underlying incident sufficient
13 to determine the arresting law enforcement agency and the date of

16 pickup, except in the performance of the official duty of the
17 employee, or to use or permit the use of any such automobile, truck,
18 ambulance or pickup for other personal or private purposes. Any
19 person convicted of violating the provisions of this section shall
20 be guilty of a misdemeanor and shall be punished by a fine of not
21 more than One Hundred Dollars (\$100.00) or by imprisonment in the
22 county jail for a period to not exceed thirty (30) days, or by both
23 said fine and imprisonment, and in addition thereto, shall be
24 discharged from state employment.

1 B. 1. Any state employee, other than the individuals provided
2 for in paragraph 2 of this subsection and any employee of the
3 Department of Public Safety who is ~~an employee in the Driver License~~
4 ~~Examining Division or the Driver Compliance Division or~~ a wrecker
5 inspector or auditor of the Wrecker Services Division as provided
6 for in paragraph 3 of this subsection, who receives emergency
7 telephone calls regularly at the residence of the employee when the
8 employee is not on duty and is regularly called upon to use a
9 vehicle after normal work hours in response to such emergency calls,
10 may be permitted to use a vehicle belonging to the state to provide
11 transportation between the residence of the employee and the
12 assigned place of employment, provided such distance does not exceed
13 seventy-five (75) miles in any round trip or is within the county

16 leased vehicle to provide temporary transportation between a

20 subject to the distance or area restrictions provided for in this
21 paragraph. Authorization for temporary use of a state-owned or
22 state-leased vehicle for a specific project shall be in writing
23 stating the justification for this use and the saving expected to
24 result. Such authorization shall be valid for not to exceed sixty

1 (60) days. Any state entity other than law enforcement that avails
2 itself of this provision shall keep a monthly record of all
3 participating employees, the number of emergency calls received and
4 the number of times that a state vehicle was used in the performance
5 of such emergency calls.

6 2. Any employee of the Department of Public Safety, Oklahoma
7 Department of Corrections, Oklahoma State Bureau of Narcotics and
8 Dangerous Drugs Control, Oklahoma State Bureau of Investigation,
9 Alcoholic Beverage Laws Enforcement Commission, Oklahoma Horse
10 Racing Commission, Oklahoma Department of Agriculture, Food, and
11 Forestry, Office of the Inspector General within the Department of
12 Human Services or Office of the State Fire Marshal, who is a law
13 enforcement officer or criminalist, Public Information officer,

16 board or any employee of a district attorney who is a law
17 enforcement officer, may be permitted to use a state-owned or state-
18 leased vehicle to provide transportation between the residence of
19 the employee and the assigned place of employment and between the
20 residence and any location other than the assigned place of
21 employment to which the employee travels in the performance of the
22 official duty of the employee.

23 3. Any employee of the Department of Public Safety who is an
24 ~~employee in the Driver License Examining Division, an employee of~~

1 ~~the Driver Compliance Division,~~ a wrecker inspector or auditor of
2 the Wrecker Services Division, or a noncommissioned pilot may be
3 permitted, as determined by the Commissioner, to use a state-owned
4 or state-leased vehicle to provide transportation between the
5 residence of the employee and the assigned place of employment and
6 between the residence and any location other than the assigned place
7 of employment to which the employee travels in the performance of
8 the official duty of the employee.

9 4. The Director, department heads and other essential employees
10 of the Department of Wildlife Conservation, as authorized by the
11 Wildlife Conservation Commission, may be permitted to use a state-
12 owned or state-leased vehicle to provide transportation between the
13 residence of the employee and the assigned place of employment and
14 between the residence and any location other than the assigned place
15 of employment to which the employee travels in the performance of
16 the official duty of the employee.

17 5. The Director, department heads, emergency responders and
18 other essential employees of the Department of Corrections, as
19 authorized by the Director, may be permitted to use a state-owned or
20 state-leased vehicle to provide transportation between the residence
21 of the employee and the assigned place of employment and between the
22 residence and any location other than the assigned place of
23 employment to which the employee travels in the performance of the
24 official duty of the employee.

1 6. Designated Examiner Auditors, Designated Examiner
2 Supervisors, Commercial Driver License Examiners, Commercial Driver
3 License Auditors, Commercial Driver License Supervisors, and Driver
4 License Supervisors, as an employee of Service Oklahoma may be
5 permitted, as determined by the Director of Service Oklahoma, to use
6 a state-owned or state-leased vehicle to provide transportation
7 between the residence of the employee and the assigned place of
8 employment and between the residence and any location other than the
9 assigned place.

10 C. The principal administrator of the state agency with which
11 the employee is employed shall so designate the status of the
12 employee in writing or provide a copy of the temporary authorization
13 to the Governor, the President Pro Tempore of the Senate and the
14 Speaker of the House of Representatives. Such employee status
15 report shall also be provided to the State Fleet Manager of the
16 Division of Fleet Management if the motor vehicle for emergency use
17 is provided by said Division.

18 SECTION 22. AMENDATORY 47 O.S. 2021, Section 752, is
19 amended to read as follows:

20 Section 752. A. Only a licensed medical doctor, licensed
21 osteopathic physician, licensed chiropractic physician, registered
22 nurse, licensed practical nurse, physician's assistant, certified by
23 any state's appropriate licensing authority, an employee of a
24 hospital or other health care facility authorized by the hospital or

1 health care facility to withdraw blood, or individuals licensed in
2 accordance with Section 1-2505 of Title 63 of the Oklahoma Statutes
3 as an Intermediate Emergency Medical Technician, an Advanced
4 Emergency Medical Technician or a Paramedic, acting within the scope
5 of practice prescribed by their medical director, acting at the
6 request of a law enforcement officer may withdraw blood for the
7 purpose of having a determination made of its concentration of
8 alcohol or the presence or concentration of other intoxicating
9 substance. Only qualified persons authorized by the Board may
10 collect breath, saliva or urine, or administer tests of breath under
11 the provisions of this title.

12 B. If the person authorized to withdraw blood as specified in
13 subsection A of this section is presented with a written statement:

14 1. Authorizing blood withdrawal signed by the person whose
15 blood is to be withdrawn;

16 2. Signed by a duly authorized peace officer that the person
17 whose blood is to be withdrawn has agreed to the withdrawal of
18 blood;

19 3. Signed by a duly authorized peace officer that the person
20 whose blood is to be withdrawn has been placed under arrest and that
21 the officer has probable cause to believe that the person, while
22 intoxicated, has operated a motor vehicle in such manner as to have
23 caused the death or serious physical injury of another person, or
24 the person has been involved in a traffic accident and has been

1 removed from the scene of the accident that resulted in the death or
2 great bodily injury, as defined in subsection B of Section 646 of
3 Title 21 of the Oklahoma Statutes, of any person to a hospital or
4 other health care facility outside the State of Oklahoma before the
5 law enforcement officer was able to effect an arrest for such
6 offense; or

7 4. In the form of an order from a district court that blood be
8 withdrawn, the person authorized to withdraw the blood and the
9 hospital or other health care facility where the withdrawal occurs
10 may rely on such a statement or order as evidence that the person
11 has consented to or has been required to submit to the clinical
12 procedure and shall not require the person to sign any additional
13 consent or waiver form. In such a case, the person authorized to
14 perform the procedure, the employer of such person and the hospital
15 or other health care facility shall not be liable in any action
16 alleging lack of consent or lack of informed consent.

17 C. No person specified in subsection A of this section, no
18 employer of such person and no hospital or other health care
19 facility where blood is withdrawn shall incur any civil or criminal
20 liability as a result of the proper withdrawal of blood when acting
21 at the request of a law enforcement officer by the provisions of
22 Section 751 or 753 of this title, or when acting in reliance upon a
23 signed statement or court order as provided in this section, if the
24 act is performed in a reasonable manner according to generally

1 accepted clinical practice. No person specified in subsection A of
2 this section shall incur any civil or criminal liability as a result
3 of the proper collection of breath, saliva or urine when acting at
4 the request of a law enforcement officer under the provisions of
5 Section 751 or 753 of this title or when acting pursuant to a court
6 order.

7 D. The blood, breath, saliva or urine specimens obtained shall
8 be tested by the appropriate test as determined by the Board, or
9 tested by a laboratory that is exempt from the Board rules pursuant
10 to Section 759 of this title, to determine the alcohol concentration
11 thereof, or the presence or concentration of any other intoxicating
12 substance which might have affected the ability of the person tested
13 to operate a motor vehicle safely.

14 E. When blood is withdrawn for testing of its alcohol
15 concentration or other intoxicating substance presence or
16 concentration, at the request of a law enforcement officer, a
17 sufficient quantity of the same specimen shall be obtained to enable
18 the tested person, at his or her own option and expense, to have an
19 independent analysis made of such specimen. The excess blood
20 specimen shall be retained by a laboratory approved by the Board in
21 accordance with the rules and regulations of the Board or by a
22 laboratory that is exempt from the Board rules pursuant to Section
23 759 of this title, for sixty (60) days from the date of collection.
24 At any time within that period, the tested person or his or her

1 attorney may direct that such blood specimen be sent or delivered to
2 a laboratory of his or her own choosing and approved by the Board
3 for an independent analysis. Neither the tested person, nor any
4 agent of such person, shall have access to the additional blood
5 specimen prior to the completion of the independent analysis, except
6 the analyst performing the independent analysis and agents of the
7 analyst.

8 F. The costs of collecting blood specimens for the purpose of
9 determining the alcohol or other intoxicating substance thereof, by
10 or at the direction of a law enforcement officer, shall be borne by
11 the law enforcement agency employing such officer; provided, if the
12 person is convicted for any offense involving the operation of a
13 motor vehicle while under the influence of or while impaired by
14 alcohol or an intoxicating substance, or both, as a direct result of
15 the incident which caused the collection of blood specimens, an
16 amount equal to the costs shall become a part of the court costs of
17 the person and shall be collected by the court and remitted to the
18 law enforcement agency bearing the costs. The cost of collecting,
19 retaining and sending or delivering to an independent laboratory the
20 excess specimens of blood for independent analysis at the option of
21 the tested person shall also be borne by such law enforcement
22 agency. The cost of the independent analysis of such specimen of
23 blood shall be borne by the tested person at whose option such
24 analysis is performed. The tested person, or his or her agent,

1 shall make all necessary arrangements for the performance of such
2 independent analysis other than the forwarding or delivery of such
3 specimen.

4 G. Tests of blood or breath for the purpose of determining the
5 alcohol concentration thereof, and tests of blood for the purpose of
6 determining the presence or concentration of any other intoxicating
7 substance therein, under the provisions of this title, whether
8 administered by or at the direction of a law enforcement officer or
9 administered independently, at the option of the tested person, on
10 the excess specimen of such person's blood to be considered valid
11 and admissible in evidence under the provisions of this title, shall
12 have been administered in accordance with Section 759 of this title.

13 H. Any person who has been arrested for any offense arising out
14 of acts alleged to have been committed while the person was
15 operating or in actual physical control of a motor vehicle while
16 under the influence of alcohol, any other intoxicating substance or
17 the combined influence of alcohol and any other intoxicating
18 substance who is not requested by a law enforcement officer to
19 submit to a test shall be entitled to have an independent test of
20 his or her blood for the purpose of determining its alcohol
21 concentration or the presence or concentration of any other
22 intoxicating substance therein, performed by a person of his or her
23 own choosing who is qualified as stipulated in this section. The
24 arrested person shall bear the responsibility for making all

1 necessary arrangements for the administration of such independent
2 test and for the independent analysis of any specimens obtained, and
3 bear all costs thereof. The failure or inability of the arrested
4 person to obtain an independent test shall not preclude the
5 admission of other competent evidence bearing upon the question of
6 whether such person was under the influence of alcohol, or any other
7 intoxicating substance or the combined influence of alcohol and any
8 other intoxicating substance.

9 I. Any agency or laboratory certified by the Board or any
10 agency or laboratory that is exempt from the Board rules pursuant to
11 Section 759 of this title, which analyses blood shall make available
12 a written report of the results of the test administered by or at
13 the direction of the law enforcement officer to:

- 14 1. The tested person, or his or her attorney;
- 15 2. The Commissioner of Public Safety; ~~and~~
- 16 3. The Director of Service Oklahoma; and
- 17 4. The Fatality Analysis Reporting System (FARS) analyst of the
18 state, upon request.

19 The results of the tests provided for in this title shall be
20 admissible in all civil actions, including administrative hearings
21 regarding driving privileges.

22 SECTION 23. AMENDATORY 47 O.S. 2021, Section 753, as
23 amended by Section 6, Chapter 376, O.S.L. 2022 (47 O.S. Supp. 2022,
24 Section 753), is amended to read as follows:

1 Section 753. A. If a conscious person under arrest refuses to
2 submit to testing of his or her blood or breath for the purpose of
3 determining the alcohol concentration thereof, or to a test of his
4 or her blood, saliva or urine for the purpose of determining the
5 presence or concentration of any other intoxicating substance, or
6 the combined influence of alcohol and any other intoxicating
7 substance, none shall be given except upon the issuance of a search
8 warrant or unless the investigating officer has probable cause to
9 believe that the person under arrest, while intoxicated, has
10 operated the motor vehicle in such a manner as to have caused the
11 death or serious physical injury of any other person or persons. In
12 such event, such test otherwise authorized by law may be made in the
13 same manner as if a search warrant had been issued for such test or
14 tests. The sample shall be taken in a medically acceptable manner
15 as authorized by Section 752 of this title. The ~~Commissioner of~~
16 ~~Public Safety~~ Director of Service Oklahoma, upon the receipt of a
17 sworn report of the law enforcement officer that the officer had
18 reasonable grounds to believe the arrested person had been driving
19 or was in actual physical control of a motor vehicle upon the public
20 roads, highways, streets, turnpikes or other public place of this
21 state while under the influence of alcohol, any other intoxicating
22 substance, or the combined influence of alcohol and any other
23 intoxicating substance, or that the person had refused to submit to
24 the test or tests, shall revoke the license to drive and any

1 nonresident operating privilege for a period provided by Section 6-
2 205.1 of this title. If the person is a resident or nonresident
3 without a license or permit to operate a motor vehicle in this
4 state, the ~~Commissioner of Public Safety~~ Director of Service
5 Oklahoma shall deny to the person the issuance of a license or
6 permit for a period provided by Section 6-205.1 of this title
7 subject to a review as provided in Section 754 of this title. The
8 revocation or denial shall become effective forty-five (45) days
9 after the arrested person is given written notice thereof by the
10 officer or by the ~~Department of Public Safety~~ Service Oklahoma as
11 provided in Section 754 of this title.

12 B. ~~The Department~~ Service Oklahoma shall immediately reinstate
13 the driving privilege of the person if:

14 1. The arrested person was required to submit to the testing of
15 his or her blood or breath pursuant to the provisions of a search
16 warrant despite his or her refusal to submit to testing; and

17 2. ~~The Department~~ Service Oklahoma receives a written blood or
18 breath test report that reflects the arrested person did not have
19 any measurable quantity of alcohol, or any other intoxicating
20 substance, or the combination of alcohol and any other intoxicating
21 substance in the blood or breath of the arrested person.

22 SECTION 24. AMENDATORY 47 O.S. 2021, Section 754, as
23 amended by Section 7, Chapter 376, O.S.L. 2022 (47 O.S. Supp. 2022,

1 Section 754. A. The sworn report of the officer stating the
2 officer had reasonable grounds to believe the arrested person had
3 been driving or was in actual physical control of a motor vehicle
4 upon the public roads, highways, streets, turnpikes or other public
5 place of this state while under the influence of alcohol, any other
6 intoxicating substance or the combined influence of alcohol and any
7 other intoxicating substance, shall be submitted by mail, by
8 electronic means approved by ~~the Department~~ Service Oklahoma or in
9 person to ~~the Department~~ Service Oklahoma within seventy-two (72)
10 hours of the issuance of the report. The failure of the officer to

23 eight-hundredths (0.08) or more, accompanied by a sworn report from
24 a law enforcement officer that the officer had reasonable grounds to

3 alcohol as prohibited by law, ~~the Department~~ Service Oklahoma shall
4 revoke or deny the driving privilege of the arrested person for a

8 which is the subject of the report. Revocation or denial of the
9 driving privilege of the arrested person shall become effective

12 ~~by the Department as provided in Section 2-116 of this title~~ Service
13 Oklahoma.

14 C. The appeal hearing before the district court shall be
15 conducted in accordance with Section 6-211 of this title. The
16 hearing shall cover the issues of whether the officer had reasonable
17 grounds to believe the person had been operating or was in actual
18 physical control of a vehicle upon the public roads, highways,
19 streets, turnpikes or other public place of this state while under
20 the influence of alcohol, any other intoxicating substance or the
21 combined influence of alcohol and any other intoxicating substance
22 as prohibited by law, and whether the person was placed under
23 arrest.

1 1. If the revocation or denial is based upon a breath or blood
2 test result and a sworn report from a law enforcement officer, the
3 scope of the hearing shall also cover the issues as to whether:

- 4 a. if timely requested by the person, the person was not
5 denied a breath or blood test,
- 6 b. the specimen was obtained from the person within two
7 (2) hours of the arrest of the person,
- 8 c. the person, if under twenty-one (21) years of age, was
9 advised that driving privileges would be revoked or
10 denied if the test result reflected the presence of
11 any measurable quantity of alcohol,
- 12 d. the person, if twenty-one (21) years of age or older,
13 was advised that driving privileges would be revoked
14 or denied if the test result reflected an alcohol

18 2. If the revocation or denial is based upon the refusal of the
19 person to submit to a breath or blood test, reflected in a sworn

1 b. the person was informed that driving privileges would
2 be revoked or denied if the person refused to submit
3 to the test or tests.

4 D. After the hearing, the district court shall order the
5 revocation or denial either rescinded or sustained.

8 Section 761. A. Any person who operates a motor vehicle while
9 his ability to operate such motor vehicle is impaired by the
10 consumption of alcohol, or any other substance, other than alcohol,
11 which is capable of being ingested, inhaled, injected or absorbed
12 into the human body and is capable of adversely affecting the
13 central nervous system, vision, hearing or other sensory or motor
14 functions shall be subject to a fine of not less than One Hundred
15 Dollars (\$100.00) nor more than Five Hundred Dollars (\$500.00), or
16 imprisonment in the county jail for not more than six (6) months, or
17 by both such fine and imprisonment.

18 B. Upon the receipt of any person's record of conviction of
19 driving while impaired, when such conviction has become final, ~~the~~
20 ~~Department of Public Safety~~ Service Oklahoma shall suspend the
21 driving privilege of such person, as follows:

22 1. The first suspension shall be for thirty (30) days;

1 2. The second suspension shall be for a period of six (6)
2 months, which may be modified; provided, any modification under this
3 paragraph shall apply to Class D motor vehicles only; and

4 3. The third or subsequent suspension shall be for twelve (12)
5 months, which may be modified; provided, any modification under this
6 paragraph shall apply to Class D motor vehicles only.

7 Provided, however, ~~the Department~~ Service Oklahoma shall not
8 suspend such privilege pursuant to this subsection if said person's
9 driving privilege has been revoked based upon a test result or test
10 refusal pursuant to Section 753 or Section 754 of this title arising
11 from the same circumstances which resulted in the conviction.

12 C. The violations as set out in this section shall not be
13 bondable under Section 1115.3 of Title 22 of the Oklahoma Statutes.

14 D. Any person who is found guilty of a violation of the
15 provisions of this section or pleading guilty or nolo contendere for
16 a violation of any provision of this section shall be ordered to
17 participate in, prior to sentencing, an alcohol and drug assessment
18 and evaluation by an assessment agency or assessment personnel
19 certified by the Department of Mental Health and Substance Abuse
20 Services for the purpose of evaluating the receptivity to treatment
21 and prognosis of the person. The court shall order the person to
22 reimburse the agency or assessor for the assessment and evaluation.
23 The fee for an assessment and evaluation shall be the amount
24 provided in subsection C of Section 3-460 of Title 43A of the

1 Oklahoma Statutes. The evaluation shall be conducted at a certified
2 assessment agency, the office of a certified assessor or at another
3 location as ordered by the court. The agency or assessor shall,
4 within seventy-two (72) hours from the time the person is assessed,
5 submit a written report to the court for the purpose of assisting
6 the court in its final sentencing determination. If such report
7 indicates that the evaluation shows that the defendant would benefit
8 from a ten-hour or twenty-four-hour alcohol and drug substance abuse
9 course or a treatment program or both, the court shall, as a

11 a suspended sentence, require the person to follow all
12 recommendations identified by the assessment and evaluation and
13 ordered by the court. No person, agency or facility operating an

18 B. Rules promulgated by ~~the Commissioner~~ Service Oklahoma, in
19 conjunction with the Department of Public Safety, shall state the
20 requirements for an instructor's license, including requirements
21 concerning moral character, physical condition, knowledge of the
22 courses of instruction, motor vehicle laws and safety principles and
23 practices, previous personnel and employment records, and such other
24 matters as ~~the Commissioner~~ Service Oklahoma, in conjunction with

1 the Department of Public Safety, may prescribe for the protection of
2 the public.

3 SECTION 29. AMENDATORY 47 O.S. 2021, Section 805, is
4 amended to read as follows:

5 Section 805. All licenses shall expire on the last day of the
6 calendar year and may be renewed upon application to ~~the~~
7 ~~Commissioner~~ Service Oklahoma as prescribed by ~~his~~ its regulation.
8 Each application for an original or renewal school license shall be
9 accompanied by a fee of Twenty-five Dollars (\$25.00). Each
10 application for an original or renewal instructor's license shall be
11 accompanied by a fee of Five Dollars (\$5.00). The license fees
12 collected pursuant to Sections 801 through 808 of this title shall
13 be remitted to the State Treasurer to be credited to the General
14 Revenue Fund in the State Treasury. No license fee shall be
15 refunded in the event that the license is rejected, suspended, or
16 revoked.

17 SECTION 30. AMENDATORY 47 O.S. 2021, Section 806, is
18 amended to read as follows:

19 Section 806. ~~The Commissioner~~ Service Oklahoma may cancel,
20 suspend, revoke, or refuse to issue or renew a school or
21 instructor's license in any case where he finds the licensee or
22 applicant has not complied with, or has violated, any of the
23 provisions of this Act or any regulation adopted by ~~the Commissioner~~
24 Service Oklahoma hereunder. Any canceled, suspended or revoked

9 title, applications therefor, vehicle registration records, records
10 related to boats and motors, and computer data files is hereby
11 declared to be confidential information and shall not be copied by
12 anyone or disclosed to anyone other than employees of Service
13 Oklahoma or the Corporation Commission in the regular course of
14 their employment, except as provided in subsection B of this
15 section. As used in this section, "personal information" means
16 information that identifies an individual including name, address
17 (excluding the five-digit ZIP code) and telephone number, but does
18 not include information on vehicular accidents, driving violations
19 and driver's status.

20 B. Personal information referred to in subsection A of this
21 section shall be disclosed for use in connection with matters of
22 motor vehicle or driver safety and theft, motor vehicle emissions,
23 motor vehicle product alterations, recalls or advisories, and
24 removal of non-owner records from the original owner records of

1 motor vehicle manufacturers to carry out the purpose of Titles I and
2 IV of the Anti Car Theft Act of 1992, the Automobile Information
3 Disclosure Act (15 U.S.C., Section 1231 et seq.), the Clean Air Act
4 (42 U.S.C., Section 7401 et seq.) and Chapters 301, 305 and 321-331
5 of Title 49 of the United States Code and may be disclosed as
6 follows:

7 1. For use by any governmental agency, including but not
8 limited to any court or law enforcement agency, in carrying out its
9 functions, or any private person or entity acting on behalf of a
10 federal, state or local governmental agency in carrying out its
11 functions. Information relating to motor vehicle insurance,
12 including the insurer and insurance policy numbers, may be released
13 to law enforcement officers investigating an accident pursuant to
14 the provisions of Section 10-104 of this title;

15 2. For use by any motor vehicle manufacturer or an authorized
16 representative thereof in connection with matters of motor vehicle
17 or driver safety and theft, motor vehicle emissions, motor vehicle
18 product alterations, recalls or advisories, performance monitoring
19 of motor vehicles, motor vehicle parts and dealers, motor vehicle
20 market research activities, including survey research, and removal
21 of non-owner records from the original owner records of motor
22 vehicle manufacturers. The confidentiality of the information shall
23 be protected, as set out above, and used only for the purpose
24 stated; provided, further, that Service Oklahoma or the Corporation

1 Commission shall be authorized to review the use of and the measures
2 employed to safeguard the information; and provided, further, that
3 the manufacturer or representative shall bear the cost incurred by
4 Service Oklahoma or the Corporation Commission in the production of
5 the information requested. If the confidentiality provisions, as
6 set out above, are violated, the provisions of subsection D of
7 Section 205 of Title 68 of the Oklahoma Statutes shall apply and the
8 privilege of obtaining information shall be terminated. Any
9 manufacturer or representative violating the provisions of this
10 paragraph, upon conviction, shall be punishable by a fine not to
11 exceed Fifty Thousand Dollars (\$50,000.00);

12 3. For use by any person compiling and publishing motor vehicle
13 statistics, provided that such statistics do not disclose the names
14 and addresses of individuals. Such information shall be provided
15 upon payment of a reasonable fee as determined by Service Oklahoma
16 or the Corporation Commission;

17 4. For use by a wrecker or towing service licensed pursuant to
18 the provisions of Section 951 et seq. of this title for use in
19 providing notice to the owners and secured parties of towed or
20 impounded vehicles, upon payment of a fee of One Dollar (\$1.00) per
21 vehicle record page to Service Oklahoma, the Corporation Commission
22 or any licensed operator;

23 5. For use by a legitimate business or its agents, employees,
24 or contractors for use in the normal course of business, upon

1 payment of a fee of One Dollar (\$1.00) per vehicle record page to
2 Service Oklahoma, the Corporation Commission or any licensed
3 operator, but only:

4 a. to verify the accuracy of personal information
5 submitted by the individual to whom the information
6 pertains to the business or its agents, employees, or
7 contractors, or

8 b. to obtain the correct information, if such information
9 submitted by the individual to whom the information
10 pertains to the business is not correct, or is no
11 longer correct, but only for the purposes of
12 preventing fraud by, pursuing legal remedies against,
13 or recovering on a debt or security interest against
14 the individual;

15 6. For use in connection with any civil, criminal,
16 administrative or arbitral proceeding in any federal, state or local
17 court or agency or before any self-regulatory body, including the
18 service of process, investigation in anticipation of litigation, and
19 the execution or enforcement of judgments and orders, or pursuant to
20 an order of a federal, state or local court, upon payment of a fee
21 of One Dollar (\$1.00) per vehicle record page to Service Oklahoma,
22 the Corporation Commission or any licensed operator;

23 7. For use by any insurer or insurance support organization, or
24 by a self-insured entity, or its agents, employees, or contractors,

1 in connection with claims investigation activities, anti-fraud
2 activities, rating or underwriting, upon payment of a fee of One
3 Dollar (\$1.00) per vehicle record page to Service Oklahoma, the
4 Corporation Commission or any licensed operator;

5 8. For use by any licensed private investigative agency or
6 licensed security service for any purpose permitted under this
7 subsection, upon payment of a fee of One Dollar (\$1.00) per vehicle
8 record page to Service Oklahoma, the Corporation Commission or any
9 licensed operator;

10 9. For use by a requester, upon payment of a fee of One Dollar
11 (\$1.00) per vehicle record page to Service Oklahoma, the Corporation
12 Commission or any licensed operator, if the requester demonstrates
13 that it has obtained the written consent of the individual to whom
14 the information pertains;

15 10. For use in connection with the operation of private toll
16 transportation facilities; or

17 11. For furnishing the name and address of all commercial
18 entities who have current registrations of any particular model of
19 vehicle; provided, this exception shall not allow the release of
20 personal information pursuant to the provisions of the Driver's
21 Privacy Protection Act, 18 U.S.C., Sections 2721 through 2725.

22 Service Oklahoma shall collect a reasonable fee to recover the
23 costs of providing the data. As used in this section, the term
24 "vehicle record page" means a computer-generated printout of the

1 motor vehicle inquiry screen. Information provided on the motor
2 vehicle inquiry screen printout shall include the current vehicle
3 owner name and address, vehicle make, model and year, identifying
4 numbers for the vehicle license plate, certificate of title and
5 vehicle identification number, relevant dates relating to the
6 vehicle registration and certificate of title, lienholder
7 information and lien status.

8 C. In addition to the information provided on the vehicle
9 record page, Service Oklahoma or the Corporation Commission may,
10 upon written request, release to any requester authorized by the
11 provisions of this section to obtain individual motor vehicle
12 information, corresponding copies of vehicle certificates of title,
13 applications therefor, vehicle registration records and computer
14 data files.

15 There shall be an informational search and retrieval fee of Five
16 Dollars (\$5.00) per vehicle computer record search. If Service
17 Oklahoma or the Corporation Commission performs a manual search, the
18 fee shall be Seven Dollars and fifty cents (\$7.50) per vehicle.
19 Service Oklahoma is authorized to promulgate rules whereby licensed
20 operators, when requesting such documentation in the performance of
21 their duties, are exempt from this retrieval fee. Certified copies
22 of vehicle certificates of title and applications therefor shall be
23 included within the informational search and retrieval by Service
24 Oklahoma or the Corporation Commission for a fee of Ten Dollars

1 (\$10.00). Such duly certified copies may be received in evidence
2 with the same effect as the original when the original is not in the
3 possession or under the control of the party desiring to use the
4 same.

5 D. Requesters authorized by this section to receive information
6 shall submit to Service Oklahoma, the Corporation Commission or any
7 licensed operator an affidavit supported by such documentation as
8 Service Oklahoma or the Corporation Commission may require, on a
9 form prescribed by Service Oklahoma or the Corporation Commission
10 certifying that the information is requested for a lawful and
11 legitimate purpose and will not be further disseminated.

12 E. Notwithstanding the foregoing, Service Oklahoma or the
13 Corporation Commission may allow the release of information from its
14 motor vehicle records upon magnetic tape consisting only of the
15 following information:

- 16 1. The date of the certificate of title;
 - 17 2. The certificate of title number;
 - 18 3. The type of title issued for the vehicle;
 - 19 4. The odometer reading from the certificate of title;
 - 20 5. The year in which the vehicle was manufactured;
 - 21 6. The vehicle identification number for the vehicle;
 - 22 7. The make of the vehicle; and
 - 23 8. The location in which the vehicle is registered.

1 Service Oklahoma or the Corporation Commission shall allow the
2 release of such information upon payment of a reasonable fee to be
3 determined by Service Oklahoma or the Corporation Commission. The
4 information released as authorized by this subsection may only be
5 used for purposes of detecting odometer rollback or odometer
6 tampering, for determining the issuance in this state or any other
7 state of salvage or rebuilt titles for vehicles or for determining
8 whether a vehicle has been reported stolen in this state or any
9 other state.

10 F. Notwithstanding the provisions of this section or of Section
11 205 of Title 68 of the Oklahoma Statutes, Service Oklahoma or the
12 Corporation Commission may inform a secured party that taxes and
13 fees are delinquent with respect to a vehicle upon which the secured
14 party has a perfected lien.

15 G. Fees received by a licensed operator pursuant to the
16 provisions of this section shall not be included in the maximum sum
17 that may be retained by licensed operators as compensation pursuant
18 to the provisions of Section 1143 of this title.

19 H. All funds collected by the Tax Commission pursuant to the
20 provisions of this section shall be deposited in the Oklahoma Tax
21 Commission Revolving Fund. Beginning January 1, 2023, all funds
22 collected by Service Oklahoma pursuant to the provisions of this
23 section shall be deposited in the Service Oklahoma Revolving Fund.
24 All funds collected by the Corporation Commission pursuant to the

1 provisions of this section shall be apportioned as provided in
2 subsection C of Section 1161 of this title.

3 I. It is further provided that the provisions of this section
4 shall be strictly interpreted and shall not be construed as
5 permitting the disclosure of any other information contained in the
6 files and records of Service Oklahoma or the Corporation Commission.

7 J. It shall be unlawful for any person to commit any of the
8 following acts:

9 1. To knowingly obtain or disclose personal information from a
10 motor vehicle record for any use not expressly permitted by this
11 section; or

12 2. To make false representation to obtain any personal
13 information from an individual's motor vehicle record.

14 Any violation of the provisions of this section shall constitute
15 a misdemeanor and shall be punishable by the imposition of a fine
16 not exceeding One Thousand Dollars (\$1,000.00), or by imprisonment
17 in the county jail for a term not exceeding one (1) year, or by both
18 such fine and imprisonment. Where applicable, a person convicted of
19 a violation of the provisions of this section shall be removed or
20 dismissed from office or state employment. No liability whatsoever,
21 civil or criminal, shall attach to any member or employee of Service
22 Oklahoma or the Corporation Commission for any error or omission in
23 the disclosure of such information.

1 SECTION 32. AMENDATORY 47 O.S. 2021, Section 1135.5, as
2 last amended by Section 164, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
3 2022, Section 1135.5), is amended to read as follows:

4 Section 1135.5. A. Service Oklahoma is hereby authorized to
5 design and issue appropriate official special license plates to
6 persons wishing to demonstrate support and provide financial
7 assistance as provided by this section.

8 Special license plates shall not be transferred to any other
9 person but shall be removed from the vehicle upon transfer of
10 ownership and retained. The special license plate may then be used
11 on another vehicle but only after such other vehicle has been
12 registered for the current year with a licensed operator.

13 Special license plates shall be renewed each year by Service
14 Oklahoma or a licensed operator, unless authorized by Service
15 Oklahoma to be renewed for a period greater than one (1) year.
16 Service Oklahoma shall notify by mail all persons issued special
17 license plates. The notice shall contain all necessary information
18 and shall contain instructions for the renewal procedure upon
19 presentation to a licensed operator or Service Oklahoma. The
20 license plates shall be issued on a staggered system.

21 Service Oklahoma is hereby directed to develop and implement a
22 system whereby licensed operators are permitted to accept
23 applications for special license plates authorized under this
24 section. The licensed operator shall confirm the applicant's

1 eligibility, if applicable, collect and deposit any amount
2 specifically authorized by law, accept and process the necessary
3 information directly into such system and generate a receipt
4 accordingly. For performance of these duties, licensed operators
5 shall retain the fee provided in Section 1141.1 of this title for
6 registration of a motor vehicle. The licensed operator fees for
7 acceptance of applications and renewals shall be paid out of the
8 ~~Oklahoma~~ Tax Commission Reimbursement Fund. Beginning January 1,
9 2023, the licensed operator fees for acceptance of applications and
10 renewals shall be paid out of the Service Oklahoma Reimbursement
11 Fund.

12 If fewer than ~~one hundred~~ fifty (50) of any type of special
13 license plates authorized prior to January 1, 2004, are issued prior
14 to January 1, 2006, Service Oklahoma shall discontinue issuance and
15 renewal of that type of special license plate. Any such authorized
16 special license plate registrant shall be allowed to display the
17 license plate upon the designated vehicle until the registration
18 expiration date. After such time the expired special license plate
19 shall be removed from the vehicle.

20 For special license plates authorized on or after July 1, 2004,
21 no special license plates shall be developed or issued by Service
22 Oklahoma until Service Oklahoma receives one hundred prepaid
23 applications therefor. The prepaid applications must be received by

11 apportioned as provided in Section 1104.1 of this title;

12 2. Environmental Awareness License Plate - such plates shall be
13 designed, subject to the criteria to be presented to Service
14 Oklahoma by the Department of Environmental Quality in consultation
15 with the Oklahoma Arts Council, and issued to any person wishing to
16 demonstrate support to implement the statewide general public
17 ~~environmental education program~~ Environmental Education Program
18 created pursuant to the provisions of the Oklahoma Environmental
19 Quality Code. Such plates shall be designed and issued to any
20 person in any combination of numbers and letters from one to a
21 maximum of seven, as for personalized license plates. A dealer's
22 license plate issued pursuant to Section 1116.1 or 1128 of this
23 title may be designated an Environmental Awareness License Plate
24 upon payment of the fee imposed by this section and any other

1 registration fees required by the Oklahoma Vehicle License and
2 Registration Act. As provided in this section, an amount of the fee
3 collected shall be apportioned pursuant to Section 1104.2 of this
4 title;

5 3. Firefighter License Plate - such plates shall be designed
6 for any career or retired firefighter, volunteer or paid.
7 Firefighters may apply for firefighter plates for up to four
8 vehicles with a rated capacity of one (1) ton or less or for a
9 motorcycle upon proof of a fire department membership by either an
10 identification card or letter from the chief of the fire department.
11 Retirees who are eligible for such plates shall provide proof of
12 eligibility upon initial application, but shall not be required to
13 provide proof of eligibility annually. The surviving spouse of any
14 deceased firefighter, if the spouse has not since remarried, may
15 apply for a firefighter license plate for one vehicle with a rated
16 carrying capacity of one (1) ton or less or for a motorcycle upon
17 proof that the deceased firefighter was a member of a fire
18 department by either an identification card or letter from the chief
19 of the fire department. The license plate shall be designed in

21 As provided in this section, an amount of the fee collected

24 and the Oklahoma Fallen and Living Firefighters Memorial;

1 4. Wildlife Conservation License Plate - such plates shall be
2 designed, subject to the criteria to be presented to Service
3 Oklahoma by the ~~Oklahoma~~ Department of Wildlife Conservation in
4 consultation with the Oklahoma Arts Council, and issued to any
5 person wishing to demonstrate support for wildlife conservation in
6 this state through the Wildlife Diversity Fund, provided for in

8 be designed and issued to any person as for personalized license
9 plates.

10 As provided in this section, an amount of the fee collected
11 shall be apportioned pursuant to subsection D of Section 3-310 of
12 Title 29 of the Oklahoma Statutes;

13 5. Child Abuse Prevention License Plate - such plates shall be
14 designed, subject to the criteria to be presented to Service
15 Oklahoma by the Office of Child Abuse Prevention in the State
16 Department of Health and the ~~Oklahoma Committee to Prevent Child~~
17 ~~Abuse~~ Child Abuse Prevention Action Committee, and issued to any
18 person wishing to demonstrate support for the prevention of child
19 abuse.

20 As provided in this section, an amount of the fee collected
21 shall be deposited in the Child Abuse Prevention Fund;

22 6. United States Olympic and Paralympic Committee Supporter
23 License Plate - such plates shall be designed and issued to any
24 person wishing to demonstrate support for the United States Olympic

1 and Paralympic Committee. The plates shall be issued to any person
2 in any combination of numbers and letters from one to a maximum of
3 seven, as for personalized license plates. The plate shall contain
4 the official United States Olympic and Paralympic Committee logo.
5 Service Oklahoma shall be authorized, if necessary, to enter into a
6 licensing agreement with the United States Olympic and Paralympic
7 Committee for any licensing fees which may be required in order to
8 use the United States Olympic and Paralympic Committee logo or
9 design. The licensing agreement shall provide for a payment ~~of~~ not
10 more than Twenty-five Dollars (\$25.00) for each license plate
11 issued;

12 7. Oklahoma History License Plate - such plates shall be
13 designed and issued to any person wishing to demonstrate interest in
14 Oklahoma history. As provided in this section, an amount of the fee
15 collected shall be deposited to the Oklahoma Historical Society
16 Revolving Fund to be used for educational purposes;

17 8. Historic Route 66 License Plate - such:

18 a. vehicle plates shall be designed to honor historic
19 Route 66, also known as the "Mother Road". As
20 provided in this section, an amount of the fee
21 collected for each vehicle license plate shall be
22 apportioned to the Oklahoma Historical Society
23 Revolving Fund to be distributed to the Route 66
24 Museum located in Clinton, Oklahoma, and

b. motorcycle plates shall be designed in consultation with the Oklahoma Route 66 Association, Inc. Service Oklahoma shall be authorized to enter into a licensing agreement with the Oklahoma Route 66 Association, Inc., for any licensing fees which may be required in order to use the Oklahoma Route 66 Association, Inc., logo or design. The licensing agreement shall provide for a payment to the Oklahoma Route 66 Association, Inc., of not more than Twenty Dollars (\$20.00) for each motorcycle license plate issued;

9. Heart of the Heartland License Plate - such plates shall be designed and issued to any person wishing to honor the victims of the terrorist bombing attack on the Alfred P. Murrah Federal Building in downtown Oklahoma City on April 19, 1995. As provided in this section, an amount of the fee collected shall be deposited in the Heart of the Heartland Scholarship Fund, as established in Section 2282 of Title 70 of the Oklahoma Statutes;

10. Emergency Medical Technician License Plate - such plates shall be designed and issued to any person who is an emergency medical technician. Such persons may apply for an emergency medical technician license plate for each vehicle with a rated carrying capacity of one (1) ton or less upon proof of an emergency medical technician's license. The license plate shall be designed in consultation with the ~~state association of emergency medical~~

1 ~~technicians~~ Oklahoma Emergency Medical Technicians Association. As
2 provided in this section, an amount of the fee collected shall be
3 apportioned to the Emergency Medical Personnel Death Benefit

6 11. Fight Breast Cancer License Plate - such plates shall be

11 12. Crime Victims Awareness License Plate - such plates shall
12 be designed and issued to any person wishing to demonstrate

16 section, an amount of the fee collected shall be apportioned to the

8 designed, subject to criteria to be presented to Service Oklahoma by
9 the State Department of Education in consultation with the Oklahoma
10 Arts Council, and issued to any person wishing to demonstrate
11 support for education in this state. All licensed operators shall
12 display a sample of the Support Education License plate in the area
13 of the business accessed by the public. Twenty-three Dollars
14 (\$23.00) of the fee collected shall be apportioned as follows:

- 15 a. five percent (5%) shall be deposited to the Education
16 Reform Revolving Fund,
- 17 b. five percent (5%) shall be deposited to the Oklahoma
18 State Regents for Higher Education Revolving Fund,
- 19 c. five percent (5%) shall be deposited to the State
20 ~~Career-Technology~~ Career-Technology Fund, and
- 21 d. eighty-five percent (85%) shall be deposited to the
22 Teachers' Retirement Benefit Fund as set forth in
23 Section 17-108 of Title 70 of the Oklahoma Statutes.

1 However, when the Teachers' Retirement Benefit Fund attains a
2 seventy percent (70%) funded ratio based on an annual actuarial
3 valuation as required by law, the amount of the fee shall be
4 apportioned equally pursuant to subparagraphs a, b and c of this
5 paragraph;

6 18. Retired Oklahoma Highway Patrol Officers License Plate -
7 such plates shall be designed and issued to any retired officer of

4 to any person in any combination of numbers and letters from one to
5 a maximum of seven, as for personalized license plates. The plate
6 shall contain the official Boy Scouts of America logo. Service
7 Oklahoma shall be authorized, if necessary, to enter into a
8 licensing agreement with the Boy Scouts of America for any licensing
9 fees which may be required in order to use the Boy Scouts of America
10 logo or design. The licensing agreement shall provide for a payment
11 to the Boy Scouts of America of not more than Twenty Dollars
12 (\$20.00) for each license plate issued;

13 20. Urban Forestry and Beautification License Plate - such
14 plates shall be designed, subject to criteria to be presented to
15 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,
16 and Forestry in consultation with nonprofit organizations in this
17 state that develop and operate programs to encourage urban forestry
18 and beautification, and issued to any person wishing to demonstrate
19 support of such programs. As provided in this section, an amount of
20 the fee collected shall be apportioned as provided in Section 1104.5
21 of this title;

22 21. Oklahoma State Parks Supporter License Plate - such plates
23 shall be designed, subject to criteria to be presented to Service
24 Oklahoma by the Oklahoma Tourism and Recreation Department, and

1 issued to any person wishing to demonstrate support for the Oklahoma
2 state parks system. Twenty-three Dollars (\$23.00) of the fee
3 collected shall be deposited in the Oklahoma Tourism and Recreation
4 Department Revolving Fund. Such money shall be designated for and
5 may only be expended for the support of Oklahoma state parks;

6 22. Adoption Creates Families License Plate - such plates shall
7 be issued to any person wishing to demonstrate support of pregnant
8 women who are committed to placing their children for adoption and
9 wishing to provide assistance to guardians, adoptive parents and
10 other created families to assist in the adoption and placement of
11 children in permanent, safe homes. The license plates shall be
12 designed and final terminology delivered in consultation with the
13 Oklahoma Adoption Coalition and the Department of Human Services.
14 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
15 in a revolving fund established in the State Treasury for and to be
16 used by the Department of Human Services for the implementation of
17 the Investing in Stronger Oklahoma Families Act specifically for
18 created families;

19 23. Choose Life License Plate - such plates shall be designed,
20 subject to criteria presented to Service Oklahoma, by Choose Life

8 provided in this section, an amount of the fee collected shall be
9 apportioned as provided in Section 1104.7 of this title;

10 25. Lions Club License Plate - such plates shall be designed
11 and issued to persons wishing to demonstrate support for the Lions

13 any combination of numbers and letters from one to a maximum of
14 seven, as for personalized license plates. The license plates shall
15 be designed in consultation with the Oklahoma Lions Service

17 Association of Lions Clubs. Service Oklahoma shall be authorized to
18 enter into a licensing agreement with the Oklahoma Lions Service
19 Foundation. The licensing agreement shall provide for a payment to
20 the Oklahoma Lions Service Foundation of not more than Ten Dollars
21 (\$10.00) for each license plate issued;

22 26. Color Oklahoma License Plate - such plates shall be
23 designed, subject to criteria to be presented to Service Oklahoma by
24 the Oklahoma Native Plant Society, and issued to any person wishing

1 to demonstrate support for preserving and planting wildflowers and
2 native plants in ~~Oklahoma~~ this state and to promote Oklahoma's
3 wildflower heritage through education. As provided in this section,
4 an amount of the fee collected shall be apportioned as provided in
5 Section 1104.8 of this title;

6 27. Girl Scouts of the United States of America Supporter
7 License Plate - such plates shall be designed and issued to any
8 person wishing to demonstrate support for the Girl Scouts of the
9 United States of America. The plates shall be issued to any person
10 in any combination of numbers and letters from one to a maximum of
11 seven, as for personalized license plates. The plate shall contain
12 the official Girl Scouts of the United States of America logo.
13 Service Oklahoma shall be authorized, if necessary, to enter into a
14 licensing agreement with the Girl Scouts of the United States of
15 America for any licensing fees which may be required in order to use
16 the Girl Scouts of the United States of America logo or design. The
17 licensing agreement shall provide for a payment to the ~~Girl Scouts~~

10 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for
11 each license plate issued;

12 40. Folds of Honor Supporter License Plate - such plates shall
13 be authorized to be designed and issued to any person wishing to
14 demonstrate support for the Oklahoma City Chapter of Folds of Honor
15 Incorporated, a nonprofit charitable organization exempt from
16 taxation pursuant to the provisions of the Internal Revenue Code, 26
17 U.S.C., Section 501(c)(3), providing educational scholarships to
18 spouses and children of America's fallen and disabled military

3 (\$20.00) for each license plate issued;

5 plates shall be issued to persons wishing to demonstrate support for

8 plates shall be issued to any person in any combination of numbers

12 Service Oklahoma shall be authorized to enter into a licensing

17 paid to the county treasurer for the county in which the license
18 plate was purchased to be credited to the ~~County Highway Fund~~ county

21 101. Blue Star Mothers License Plate - such plates shall be
22 designed and issued to any person showing proof of membership in an

2 authorized to enter into a licensing agreement with Blue Star

4 fees which may be required in order to use the Blue Star Mothers of
5 America logo or design. The licensing agreement shall provide for a
6 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One

8 issued;

9 102. Stillwater Public Schools License Plate - such plates
10 shall be designed and issued to any person wishing to demonstrate
11 support for the Stillwater ~~School District~~ school district. The
12 license plates shall be designed in consultation with the
13 administration of the Stillwater ~~School District~~ school district.
14 Service Oklahoma shall be authorized to enter into a licensing
15 agreement with the Stillwater ~~School District~~ school district for
16 any licensing fees which may be required in order to use the school
17 district's logo or design. The licensing agreement shall provide
18 for a payment to the Stillwater ~~School District~~ school district
19 not more than Twenty Dollars (\$20.00) for each license plate issued;

20 103. Oklahoma Golf License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 the sport of golf in Oklahoma. The license plates shall be designed
23 in consultation with the South Central Section of the Professional
24 Golfers' Association of America and issued to any person wishing to

1 demonstrate support for the sport of golf in Oklahoma. Service
2 Oklahoma shall be authorized to enter into a licensing agreement
3 with the South Central Section of the Professional Golfers'
4 Association of America for any licensing fees which may be required
5 in order to use the organization's logo or design. The licensing
6 agreement shall provide for a payment to the South Central Section
7 of the Professional Golfers' Association of America of not more than
8 Twenty Dollars (\$20.00) for each license plate issued;

9 104. Paramedic License Plate - such plates shall be designed
10 and issued to any person who is a paramedic. Such persons may apply
11 for a paramedic license plate for each vehicle with a rated carrying
12 capacity of one (1) ton or less upon proof of a paramedic license.
13 The license plates shall be designed in consultation with the
14 Oklahoma State University-Oklahoma City Paramedicine ~~Program~~ program
15 and the Oklahoma Emergency Medical Technicians Association. Service
16 Oklahoma shall be authorized to enter into a licensing agreement
17 with the Oklahoma Emergency Medical Technicians Association for any

6 Veterans Affairs. Service Oklahoma shall be authorized to enter
7 into a licensing agreement with the Oklahoma Department of Veterans
8 Affairs for any licensing fees which may be required in order to use
9 the Department's logo or design. The licensing agreement shall
10 provide for a payment to the Oklahoma Department of Veterans Affairs
11 of not more than Twenty Dollars (\$20.00) for each license plate
12 issued;

13 106. University of Oklahoma RUF/NEKS License Plate - such
14 plates shall be designed and issued to any past or present member of
15 the University of Oklahoma RUF/NEKS upon providing proof of
16 membership in the organization as may be required by Service
17 Oklahoma. The license plates shall be designed in consultation with
18 the University of Oklahoma RUF/NEKS. Service Oklahoma shall be
19 authorized to enter into a licensing agreement with the University
20 of Oklahoma RUF/NEKS for any licensing fees which may be required in
21 order to use the organization's logo or design. The licensing
22 agreement shall provide for a payment to the ~~University of Oklahoma~~
23 ~~RUF/NEKS Scholarship Fund~~ Mike James RUF/NEKS Memorial Scholarship

9 or design. The licensing agreement shall provide for a payment to
10 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
11 each license plate issued;

12 108. ~~Guthrie~~ Street Kings Car Club License Plate - such plates
13 shall be designed and issued to any person wishing to demonstrate
14 support for the ~~Guthrie~~ Street Kings Car Club in Guthrie. The
15 license plates shall be designed in consultation with the ~~Guthrie~~
16 Street Kings Car Club. Service Oklahoma shall be authorized to
17 enter into a licensing agreement with the ~~Guthrie~~ Street Kings Car
18 Club for any licensing fees which may be required in order to use
19 the organization's logo or design. The licensing agreement shall
20 provide for a payment to the ~~Guthrie~~ Street Kings ~~of~~ Car Club not
21 more than Twenty Dollars (\$20.00) for each license plate issued;

22 109. Epilepsy Foundation License Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate support for
24 the Epilepsy Foundation. The license plates shall be designed in

1 consultation with the Epilepsy Foundation of Oklahoma. Service
2 Oklahoma shall be authorized to enter into licensing agreements with
3 the Epilepsy Foundation for any licensing fees which may be required
4 in order to use the organization's logo or design. The licensing
5 agreement shall provide for a payment to the Epilepsy Foundation of
6 not more than Twenty Dollars (\$20.00) for each license plate issued;
7 and

8 110. America First License Plate - such plates shall be
9 designed and issued to any person wishing to demonstrate support for
10 the proclamation of "America First". The license plates shall be
11 designed in consultation with Warriors for Freedom and the Honoring
12 America's Warriors Foundations. Service Oklahoma shall be
13 authorized to enter into licensing agreements with the Warriors for
14 Freedom and Honoring America's Warriors Foundations for any
15 licensing fees which may be required in order to use the
16 Foundations' logos or designs. The licensing agreements shall
17 provide for a payment to the Honoring America's Warriors Foundation
18 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
19 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
20 each license plate issued.

21 C. The fee for such plates shall be Thirty-five Dollars
22 (\$35.00) per year of renewal and shall be in addition to all other
23 registration fees provided by the Oklahoma Vehicle License and
24 Registration Act. The fee shall be apportioned as follows:

1 1. Twenty Dollars (\$20.00) per year of renewal or any other
2 amount as provided in this title of the fee shall be apportioned as
3 provided or deposited in a fund as specified within the paragraph
4 authorizing the special license plate;

5 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
6 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be
7 used for the administration of the Oklahoma Vehicle License and
8 Registration Act. Beginning January 1, 2023, Eight Dollars (\$8.00)
9 per year of renewal of the fee shall be deposited in the Service
10 Oklahoma Reimbursement Fund to be used for the administration of the
11 Oklahoma Vehicle License and Registration Act; and

12 3. Any remaining amounts of the fee shall be apportioned as
13 provided in Section 1104 of this title.

14 SECTION 33. AMENDATORY 47 O.S. 2021, Section 1140, as
15 amended by Section 174, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
16 2022, Section 1140), is amended to read as follows:

17 Section 1140. A. The Service Oklahoma Operator Board shall
18 adopt rules prescribing minimum qualifications and requirements for
19 locating Service Oklahoma locations and for persons applying for a
20 license to operate a designated Service Oklahoma location. Such
21 qualifications and requirements shall include, but not be limited
22 to, the following:

- 23 1. Necessary job skills and experience;
24 2. Minimum office hours;

1 3. Provision for sufficient staffing, equipment, office space
2 and parking to provide maximum efficiency and maximum convenience to
3 the public;

4 4. Obtainment of a faithful performance surety bond as provided
5 for by law;

6 5. That the applicant has not been convicted of a felony and
7 that no felony charges are pending against the applicant;

8 6. That the location specified in the individual's application
9 for a license to operate a designated Service Oklahoma location not
10 be owned by a member of Service Oklahoma or an employee of Service
11 Oklahoma or any person related to a member of Service Oklahoma or an
12 employee of Service Oklahoma within the third degree by
13 consanguinity, marriage, or adoption and that the location not be
14 within a three-mile radius of an existing licensed operator unless
15 the applicant is assuming the location of an operating licensed
16 operator;

17 7. That a single website, designated by Service Oklahoma, will
18 be used for the distribution of services provided by Service
19 Oklahoma with motor vehicle services to be fulfilled by licensed
20 operators;

21 8. That licensed operators will attend all required training
22 provided by Service Oklahoma; and

23 9. That there should be at least one Service Oklahoma location
24 in each county.

1 B. 1. Any person making application to the Service Oklahoma
2 Operator Board for the purpose of obtaining a license to operate a
3 designated Service Oklahoma location shall pay, when submitting the
4 application, a nonrefundable application fee of One Hundred Dollars
5 (\$100.00). All such application fees shall be deposited in the
6 Oklahoma Tax Commission Revolving Fund. Beginning January 1, 2023,
7 all such application fees shall be deposited in the Service Oklahoma
8 Revolving Fund.

9 2. Any person making application to the Service Oklahoma
10 Operator Board for the purpose of obtaining a license to operate a
11 designated Service Oklahoma location must meet standardization and
12 branding requirements established by the Service Oklahoma Operator
13 Board, upon recommendations from Service Oklahoma. Upon approval,
14 the person must either pay a fee to Service Oklahoma for all costs
15 related to meeting the standardization and branding requirements or
16 obtain approval from the Service Oklahoma Operator Board that the
17 location meets all standardization and branding requirements. All
18 such fees shall be deposited in the Service Oklahoma Revolving Fund.
19 The amount of the license fee will be determined by the Service
20 Oklahoma Operator Board. This provision shall not apply to any
21 existing Service Oklahoma location.

22 3. Any person shall have been a resident of the State of
23 Oklahoma for a period of six (6) months prior to submitting an
24 application for a license to operate a designated Service Oklahoma

1 location. If a licensed operator moves his or her residence to a
2 place outside the State of Oklahoma, the licensed operator shall
3 provide notice to the Service Oklahoma Operator Board and sell his
4 or her license within ninety (90) days of such notice.

5 C. Upon application by a person to serve as a licensed
6 operator, the Service Oklahoma Operator Board is authorized to make
7 a determination whether such person and such location meets the
8 criteria and guidelines established by the Service Oklahoma Operator
9 Board and, if such be the case, may issue a license to operate a
10 designated Service Oklahoma location.

11 D. 1. A licensed operator may be permitted, upon application,
12 to sell or transfer an existing license to operate a designated
13 Service Oklahoma location. Any sale or transfer of a license is
14 subject to approval of the Service Oklahoma Operator Board. In
15 order to sell or transfer an existing licensed operator license, the
16 licensed operator shall meet the following guidelines and
17 requirements:

18 a. the licensed operator shall be in good standing with
19 the Service Oklahoma Operator Board,

20 b. the licensed operator shall have held a licensed
21 operator license, issued by the Service Oklahoma
22 Operator Board, for a minimum of five (5) years, and

23 c. the licensed operator shall provide the Service
24 Oklahoma Operator Board evidence that the proposed

1 buyer or transferee of the licensed operator licensee
2 meets the qualifications and requirements set forth in
3 subsection A of this section, has the ability to meet
4 all financial requirements and terms of any current
5 existing contract between the licensed operator and
6 Service Oklahoma, and agrees to the onboarding and
7 training requirements of Service Oklahoma, as
8 established by Service Oklahoma and the Service
9 Oklahoma Operator Board.

10 2. The purchase price of a licensed operator license shall be
11 agreed upon by the licensed operator and the individual purchasing
12 the license to operate a designated Service Oklahoma location.
13 However, the purchaser or transferee agrees to pay a transfer fee to
14 Service Oklahoma in the amount of three percent (3%) of the last
15 annual gross revenue from fees retained at the Service Oklahoma
16 location to be purchased, not to exceed Fifteen Thousand Dollars
17 (\$15,000.00). The transfer fee shall be deposited in the Service
18 Oklahoma Revolving Fund.

19 3. Upon receipt of the application to sell or transfer an
20 existing licensed operator license, the Service Oklahoma Operator
21 Board will determine whether the licensed operator license may be
22 sold or transferred on the condition that the existing location is
23 in good standing and the new licensee meets the requirements
24 outlined in Section 1140 et seq. of this title.

1 4. The Service Oklahoma Operator Board may, at its discretion,
2 buy back a licensed operator license from a licensed operator who
3 desires to sell or transfer its licensed operator license but has
4 held a licensed operator license issued by Service Oklahoma for less
5 than five (5) years. The purchase price for such a license will be
6 one-half (1/2) times the most recent annual gross revenue from fees
7 retained of that Service Oklahoma location, not to exceed Two
8 Hundred Thousand Dollars (\$200,000.00).

9 5. Licensed operators issued a license to operate a designated
10 Service Oklahoma location on January 1, 2023, may be permitted, upon
11 application, to sell or transfer their existing license within the
12 first five (5) years. Any sale or transfer of such license is
13 subject to the approval of the Service Oklahoma Operator Board.

14 a. In order to sell or transfer the existing license
15 within the first five (5) years, the licensed operator
16 shall meet the following guidelines and requirements:

- 17 1. the licensed operator shall be in good standing
18 with the Service Oklahoma Operator Board, and
19 2. the licensed operator shall provide the Service
20 Oklahoma Operator Board evidence that the
21 proposed buyer or transferee of the licensed
22 operator licensee meets the qualifications and
23 requirements set forth in this section, has the
24 ability to meet all financial requirements and

1 terms of any current existing contract between
2 the licensed operator and Service Oklahoma, and
3 agrees to the onboarding and training
4 requirements of Service Oklahoma, as established
5 by Service Oklahoma and the Service Oklahoma
6 Operator Board.

7 b. The branding and physical standardization exemption
8 specified in this section shall not transfer to the
9 purchaser, unless:

10 (1) the licensed operator submitted a contingent
11 resignation and the purchaser submitted a
12 relation application to the Oklahoma Tax
13 Commission prior to May 19, 2022, or

14 2. the purchaser is related to the licensed operator
15 within the third degree by consanguinity,
16 marriage, or adoption.

17 E. 1. Licensed operators shall be subject to all laws relating
18 to licensed operators and shall be subject to removal for cause by
19 the Service Oklahoma Operator Board. Any action taken by Service
20 Oklahoma to revoke a license shall be pursuant to and in accordance
21 with the provisions of the Administrative Procedures Act. For the
22 purposes of this section, "for cause" shall be defined as follows:

23 a. repeated violations of written contracts, rules,
24 regulations and statutes pertaining to licensed

- 1 operators after written warning by the Service
2 Oklahoma Operator Board and an opportunity to correct
3 such violations,
- 4 b. failure of the licensed operator to promptly remit
 - 5 funds owed to Service Oklahoma upon written demand,
 - 6 c. being charged with a felony crime involving dishonesty
 - 7 or moral turpitude,
 - 8 d. failure to timely file state and federal income tax
 - 9 returns, or
 - 10 e. any act of official misconduct as set forth in Section
 - 11 93 of Title 51 of the Oklahoma Statutes.

12 In the event a license is revoked by the Service Oklahoma
13 Operator Board for cause, the Service Oklahoma location operated by
14 the licensed operator will be permanently closed and the licensed
15 operator shall not be entitled to any compensation.

16 Motor license agents and licensed operators in good standing as
17 of November 1, 2022, shall be exempt from the branding and physical
18 standardization requirements to be established by the Service
19 Oklahoma Operator Board, with the recommendation of the Director of
20 Service Oklahoma.

21 2. A license to operate a designated Service Oklahoma location
22 may be revoked by the Service Oklahoma Operator Board for failure to
23 meet the standards for customer satisfaction established by the
24 Service Oklahoma Operator Board. In the event of revocation, the

1 licensed operator shall sell his or her license to operate a Service
2 Oklahoma location to Service Oklahoma at a rate of one-half (1/2)
3 times the most recent annual gross revenue from fees retained of
4 that Service Oklahoma location, not to exceed Two Hundred Thousand
5 Dollars (\$200,000.00).

6 F. All licensed operators shall be licensed by and under the
7 supervision of Service Oklahoma; provided, any agent authorized to
8 issue registrations pursuant to the International Registration Plan
9 shall also be under the supervision of the Corporation Commission,
10 subject to rules promulgated by the Corporation Commission pursuant
11 to the provisions of subsection E of Section 1166 of this title.
12 Service Oklahoma shall be the holder of all licenses and has the
13 right to approve and revoke such licenses. After obtaining a
14 license, any such licensed operator shall furnish and file with
15 Service Oklahoma a bond in such amount as may be fixed by Service
16 Oklahoma. Such licensed operator shall be removable at the will of
17 Service Oklahoma. Such licensed operator shall perform all duties
18 and do such things in the administration of the laws of this state
19 as shall be enjoined upon and required by the Service Oklahoma
20 Operator Board. Provided, Service Oklahoma may operate a Service
21 Oklahoma location in any county where a vacancy occurs, as
22 determined by Service Oklahoma.

23 G. In the event of a vacancy due to the death of a licensed
24 operator, the licensed operator's designee or a licensed operator

1 location employee shall immediately notify Service Oklahoma. A
2 licensed operator may designate an individual to continue to operate
3 the Service Oklahoma location upon the death of the licensed
4 operator. The designee shall apply to obtain a license to operate
5 the vacant licensed operator location with the Service Oklahoma
6 Operator Board within thirty (30) days of the licensed operator's
7 death. In the event that no designee is designated or that the
8 designee fails to apply to be a licensed operator with Service
9 Oklahoma within thirty (30) days, Service Oklahoma may take any and
10 all action it deems appropriate in order to provide for the orderly
11 transition and the maintenance of operations of the Service Oklahoma
12 location, as permitted by law.

13 H. When an application for registration is made with Service
14 Oklahoma, the Corporation Commission or a licensed operator, a
15 registration fee of One Dollar and seventy-five cents (\$1.75) shall
16 be collected for each license plate or decal issued. Such fees
17 shall be in addition to the registration fees on motor vehicles and
18 when an application for registration is made to the licensed
19 operator, such licensed operator shall retain a fee as provided in
20 Section 1141.1 of this title. When the fee is paid by a person
21 making application directly with Service Oklahoma or the Corporation
22 Commission, as applicable, the registration fees shall be in the
23 same amount as provided for licensed operators and the fee provided
24 by Section 1141.1 of this title shall be deposited in the Oklahoma

1 Tax Commission Revolving Fund or as provided in Section 1167 of this
2 title, as applicable. Beginning January 1, 2023, the fee provided
3 by Section 1141.1 of this title shall be deposited in the Service
4 Oklahoma Revolving Fund or as provided in Section 1167 of this
5 title, as applicable. Service Oklahoma shall prepare schedules of
6 registration fees and charges for titles which shall include the
7 fees for such licensed operators and all fees and charges paid by a
8 person shall be listed separately on the application and
9 registration and totaled on the application and registration. The
10 licensed operators shall charge only such fees as are specifically
11 provided for by law, and all such authorized fees shall be posted in
12 such a manner that any person shall have notice of all fees that are
13 imposed by law.

14 I. Any licensed operator shall be responsible for all costs
15 incurred by Service Oklahoma when relocating an existing Service
16 Oklahoma location. The Service Oklahoma Operator Board may waive
17 payment of such costs in case of unforeseen business or emergency
18 conditions beyond the control of the licensed operator.

19 J. Any existing contracts by or between any motor license agent
20 and the Oklahoma Tax Commission shall be assigned to Service
21 Oklahoma. All existing motor license agents in good standing with
22 the Oklahoma Tax Commission will be offered a subsequent contract
23 from Service Oklahoma to become a licensed operator to take effect
24 on January 1, 2023. The contract between existing motor license

1 agents and Service Oklahoma shall be agreed to no later than
2 December 31, 2022. In the event an existing motor license agent
3 declines to enter into the subsequent contract with Service Oklahoma
4 to become a licensed operator, that motor license agent may continue
5 to conduct business pursuant to the existing contract through
6 December 31, 2025, so long as that motor license agent remains in
7 good standing with Service Oklahoma in accordance with the terms of
8 the existing contract.

9 SECTION 34. AMENDATORY 63 O.S. 2021, Section 1-229.13,
10 is amended to read as follows:

11 Section 1-229.13. A. It is unlawful for any person to sell,
12 give or furnish in any manner any tobacco product, nicotine product
13 or vapor product to another person who is under twenty-one (21)
14 years of age, or to purchase in any manner a tobacco product,
15 nicotine product or vapor product on behalf of any such person. It
16 shall not be unlawful for an employee under twenty-one (21) years of
17 age to handle tobacco products, nicotine products or vapor products
18 when required in the performance of the employee's duties.

19 B. A person engaged in the sale or distribution of tobacco
20 products, nicotine products or vapor products shall demand proof of
21 age from a prospective purchaser or recipient if an ordinary person
22 would conclude on the basis of appearance that the prospective
23 purchaser may be under twenty-one (21) years of age.

24

1 If an individual engaged in the sale or distribution of tobacco
2 products, nicotine products or vapor products has demanded proof of
3 age from a prospective purchaser or recipient who is not under
4 twenty-one (21) years of age, the failure to subsequently require
5 proof of age shall not constitute a violation of this subsection.

6 C. 1. When a person violates subsection A or B of this
7 section, the Alcoholic Beverage Laws Enforcement (ABLE) Commission
8 shall impose an administrative fine of:

9 a. not more than One Hundred Dollars (\$100.00) for the
10 first offense,

11 b. not more than Two Hundred Dollars (\$200.00) for the
12 second offense within a two-year period following the
13 first offense,

14 c. not more than Three Hundred Dollars (\$300.00) for a
15 third offense within a two-year period following the
16 first offense. In addition to any other penalty, the
17 store's license to sell tobacco products or nicotine
18 products or the store's sales tax permit for a store
19 that is predominantly engaged in the sale of vapor
20 products in which the sale of other products is merely
21 incidental may be suspended for a period not exceeding
22 thirty (30) days, or

23 d. not more than Three Hundred Dollars (\$300.00) for a
24 fourth or subsequent offense within a two-year period

1 following the first offense. In addition to any other
2 penalty, the store's license to sell tobacco products
3 or nicotine products or the store's sales tax permit
4 for a store that is predominantly engaged in the sale
5 of vapor products in which the sale of other products
6 is merely incidental may be suspended for a period not
7 exceeding sixty (60) days.

8 2. When it has been determined that a penalty shall include a
9 license or permit suspension, the ABLE Commission shall notify the
10 Oklahoma Tax Commission, and the Tax Commission shall suspend the
11 store's license to sell tobacco products or nicotine products or the
12 store's sales tax permit for a store that is predominantly engaged
13 in the sale of vapor products in which the sale of other products is
14 merely incidental at the location where the offense occurred for the
15 period of time prescribed by the ABLE Commission.

16 3. Proof that the defendant demanded, was shown, and reasonably
17 relied upon proof of age shall be a defense to any action brought
18 pursuant to this section. A person cited for violating this section
19 shall be deemed to have reasonably relied upon proof of age, and
20 such person shall not be found guilty of the violation if such
21 person proves that:

22 a. the individual who purchased or received the tobacco
23 product, nicotine product or vapor product presented a
24 driver license or other government-issued photo

1 identification purporting to establish that such
2 individual was twenty-one (21) years of age or older,
3 or

4 b. the person cited for the violation confirmed the
5 validity of the driver license or other government-
6 issued photo identification presented by such
7 individual by performing a transaction scan by means
8 of a transaction scan device.

9 Provided, that this defense shall not relieve from liability any
10 person cited for a violation of this section if the person failed to
11 exercise reasonable diligence to determine whether the physical
12 description and picture appearing on the driver license or other
13 government-issued photo identification was that of the individual
14 who presented it. The availability of the defense described in this
15 subsection does not affect the availability of any other defense
16 under any other provision of law.

17 D. If the sale is made by an employee of the owner of a store
18 at which tobacco products, nicotine products or vapor products are
19 sold at retail, the employee shall be guilty of the violation and
20 shall be subject to the fine. Each violation by any employee of an
21 owner of a store licensed to sell tobacco products or nicotine
22 products or permitted to sell vapor products shall be deemed a
23 violation against the owner for purposes of a license suspension
24 pursuant to subsection C of this section. Each violation by an

1 employee of a store predominantly engaged in the sale of vapor
2 products in which the sale of other products is merely incidental
3 shall be deemed a violation against the owner for purposes of a
4 sales tax permit suspension pursuant to the provisions of subsection
5 C of this section. An owner of a store licensed to sell tobacco
6 products or nicotine products or permitted to sell vapor products
7 shall not be deemed in violation of the provisions of the Prevention
8 of Youth Access to Tobacco Act for any acts constituting a violation
9 by any person, when the violation occurs prior to actual employment
10 of the person by the storeowner or the violation occurs at a
11 location other than the owner's retail store. For purposes of
12 determining the liability of a person controlling franchises or
13 business operations in multiple locations, for any violations of
14 subsection A or B of this section, each individual franchise or
15 business location shall be deemed a separate entity.

16 E. On or before December 15, 1997, the ABLE Commission shall
17 adopt rules establishing a method of notification of storeowners
18 when an employee of such storeowner has been determined to be in
19 violation of this section by the ABLE Commission or convicted of a
20 violation by a municipality.

21 F. 1. Upon failure of the employee to pay the administrative
22 fine within ninety (90) days of the day of the assessment of such
23 fine, the ABLE Commission shall notify ~~the Department of Public~~
24 ~~Safety~~ Service Oklahoma, and ~~the Department~~ Service Oklahoma shall

1 suspend or not issue a driver license to the employee until proof of
2 payment has been furnished to ~~the Department of Public Safety~~
3 Service Oklahoma.

4 2. Upon failure of a storeowner to pay the administrative fine
5 within ninety (90) days of the assessment of the fine, the ABLE
6 Commission shall notify the Tax Commission, and the Tax Commission
7 shall suspend the store's license to sell tobacco products or
8 nicotine products or the store's sales tax permit for a store that
9 is predominantly engaged in the sale of vapor products in which the
10 sale of other products is merely incidental until proof of payment
11 has been furnished to the Oklahoma Tax Commission.

12 G. Cities and towns may enact and municipal police officers may
13 enforce ordinances prohibiting and penalizing conduct under
14 provisions of this section, but the provisions of municipal
15 ordinances shall be the same as provided for in this section, and
16 the penalty provisions under such ordinances shall not be more
17 stringent than those of this section.

18 H. County sheriffs may enforce the provisions of the Prevention
19 of Youth Access to Tobacco Act.

20 SECTION 35. AMENDATORY 68 O.S. 2021, Section 118, is
21 amended to read as follows:

22 Section 118. A. Upon receipt of a written request from a
23 member or employee of the Legislature, the Oklahoma Tax Commission
24 shall provide:

1 1. A written estimate of the revenue gain or loss to the state
2 as a result of an actual or proposed change to ~~a~~ any state tax law
3 within the implementation, enforcement and collection duties and
4 responsibilities of the Tax Commission; provided, upon request of a
5 legislative member or staff, Service Oklahoma shall be responsible
6 for furnishing written estimates of revenue gains or losses
7 attributable to current or proposed amendments to any state law
8 under its statutorily assigned functions and responsibilities;

9 2. A written statement of the Tax Commission's recommendation
10 to the State Board of Equalization as to the change in the amount
11 certified as available for appropriation by the Legislature as a
12 result of an actual or proposed change to a state tax law; and

13 3. A written statement outlining all analysis and methodology
14 provided by or made available by the Tax Commission to the State
15 Board of Equalization for the purpose of influencing or serving as
16 the basis for an official action of the State Board of Equalization.

17 The Tax Commission shall provide such estimate and statement
18 within two (2) weeks of the date the request was received unless the
19 member or employee of the Legislature specifies an earlier date.

20 B. On or after December 31, 2009, and subject to the
21 availability of funds, the Tax Commission shall develop the
22 estimates and statements required by subsection A of this section
23 utilizing a dynamic revenue estimating model. Such model shall take
24 into consideration changes in economic activity as a result of the

1 proposed legislation and consequent revenue gains or losses due to
2 factors such as taxpayer behavior, employment and business
3 investment. The Tax Commission may, subject to the laws of this
4 state relating to confidentiality of information, contract with
5 institutions of higher education in this state or other entities to
6 perform its duties as set forth in this subsection. The Tax
7 Commission is authorized to promulgate rules to carry out the
8 implementation of this section.

9 C. For the purpose of providing an annual forecast of gross
10 production tax revenues from the production of natural and
11 casinghead gas to the Office of Management and Enterprise Services,
12 the Tax Commission shall subscribe to appropriate reference
13 materials which provide economic outlook of future gas prices that
14 have most closely followed the historical trend of Oklahoma gas
15 prices. To determine the average differential between the published
16 forecasted prices and Oklahoma gas prices, the Tax Commission shall
17 compare prices in at least twenty-four (24) of the immediate thirty-
18 six (36) previous months of production. The Tax Commission shall
19 utilize the procedures provided herein to forecast the collection of
20 gross production tax revenues from the production of natural and
21 casinghead gas for the fiscal year beginning July 1, 2005, and each
22 fiscal year thereafter.

23 SECTION 36. AMENDATORY 70 O.S. 2021, Section 19-115, is
24 amended to read as follows:

1 Section 19-115. A. The establishment, conduct and scope of the
2 driver education program for secondary schools shall be the program
3 established by rules adopted and promulgated by the State Board of
4 Education, subject to the requirements and exceptions set forth in
5 Section 19-113 et seq. of this title. Said program shall be
6 established and maintained only in accordance with such rules and
7 laws. The State Superintendent of Public Instruction shall prepare
8 an administrative budget from funds made available under this
9 article, which budget shall be approved by the State Board of
10 Education. It shall be the responsibility of the State
11 Superintendent of Public Instruction to appoint supervisors of
12 safety education and the necessary clerical personnel.

13 B. The State Department of Education shall designate or employ
14 a state coordinator of driver education programs to provide
15 oversight of all driver education programs throughout the state.
16 The responsibilities of such coordinator shall include, but not be
17 limited to:

- 18 1. Assuring quality driver education programs in this state;
- 19 2. Serving as a liaison between the State Department of
20 Education and ~~the Department of Public Safety~~ Service Oklahoma;
- 21 3. Promoting driver safety throughout the state; and
- 22 4. Coordinating the activities of the supervisors of safety
23 education and the necessary clerical staff.

24

1 SECTION 37. AMENDATORY 75 O.S. 2021, Section 250.4, is
2 amended to read as follows:

3 Section 250.4. A. 1. Except as is otherwise specifically
4 provided in this subsection, each agency is required to comply with
5 Article I of the Administrative Procedures Act.

6 2. The Corporation Commission shall be required to comply with
7 the provisions of Article I of the Administrative Procedures Act
8 except for subsections A, B, C and E of Section 303 of this title
9 and Section 306 of this title. To the extent of any conflict or
10 inconsistency with Article I of the Administrative Procedures Act,
11 pursuant to Section 35 of Article IX of the Oklahoma Constitution,
12 it is expressly declared that Article I of the Administrative
13 Procedures Act is an amendment to and alteration of Sections 18
14 through 34 of Article IX of the Oklahoma Constitution.

15 3. The Oklahoma Military Department shall be exempt from the
16 provisions of Article I of the Administrative Procedures Act to the
17 extent it exercises its responsibility for military affairs.
18 Military publications, as defined in Section 801 of Title 44 of the
19 Oklahoma Statutes, shall be exempt from the provisions of Article I
20 and Article II of the Administrative Procedures Act, except as
21 provided in Section 251 of this title.

22 4. The Oklahoma Ordnance Works Authority, the Northeast
23 Oklahoma Public Facilities Authority, the Oklahoma Office of
24 Homeland Security and the Board of Trustees of the Oklahoma College

1 Savings Plan shall be exempt from Article I of the Administrative
2 Procedures Act.

3 5. The Transportation Commission and the Department of
4 Transportation shall be exempt from Article I of the Administrative
5 Procedures Act to the extent they exercise their authority in
6 adopting standard specifications, special provisions, plans, design
7 standards, testing procedures, federally imposed requirements and
8 generally recognized standards, project planning and programming,
9 and the operation and control of the State Highway System.

10 6. The Oklahoma State Regents for Higher Education shall be
11 exempt from Article I of the Administrative Procedures Act with
12 respect to:

- 13 a. prescribing standards of higher education,
- 14 b. prescribing functions and courses of study in each
15 institution to conform to the standards,
- 16 c. granting of degrees and other forms of academic
17 recognition for completion of the prescribed courses,
- 18 d. allocation of state-appropriated funds, and
- 19 e. fees within the limits prescribed by the Legislature.

20 7. Institutional governing boards within The Oklahoma State
21 System of Higher Education shall be exempt from Article I of the
22 Administrative Procedures Act.

23 8. a. The Commissioner of Public Safety and the Director of
24 Service Oklahoma shall be exempt from Sections 303.1,

1 304, 307.1, 308 and 308.1 of this title insofar as it
2 is necessary to promulgate rules pursuant to the
3 Oklahoma Motor Carrier Safety and Hazardous Materials
4 Transportation Act, to maintain a current
5 incorporation of federal motor carrier safety and
6 hazardous material regulations, ~~or pursuant to Chapter~~
7 ~~6 of Title 47 of the Oklahoma Statutes, to maintain a~~
8 ~~current incorporation of federal commercial driver~~
9 ~~license regulations, for which the Commissioner has no~~
10 ~~discretion when the state is mandated to promulgate~~
11 ~~rules identical to federal rules and regulations.~~

12 b. Such rules may be adopted by the Commissioner and
13 shall be deemed promulgated twenty (20) days after
14 notice of adoption is published in "The Oklahoma
15 Register". Such publication need not set forth the
16 full text of the rule but may incorporate the federal
17 rules and regulations by reference.

18 c. Such copies of promulgated rules shall be filed with
19 the Secretary as required by Section 251 of this
20 title.

21 d. For any rules for which the Commissioner has
22 discretion to allow variances, tolerances or
23 modifications from the federal rules and regulations,
24

1 the Commissioner shall fully comply with Article I of
2 the Administrative Procedures Act.

3 9. The Council on Judicial Complaints shall be exempt from
4 Section 306 of Article I of the Administrative Procedures Act, with
5 respect to review of the validity or applicability of a rule by an
6 action for declaratory judgment, or any other relief based upon the
7 validity or applicability of a rule, in the district court or by an
8 appellate court. A party aggrieved by the validity or applicability
9 of a rule made by the Council on Judicial Complaints may petition
10 the Court on the Judiciary to review the rules and issue opinions
11 based upon them.

12 10. The Department of Corrections, State Board of Corrections,
13 county sheriffs and managers of city jails shall be exempt from
14 Article I of the Administrative Procedures Act with respect to:

- 15 a. prescribing internal management procedures for the
16 management of the state prisons, county jails and city
17 jails and for the management, supervision and control
18 of all incarcerated prisoners, and
- 19 b. prescribing internal management procedures for the
20 management of the probation and parole unit of the
21 Department of Corrections and for the supervision of
22 probationers and parolees.

23 11. The State Board of Education shall be exempt from Article I
24 of the Administrative Procedures Act with respect to prescribing

1 subject matter standards as provided for in Section 11-103.6a of
2 Title 70 of the Oklahoma Statutes.

3 B. As specified, the following agencies or classes of agency
4 activities are not required to comply with the provisions of Article
5 II of the Administrative Procedures Act:

6 1. The Oklahoma Tax Commission, except as provided in
7 subsection G of Section 1140 of Title 47 of the Oklahoma Statutes;

8 2. The Commission for Human Services;

9 3. The Oklahoma Ordnance Works Authority;

10 4. The Corporation Commission;

11 5. The Pardon and Parole Board;

12 6. The Midwestern Oklahoma Development Authority;

13 7. The Grand River Dam Authority;

14 8. The Northeast Oklahoma Public Facilities Authority;

15 9. The Council on Judicial Complaints;

16 10. The Board of Trustees of the Oklahoma College Savings Plan;

17 11. The supervisory or administrative agency of any penal,
18 mental, medical or eleemosynary institution, only with respect to
19 the institutional supervision, custody, control, care or treatment
20 of inmates, prisoners or patients therein; provided, that the
21 provisions of Article II shall apply to and govern all

22 administrative actions of the Oklahoma Alcohol Prevention, Training,
23 Treatment and Rehabilitation Authority;

1 12. The Board of Regents or employees of any university,
2 college, or other institution of higher learning;

3 13. The Oklahoma Horse Racing Commission, its employees or
4 agents only with respect to hearing and notice requirements on the
5 following classes of violations which are an imminent peril to the
6 public health, safety and welfare:

- 7 a. any rule regarding the running of a race,
- 8 b. any violation of medication laws and rules,
- 9 c. any suspension or revocation of an occupation license
10 by any racing jurisdiction recognized by the
11 Commission,
- 12 d. any assault or other destructive acts within
13 Commission-licensed premises,
- 14 e. any violation of prohibited devices, laws and rules,
15 or
- 16 f. any filing of false information;

17 14. The Commissioner of Public Safety and the Director of
18 Service Oklahoma only with respect to driver license hearings and
19 hearings conducted pursuant to the provisions of Section 2-115 of
20 Title 47 of the Oklahoma Statutes;

21 15. The Administrator of the Department of Securities only with
22 respect to hearings conducted pursuant to provisions of the Oklahoma
23 Take-over Disclosure Act of 1985;

1 16. Hearings conducted by a public agency pursuant to Section
2 962 of Title 47 of the Oklahoma Statutes;

3 17. The Oklahoma Military Department;

4 18. The University Hospitals Authority, including all hospitals
5 or other institutions operated by the University Hospitals
6 Authority;

7 19. The Oklahoma Health Care Authority Board and the
8 Administrator of the Oklahoma Health Care Authority; and

9 20. The Oklahoma Office of Homeland Security.

10 SECTION 38. REPEALER 47 O.S. 2021, Section 2-106, as
11 amended by Section 28, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2022,
12 Section 2-106), is hereby repealed.

13 SECTION 39. REPEALER 47 O.S. 2021, Section 1114.2, as
14 amended by Section 131, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
15 2022, Section 1114.2), is hereby repealed.

16 SECTION 40. This act shall become effective July 1, 2023.

17 SECTION 41. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
