14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 21 O.S. 2021, Section 1705, as
16	amended by Section 12, Chapter 116, O.S.L. 2018, is amended to read
17	as follows:
18	Section 1705. A. Grand larceny is a felony punishable as
19	follows:
20	1. If the value of the property is less than One Thousand
21	Dollars (\$1,000.00), the person shall be punished by imprisonment in
22	the county jail for a term not to exceed one (1) year or by
23	incarceration in the county jail for one or more nights or weekends
24	pursuant to Section 991a-2 of Title 22 of the Oklahoma Statutes, at

- the option of the court, or by a fine not to exceed One Thousand Dollars (\$1,000.00), or by both such imprisonment and fine;
- 2. If the property is one or more firearms, the property is taken from the person of another, or the value of the property is One Thousand Dollars (\$1,000.00) or more but less than Two Thousand Five Hundred Dollars (\$2,500.00), the person shall be punished by imprisonment in the custody of the Department of Corrections for a term not to exceed two (2) five (5) years or in the county jail for a term not to exceed one (1) year, or by a fine not to exceed One Thousand Dollars (\$1,000.00) Two Thousand Five Hundred Dollars (\$2,500.00), or by both such imprisonment and fine;
- 3. In the event the value of the property is Two Thousand Five Hundred Dollars (\$2,500.00) or more but less than Fifteen Thousand Dollars (\$15,000.00), the person shall be punished by imprisonment in the custody of the Department of Corrections for a term not to exceed five (5) years or in the county jail for a term not to exceed one (1) year, or by a fine not to exceed One Thousand Dollars (\$1,000.00), or by both such imprisonment and fine; or
- 4. If the value of the property is Fifteen Thousand Dollars (\$15,000.00) or more, the person shall be punished by imprisonment in the custody of the Department of Corrections for a term not to exceed eight (8) years, or by a fine not to exceed One Thousand Dollars (\$1,000.00), or by both such imprisonment and fine.

1	B. The person shall also be ordered to pay restitution to the
2	victim as provided in Section 991f of Title 22 of the Oklahoma
3	Statutes.
4	SECTION 2. This act shall become effective November 1, 2023.
