10 A Joint Resolution approving certain proposed
11 permanent rules of Oklahoma state agencies;
12 disapproving certain proposed permanent rules; and
13 directing distribution.

14 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
15 Statutes, the Legislature shall have a joint resolution prepared for
16 consideration each session.

17 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF
18 REPRESENTATIVES OF THE 1ST SESSION OF THE 59TH OKLAHOMA LEGISLATURE:

19 SECTION 1. All proposed permanent rules of Oklahoma state
20 agencies filed on or before April 1, 2023, are hereby approved
21 except for OAC 317:30-3-35, submitted by the Oklahoma Health Care
22 Authority, and OAC 210:10-2-1, 210:10-2-2, 210:10-2-3, 210:10-2-4,
23 210:35-3-121, 210:35-3-121.1, 210:35-3-126, and 210:35-3-128,
24 submitted by the State Department of Education. The following

1 proposed permanent rules of state agencies filed on or before April
2 1, 2023, are hereby disapproved:

3 1. State Board of Medical Licensure and Supervision, OAC
4 435:15-1-1.1, 435:15-3-1, 435:15-3-13, 435:15-3-17, 435:15-3-19,
5 435:15-5-10, 435:15-11-1, and 435:15-11-2;

6 2. Oklahoma Used Motor Vehicle, Dismantler, and Manufactured
7 Housing Commission, OAC 765:10-3-5;

8 3. Department of Public Safety, OAC 595:25-1-2, disapproving
9 adding definition of ""Payment" means compensation for services
10 rendered by a wrecker or towing company in the form of cash, credit
11 card, debit card, Automated Clearinghouse Transfer (ACH), business
12 checks, cashier's check, or money order." and OAC 595:25-5-7(b) and
13 (c), disapproving proposed changes, except for the P.O. Box number;

14 4. Department of Wildlife Conservation, OAC 800:25-24-3
15 paragraph (2) of subsection (c);

16 5. State Board of Cosmetology and Barbering, OAC 175:10-3-47,
17 and OAC 175:10-9-55, disapproving the language "Only a licensed
18 Cosmetology Instructor or licensed Facial/Esthetics Instructor may
19 teach Eyelash Extension Specialist courses or classes.", as included
20 in subparagraph (b); and

21 6. State Department of Health, OAC 310:355-1-1, 310:642-1-1,
22 310:642-1-2, 310:642-1-3, 310:642-3-1, 310:642-3-2, 310:642-5-1
23 except for subparagraphs (H) and (I) of paragraph (2), 310:642-7-1,
24 310:642-7-2, 310:642-9-1, 310:643-1-1, 310:643-1-2, 310:643-3-1,

1 310:643-3-2, 310:643-5-1, 310:643-5-2, 310:643-5-3, 310:643-7-1, and
2 310:643-7-2.

3 SECTION 2. The Secretary of State is hereby directed to
4 distribute copies of this resolution to the Governor and the editor
5 of "The Oklahoma Register".
