BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 28 O.S. 2021, Section 152.1, is  
amended to read as follows:

Section 152.1 A. In civil cases, the court clerk shall collect  
and deposit in the court fund the following charges in addition to  
the flat fee:

1. For posting notices and filing

certificates required by statute.....\$30.00

2. For the filing of any counterclaim or

setoff pursuant to Section 1758 of

Title 12 of the Oklahoma Statutes.....\$20.00

- 1 3. For mailing by any type of mail writs,  
2 warrants, orders, process, command, or  
3 notice for each person.....\$10.00
- 4 4. For the actual cost of all postage in  
5 each case in excess of .....\$10.00
- 6 5. For serving or endeavoring to serve each  
7 writ, warrant, order, process,  
8 command, or notice for each person in  
9 one or more counties..... ~~\$50.00~~ up to \$150.00  
10 provided that if more than one person is  
11 served at the same address, one flat fee  
12 of ~~Fifty Dollars (\$50.00)~~ up to One  
13 Hundred Fifty Dollars (\$150.00) may be  
14 charged
- 15 6. For sheriff's fees on court-ordered  
16 sales of real or personal property, a  
17 fee to be paid by the purchaser of the  
18 property in an amount equal to three  
19 percent (3%) of the sales price paid  
20 by the purchaser for the property;  
21 provided, however, such fee shall not  
22 exceed Five Hundred Dollars (\$500.00).....~~\$75.00~~
- 23 7. When a jury is requested.....\$349.00
- 24 8. For issuing each summons for each person.....\$10.00

1       9. For services of a court reporter at each  
2             trial held in the case.....\$20.00

3       10. For filing a motion for summary  
4             judgment or summary disposition of  
5             issue(s).....\$50.00

6       The fees prescribed in paragraphs 5 and 6 of this subsection  
7 shall be paid by the court clerk into the Sheriff's Service Fee  
8 Account, created pursuant to the provisions of Section 514.1 of  
9 Title 19 of the Oklahoma Statutes, of the sheriff in the county  
10 where service is made or attempted or where the sheriff's sale  
11 occurs. All other fees shall be deposited into the local court fund  
12 in the county where collected.

13       B. The fee prescribed in paragraph 7 of subsection A of this  
14 section shall be paid at the time of the pretrial conference by the  
15 party requesting a jury.

16       SECTION 2. This act shall become effective July 1, 2023.

17       SECTION 3. It being immediately necessary for the preservation  
18 of the public peace, health or safety, an emergency is hereby  
19 declared to exist, by reason whereof this act shall take effect and  
20 be in full force from and after its passage and approval.
