13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. NEW LAW A new section of law to be codified
15	in the Oklahoma Statutes as Section 1086.7 of Title 82, unless there
16	is created a duplication in numbering, reads as follows:
17	A. The Oklahoma Flood and Drought Management Task Force is
18	hereby established and shall be comprised of two groups, the
19	management group and the advisory group.
20	B. 1. The management group shall be comprised of designees
21	from the following state agencies:
22	a. the Oklahoma Water Resources Board, which shall serve
23	as the lead agency,
24	

1	b. the Oklahoma Department of Emergency Management and
2	Homeland Security,
3	c. the Oklahoma Department of Agriculture, Food, and
4	Forestry,
5	d. the State Department of Health,
6	e. the Department of Environmental Quality,
7	f. the Oklahoma Conservation Commission,
8	g. the Department of Wildlife Conservation,
9	h. the Oklahoma Climatological Survey, and
10	i. the Oklahoma Military Department.
11	2. The advisory group shall be comprised of designees of the
12	following state associations and entities:
13	a. Association of County Commissioners of Oklahoma,
14	b. Oklahoma Rural Water Association, and
15	c. Oklahoma Municipal League.
16	The advisory group shall also include the resources of all
17	remaining state agencies and departments available to provide advice
18	and assistance to the Oklahoma Flood and Drought Management Task
19	Force, including the Oklahoma State Regents for Higher Education.
20	C. The Oklahoma Water Resources Board shall formally coordinate
21	with the following federal agencies:
22	1. Federal Emergency Management Agency (FEMA);
23	2. U.S. Army Corps of Engineers;

3. U.S. Forest Service;

- 1 4. The United States Geological Survey;
- 2 5. Bureau of Reclamation;
  - 6. Farm Service Agency;

- 7. National Weather Service;
- 8. U.S. Fish and Wildlife Service;
  - 9. U.S. Small Business Administration;
- 7 10. Bureau of Indian Affairs;
- 8 11. U.S. Department of Housing and Urban Development;
  - 12. United States Environmental Protection Agency; and
- 13. Any other federal agency available to provide advice and assistance.
- D. The Oklahoma Flood and Drought Management Task Force shall have the following duties:
  - Developing and recommending state drought and flood response, recovery, and mitigation initiatives for conditions determined to be detrimental to the state economy and public health;
- 2. Identifying drought and flood management areas in the state;
- 3. Providing coordination and communication among federal, state, and local entities as deemed appropriate for drought and flood assistance programs, education, and information; and
- 4. Performing such other drought- and flood-related assessments and response functions as deemed necessary.
- E. Beginning in 2025, and every ten (10) years thereafter, in conjunction with the update of the Oklahoma Comprehensive Water Plan

1	and State Flood Plan, the Oklahoma Water Resources Board shall
2	coordinate with Oklahoma Flood and Drought Management Task Force to
3	update the Oklahoma Drought Management Plan.
4	F. The Oklahoma Water Resources Board shall prepare an annual
5	update of drought and flood conditions within the state and planning
6	and mitigation activities being conducted by the Task Force and
7	shall submit such report to the Speaker of the Oklahoma House of
8	Representatives and President Pro Tempore of the Oklahoma State
9	Senate.
10	SECTION 2. This act shall become effective November 1, 2023.
