16	This act shall be known and may be cited as the "Right to
17	Commerce Act".
18	SECTION 2. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 21-2 of Title 2, unless there is
20	created a duplication in numbering, reads as follows:
21	Oklahoma producers of cow milk or goat milk selling ungraded cow
22	milk or goat milk from their own herd production are exempt from
23	Sections 7-401 through 7-421 of Title 2 of the Oklahoma Statutes.
24	Nothing in Title 2 of the Oklahoma Statutes shall prohibit the sale

NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 21-3 of Title 2, unless there is 6 created a duplication in numbering, reads as follows: 7

Oklahoma producers of eggs selling ungraded eggs from their own 8 9 flock production are exempt from Sections 10-71 through 10-81 of Title 2 of the Oklahoma Statutes. Nothing in Title 2 of the 10 Oklahoma Statutes shall prohibit the sale of eggs produced on the 11 12 farm or property and sold directly to consumers in this state. Eggs sold under this section shall be produced by hens maintained on the 13 farm or property from which the eggs are sold. 14

SECTION 4. NEW LAW A new section of law to be codified 15 in the Oklahoma Statutes as Section 21-4 of Title 2, unless there is 16 created a duplication in numbering, reads as follows: 17

All producers selling items exempted under the provisions of 18 this act shall assume all liability. 19

SECTION 5. AMENDATORY 2 0.S. 2021, Section 10-78, is 20 amended to read as follows: 21

Section 10-78. A. Oklahoma producers of eggs selling ungraded 22 eggs from their own flock production are exempt from this 23 subarticle. Nothing in this subarticle shall prohibit the sale of

2	sold under this section shall be produced by hens maintained on the
