14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:	
15	SECTION 1. AMENDATORY 10 O.S. 2021, Section 640.1, as	
16	amended by Section 1, Chapter 181, O.S.L. 2022 (10 O.S. Supp. 2023,	
17	Section 640.1), is amended to read as follows:	
18	Section 640.1. A. There is hereby re-created until July 1,	
19	2024 July 1, 2027, in accordance with the Oklahoma Sunset Law, the	
20	Oklahoma Partnership for School Readiness Board. The Board shall	
21	promote school readiness supporting community-based efforts to	
22	increase the number of children who are ready to succeed by the time	
23	they enter school. The Board shall additionally serve as the	
24	state's Early Childhood Advisory Council and fulfill the	

- 1 responsibilities described in the Head Start Act of 2007 (PL 110-134, Section 642B). The Board shall consist of representatives from the private and public sectors as follows: 3 1. Fifteen private sector representatives appointed by the 4
 - Governor to include:
 - two parents of children eight (8) years of age or a. younger, and
 - one representative of licensed child care providers;
 - 2. One representative of the licensed child care industry appointed by the Governor;
 - 3. One representative of a state association of federally funded early childhood programs appointed by the Governor; and
 - 4. To ensure that existing resources are being utilized effectively, fifteen public sector representatives or their designees as follows:
 - State Superintendent of Public Instruction, a.
 - b. State Commissioner of Health,
 - Commissioner of the Department of Mental Health and Substance Abuse Services,
 - Director of the Oklahoma Department of Commerce, d.
 - Director of the Oklahoma Department of Libraries, е.
 - f. Director of the Department of Human Services,
 - Administrator of the Oklahoma Health Care Authority, g.

 The Governor shall fill all vacancies in the same manner as the original appointment was made.
 - C. The Director of the Department of Human Services shall convene an organizational meeting of the Oklahoma Partnership for School Readiness Board prior to November 1, 2003, at which time members of the Board shall elect a chair, a vice chair, and other officers as needed. A majority of the members of the Board shall constitute a quorum for the transaction of business.
 - D. Members of the Board shall receive no compensation for serving on the Board but shall receive travel reimbursement as follows:
 - 1. State agency officers and employees who are members of the Board shall be reimbursed for travel expenses incurred in the performance of their duties by their respective agencies in accordance with the State Travel Reimbursement Act; and
 - 2. Remaining members shall be reimbursed by the Board from any funds received by the Board for travel expenses incurred in the performance of their duties in accordance with the State Travel Reimbursement Act.
 - E. Members of the Board shall be exempt from the dual-office-holding provisions of Section 6 of Title 51 of the Oklahoma
 Statutes.

SECTION 2. This act shall become effective July 1, 2024. SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
