6 An Act relating to school employees; amending 70 O.S.
7 2021, Section 5-139, which relates to payroll
8 deductions for professional organizations;
9 prohibiting school districts from making deductions
10 for certain purposes upon certain date; providing an
11 effective date; and declaring an emergency.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 70 O.S. 2021, Section 5-139, is
14 amended to read as follows:

15 Section 5-139. ~~School~~ Upon the effective date of this act,
16 school districts shall ~~make~~ be prohibited from making payroll
17 deductions for either or both professional organization dues and
18 political contributions ~~at the written request of any school~~
19 ~~employee and shall transmit deducted funds to the organization~~
20 ~~designated by the school district employee. Such deductions shall~~
21 ~~be on a ten-month basis unless otherwise designated by the employee~~
22 ~~organization. However, a school employee may request at any time in~~
23 ~~writing, including by email or fax, for the school district to~~
24 ~~immediately terminate or initiate payroll deductions to a~~
~~professional organization. Upon receipt of any written request, the~~

1 ~~school district shall within five (5) business days or by the next~~
2 ~~pay period, whichever is earlier, terminate or initiate any future~~
3 ~~payroll deductions of the requesting school employee to a~~
4 ~~professional organization. Upon receipt of a written request, the~~
5 ~~school district shall notify the professional organization of the~~
6 ~~initiation or termination of payroll deductions within fifteen (15)~~
7 ~~business days. If the request is to terminate a deduction, the~~
8 ~~school district shall not make any advance payments to any~~
9 ~~professional organization of any future dues on behalf of the school~~
10 ~~employee. No school district policy or negotiated agreement shall~~
11 ~~place any other conditions or requirements, including but not~~
12 ~~limited to personal hand delivery, upon any employee to initiate or~~
13 ~~terminate any payroll deduction to a professional organization~~
14 ~~except for a written request as outlined in this section. Any~~
15 ~~school district policy or provision in a negotiated agreement that~~
16 ~~places additional conditions or requirements on initiation or~~
17 ~~termination beyond those outlined in this section shall be null and~~
18 ~~void. A school district which fails to terminate payroll deductions~~
19 ~~for an employee in accordance with this section shall immediately~~
20 ~~reimburse the employee the amount of all payroll deductions made by~~
21 ~~the school district after the employee's request, and the amount due~~
22 ~~the employee shall double every thirty (30) days until paid in full.~~

23 SECTION 2. This act shall become effective July 1, 2024.

1 SECTION 3. It being immediately necessary for the preservation
2 of the public peace, health, or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
