L2	SECTION 1. AMENDATORY 62 O.S. 2021, Section 155, as

L5	Section 155. A. There is hereby created in the State Treasury

These revolving funds shall be continuing funds, not subject to fiscal year limitations, and shall be under the control and management of the administrative authorities of the respective boards, commissions, or departments.
- Expenditures from the revolving funds shall be made pursuant 14 to the laws of the state and the statutes relating to the boards, 15 commissions, and departments, and without legislative appropriation. 16 Warrants for expenditures from the revolving funds shall be drawn by 17 the State Treasurer, based on claims signed by an authorized 18 employee or employees of the respective boards, commissions, or 19 departments and approved for payment by the Director of the Office 20 of Management and Enterprise Services. 21
