An Act relating to State Board of Cosmetology and Barbering; amending 59 O.S. 2021, Section 199.14, which relates to licensing fees; increasing fees; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 59 O.S. 2021, Section 199.14, is amended to read as follows:

2 B. In addition to the fees specified in subsection A of this
3 section, the Board shall charge a total penalty of Ten Dollars
4 (\$10.00), as provided for in Section 199.10 of this title.

5 C. Any person licensed as an advanced operator prior to July 1,
6 1985, may renew the advanced cosmetologist license annually by
7 payment of the fee required by this section and by being in
8 compliance with the rules promulgated by the State Board of
9 Cosmetology and Barbering.

10 SECTION 2. It being immediately necessary for the preservation
11 of the public peace, health or safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
