 - C. The appointed members from the Department of Wildlife
 Conservation shall serve as co-chairs of the Task Force. The cochairs shall convene the first meeting of the Task Force. The Task
 Force shall meet as often as necessary.
- D. Appointments to the Task Force shall be made by January 1, 2024.
 - E. If applicable, members of the Task Force shall be reimbursed by their respective entities for necessary travel expenses incurred in the performance of duties pursuant to the provisions of the State Travel Reimbursement Act.
- F. Administrative support for the Task Force including, but not limited to, personnel necessary to ensure the proper performance of the duties and responsibilities of the Task Force shall be provided, if necessary, by the representative entities involved in the Task Force.
