8 A Joint Resolution approving certain proposed
9 permanent rules of Oklahoma state agencies;
10 disapproving certain proposed permanent rules; and
11 directing distribution.

13 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
14 Statutes, the Legislature shall have a joint resolution prepared for
15 consideration each session.

16 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF
17 REPRESENTATIVES OF THE 1ST SESSION OF THE 59TH OKLAHOMA LEGISLATURE:

18 SECTION 1. All proposed permanent rules of Oklahoma state
19 agencies filed on or before April 1, 2023, are hereby approved
20 except for OAC 317:30-3-35, submitted by the Oklahoma Health Care
21 Authority. The following proposed permanent rules of state agencies
22 filed on or before April 1, 2023, are hereby disapproved:

2 435:15-1-1.1, 435:15-3-1, 435:15-3-13, 435:15-3-17, 435:15-3-19,
3 435:15-5-10, 435:15-11-1, and 435:15-11-2;
- 4 2. Oklahoma Used Motor Vehicle, Dismantler, and Manufactured
5 Housing Commission, OAC 765:10-3-5;
- 6 3. Department of Public Safety, OAC 595:25-1-2, disapproving
7 adding definition of ""Payment" means compensation for services
8 rendered by a wrecker or towing company in the form of cash, credit
9 card, debit card, Automated Clearinghouse Transfer (ACH), business
10 checks, cashier's check, or money order." and OAC 595:25-5-7(b) and
11 (c), disapproving proposed changes, except for the P.O. Box number;
- 12 4. Department of Wildlife Conservation, OAC 800:25-24-3
13 paragraph (2) of subsection (c);
- 14 5. State Board of Cosmetology and Barbering, OAC 175:10-3-47,
15 and OAC 175:10-9-55, disapproving the language "Only a licensed
16 Cosmetology Instructor or licensed Facial/Esthetics Instructor may
17 teach Eyelash Extension Specialist courses or classes.", as included
18 in subparagraph (b); and
- 19 6. State Department of Health, OAC 310:642-1-1, 310:642-1-2,
20 310:642-1-3, 310:642-3-1, 310:642-3-2, 310:642-5-1 except for
21 subparagraph (H) of paragraph (2), 310:642-7-1, 310:642-7-2,
22 310:642-9-1, 310:643-1-1, 310:643-1-2, 310:643-3-1, 310:643-3-2,
23 310:643-5-1, 310:643-5-2, 310:643-5-3, 310:643-7-1, and 310:643-7-2.
