12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.3, as
14	last amended by Section 1, Chapter 402, O.S.L. 2022 (51 O.S. Supp.
15	2022, Section 24A.3), is amended to read as follows:
16	Section 24A.3. As used in the Oklahoma Open Records Act:
17	1. "Record" means all documents including $_{ au}$ but not limited to $_{ au}$
18	any book, paper, photograph, microfilm, data files created by or
19	used with computer software, computer tape, disk, record, sound
20	recording, film recording, video record or other material regardless
21	of physical form or characteristic, created by, received by, under
22	the authority of, or coming into the custody, control or possession
23	of public officials, public bodies or their representatives in
24	connection with the transaction of public business, the expenditure

1 of public funds or the administering of public property. "Record" 2 does not mean:

- 1g. a Department of Defense Form 214 (DD Form 214) filed2with a county clerk including any DD Form 214 filed3before July 1, 2002,
 - h. except as provided for in Section 2-110 of Title 47 of the Oklahoma Statutes,
 - (1) any record in connection with a Motor Vehicle Report issued by the Department of Public Safety, as prescribed in Section 6-117 of Title 47 of the Oklahoma Statutes, or
- 10 (2) personal information within driver records, as 11 defined by the Driver's Privacy Protection Act, 12 18 United States Code, Sections 2721 through 13 2725, which are stored and maintained by the 14 Department of Public Safety, or

submitted with an application for licensure shall be public record;

"Public body" shall include τ but not be limited to τ any 4 office, department, board, bureau, commission, agency, trusteeship, 5 authority, council, committee, trust or any entity created by a 6 trust, county, city, village, town, township, district, school 7 district, fair board, court, executive office, advisory group, task 8 force, study group or any subdivision thereof, supported in whole or 9 in part by public funds or entrusted with the expenditure of public 10 funds or administering or operating public property, and all 11 committees, or subcommittees thereof. Except for the records 12 required by Section 24A.4 of this title, "public body" does not mean 13 judges, justices, the Council on Judicial Complaints, the 14 Legislature or legislators. "Public body" shall not include an 15 organization that is exempt from federal income tax under Section 16 501(c)(3) of the Internal Revenue Code of 1986, as amended, and 17 whose sole beneficiary is a college or university, or an affiliated 18 entity of the college or university, that is a member of The 19 Oklahoma State System of Higher Education. Such organization shall 20 not receive direct appropriations from the Oklahoma Legislature. 21 The following persons shall not be eligible to serve as a voting 22 member of the governing board of the organization:

6	3. "Public office" means the physical location where public
7	bodies conduct business or keep records;
8	4. "Public official" means any official or employee of any
9	public body as defined herein; and
10	5. "Law enforcement agency" means any public body charged with
11	enforcing state or local criminal laws and initiating criminal
12	prosecutions including, but not limited to, police departments,
13	county sheriffs, the Department of Public Safety, the Oklahoma State
14	Bureau of Narcotics and Dangerous Drugs Control, the Alcoholic
15	Beverage Laws Enforcement Commission, and the Oklahoma State Bureau
16	of Investigation.
17	SECTION 2. This act shall become effective November 1, 2023.
