- 2. Influence the conduct of or certify law enforcement officer misconduct investigations;
- 3. Recommend disciplinary actions for law enforcement officer misconduct; or
  - 4. Impose discipline for law enforcement officer misconduct.
- C. If the person or government committee, board, agency, department, office or entity does not meet the two-thirds (2/3) requirement prescribed in subsection A of this section, a supervisor, a department or an agency head that supervises a law enforcement officer may investigate and impose discipline for the law enforcement officer's misconduct if the supervisor, department or agency head acts independently of the person, committee, board, agency, department, office or entity.
  - D. This section does not apply to any of the following:
- 1. A person or a government committee, board, agency,

  department, office, civil service board or entity that only reviews

the actions described in subsection A of this section and that does not determine the initial level of discipline or have the authority to increase the severity of the disciplinary action;

2. The Council on Law Enforcement Education and Training
(CLEET);

- 3. A multijurisdictional law enforcement agency or task force or a similar entity that is charged with investigating the use of force by law enforcement officers, if at least two-thirds (2/3) of the membership of the multijurisdictional law enforcement agency or task force or the similar entity consists of law enforcement officers who are certified by CLEET; and
- 4. An entity that investigates federal employment discrimination.
  - E. The Legislature finds that setting and maintaining standards of professionalism and integrity of law enforcement officers in this state are of statewide concern.
  - F. For the purposes of this section, "members, staff, employees or seats" includes any person who participates in the following:
    - 1. Investigating law enforcement officer misconduct;
- 20 2. Influencing the conduct or certification of law enforcement officer misconduct investigations;
- 3. Recommending disciplinary actions for law enforcement officer misconduct; and
  - 4. Imposing discipline for law enforcement officer misconduct.
