13 amount; identifying source; providing purpose;

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law not to be
18 codified in the Oklahoma Statutes reads as follows:

19 There is hereby appropriated to the Oklahoma State Regents for
20 Higher Education from any monies not otherwise appropriated from the
21 General Revenue Fund of the State Treasury for the fiscal year
22 ending June 30, 2022, the sum of Nine Million Dollars
23 (\$9,000,000.00) or so much thereof as may be necessary to cover
24 costs associated with implementing the Oklahoma National Guard

1 Educational Assistance Program created by Enrolled Senate Bill No.
2 1418 of the 2nd Session of the 58th Oklahoma Legislature.

3 SECTION 2. It being immediately necessary for the preservation
4 of the public peace, health or safety, an emergency is hereby
5 declared to exist, by reason whereof this act shall take effect and
6 be in full force from and after its passage and approval.
