COMMITTEE SUBSTITUTE

An Act relating to judicial compensation; rejecting
and amending judicial salaries established by the
Board on Judicial Compensation; establishing increase
for certain categories of judges; maintaining salary
for certain categories of judges and justices;
establishing date of implementation; providing for
noncodification; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be
codified in the Oklahoma Statutes reads as follows:

Pursuant to the authority provided in Section 3.2 of Title 20 of
the Oklahoma Statutes to reject judicial salaries established by the
Board on Judicial Compensation, the Oklahoma Legislature hereby
rejects the Final Report of the Board on Judicial Compensation
issued on September 19, 2023.

SECTION 2. NEW LAW A new section of law not to be
codified in the Oklahoma Statutes reads as follows:

The Oklahoma Legislature hereby amends judicial salaries to take
effect July 1, 2024. The amended salary schedule provided for in
this section provides a salary increase of seven percent (7.0%)
above the salary levels existing during fiscal year 2024 for
positions listed as follows; all other judicial salaries shall
remain at the levels that existed as of January 1, 2024:

District Judges

Associate District Judges

Special District Judges.

SECTION 3. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby
declared to exist, by reason whereof this act shall take effect and
be in full force from and after its passage and approval.
