COMMITTEE SUBSTITUTE

An Act relating to home- and community-based services; creating the Developmental Disability Services Revolving Fund; specifying type of fund and source of monies; providing for expenditure of funds; providing for codification; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1026.1 of Title 56, unless there is created a duplication in numbering, reads as follows:

There is hereby created in the State Treasury a revolving fund for the Department of Human Services to be designated the "Developmental Disability Services Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies received by the Department from

1 appropriations provided for the purpose of funding the state share
2 of the following home- and community-based services waivers:

- 3 1. The In-Home Supports for Adults Waiver;
- 4 2. The In-Home Supports for Children Waiver;
- 5 3. The Homeward Bound Waiver; and
- 6 4. The Community Waiver.

7 All monies accruing to the credit of the fund are hereby
8 appropriated and may be budgeted and expended by the Department for
9 the purpose provided for in this section. Expenditures from the
10 fund shall be made upon warrants issued by the State Treasurer
11 against claims filed as prescribed by law with the Director of the
12 Office of Management and Enterprise Services for approval and
13 payment.

14 SECTION 2. This act shall become effective July 1, 2024.

15 SECTION 3. It being immediately necessary for the preservation
16 of the public peace, health or safety, an emergency is hereby
17 declared to exist, by reason whereof this act shall take effect and
18 be in full force from and after its passage and approval.
