COMMITTEE SUBSTITUTE

An Act relating to the Oklahoma State University
Veterinary Medicine Authority; prohibiting certain
expenditures of funds; providing for codification;
providing an effective date; and declaring an
emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 4023 of Title 2, unless there is
created a duplication in numbering, reads as follows:

Of the funds appropriated to the Oklahoma State University
Veterinary Medicine Authority in Section 108 of Enrolled Senate Bill
No. 1125 of the 2nd Session of the 59th Oklahoma Legislature, none
shall be used for equipment, personnel, or operations of the
Oklahoma Pandemic Center for Innovation and Excellence.

SECTION 2. This act shall become effective July 1, 2024.

1 SECTION 3. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
